We claim the ornamental design for a writing instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a writing instrument showing our new design;

FIG. 2 is a front view of FIG. 1;

FIG. 3 is a left side view of FIG. 1, the right side view being a mirror image of the left side view;

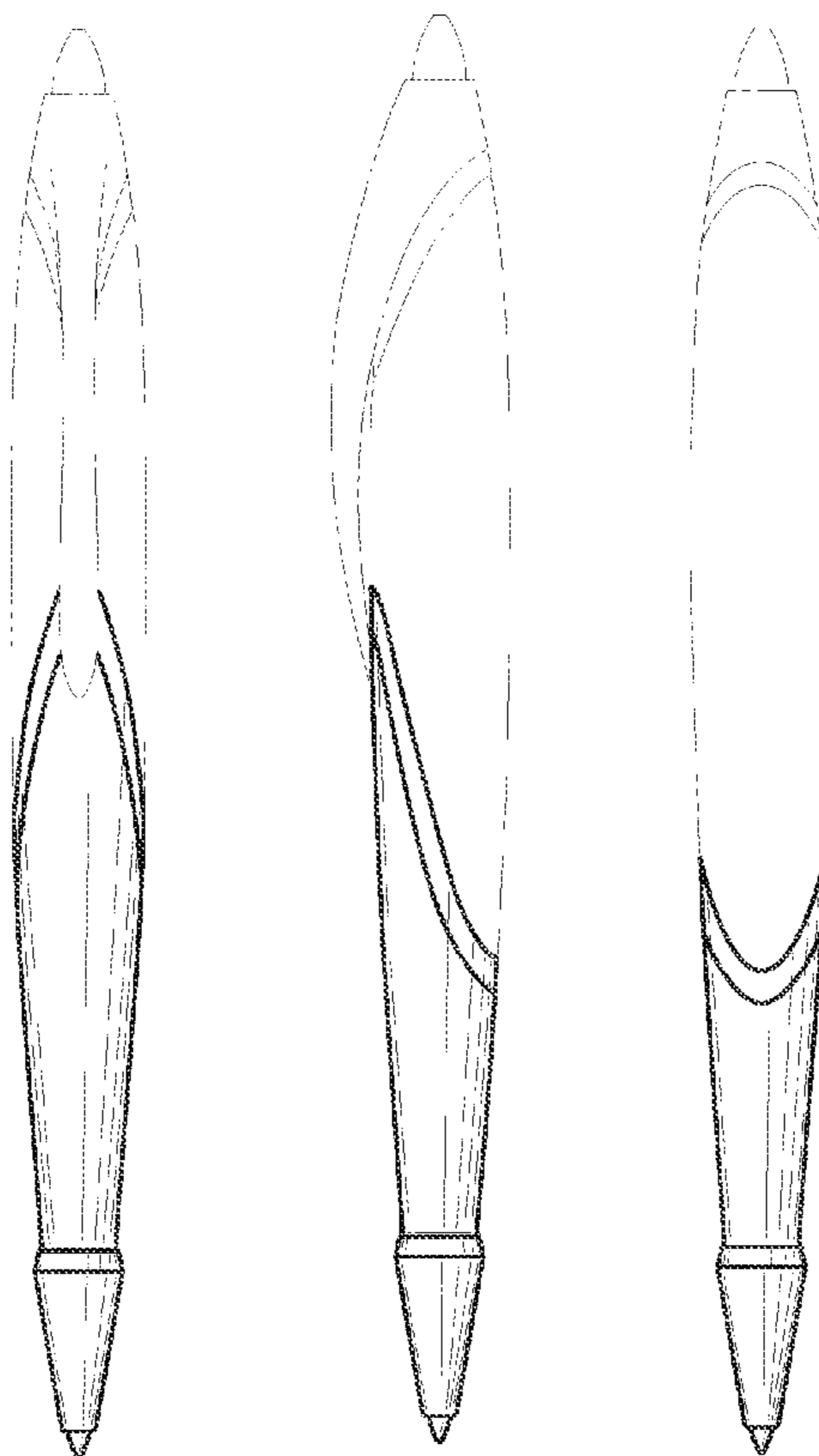
FIG. 4 is a back view of FIG. 1;

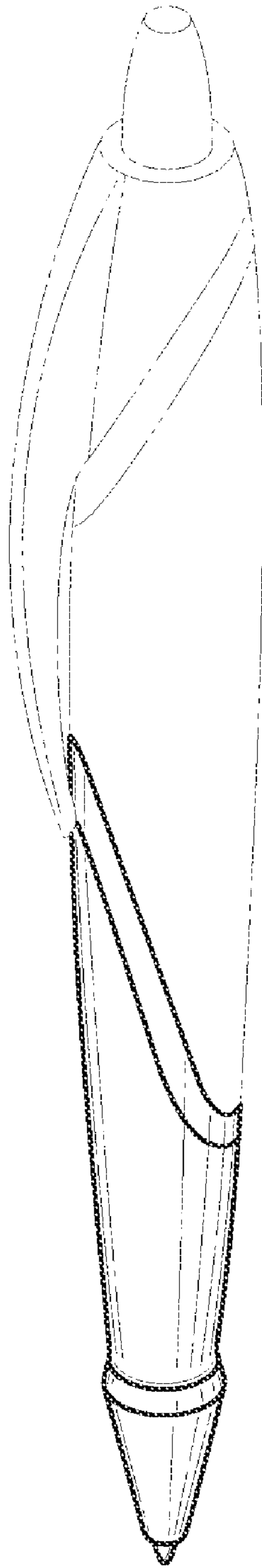

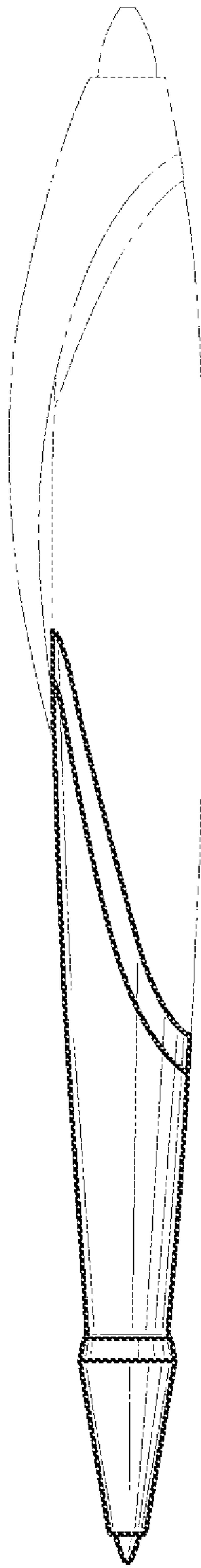

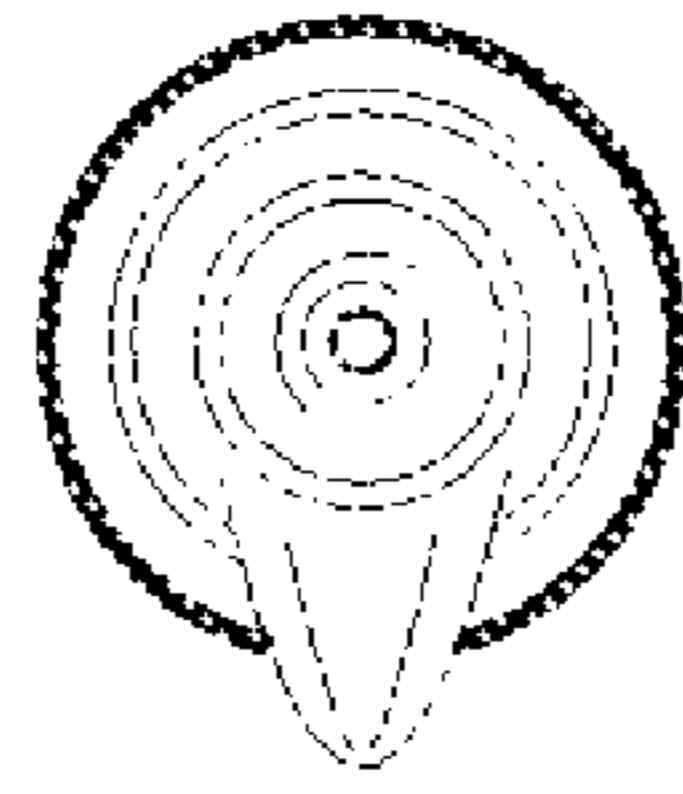

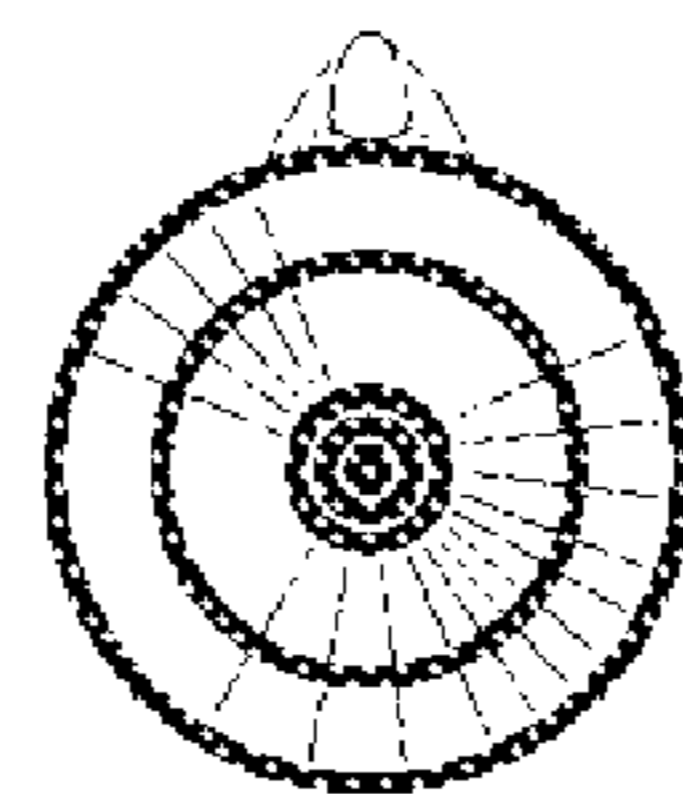
