**DESCRIPTION**

These alphabetic labels can be used as end tab labels for end tab folder pockets or applied to other labeling purposes.

FIG. 1 is a front view of the set of alphabetic labels showing my new design; and,

FIG. 2 is a front view of an alternate embodiment of my set of alphabetic labels.

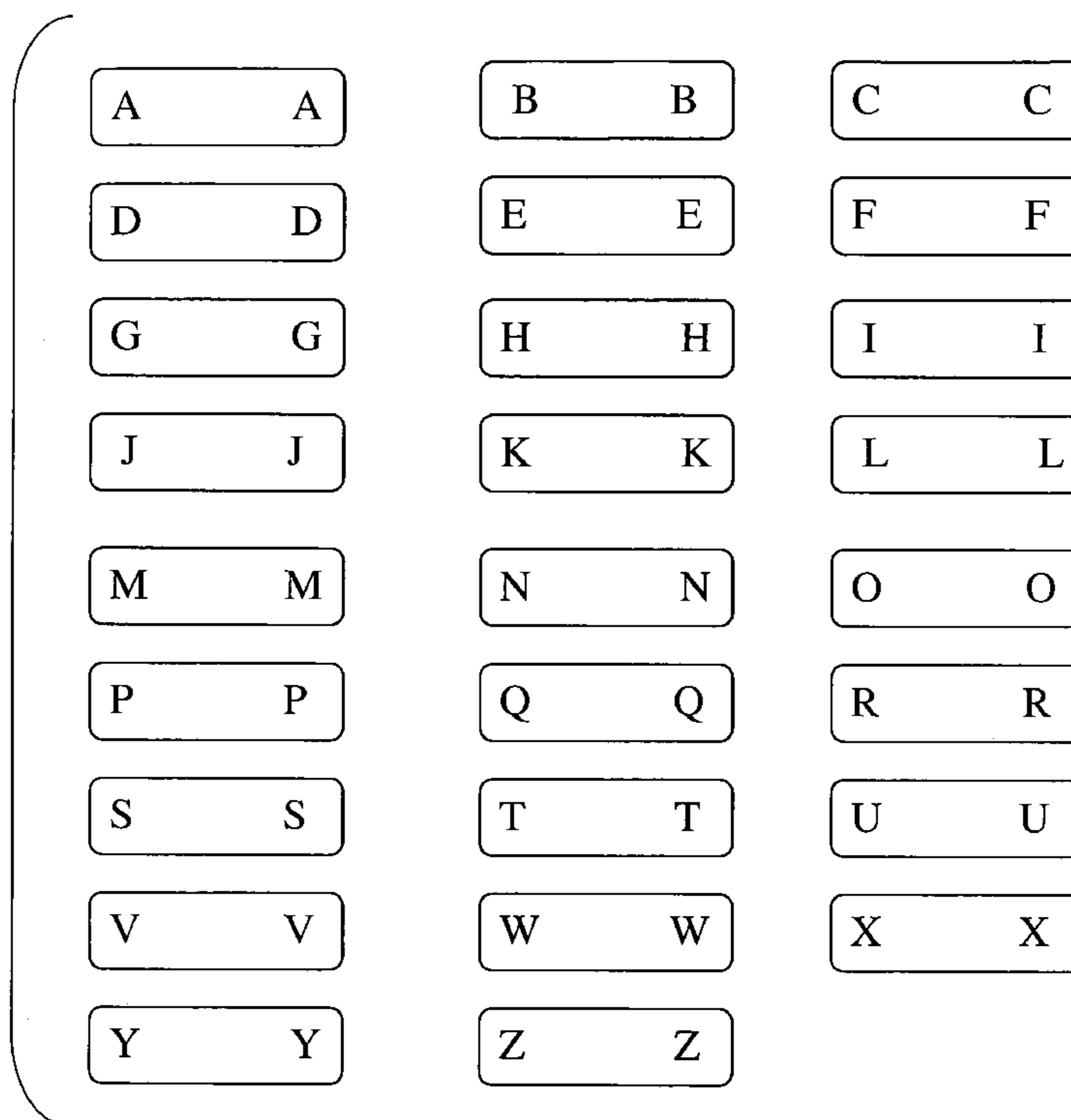

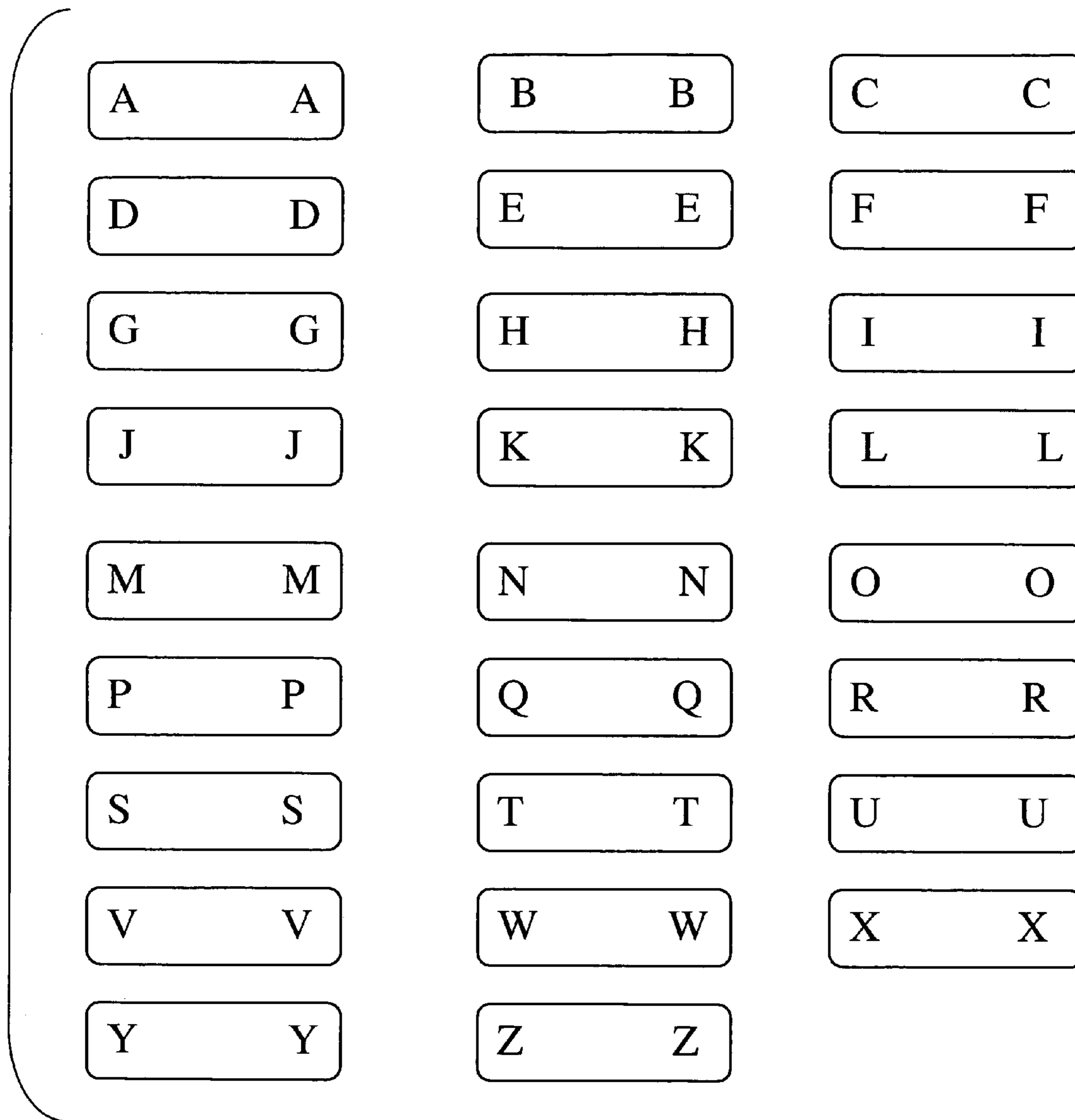
