(57) **CLAIM**

The ornamental design for a device for bone grafting, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a device for bone grafting showing my new design;

FIG. 2 is a front elevation thereof, the side opposite being identical;

FIG. 3 is a side elevation thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is another front elevation thereof;

FIG. 7 is a cross-sectional view thereof;

FIG. 8 is a top perspective view of a modified embodiment of the design shown in FIGS. 1 through 7;

FIG. 9 is a front elevation thereof, the side opposite being a mirror image thereof;

FIG. 10 is a side elevation thereof;

FIG. 11 is a top plan view thereof;

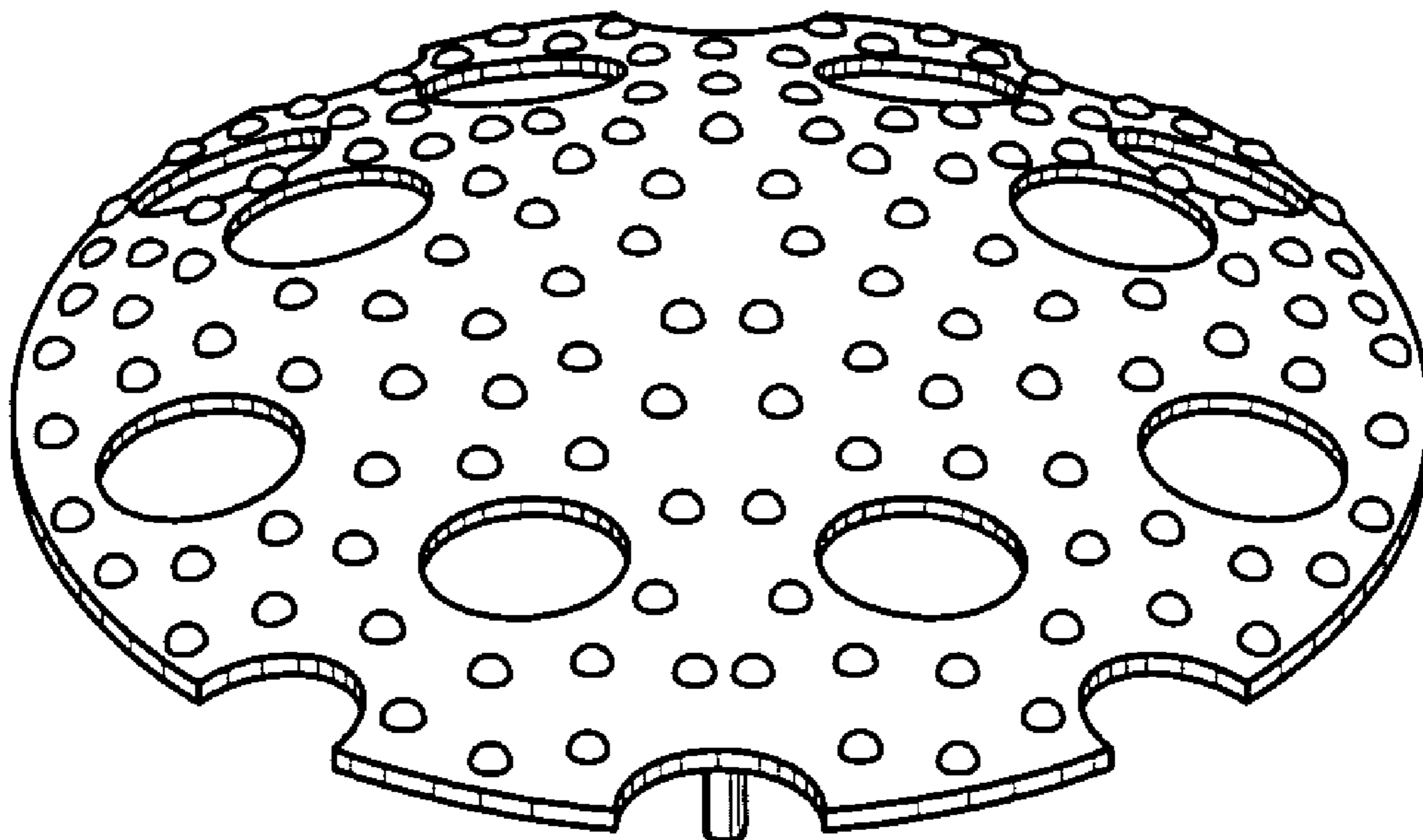
FIG. 12 is a bottom plan view thereof;

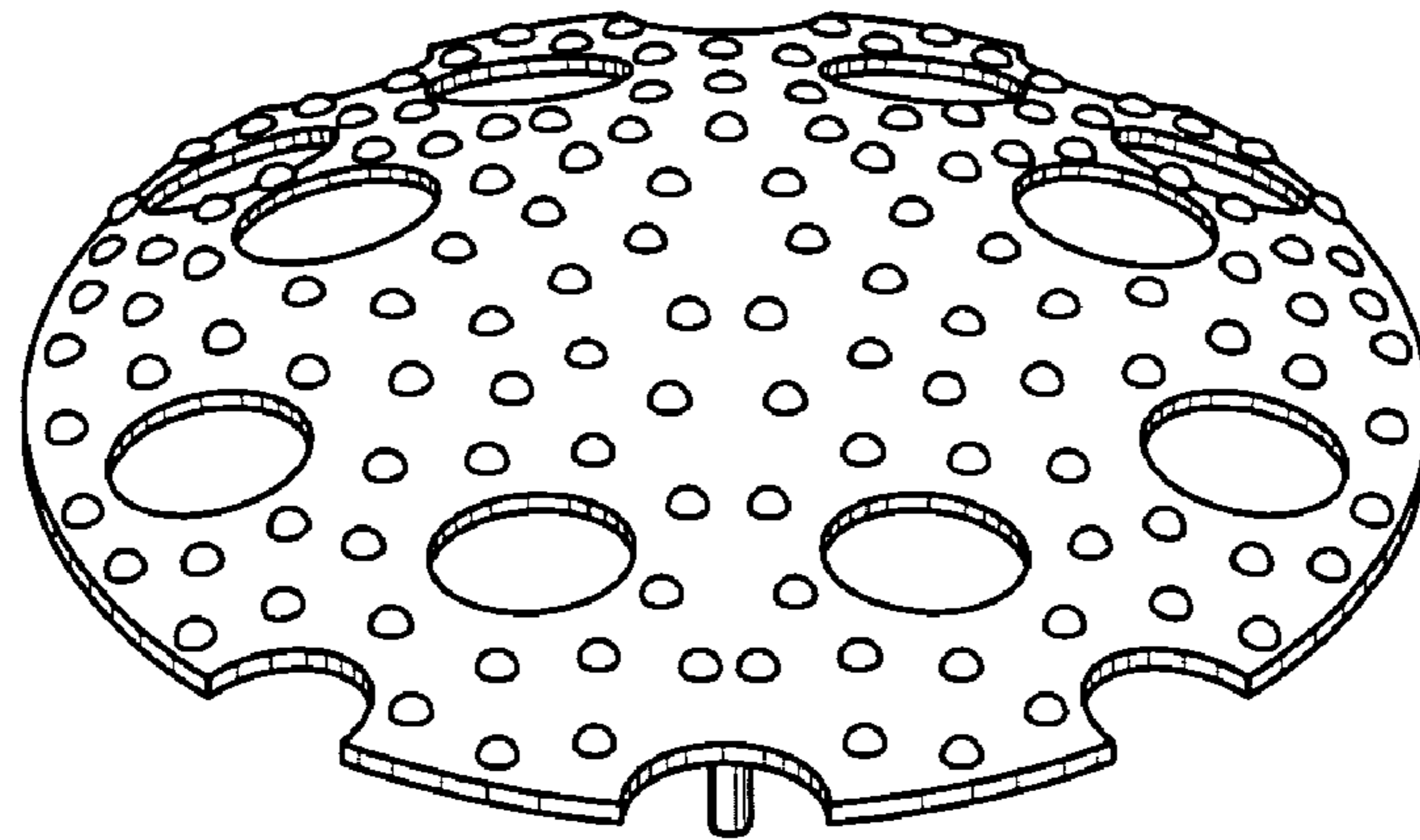

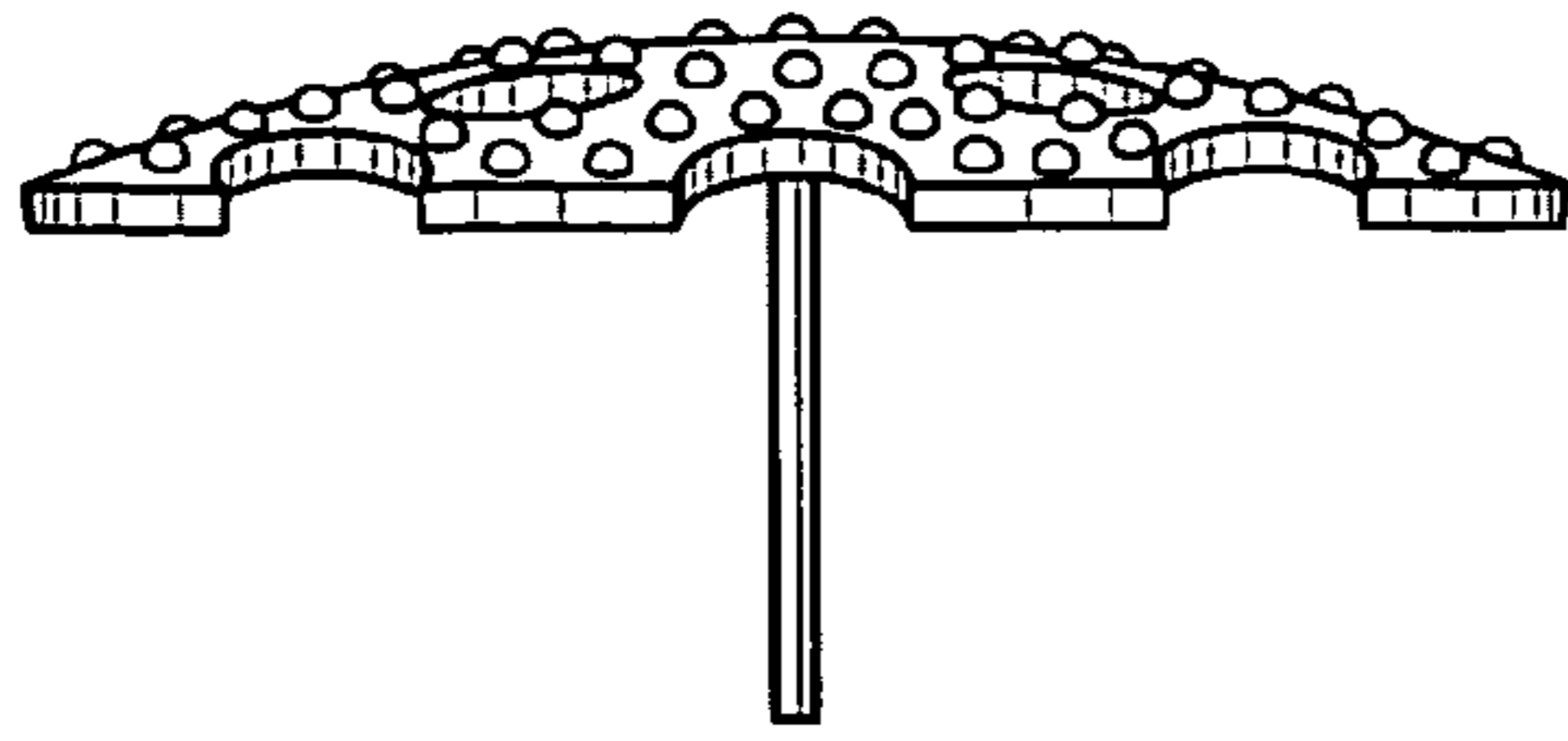

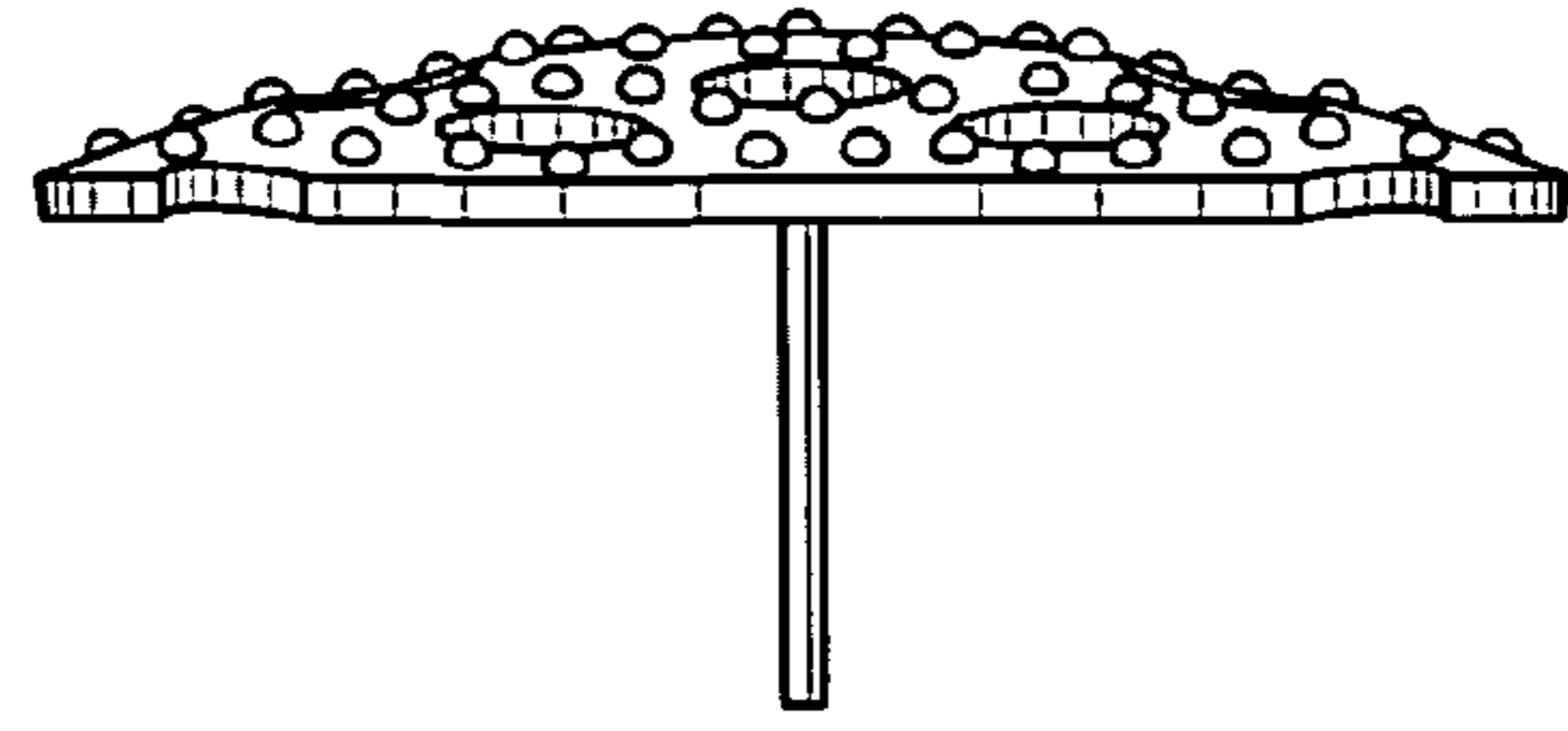

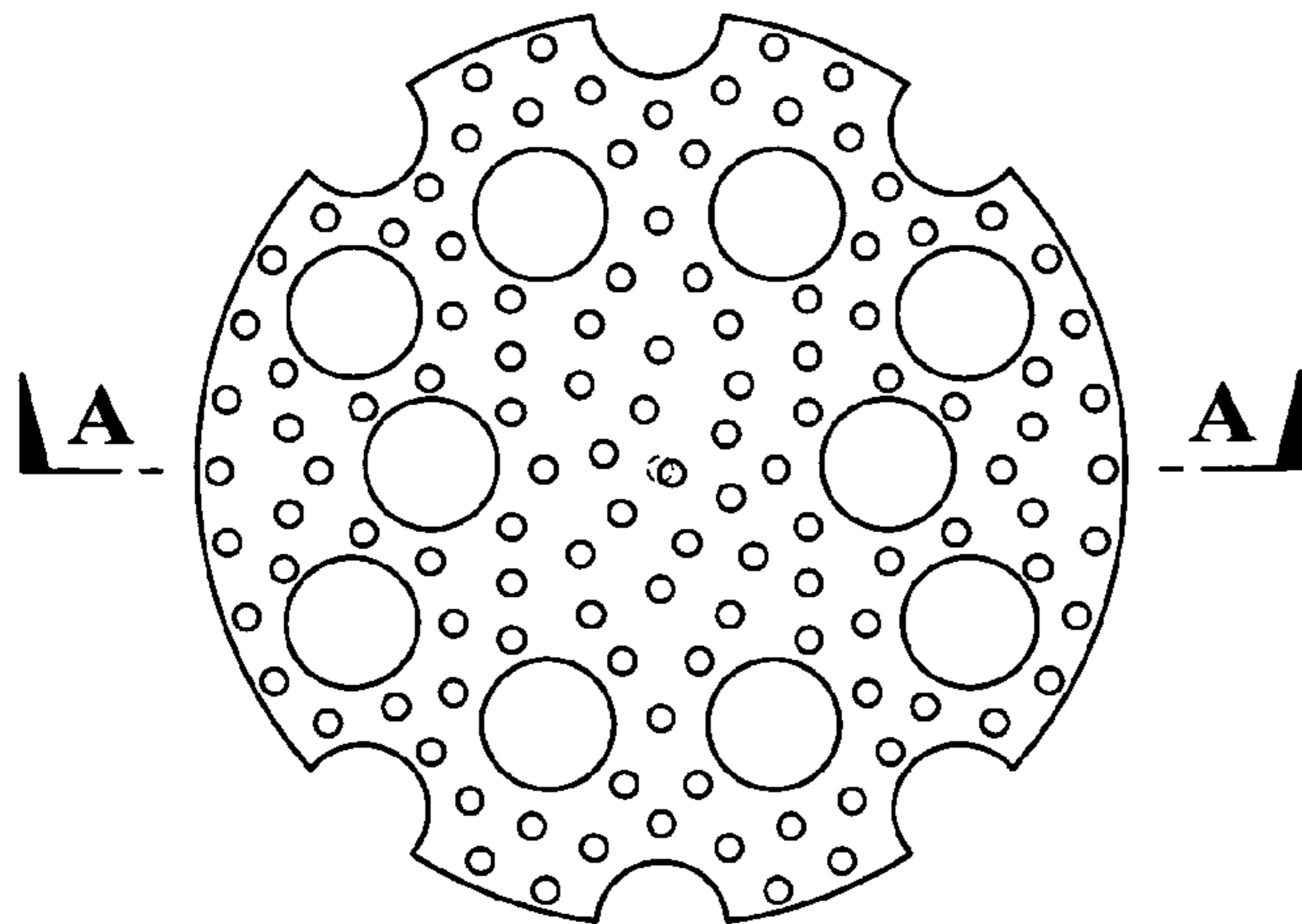

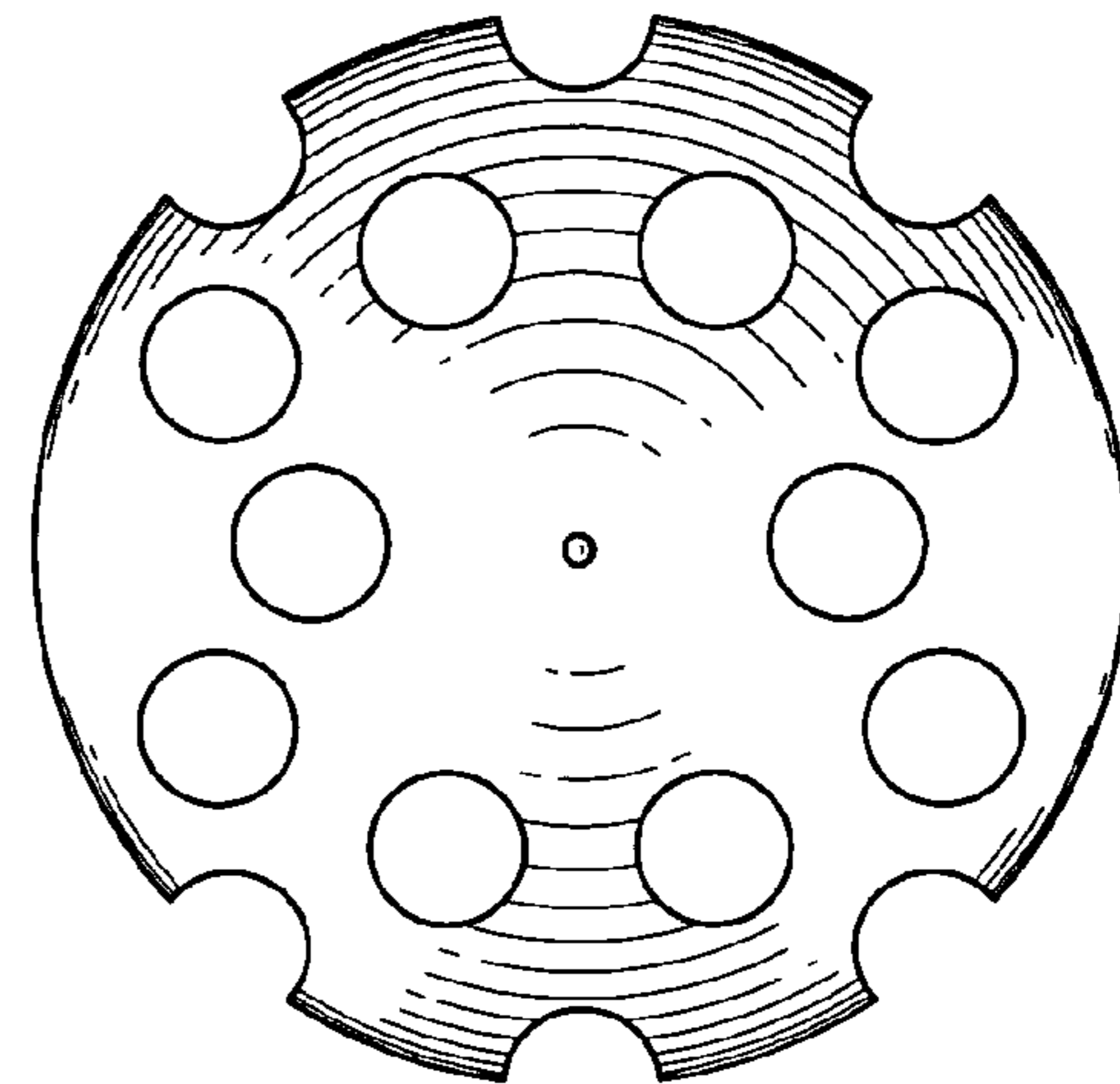

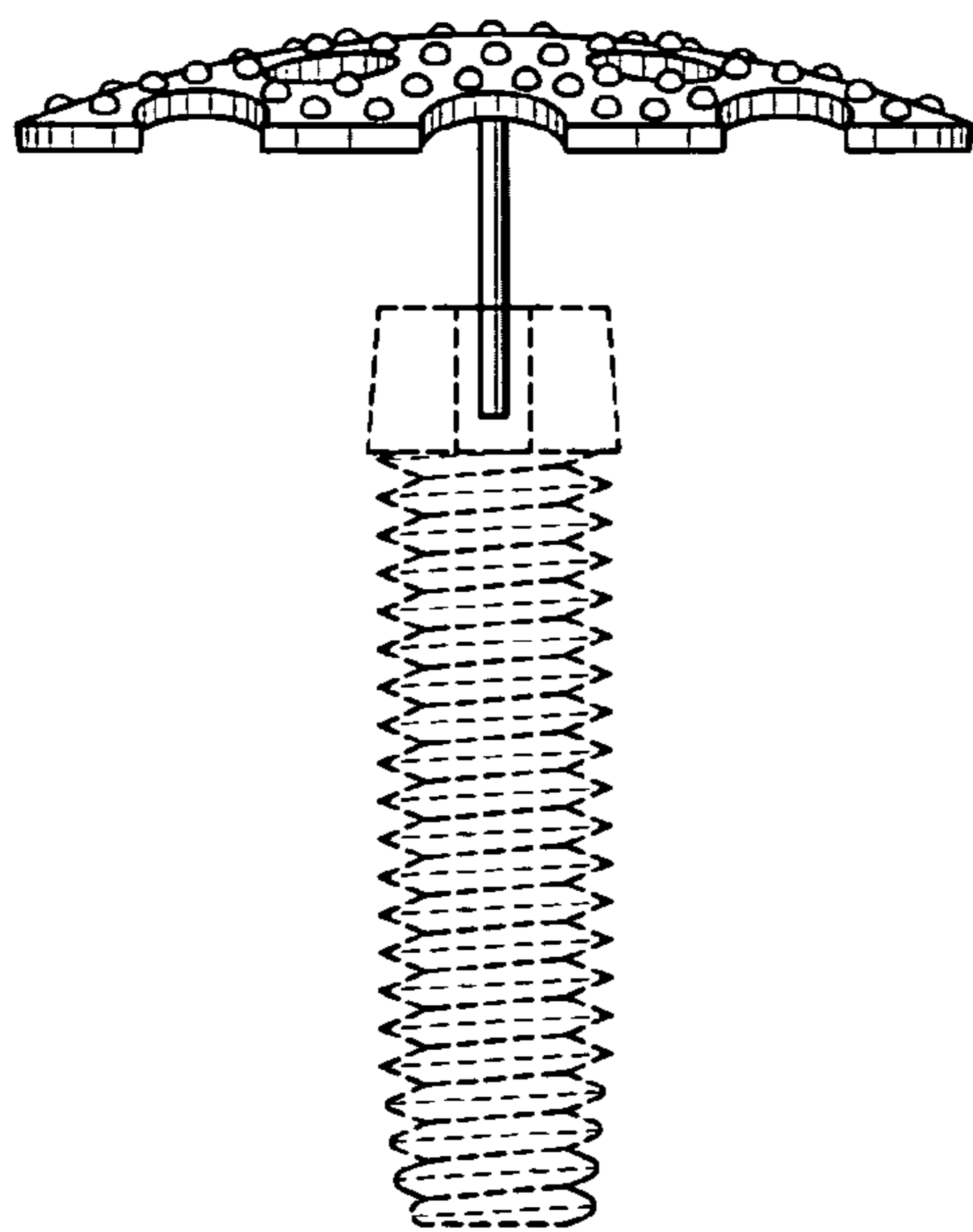

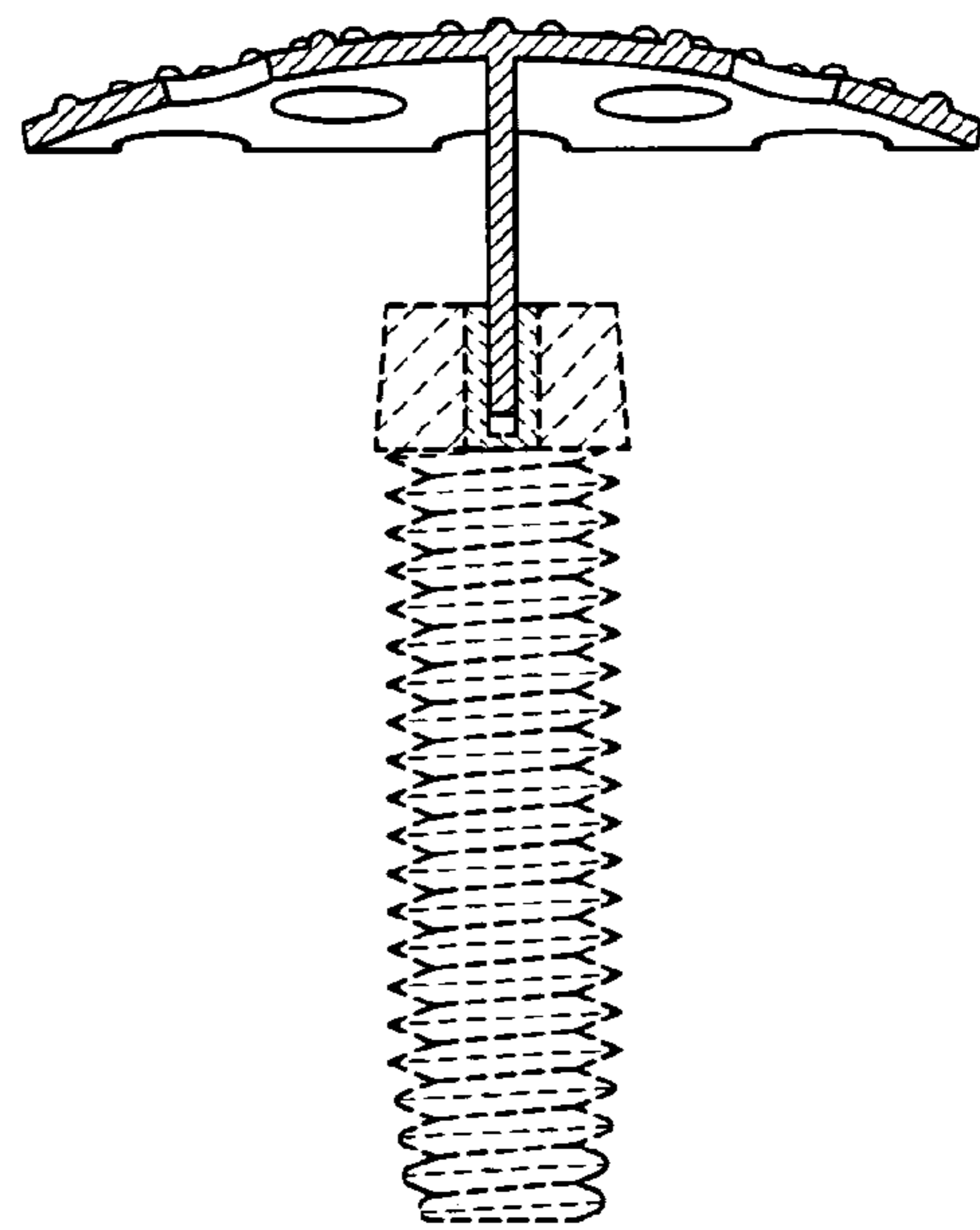

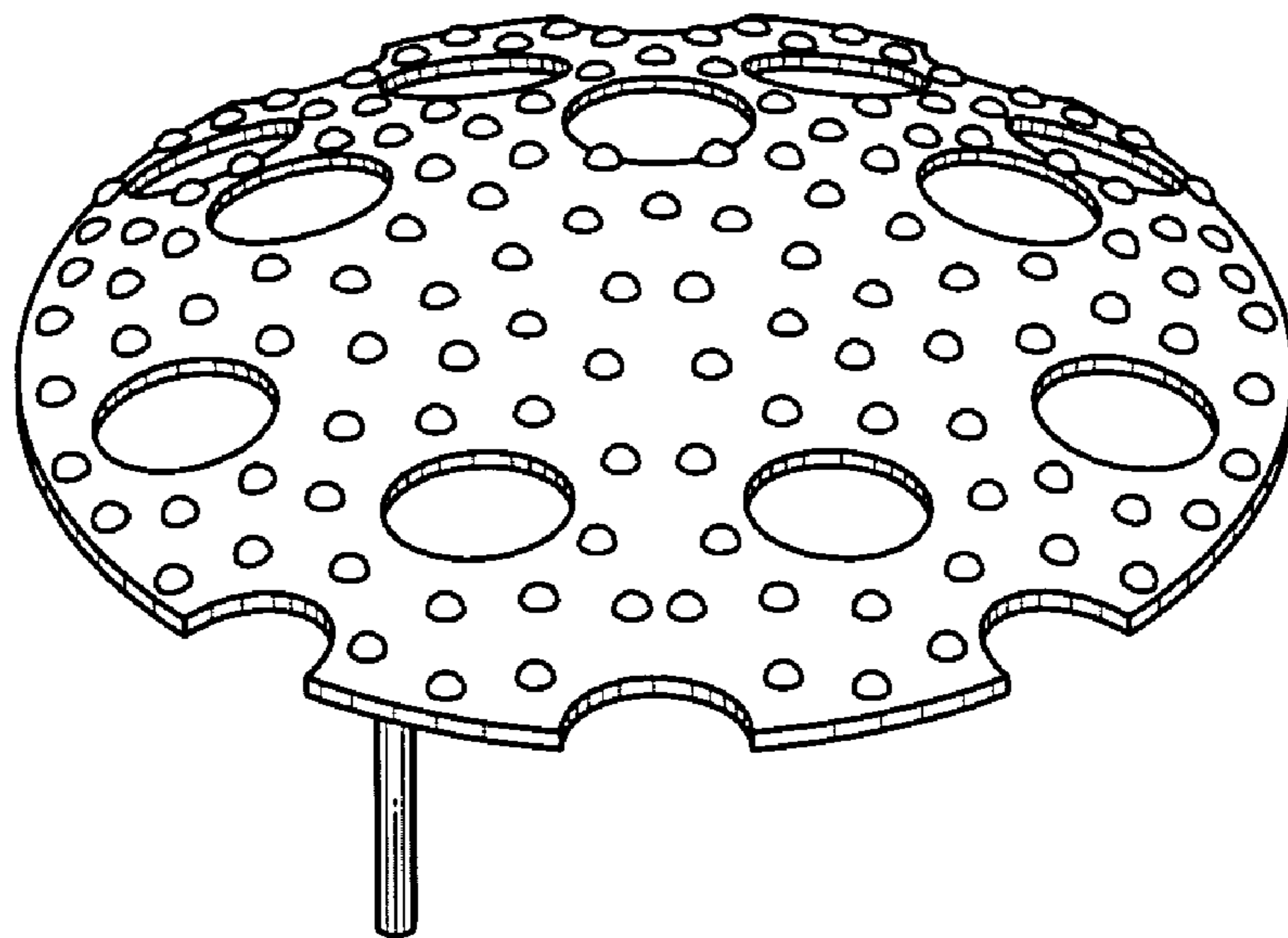

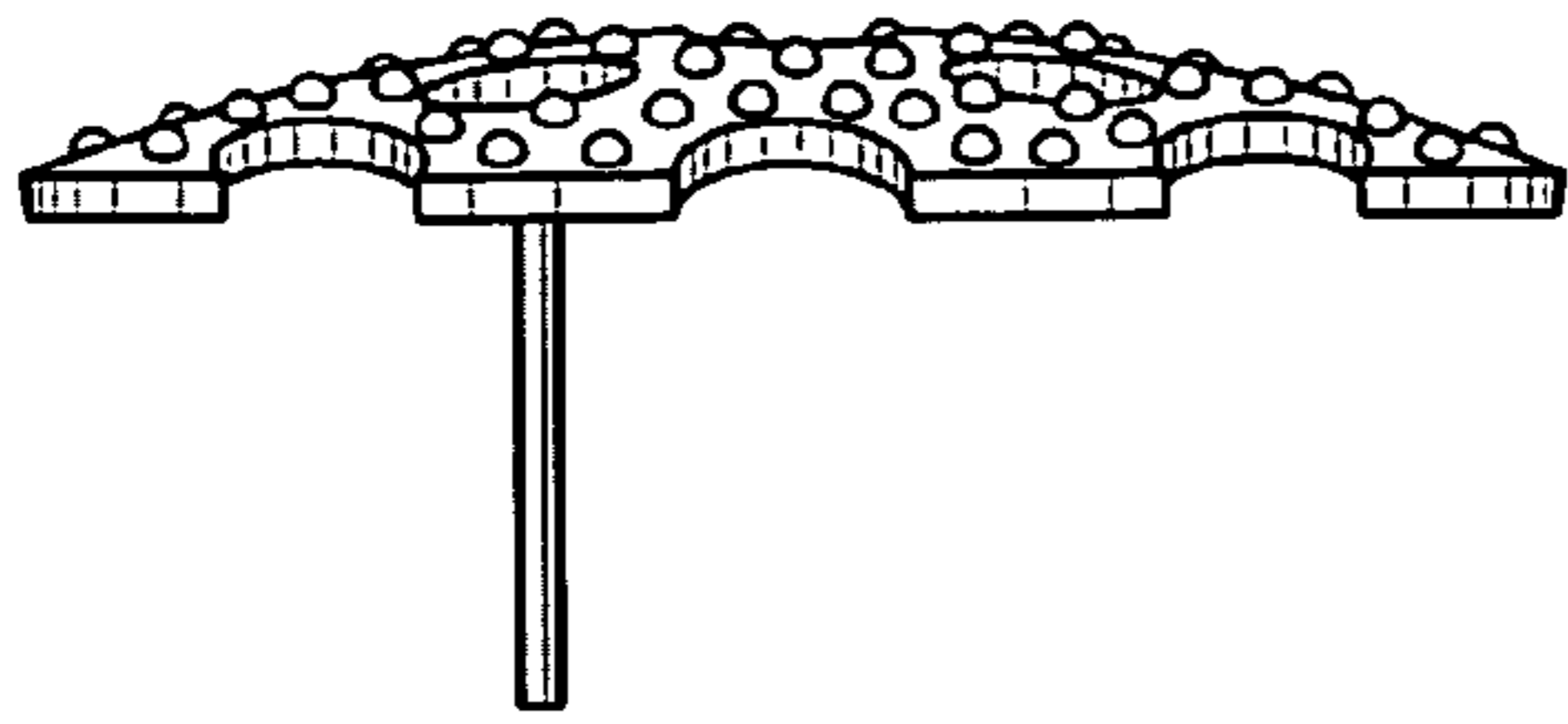

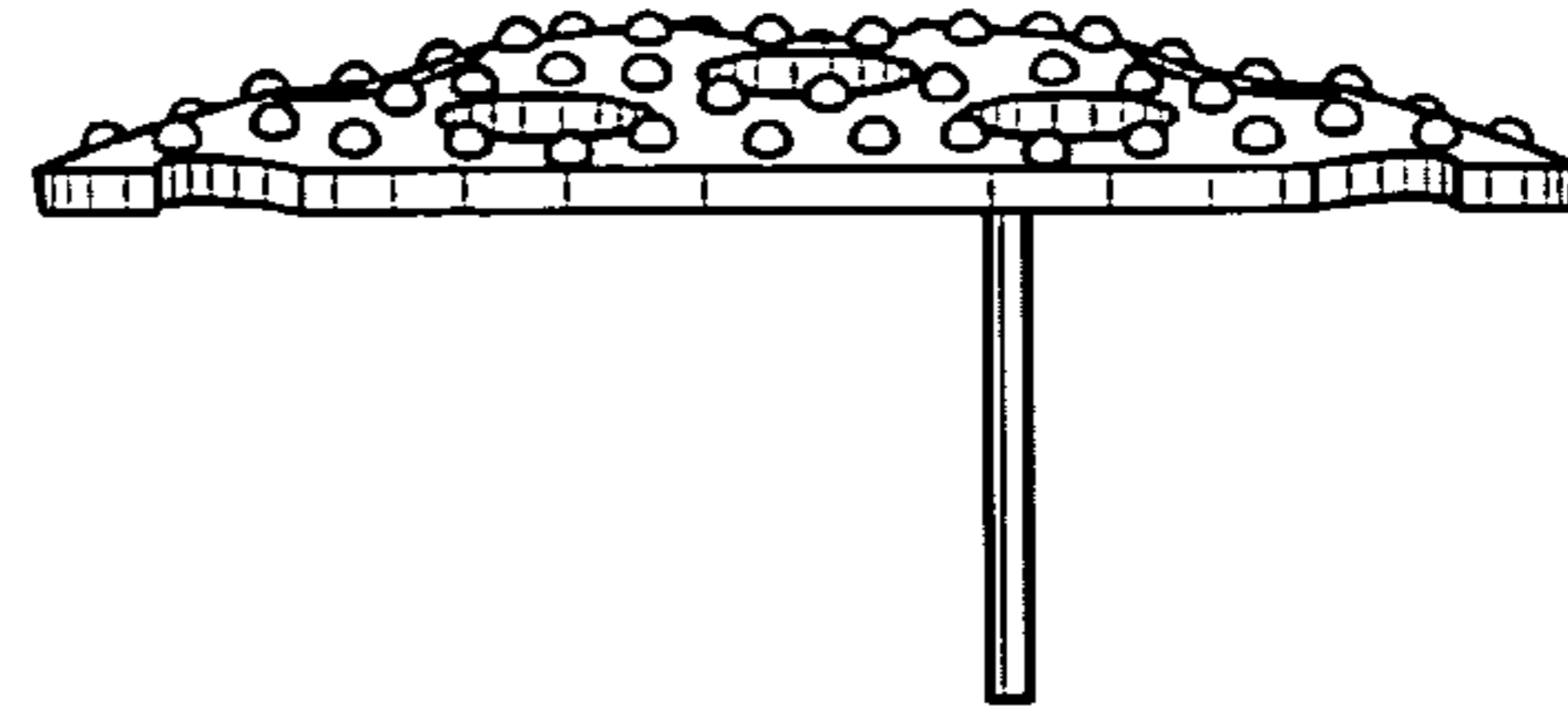

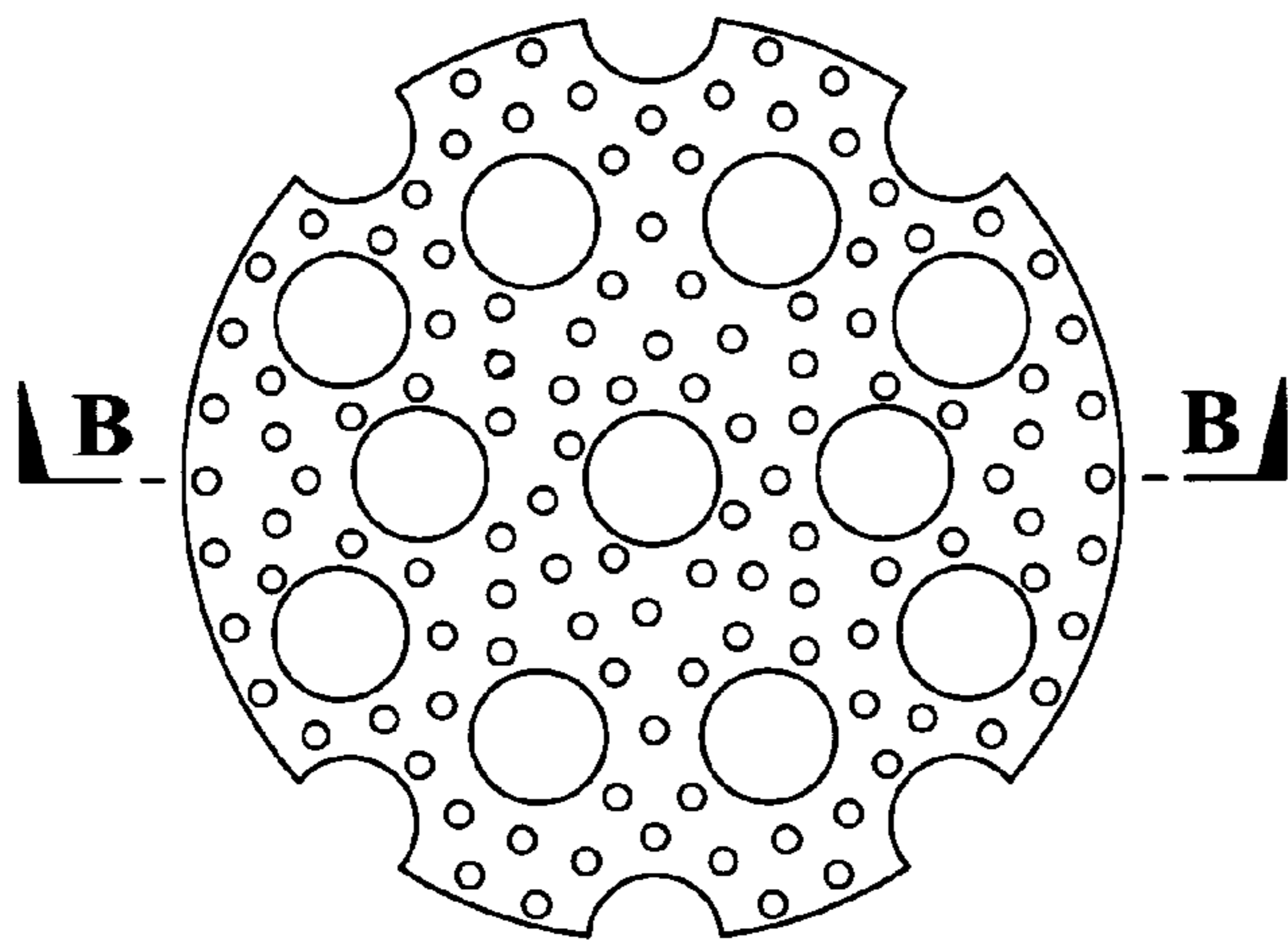

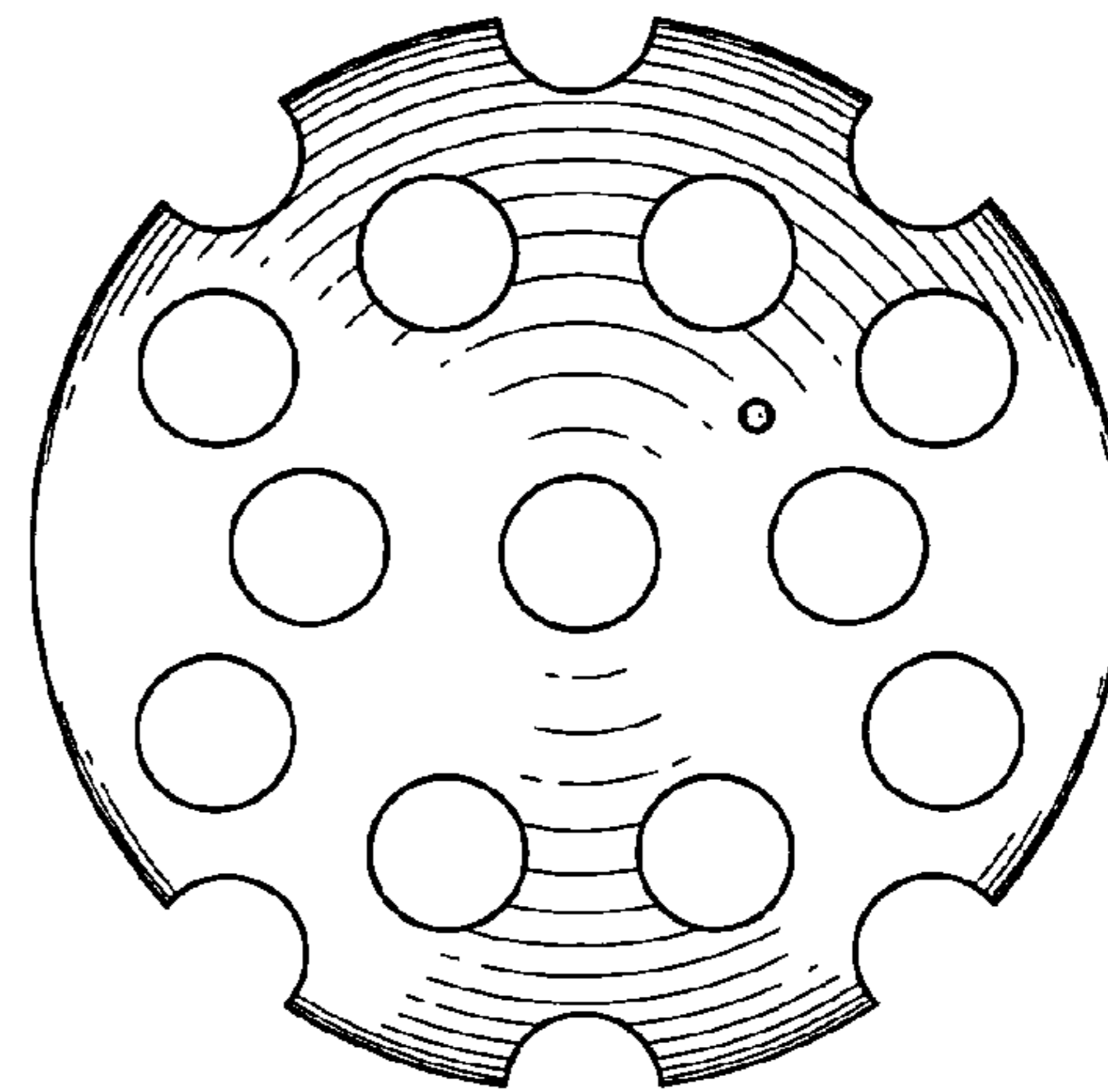

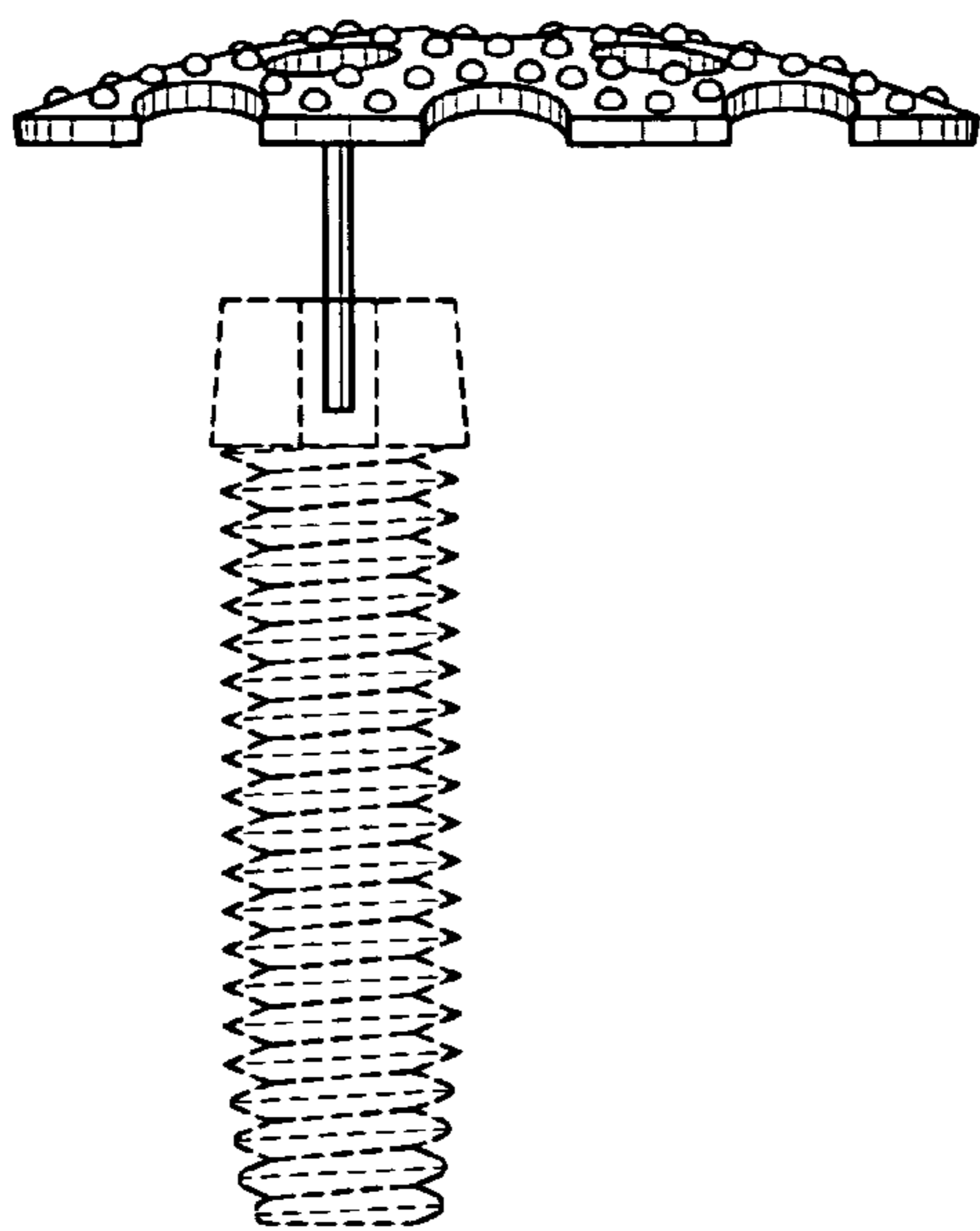

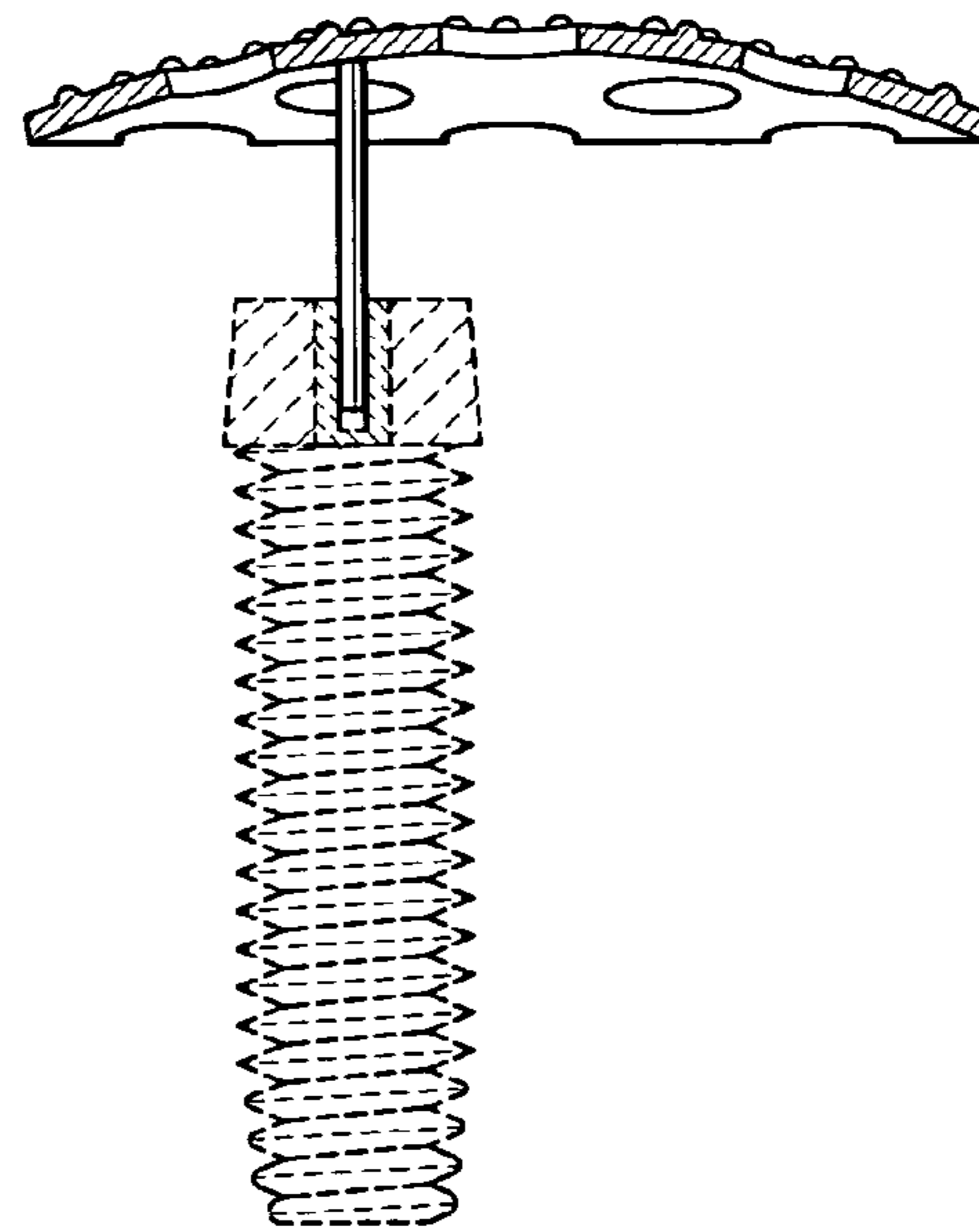
