FIG. 3 is a right side elevation view, the left side being a mirror image.

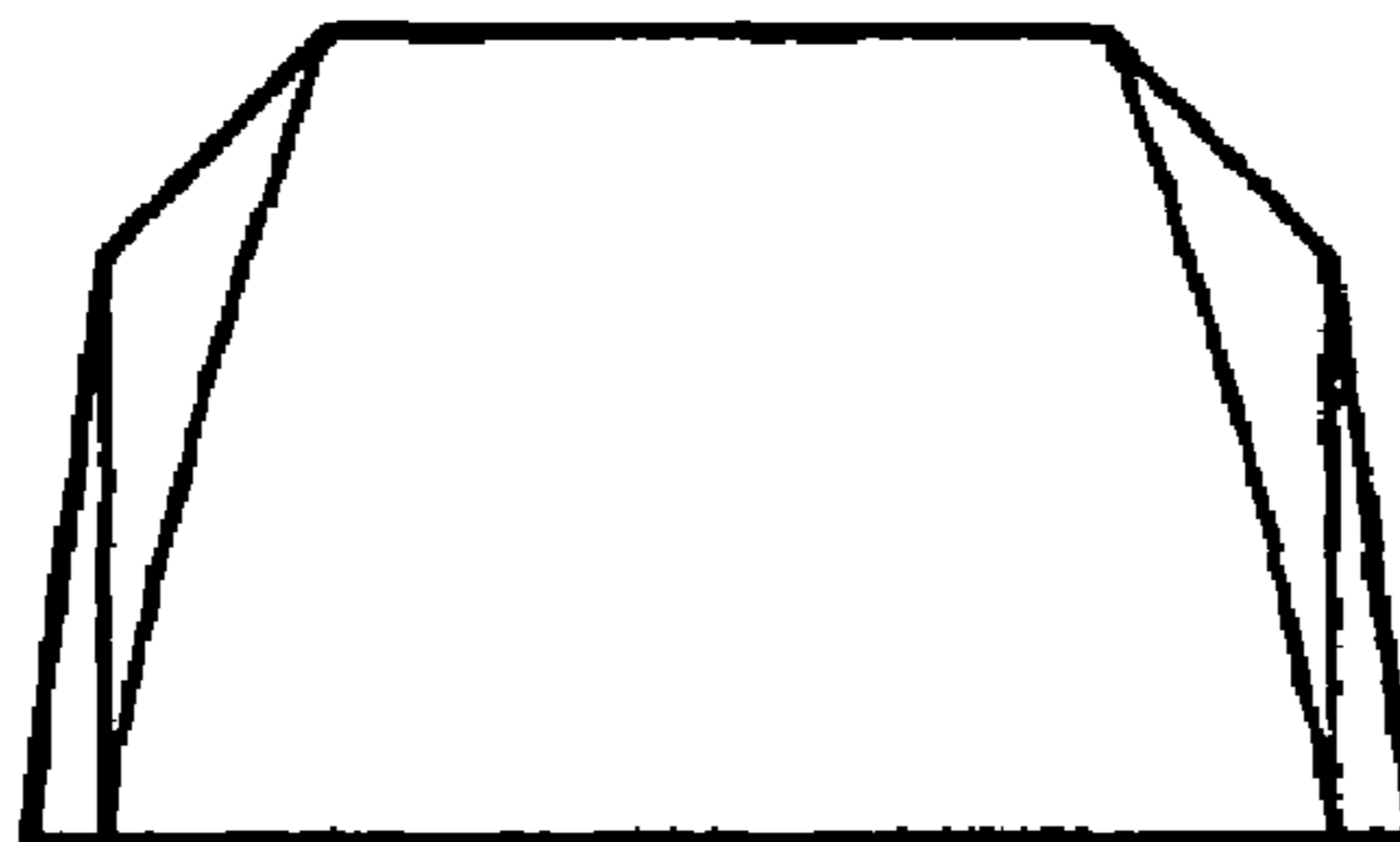
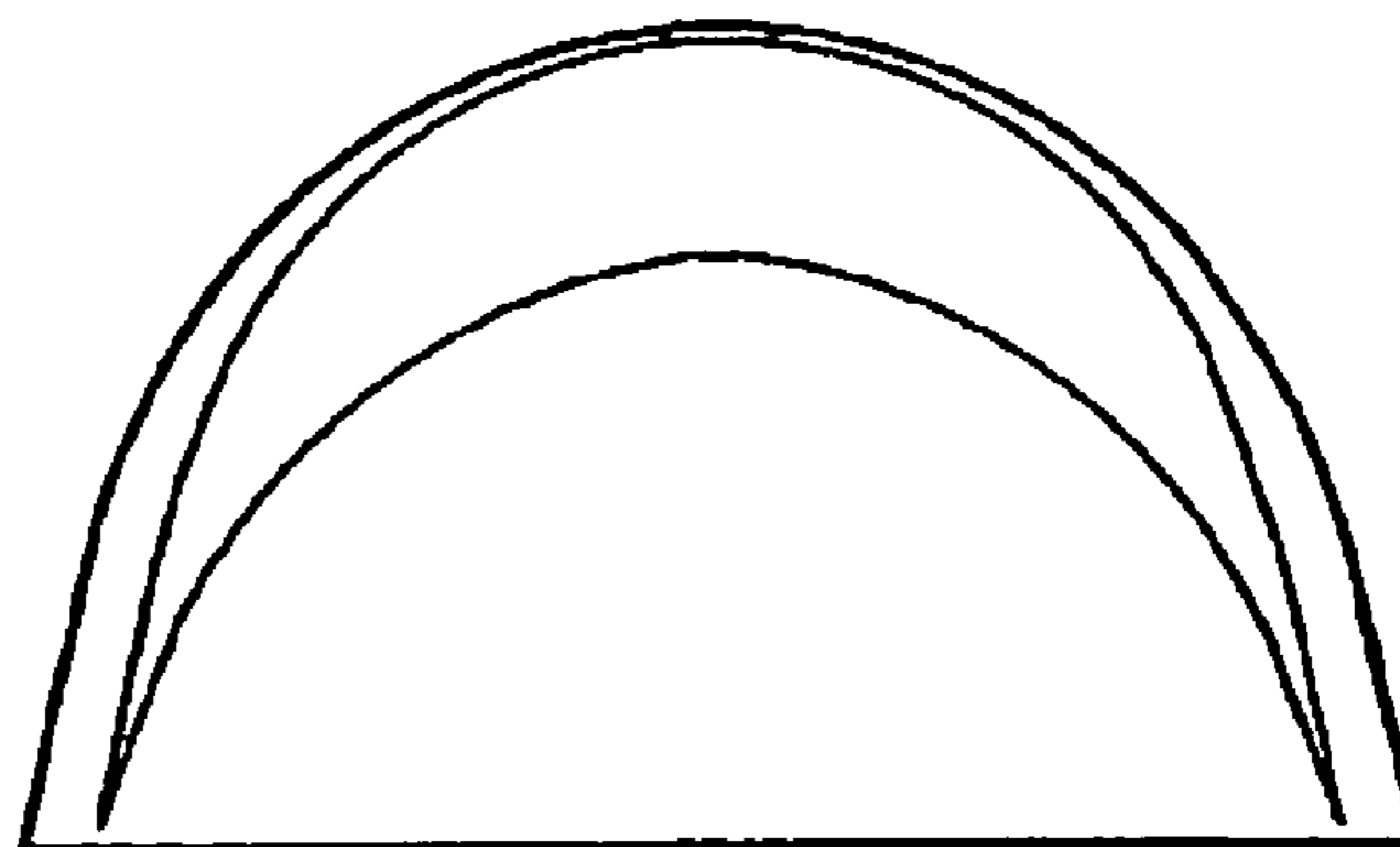
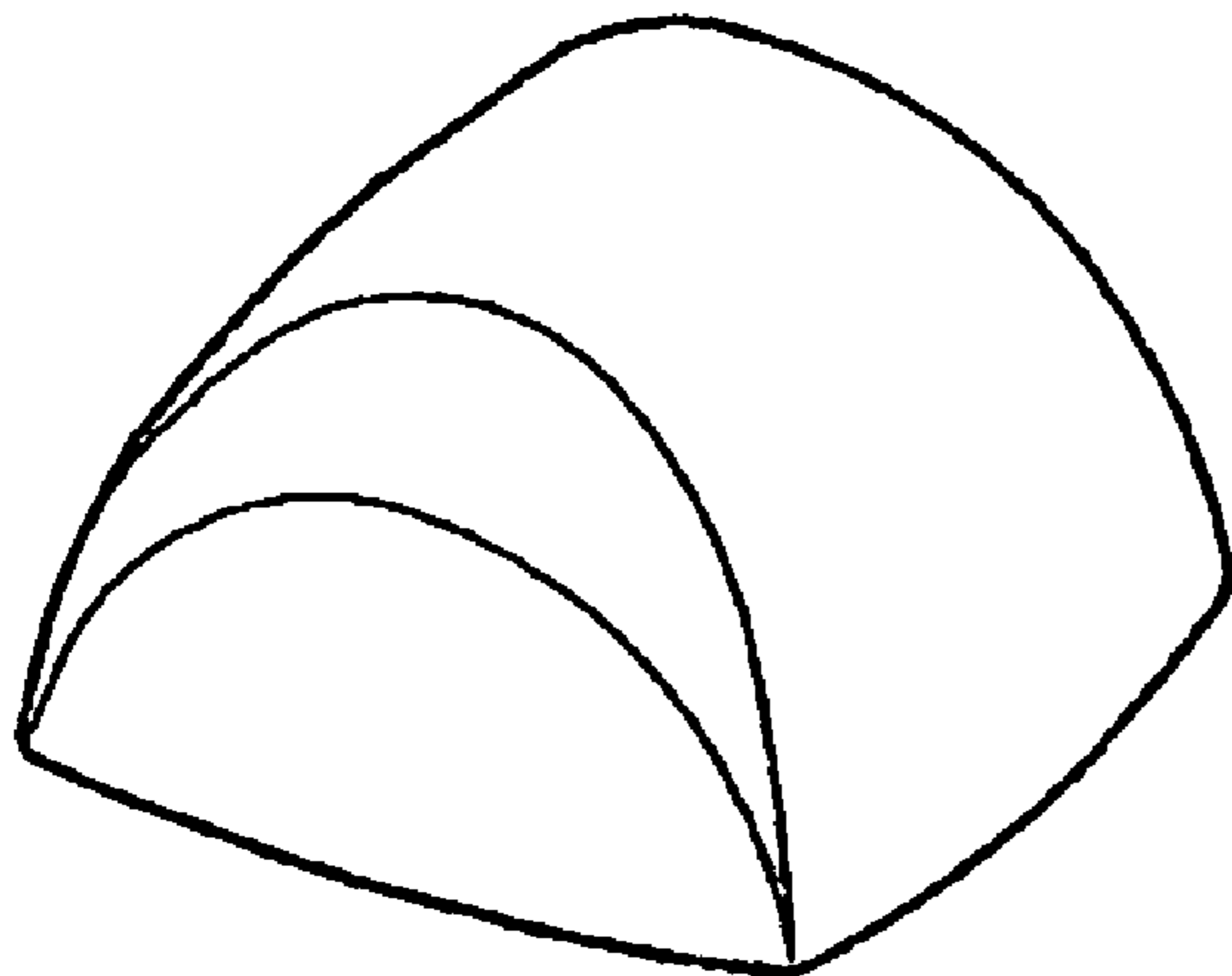
FIG. 4 is a front elevation view.

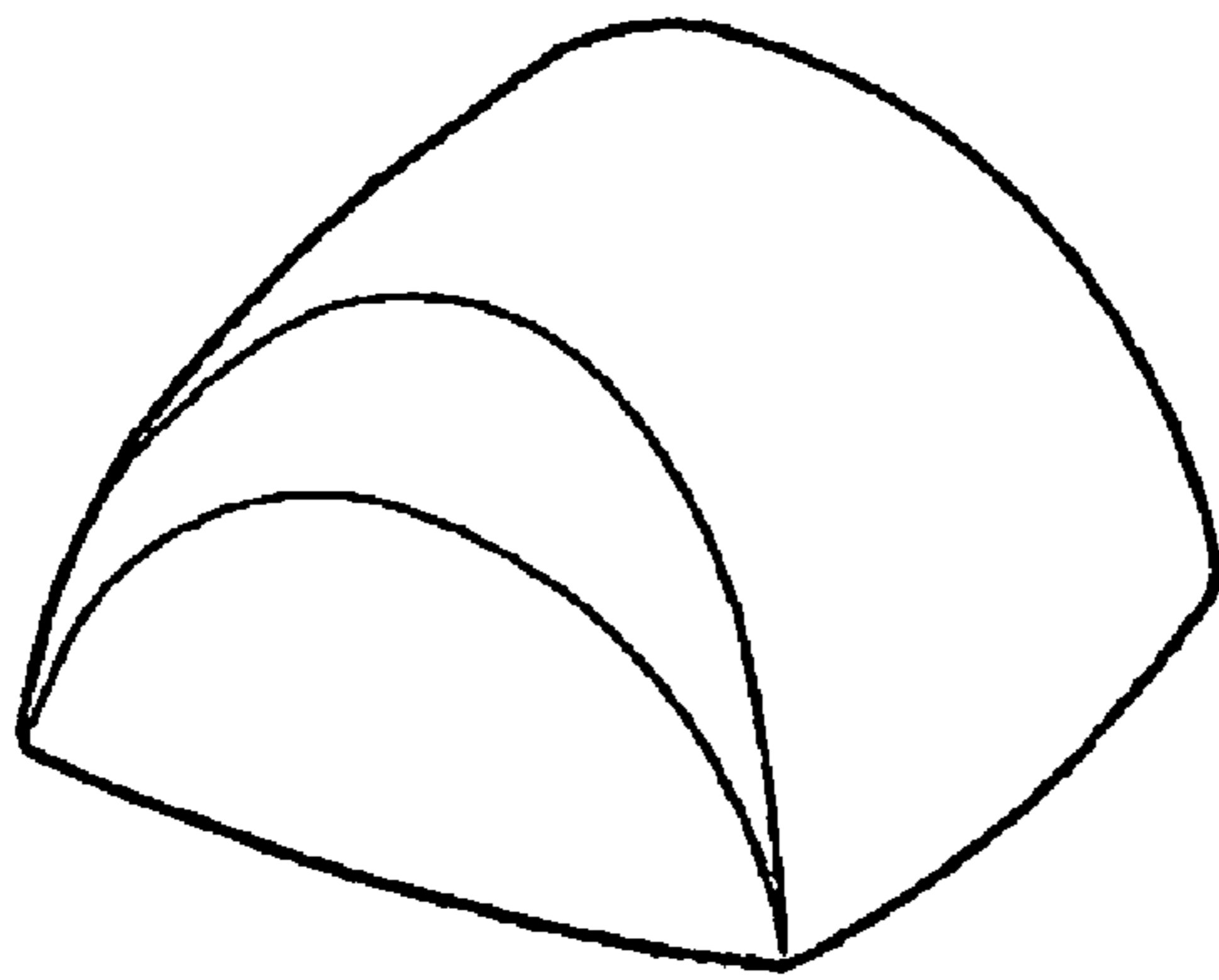

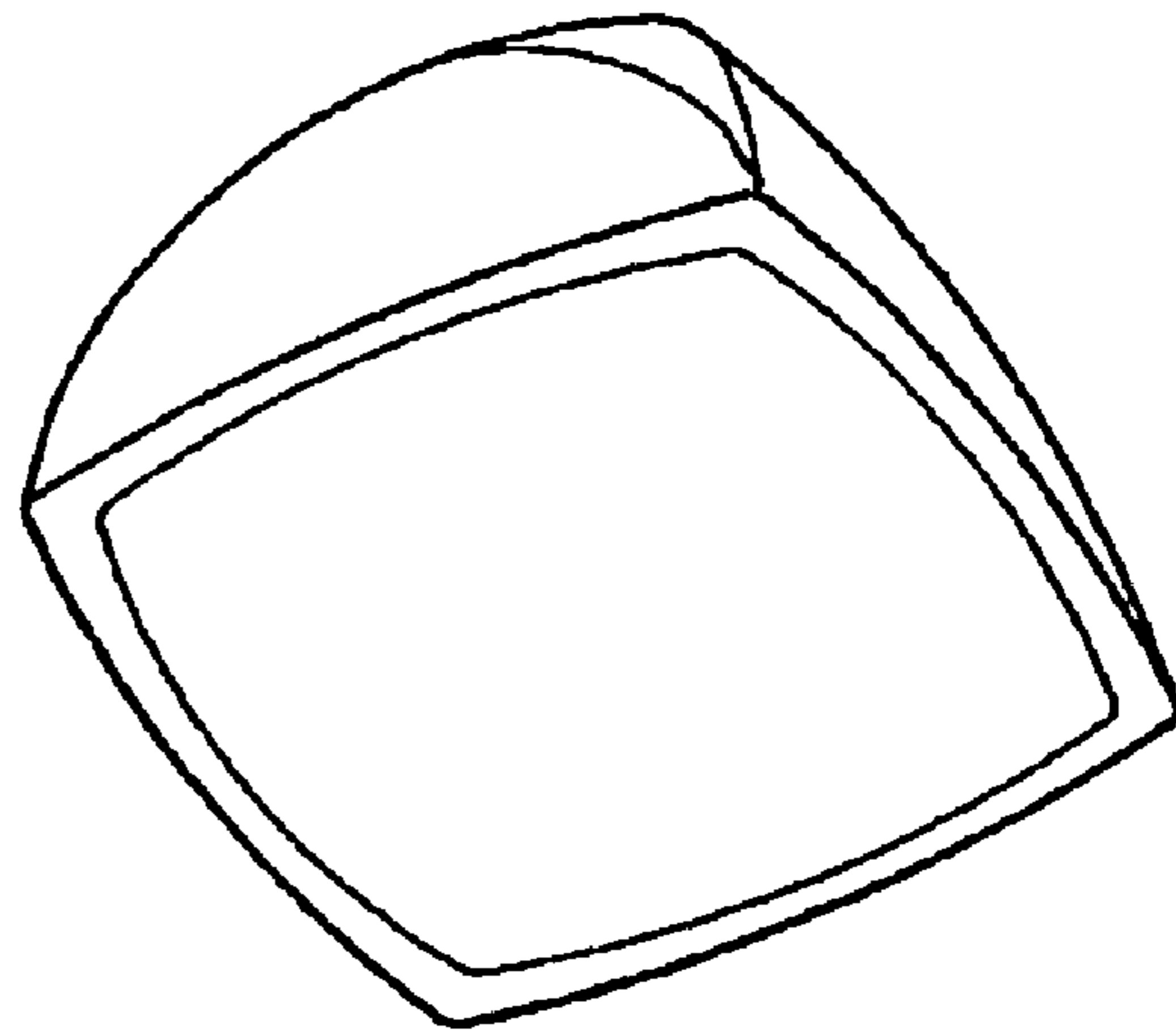

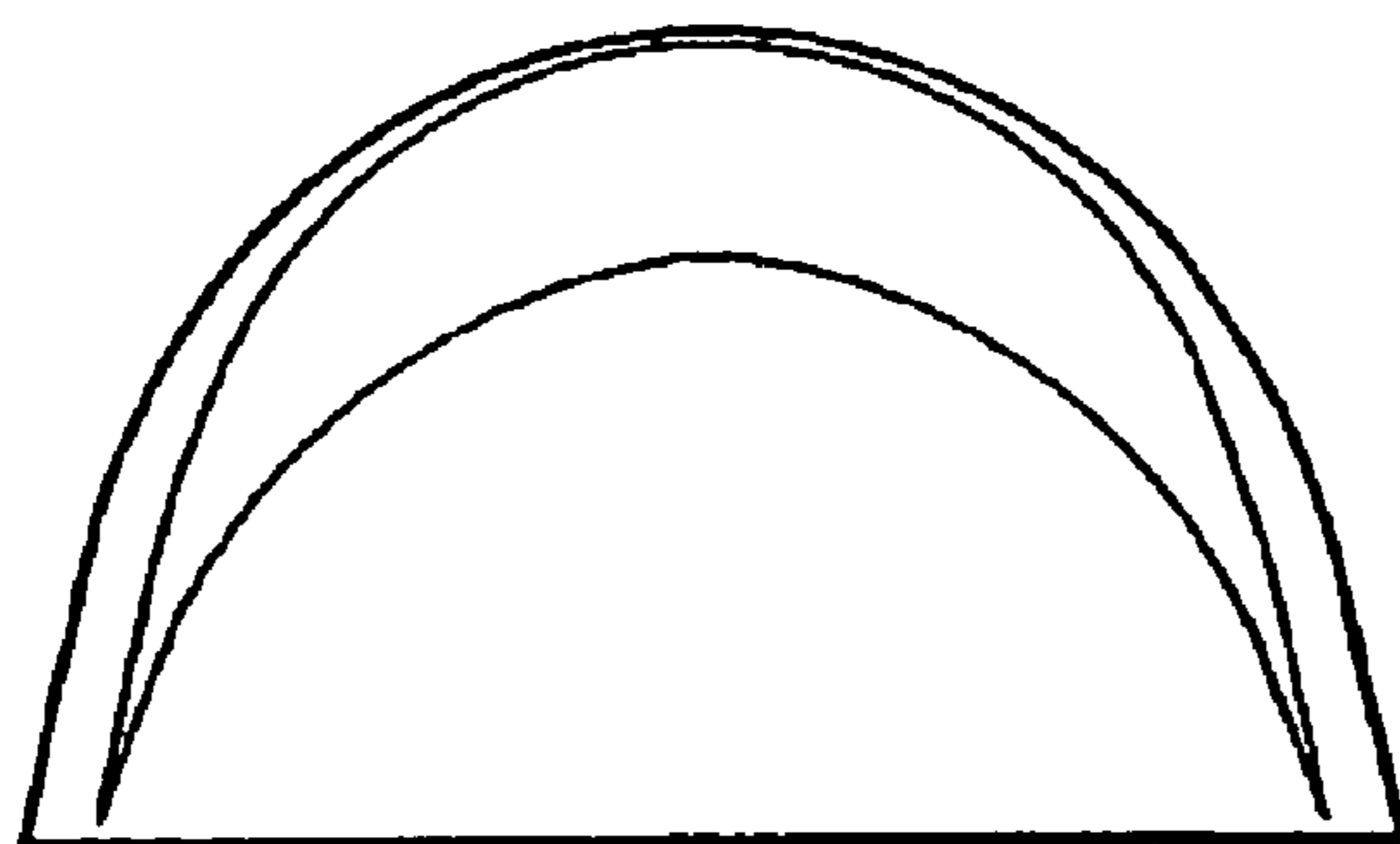

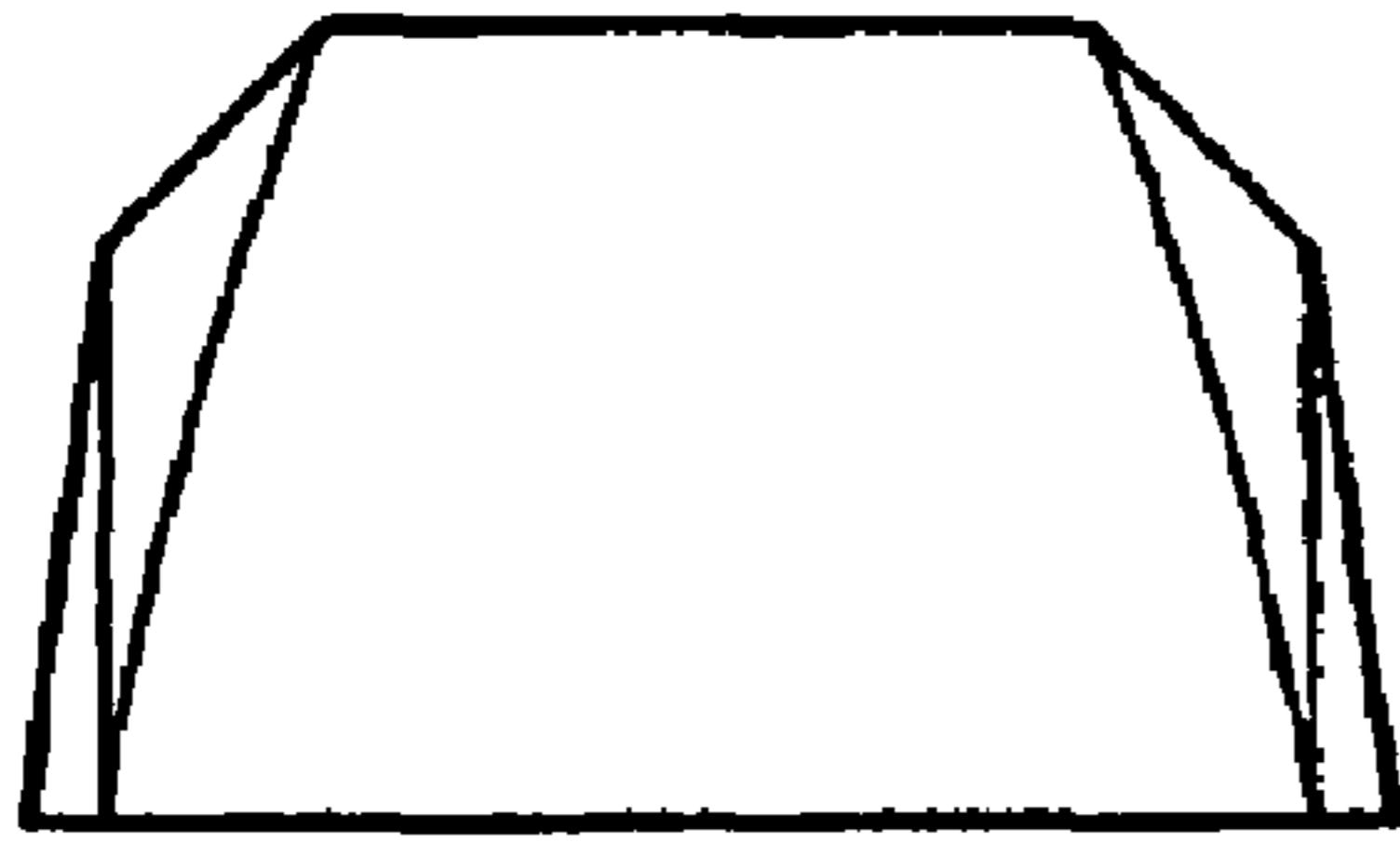

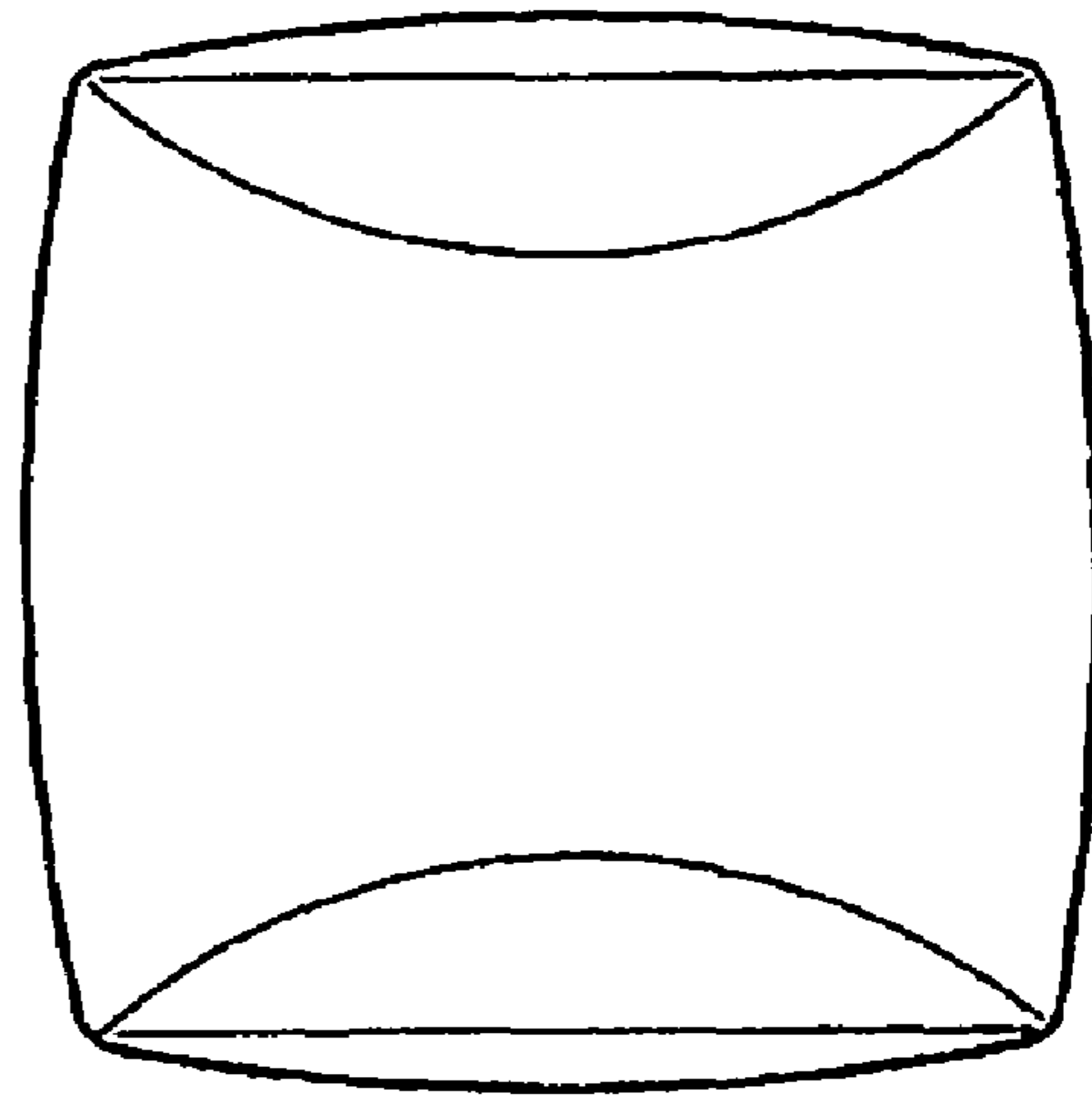

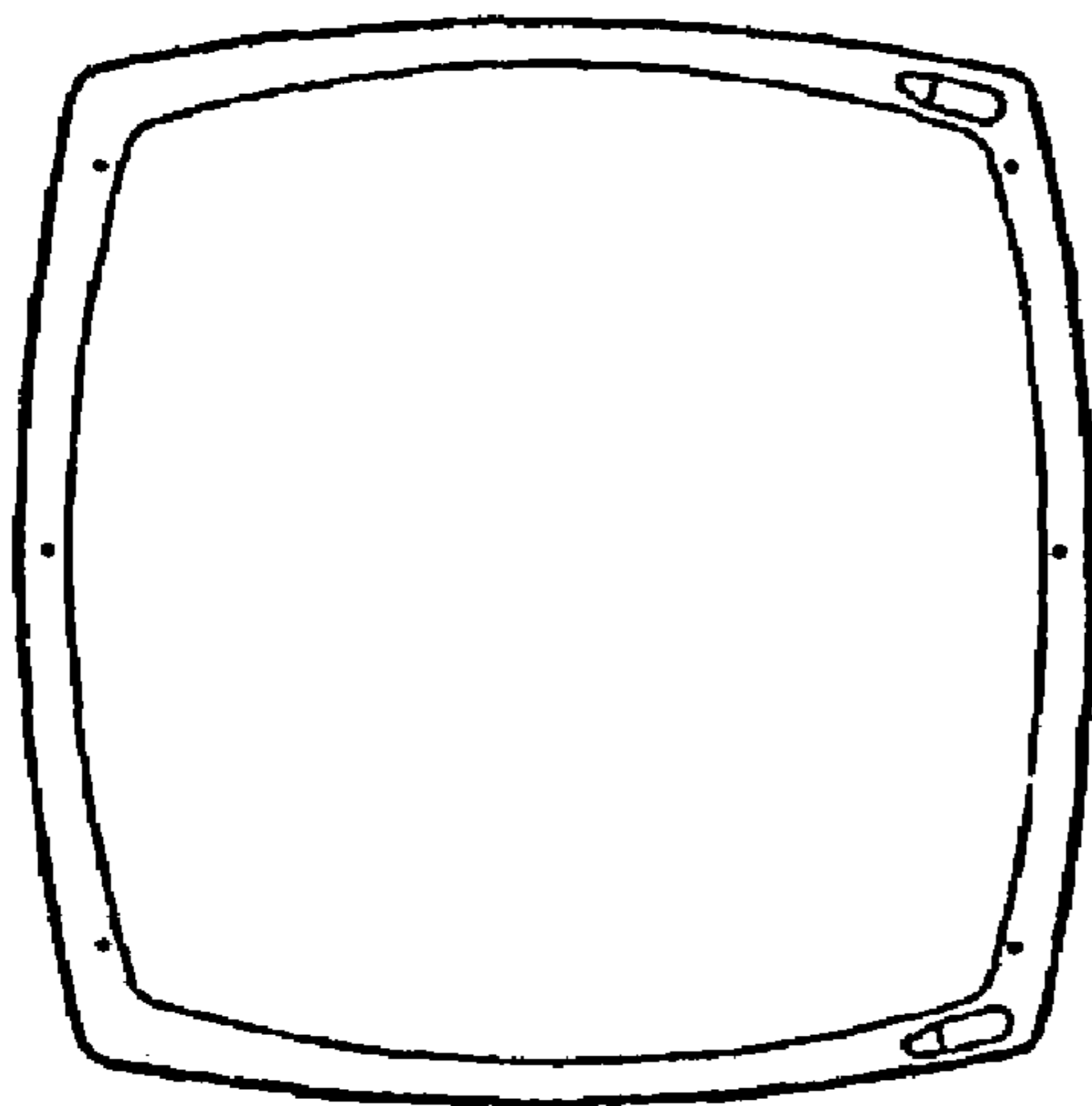
