cartridge protector;

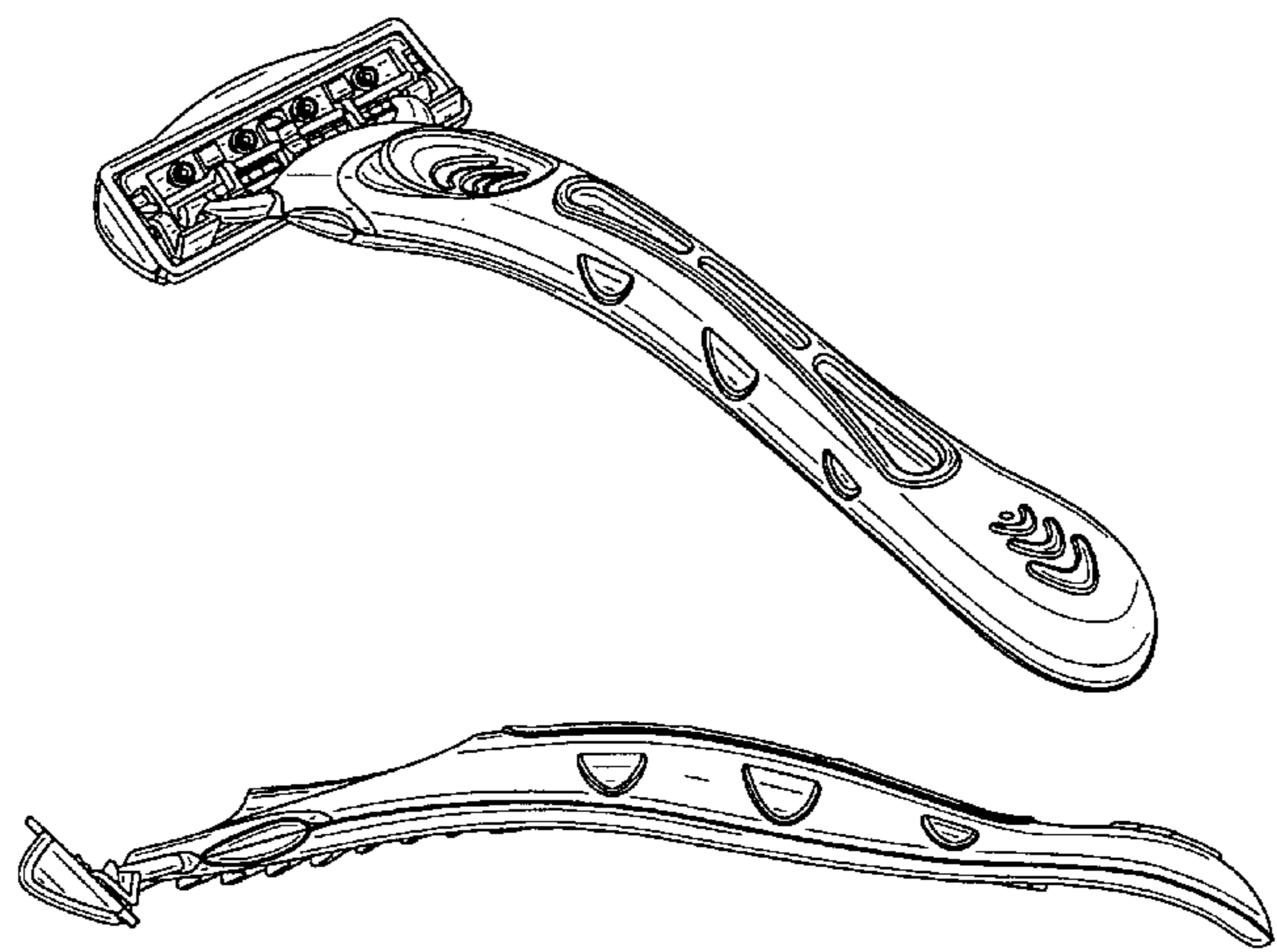
FIG. 11 is a side view of the shaving razor without the

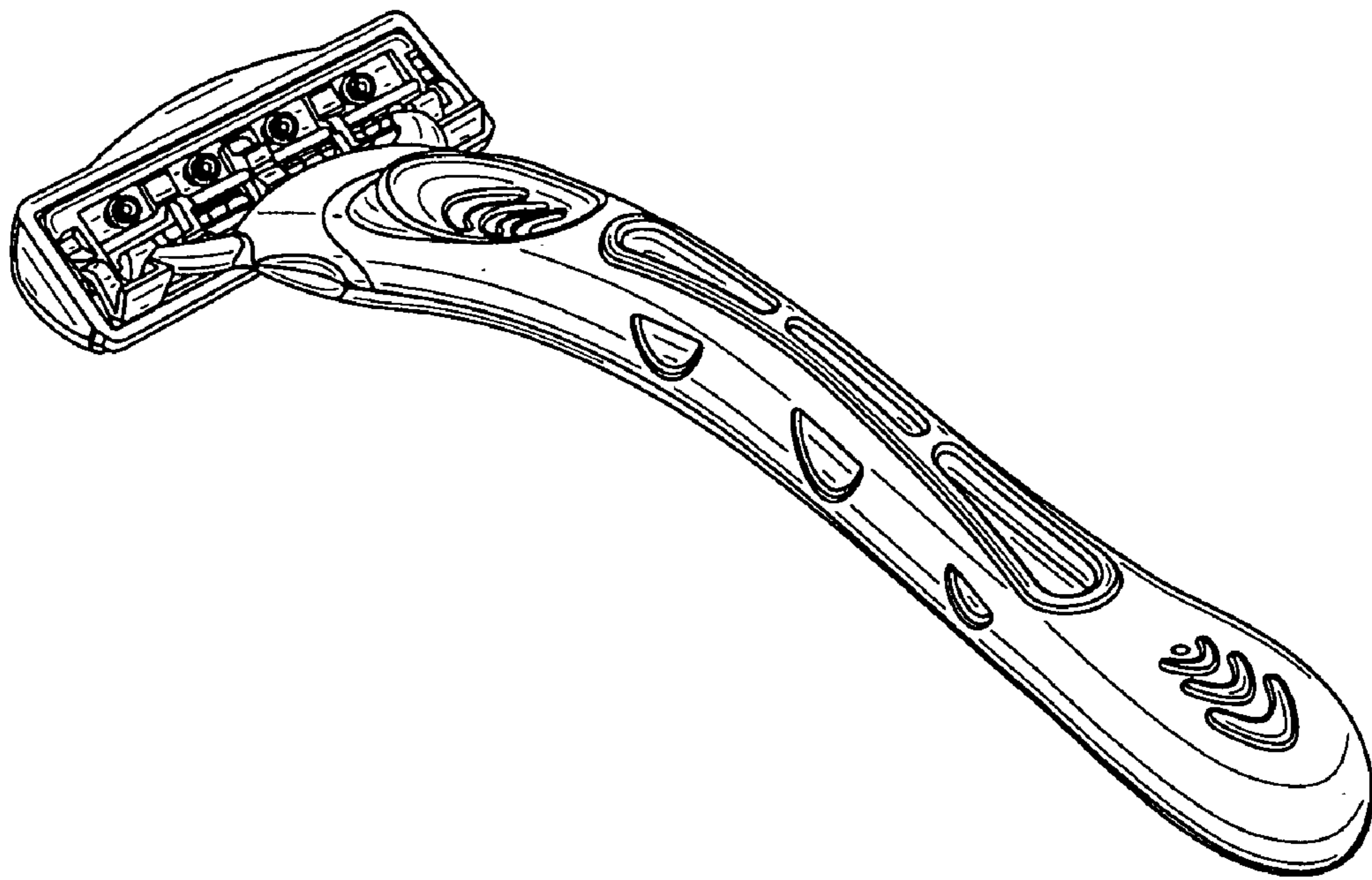

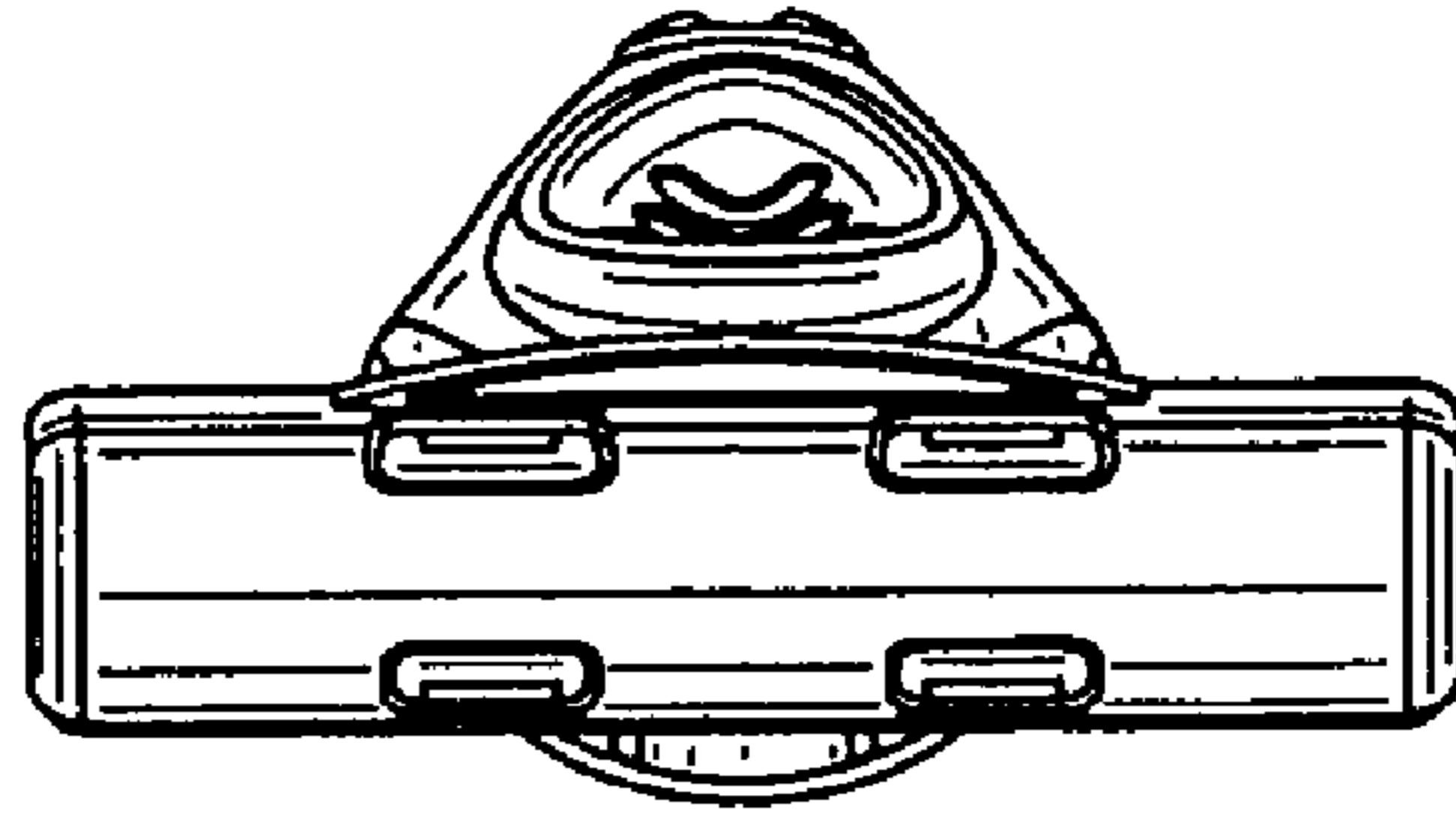

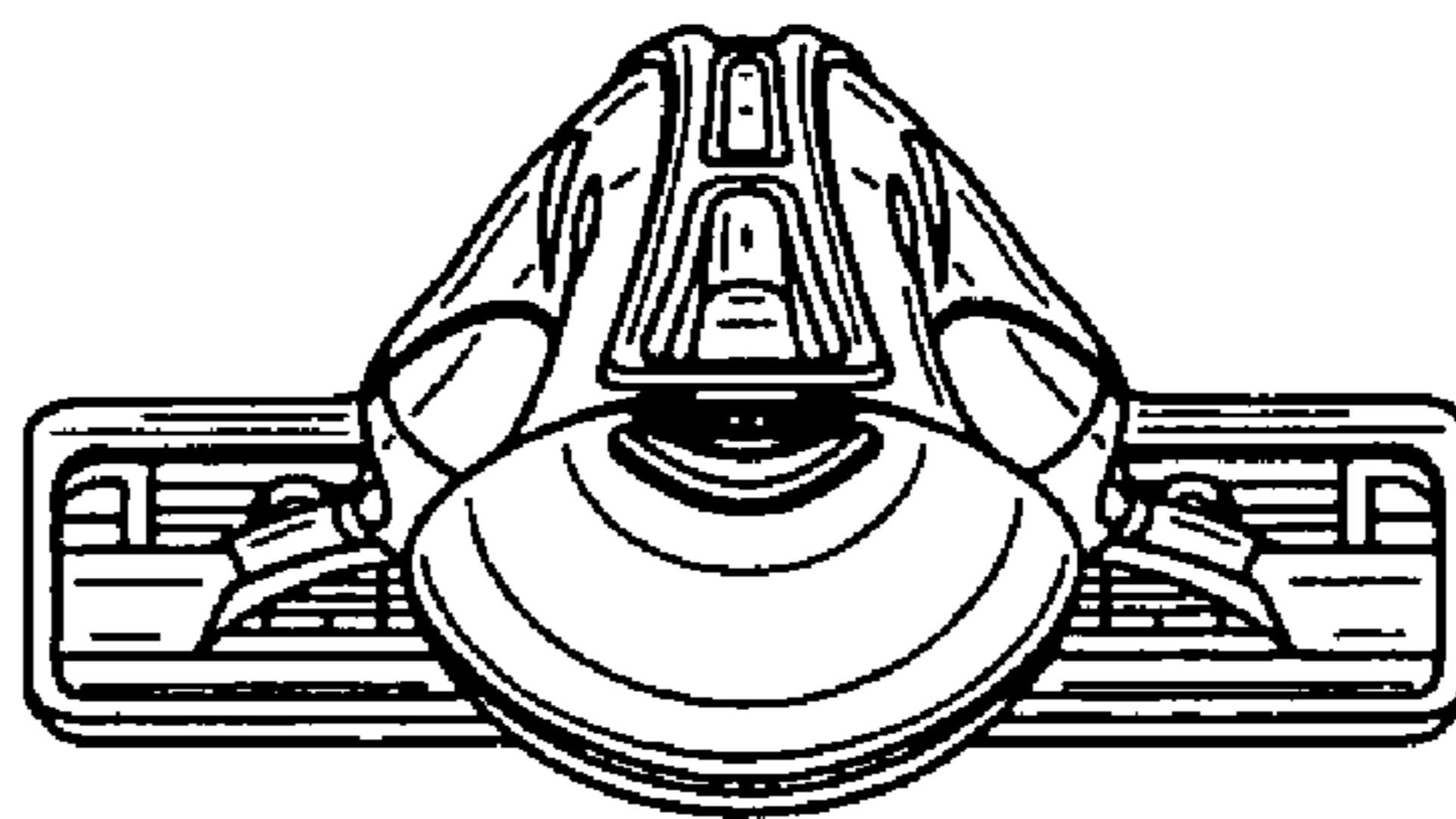

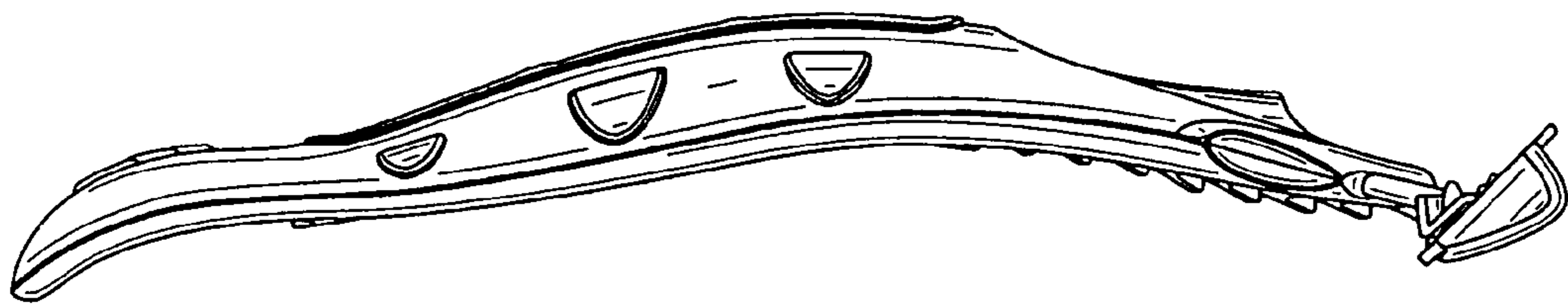

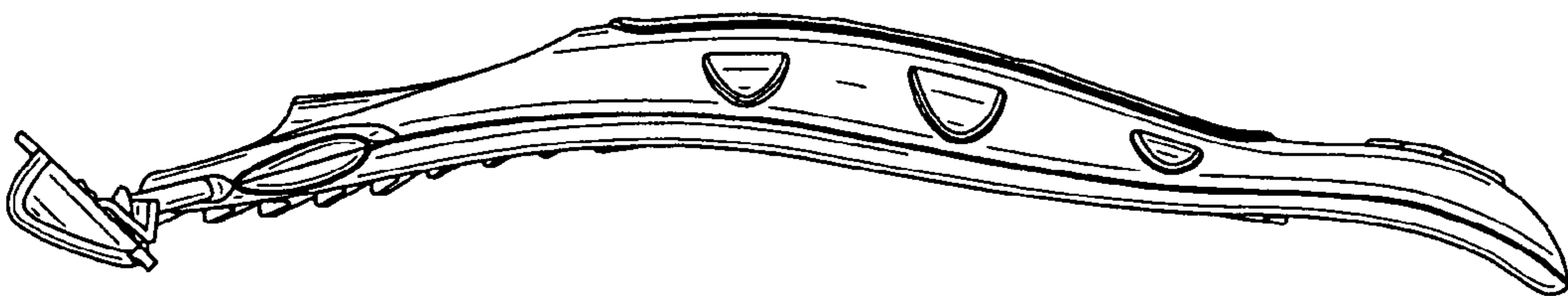

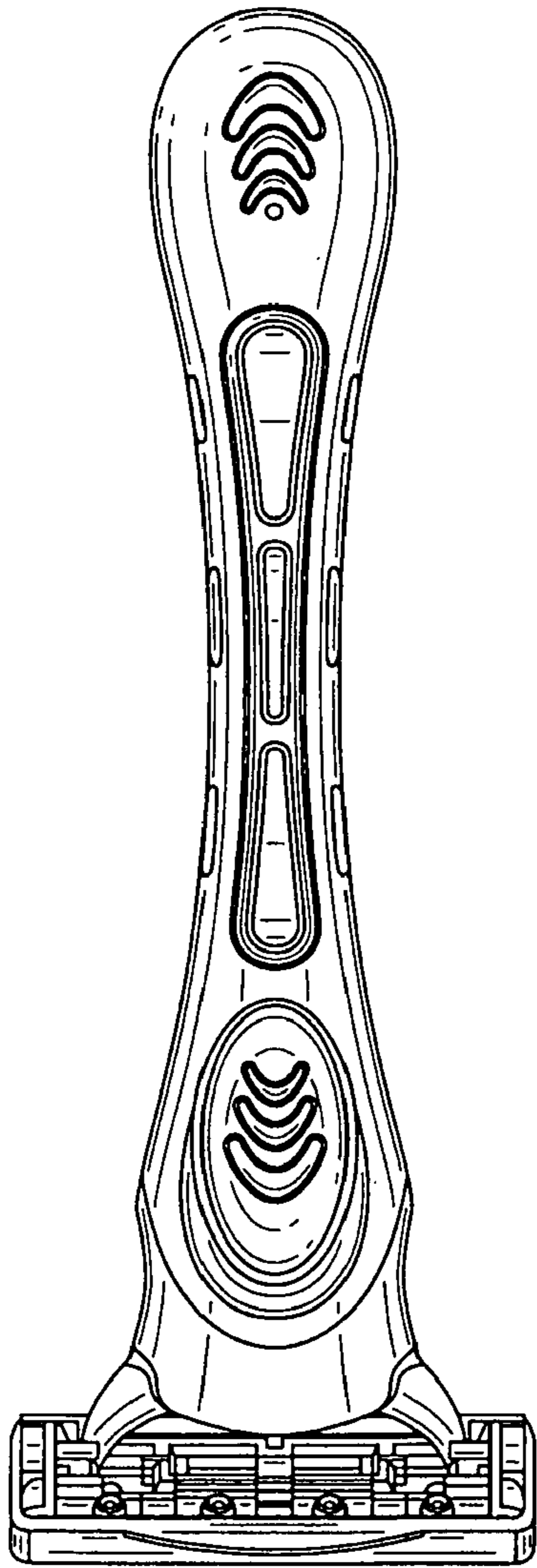

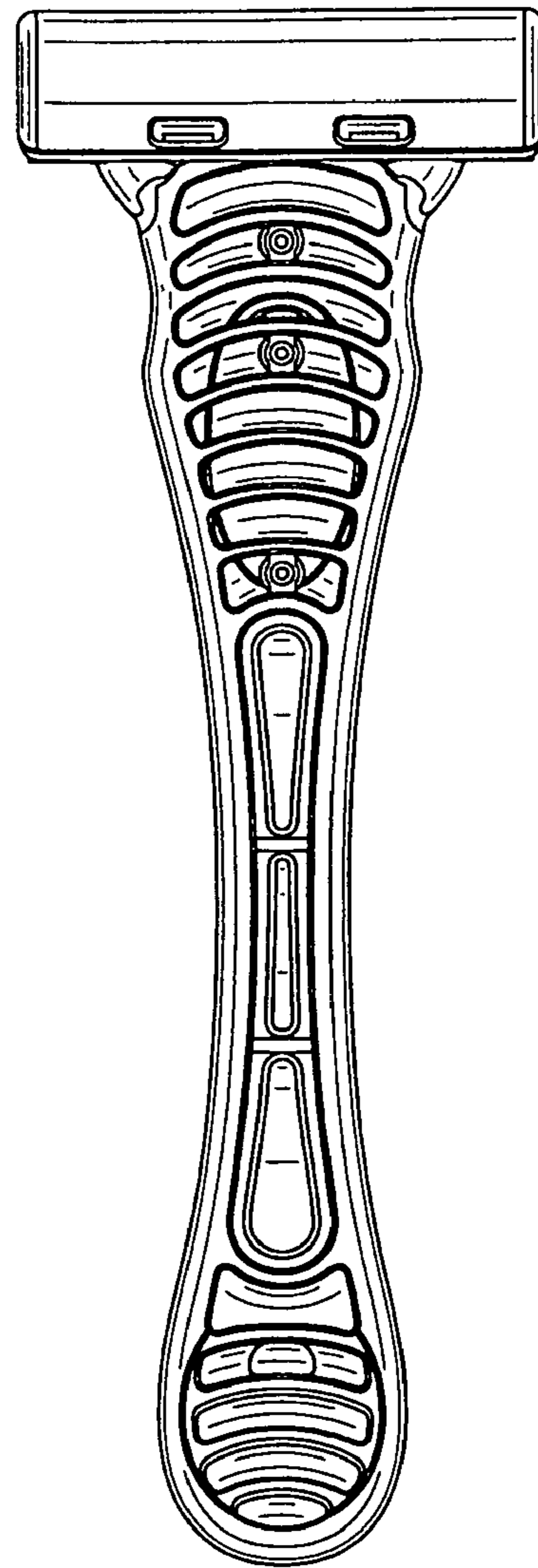

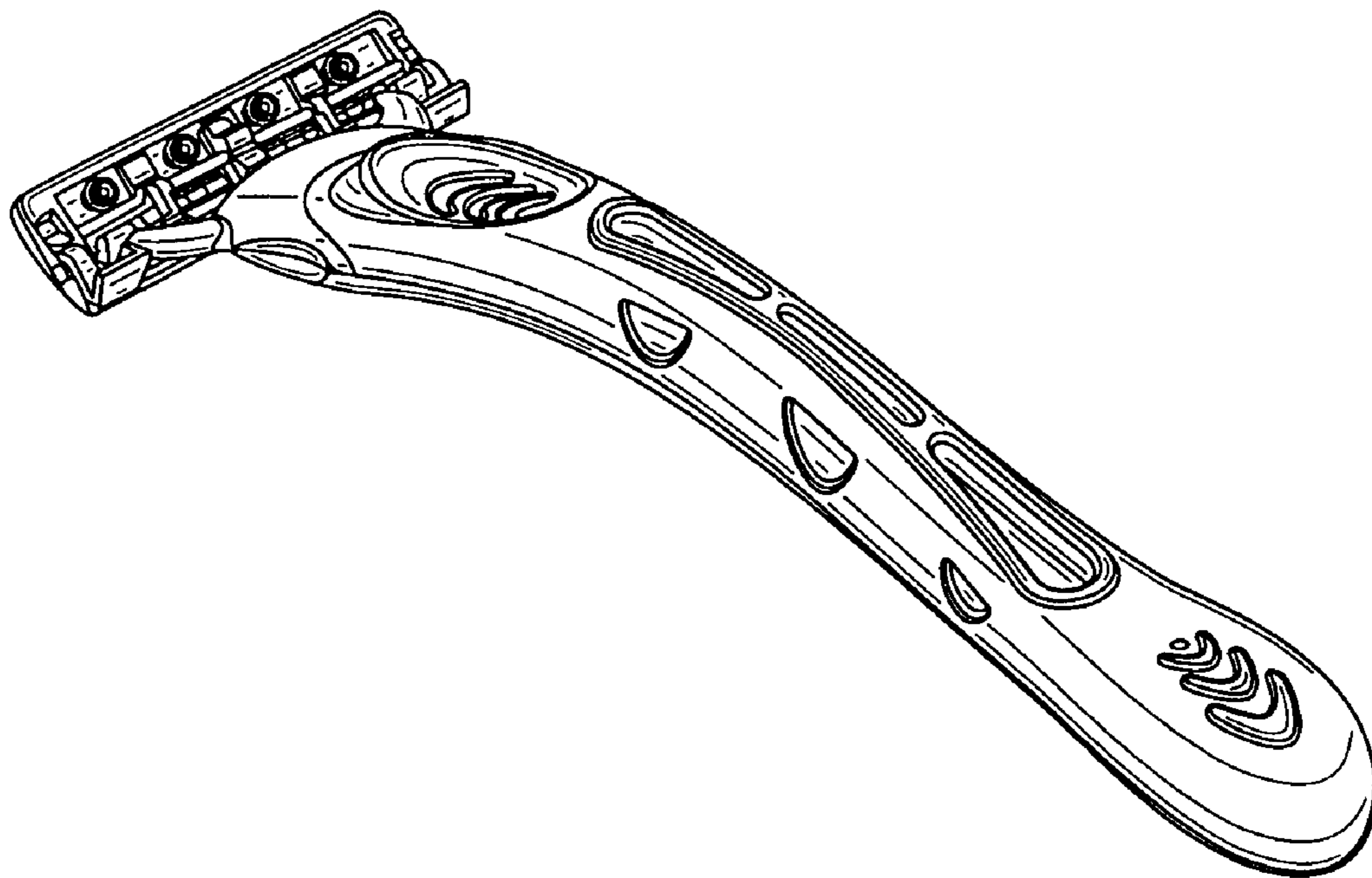

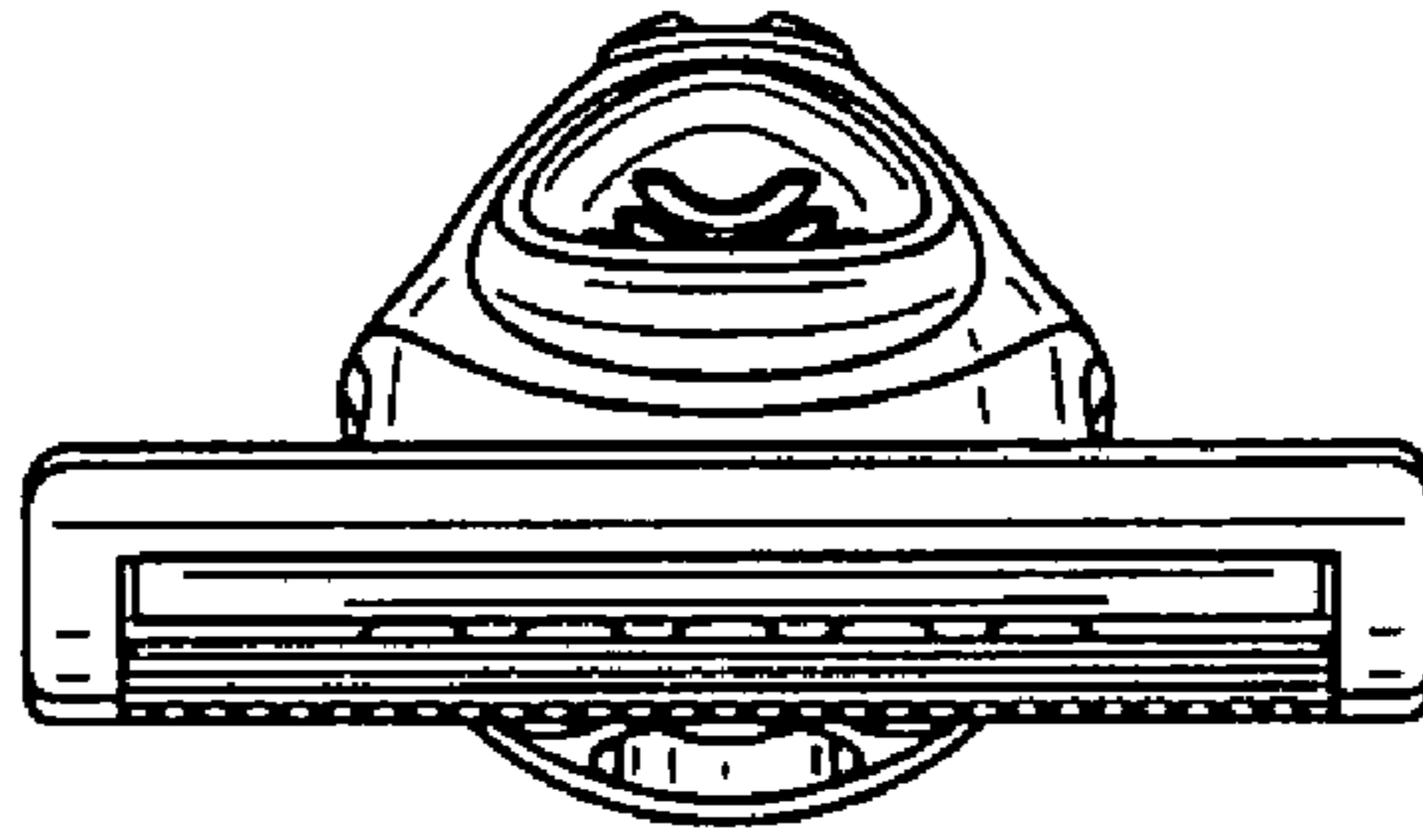

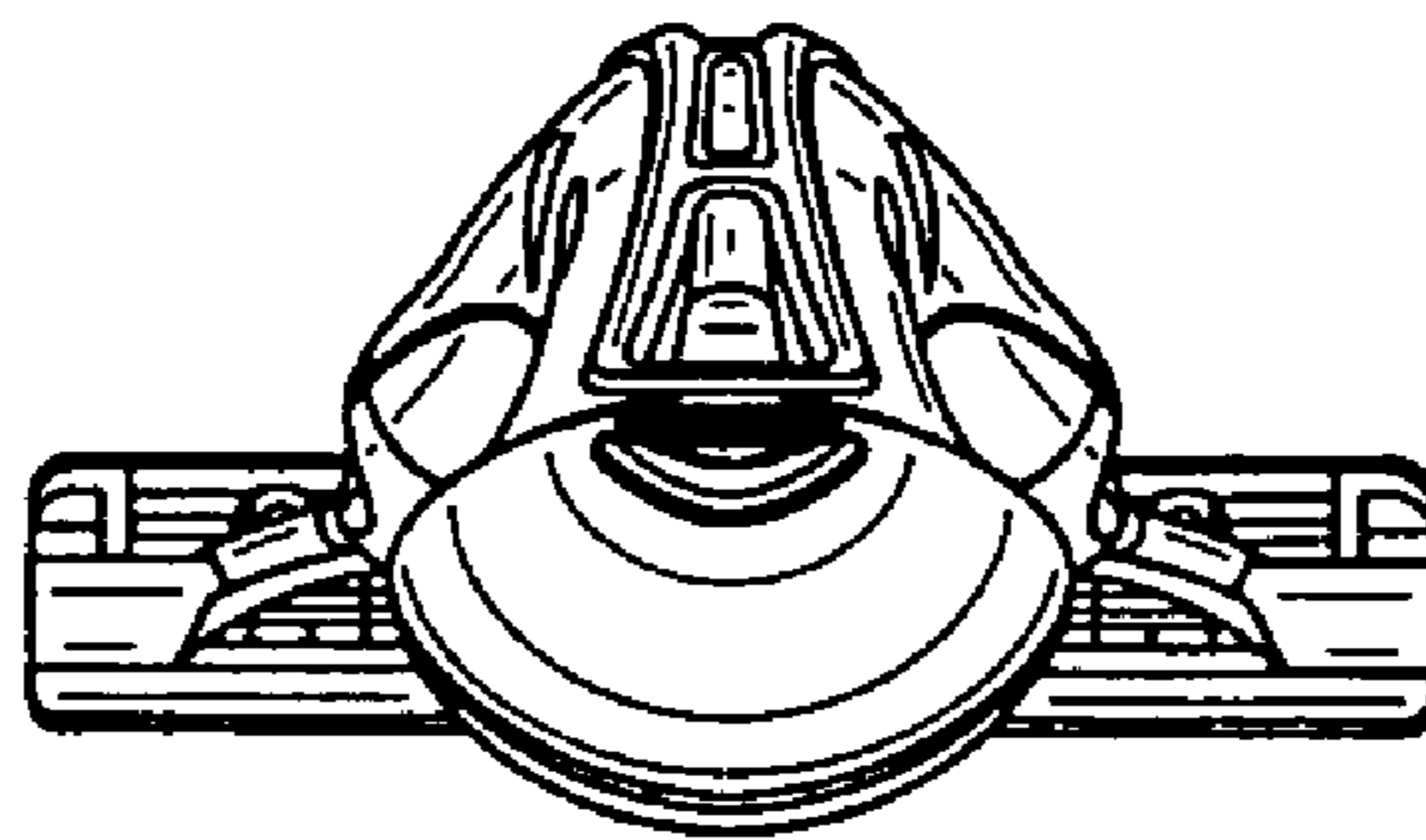

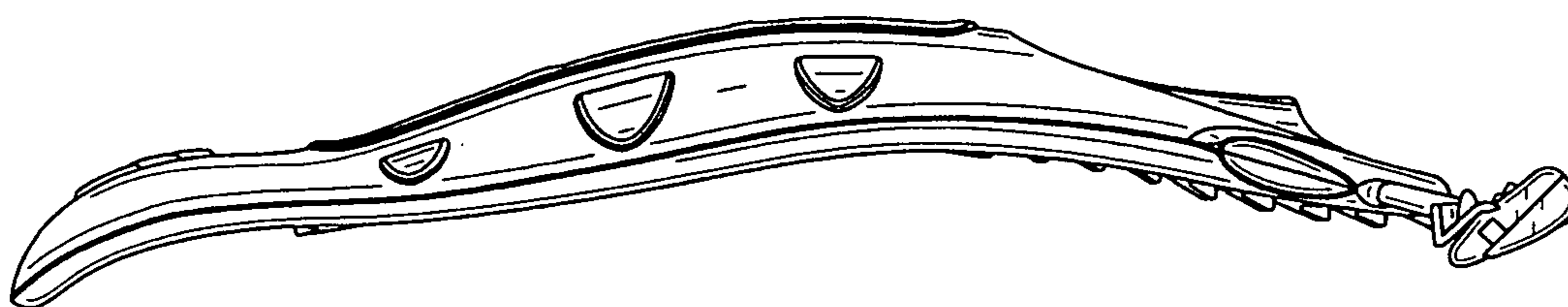

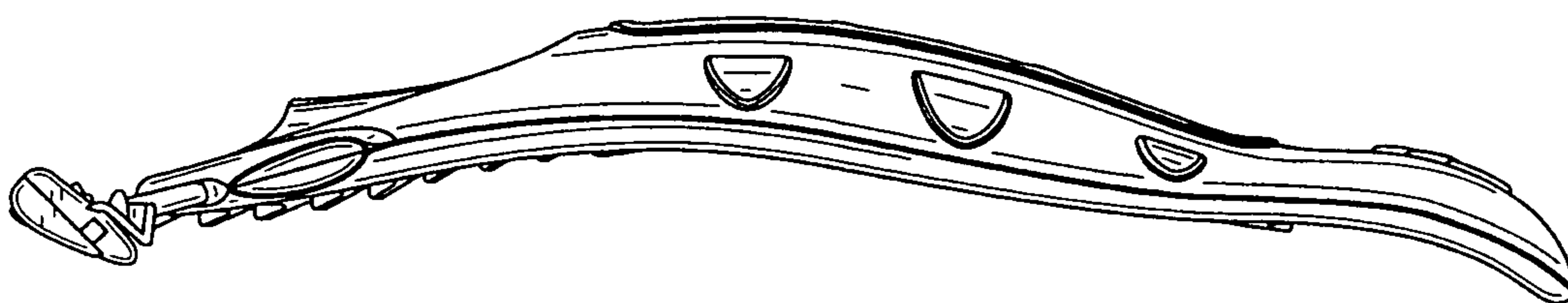

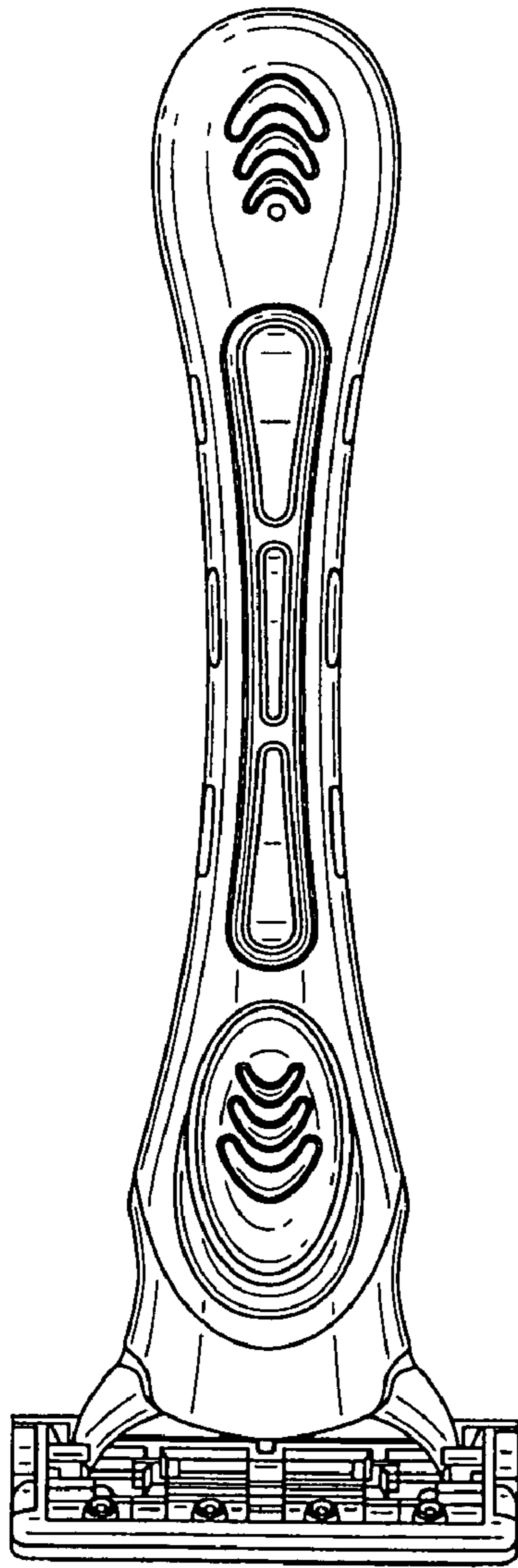

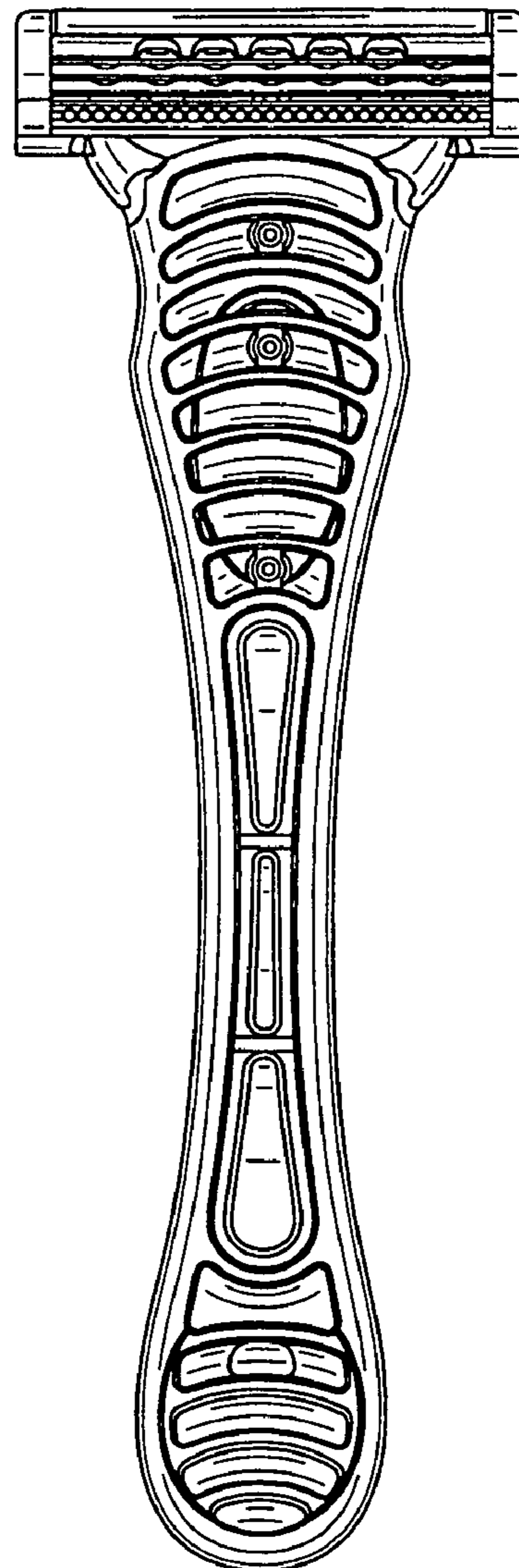
