The ornamental design for a canine comfort station, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the canine comfort station.
FIG. 2 is a front view of the canine comfort station.
FIG. 3 is a back view of the canine comfort station.
FIG. 4 is a side view of the canine comfort station, the opposite side view being a mirror image;
FIG. 5 is a top view of the canine comfort station; and,
FIG. 6 is a bottom view of the canine comfort station.

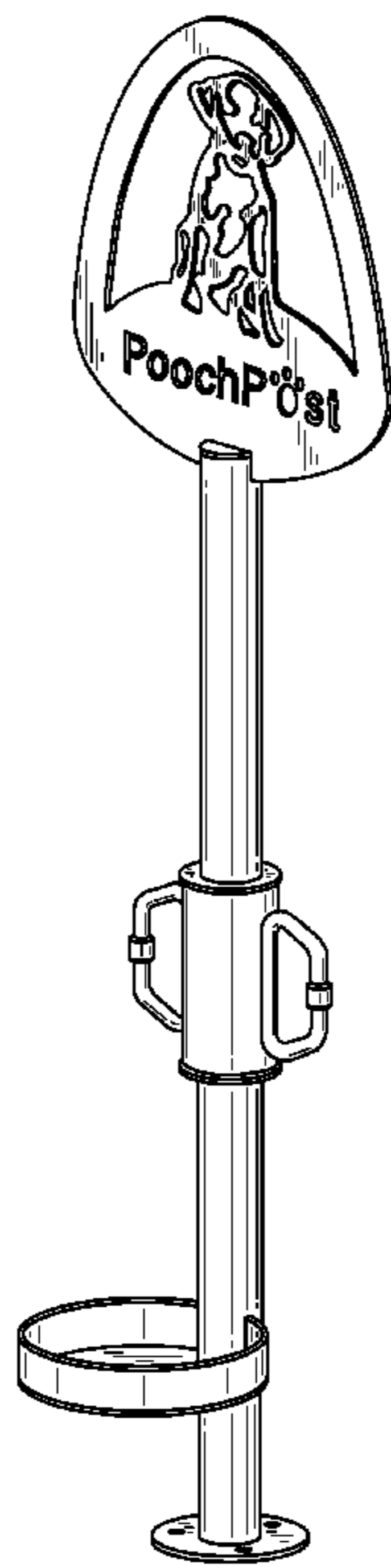

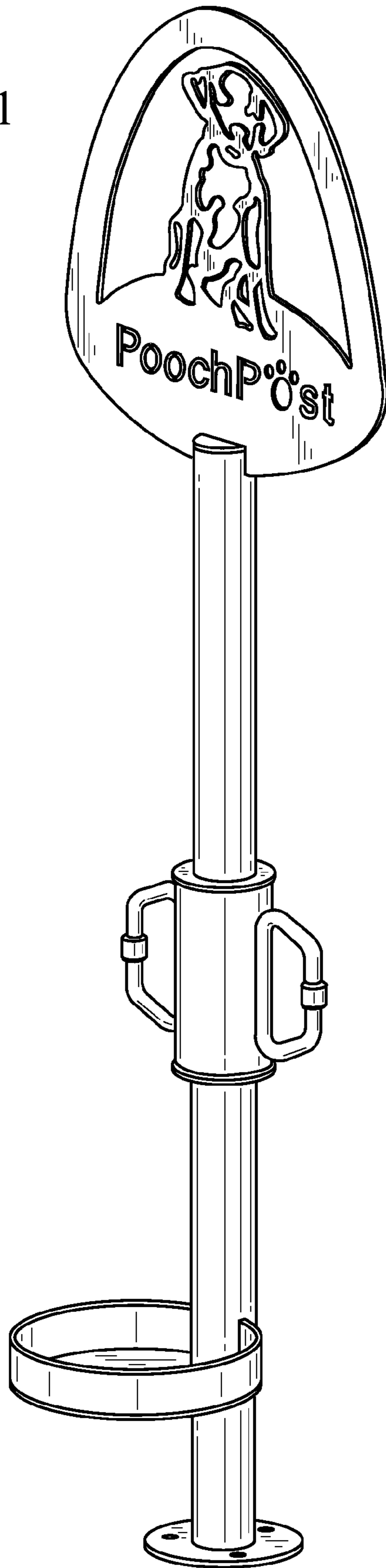

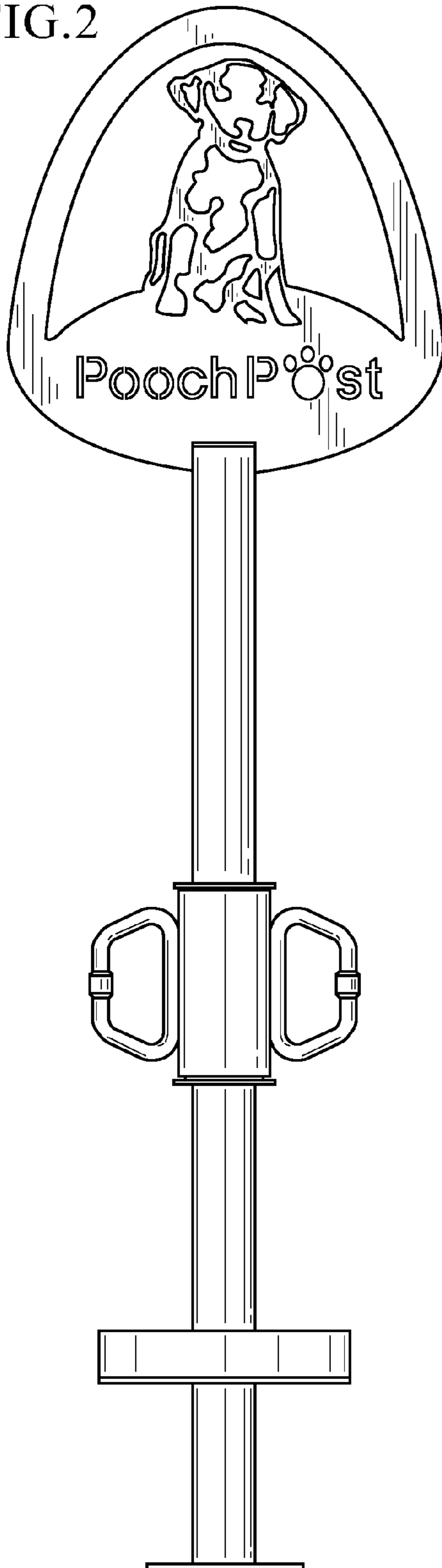

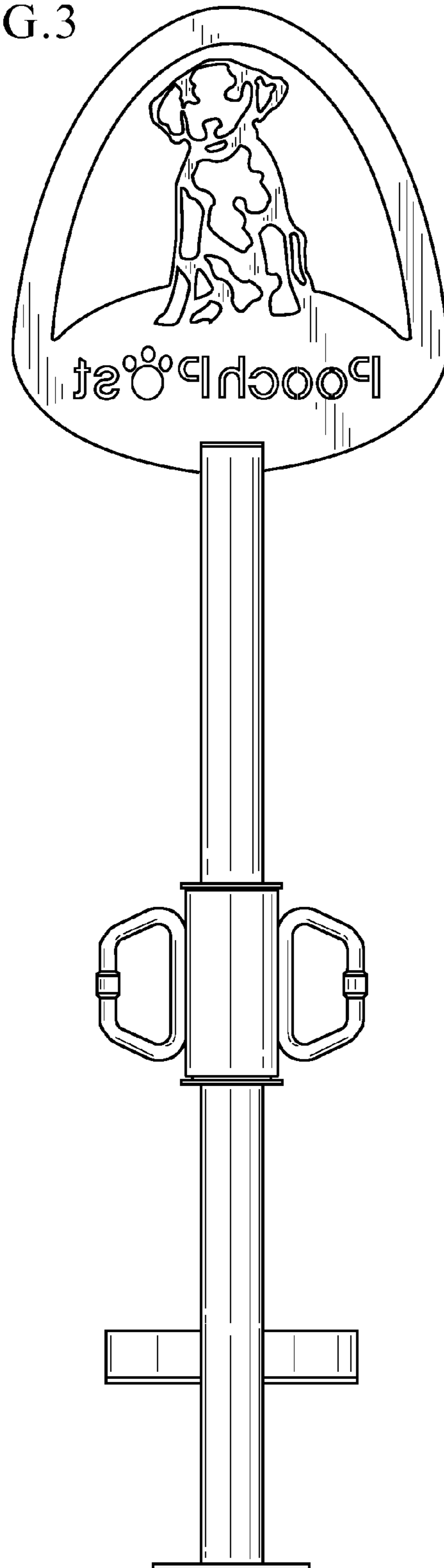

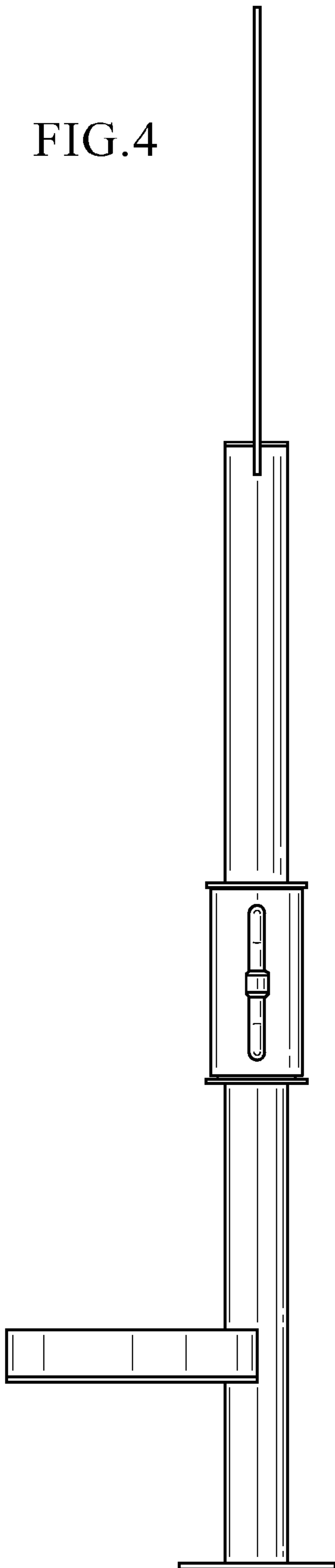

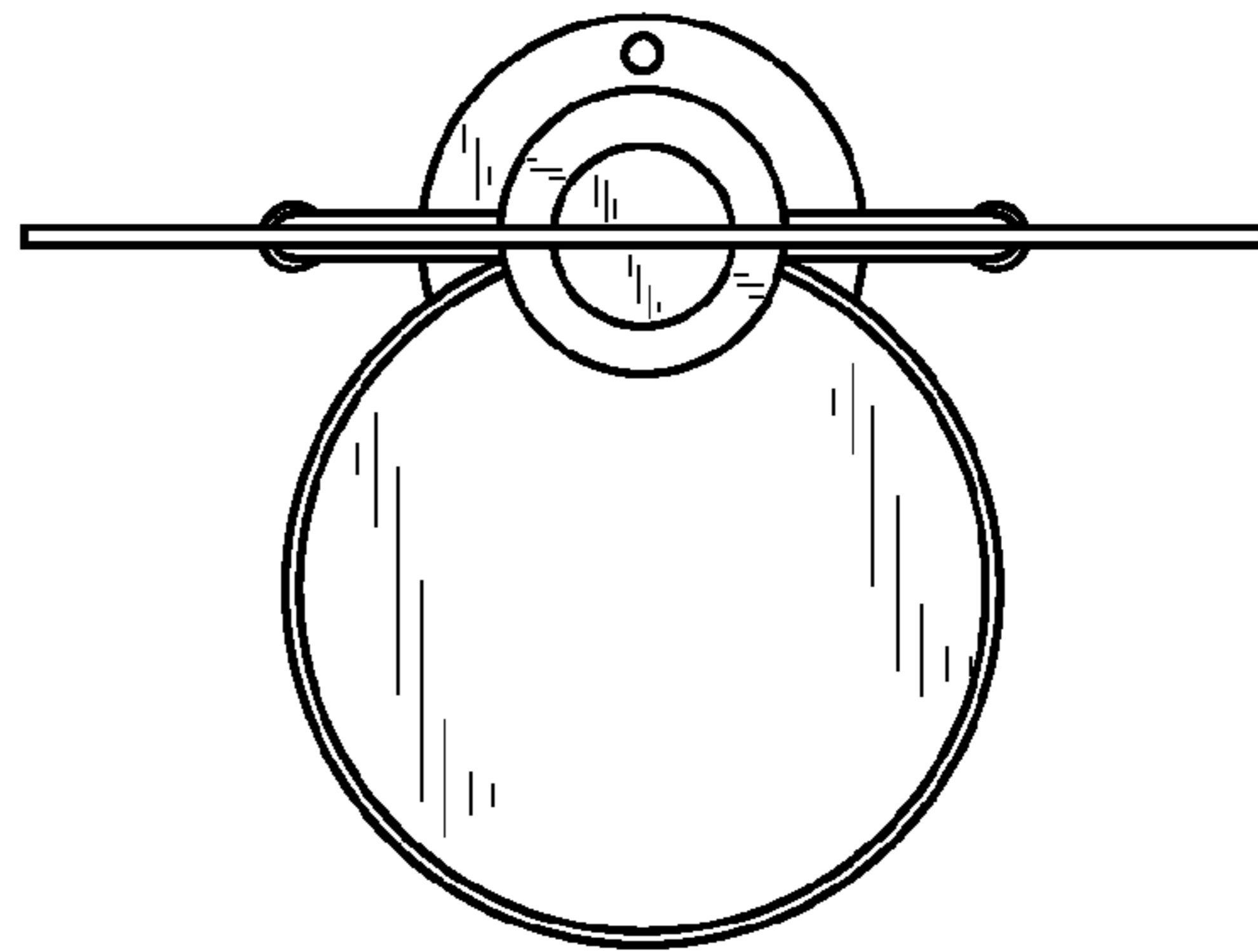
