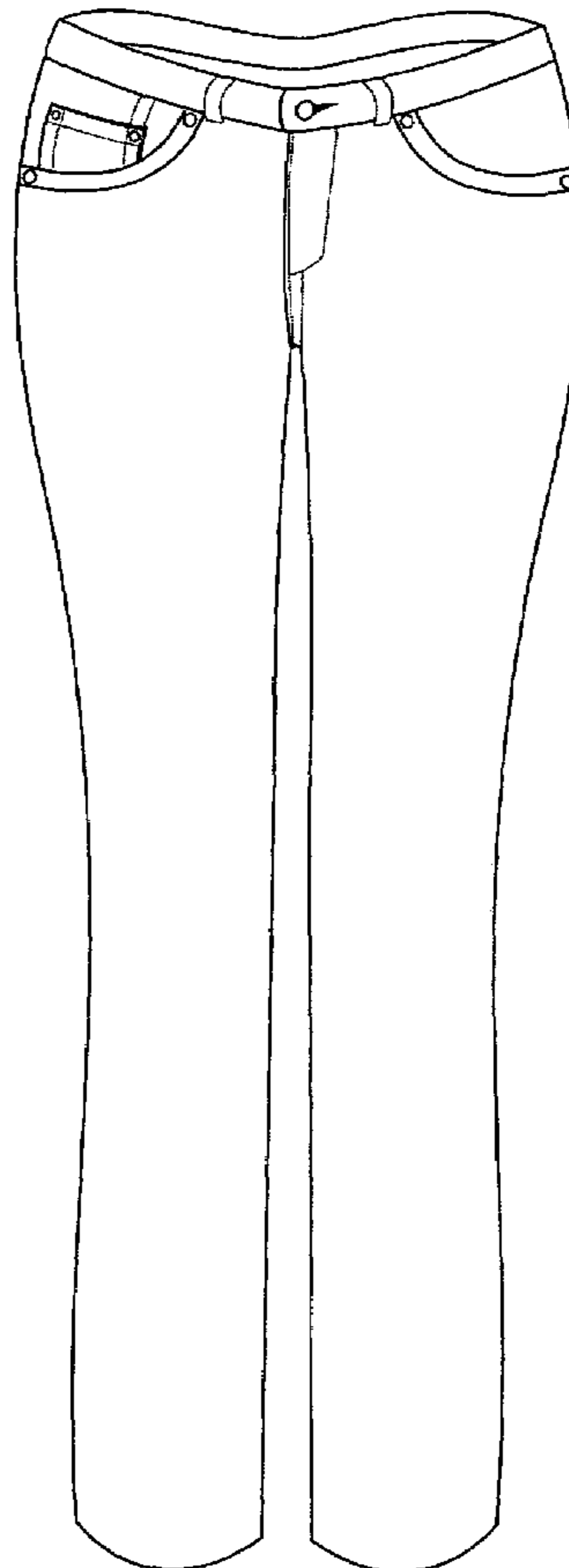
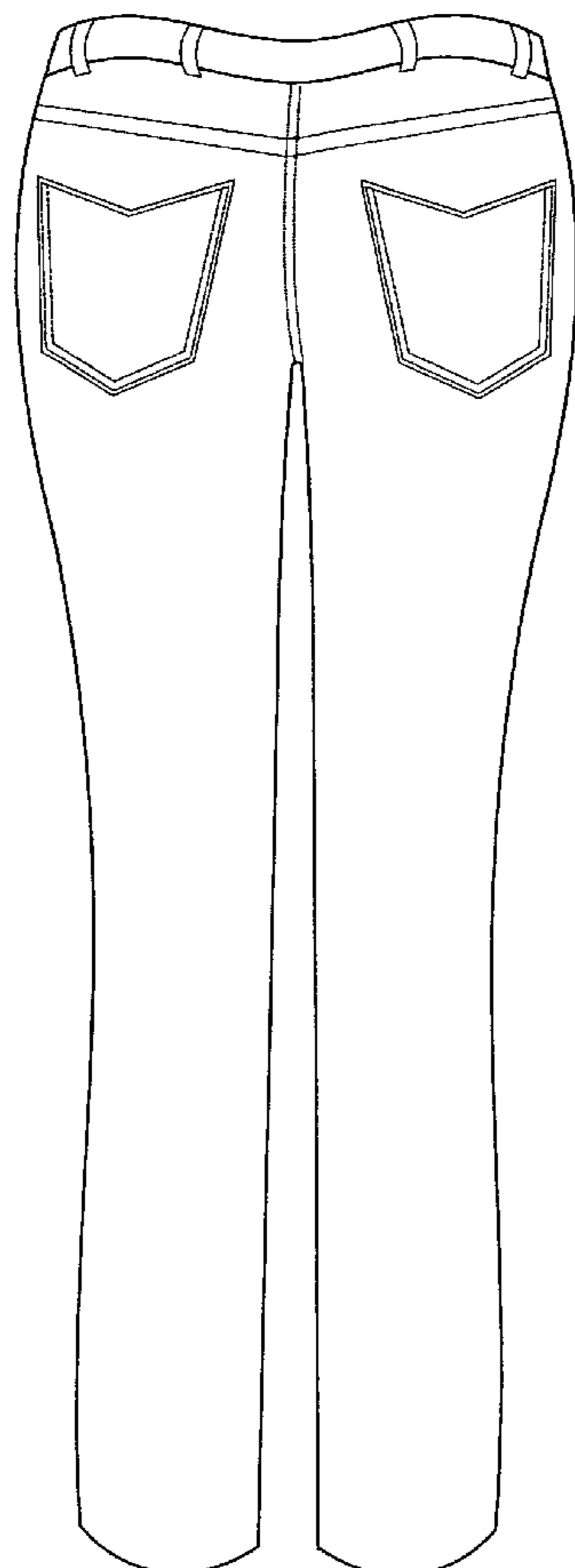
The ornamental design for pants with contoured waistband, as shown and described.

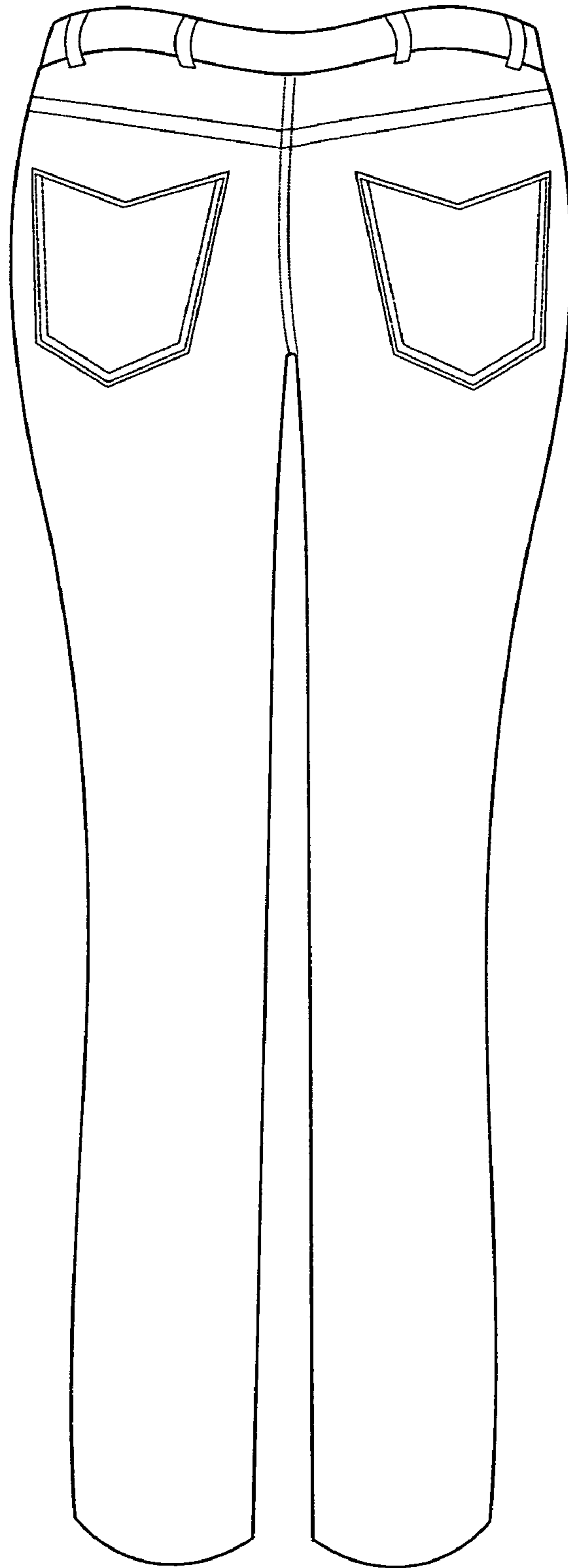
**DESCRIPTION**

FIG. 1 is a rear view of the jeans showing my new design; and,

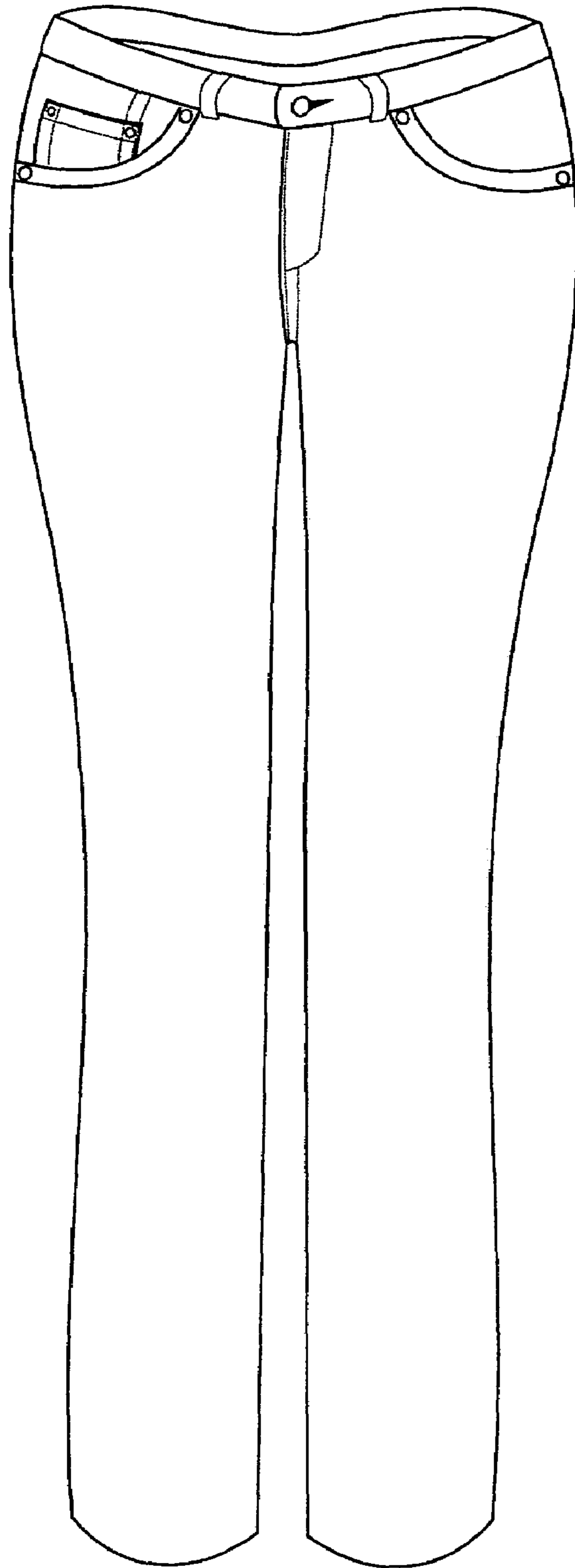
FIG. 2 is a front view thereof.
