I claim the ornamental design for a football-shaped container, as shown and described.

DESCRIPTION

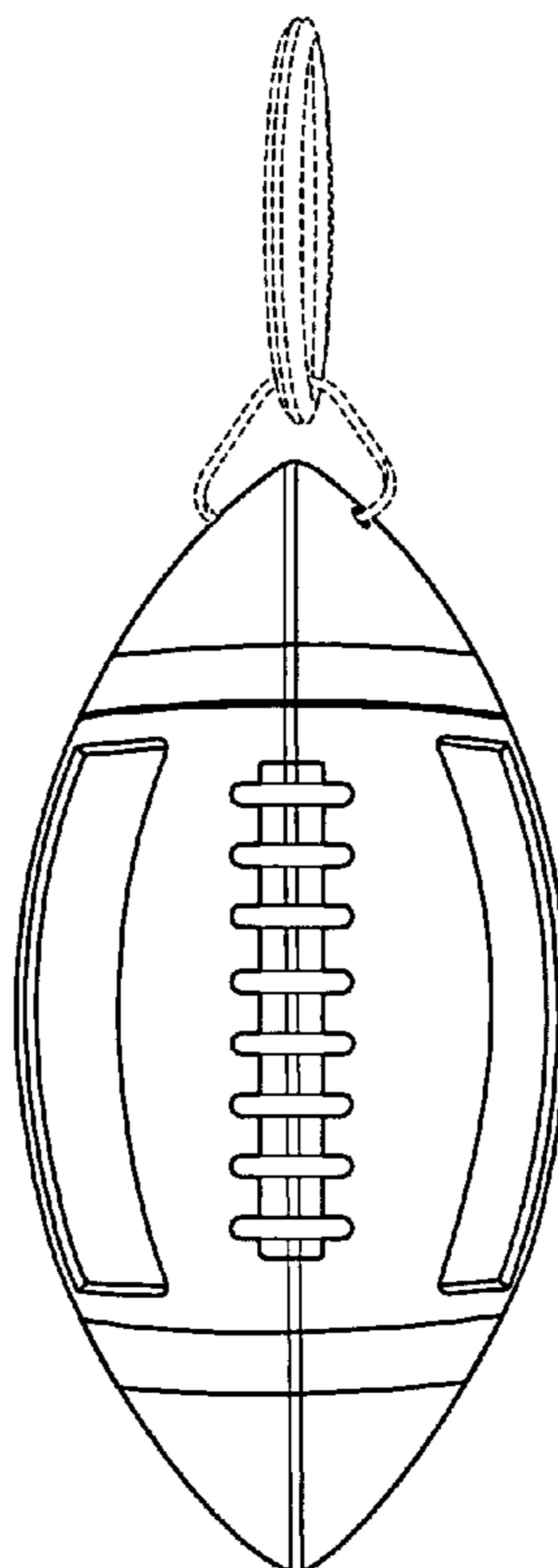
FIG. 1 is a perspective view of an assembled football-shaped container.

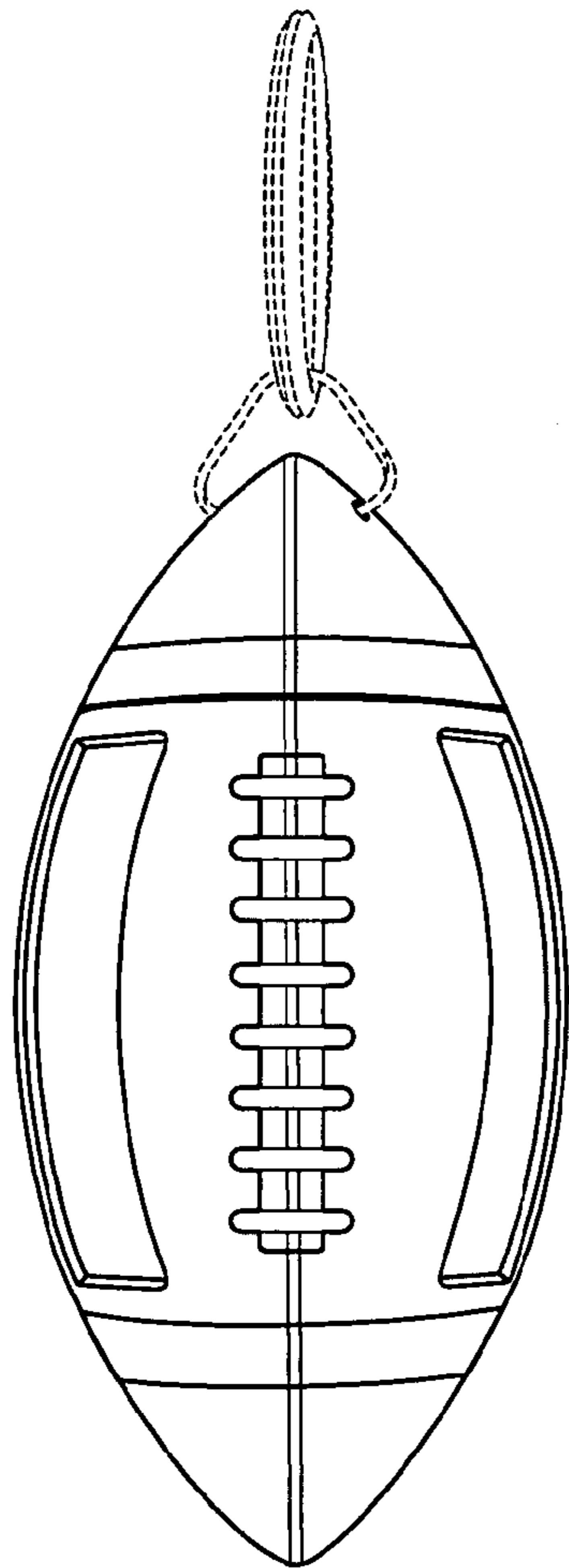

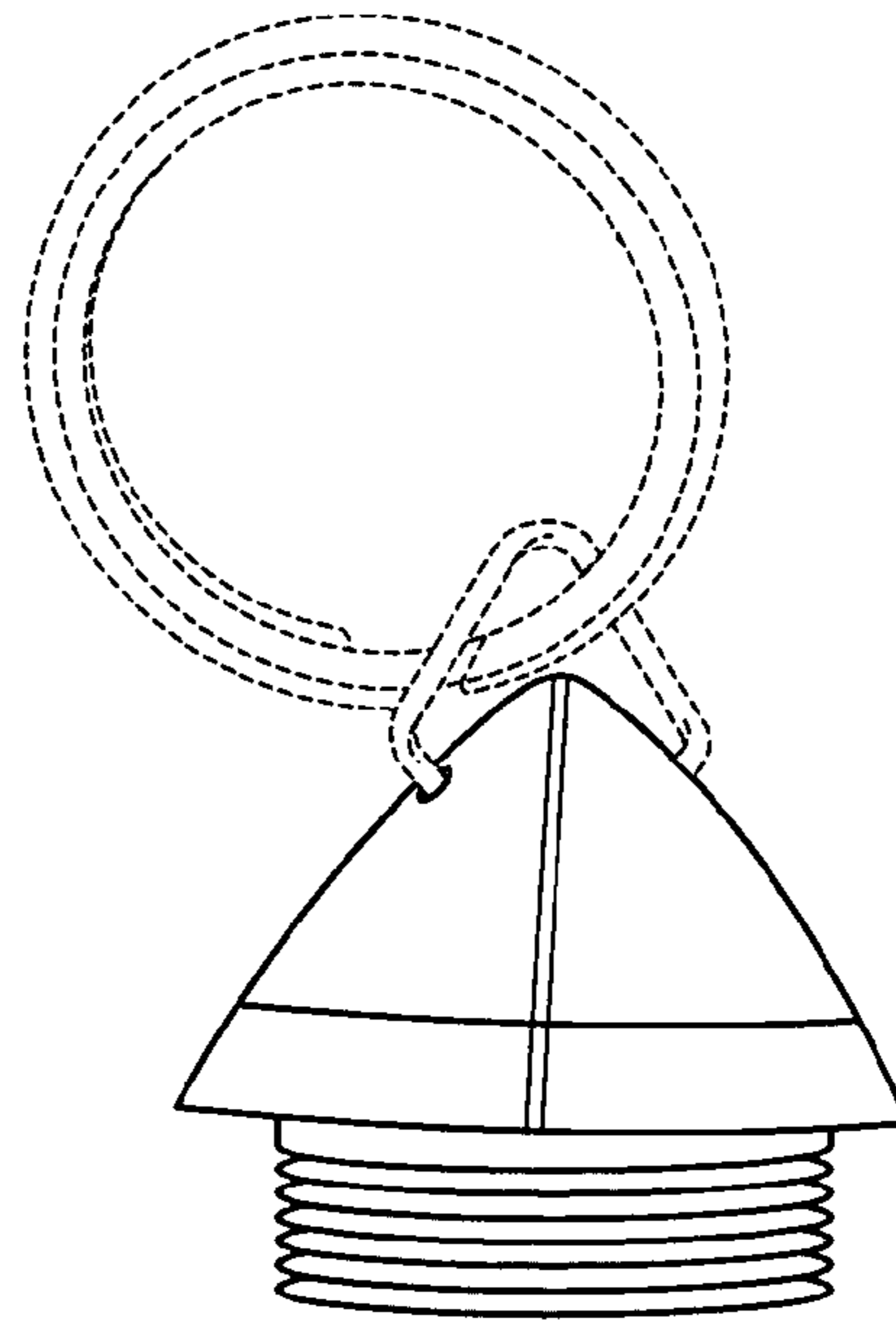

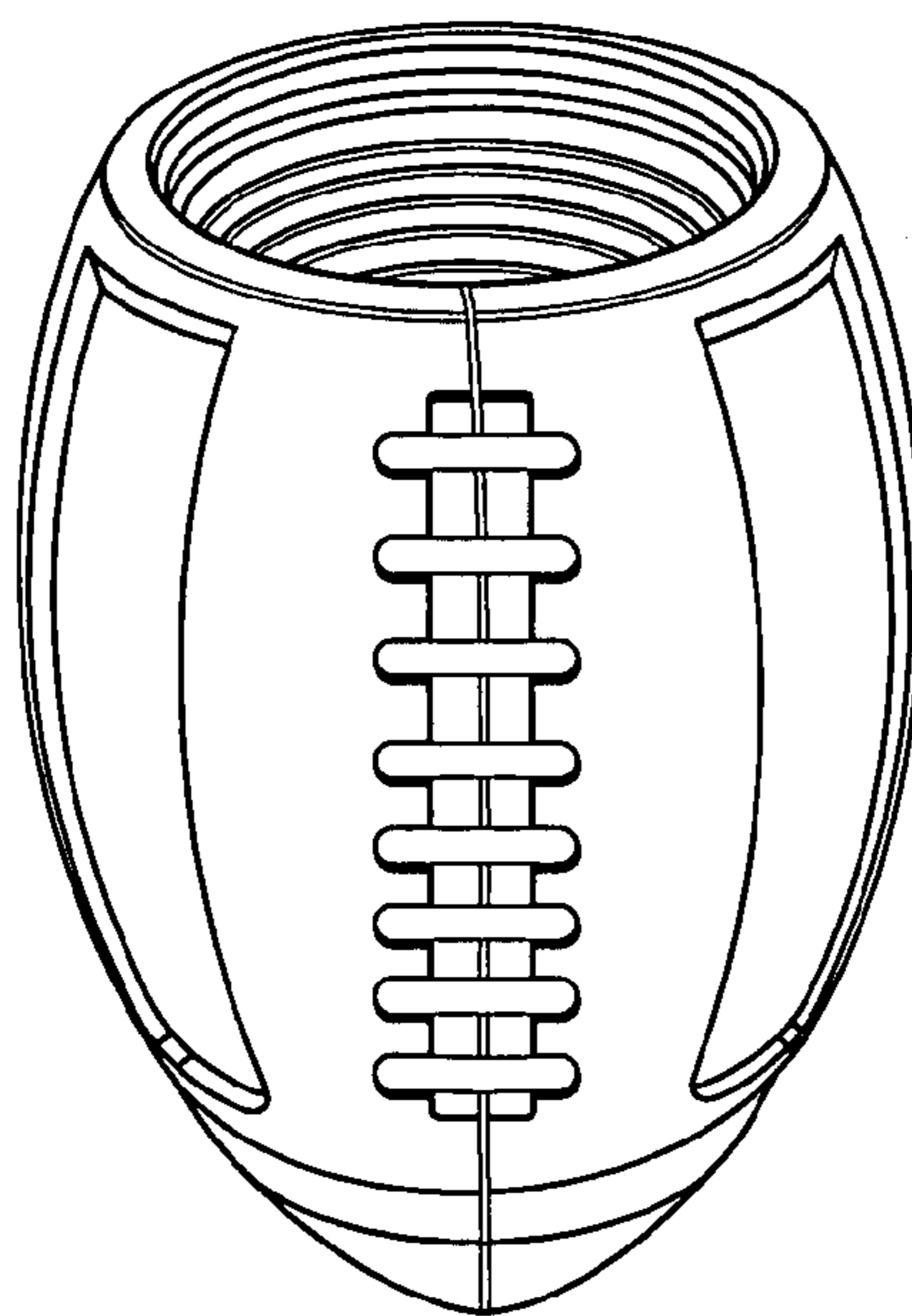
