The ornamental design for the mobile telephone case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective, front-elevational view of an assembled mobile telephone case showing my new design;

FIG. 2 is a right side-elevational view thereof;

FIG. 3 is a top-plan view thereof;

FIG. 4 is a left side-elevational view thereof;

FIG. 5 is a bottom-plan view thereof;

FIG. 6 is a rear-elevational view thereof;

FIG. 7 is another rear-elevational view of the assembled mobile telephone case showing my new design, with ear buds and a cord wrapped in place;

FIG. 8 is a rear-perspective view of the assembled mobile telephone case of FIG. 1;

FIG. 9 is a front-perspective view thereof;

FIG. 10 is a front-elevational view of a disassembled outer shell of the mobile telephone case showing my new design;

FIG. 11 is a right side-elevational thereof;

FIG. 12 is a top-plan view thereof;

FIG. 13 is a left side-elevational view thereof;

FIG. 14 is a bottom-plan view thereof;

FIG. 15 is a rear-elevational view of the disassembled outer shell of the mobile telephone case showing my new design;

FIG. 16 is a rear-elevational view of a disassembled insert of the mobile telephone case showing my new design;

FIG. 17 is a top-plan view thereof;

FIG. 18 is a side-elevational view thereof;

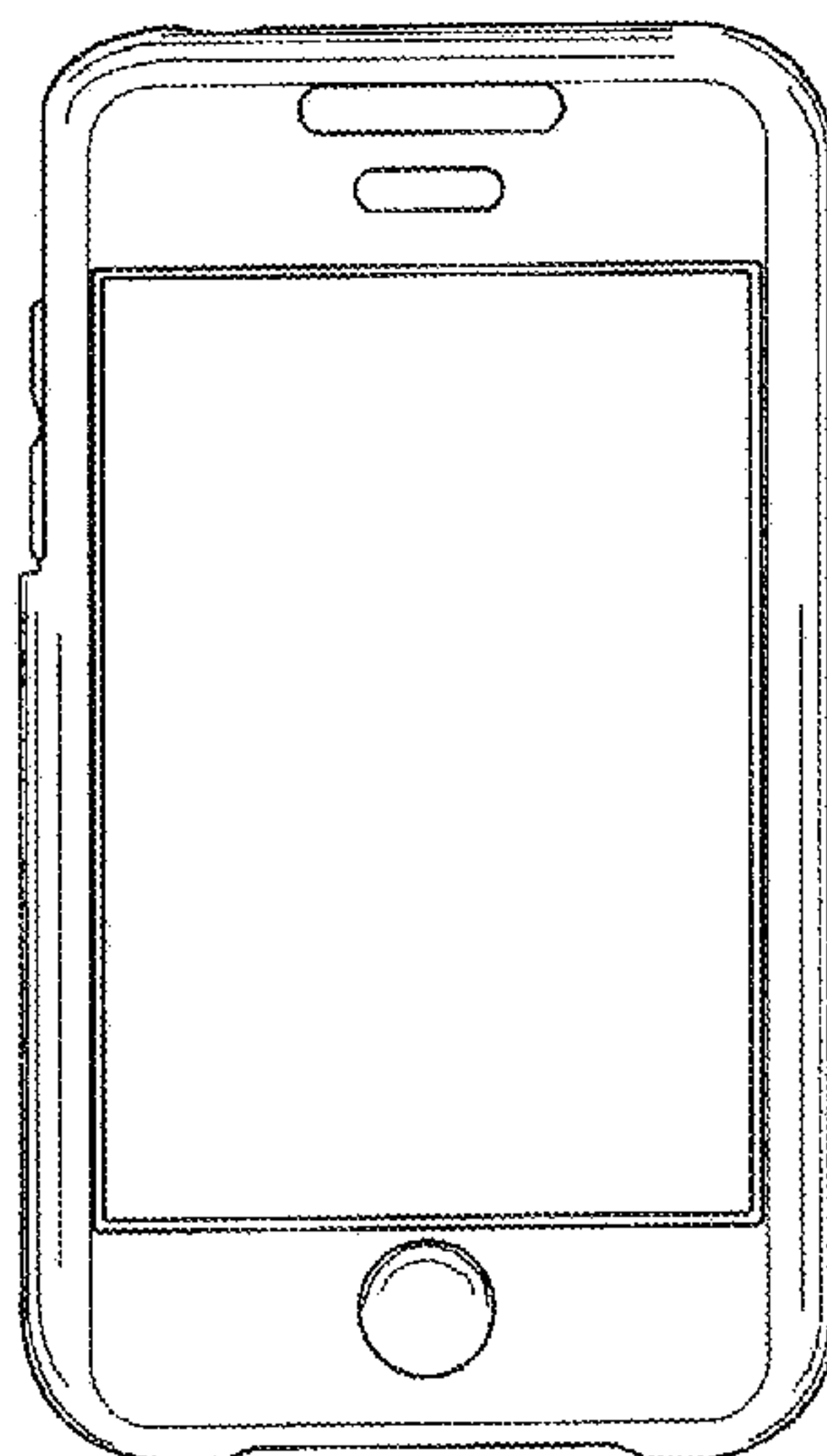
FIG. 19 is a front-elevational view thereof;

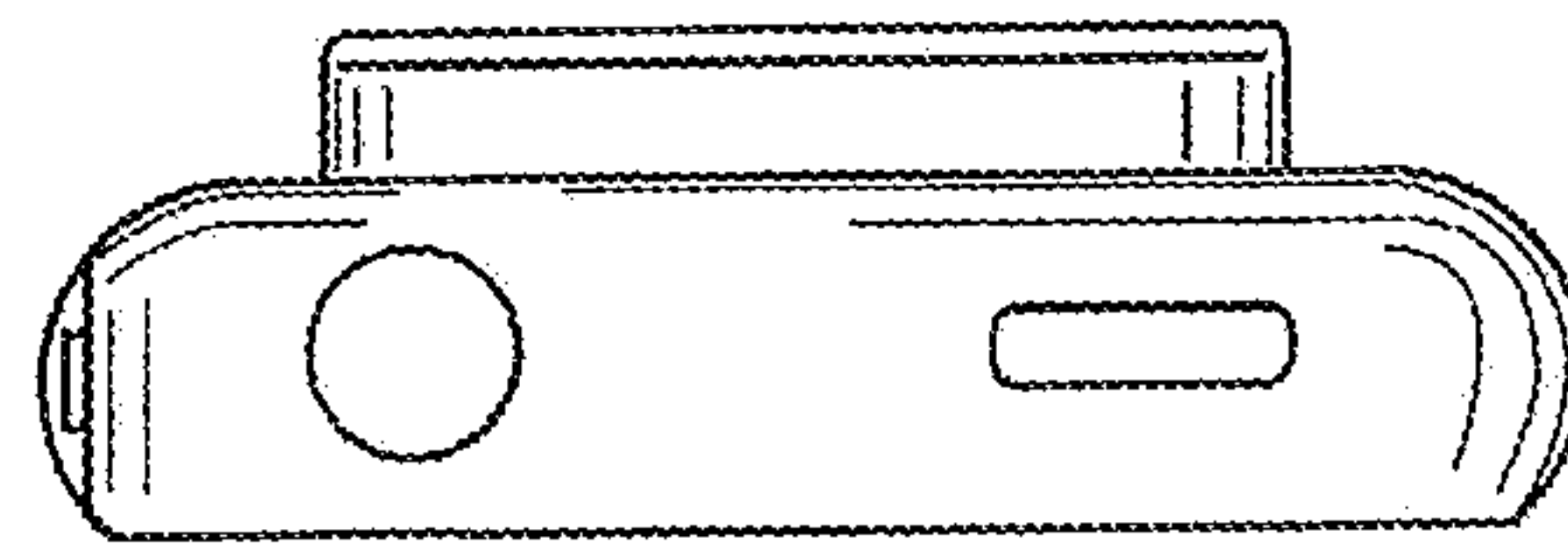

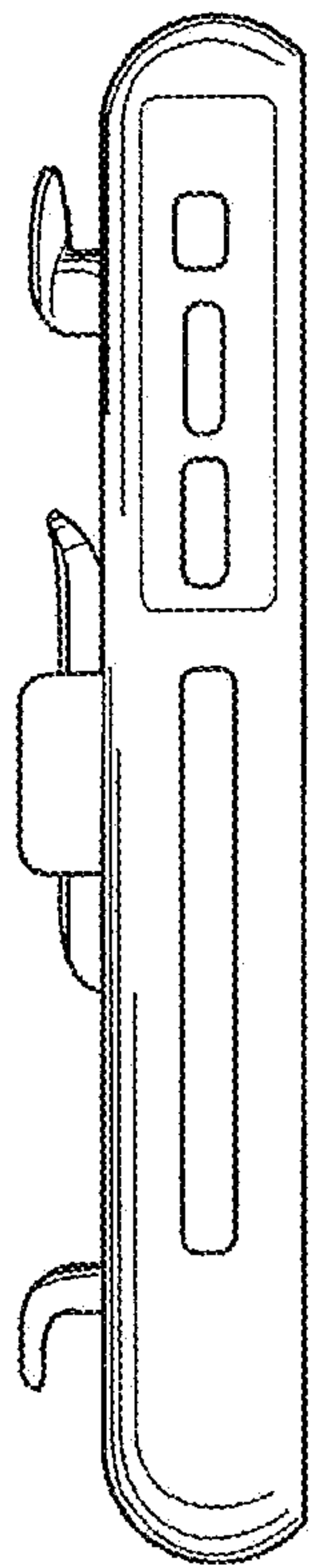

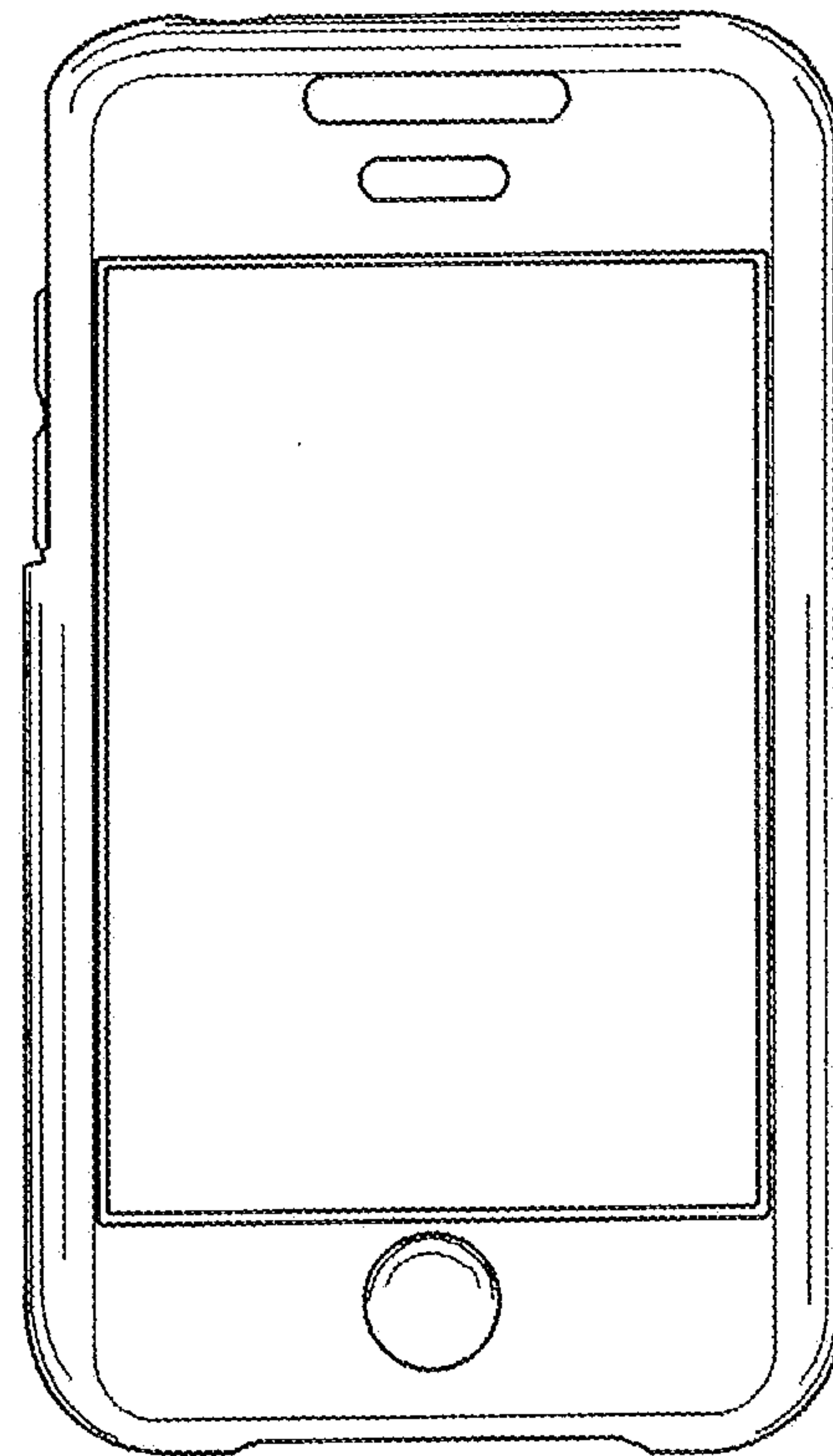

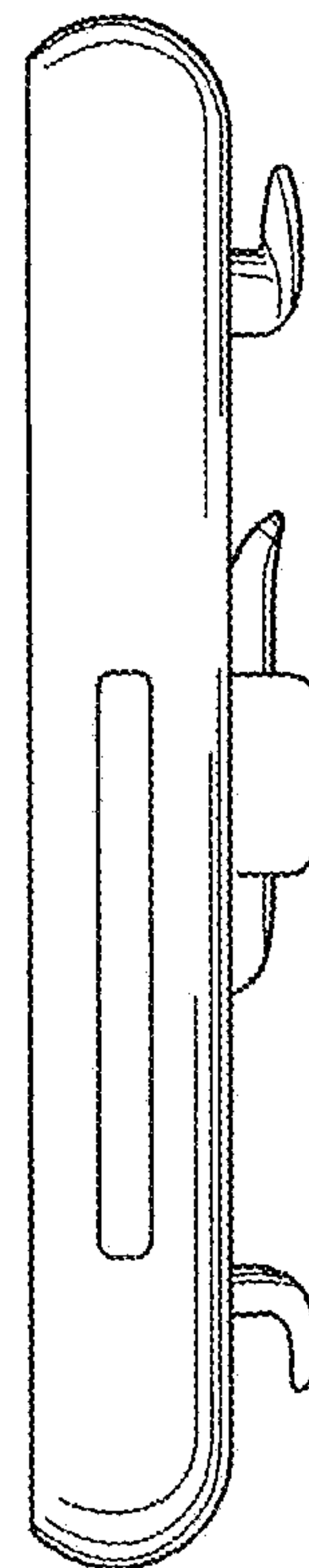

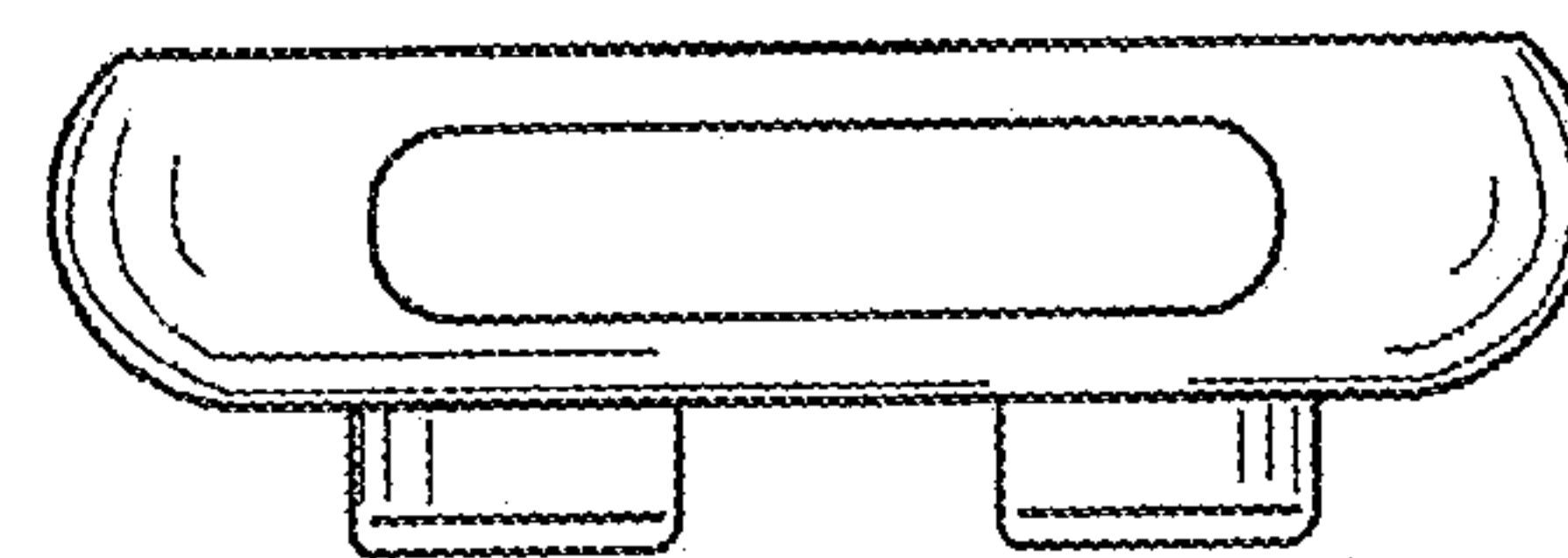

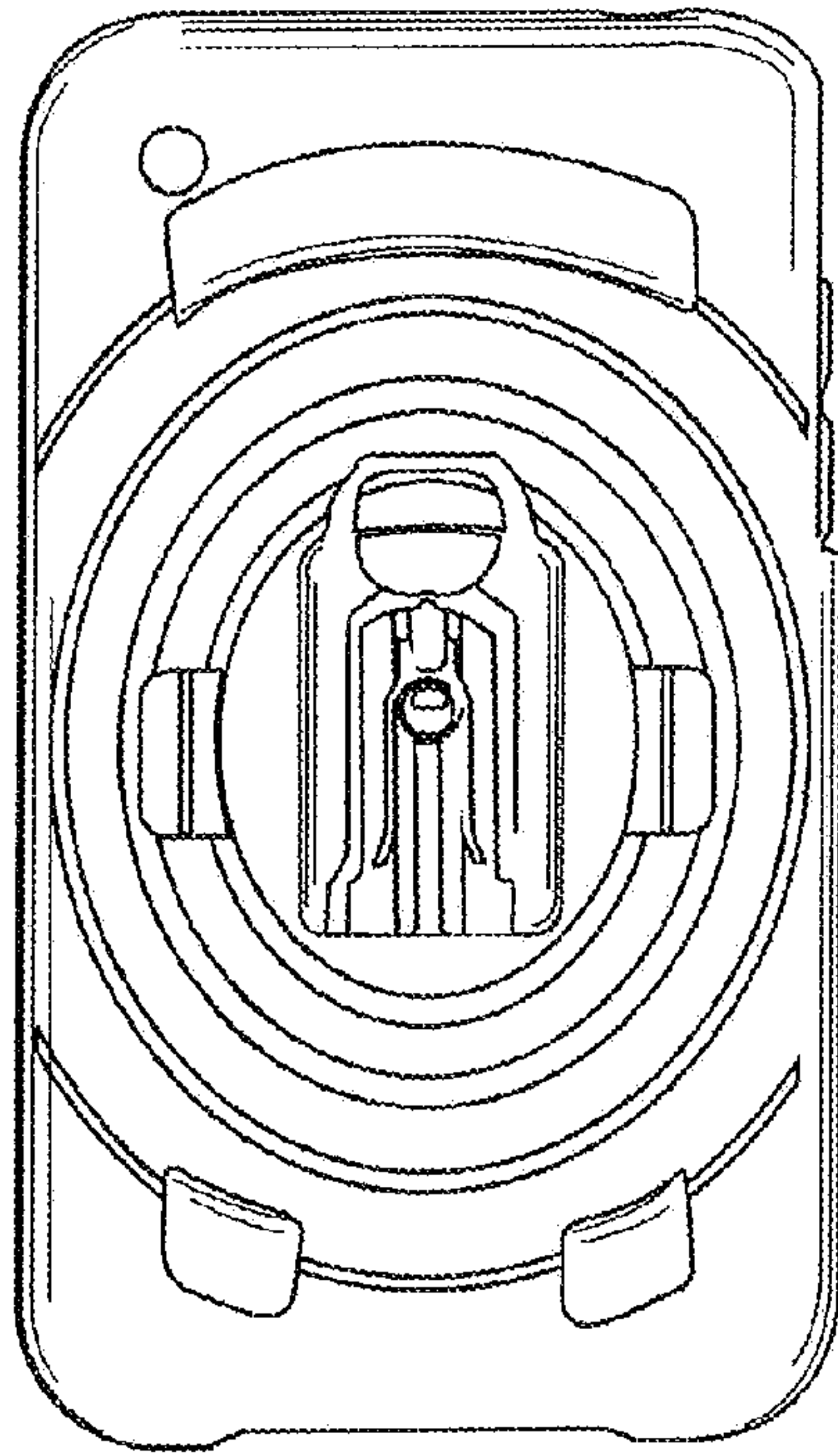

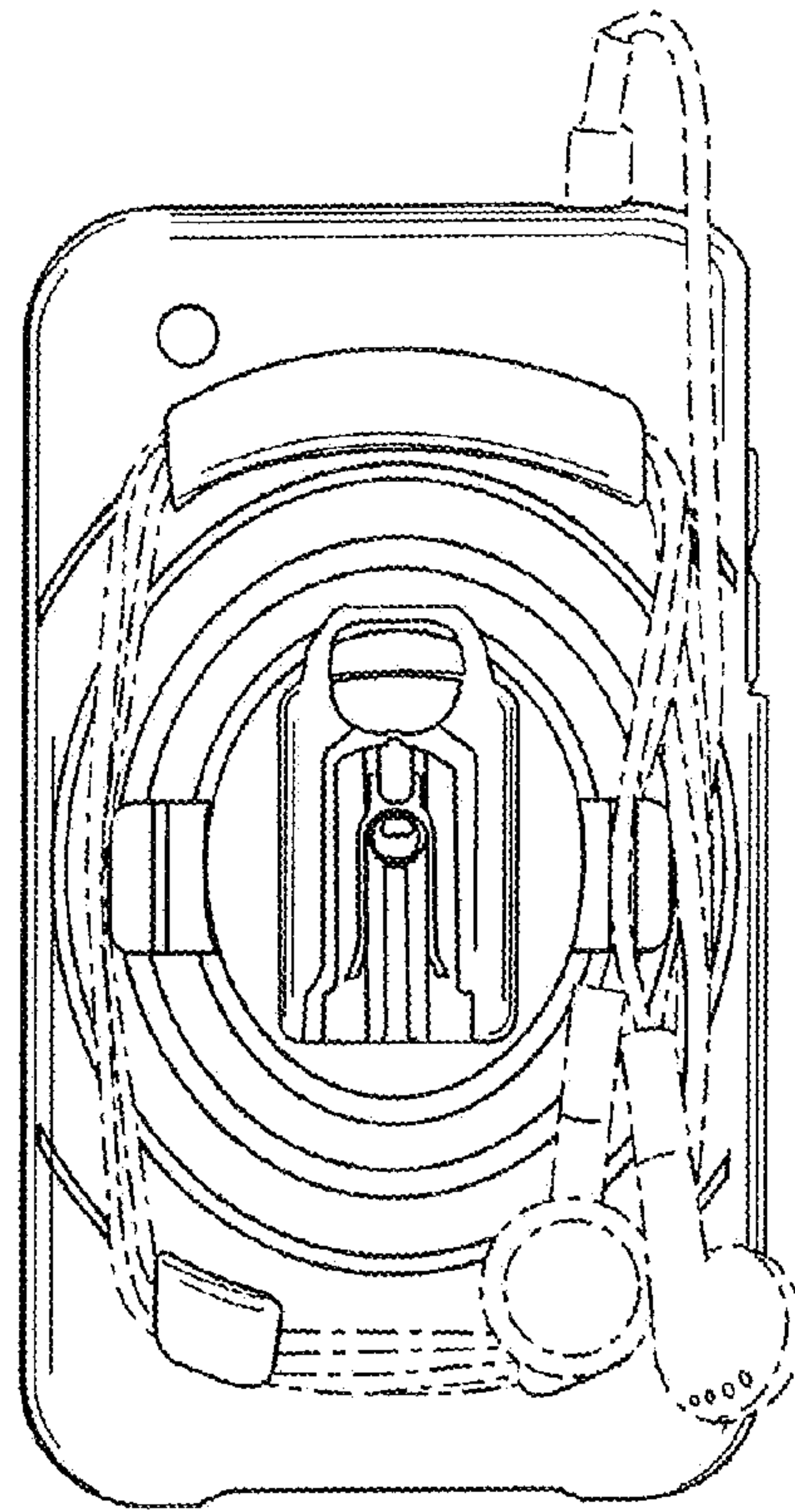

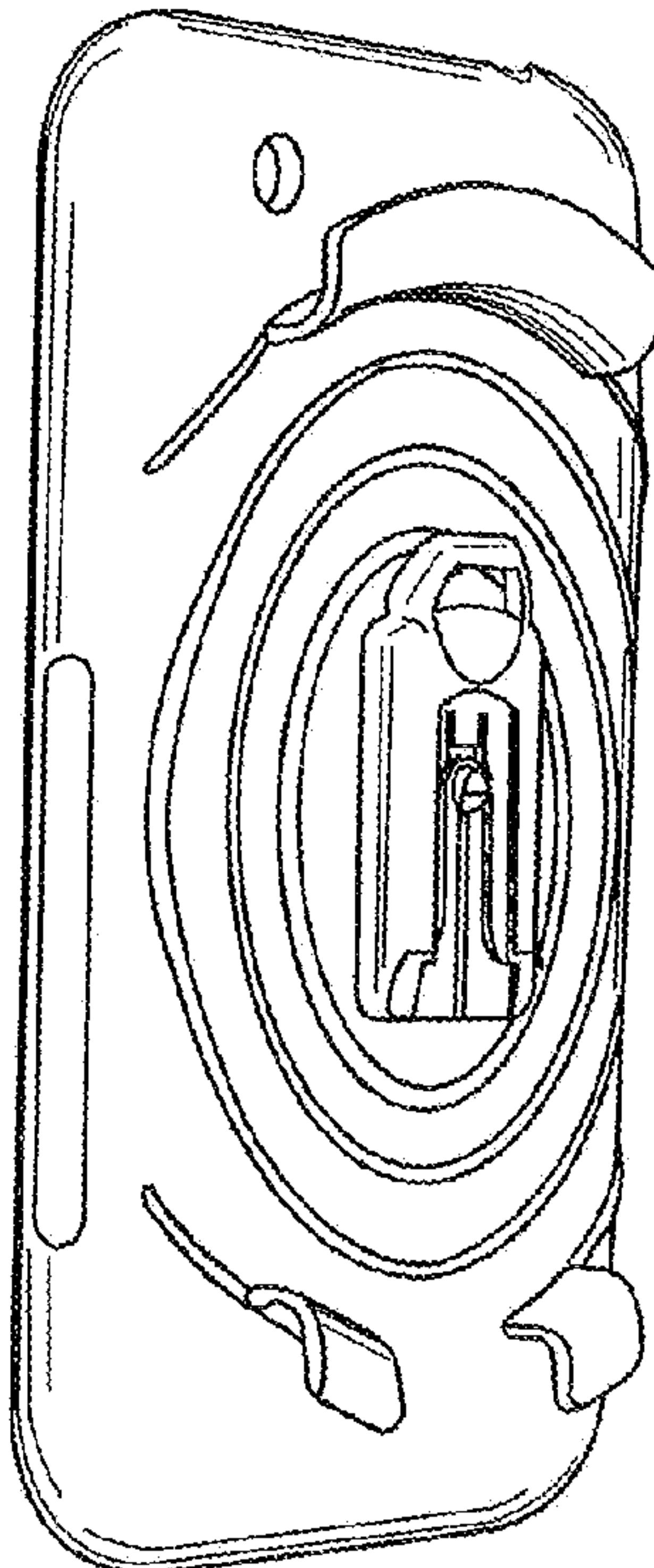

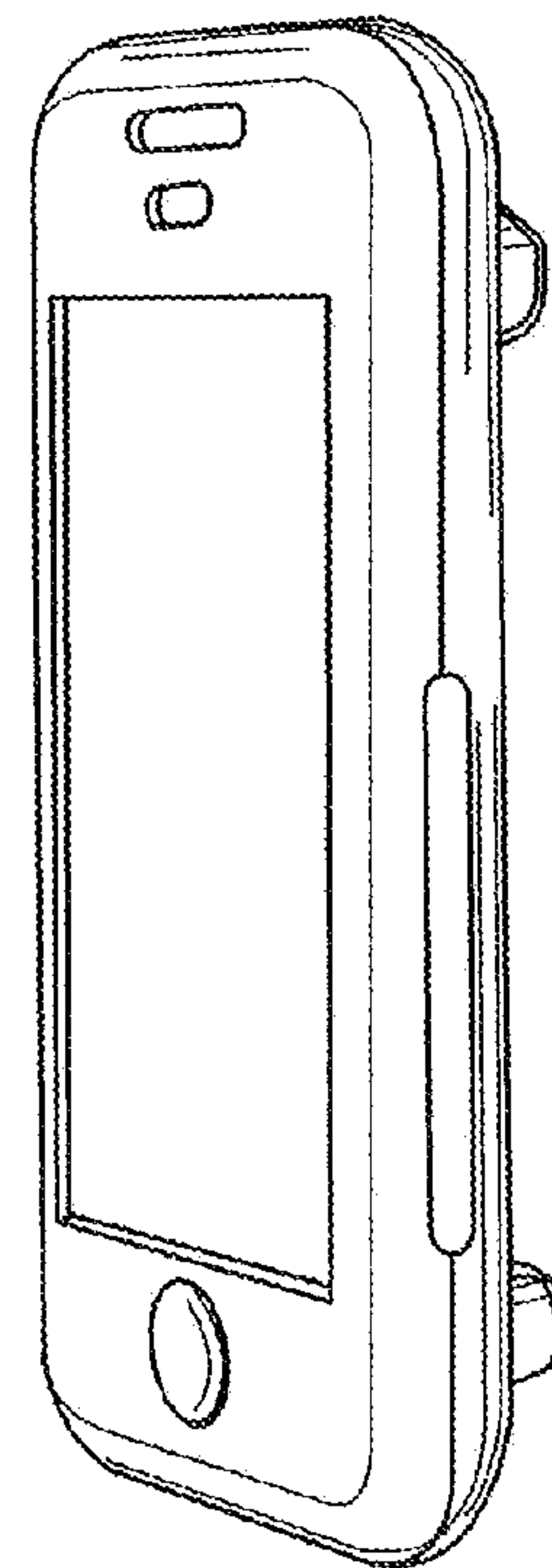

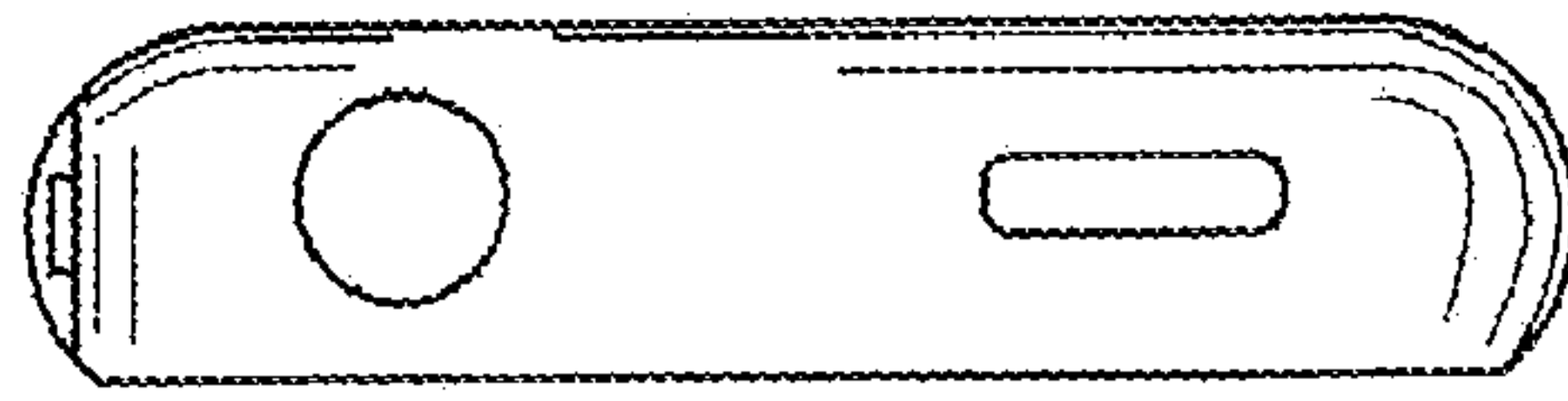

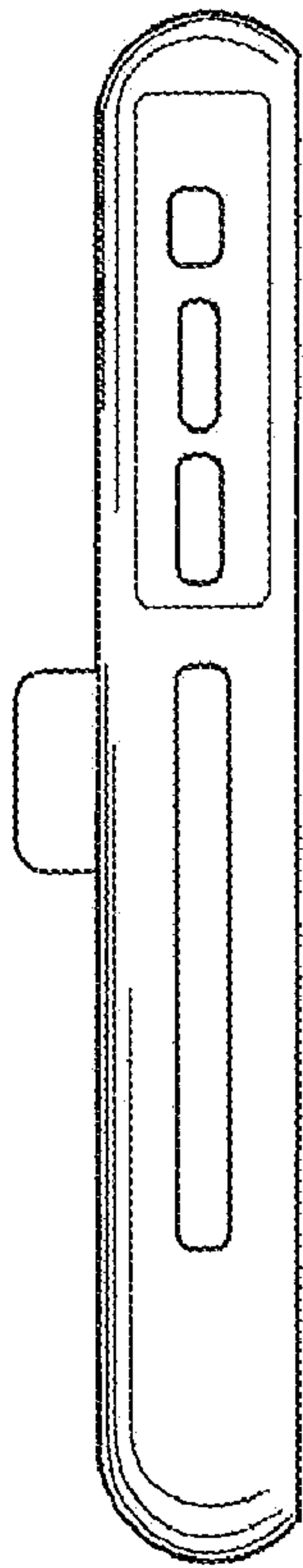

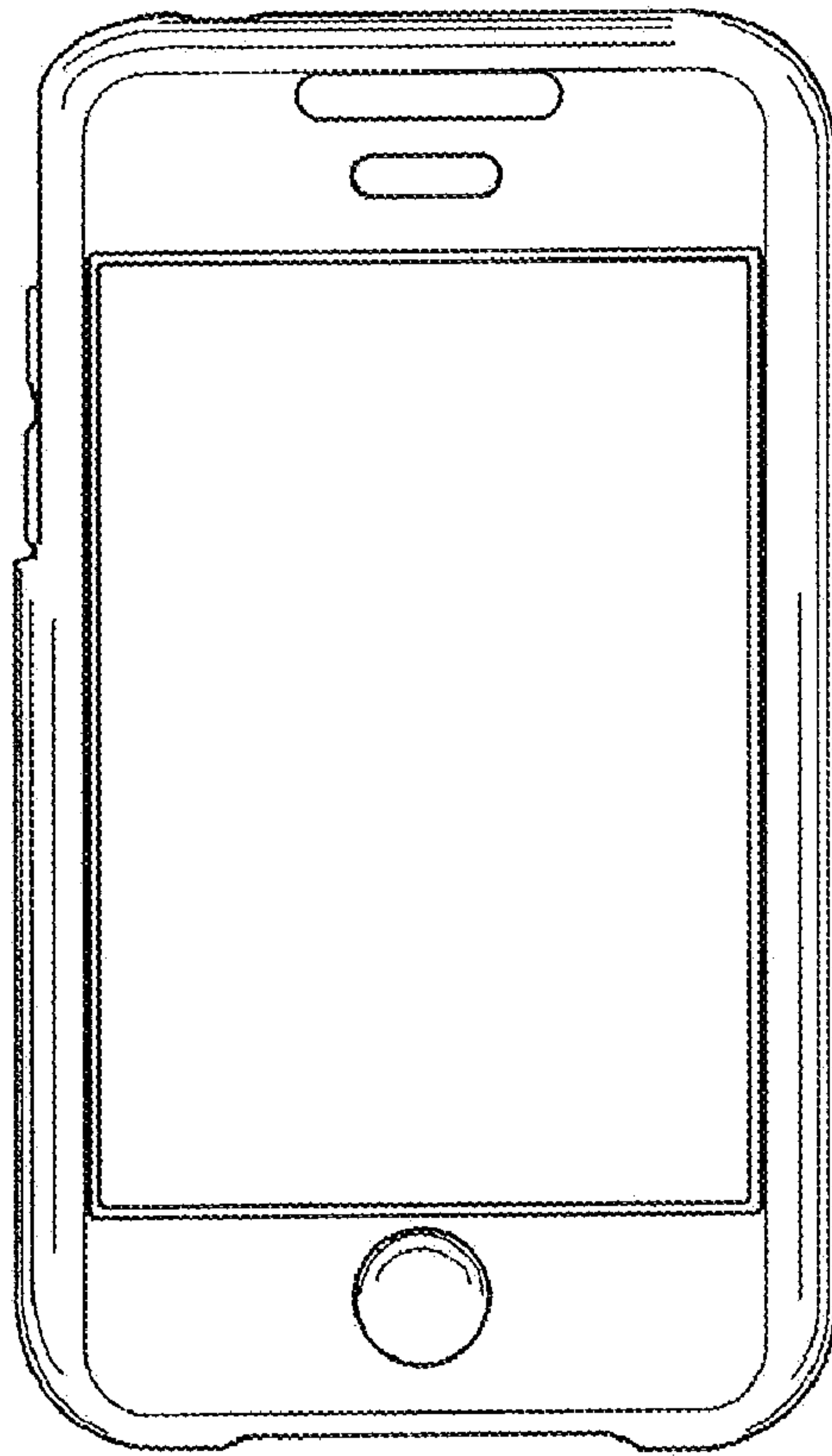

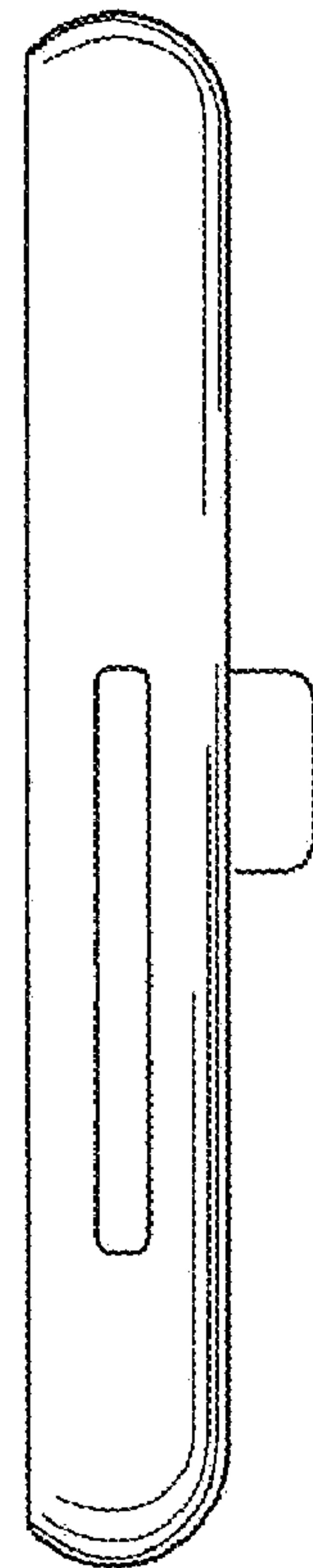

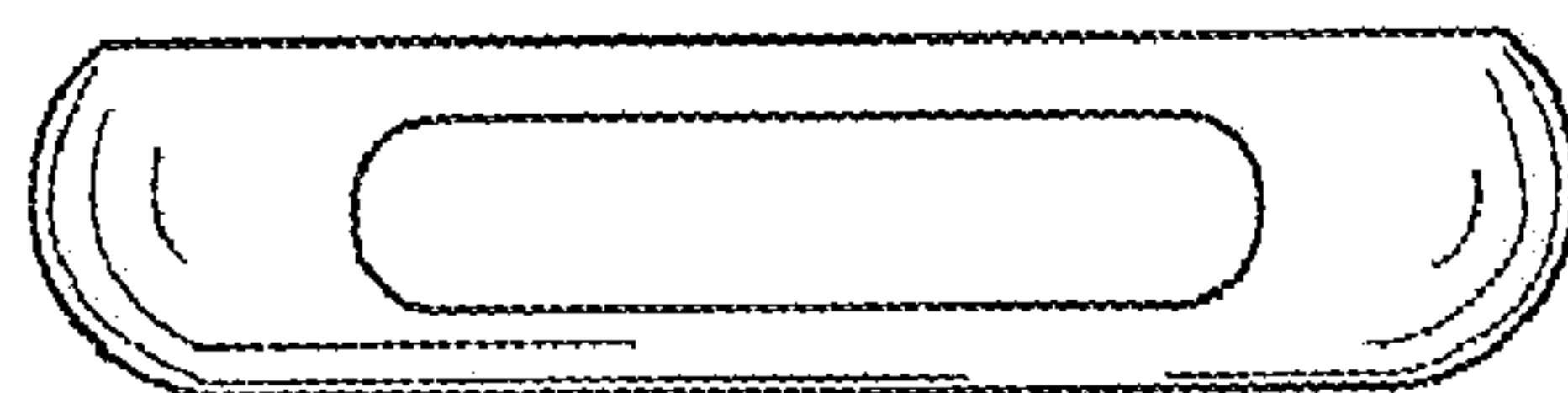

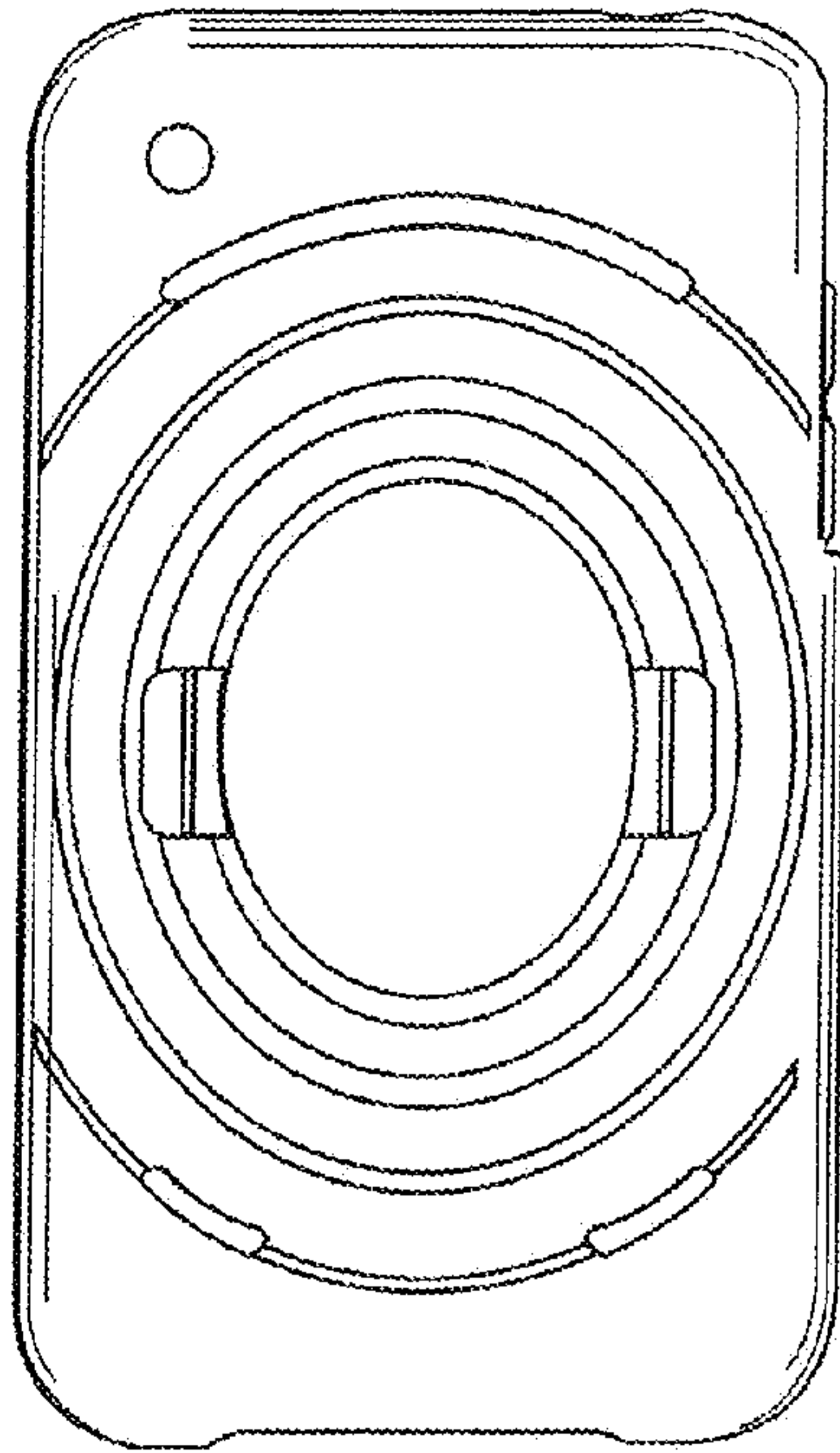

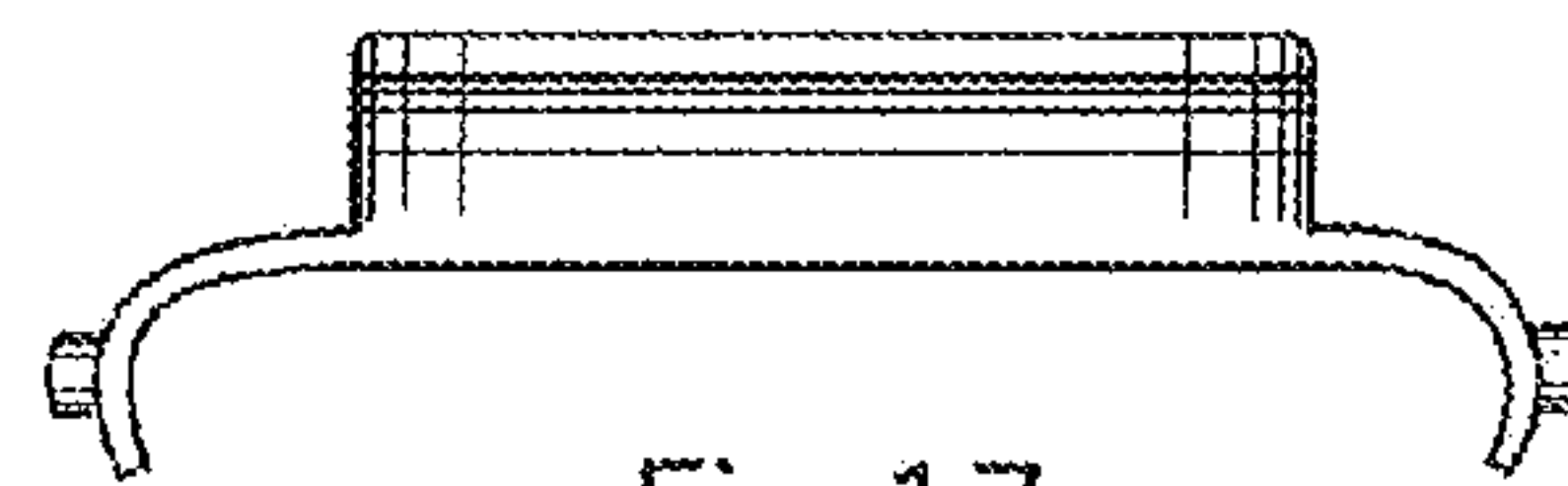

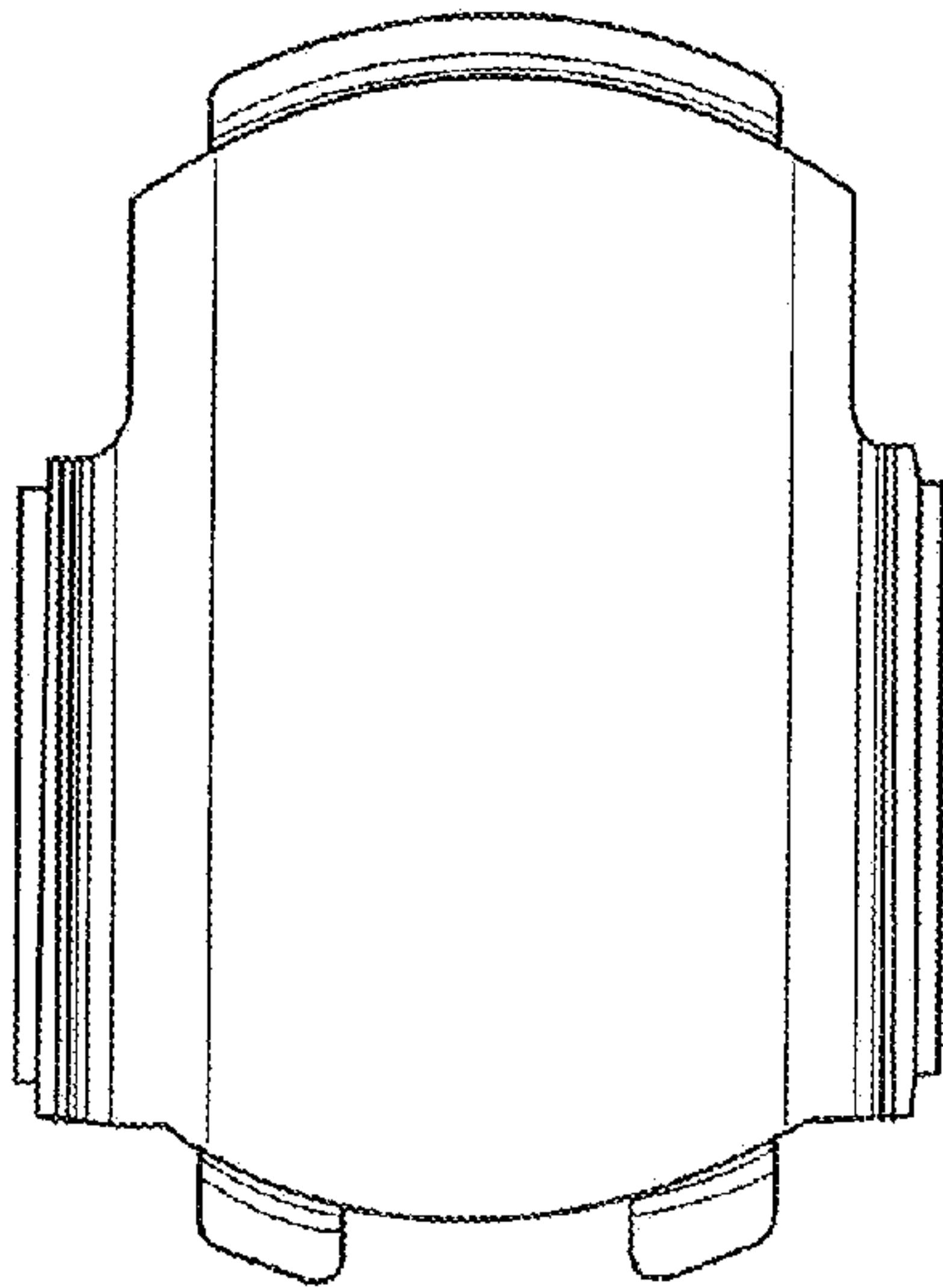

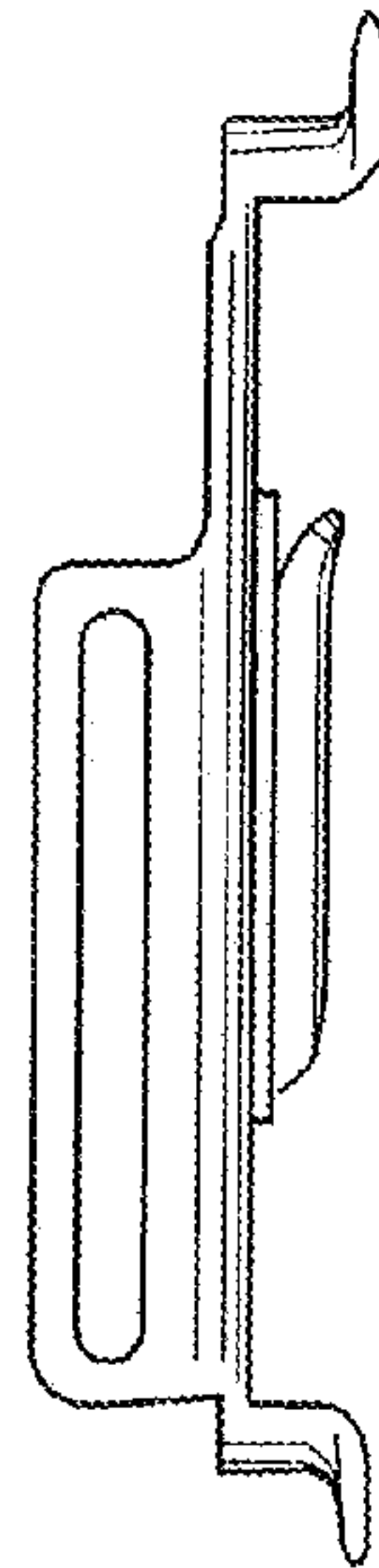

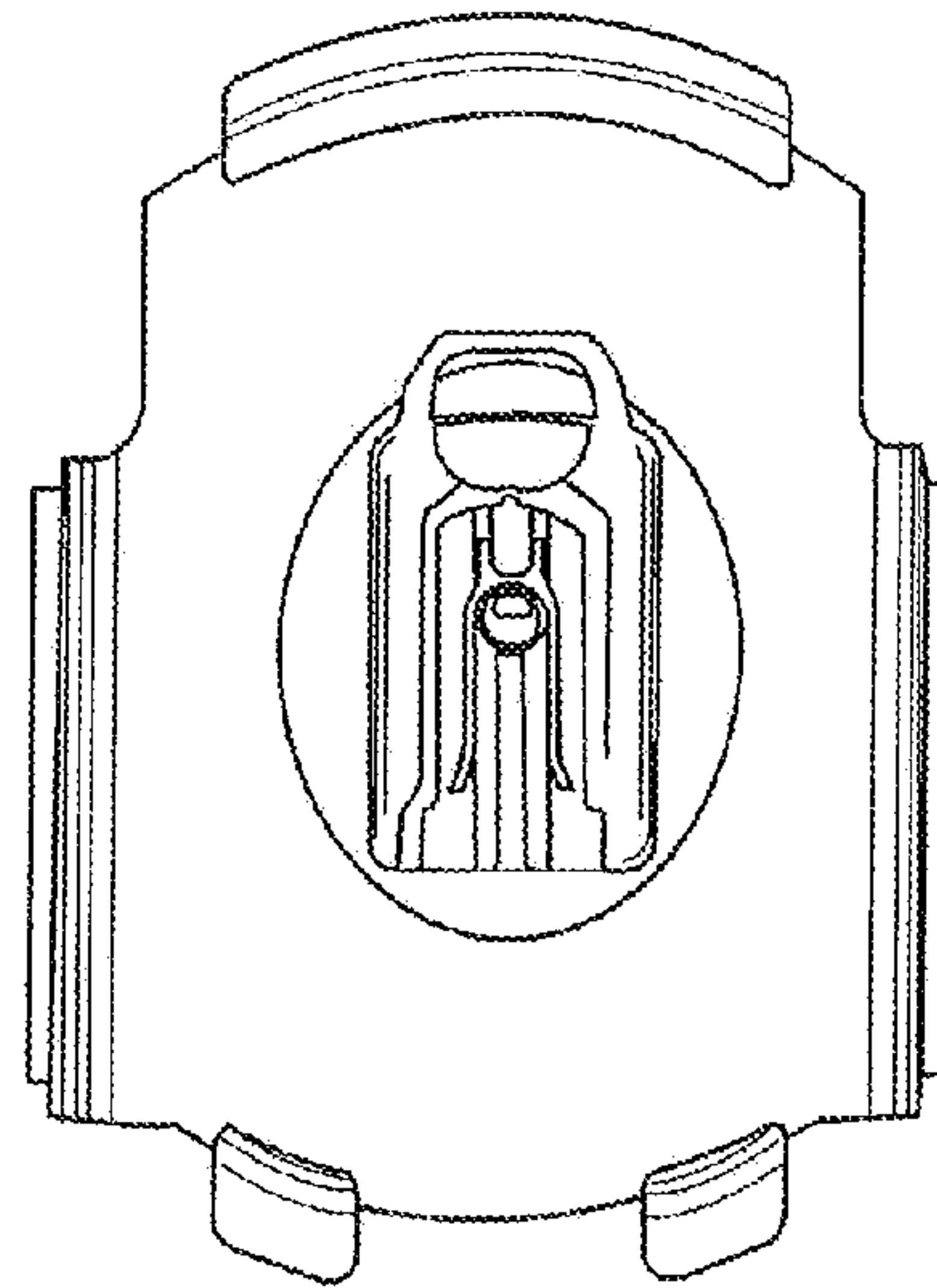

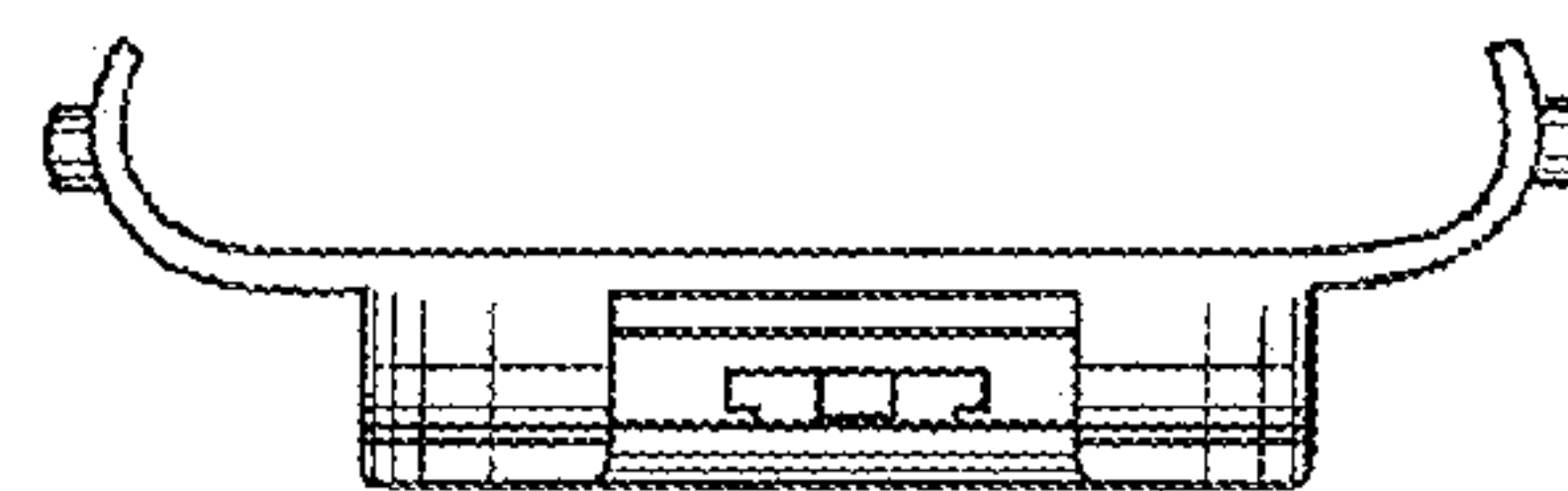

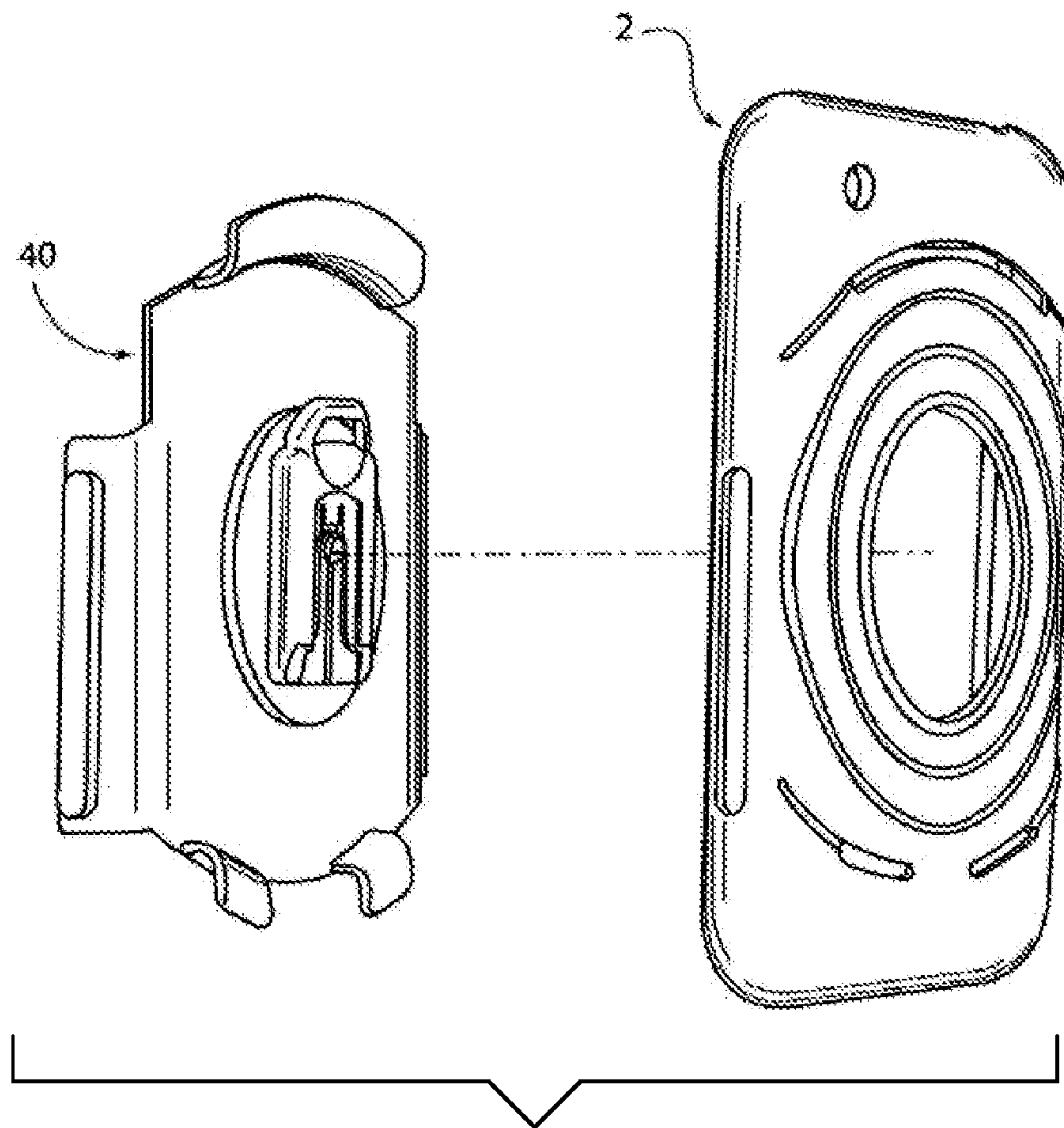
