(57) **CLAIM**

The ornamental design for a toolbox, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear and left-side perspective view of a toolbox showing my new design with the toolbox in a closed position;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right-side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a rear elevational view thereof;

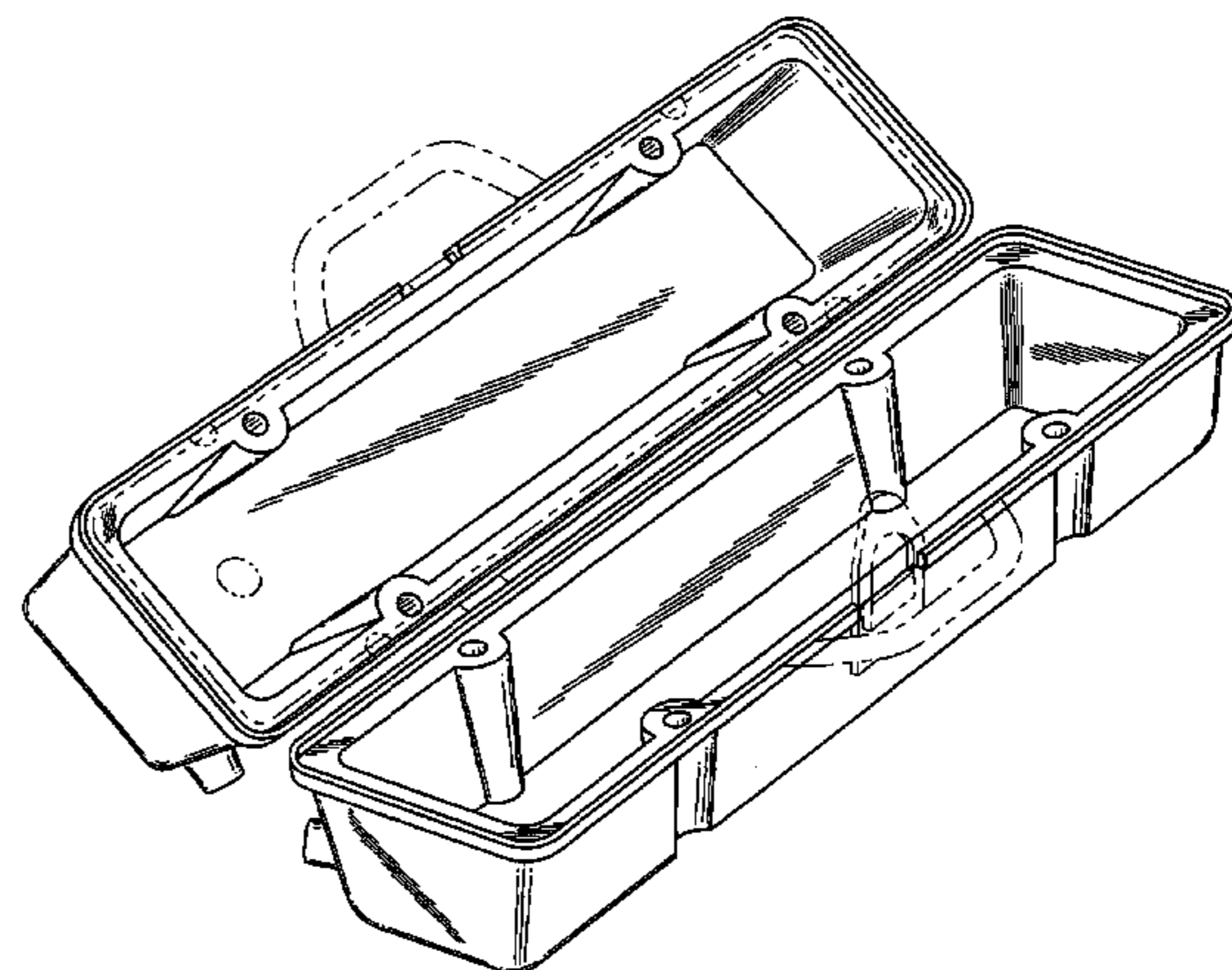
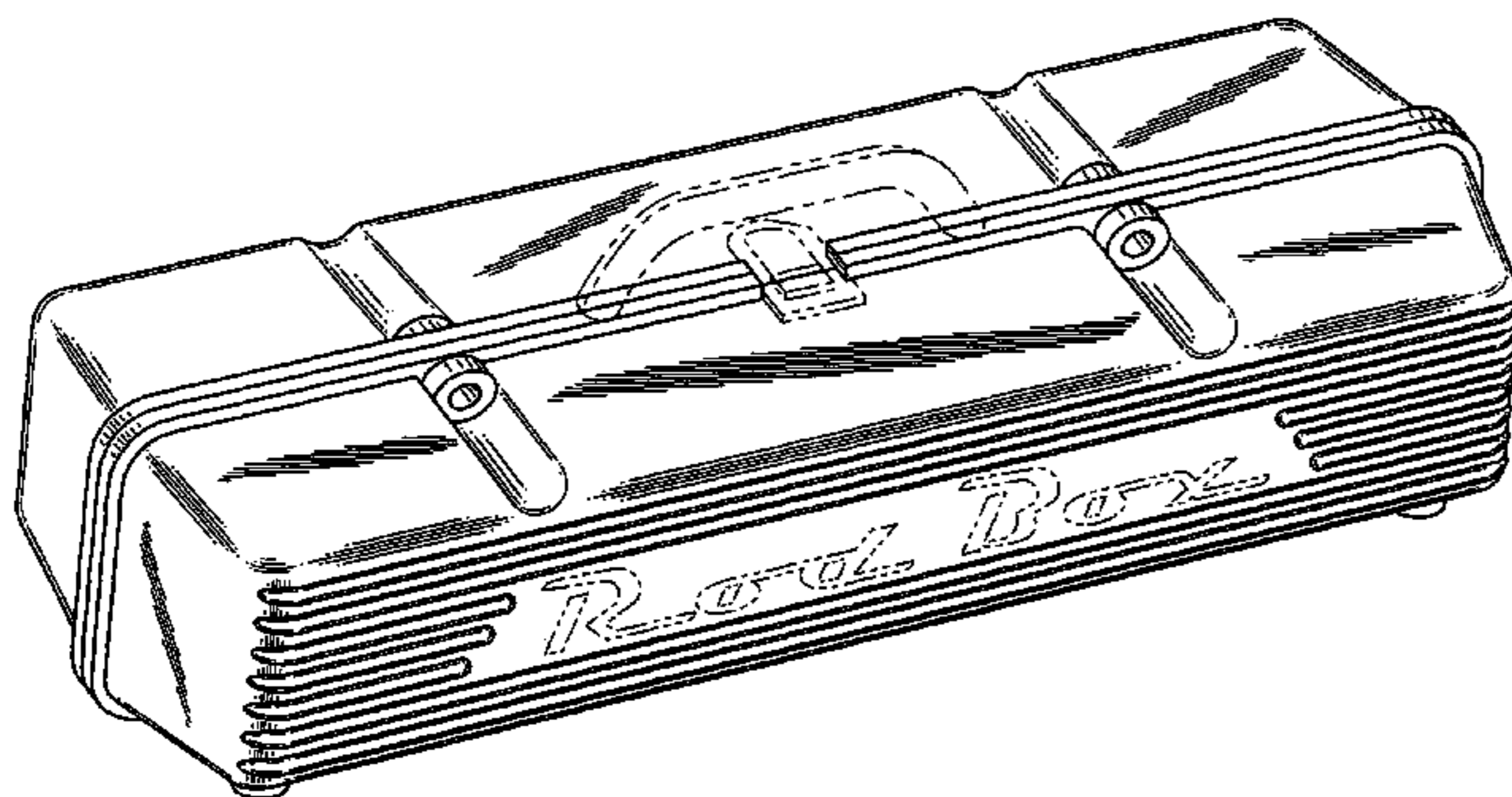
FIG. 6 is a left-side elevational view thereof;

FIG. 7 is a bottom view thereof; and,

FIG. 8 is a top and left-side perspective view of the toolbox in an open position.

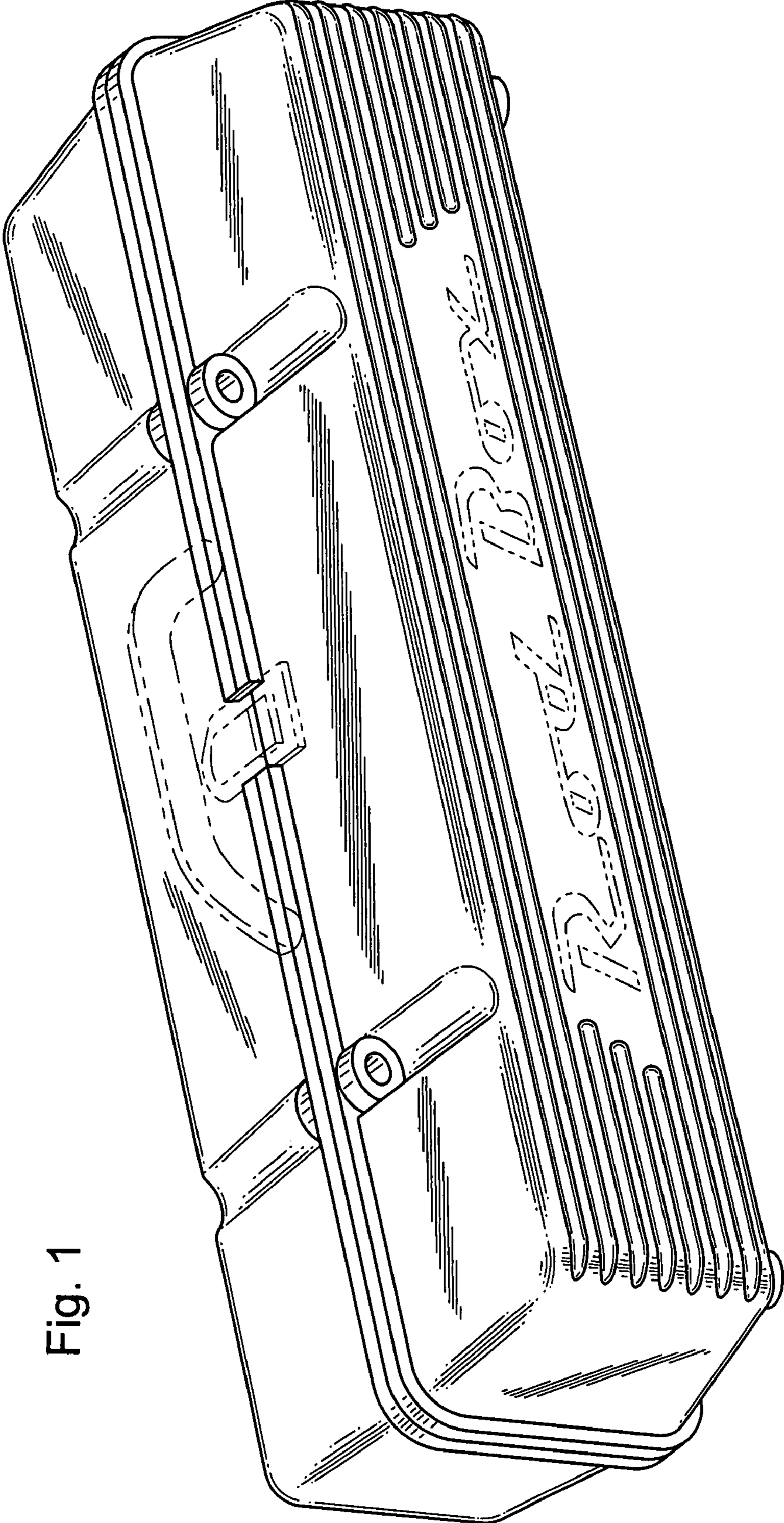

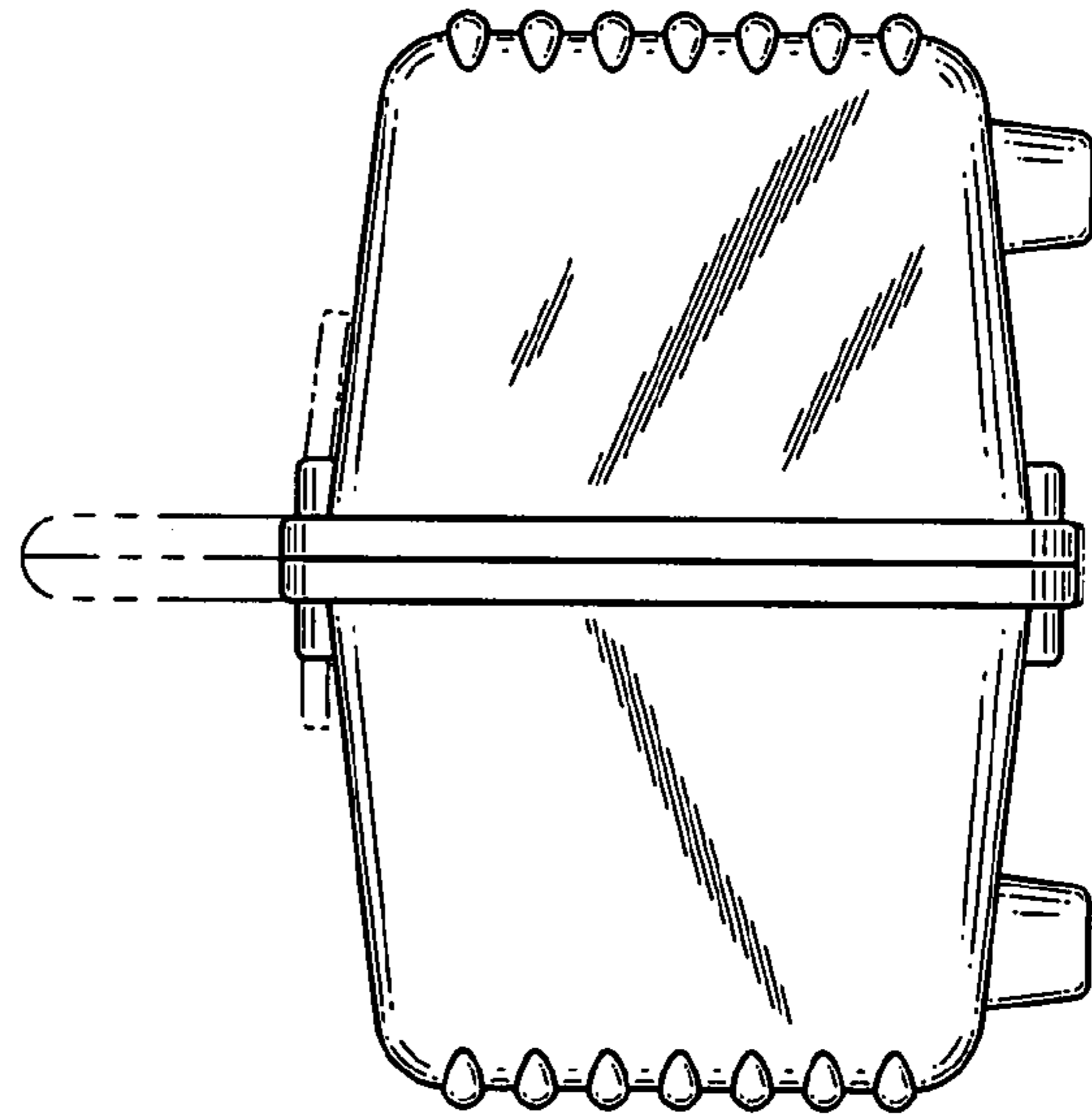
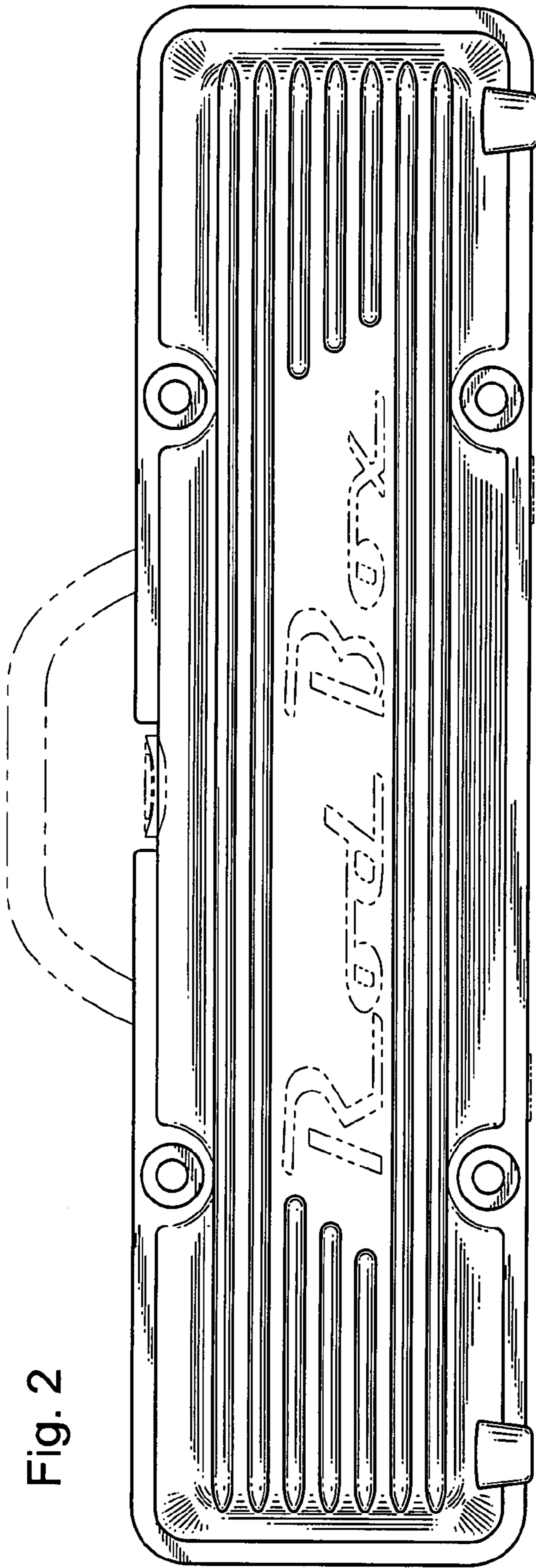
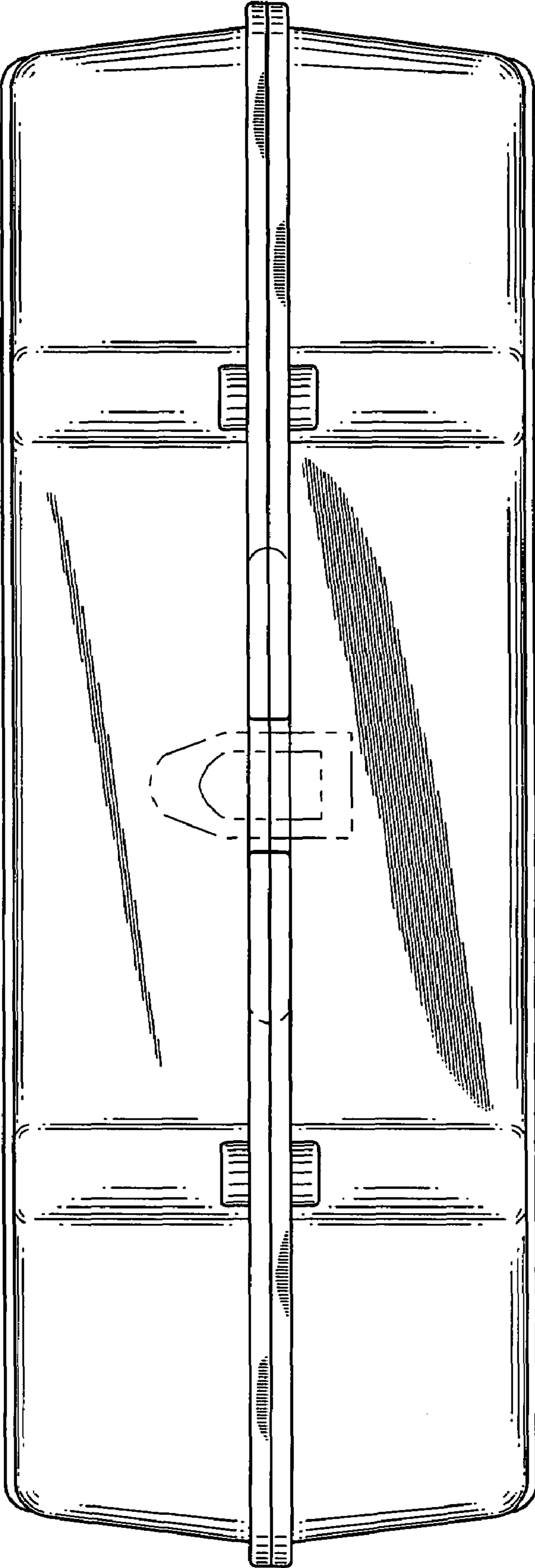

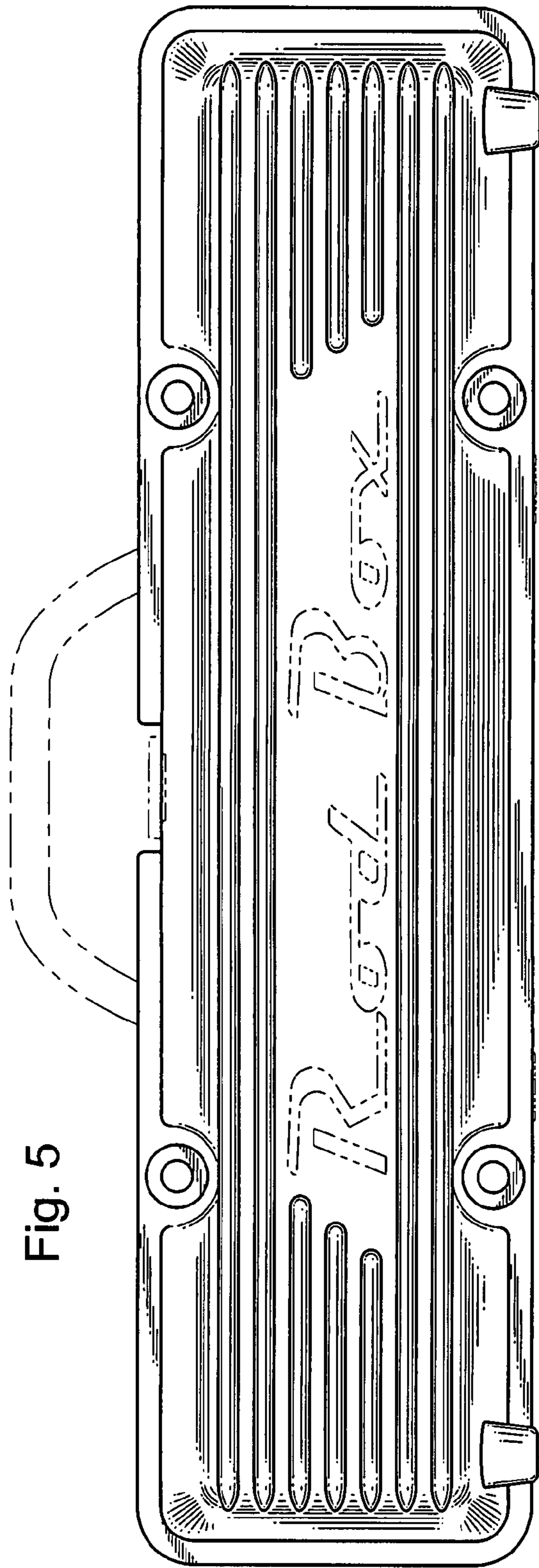

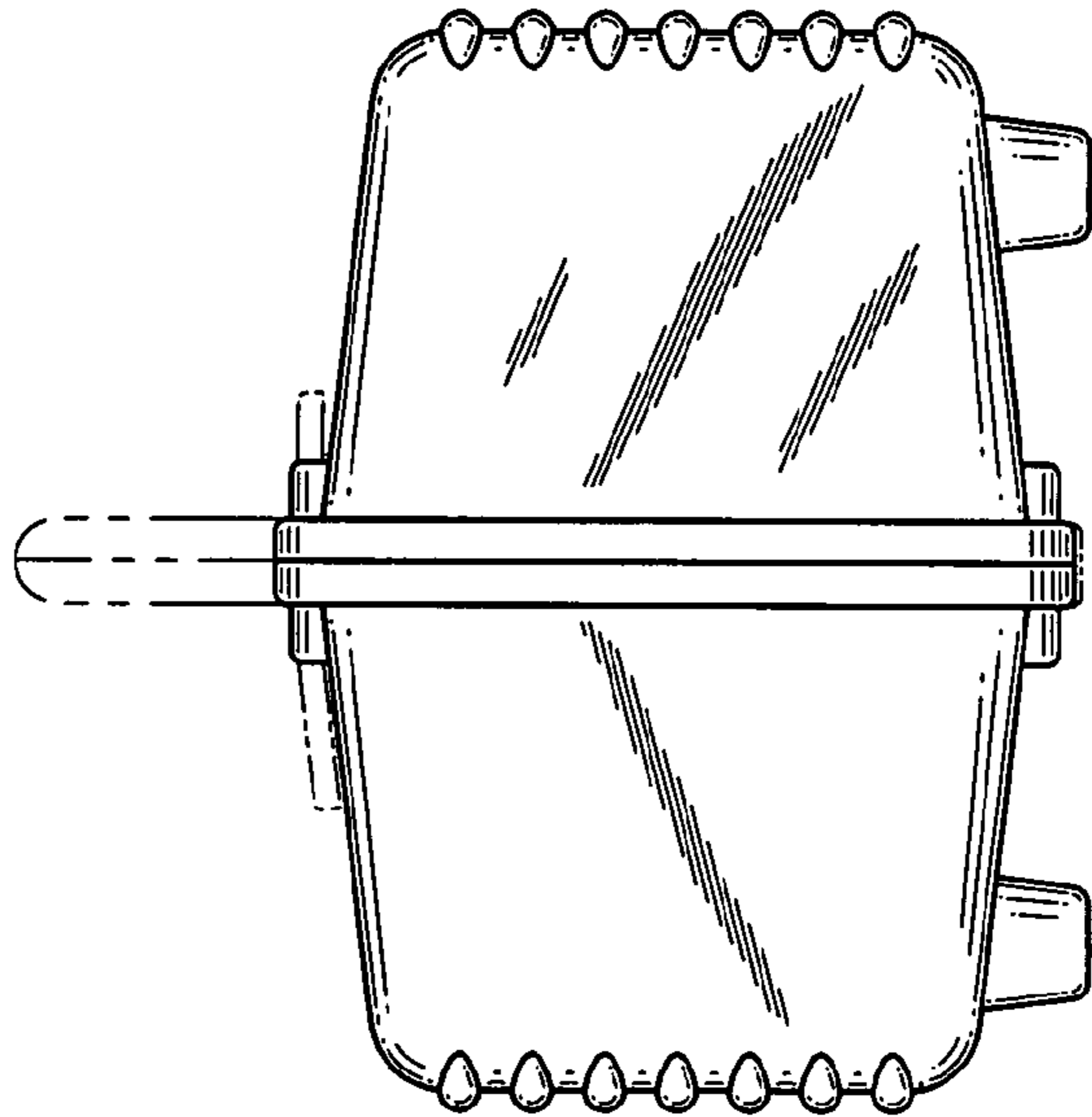
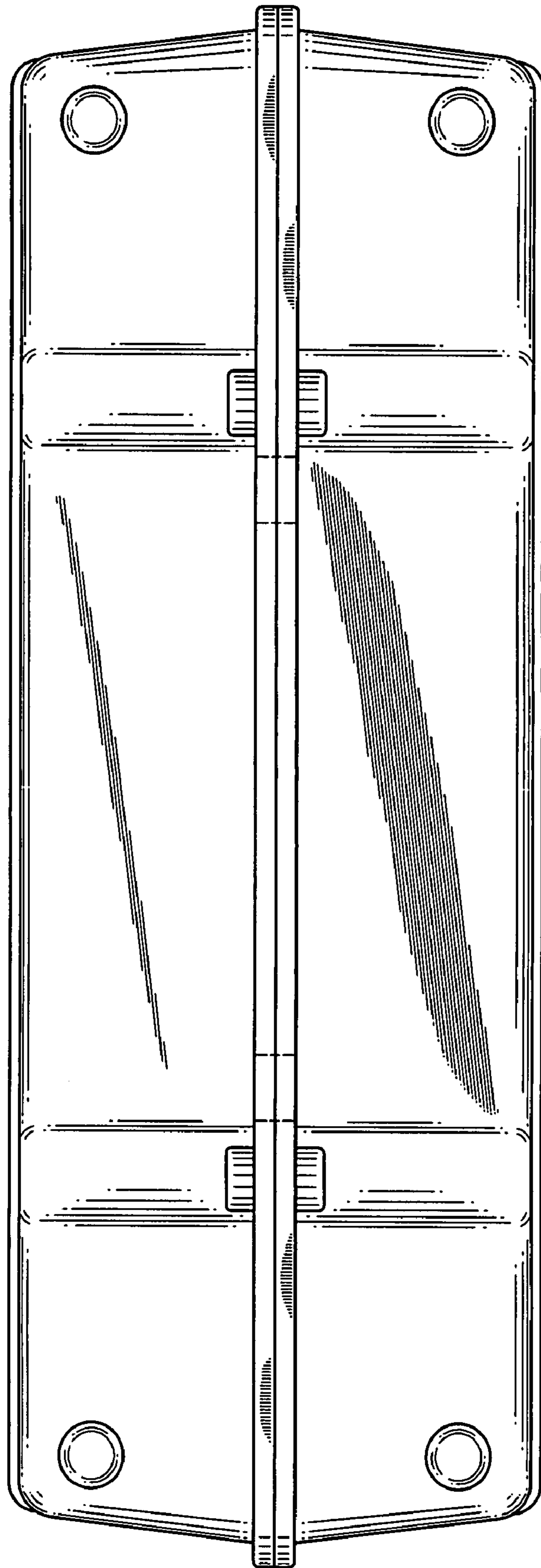

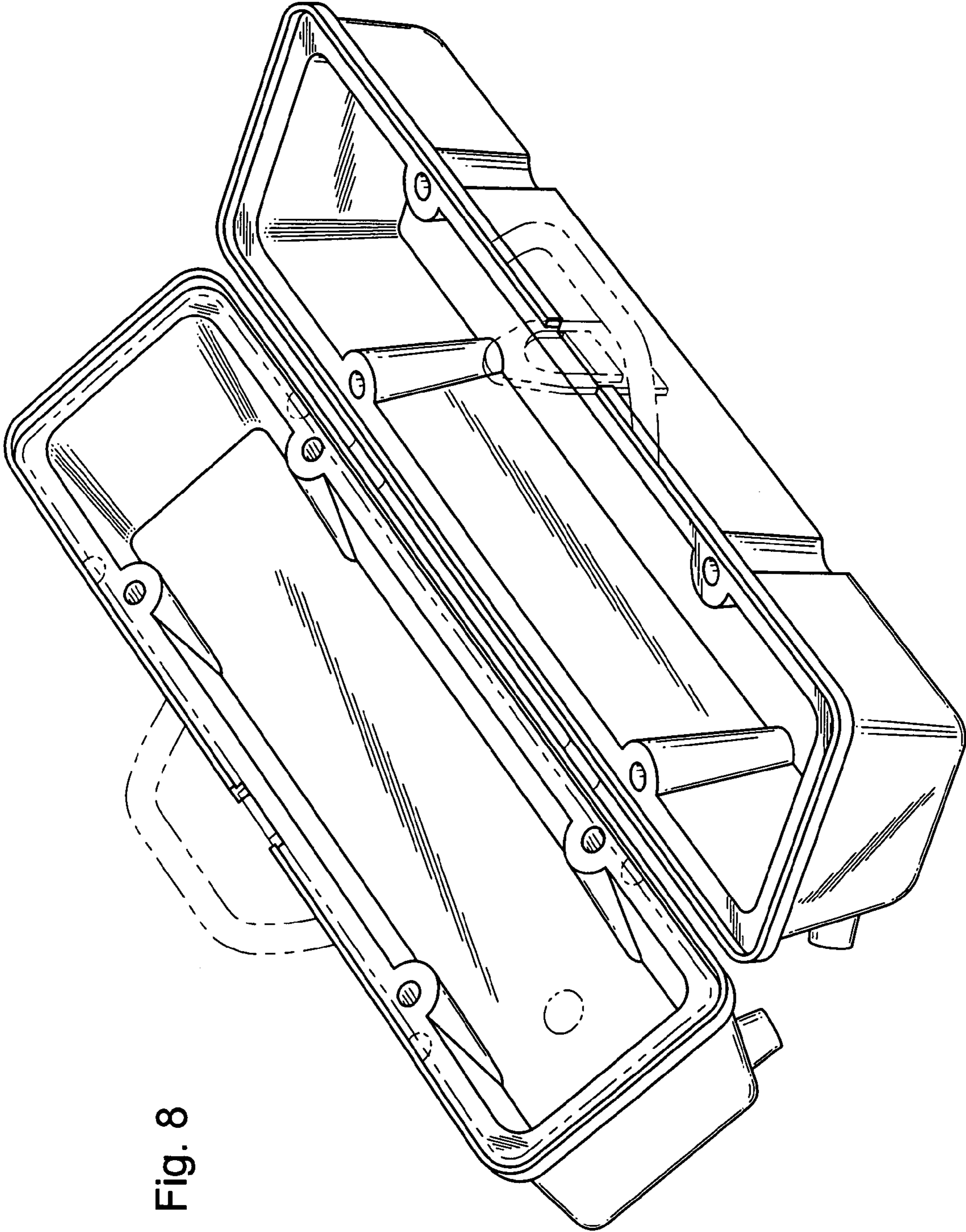
