FIG. 1 is a perspective view of a collecting container in accordance with my new design;

FIG. 2 is a front view of the collecting container in FIG. 1;

FIG. 3 is a rear view of the collecting container in FIG. 1;

FIG. 5 is a right side view of the collecting container in FIG. 1;

FIG. 6 is a top view of the collecting container in FIG. 1;

FIG. 8 is a perspective reference view of the collecting container in FIG. 1 being mounted on a positioning base; and,

FIG. 9 is a perspective reference view of the collecting container in FIG. 1 being stacked with collecting containers and being open.

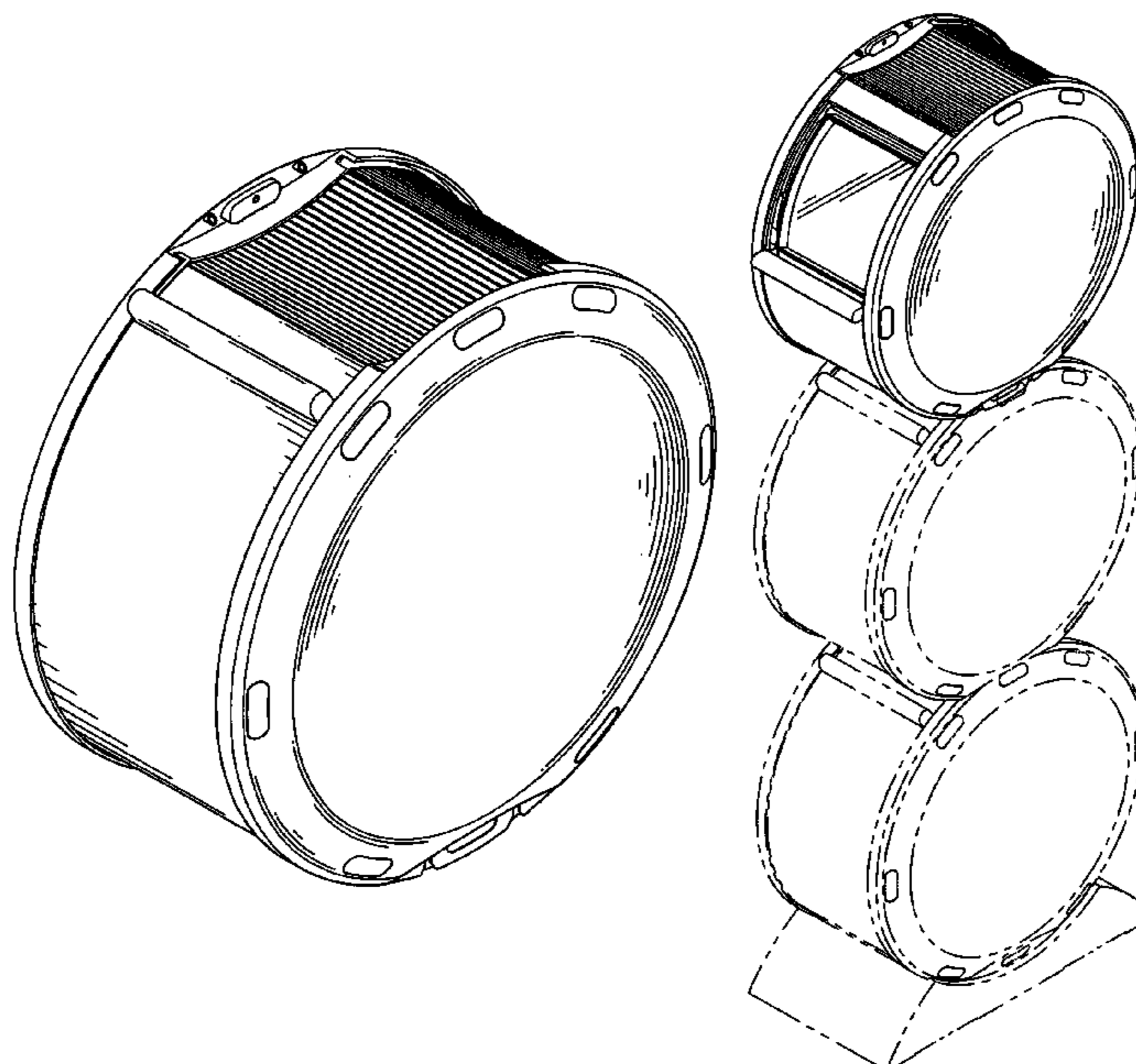

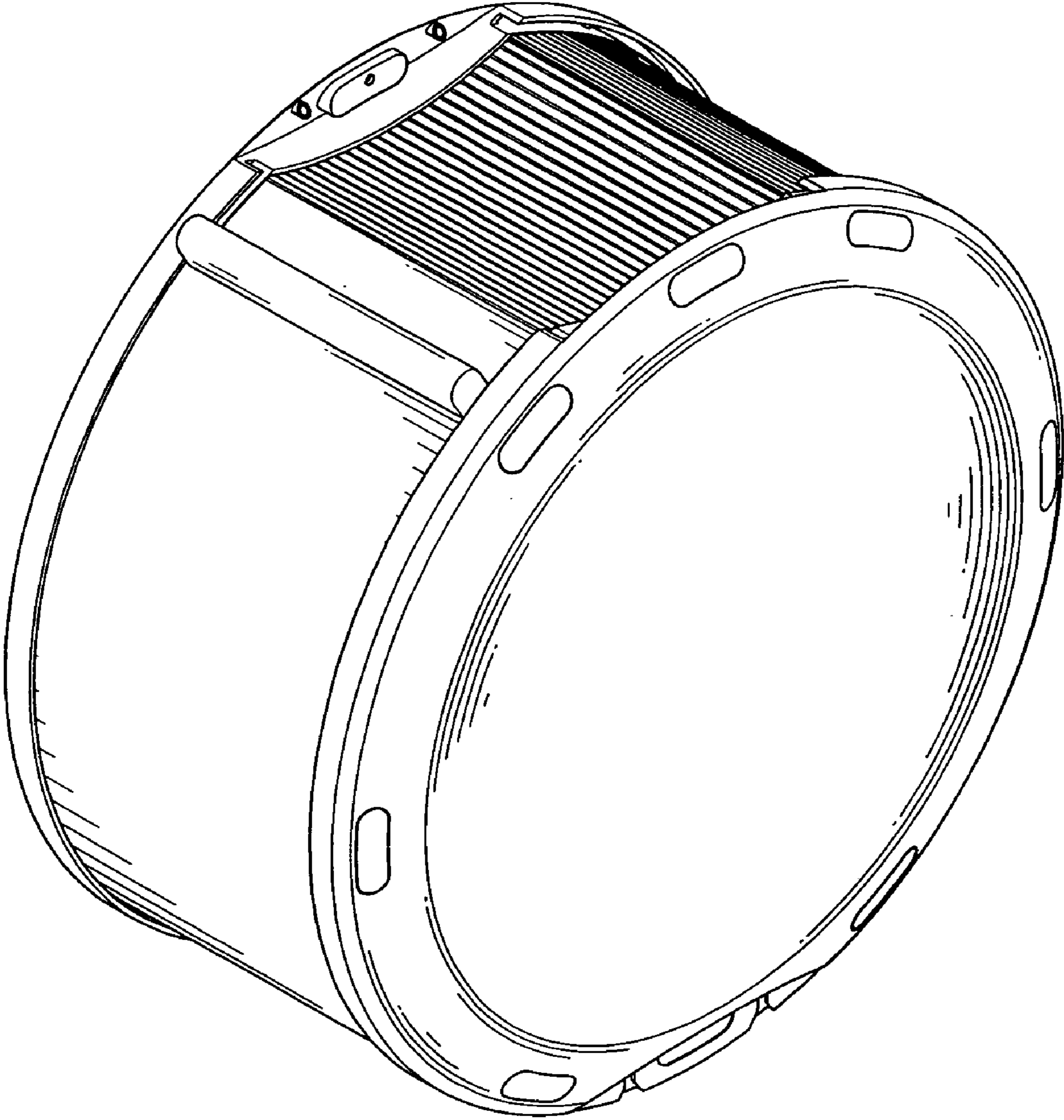

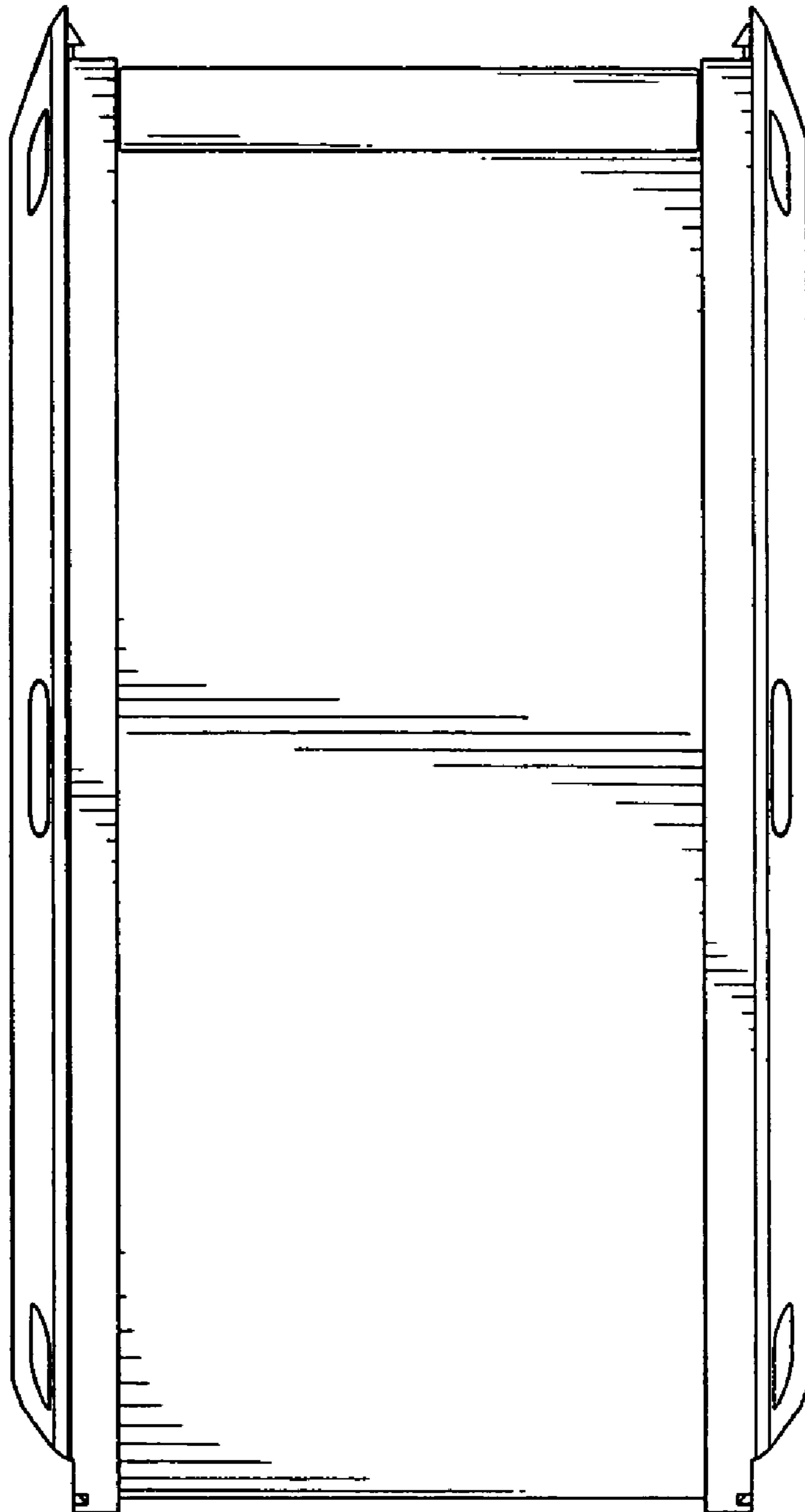

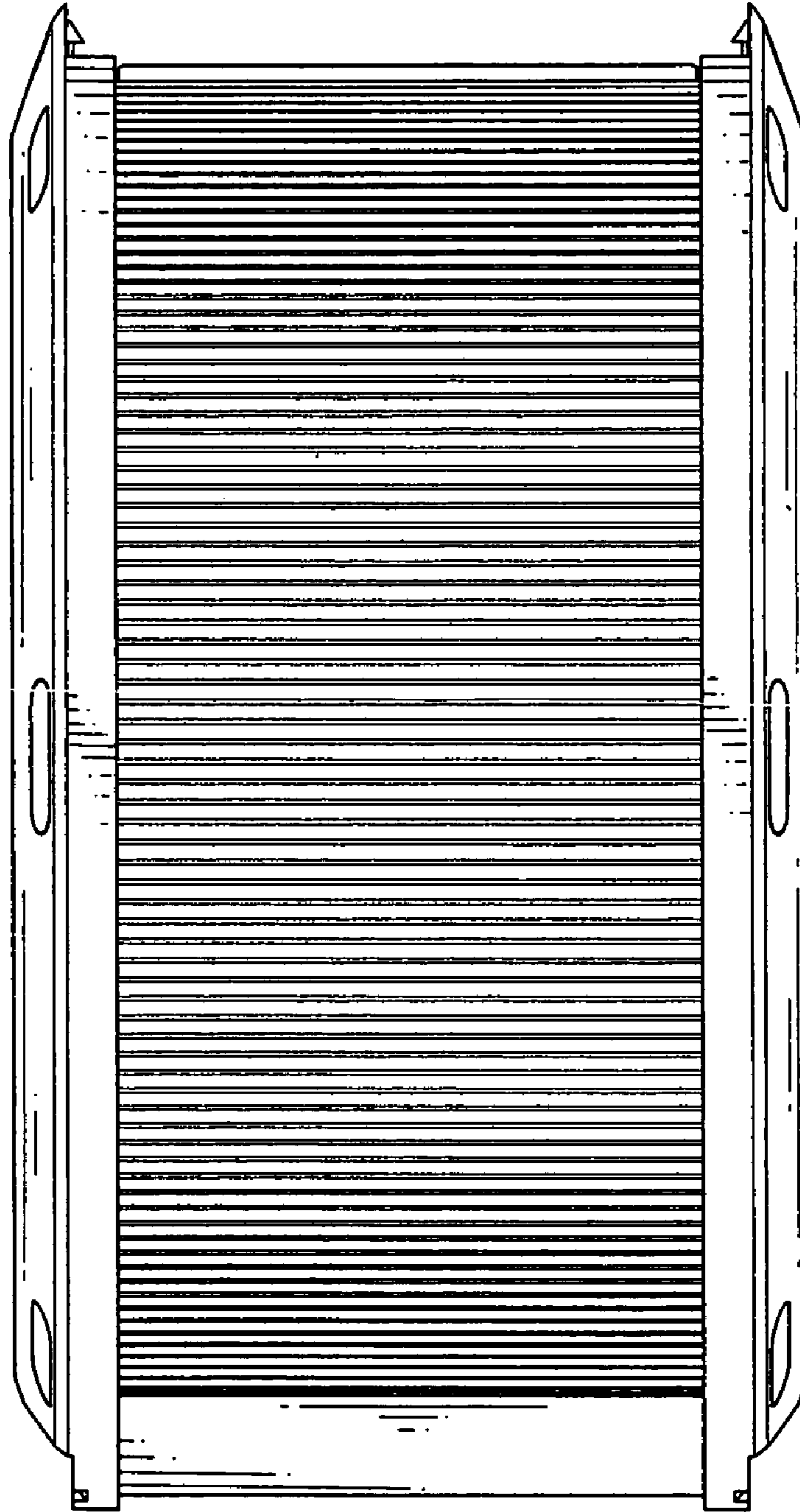

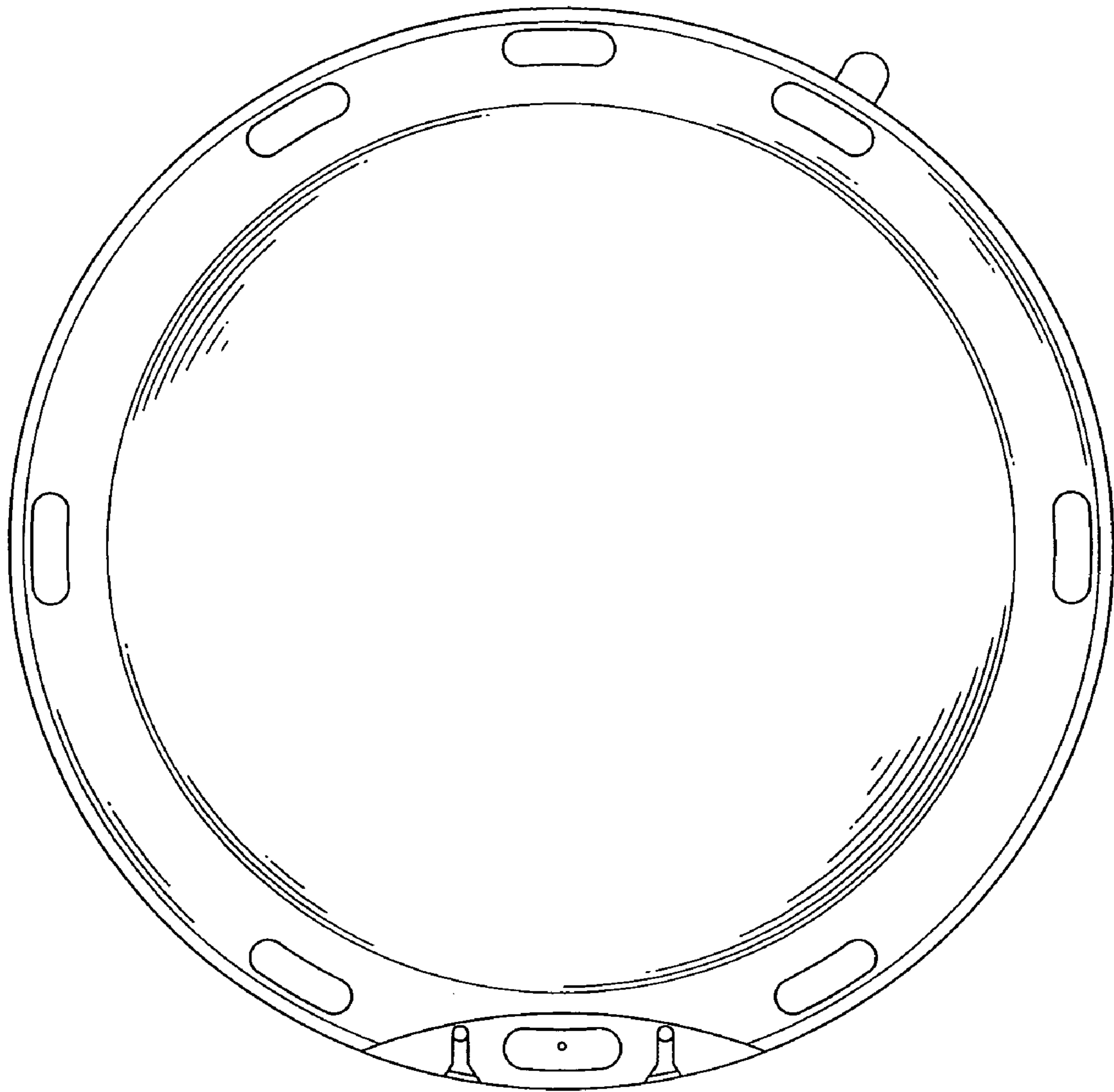

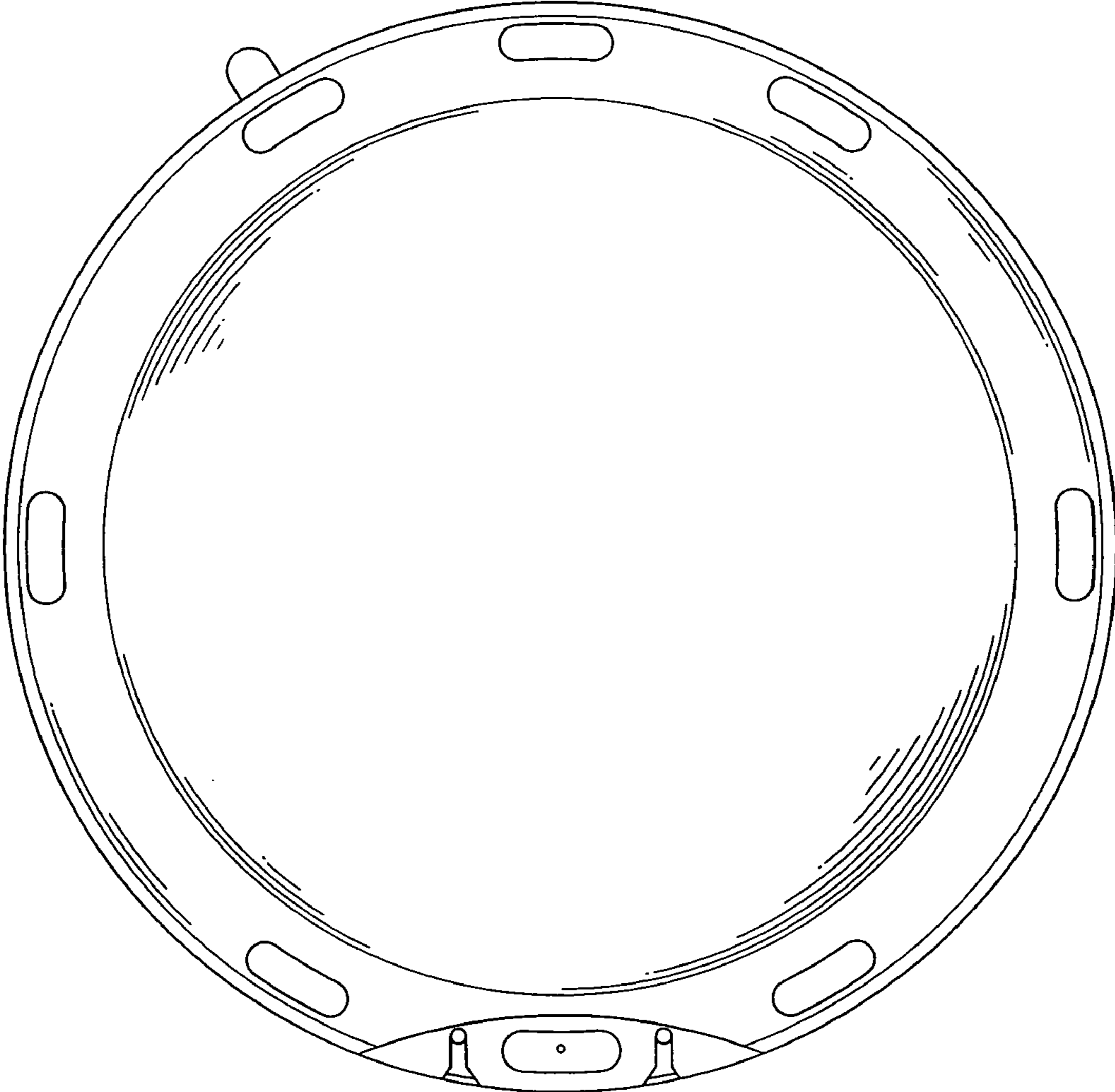

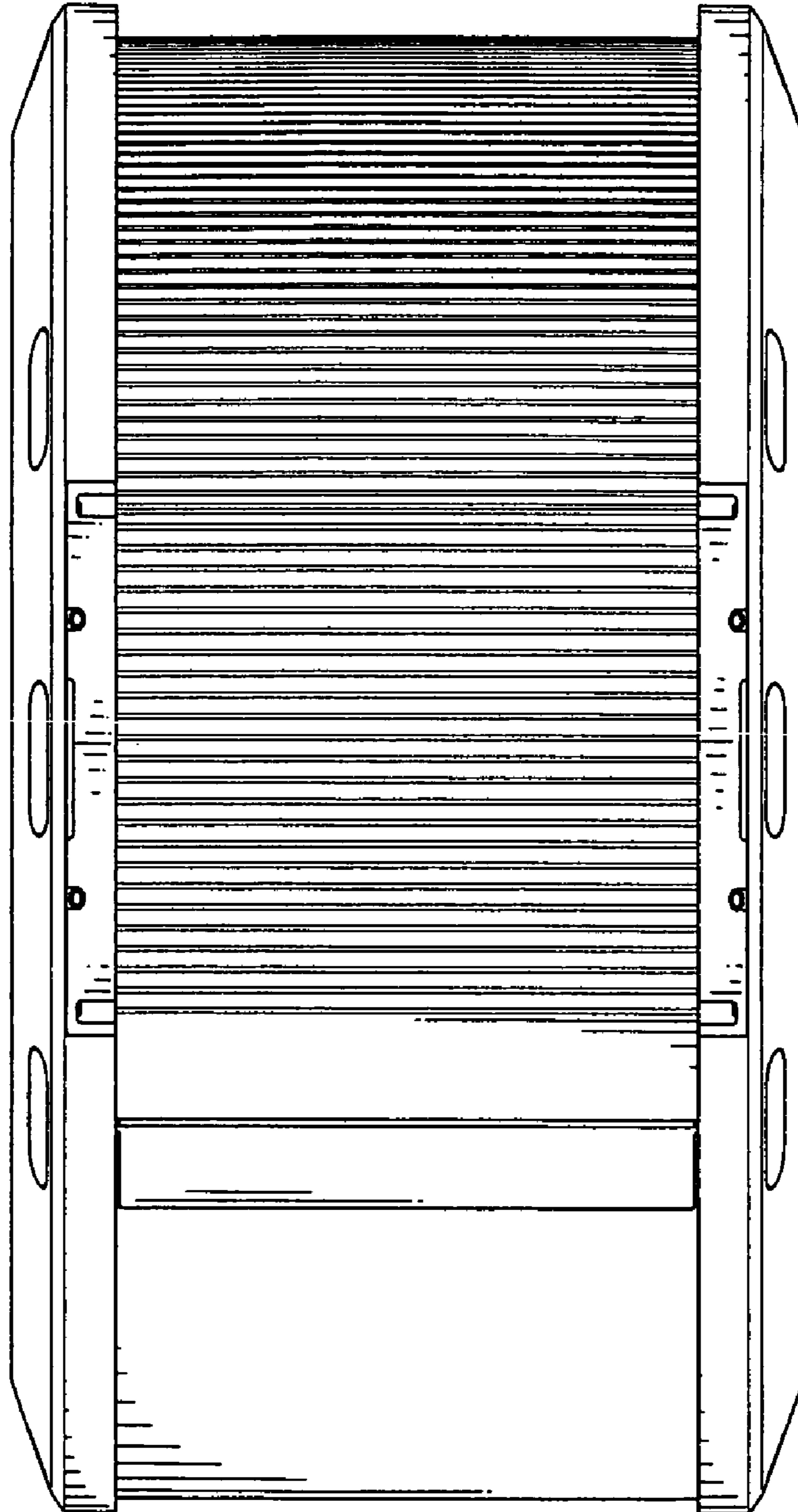

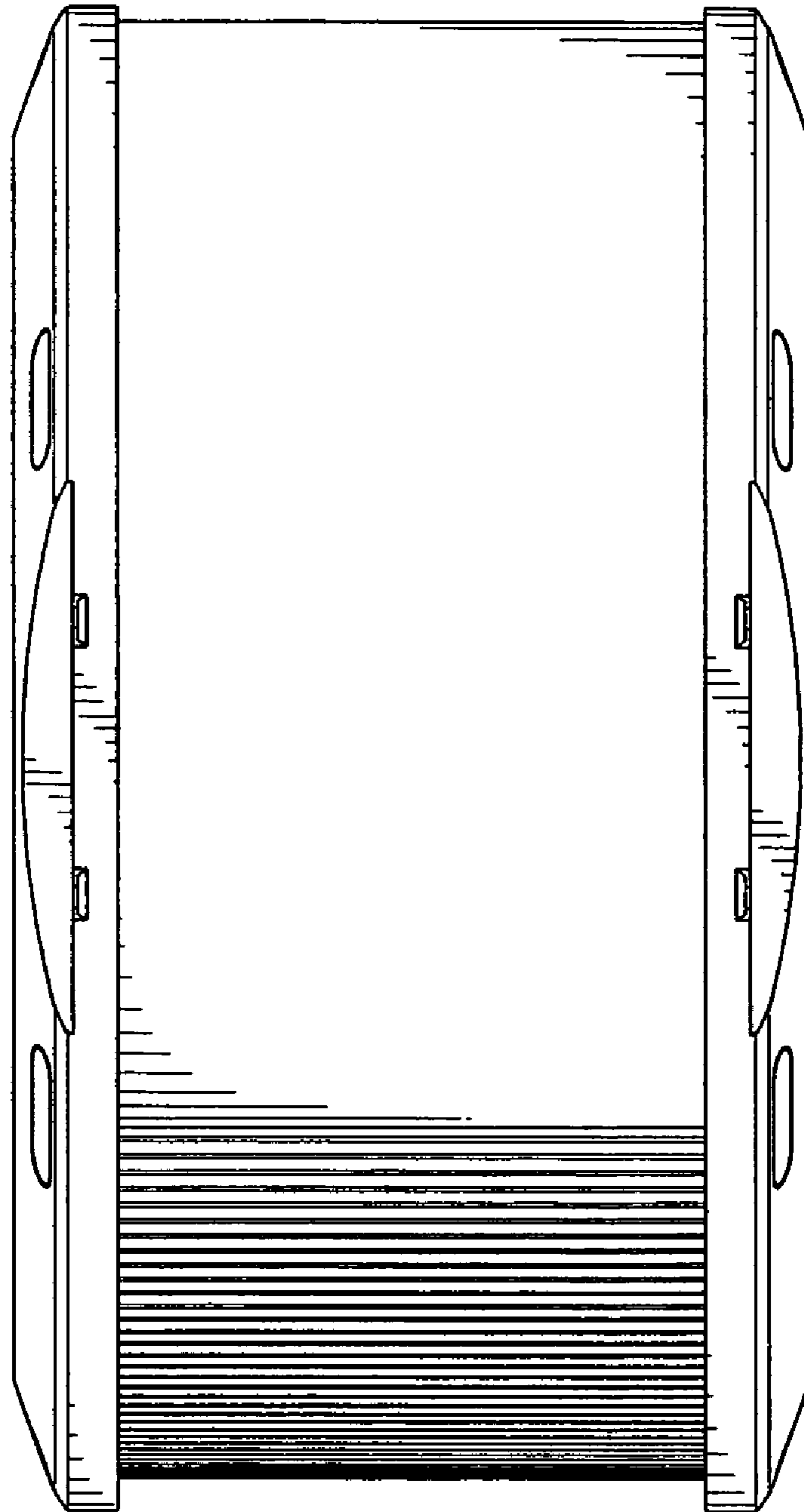

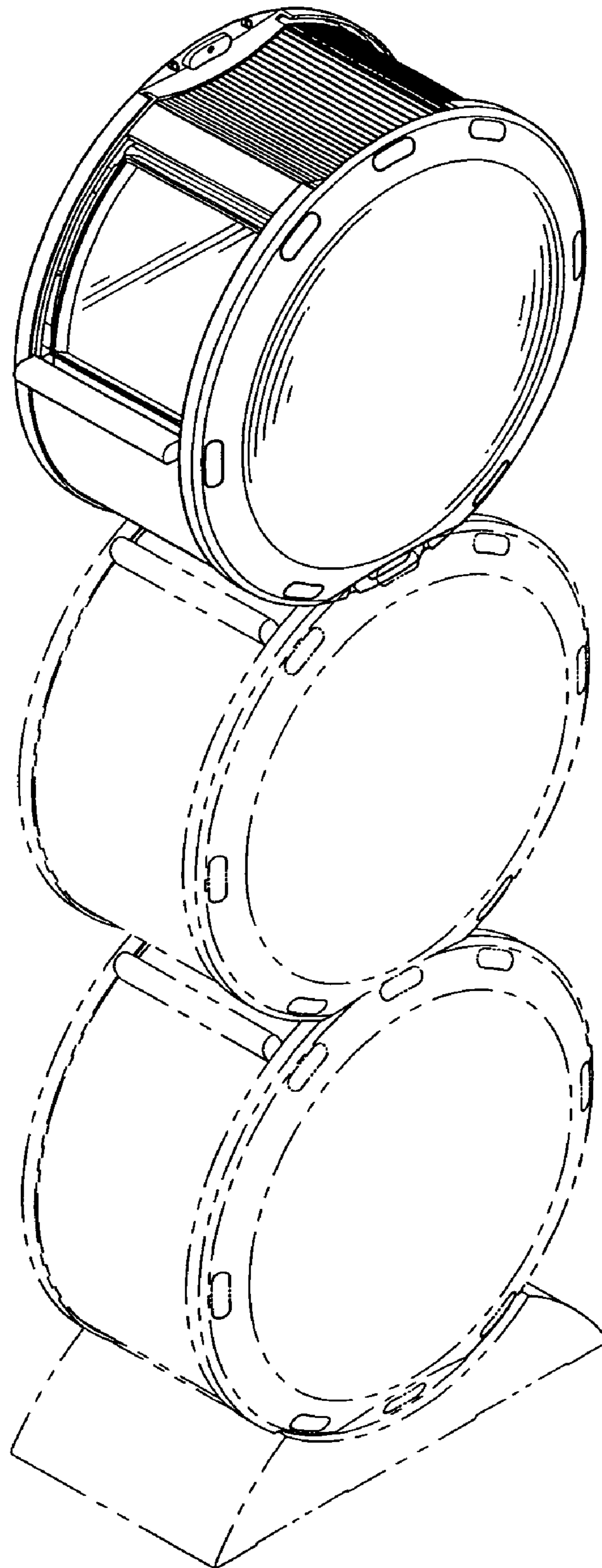
