area of FIG. 5; and,

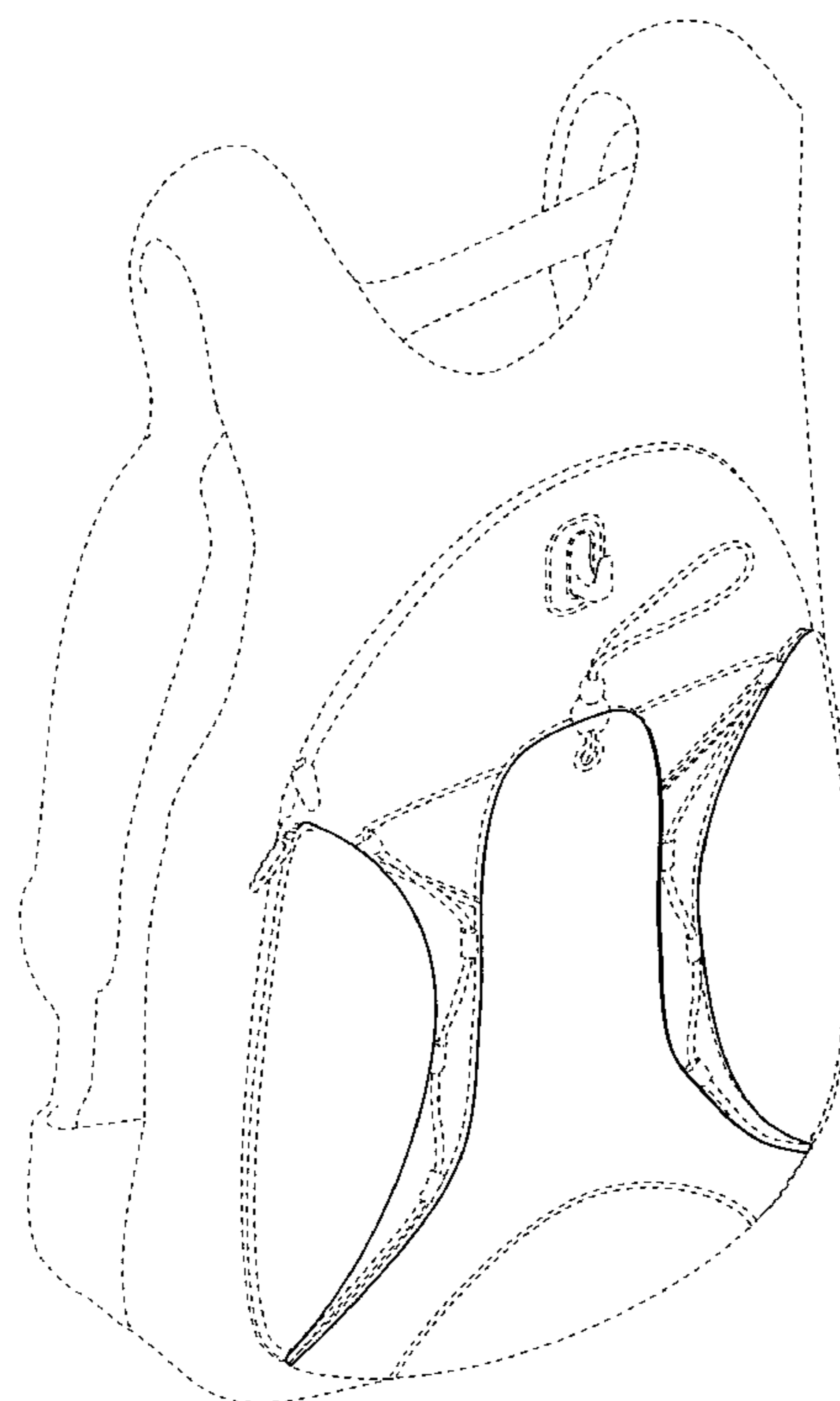
FIG. 7 is a front view of the backpack with expandable area

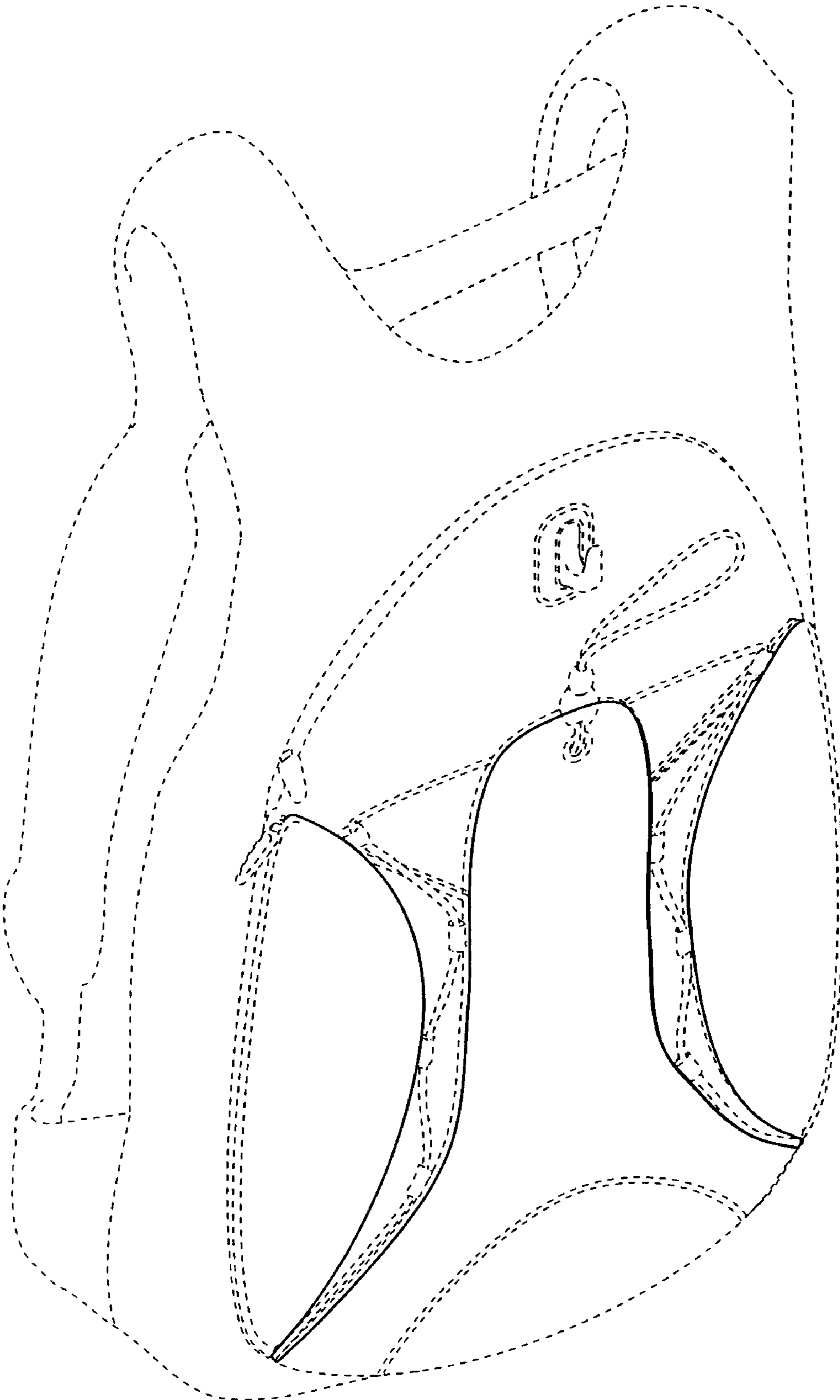

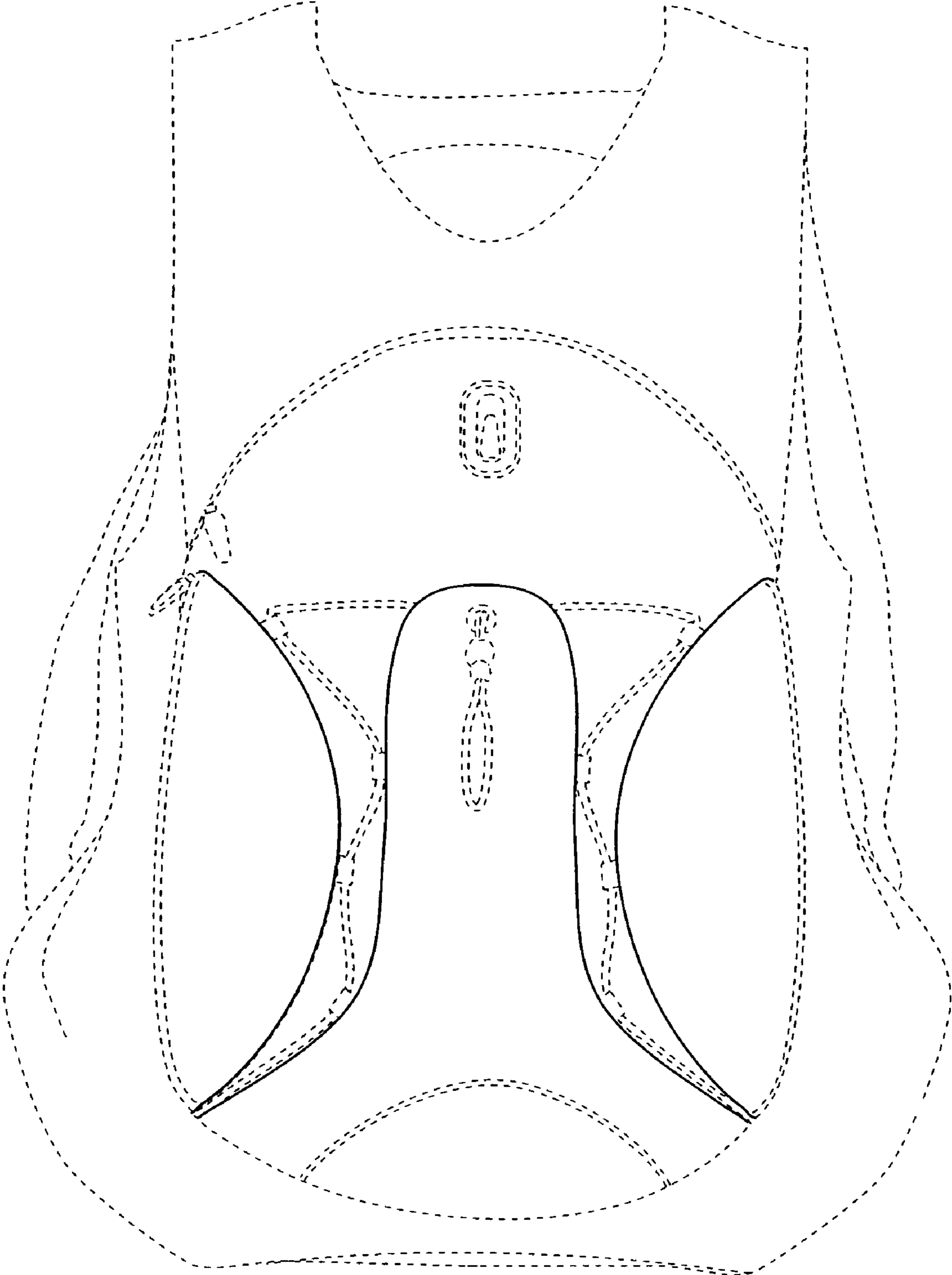

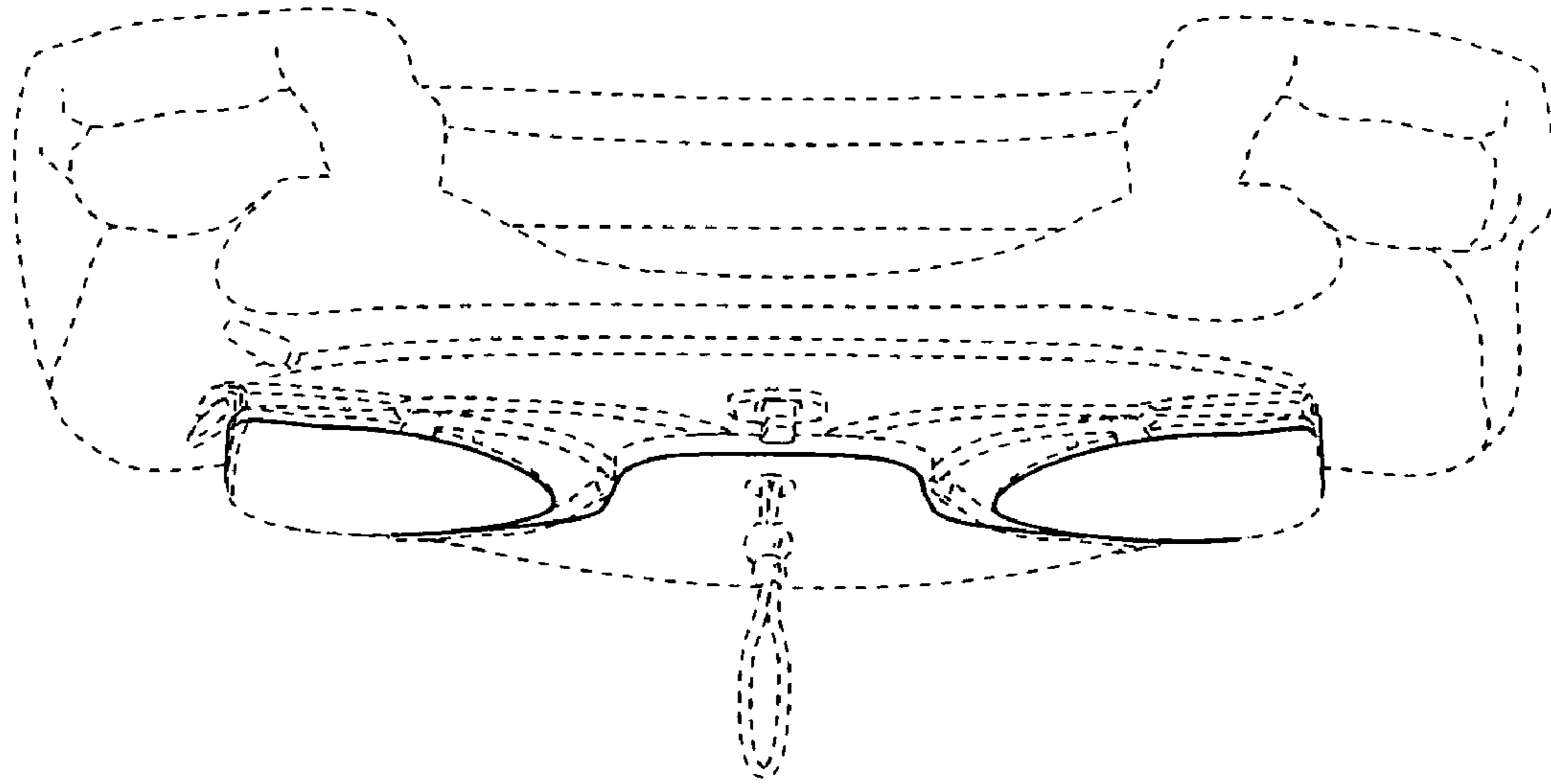

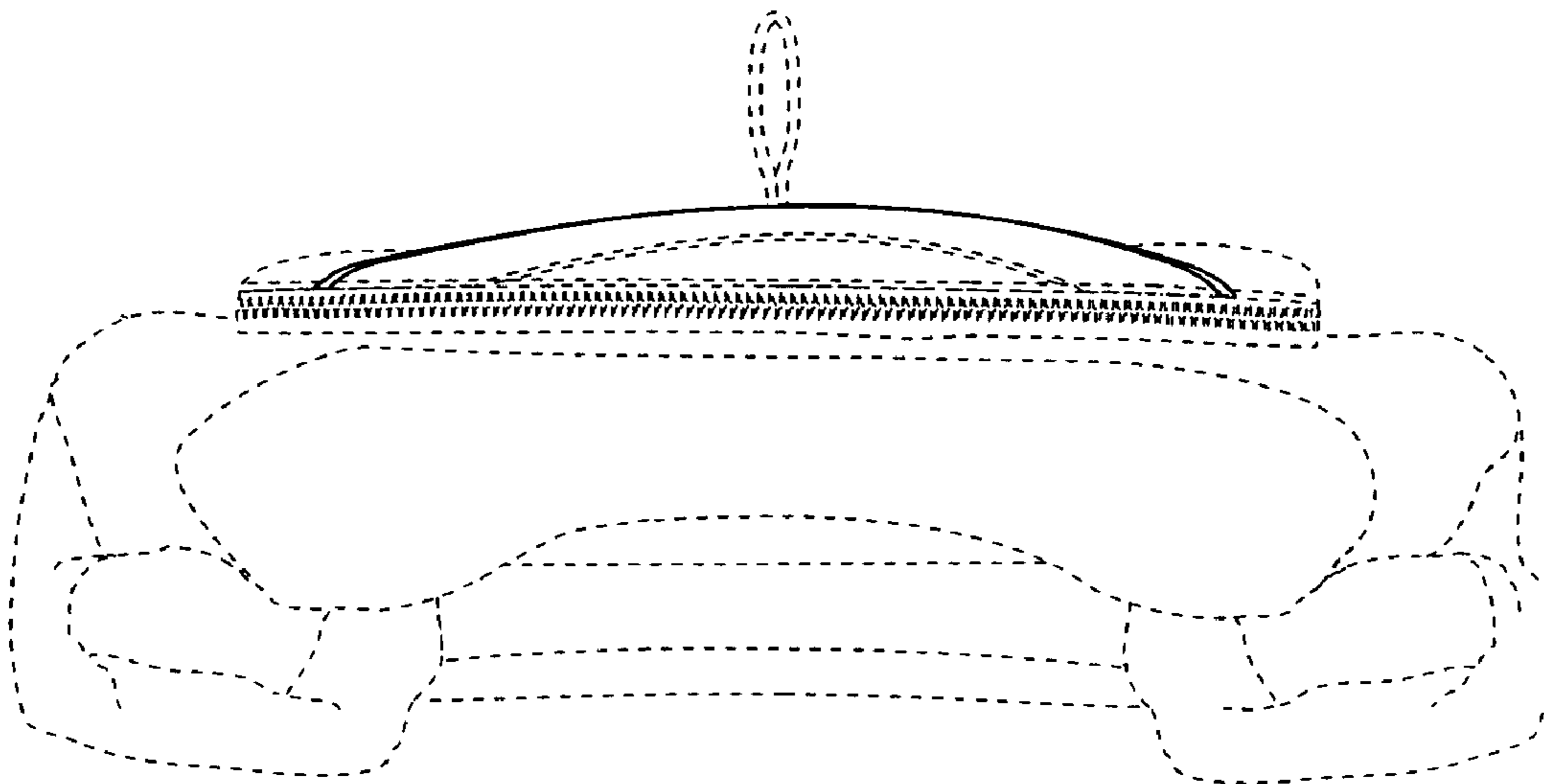

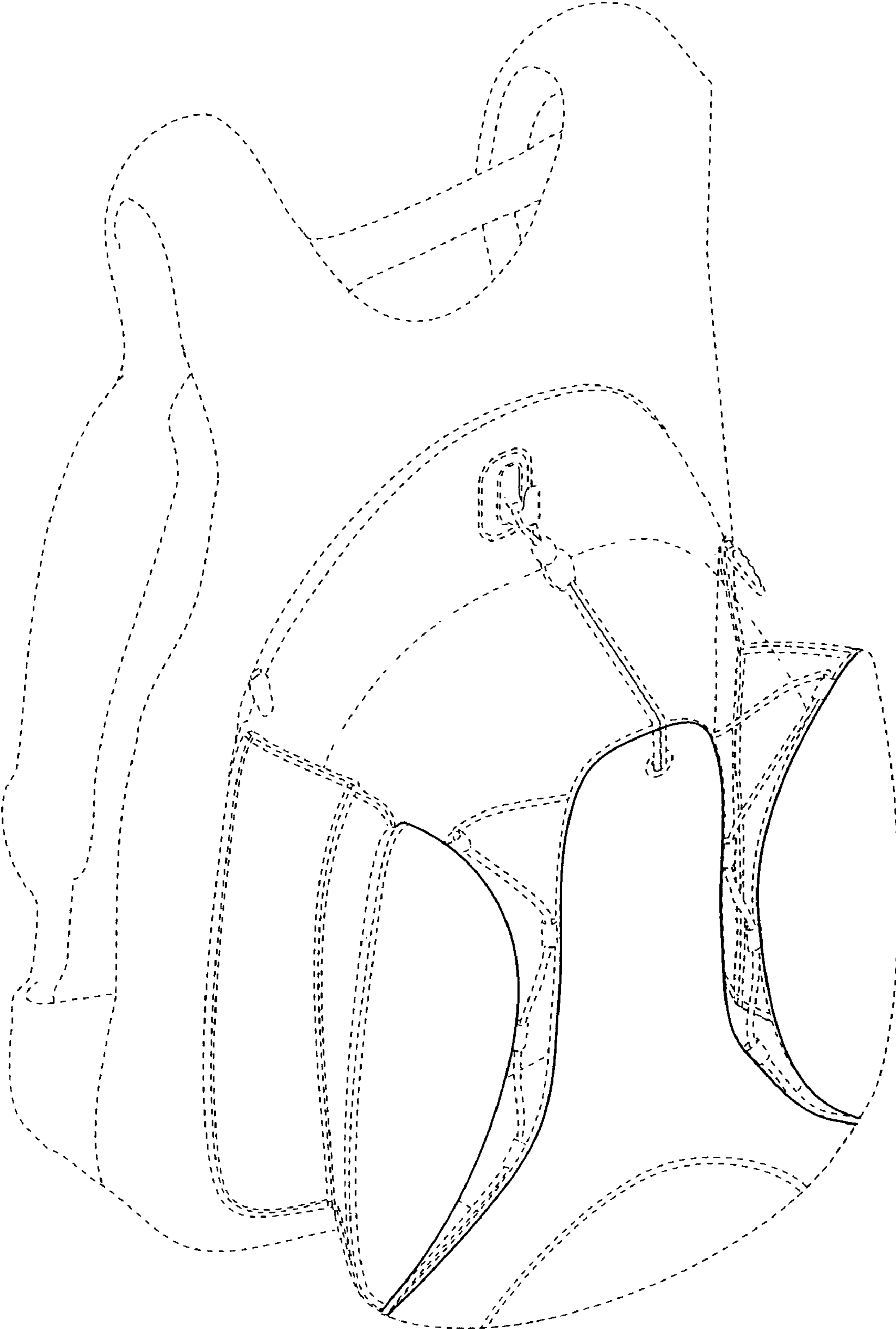

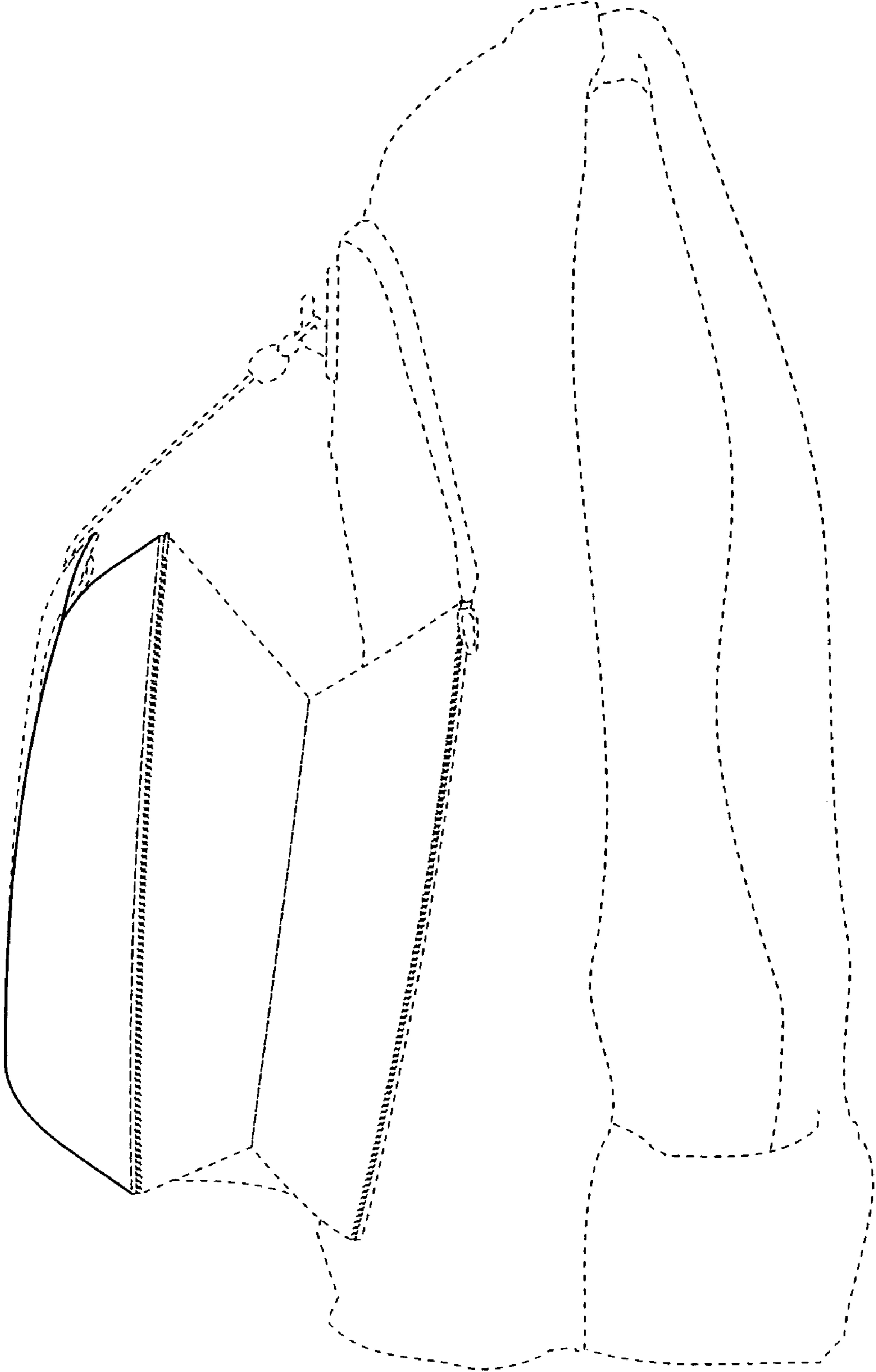

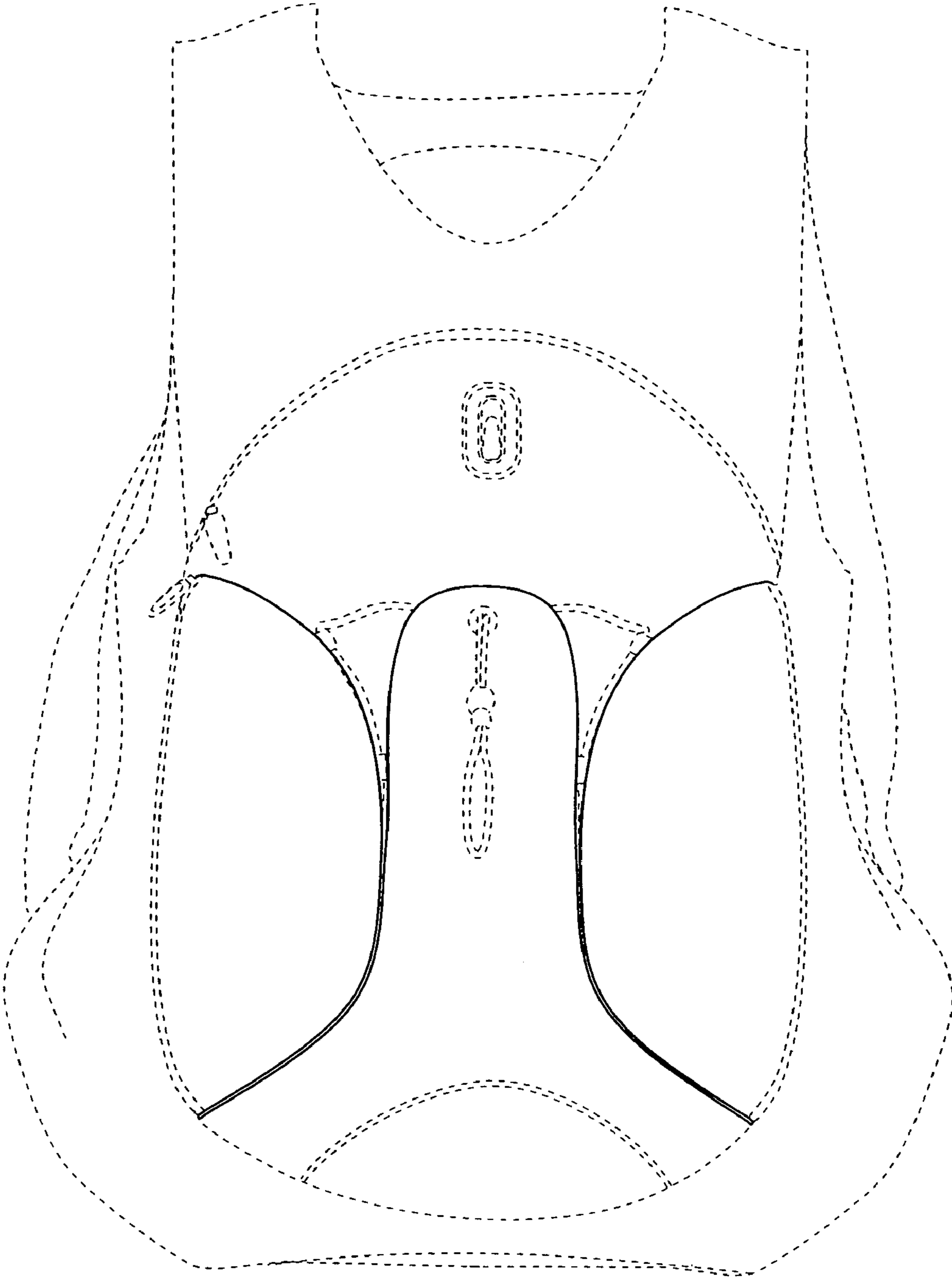
