**DESCRIPTION**

FIG. 1 is a front, left perspective view of a lid for a storage box showing my new design;

FIG. 3 is a rear elevational view thereof, the front elevational view thereof being identical thereto;

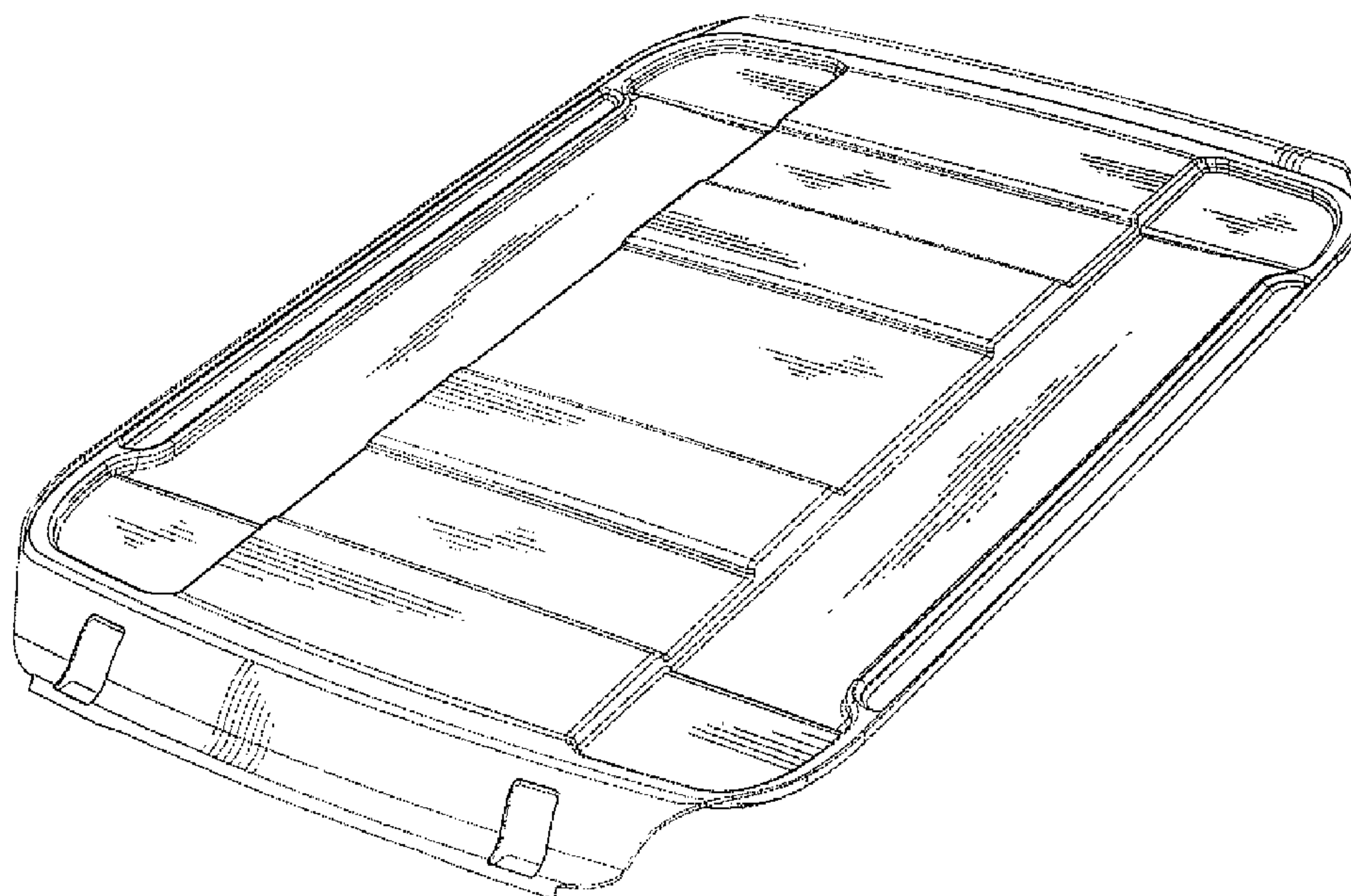
FIG. 4 is a top plan view thereof;

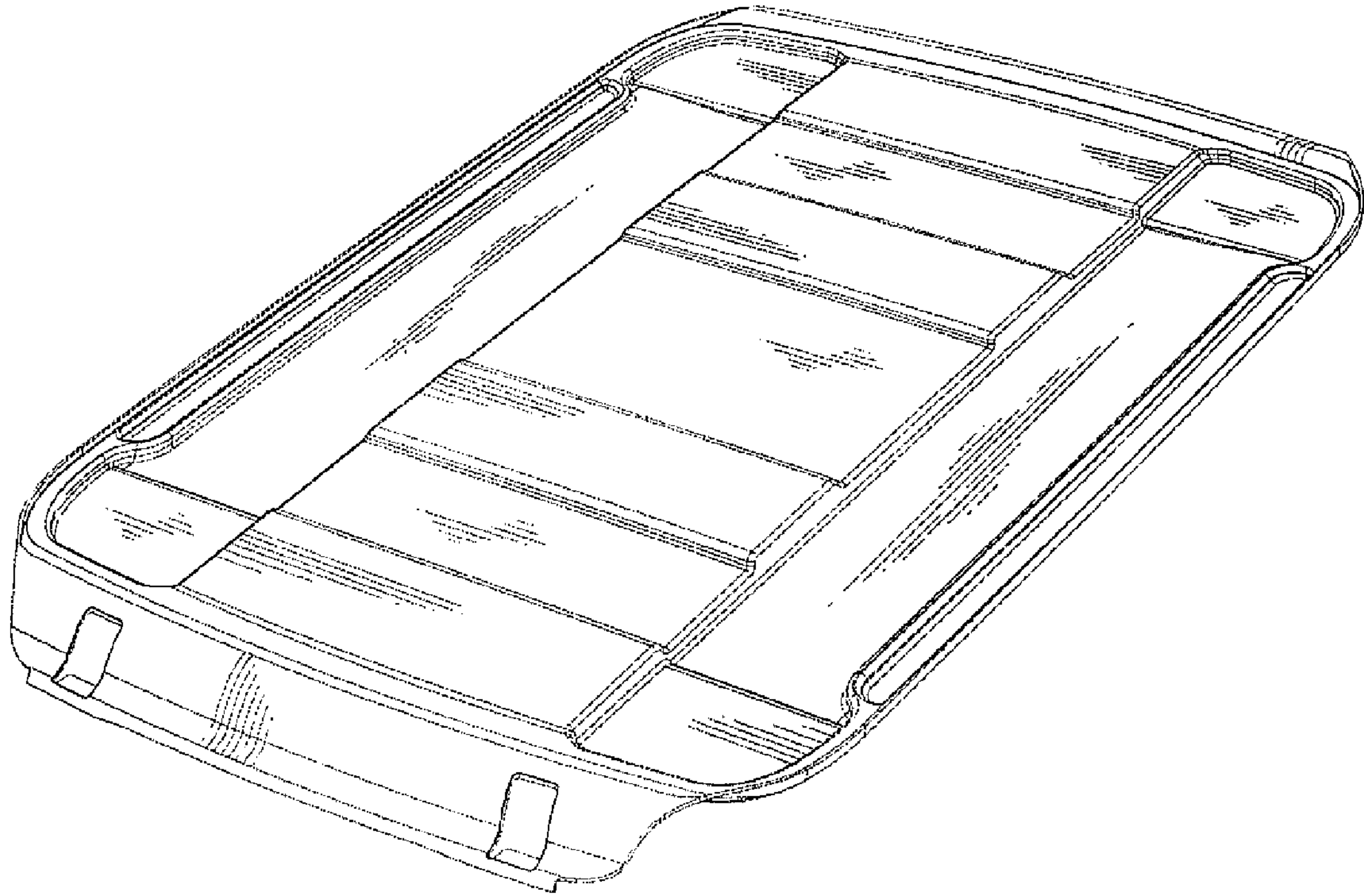

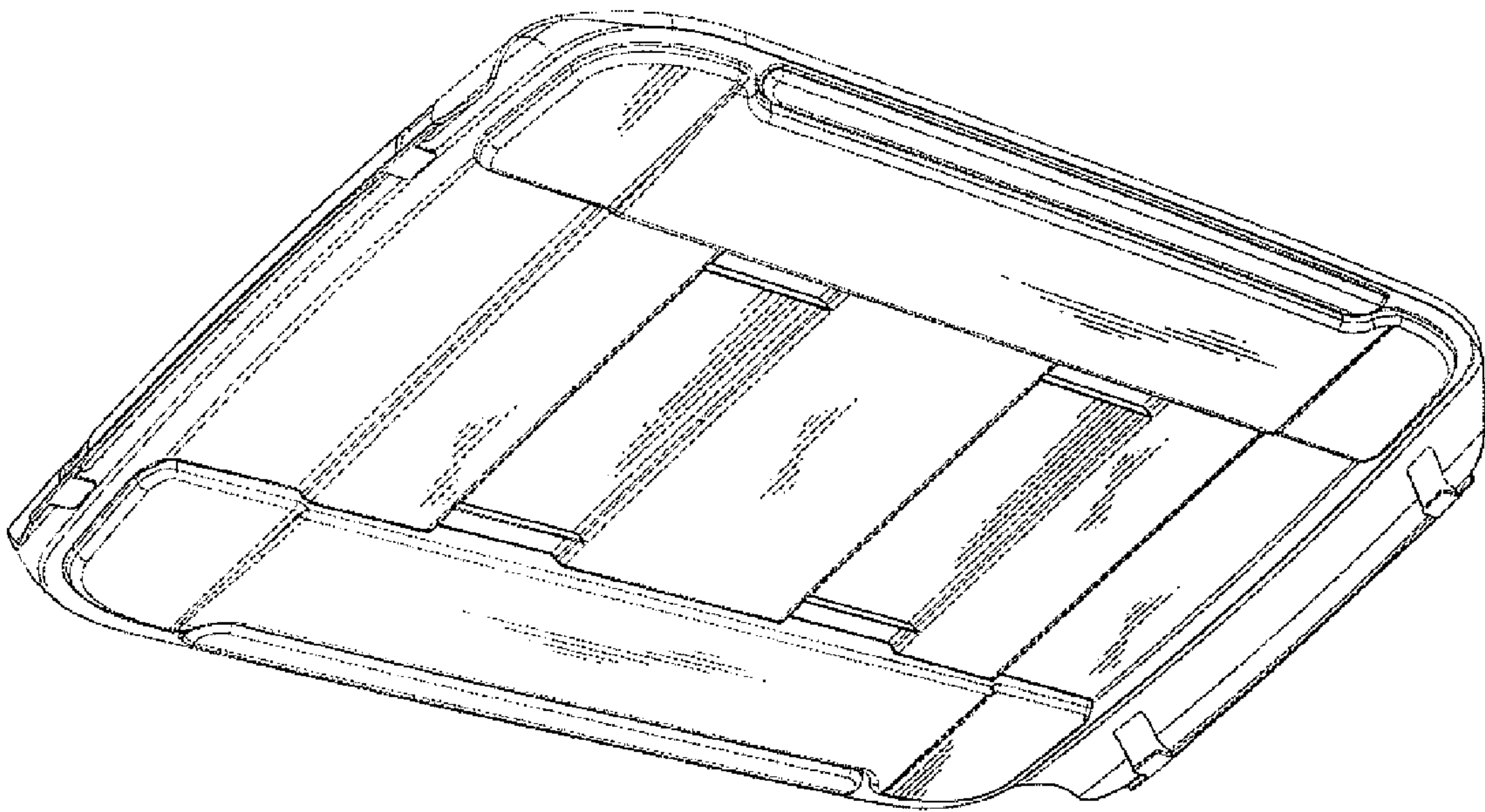

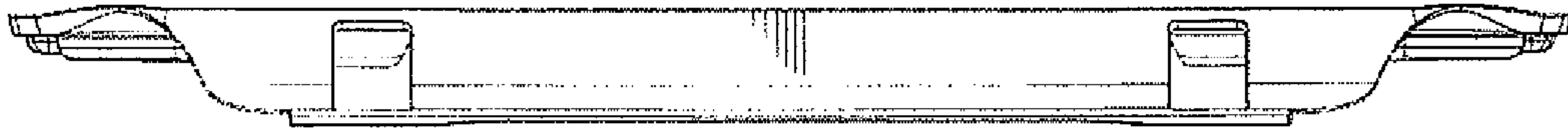

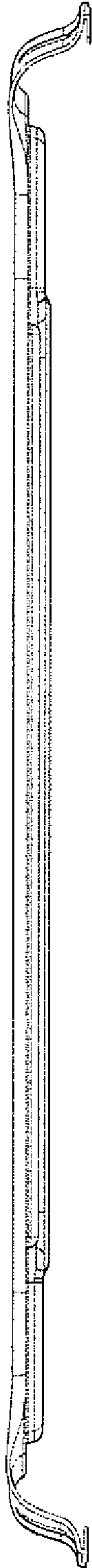

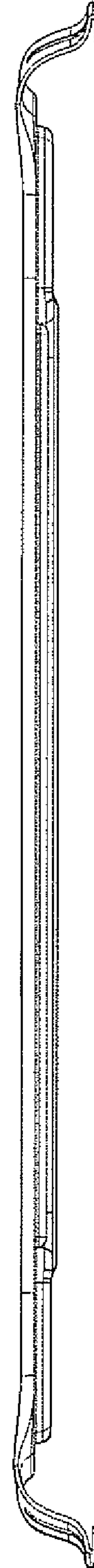

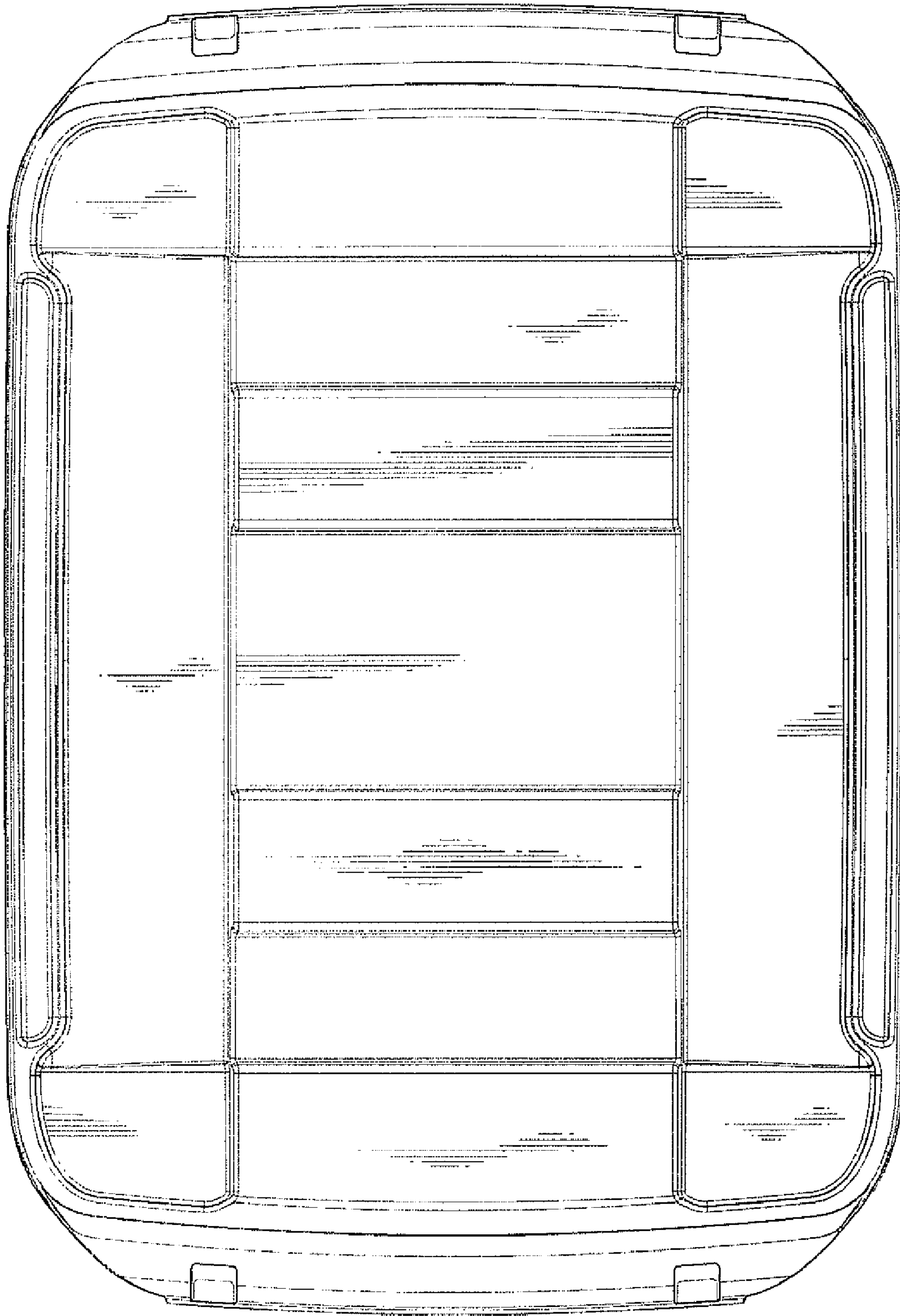

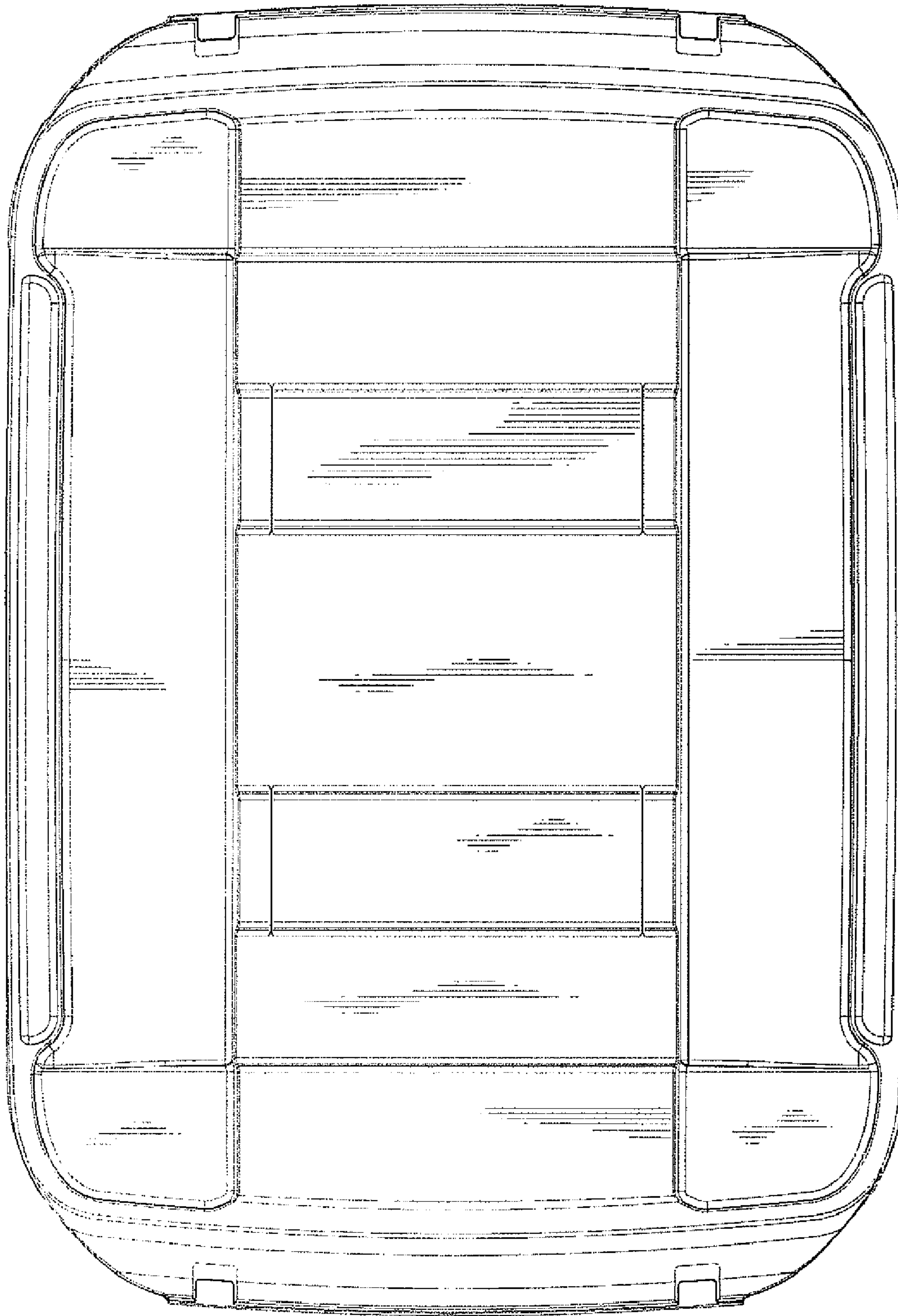
