(57) **CLAIM**

The ornamental design for a handle portion for a utensil, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle portion for a utensil, showing my design;

FIG. 2 is a lower perspective view of the handle portion for a utensil shown in FIG. 1;

FIG. 3 is an upper plan of the handle portion for a utensil shown in FIG. 1;

FIG. 4 is a lower plan view of the handle portion for a utensil shown in FIG. 1;

FIG. 5 is a right side elevation view of the handle portion for a utensil shown in FIG. 1;

FIG. 6 is a left side elevation view of the handle portion for a utensil shown in FIG. 1;

FIG. 7 is a front end elevation view of the handle portion for a utensil shown in FIG. 1;

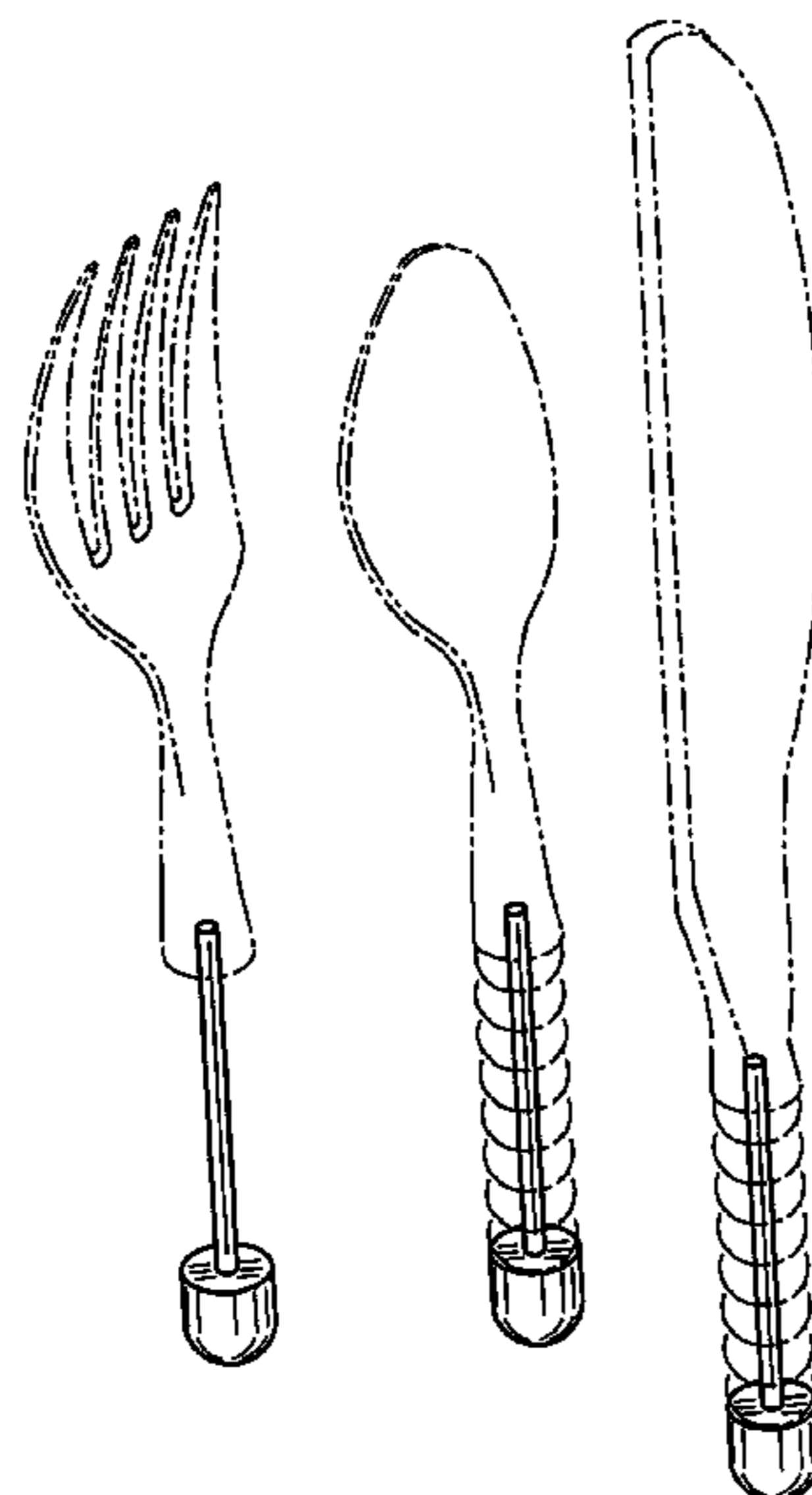
FIG. 8 is a back end elevation view of the handle portion for a utensil shown in FIG. 1;

FIG. 9 is a perspective view of a handle portion for a utensil of FIGS. 1 through 8 being used, by way of example only, with exemplary beads forming a handle of an exemplary spoon; and,

FIG. 10 is a perspective view of a handle portion for a utensil of FIGS. 1 through 8 being used, by way of example only, with exemplary beads forming a handle of an exemplary knife.

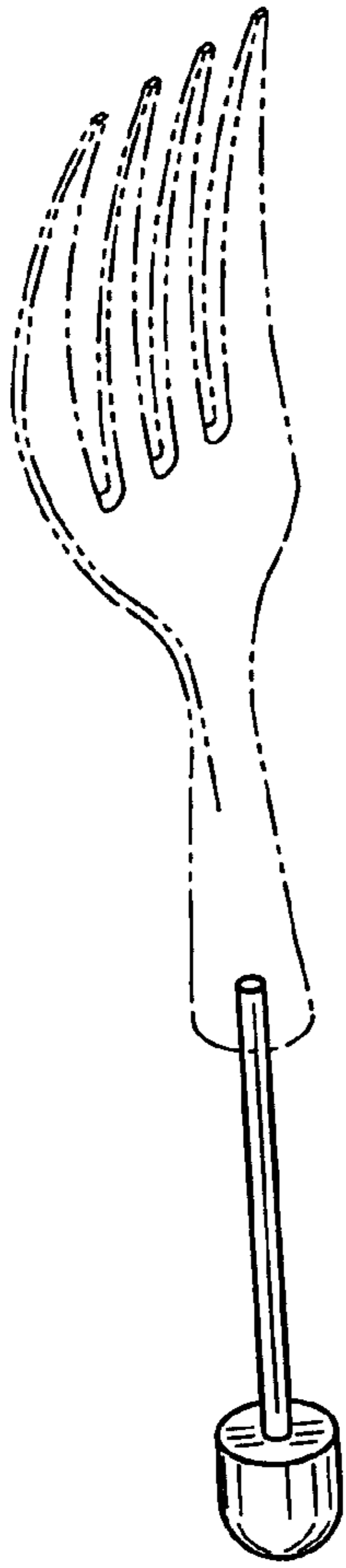

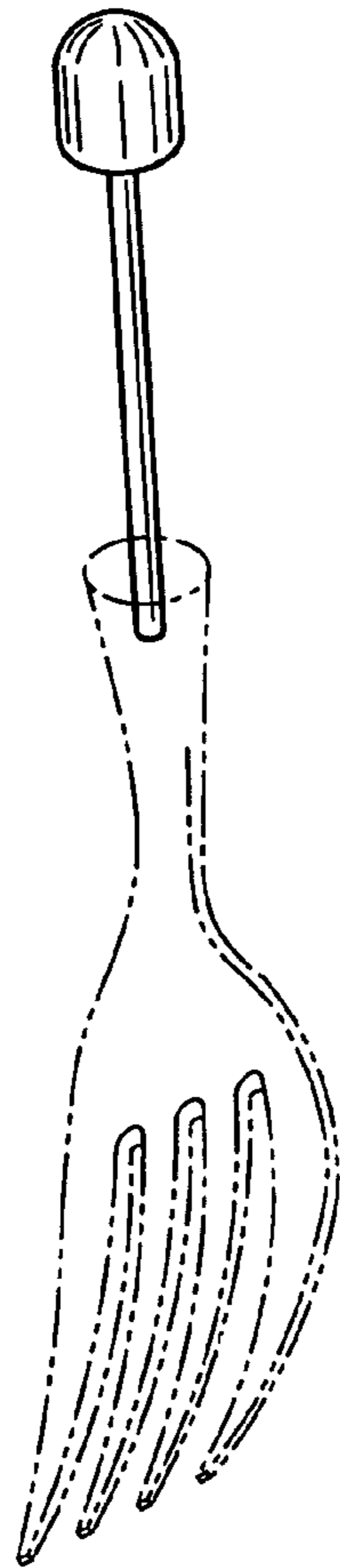

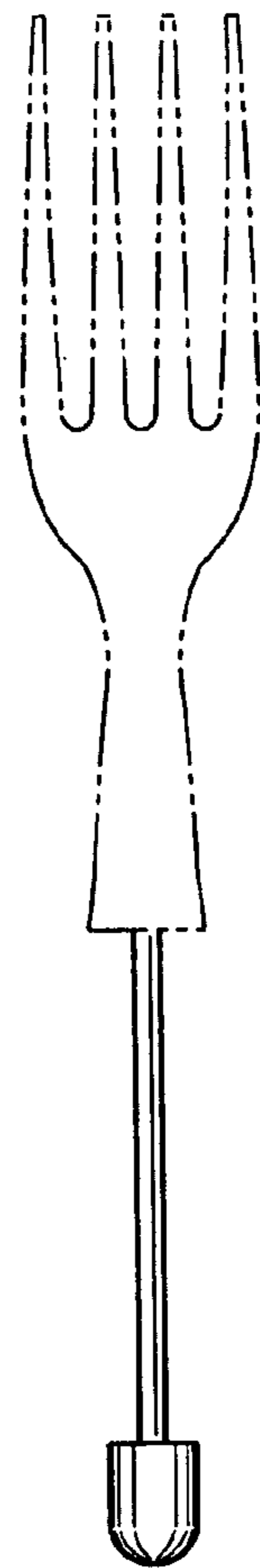

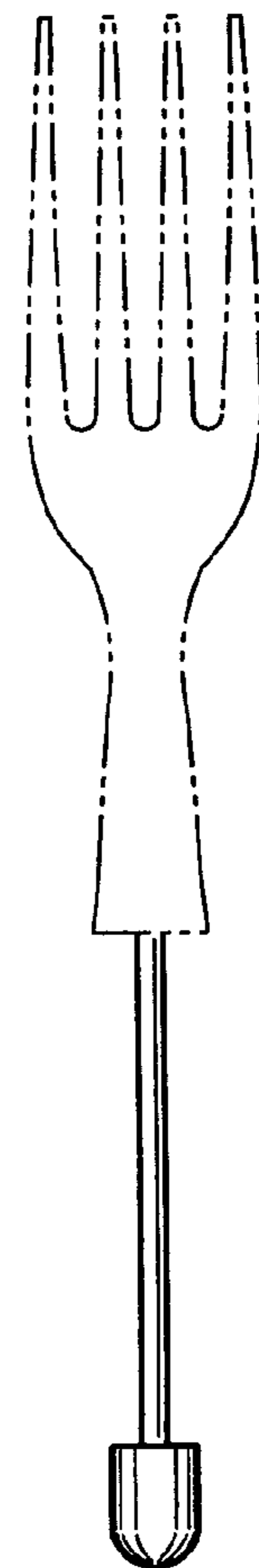

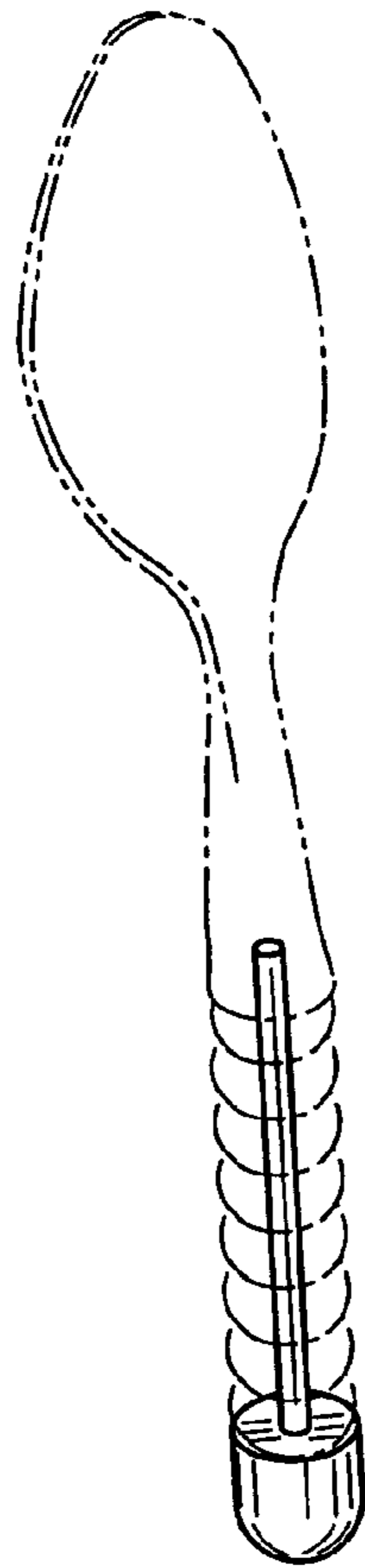

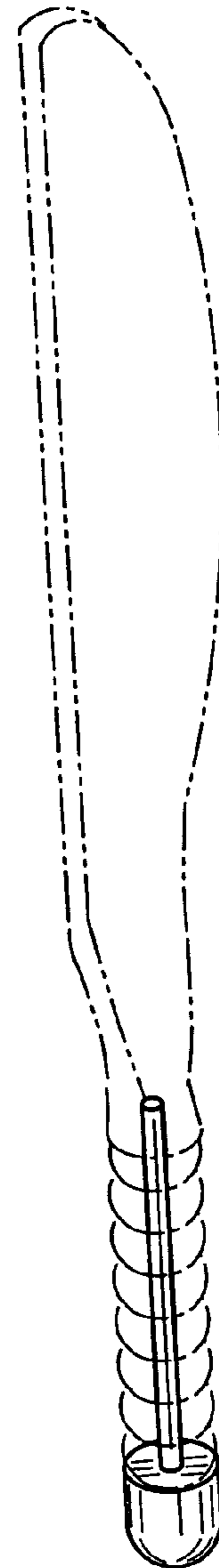
