DESCRIPTION

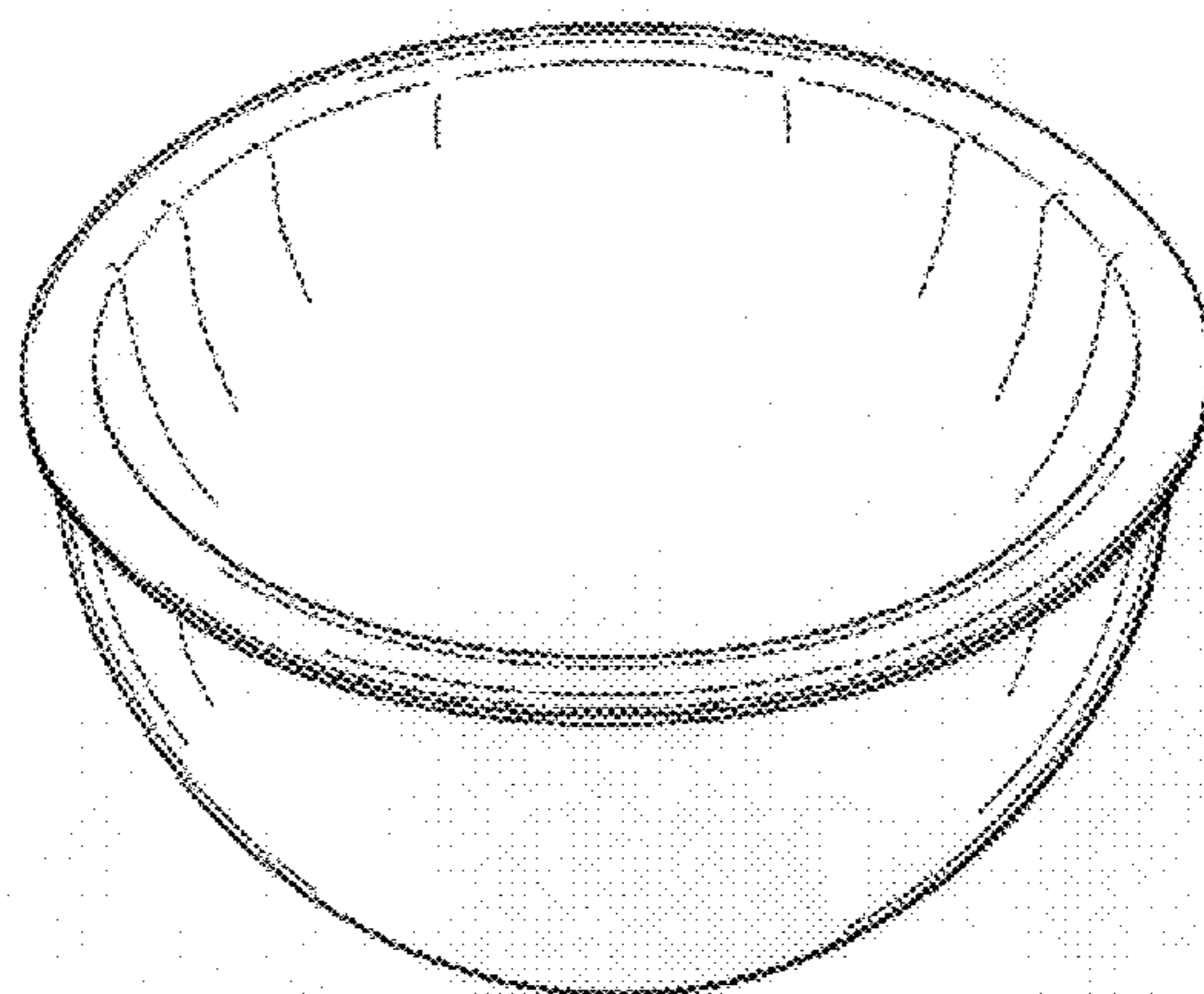
FIG. 1 is a perspective view of a mixing bowl, showing the new design;

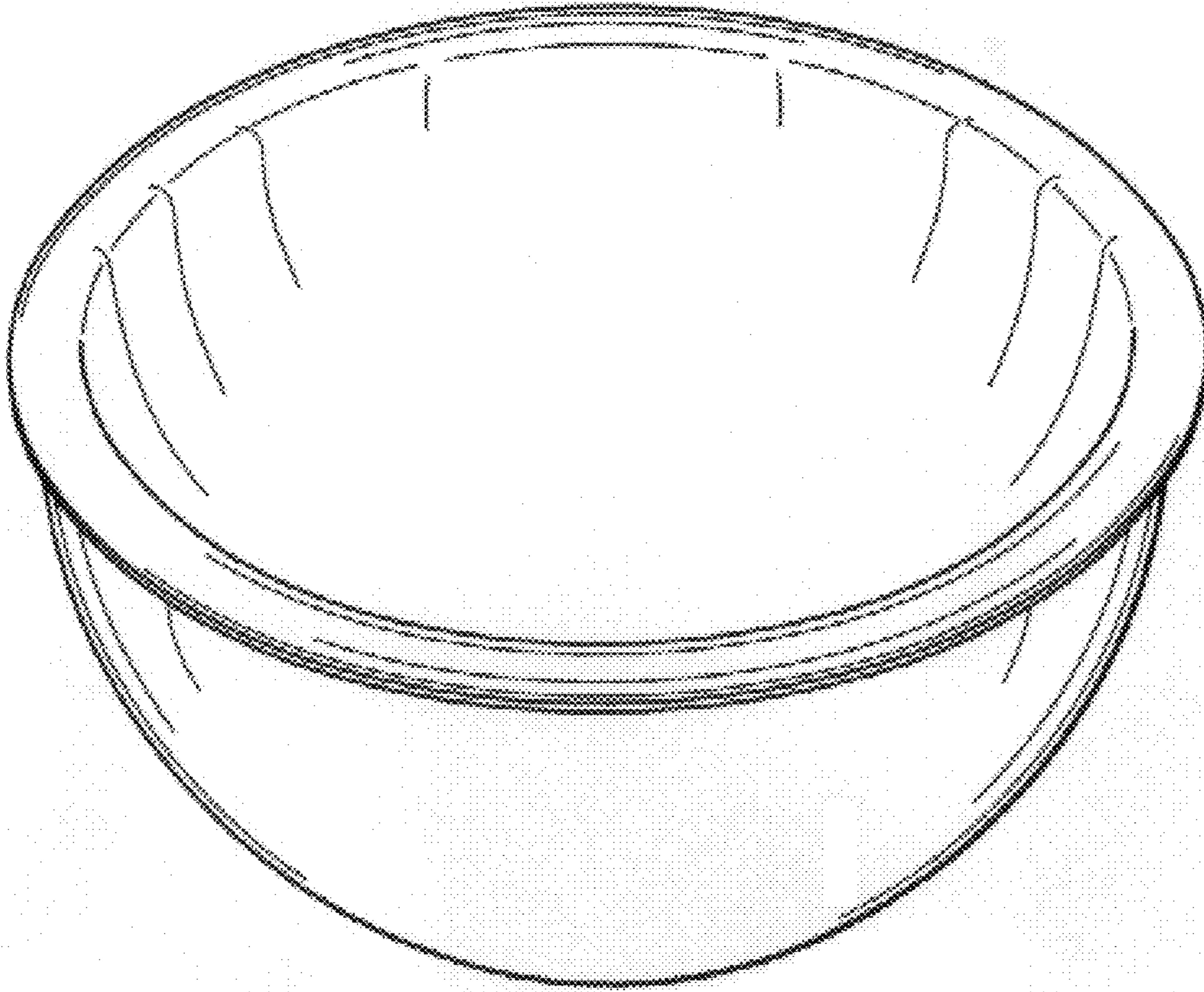

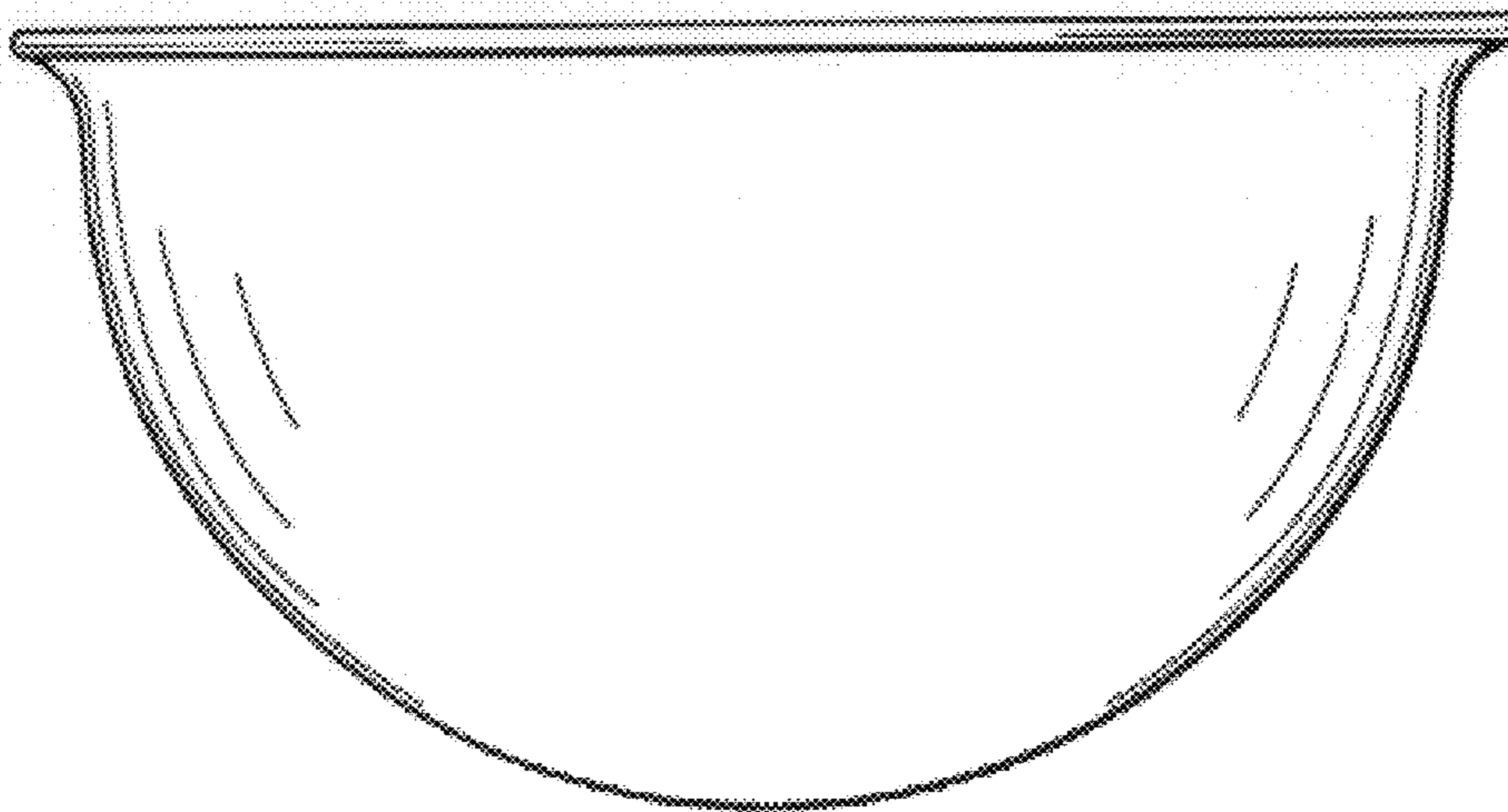

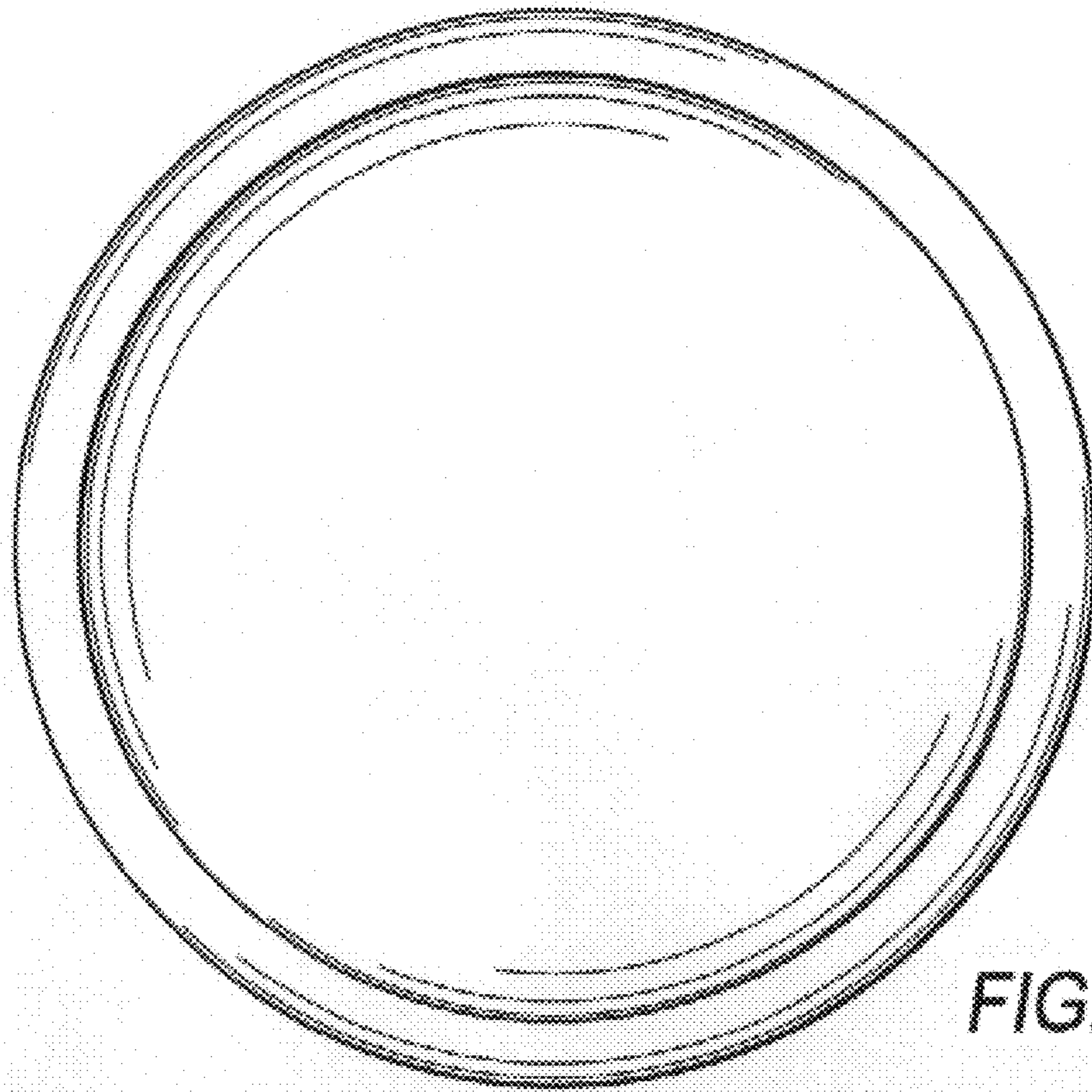

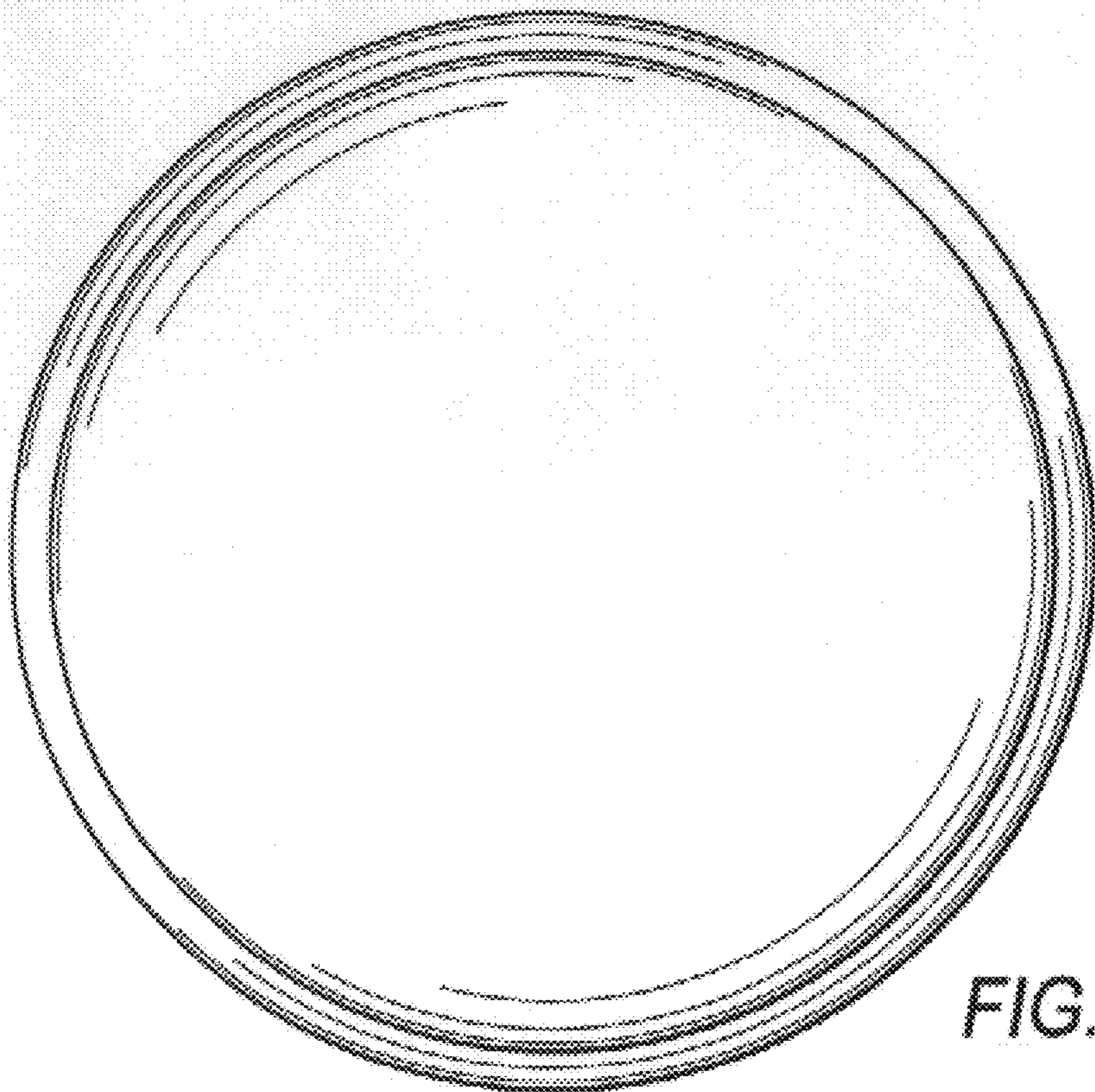
