FIG. 1 is a top, side and front isometric view of my lightweight wire support and showing my design;

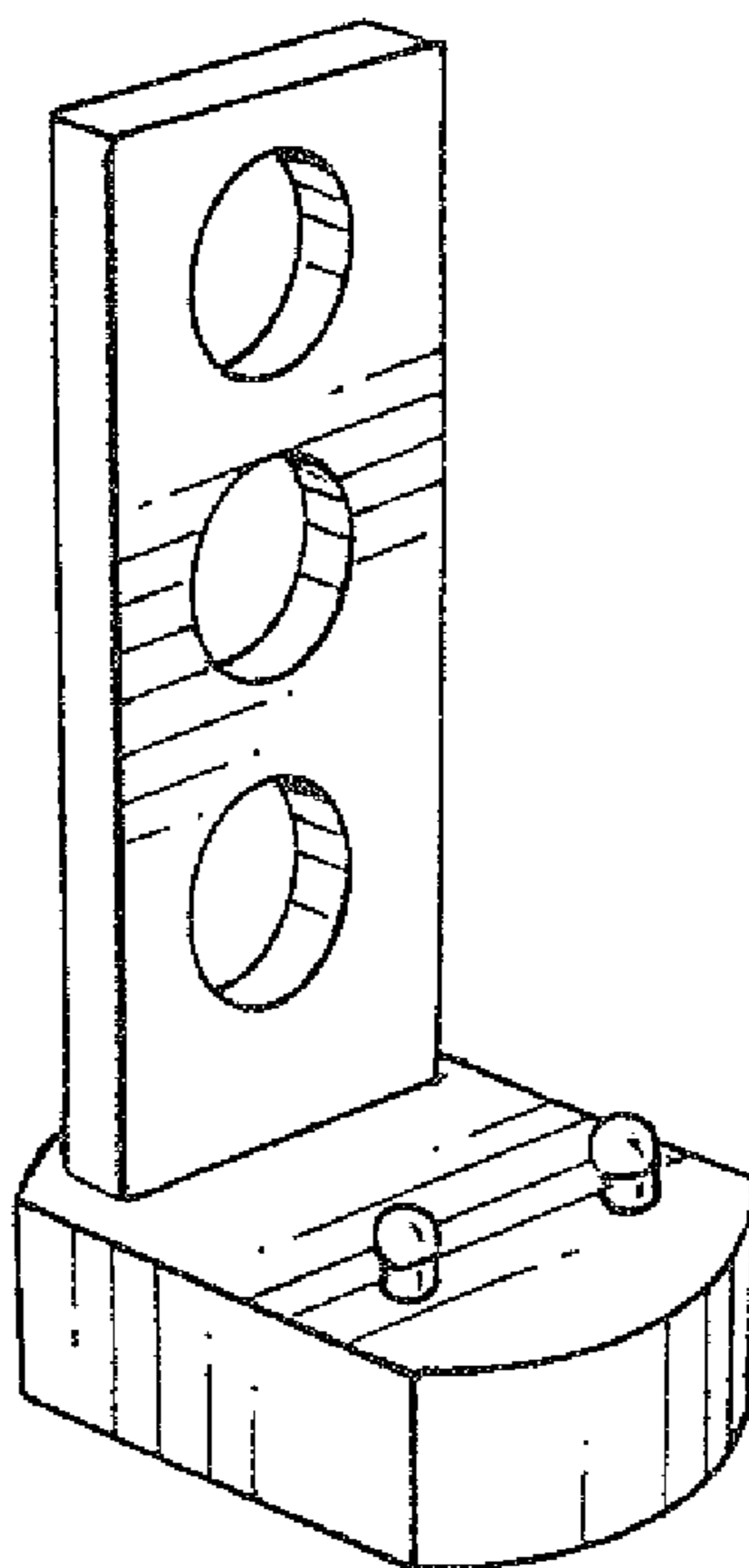
FIG. 2 is a top plan view thereof;

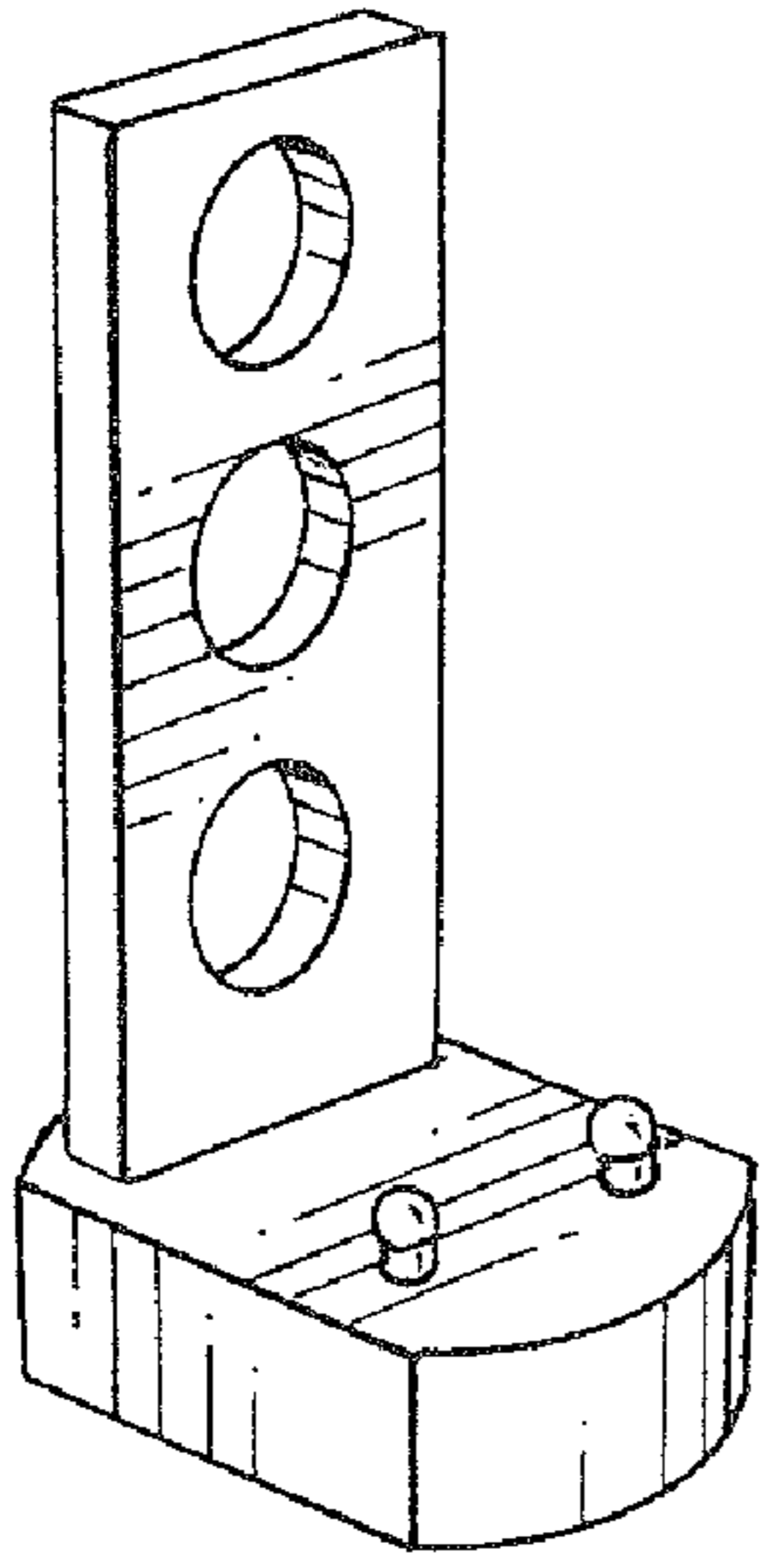

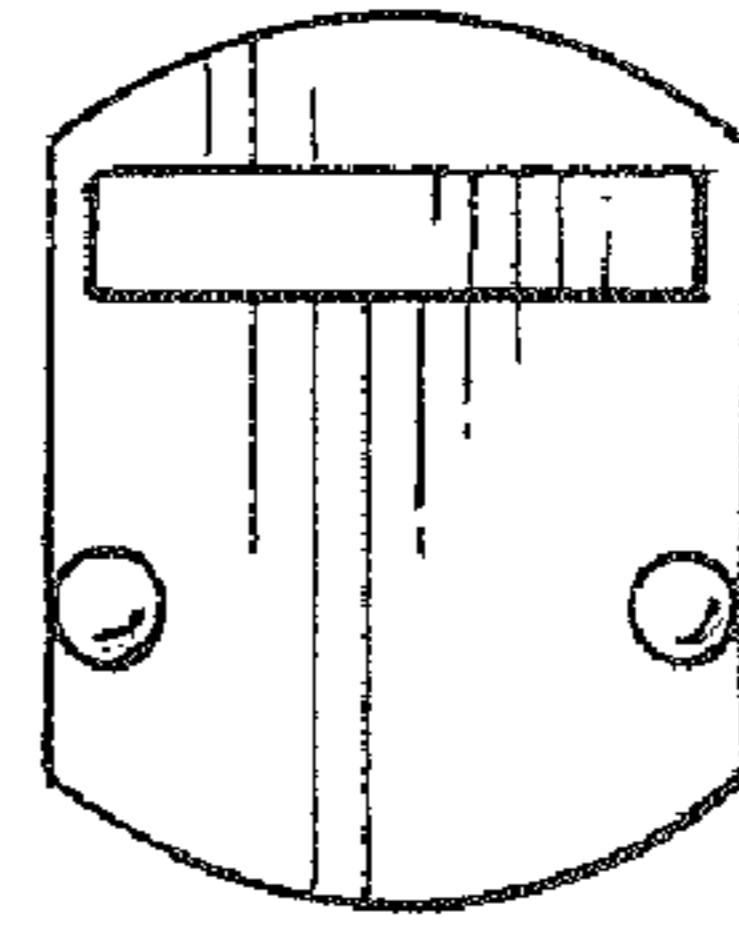

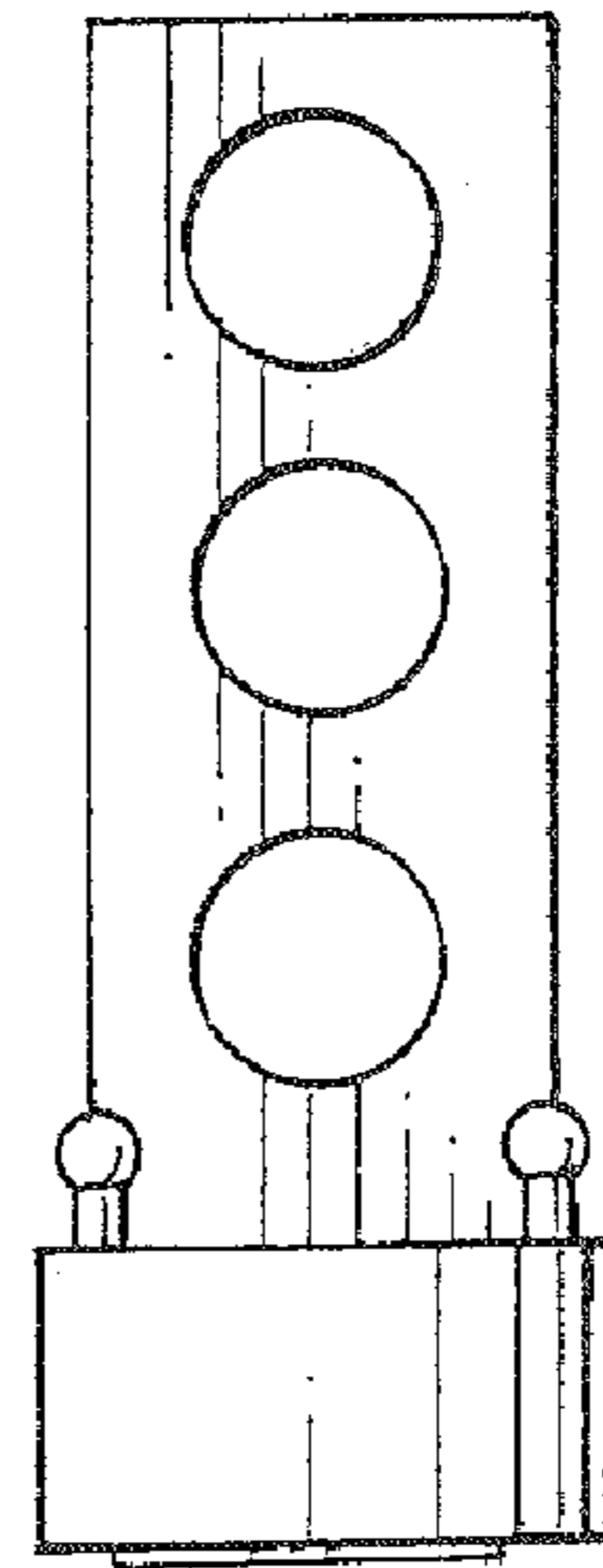

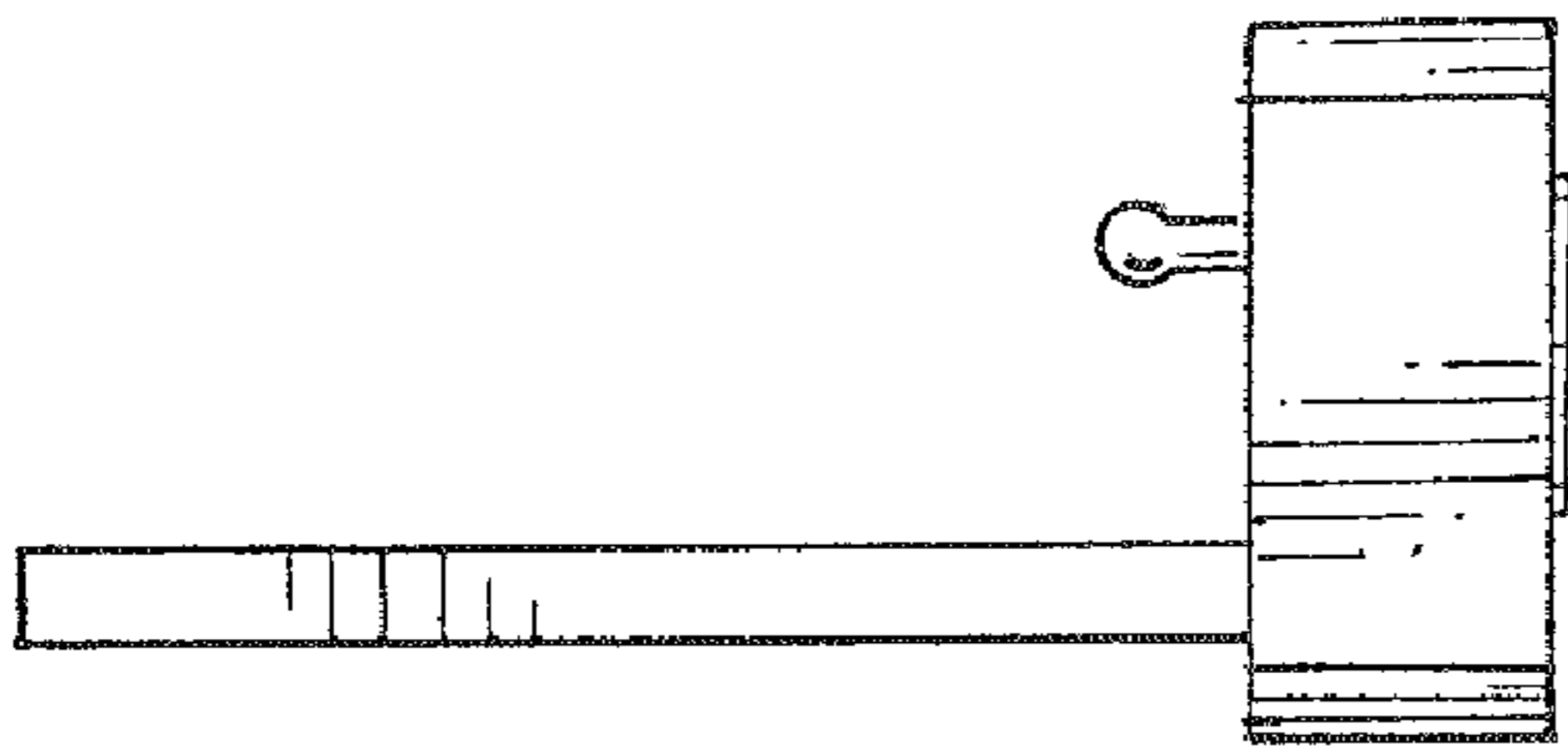

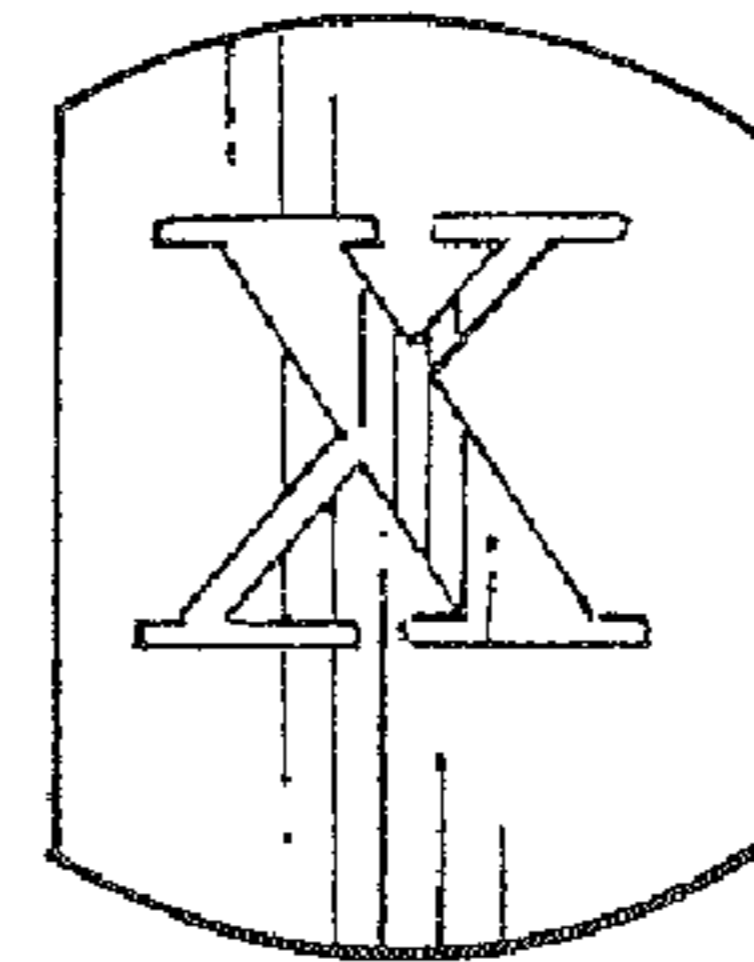
