FIG. 2 is a bottom perspective view of the handle of FIG. 1;

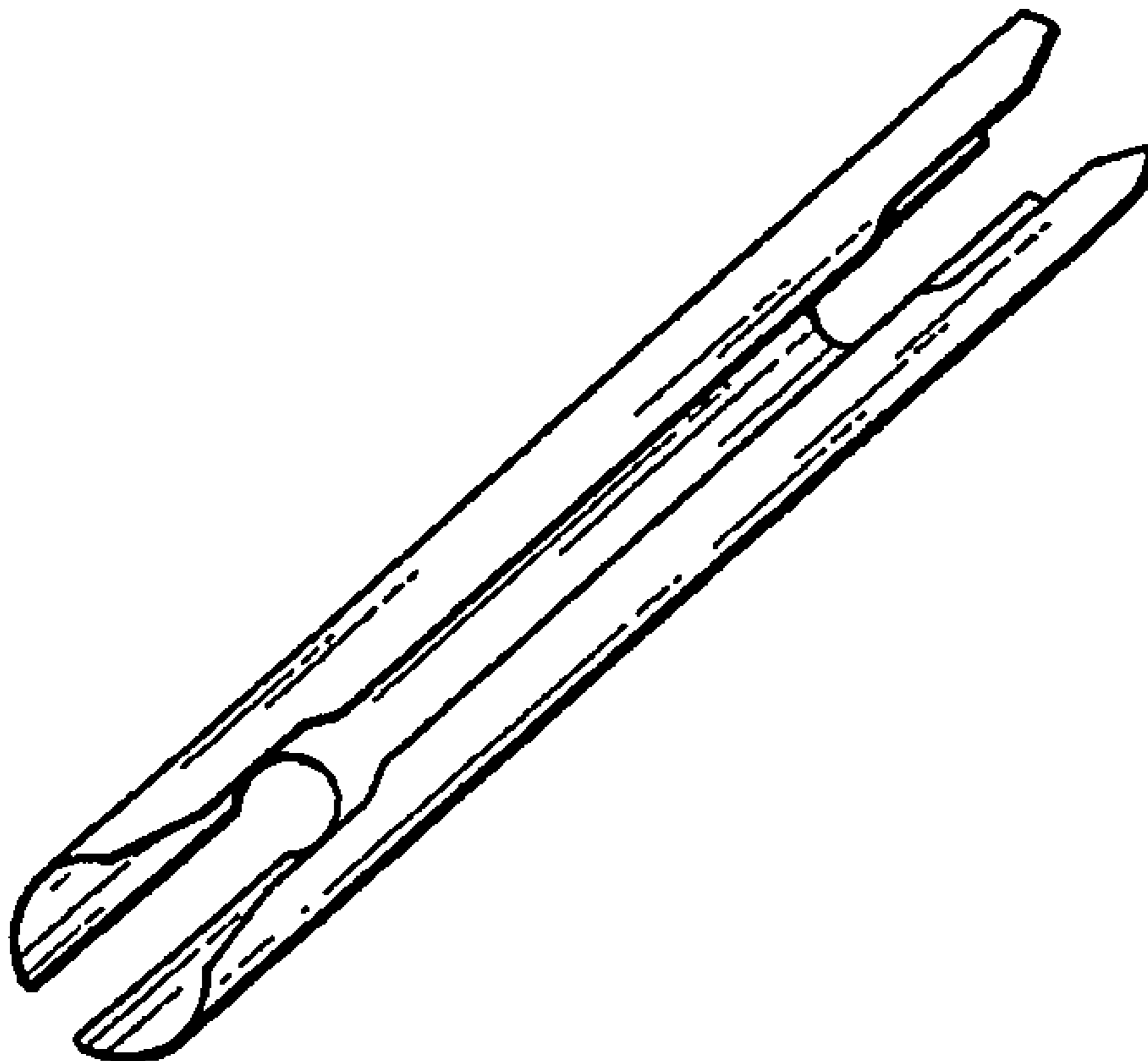
FIG. 3 is a front view of the handle of FIG. 1, the rear view being a mirror image thereof;

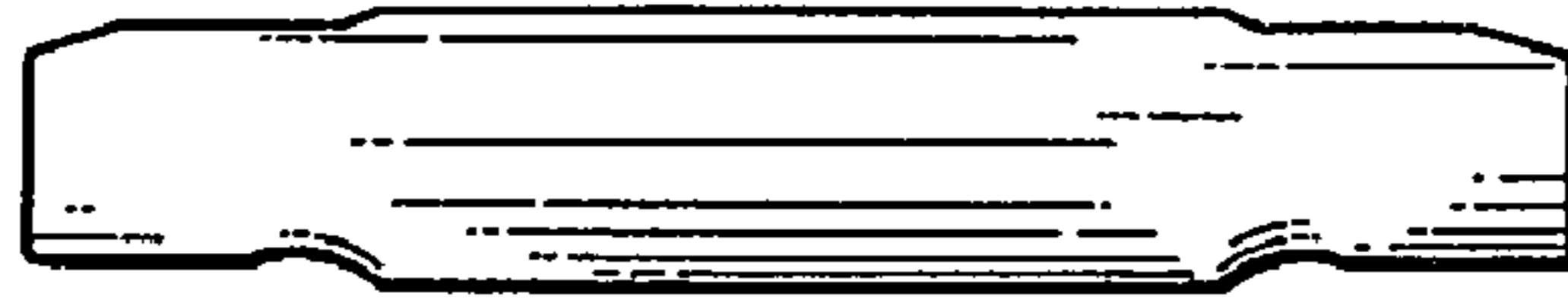
FIG. 4 is a top plan view of the handle of FIG. 1;

FIG. 5 is a bottom plan view of the handle of FIG. 1; and,

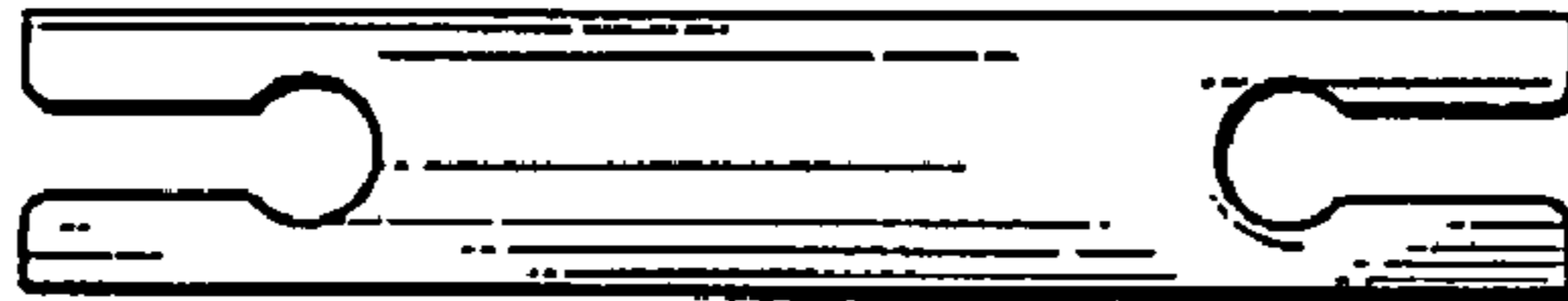
FIG. 6 is a right side view of the handle of FIG. 1, the left side view being a mirror image thereof.

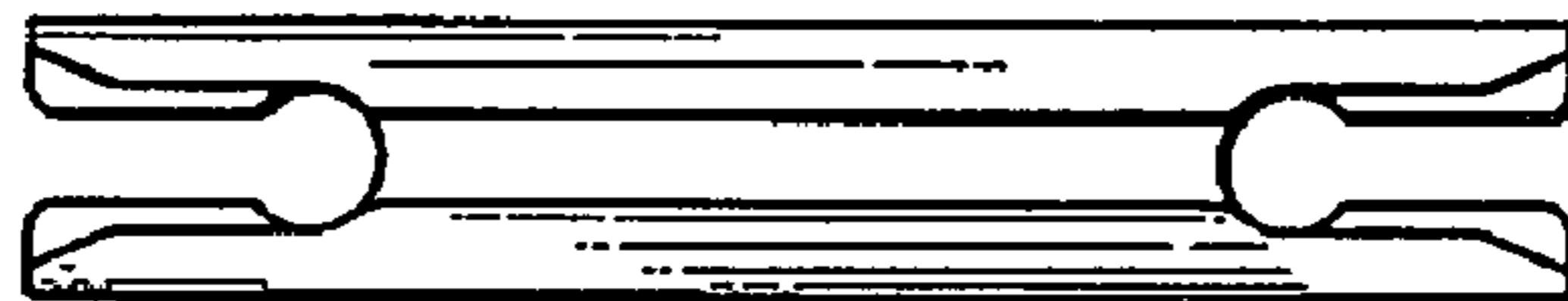

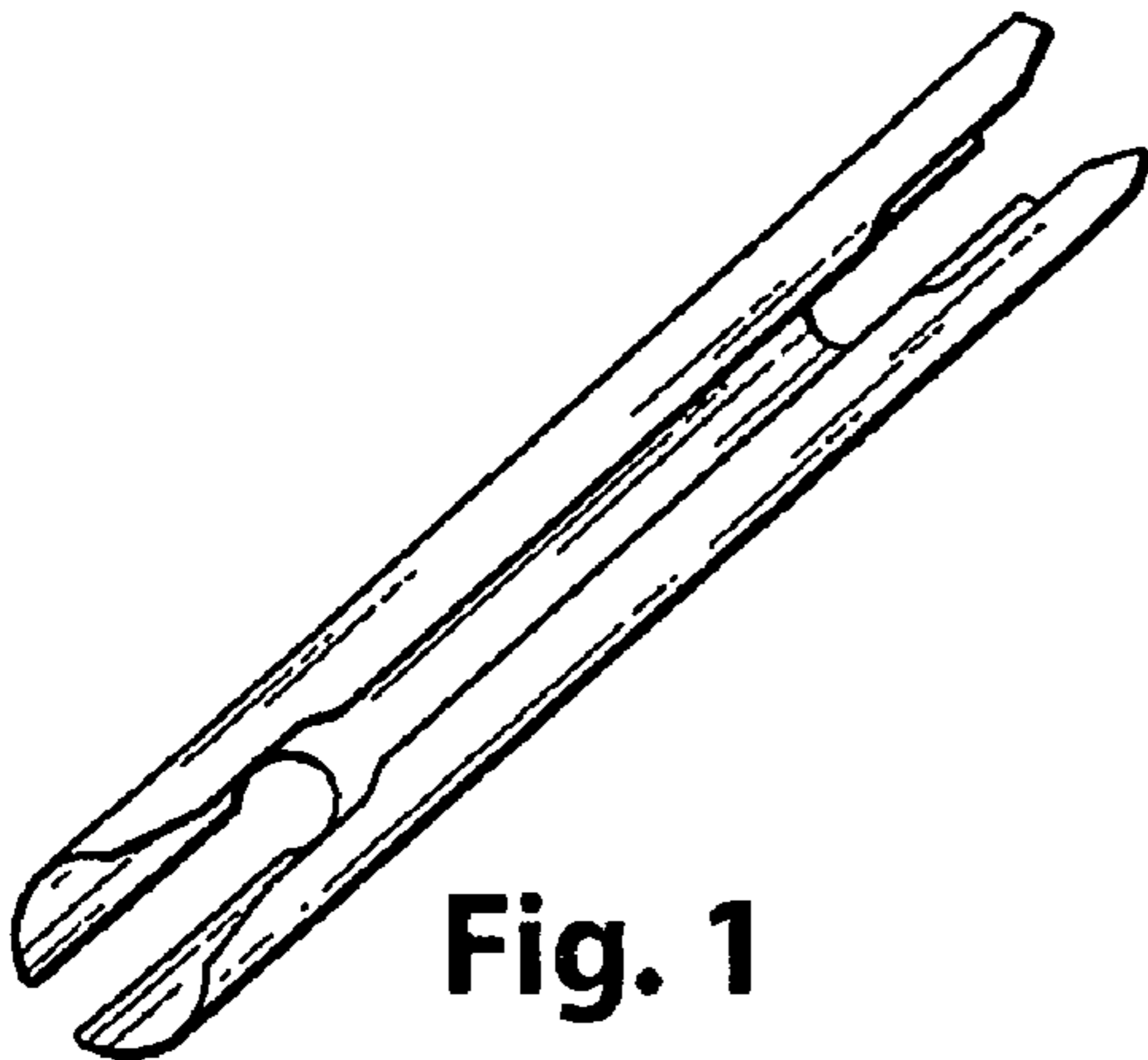

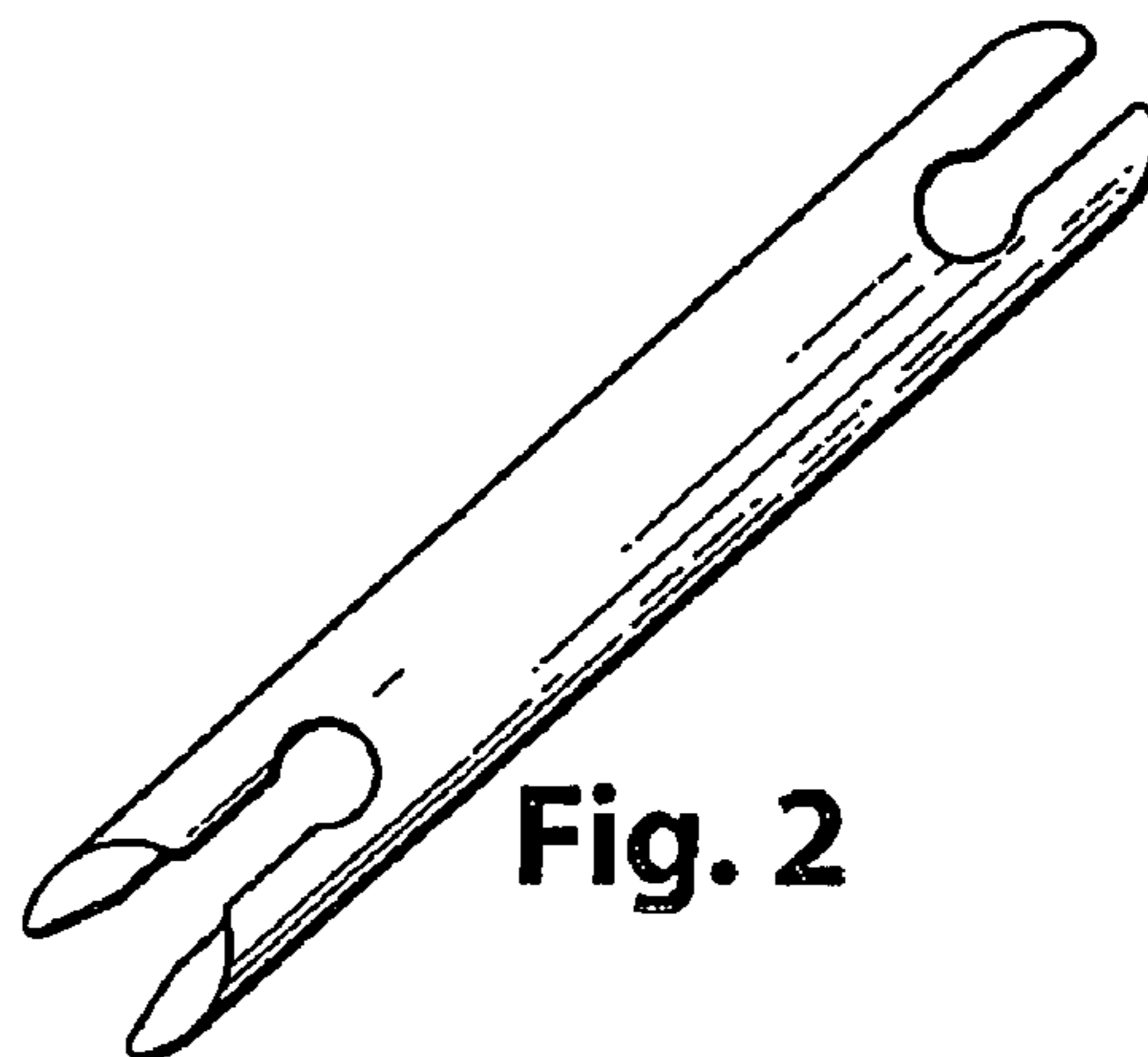
