**DESCRIPTION**

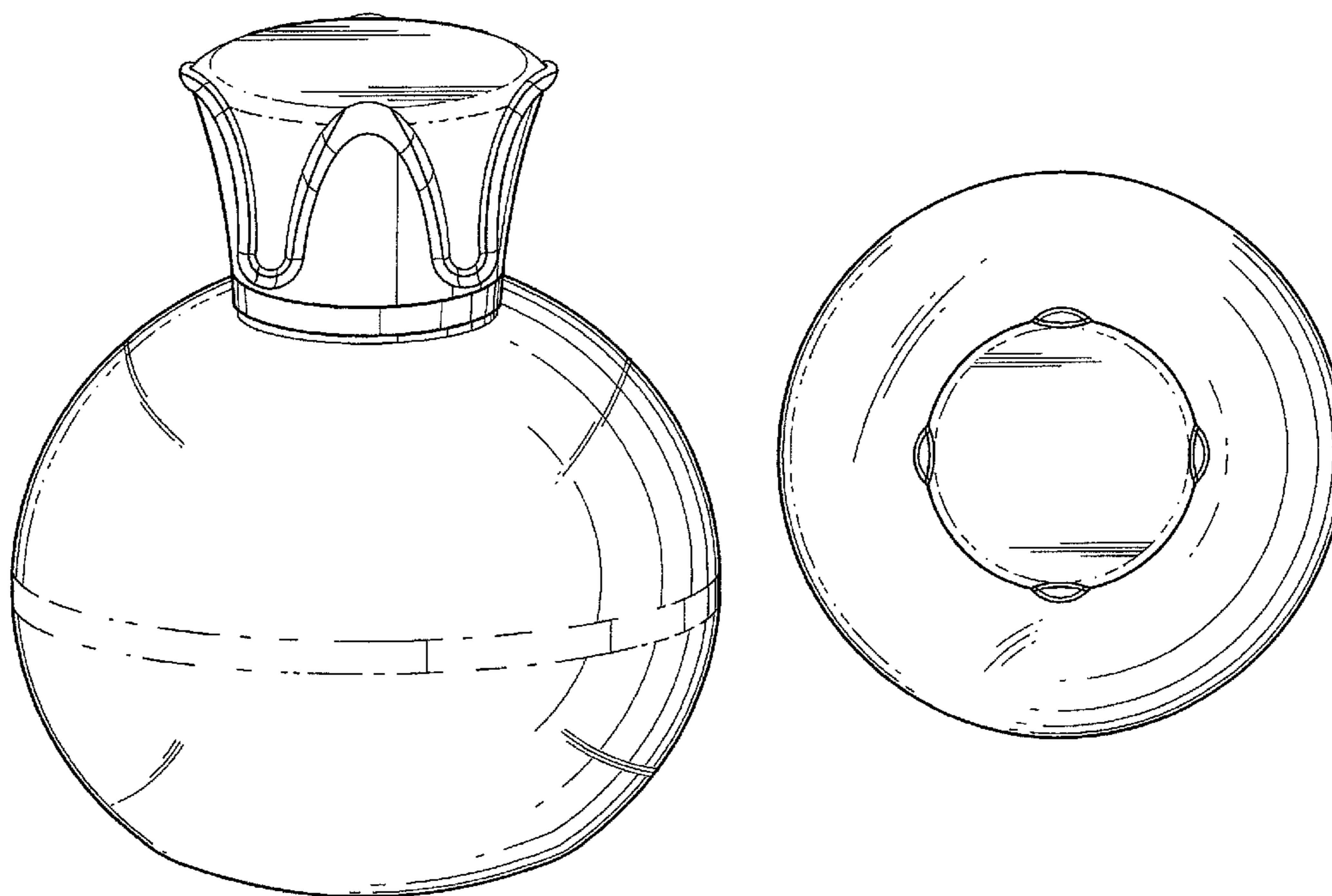
FIG. 1 is a top, front perspective view of the present invention;

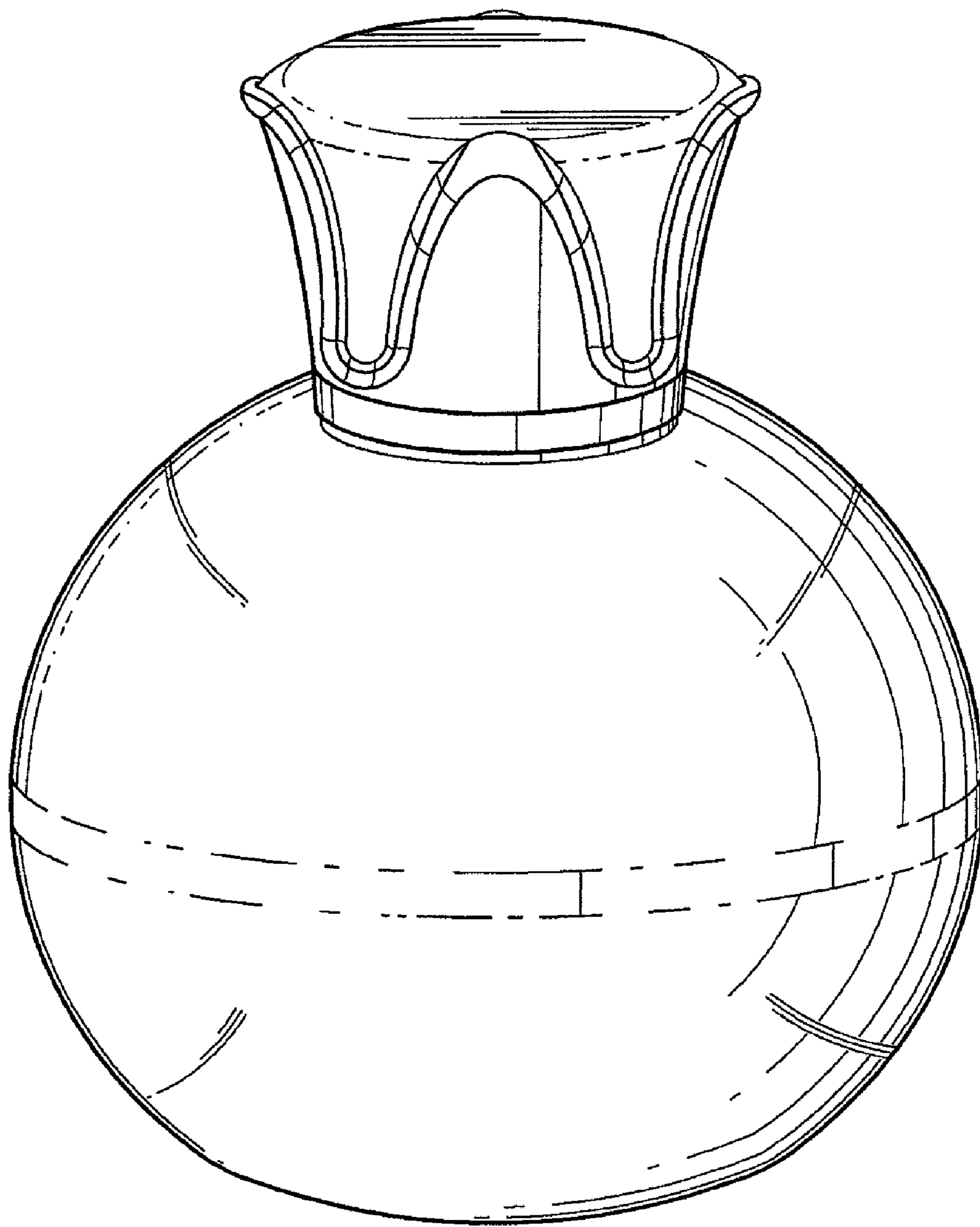
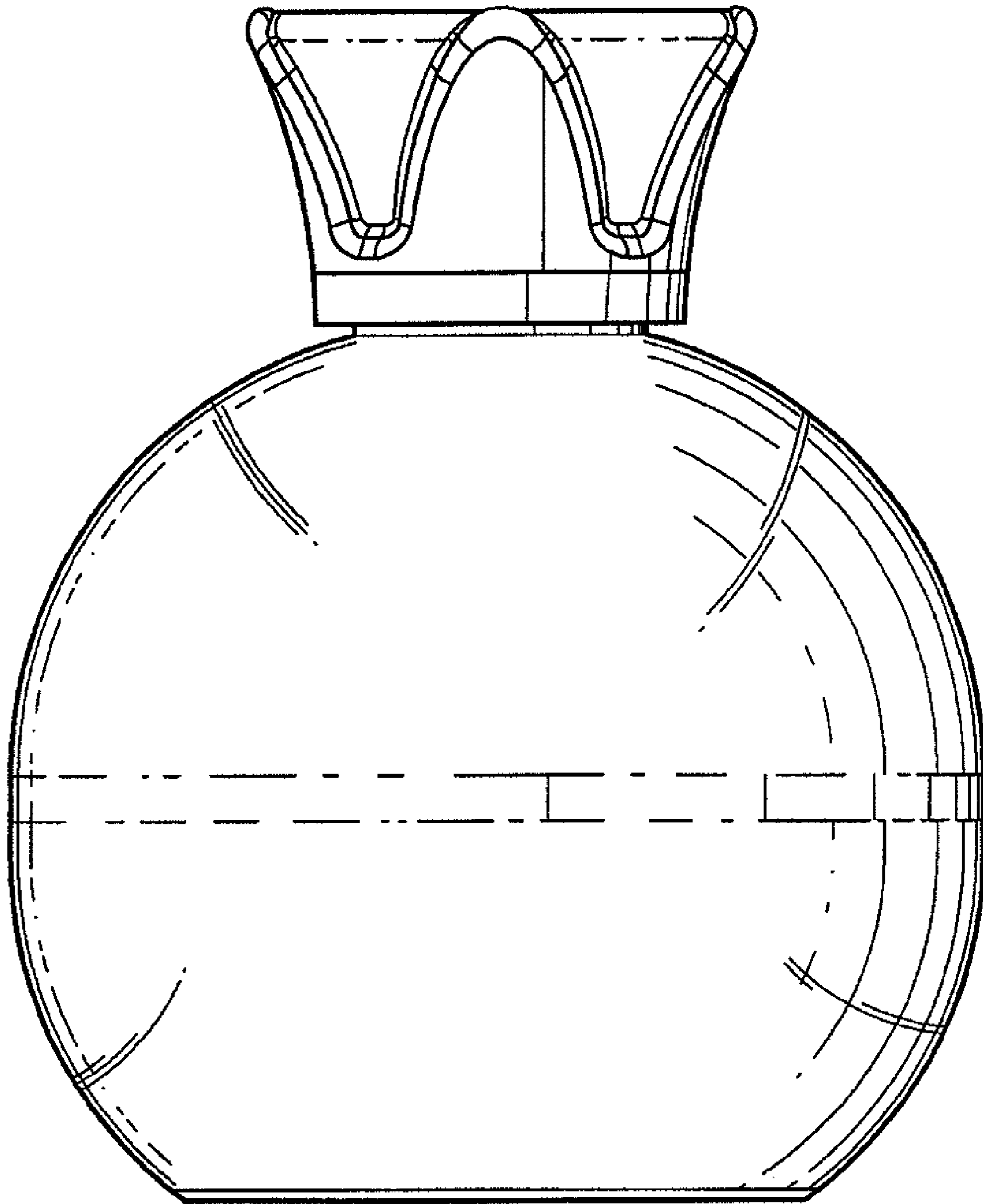

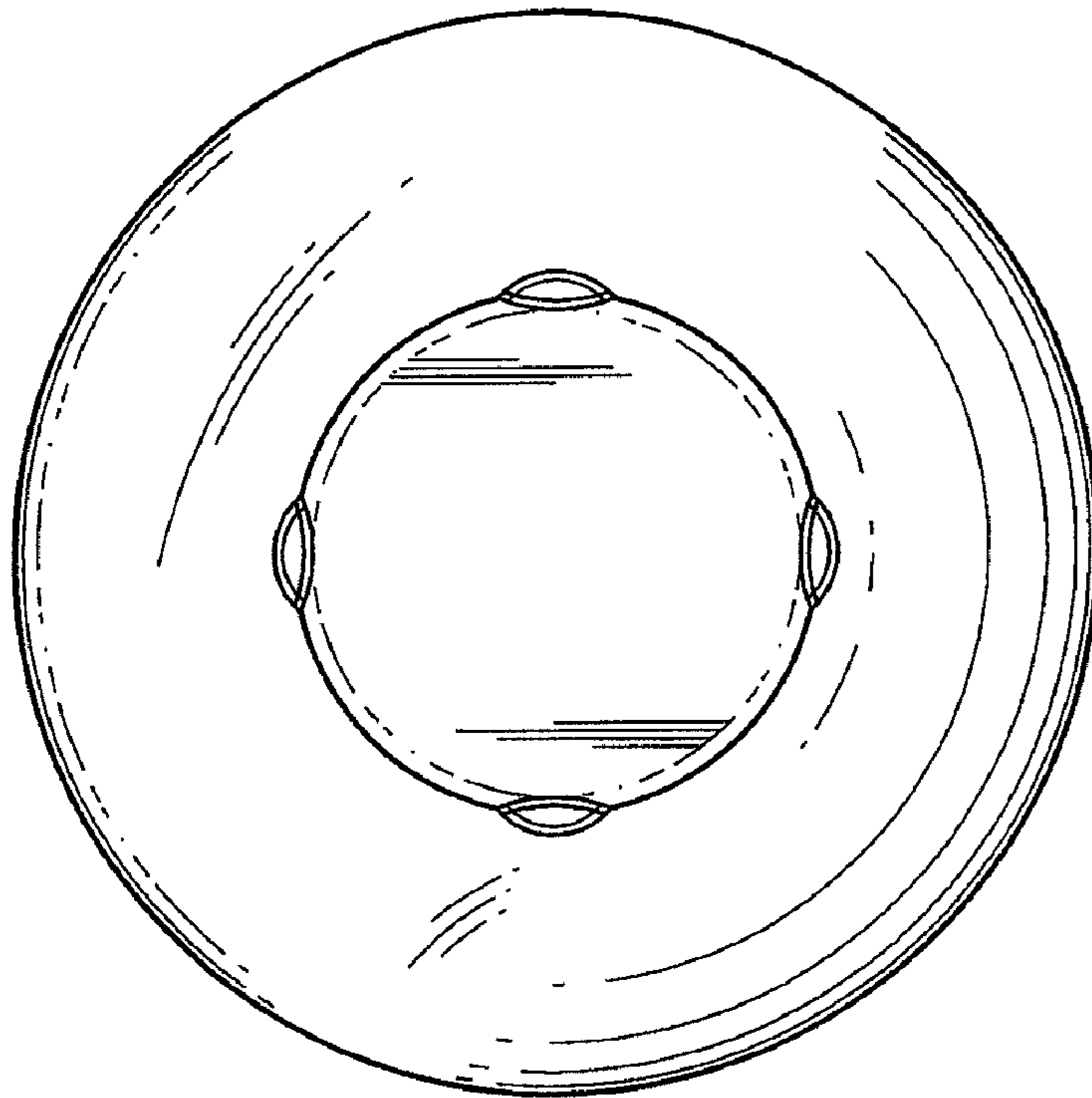

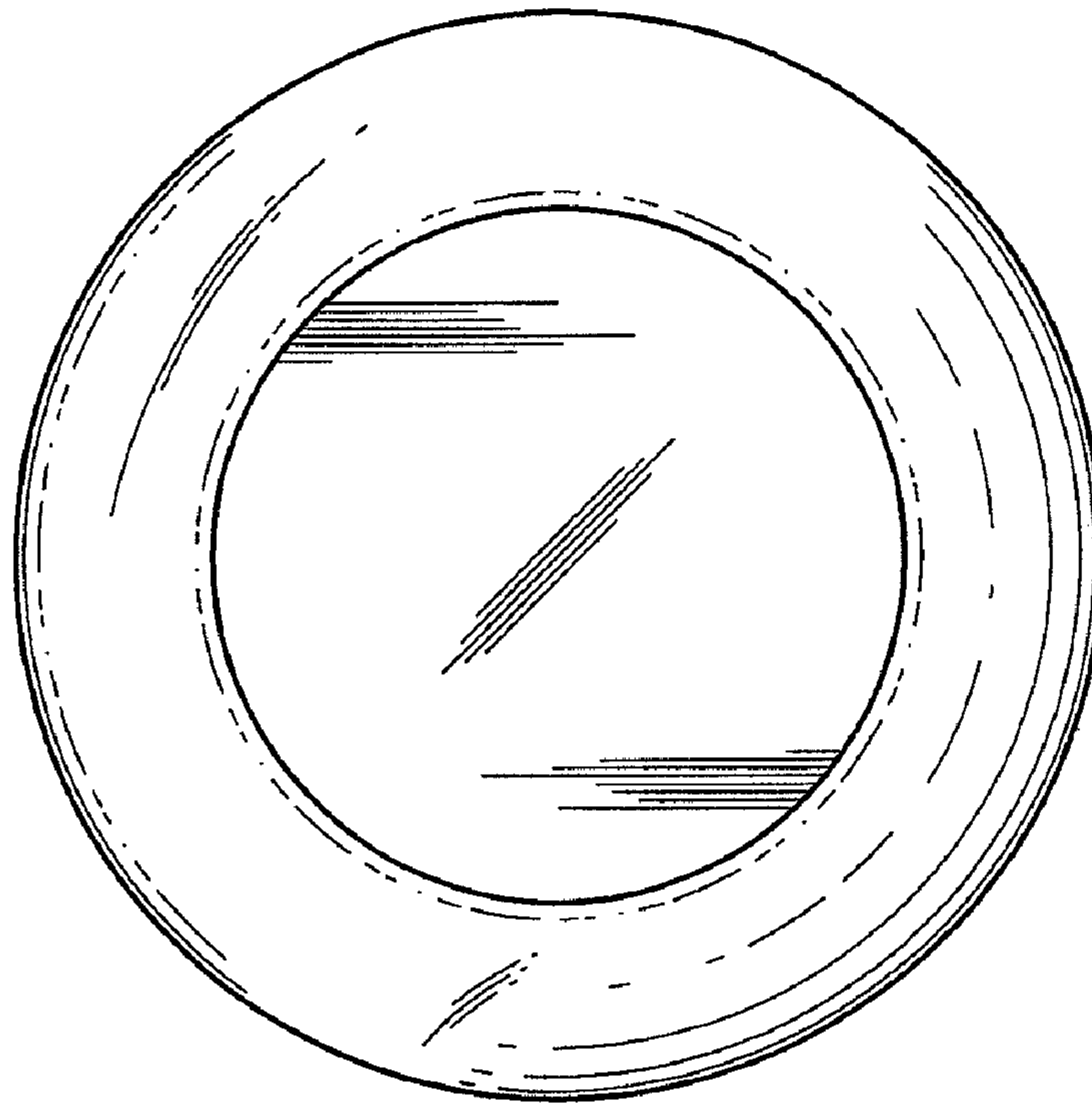
