The ornamental design for a television receiver, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a television receiver;

FIG. 2 is a front view thereof;

FIG. 3 is a sectional view showing the cut surface thereof  
taken along line 3—3 with its internal structure omitted;

FIG. 4 is an enlarged sectional view showing the cut surface  
thereof taken along line 4—4 with its internal structure  
omitted; and,

FIG. 5 is an enlarged view thereof taken along line 5—5.

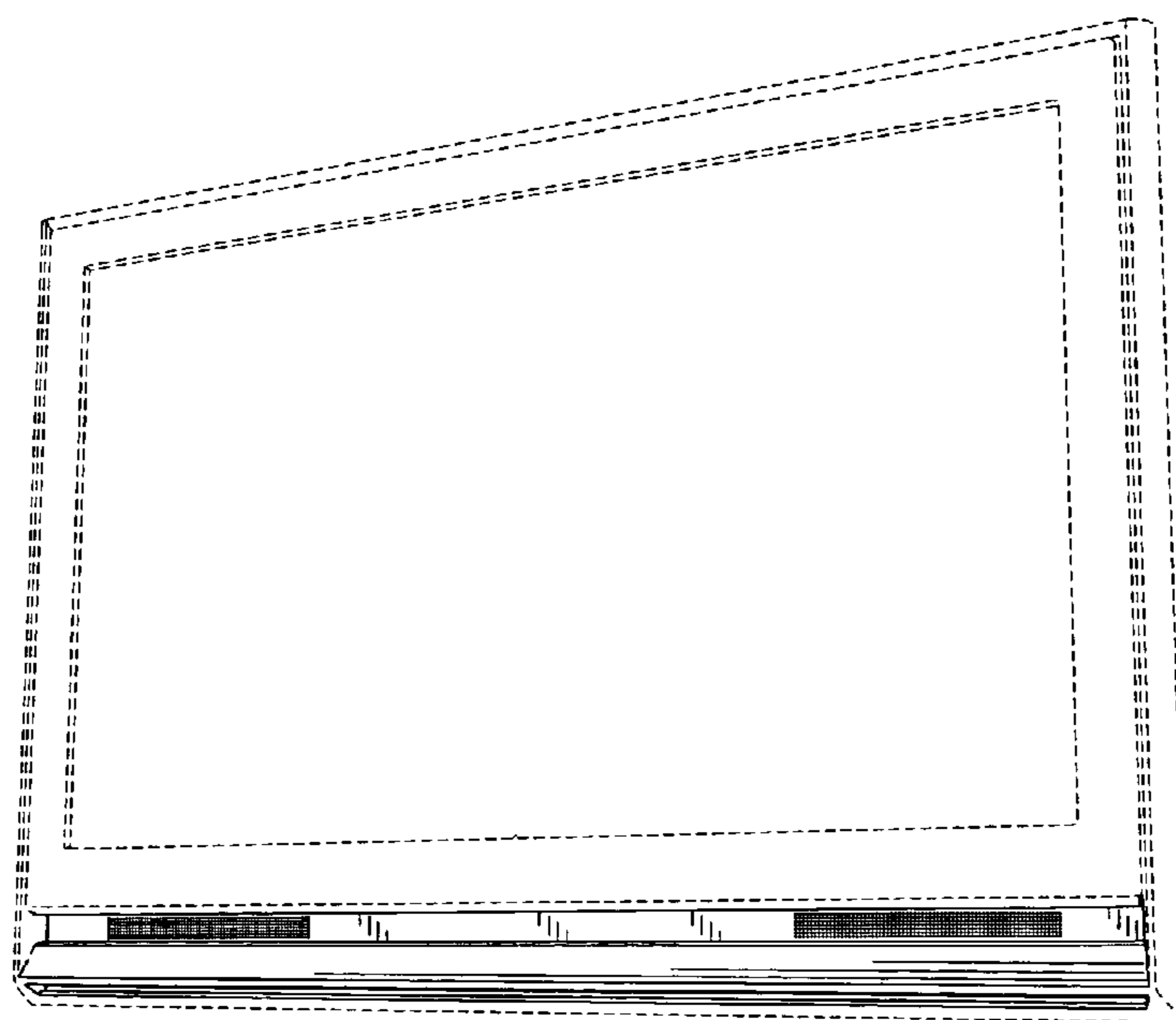

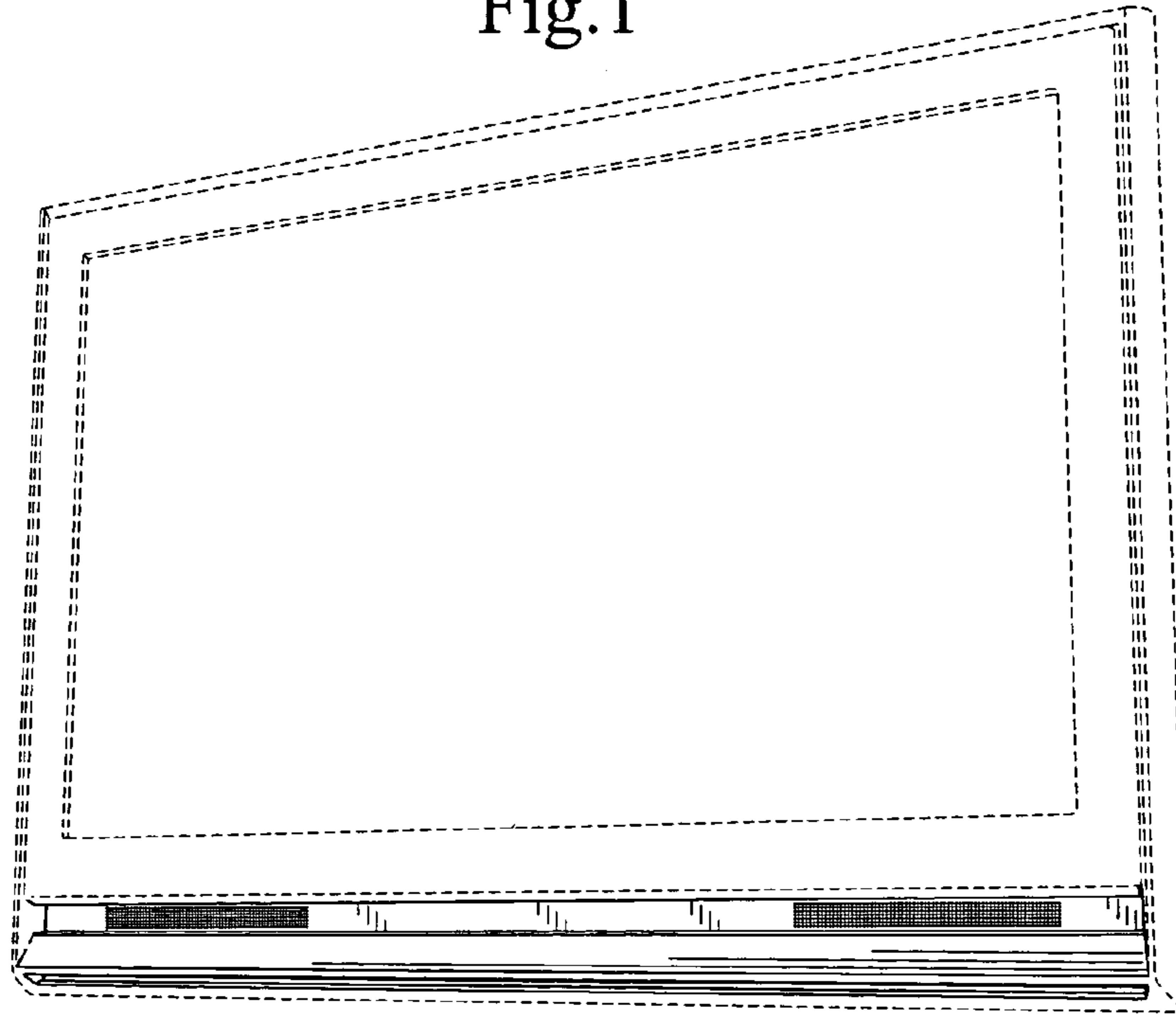

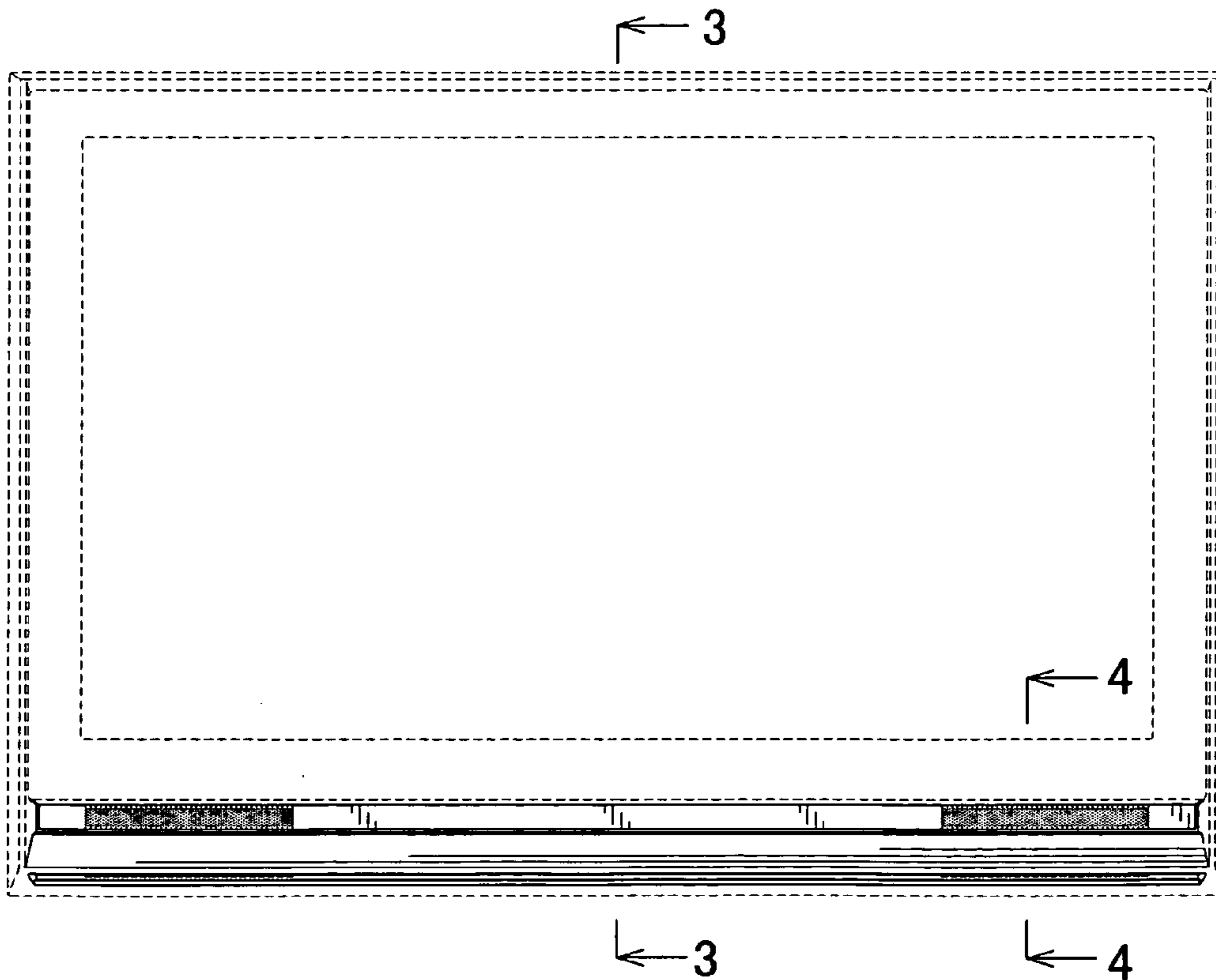

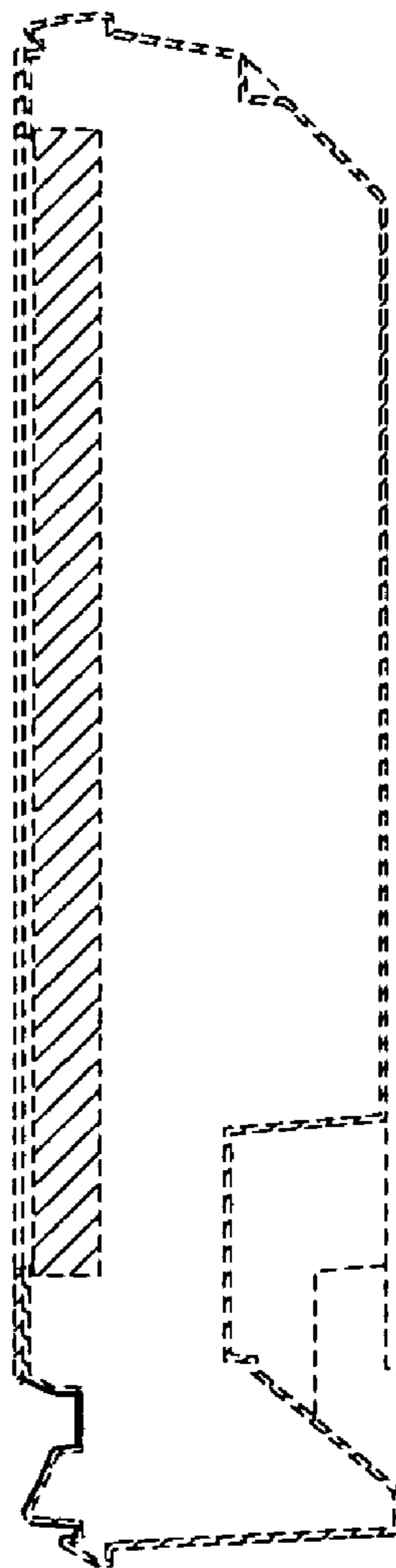

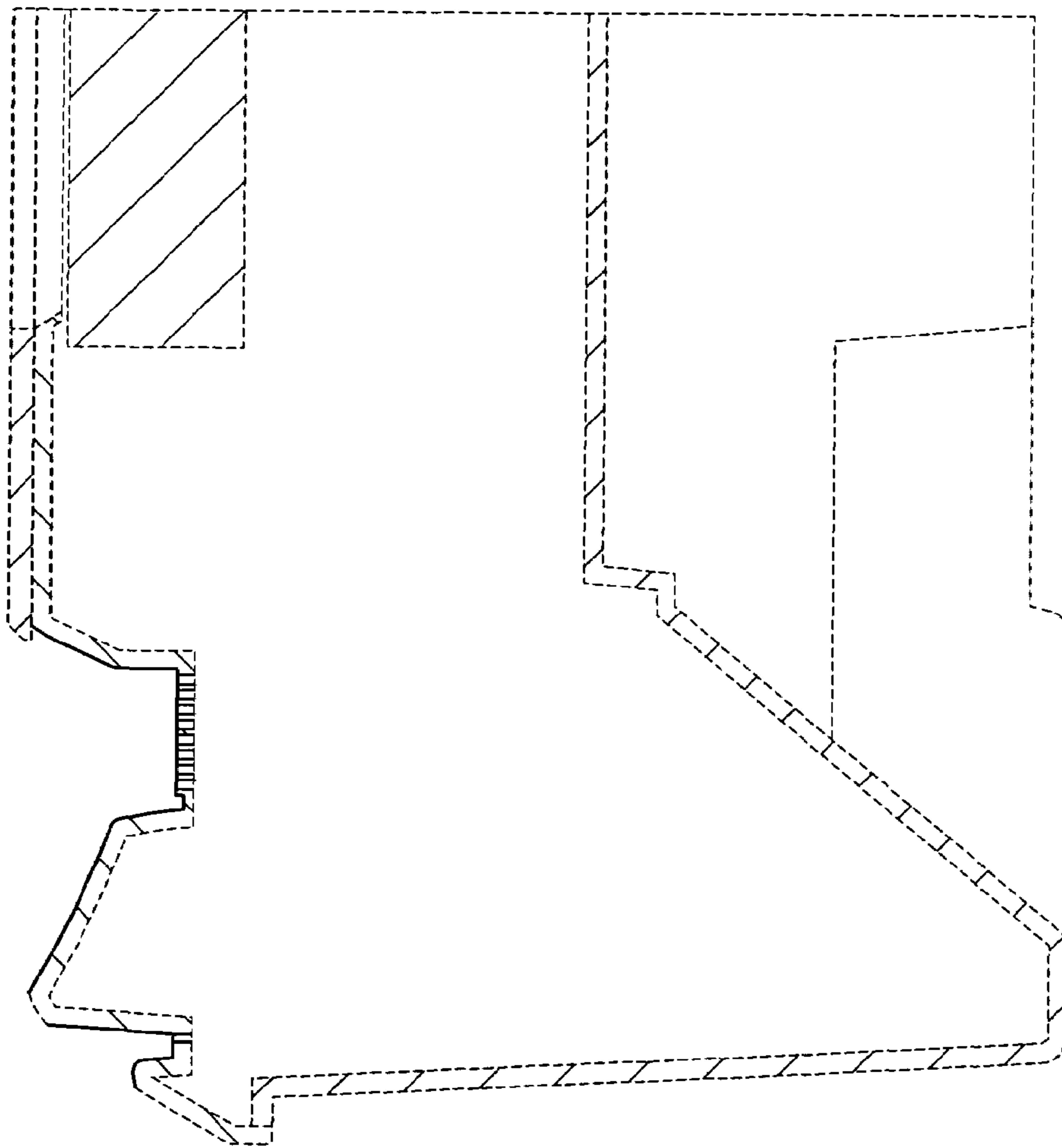
