FIG. 3 is a front view of the blade filler blank;

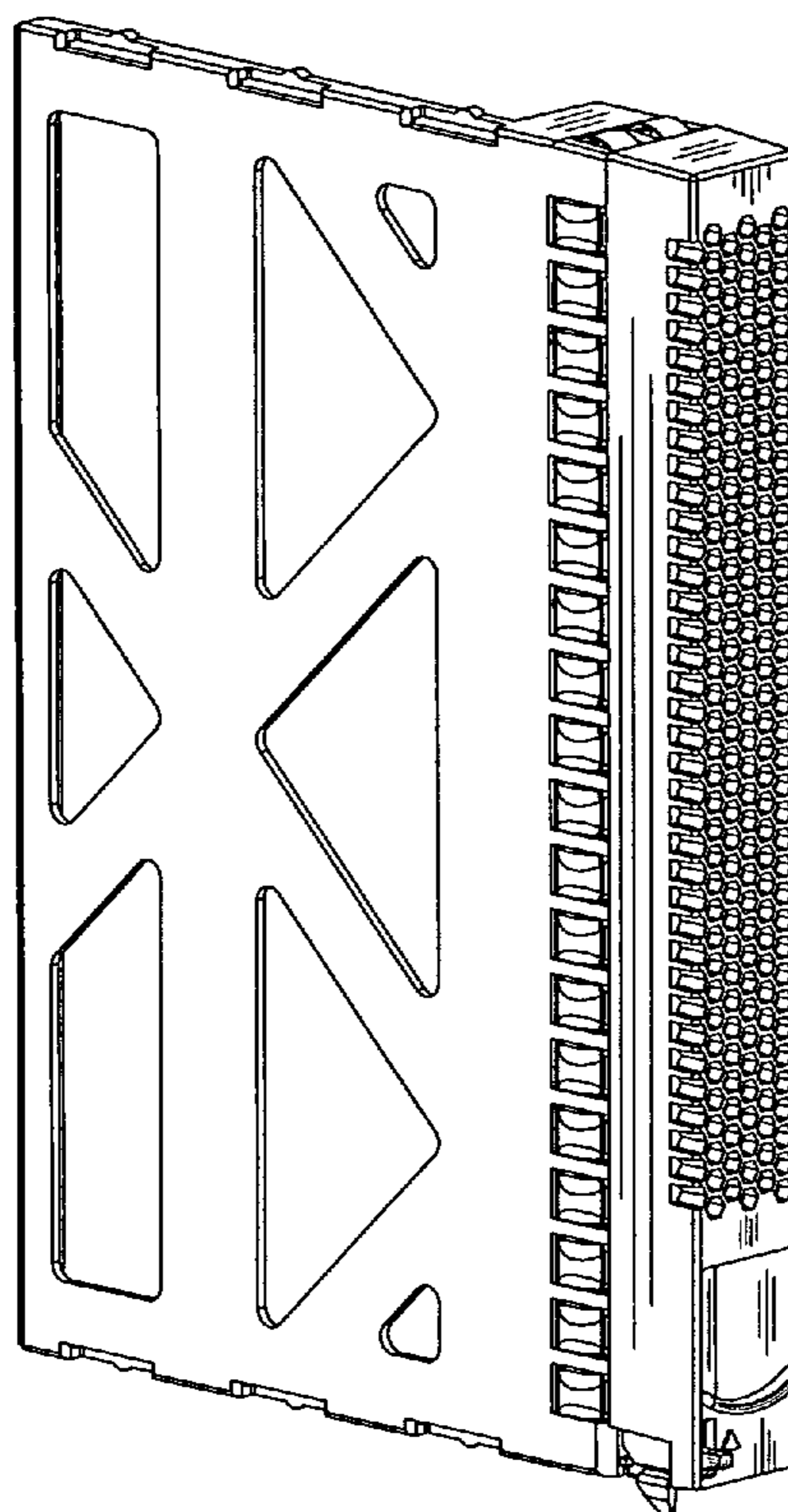
FIG. 4 is a left side view of the blade filler blank;

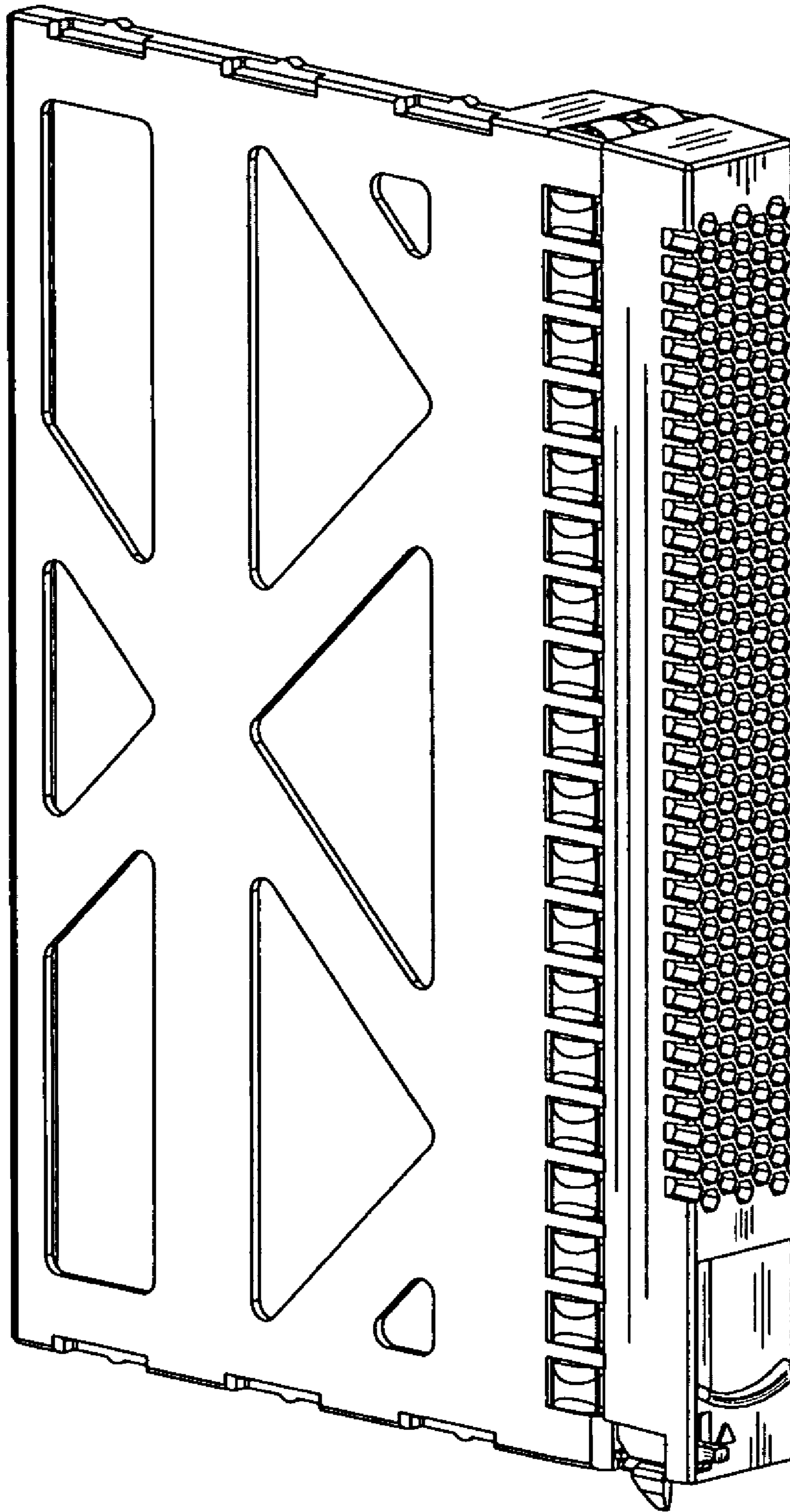

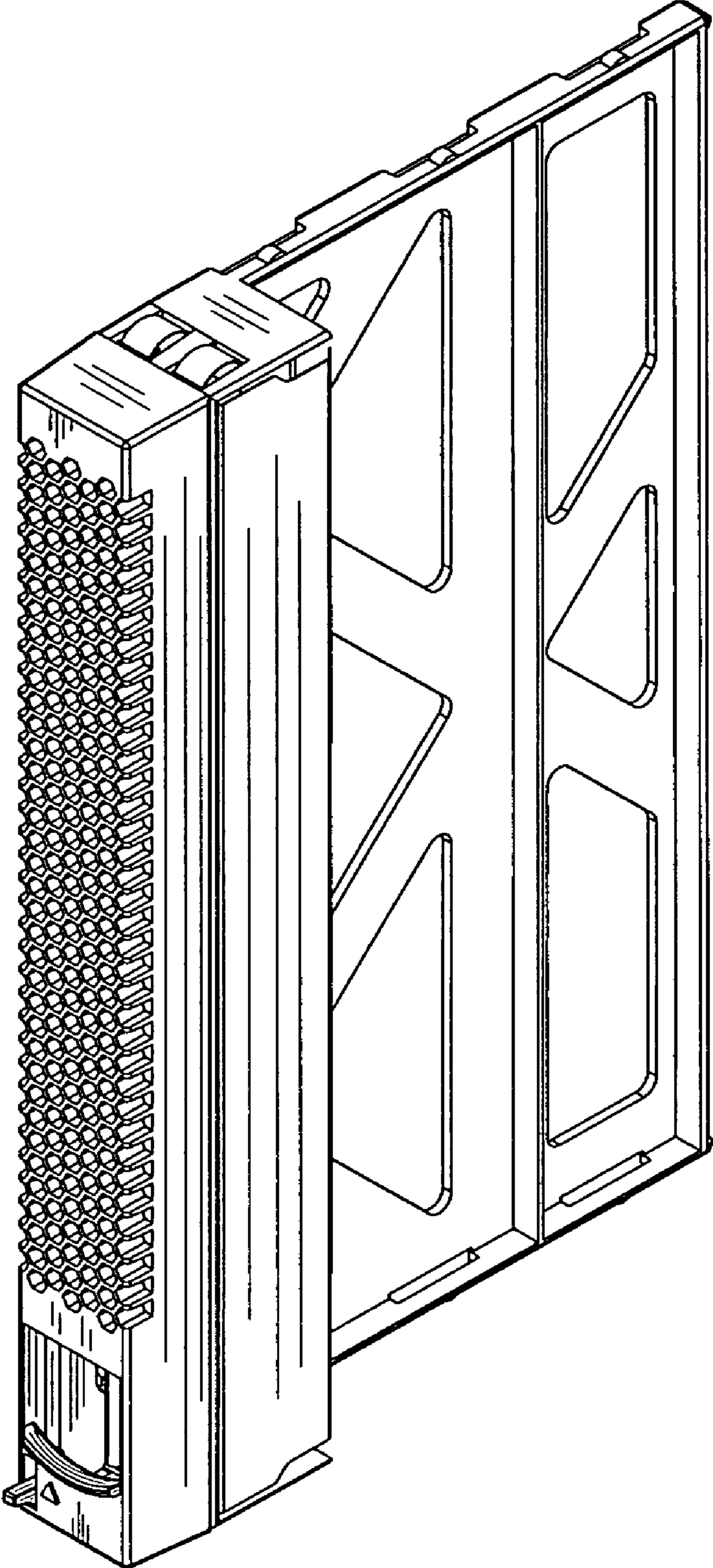

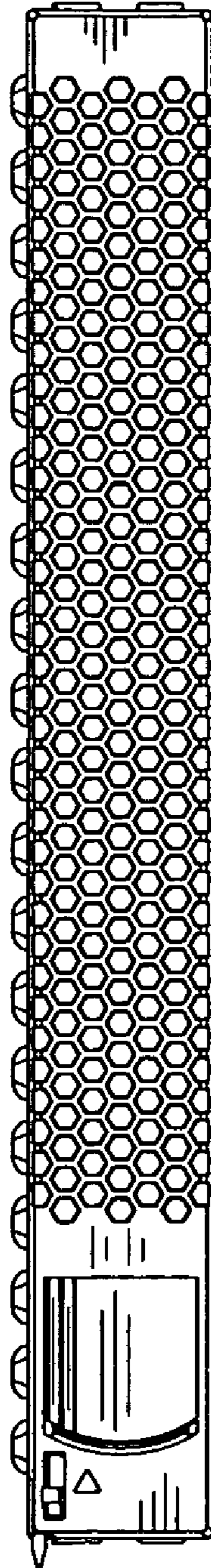

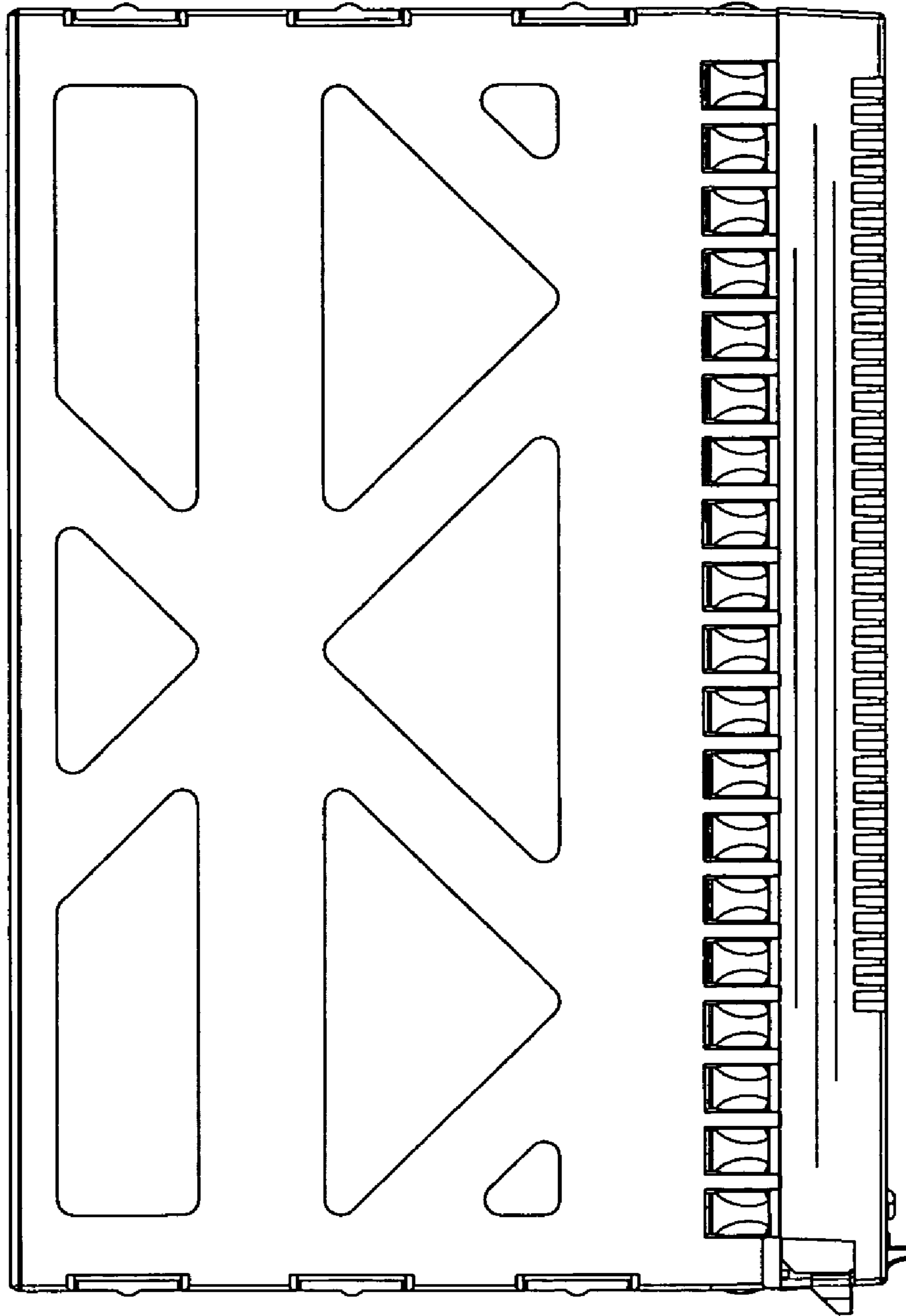

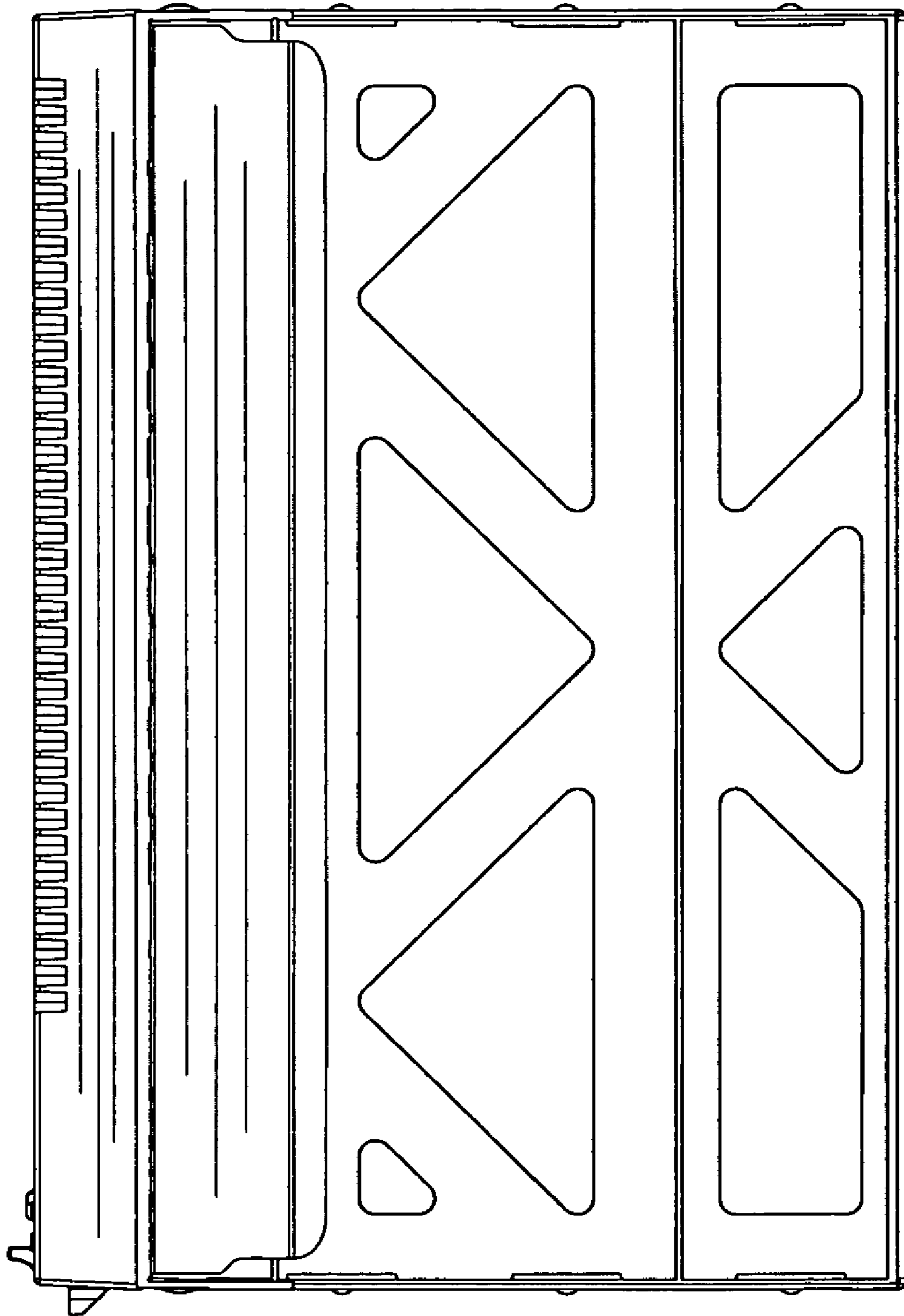

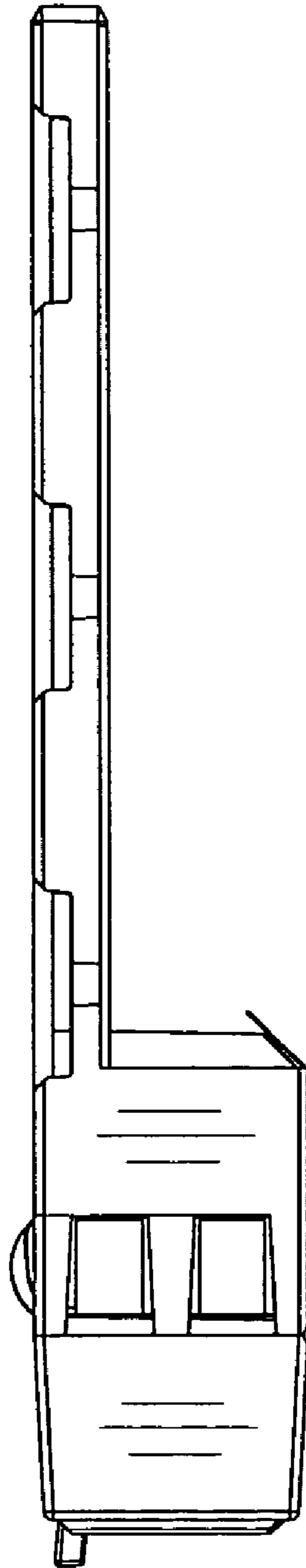

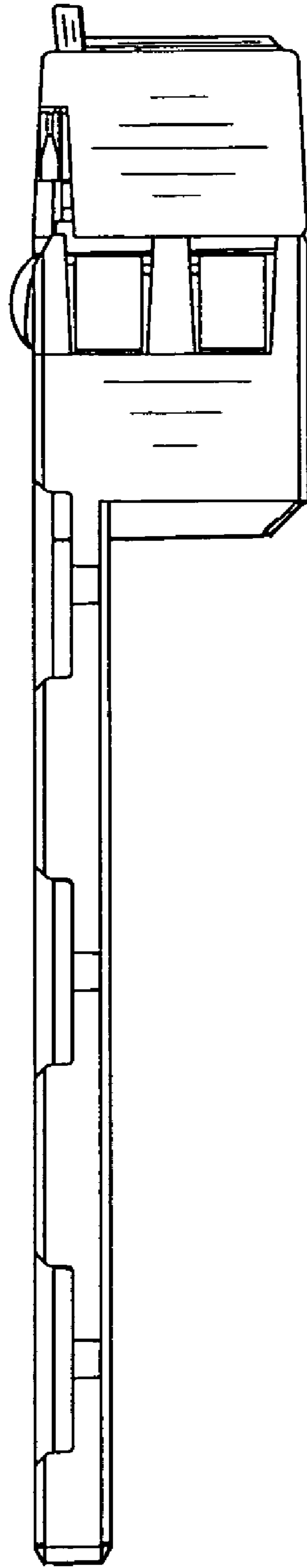
