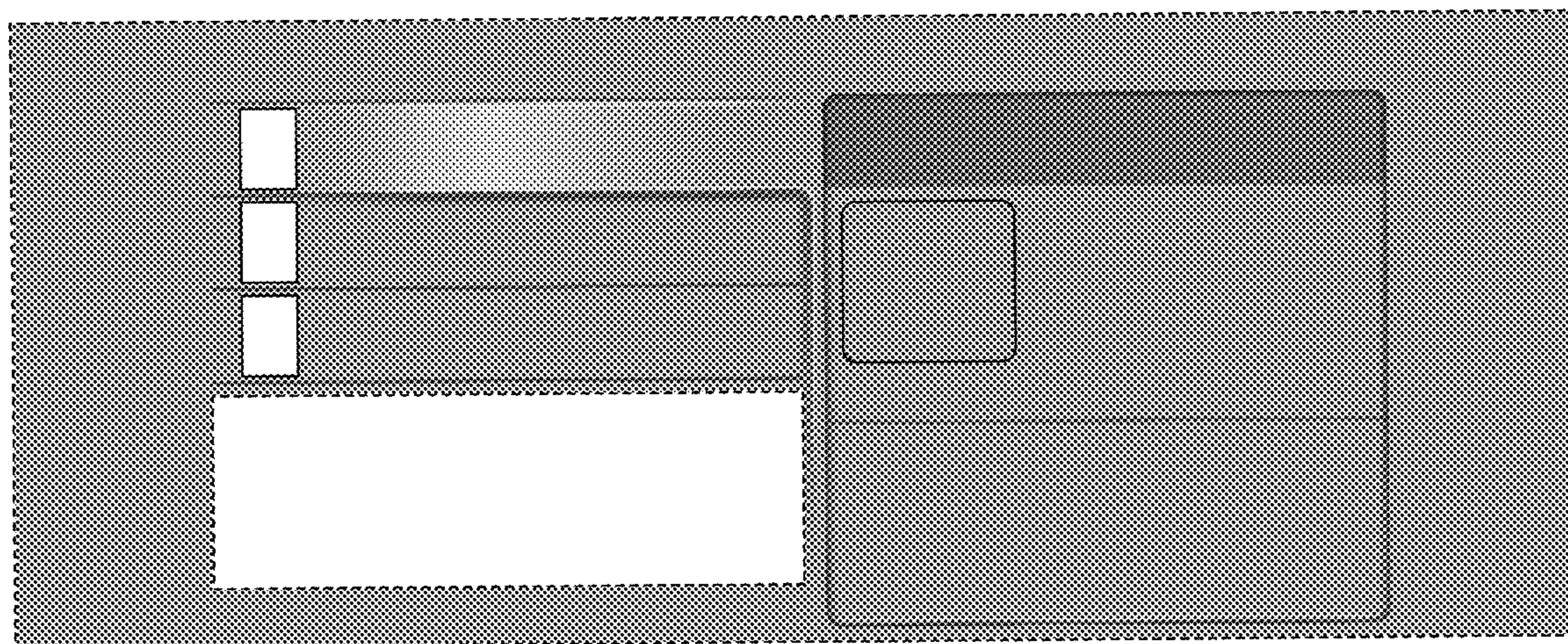
The ornamental design for a portion of a display screen with a user interface, as shown and described.

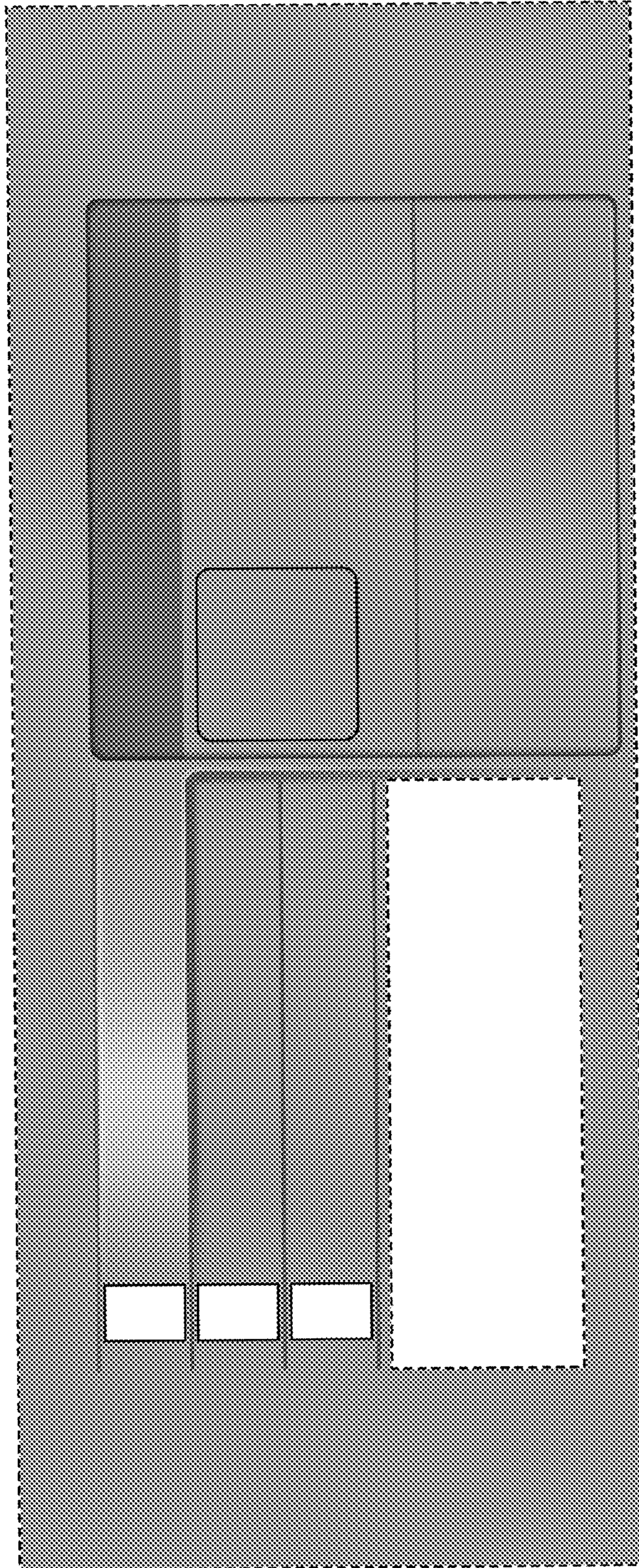
DESCRIPTION
