FIG. 3 is a front view of the device for manipulating sounds and images;

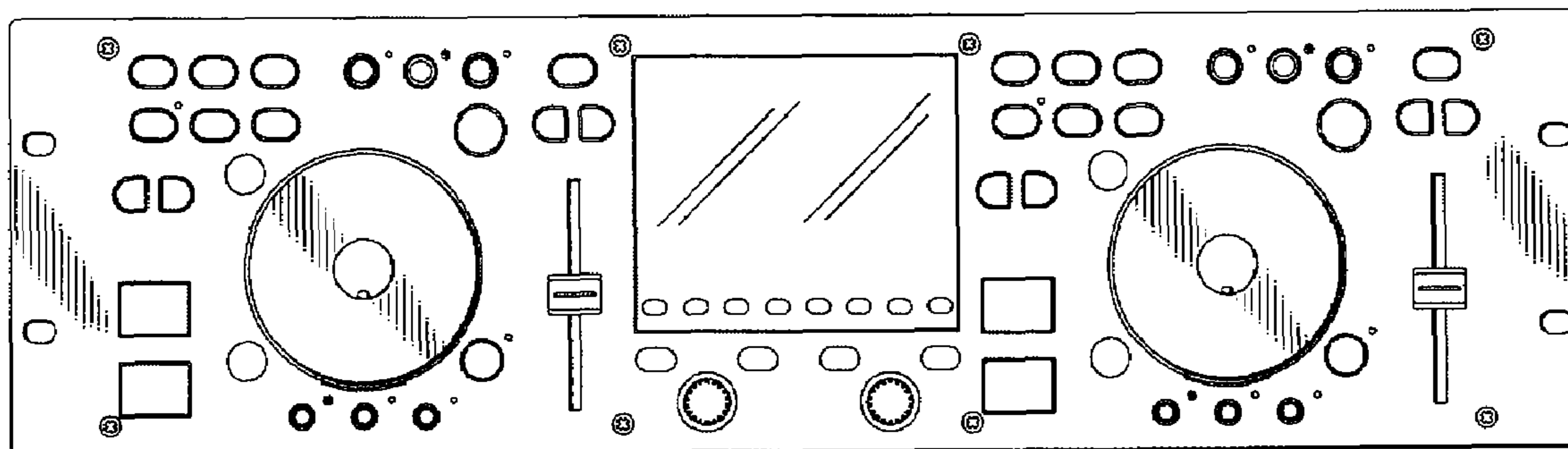
FIG. 4 is a back view of the device for manipulating sounds and images;

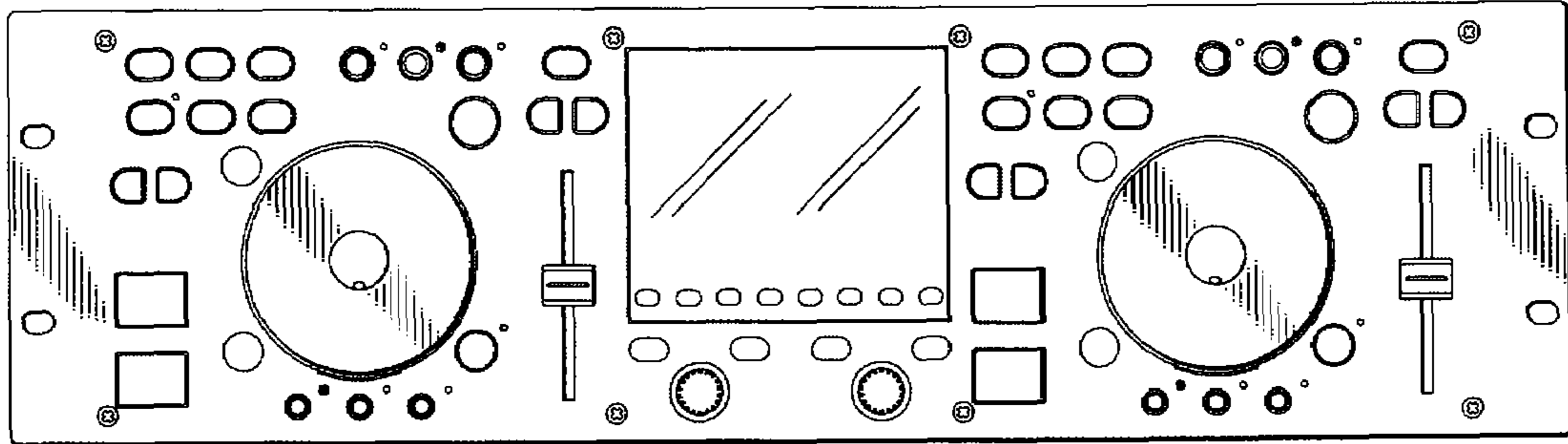

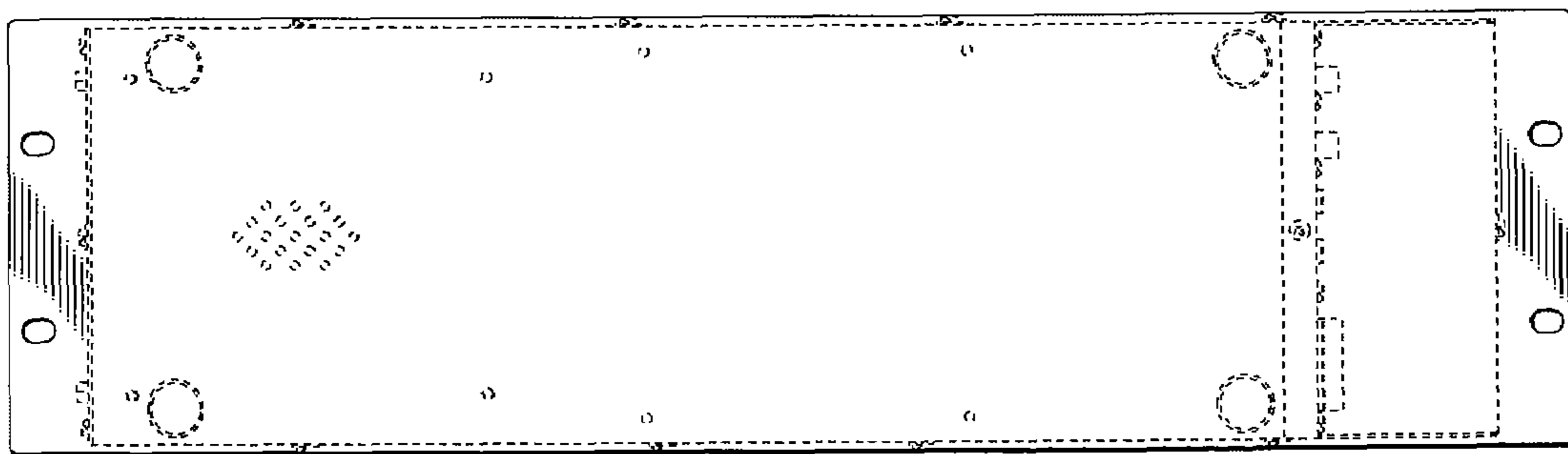

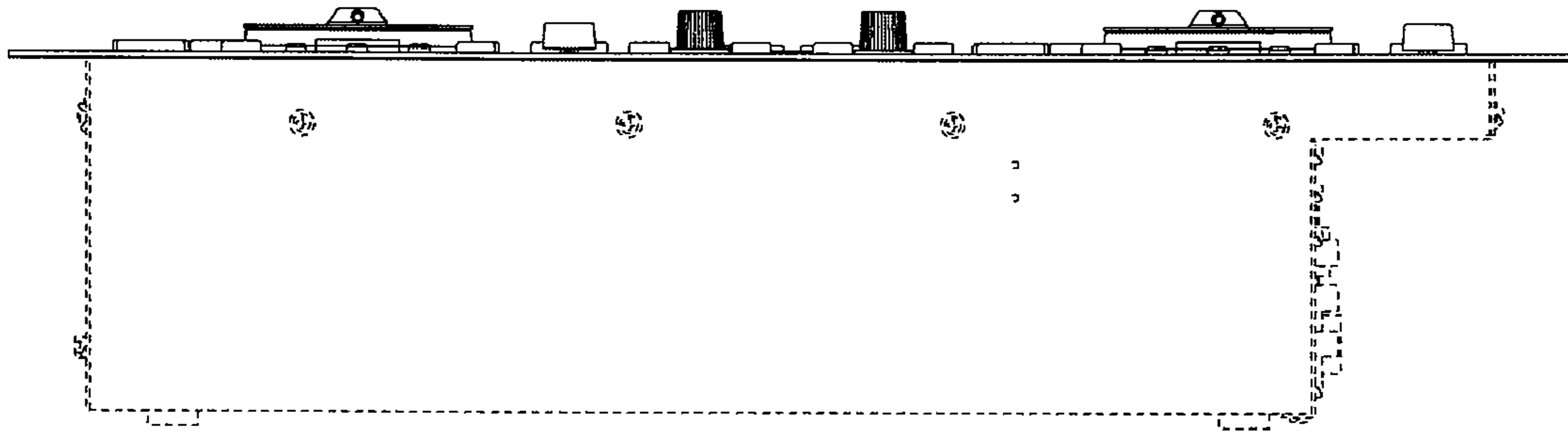

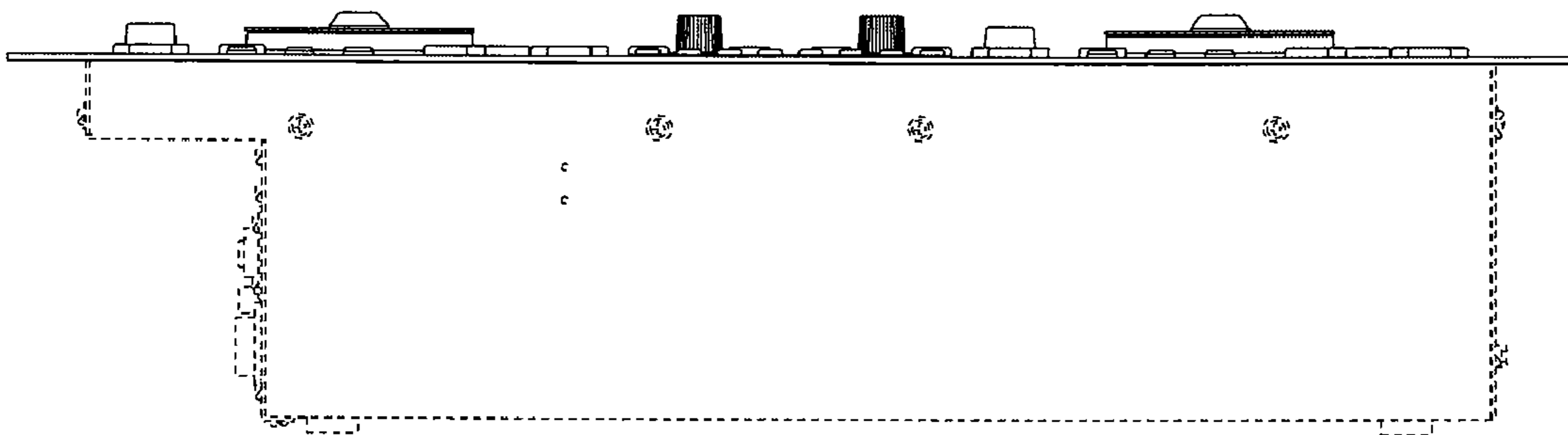

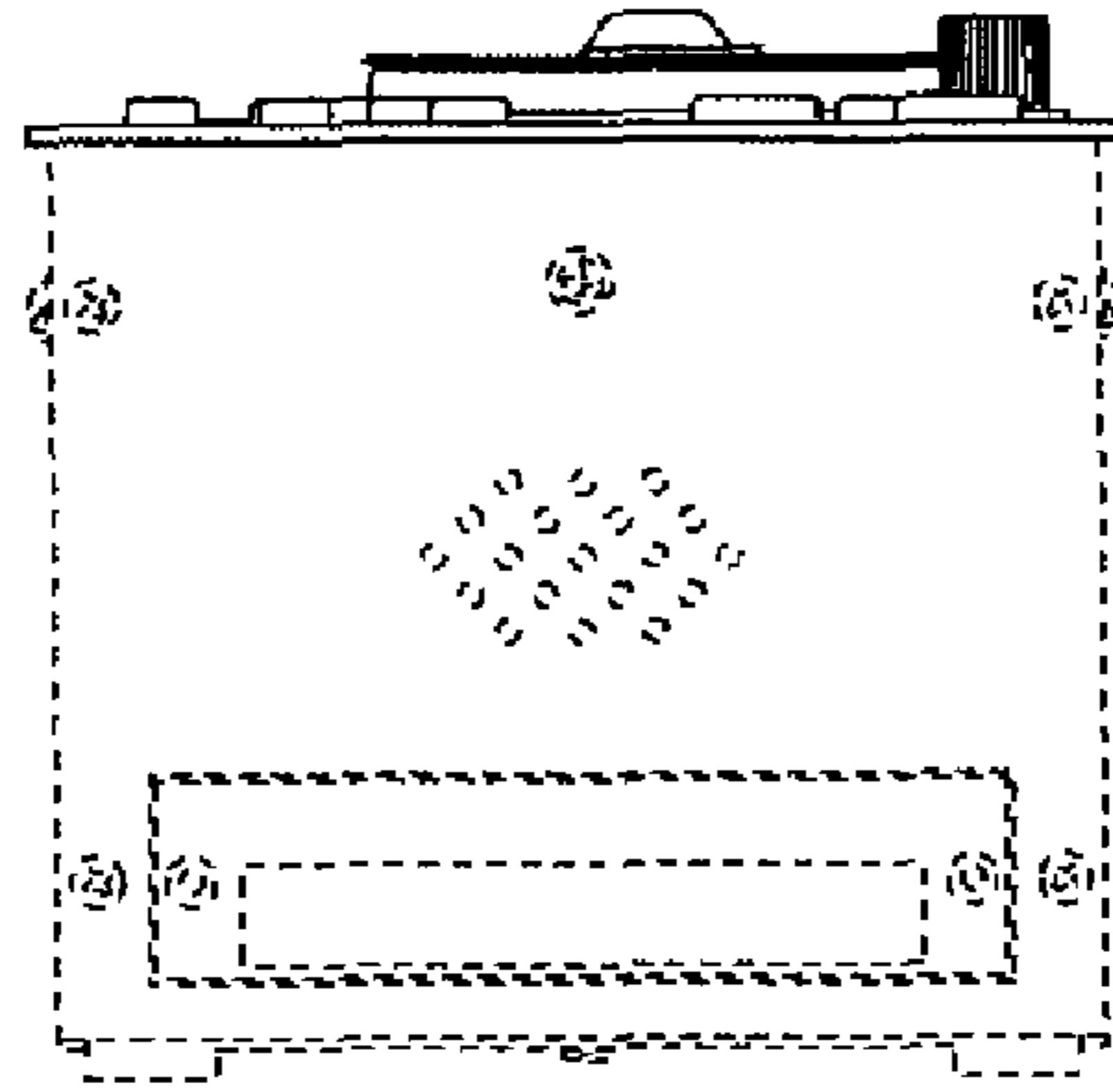

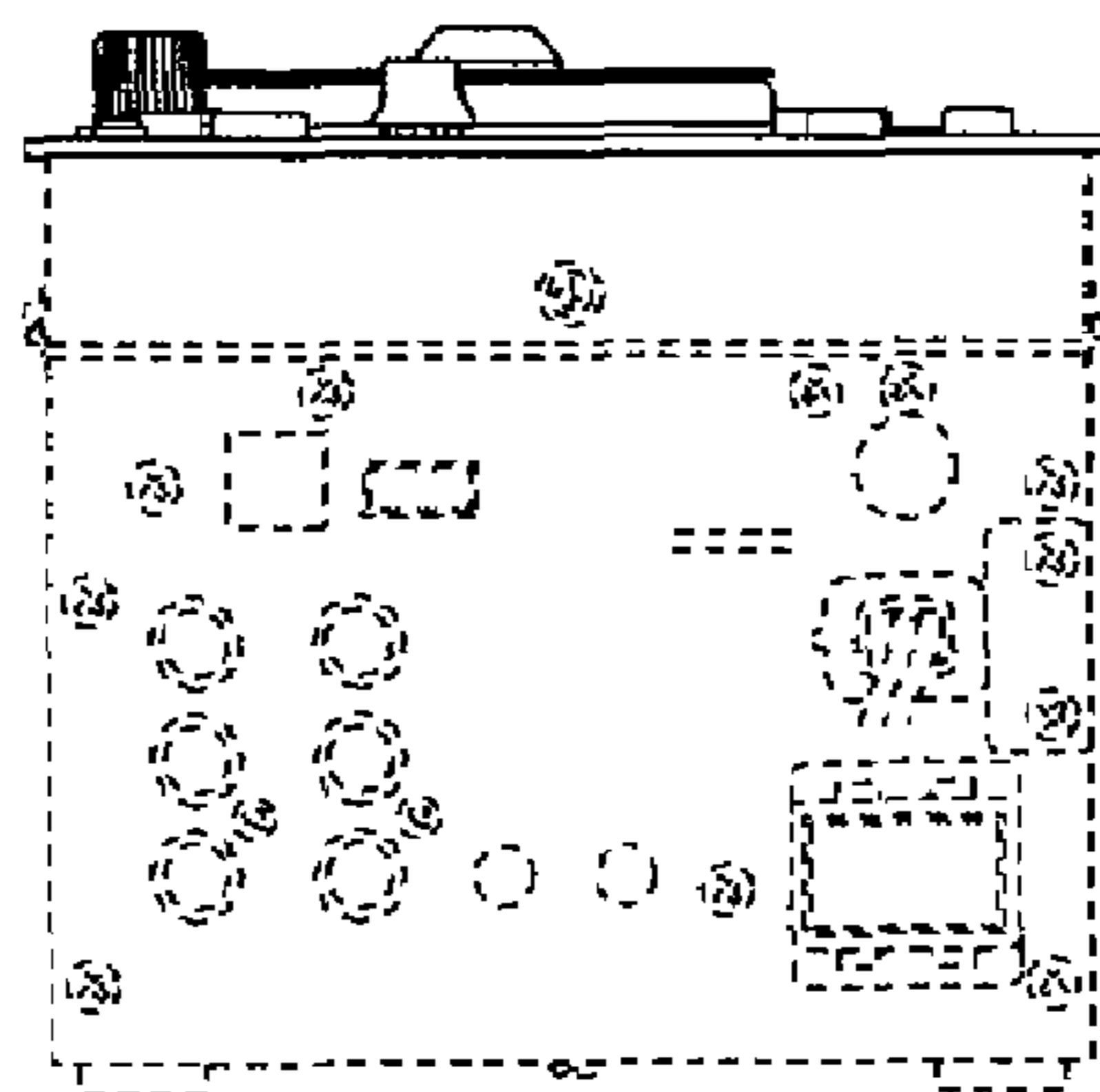
