(57) **CLAIM**

I claim the ornamental design for a LCD video projector, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a LCD video projector of the present invention;

FIG. 2 is a front elevation view thereof;

FIG. 3 is rear elevation view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is front, top and right side perspective view thereof shown in an opened position.

The broken line showing of LCD video projector is included for the purpose of illustrating environment and forms no part of the claimed design.

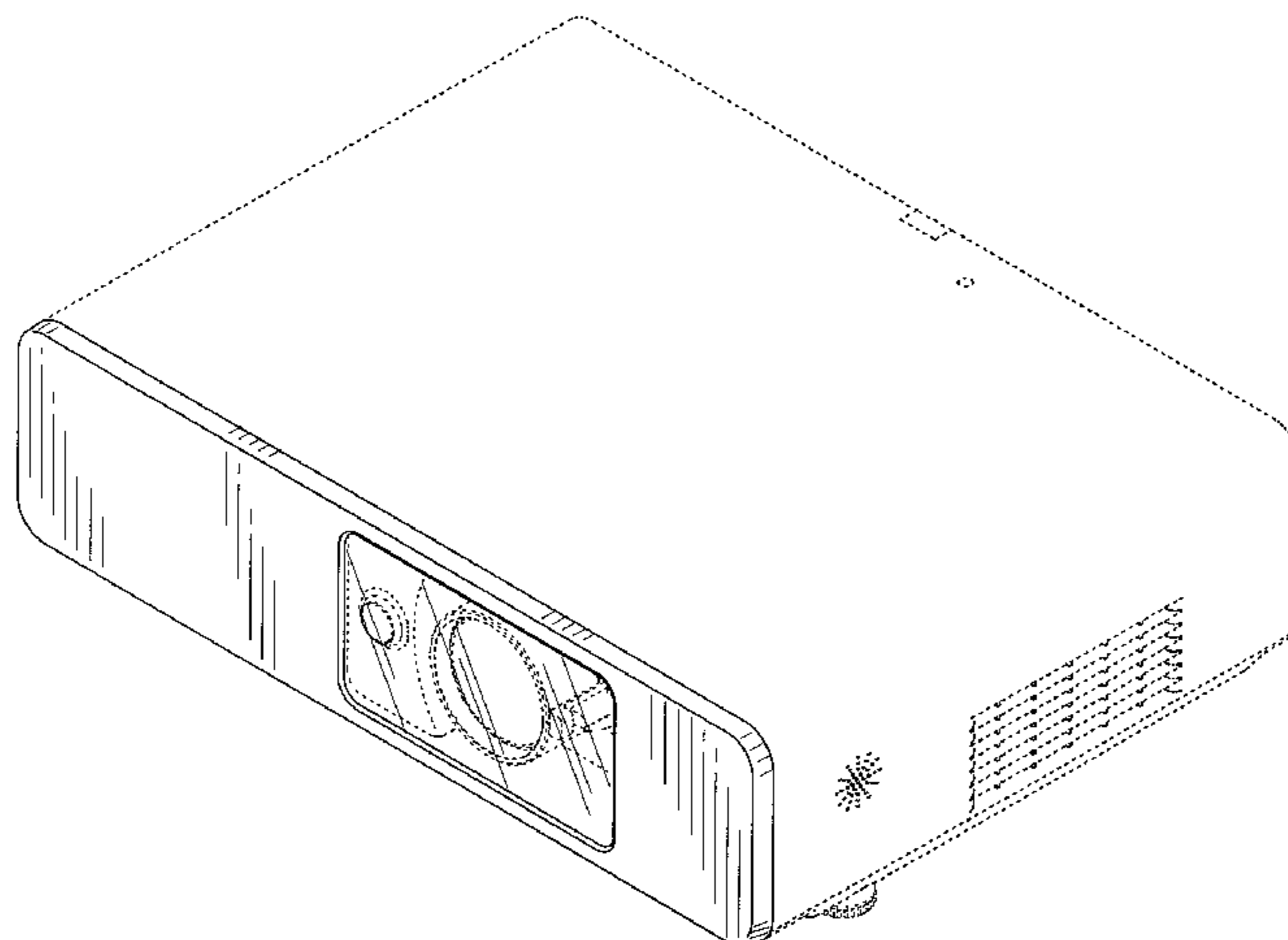

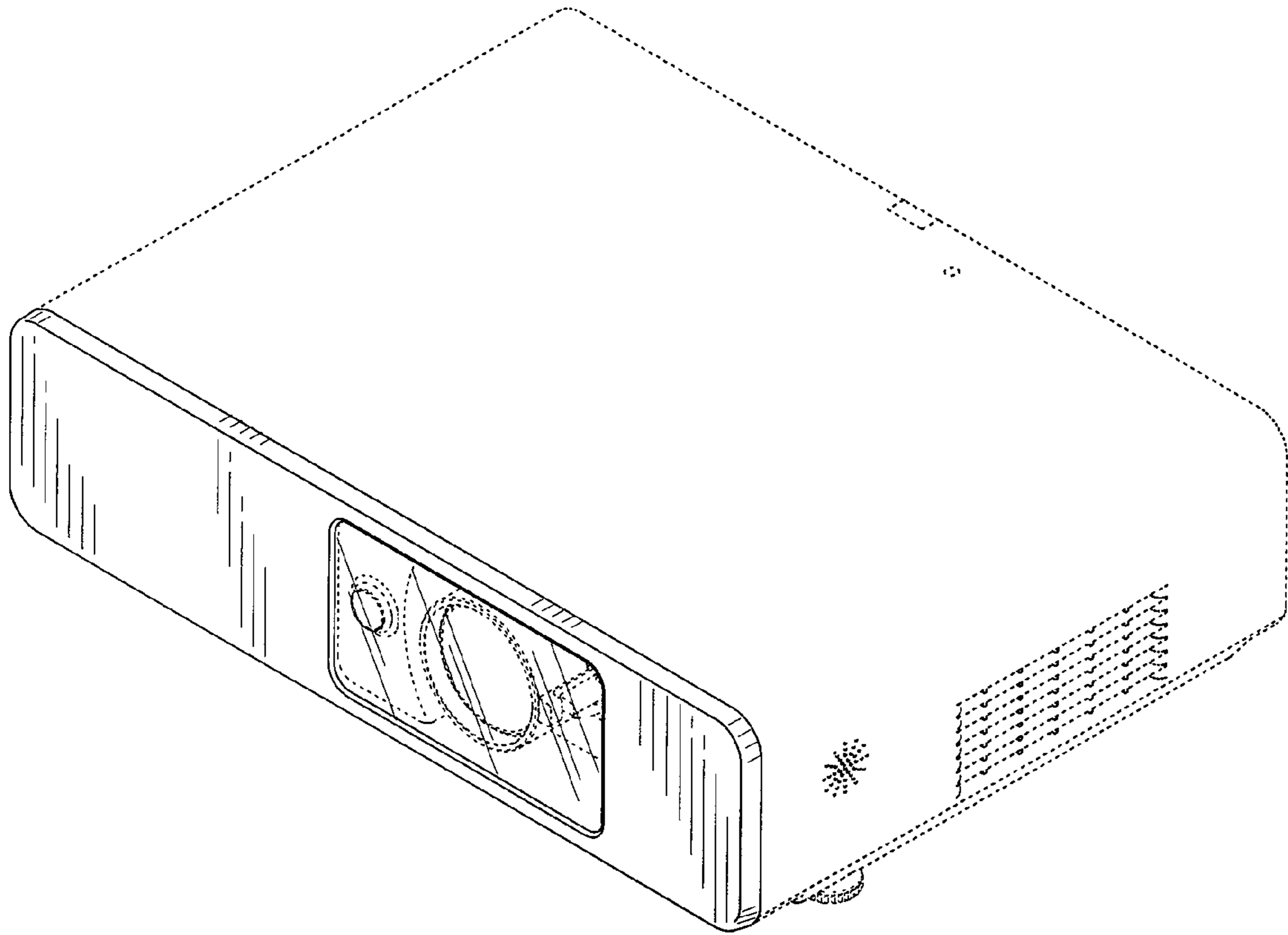

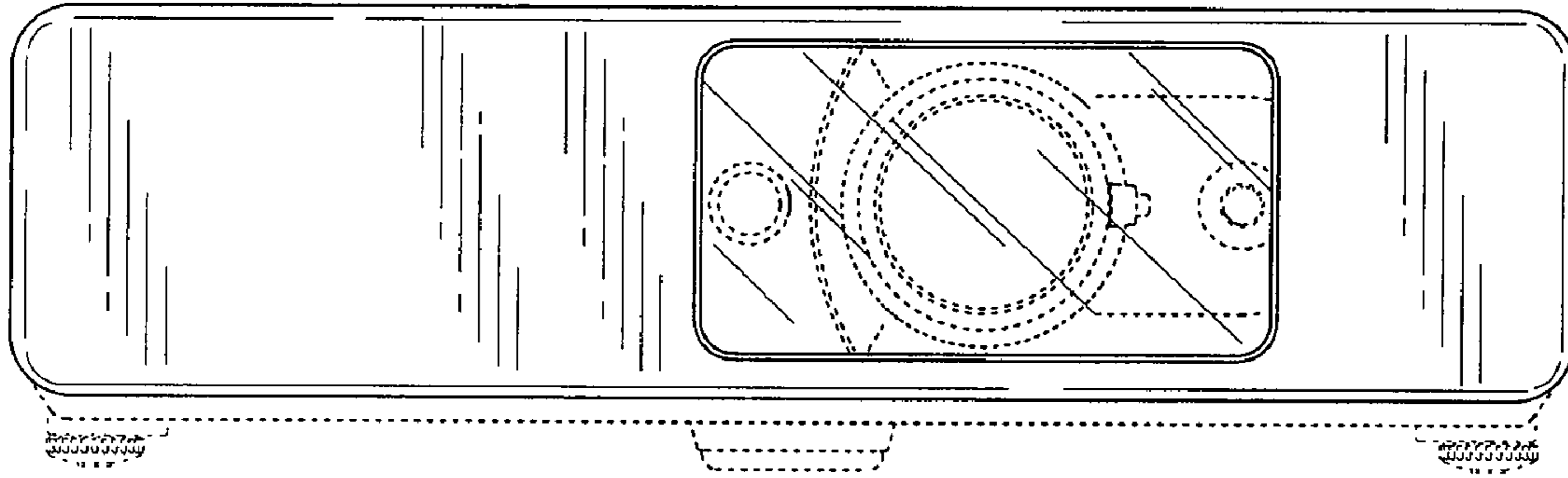

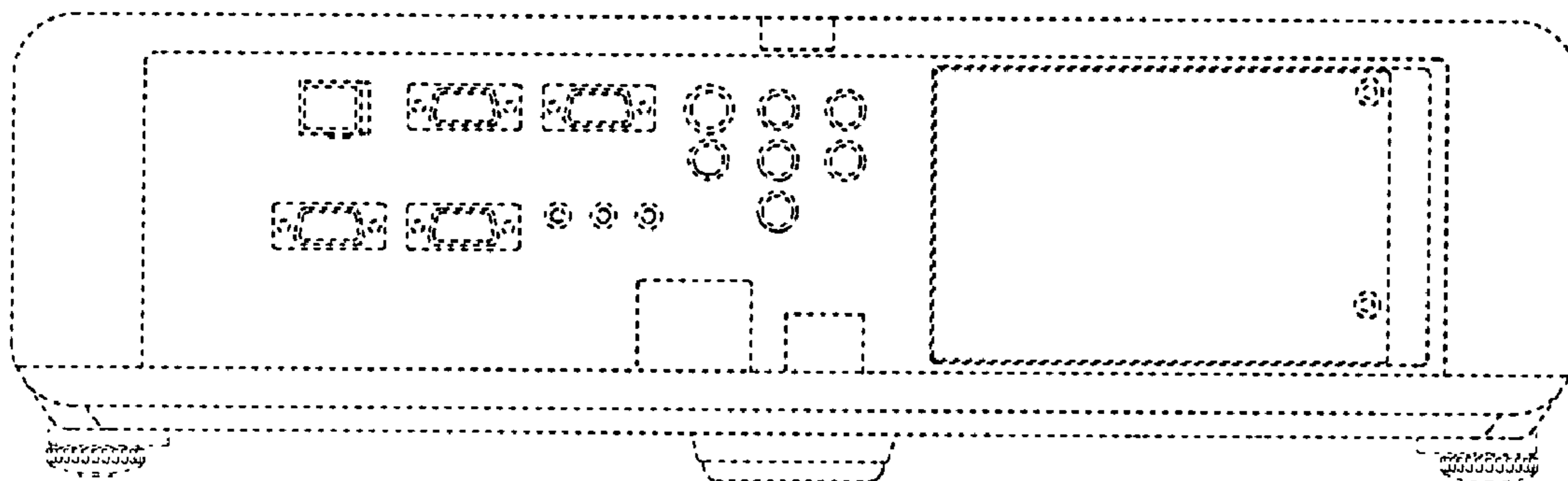

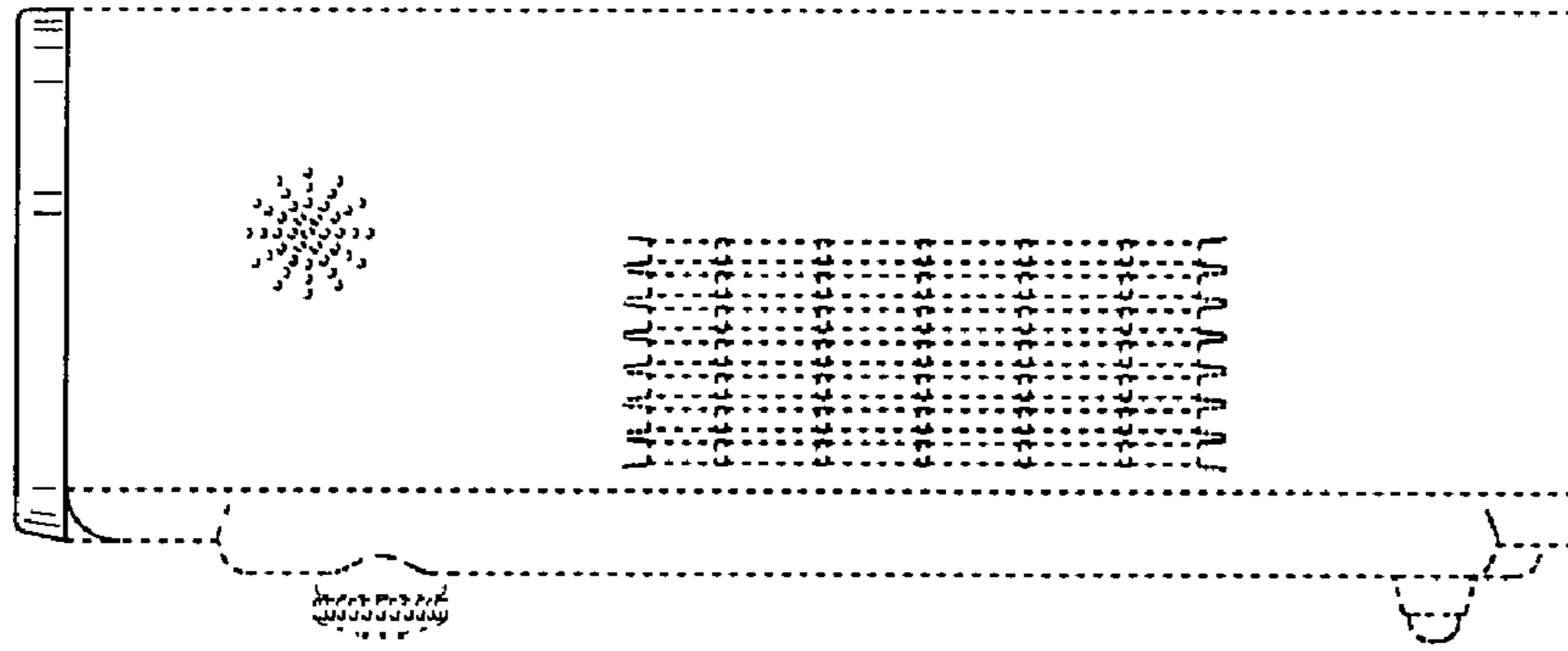

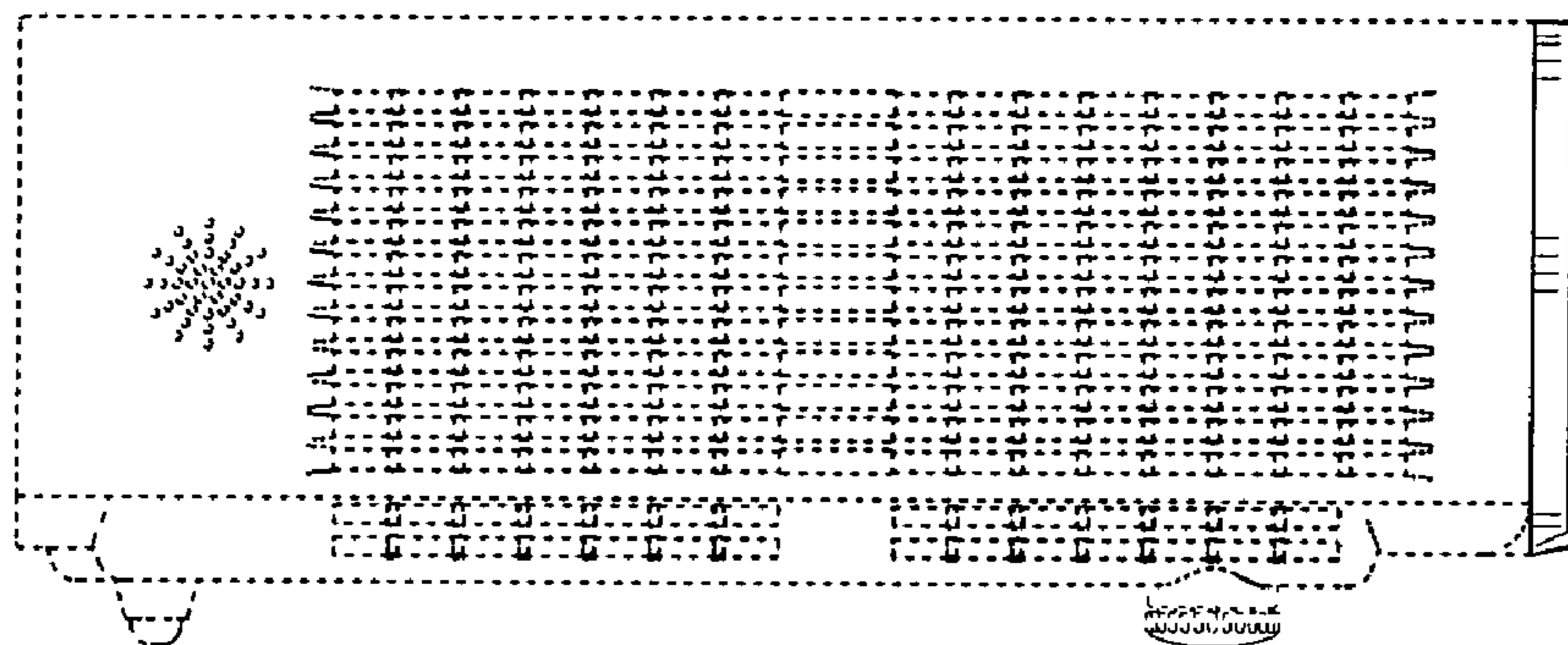

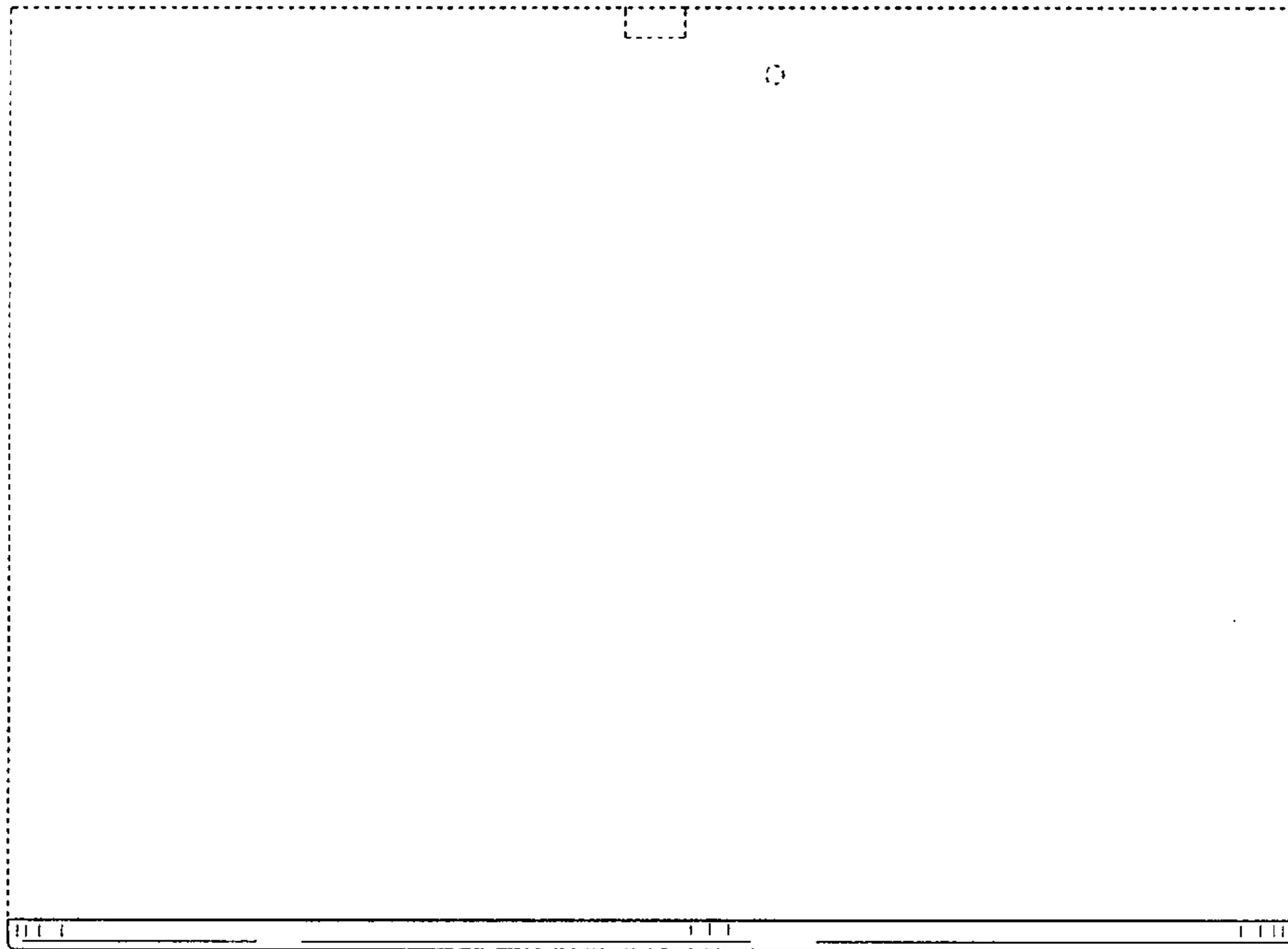

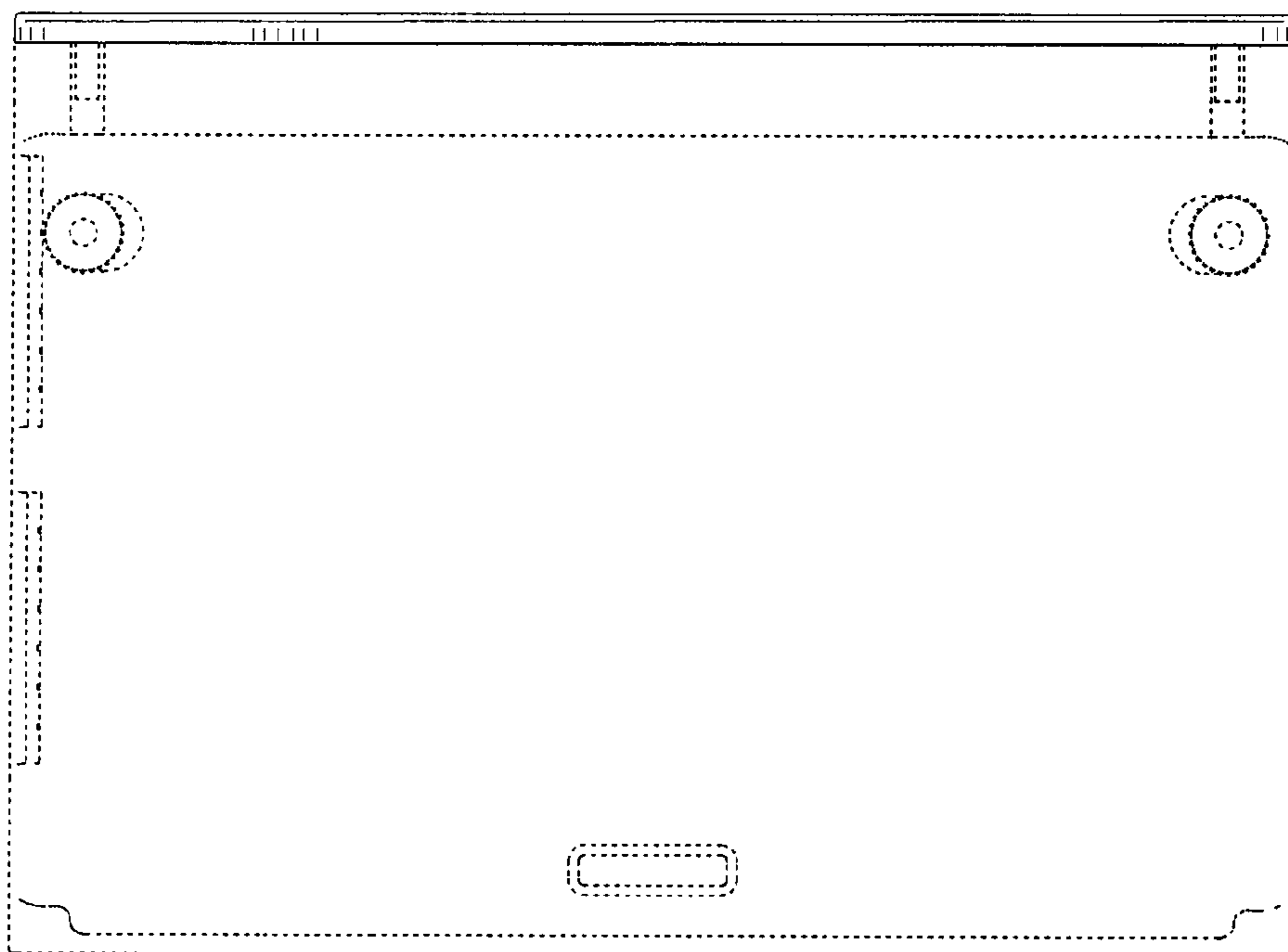
