FIG. 3 is a top plan view thereof;

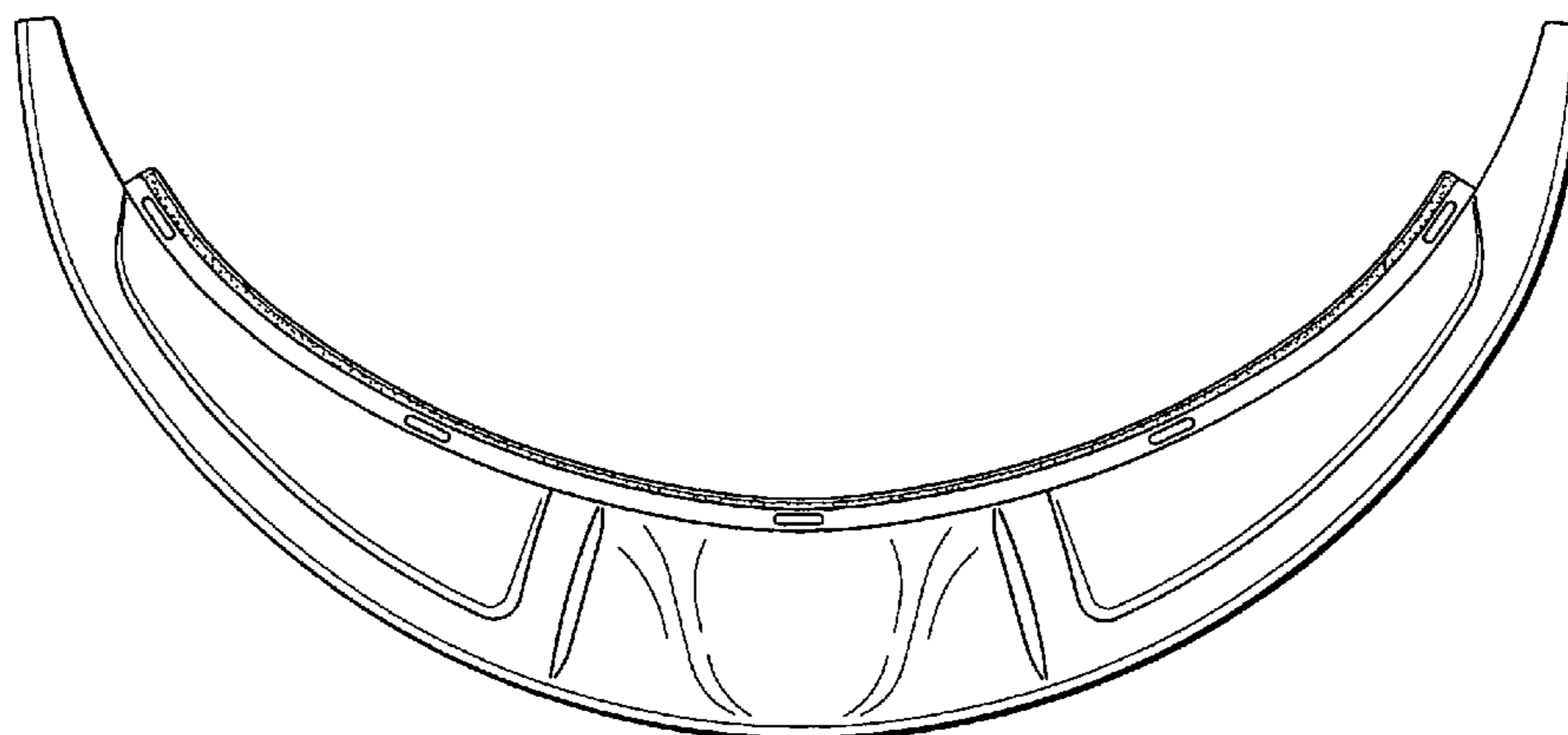
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror opposite of the right side;

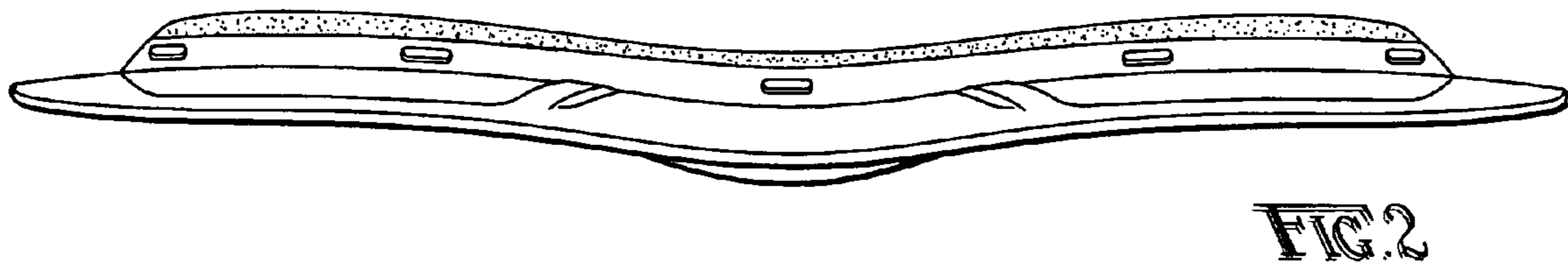
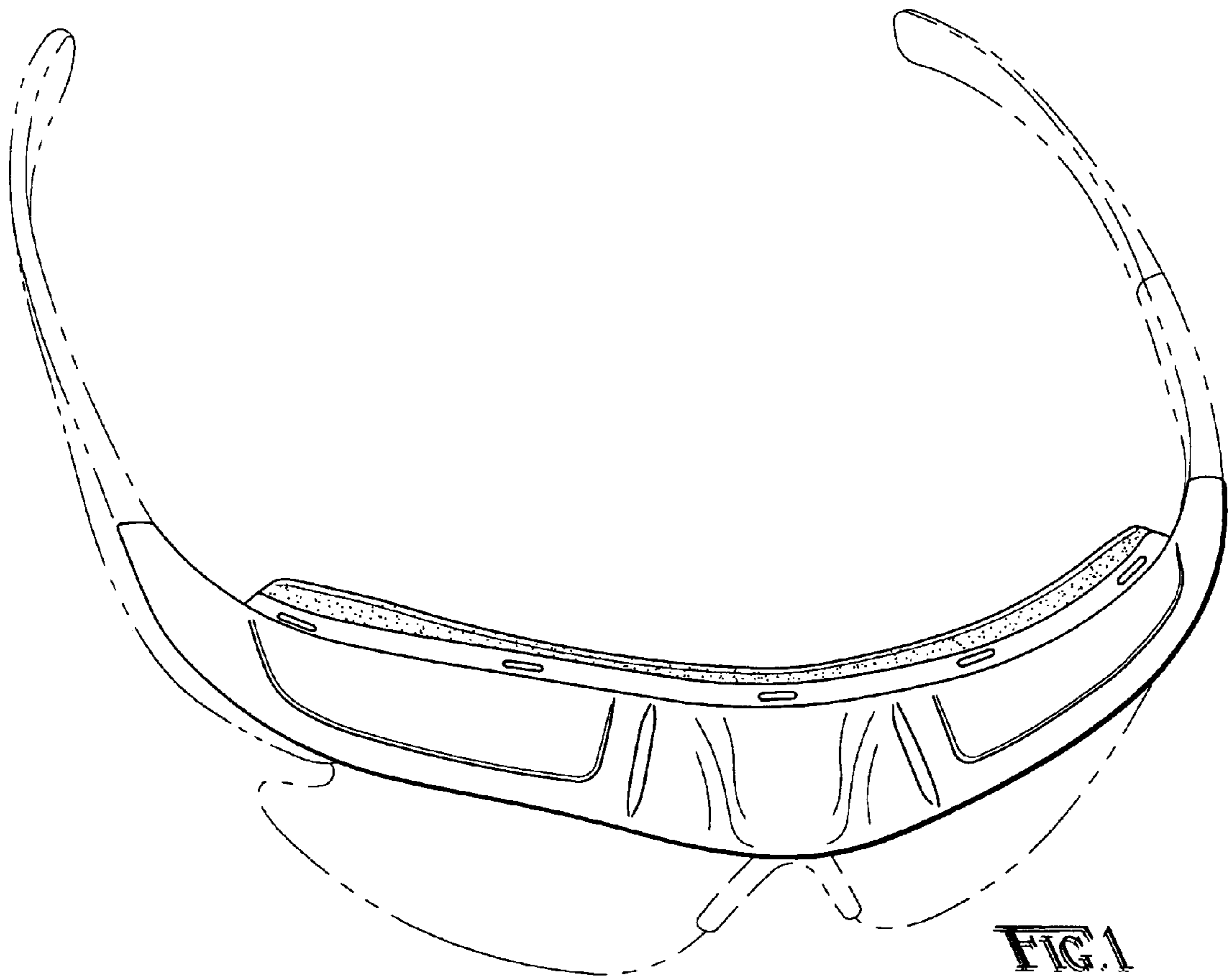
FIG. 5 is a rear elevational view thereof; and,

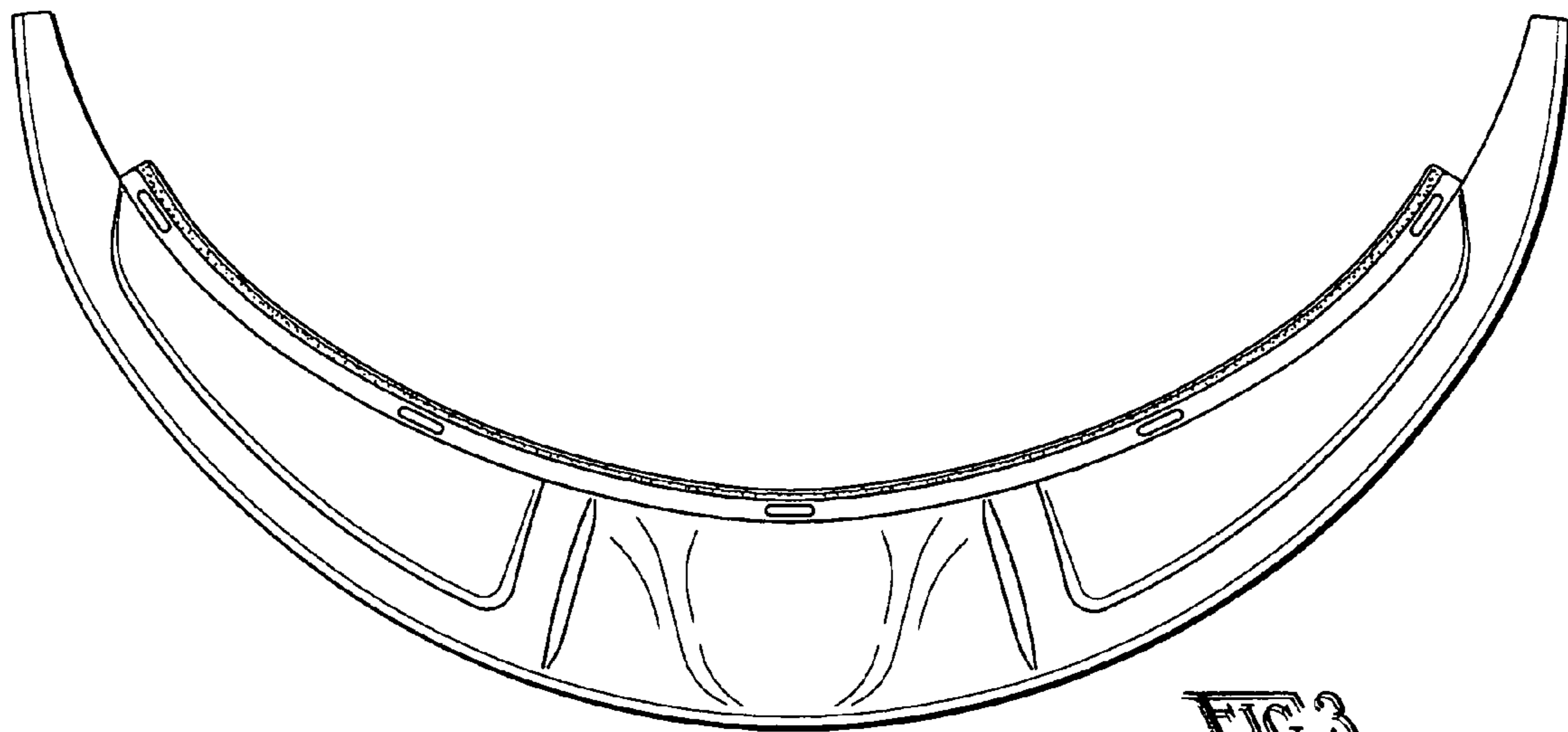

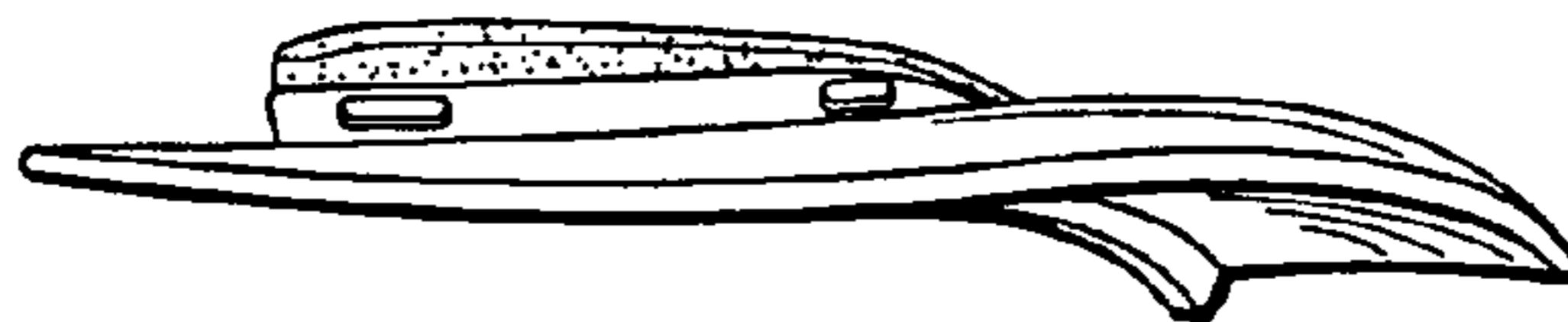

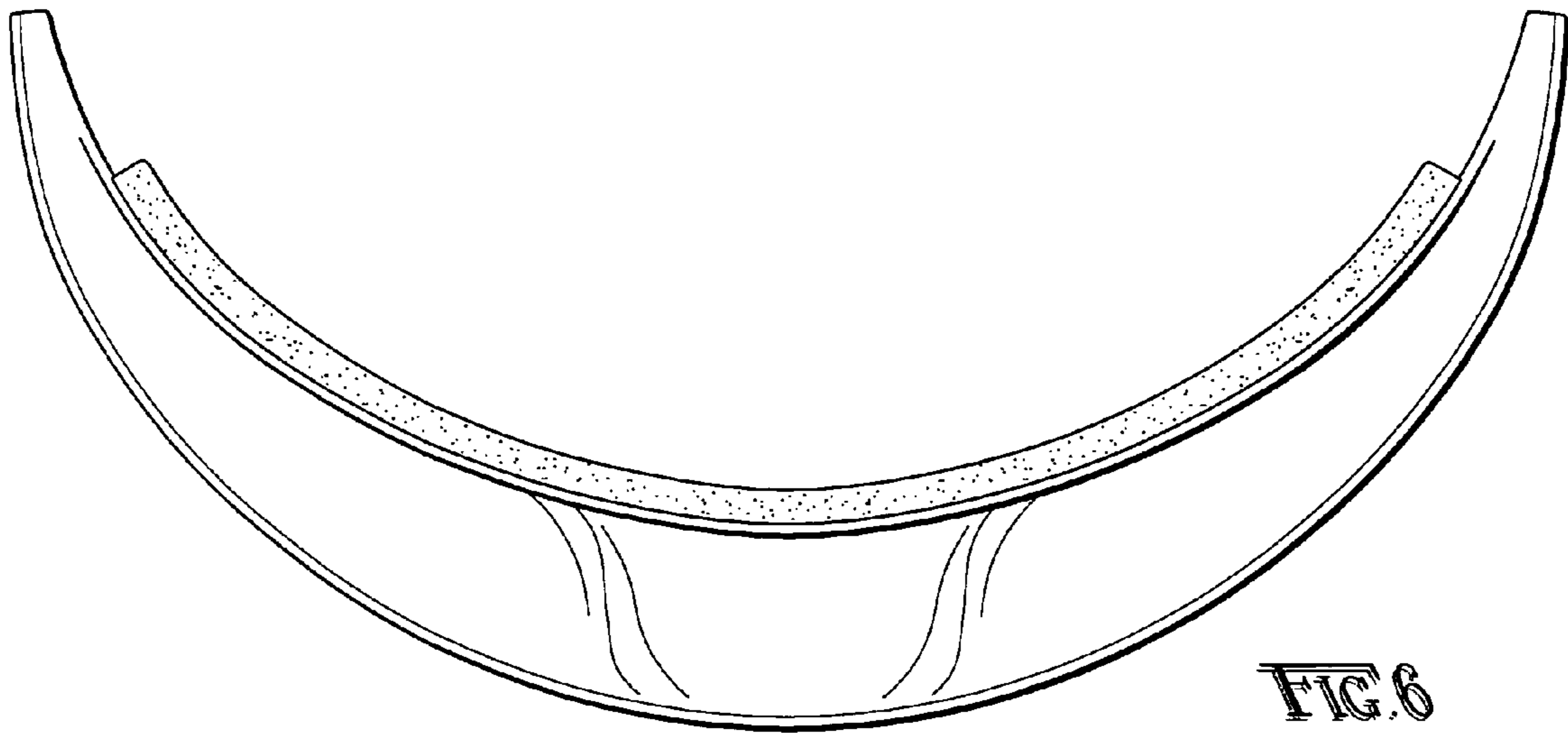
