DESCRIPTION

FIG. 1 is a front perspective view of the acoustic feedback learning aid design;

FIG. 2 is a front plan view of the acoustic feedback learning aid design;

FIG. 3 is rear plan view of the acoustic feedback learning aid design;

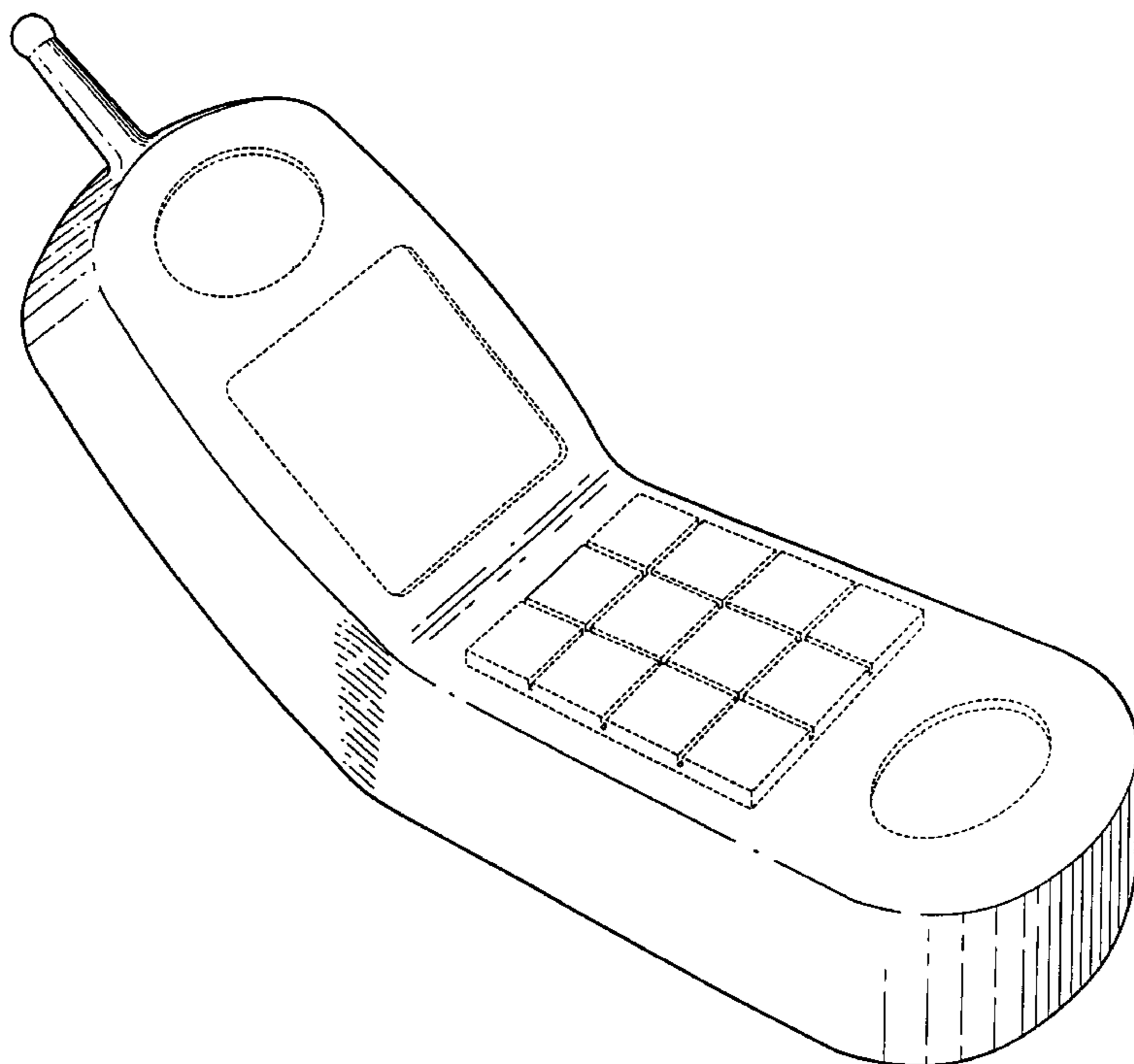
FIG. 4 is a side elevation view of the acoustic feedback learning aid design, with the opposite side being symmetrical thereto;

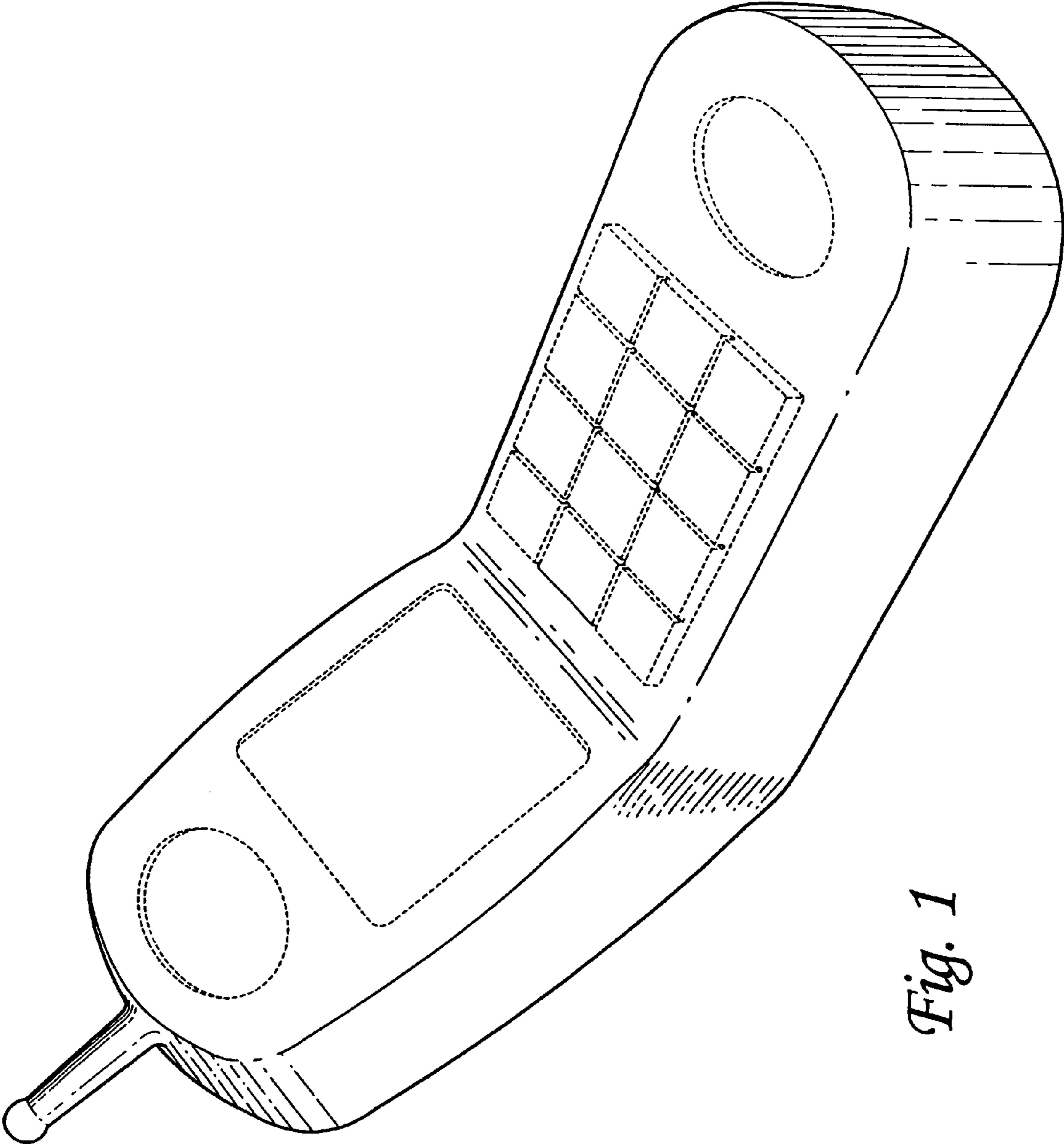

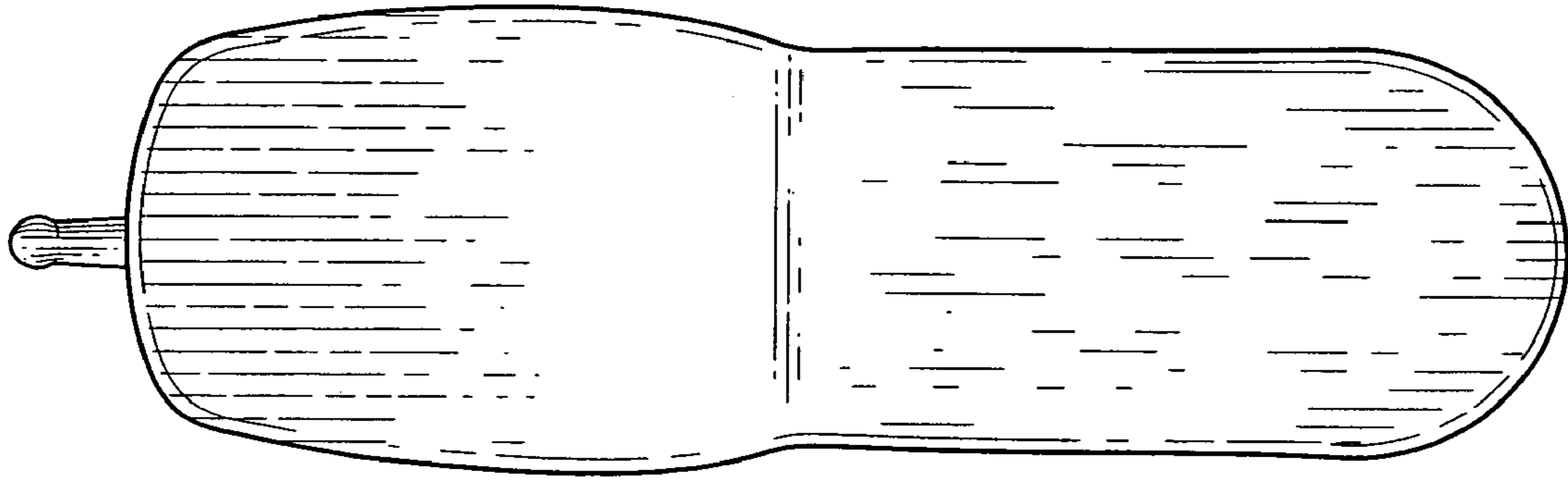

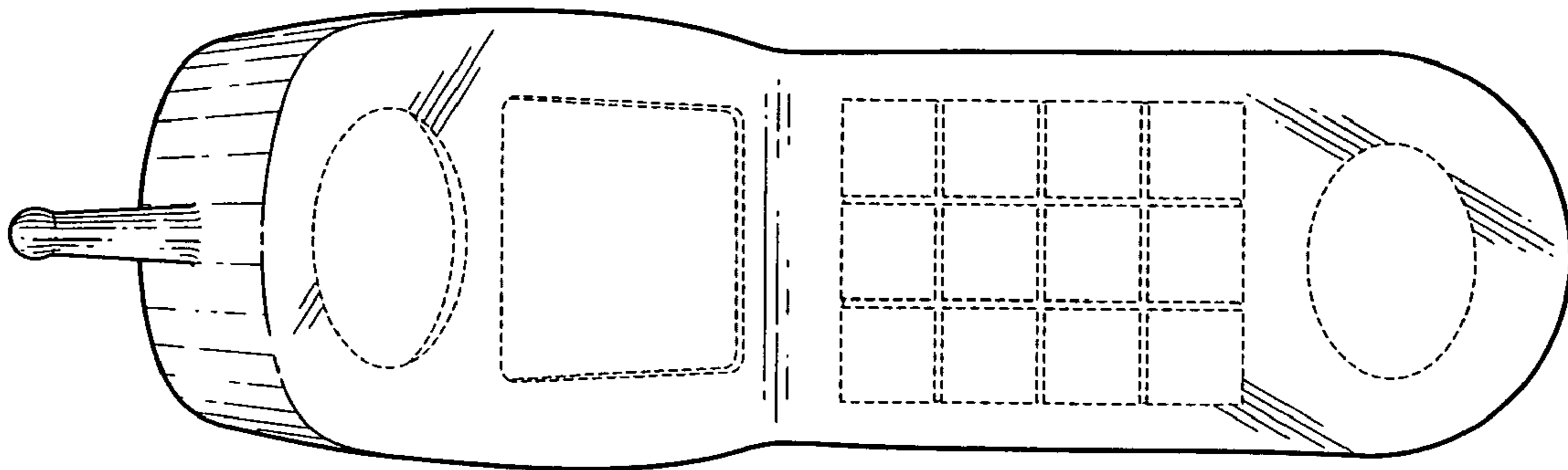

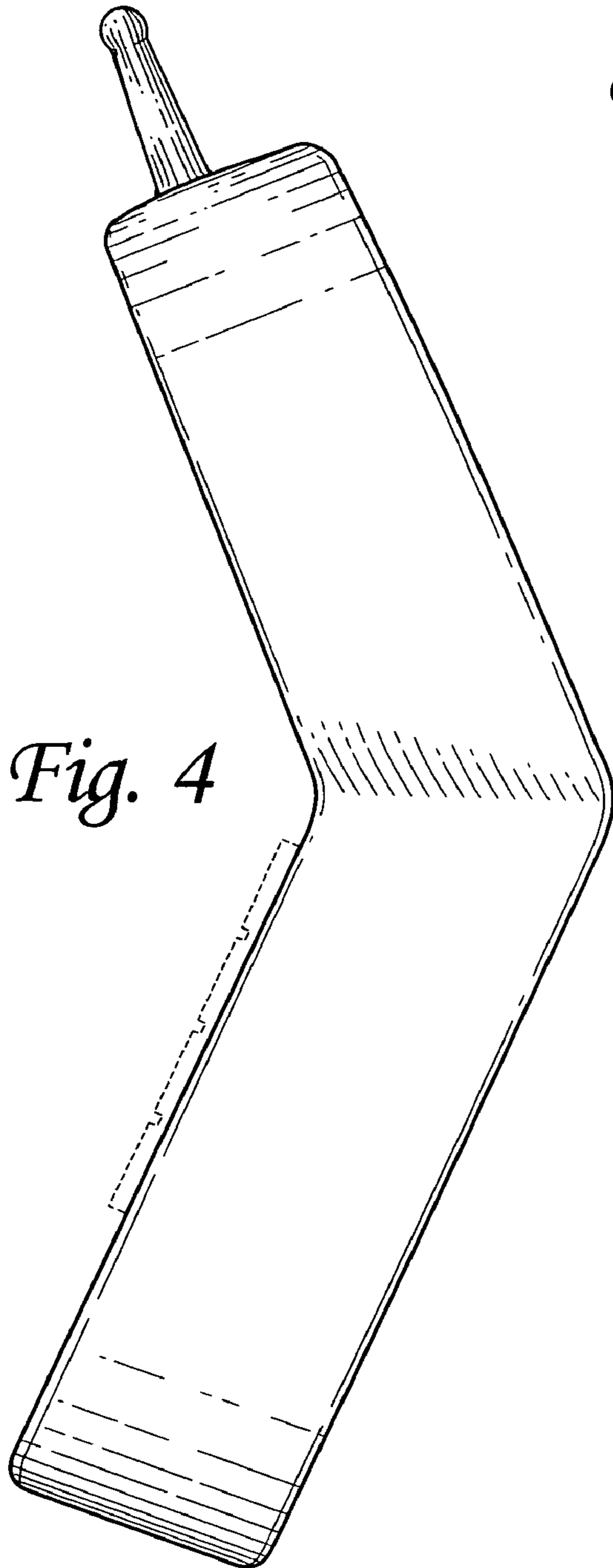

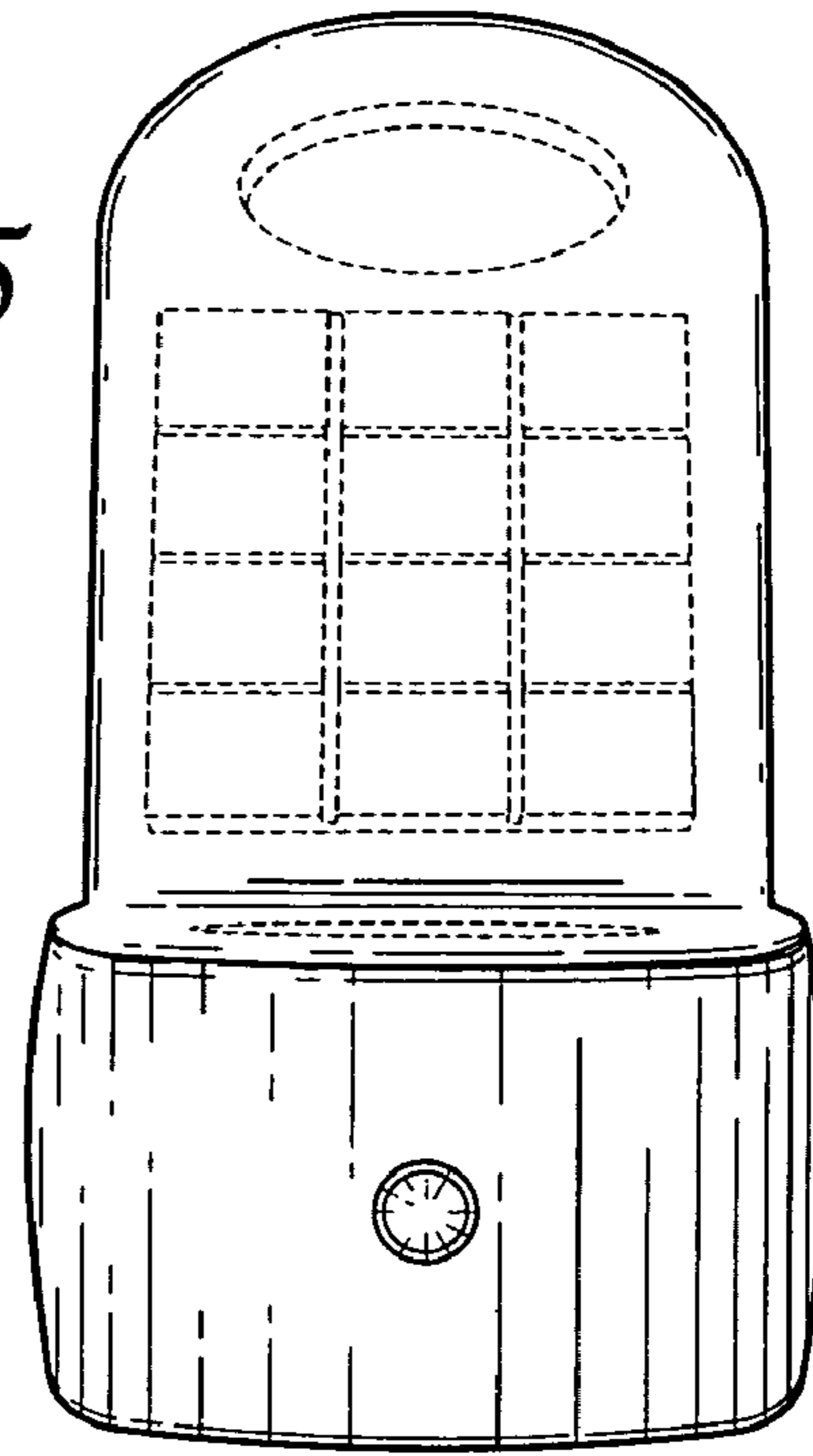
