FIG. 6 is a front view of a wood type golf club head of FIG. 1 showing our inventive design; and,

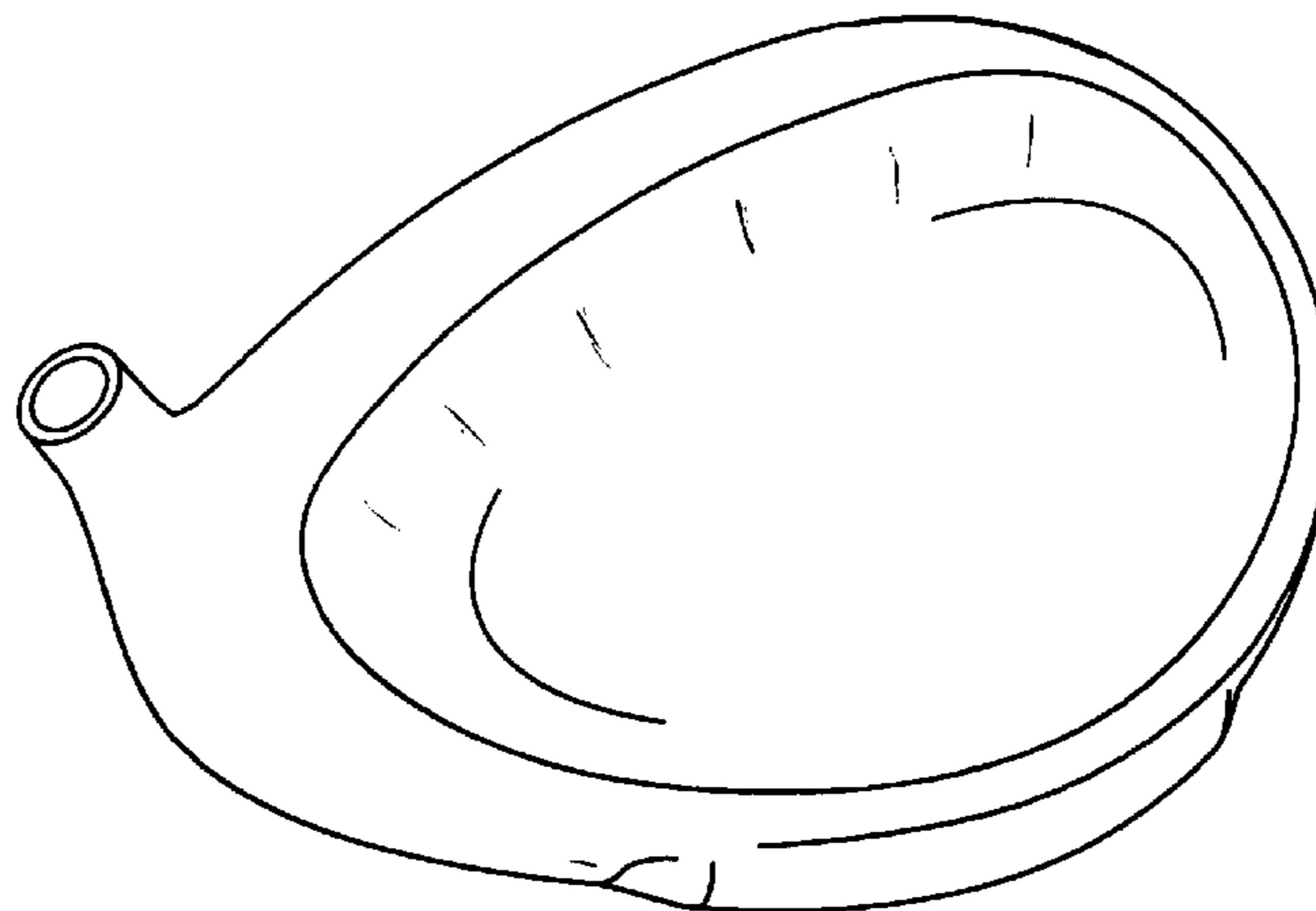
FIG. 7 is a rear perspective view of a wood type golf club head of FIG. 1 showing our inventive design.

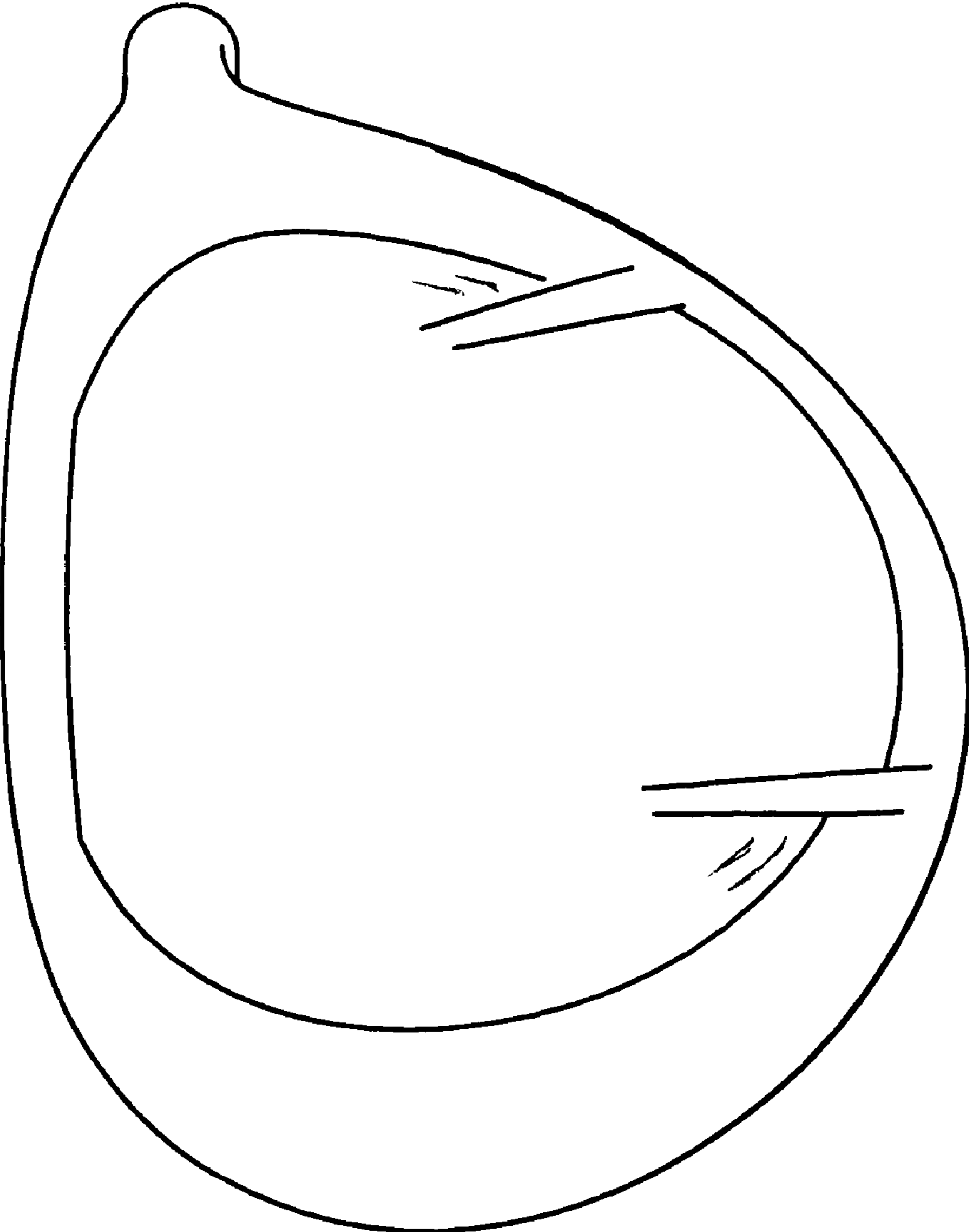

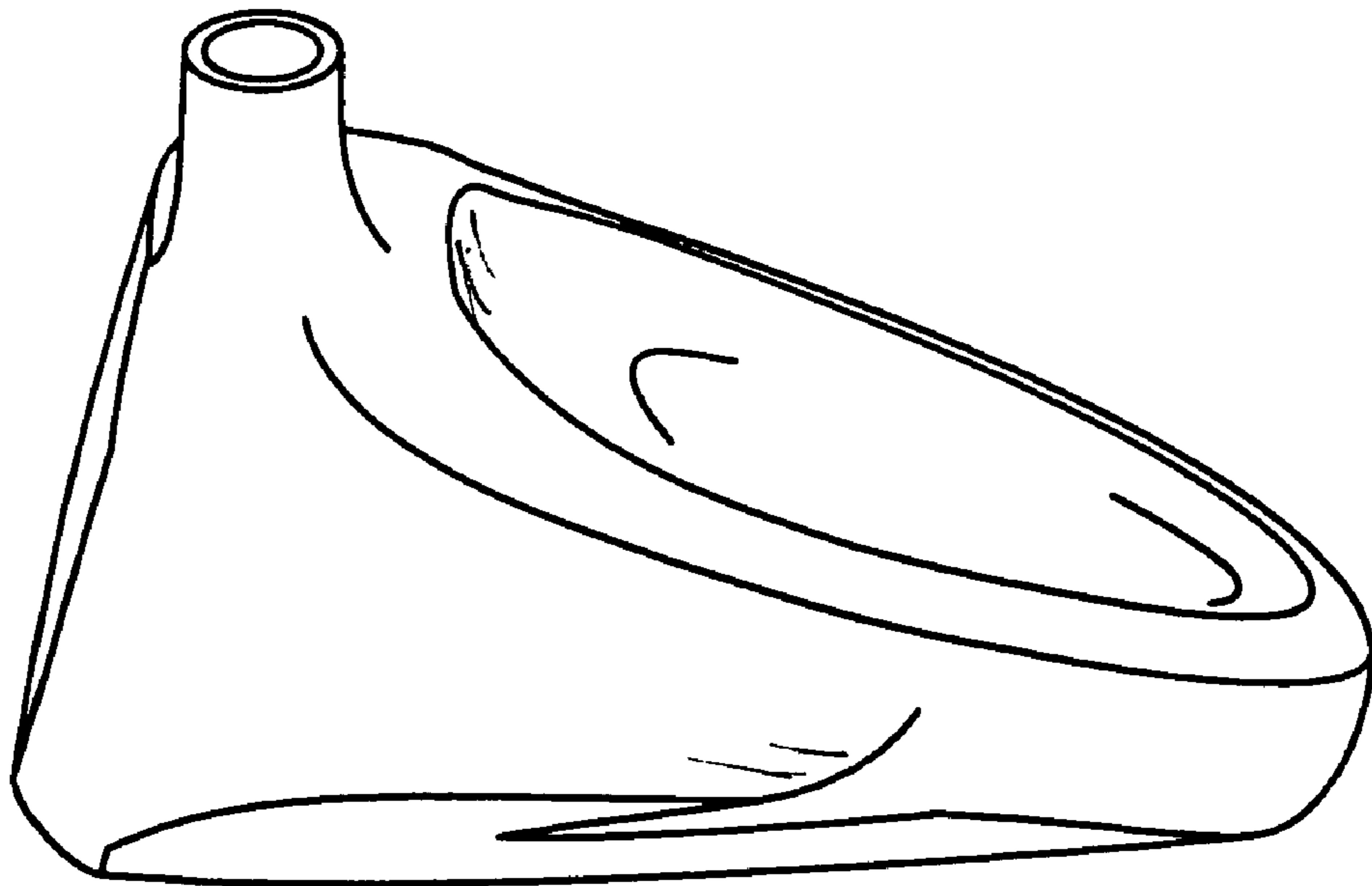

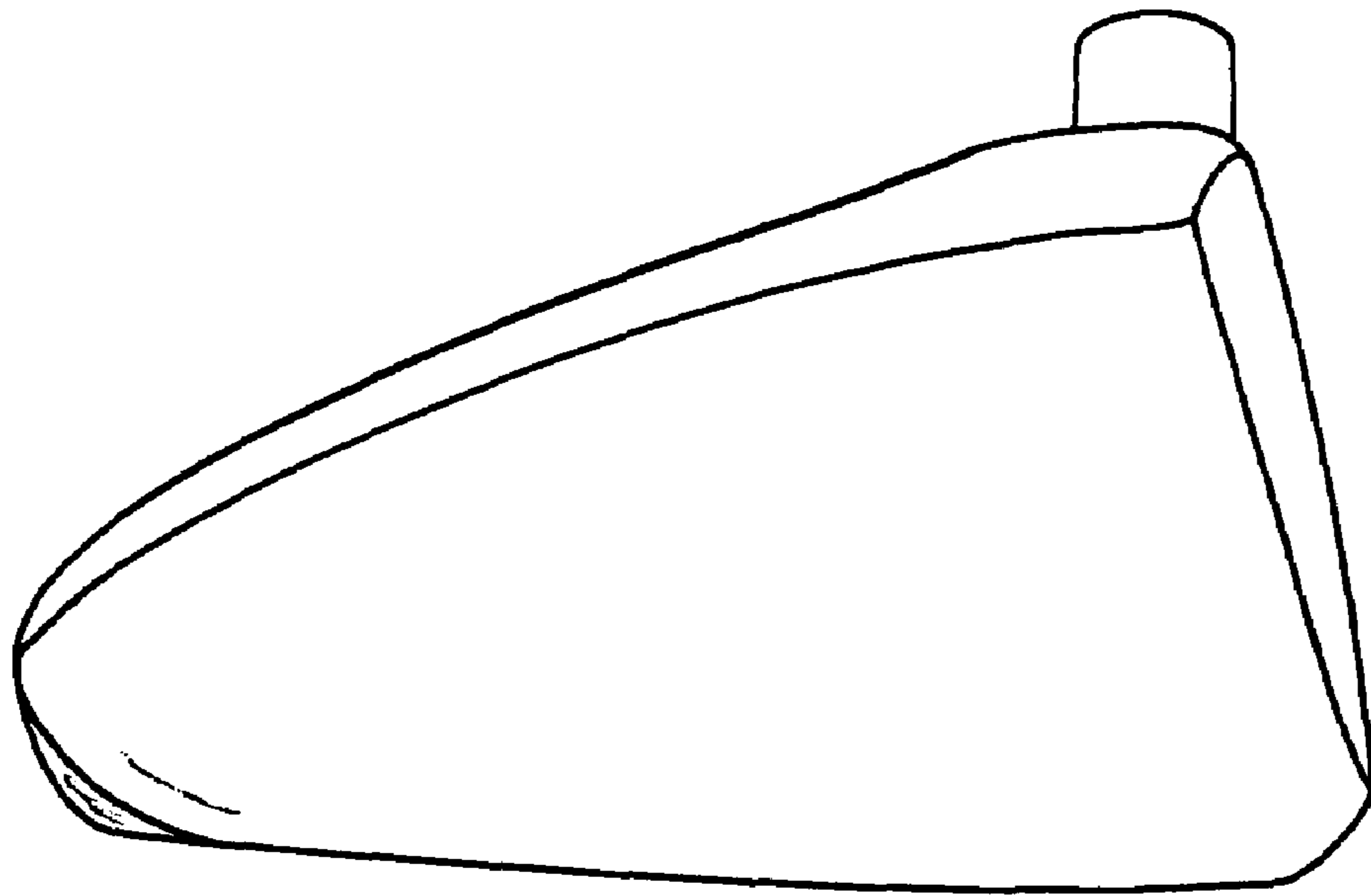

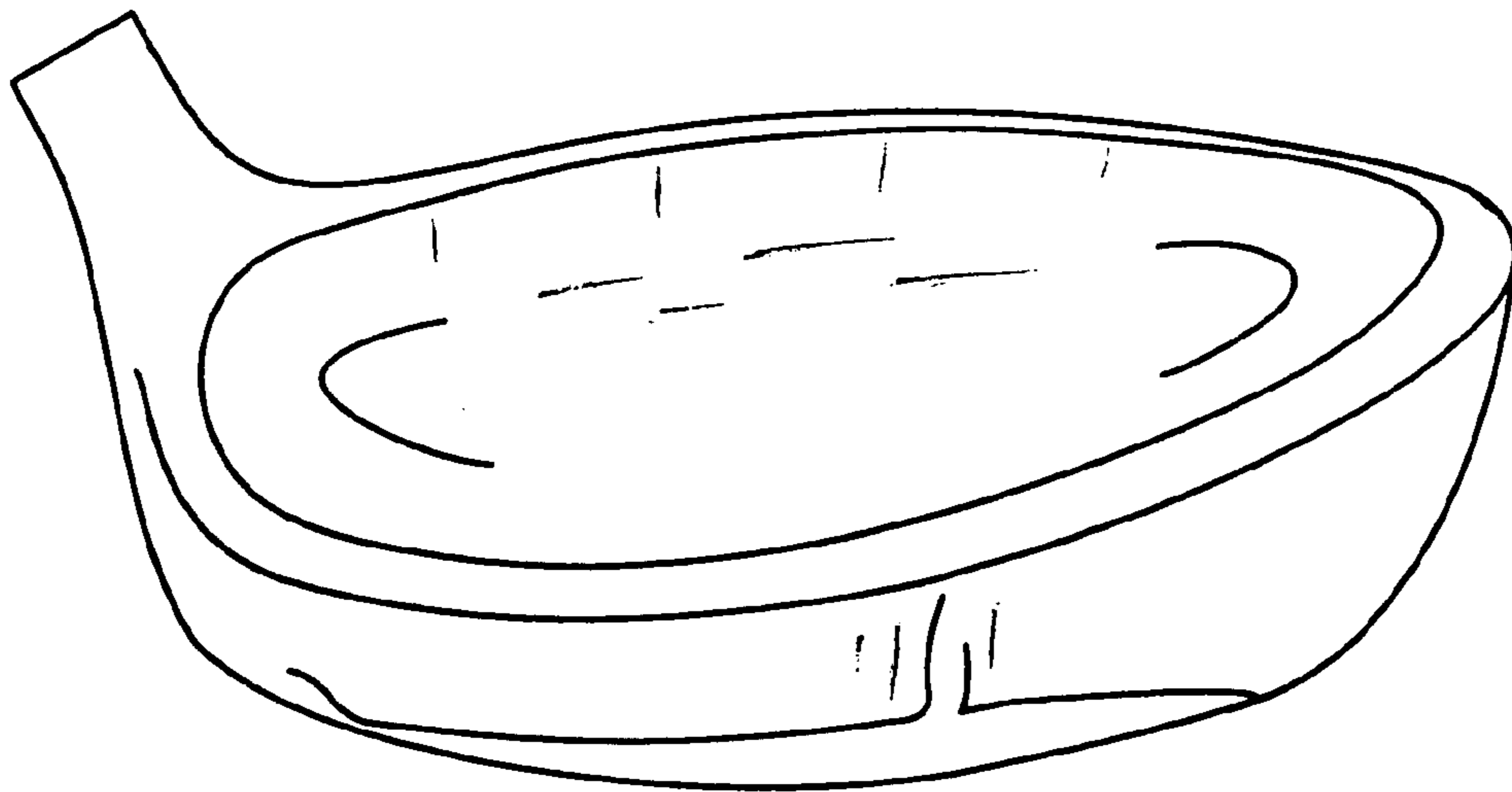

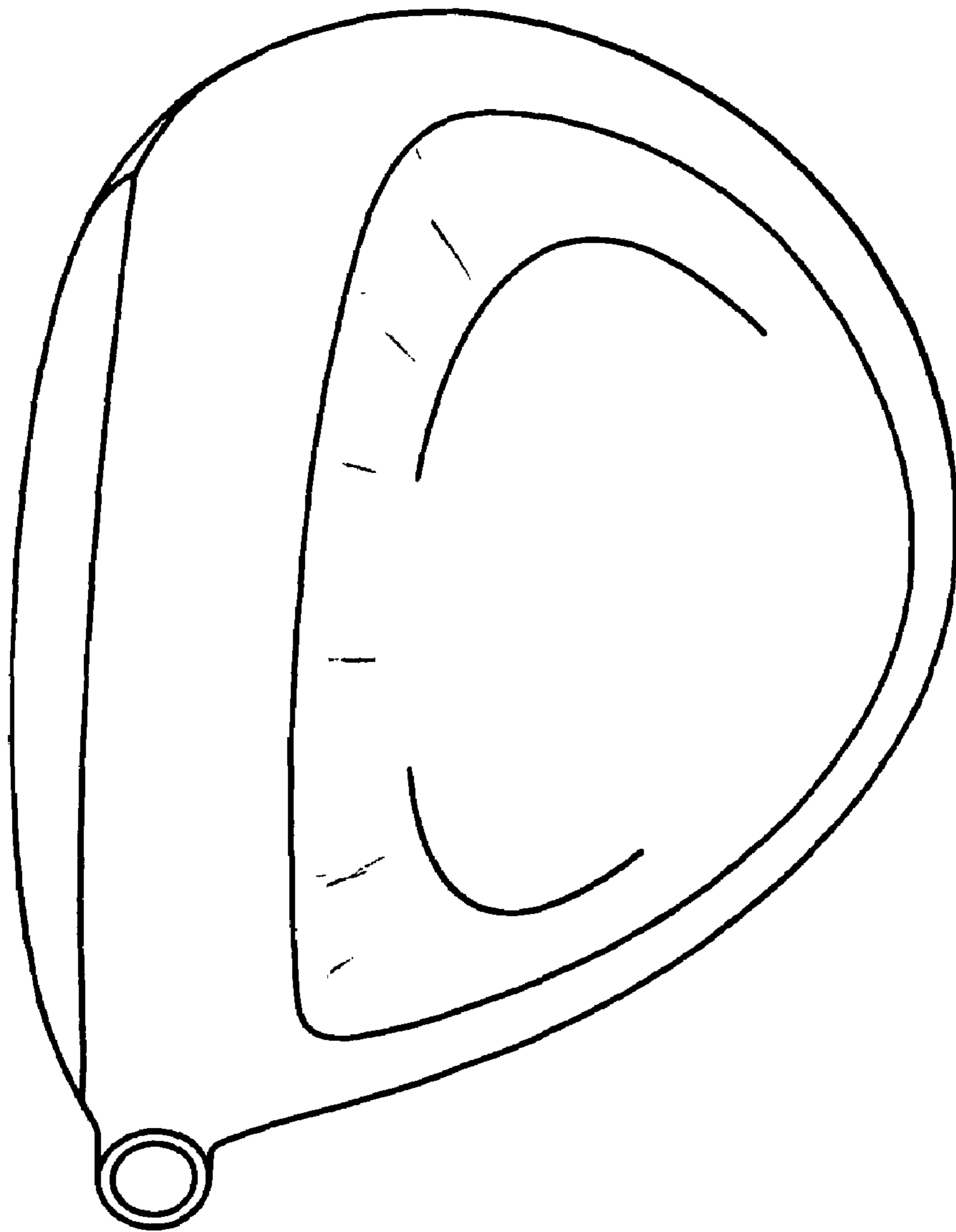

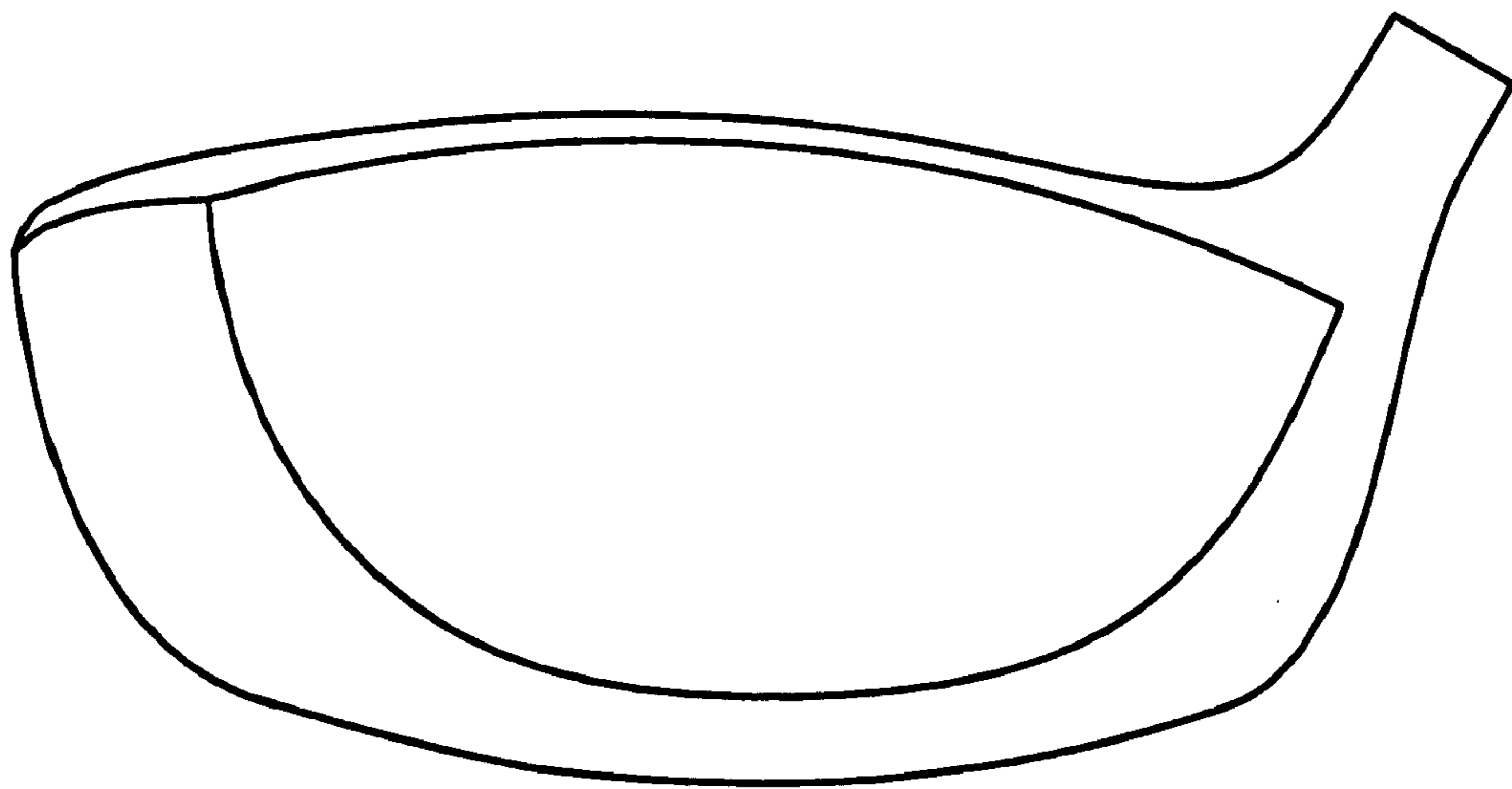

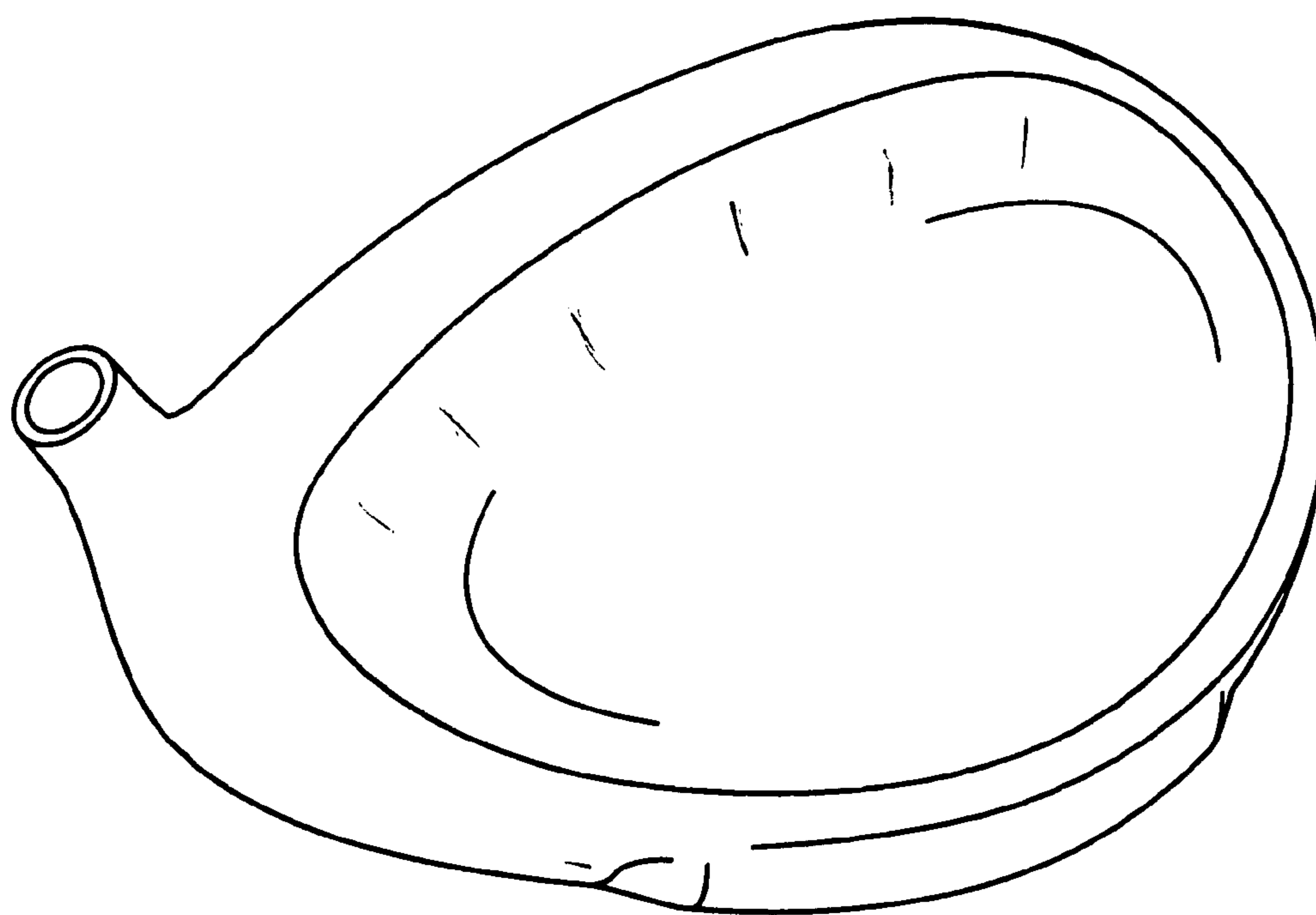
