**DESCRIPTION**

FIG. 8 is a front elevation view thereof;

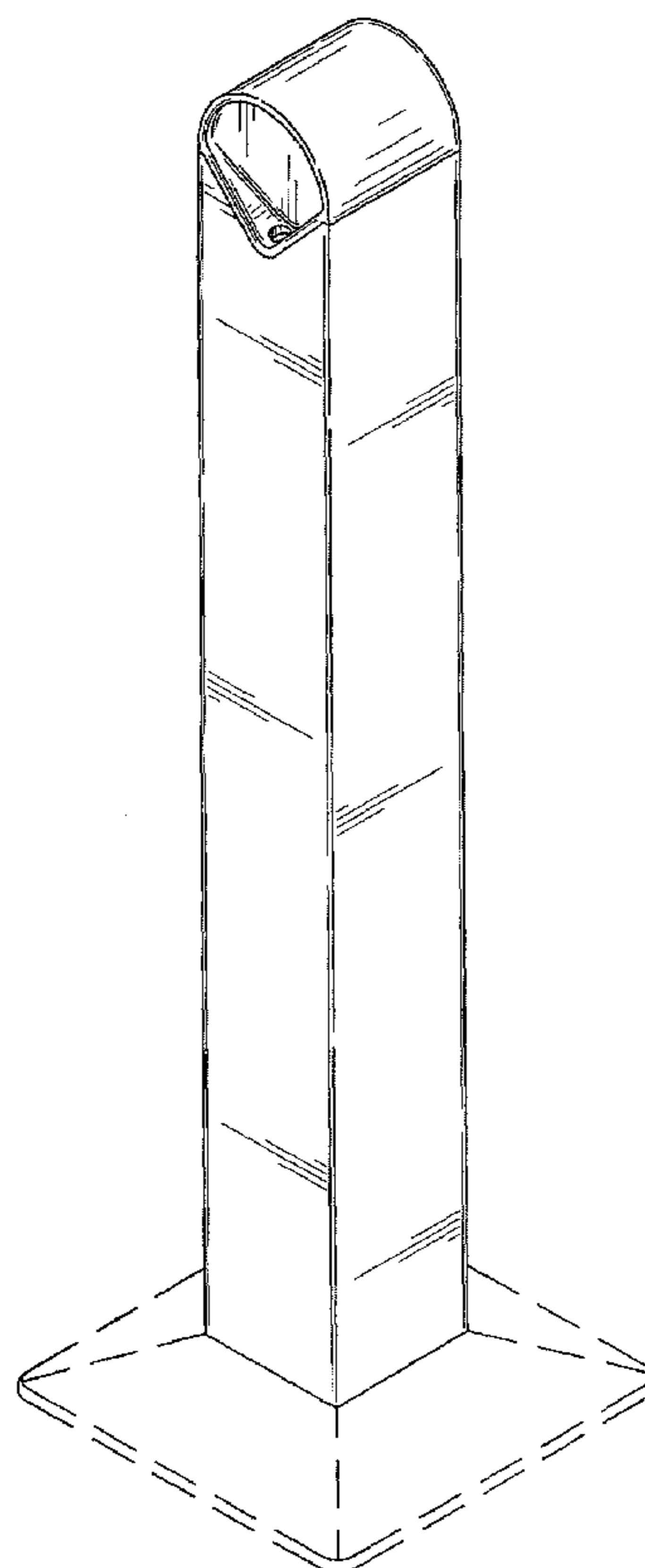
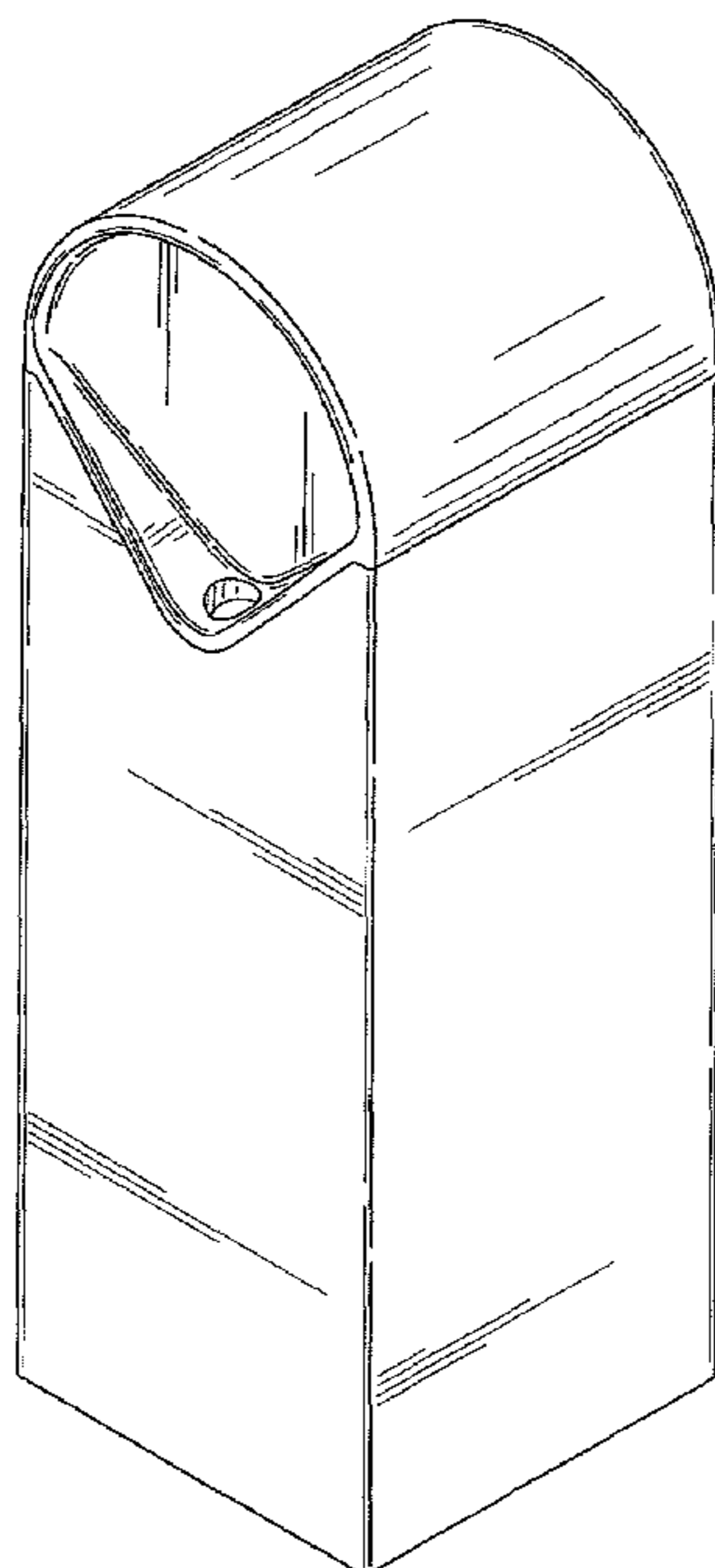
FIG. 9 is a right side elevation view thereof, the left side elevation view being identical thereto;

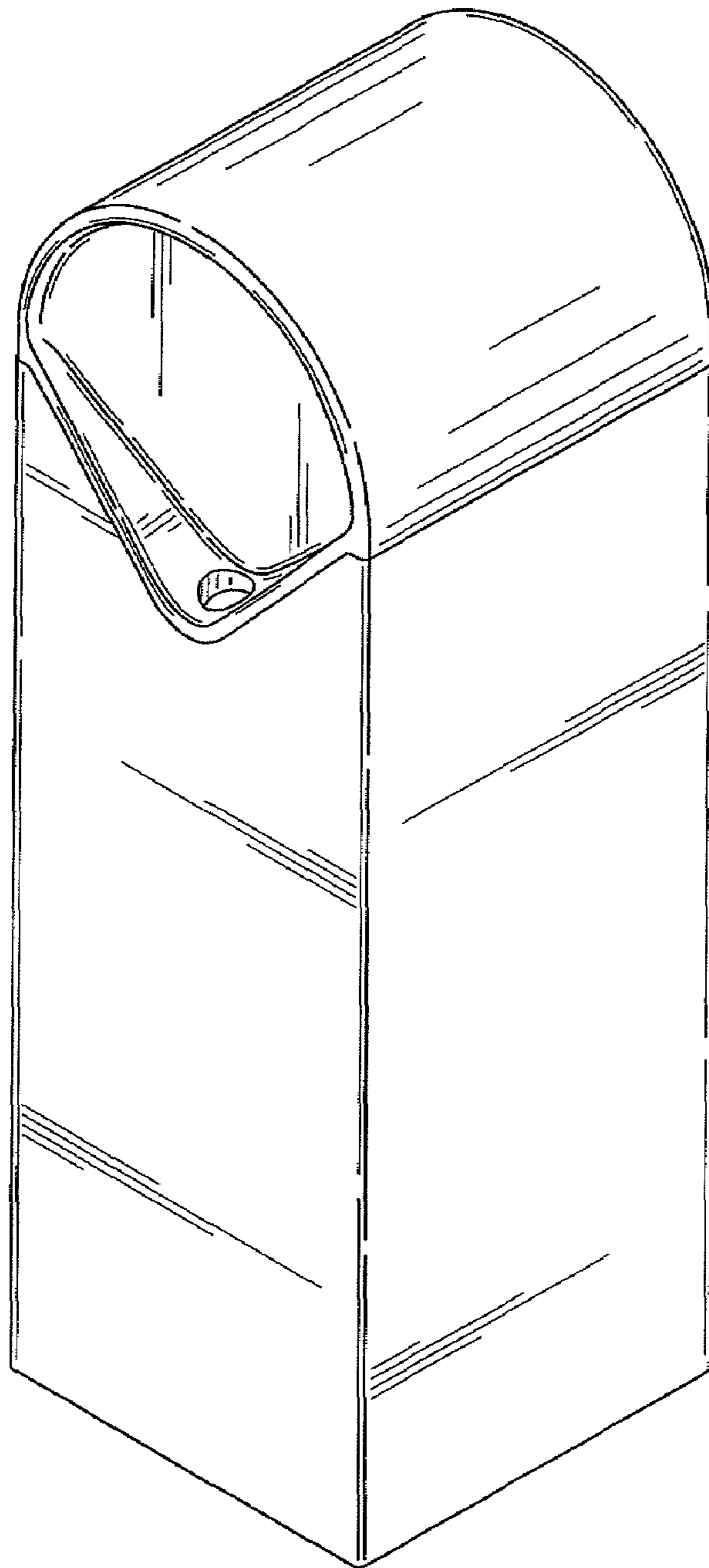
FIG. 10 is a rear elevation view thereof; and,

FIG. 11 is a top plan view thereof.

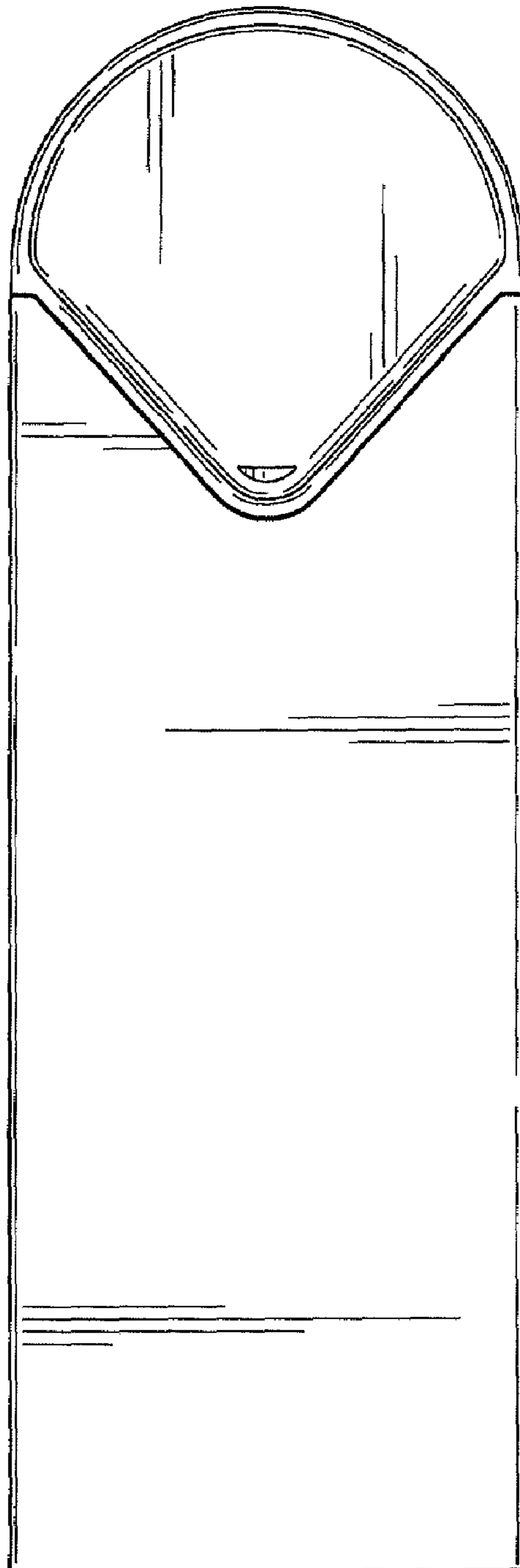

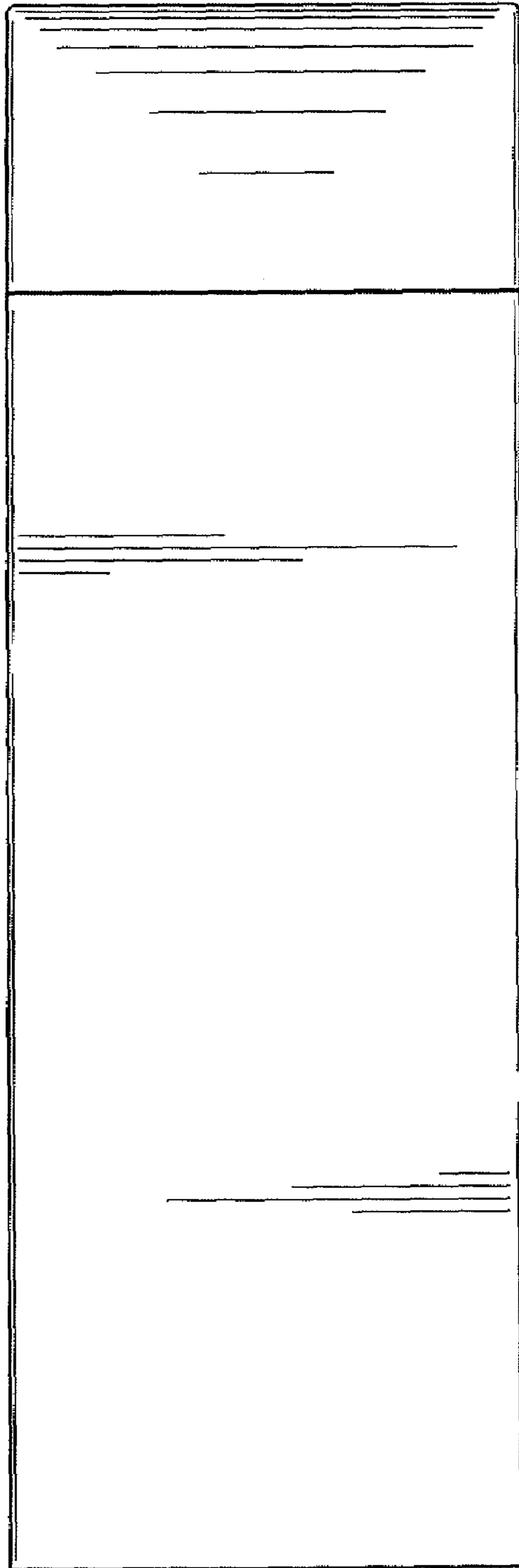




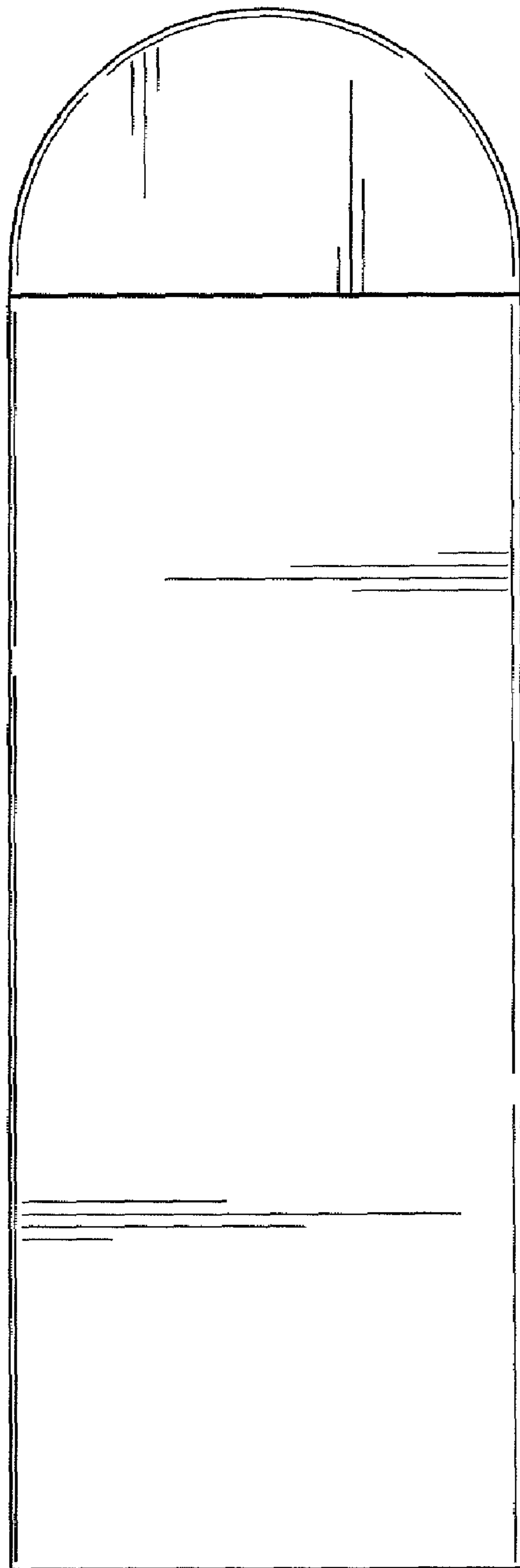

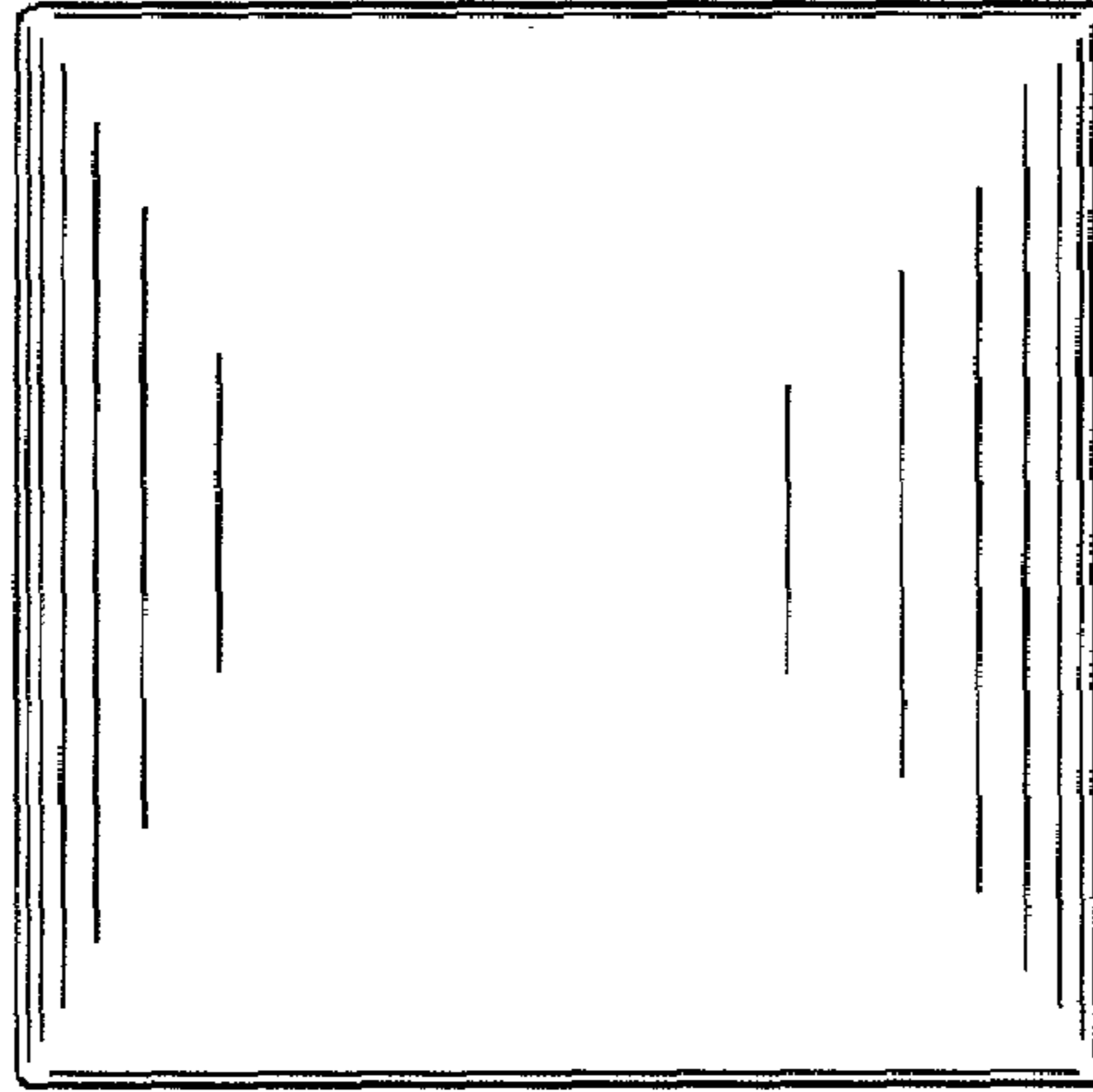

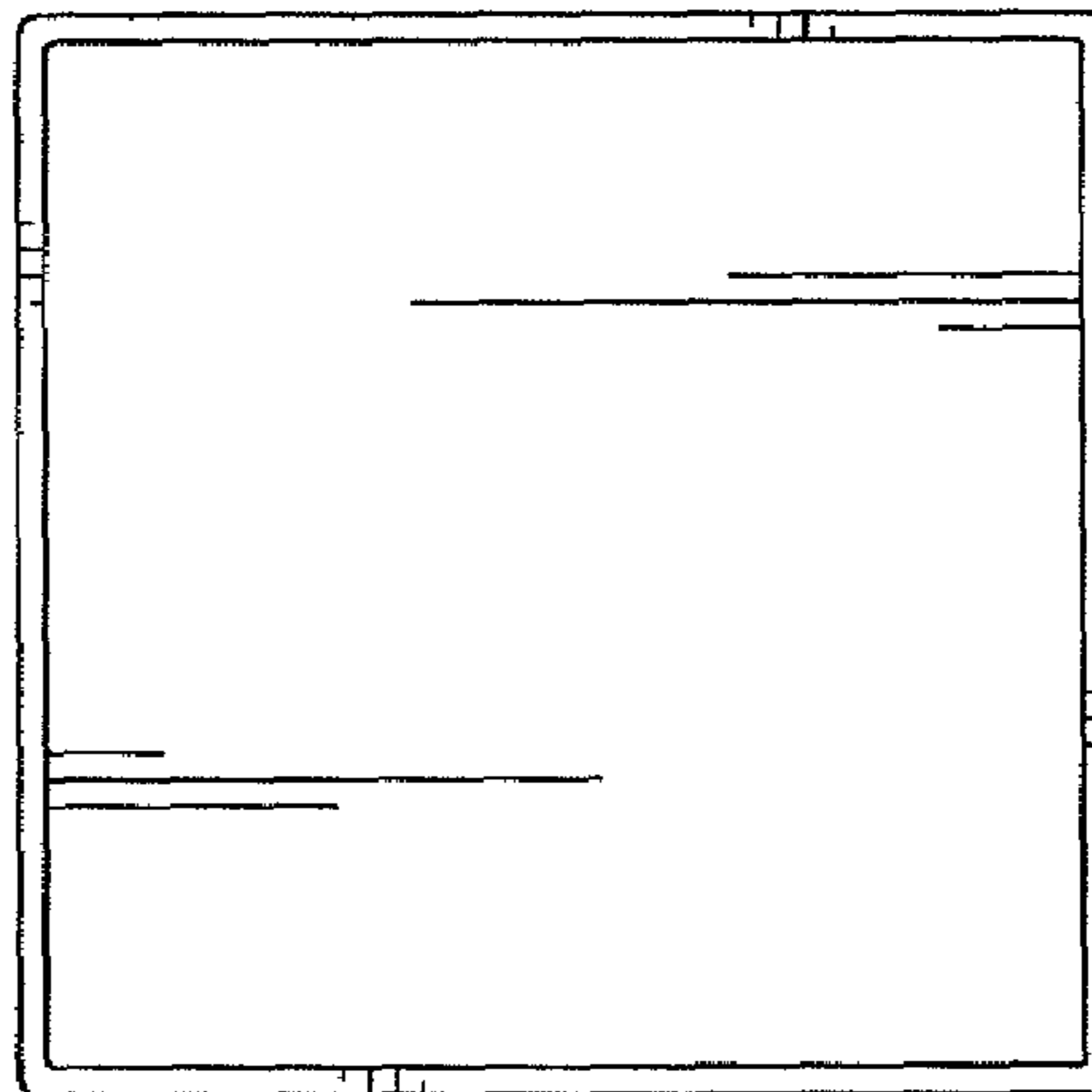

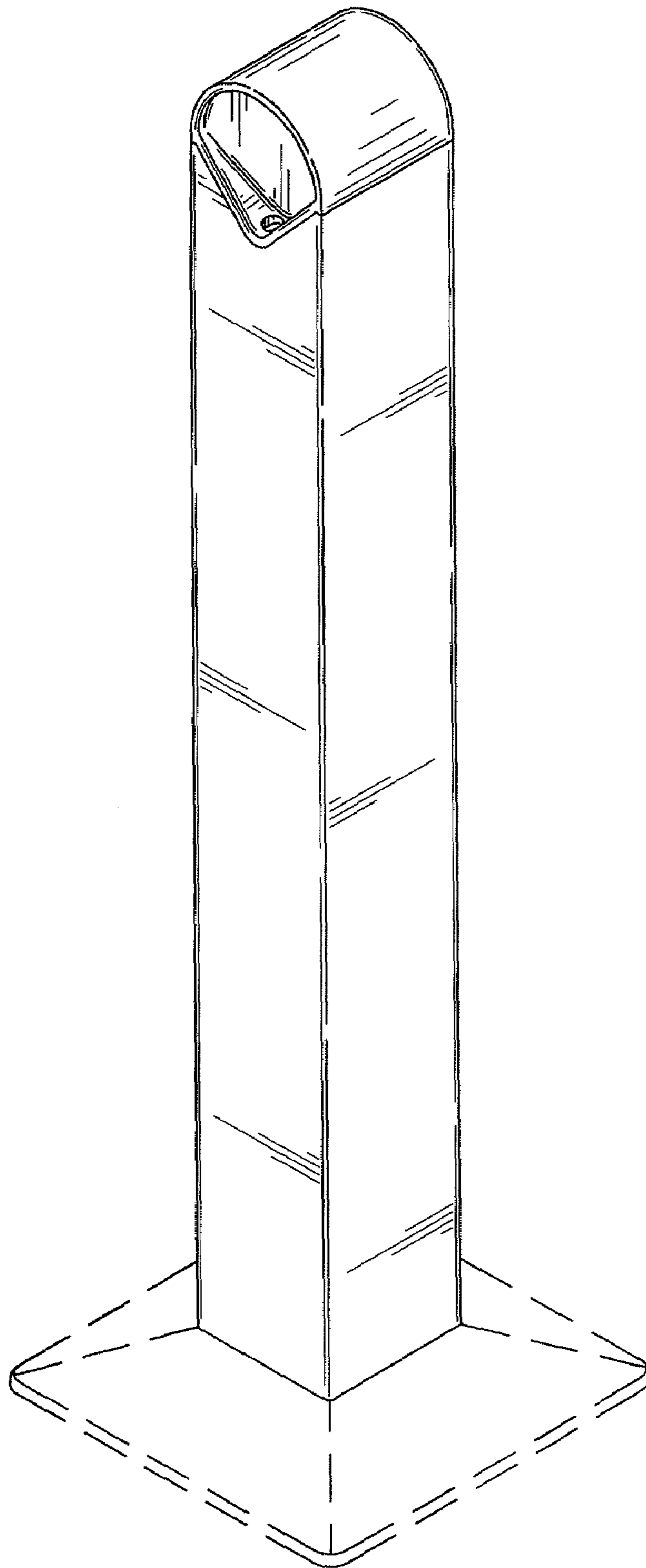

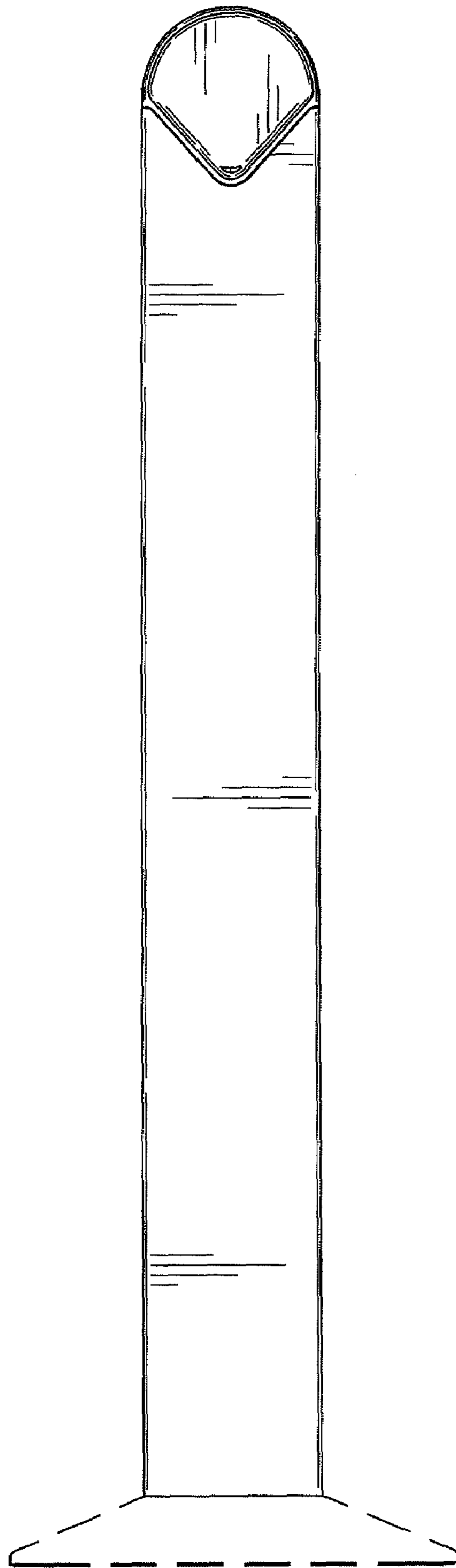

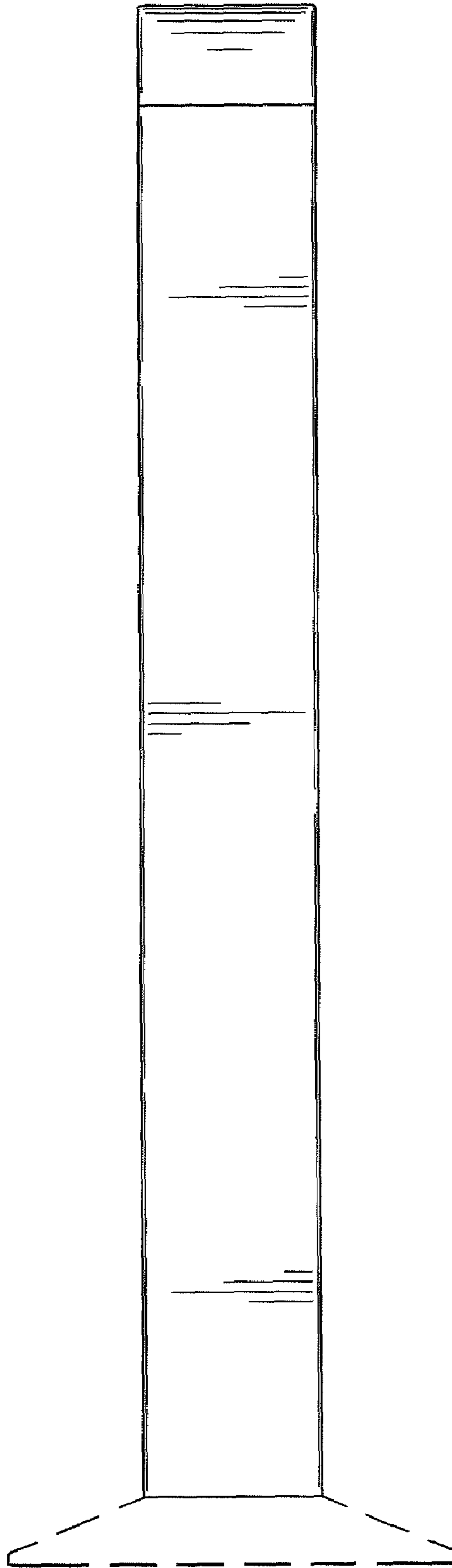

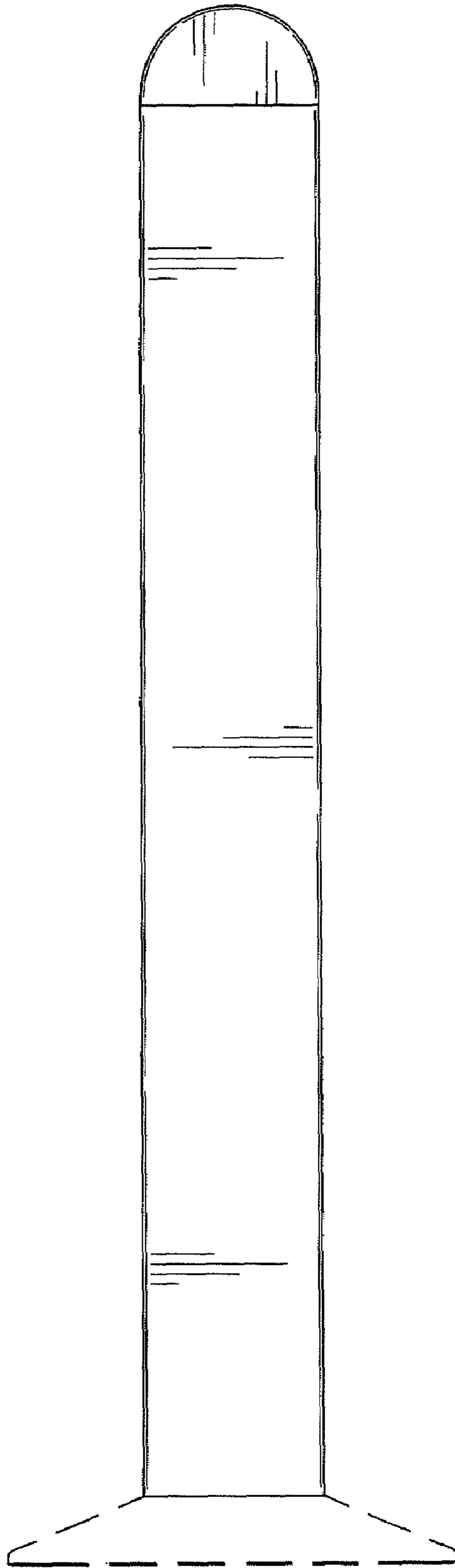

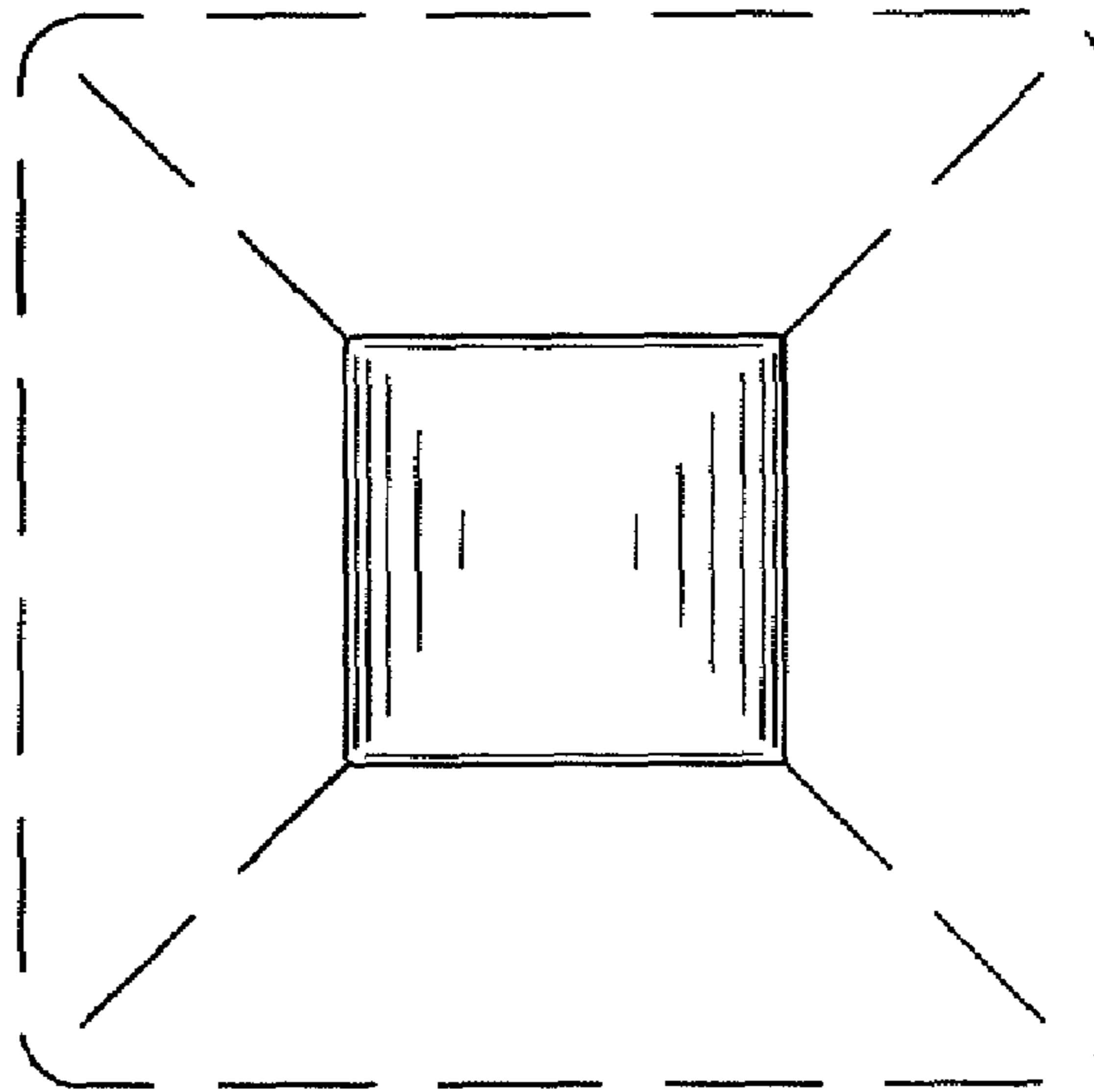
