(57) **CLAIM**

The ornamental design for a display container for promotional material, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the inside of a display container for promotional material in its open configuration showing the new design;

FIG. 2 is a side elevational view thereof in its open configuration;

FIG. 3 is a plan view of the top view of FIG. 1 in closed configuration which is identical to the bottom view;

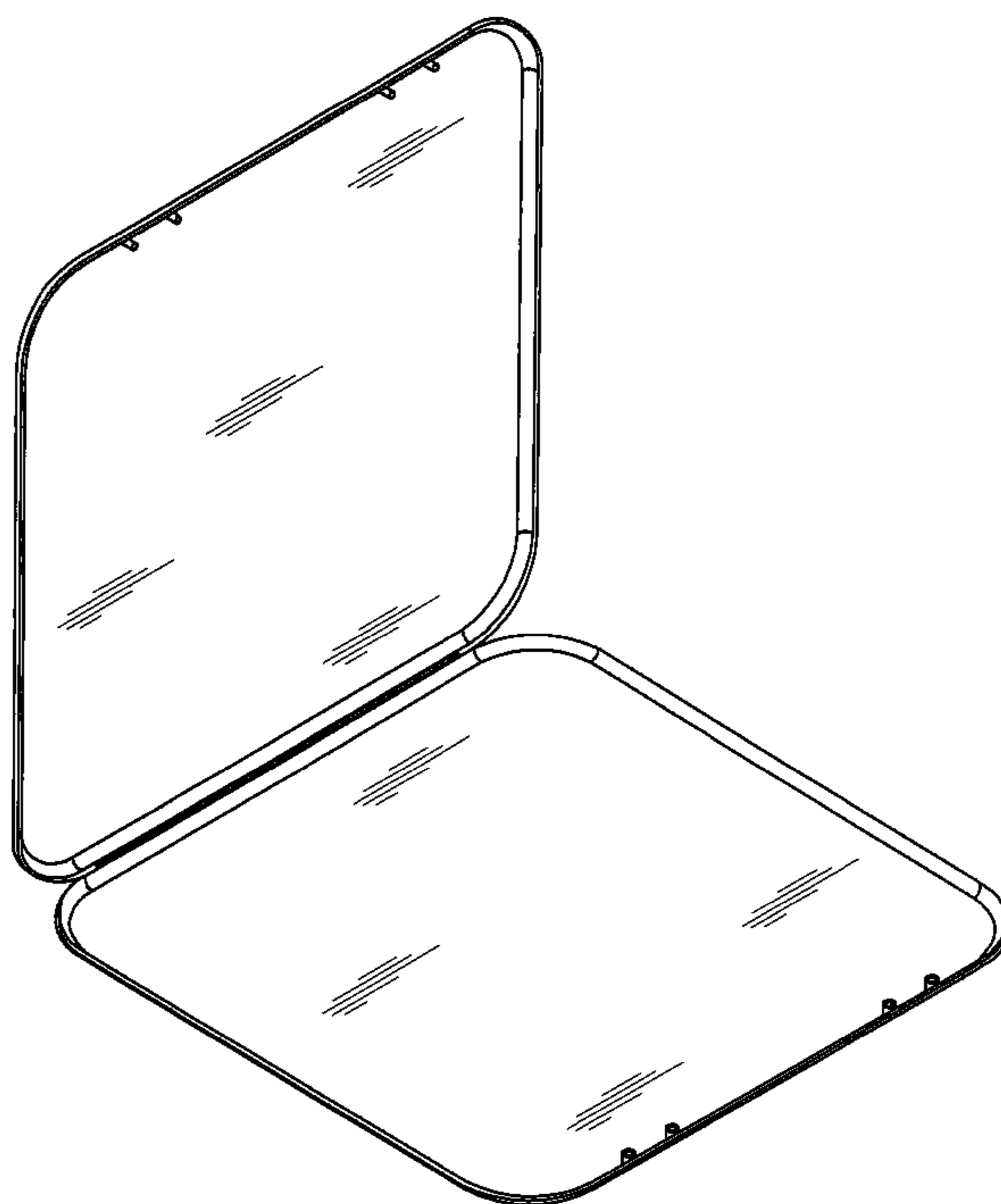
FIG. 4 is a perspective view thereof;

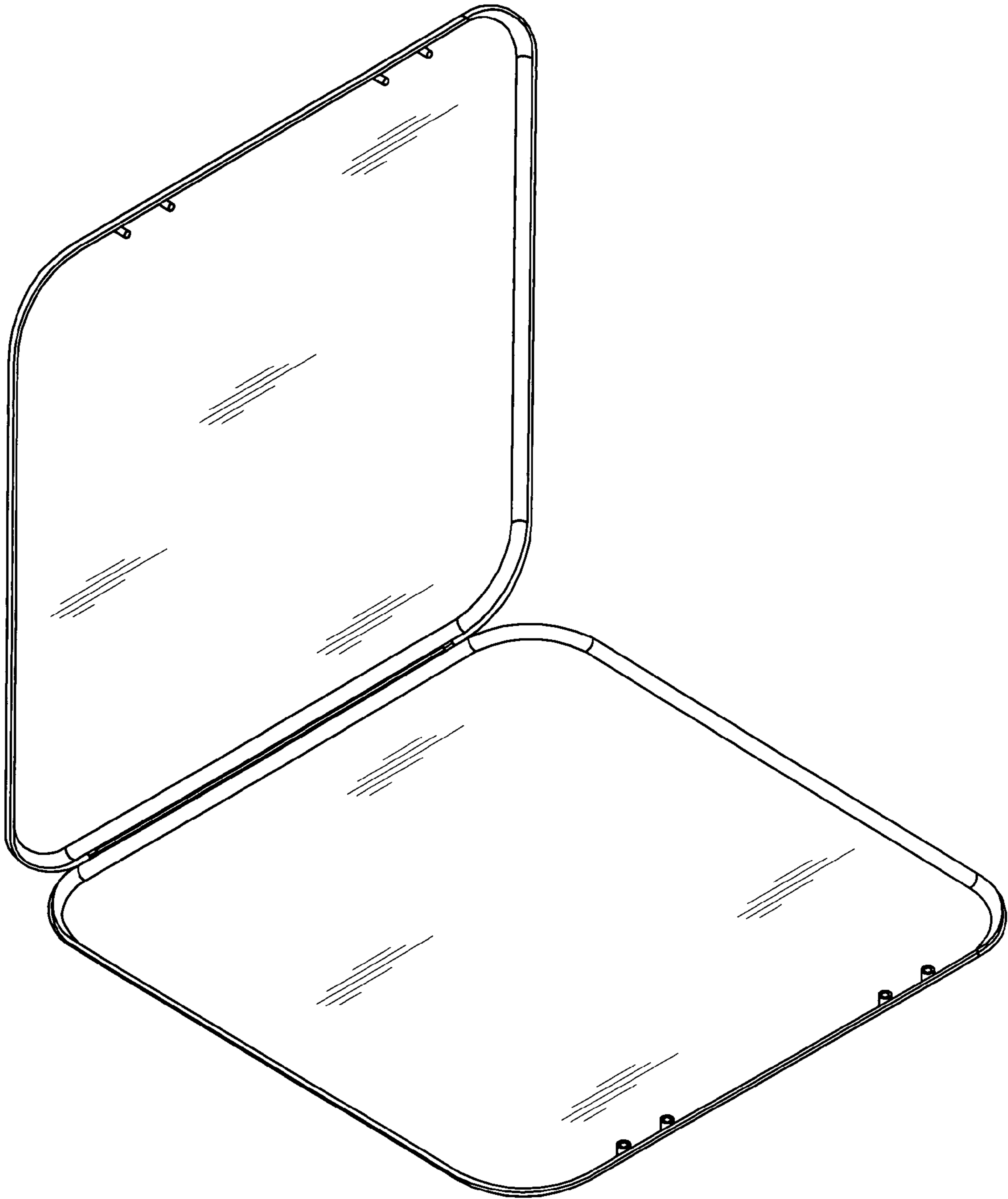

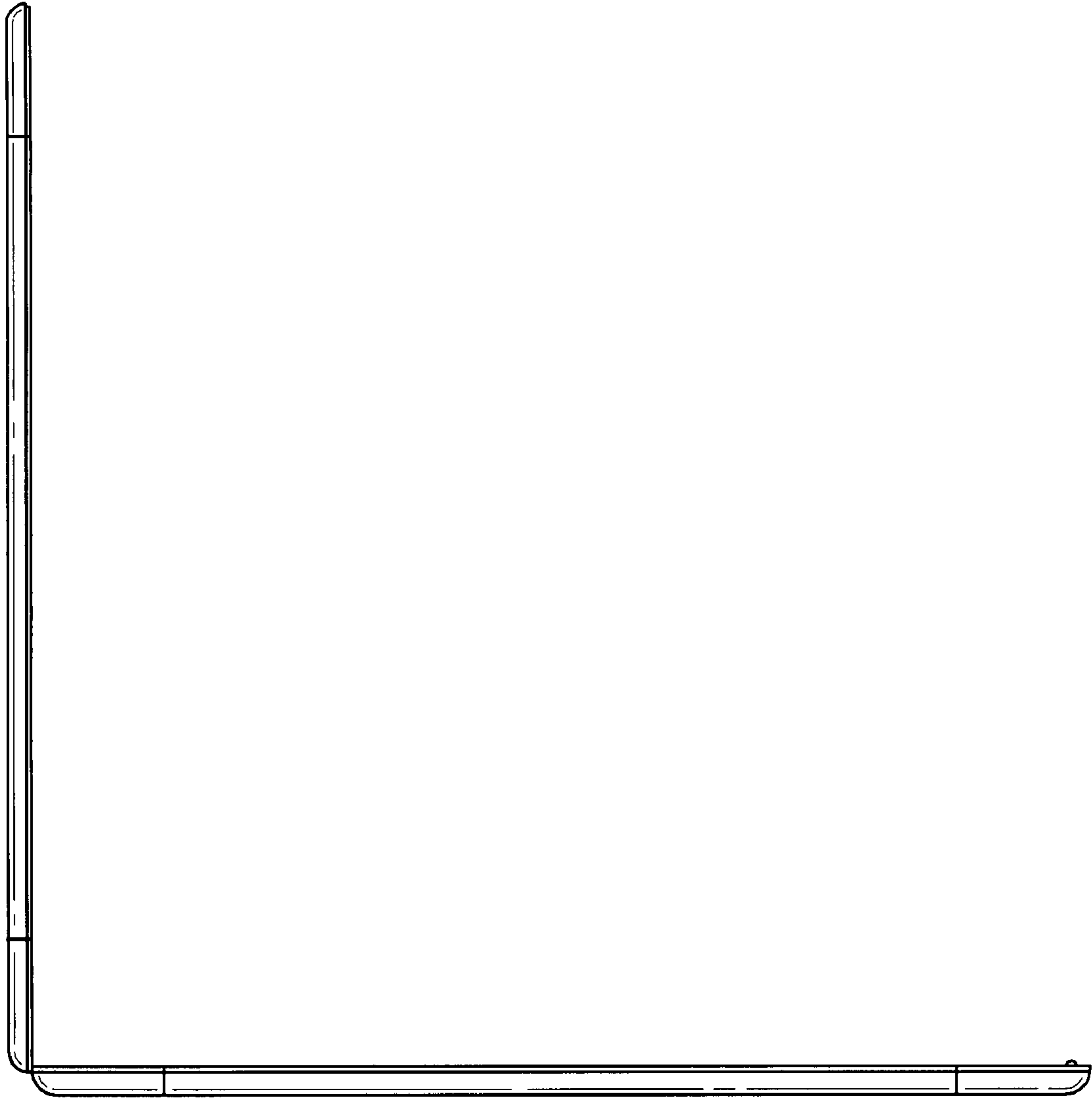

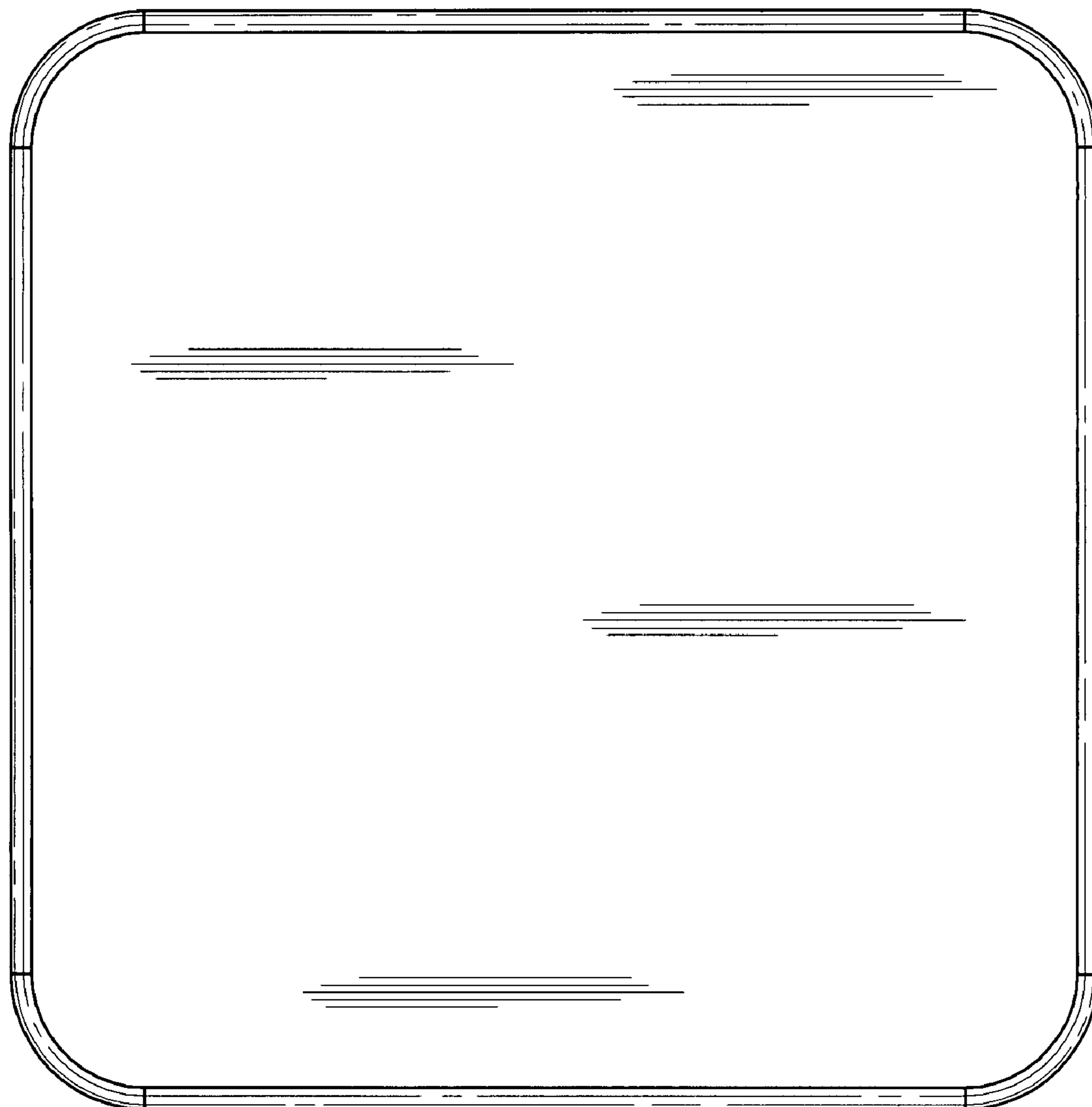

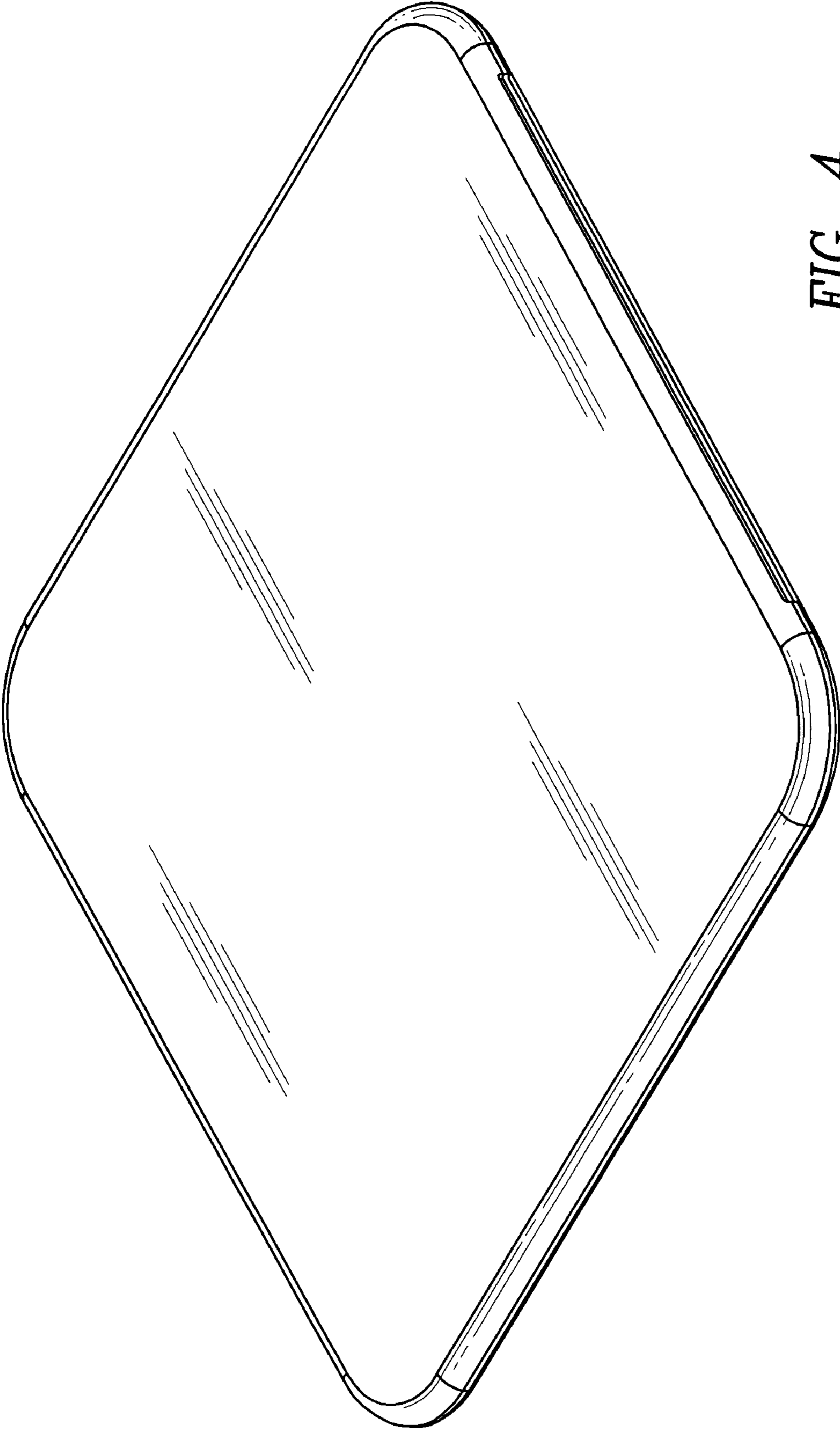

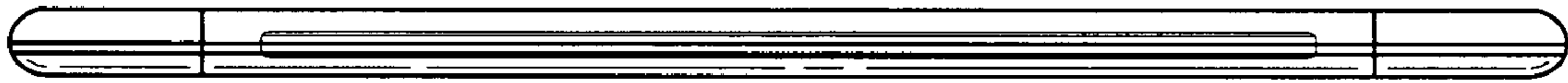

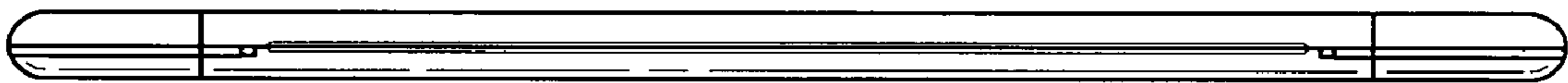

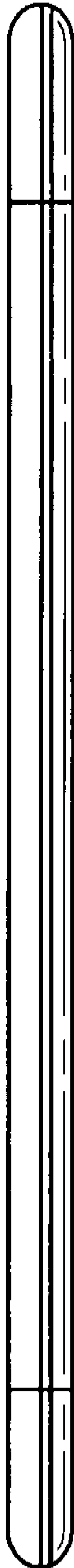
