FIG. 1.

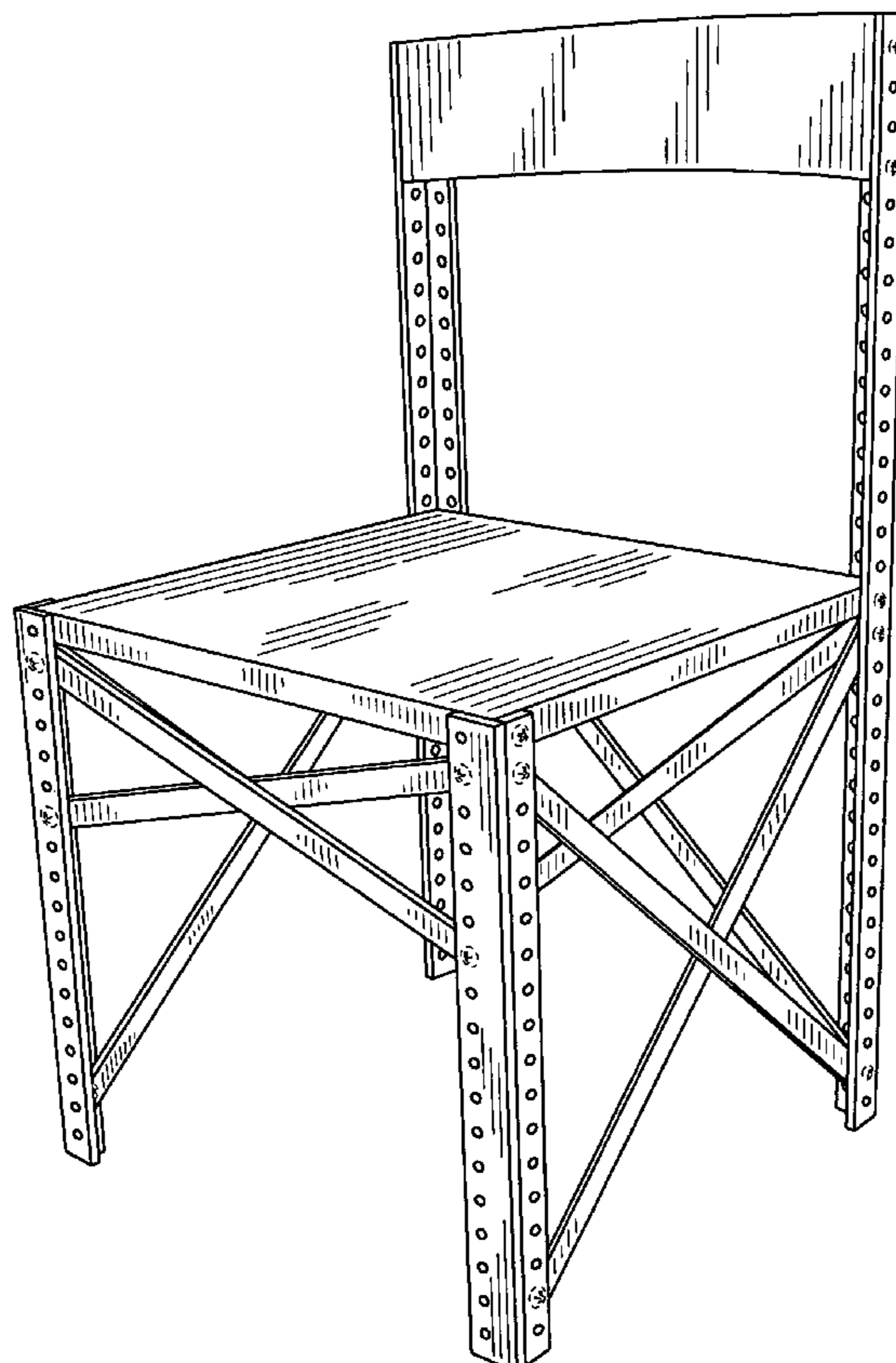

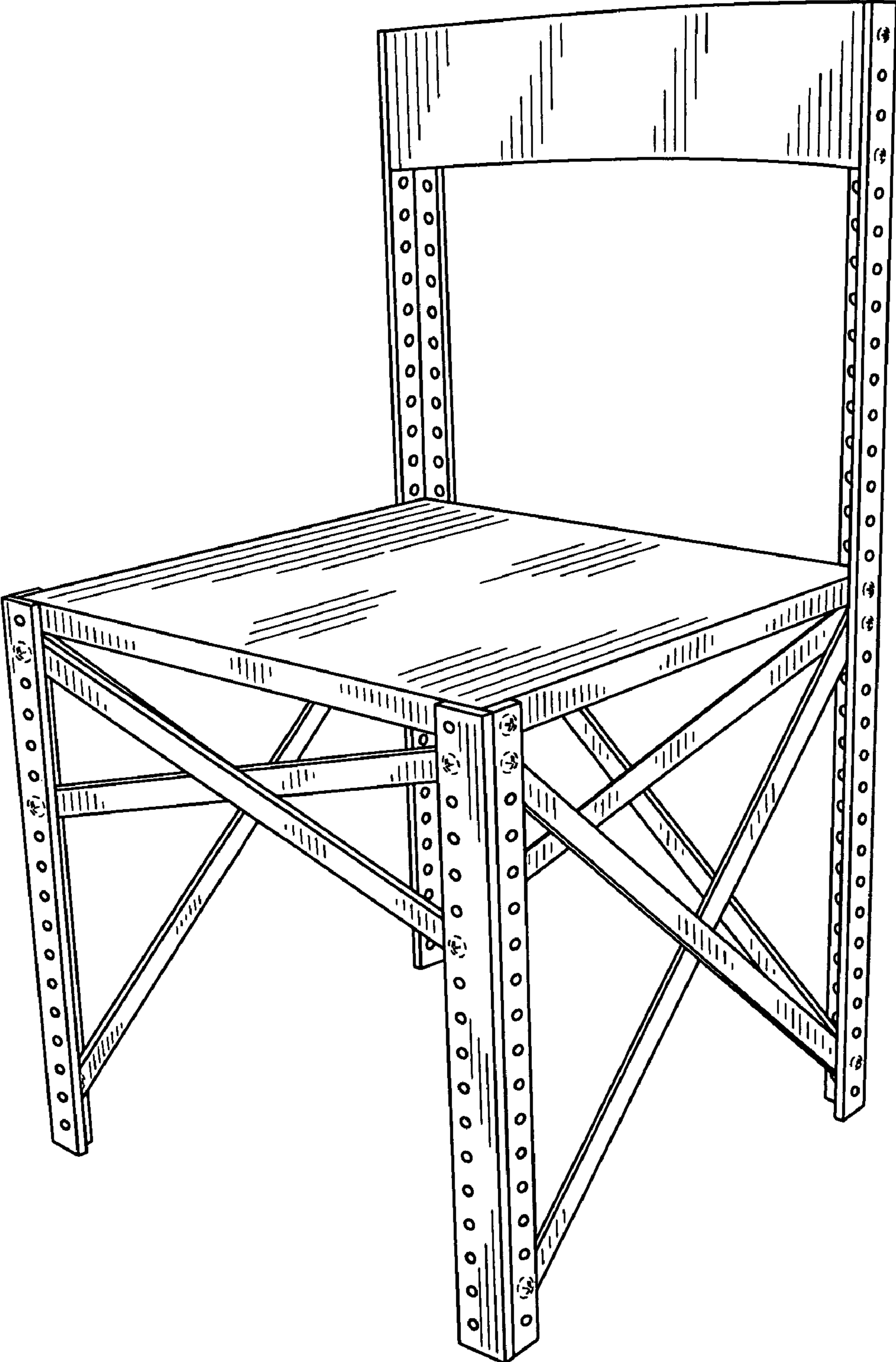

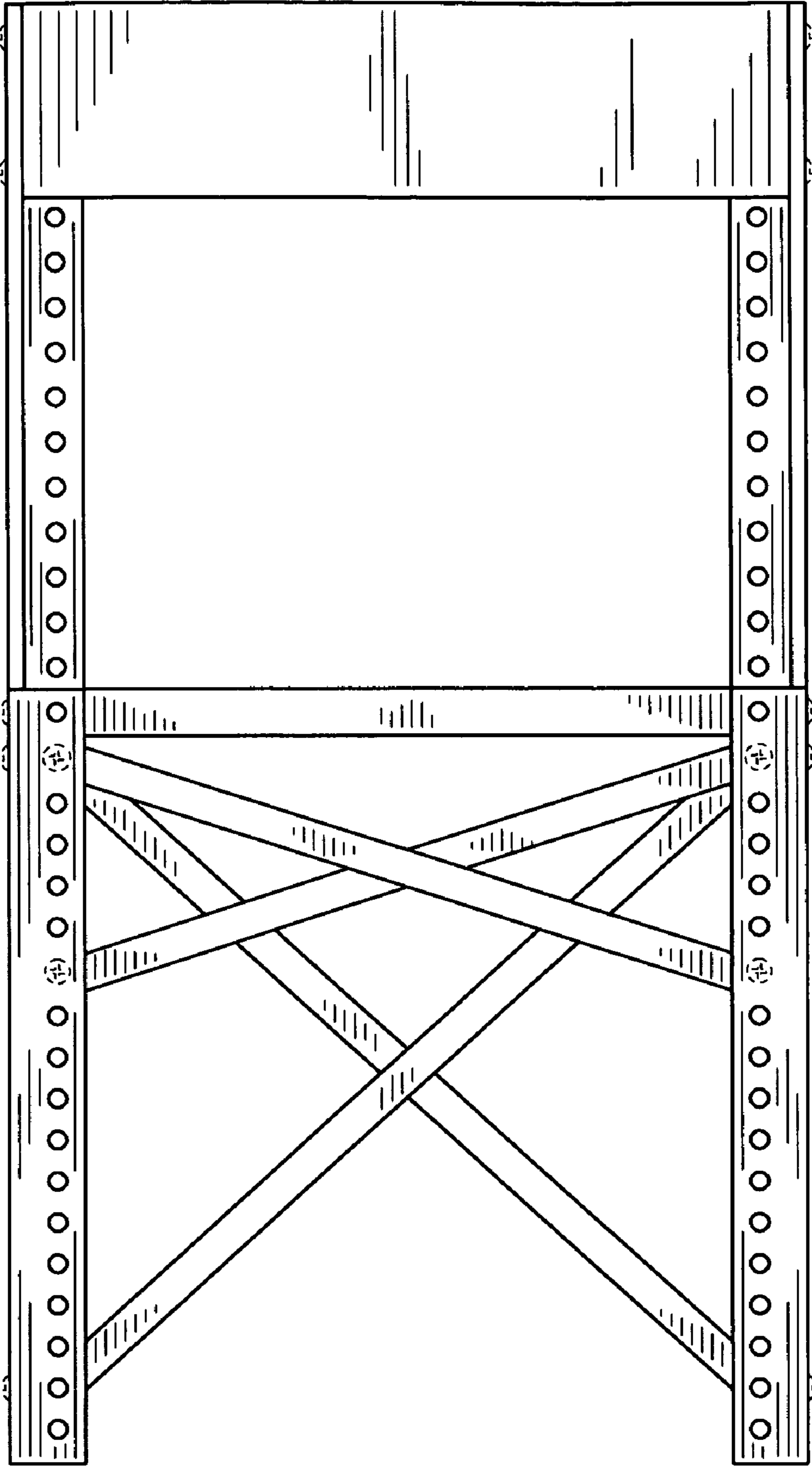

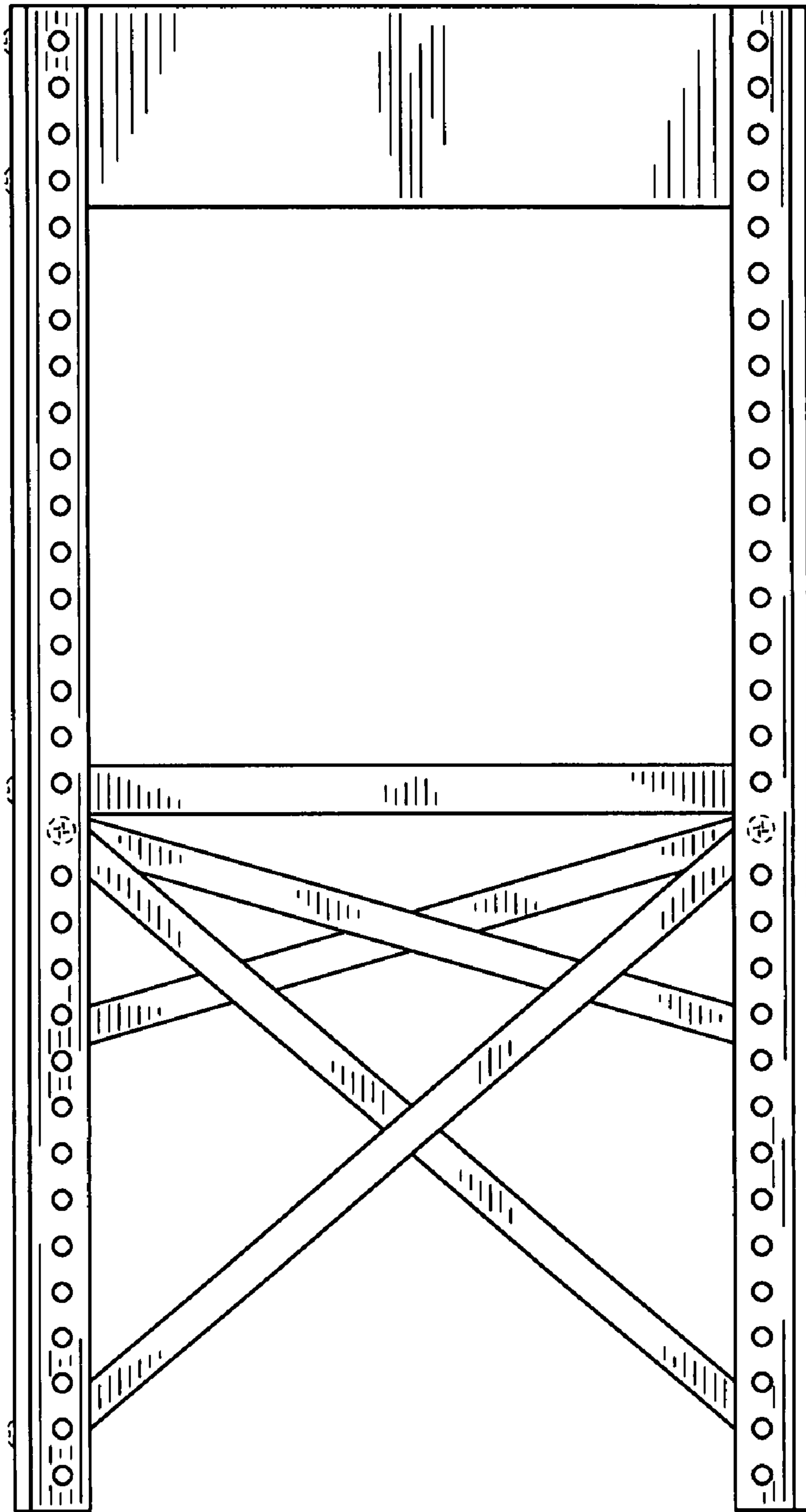

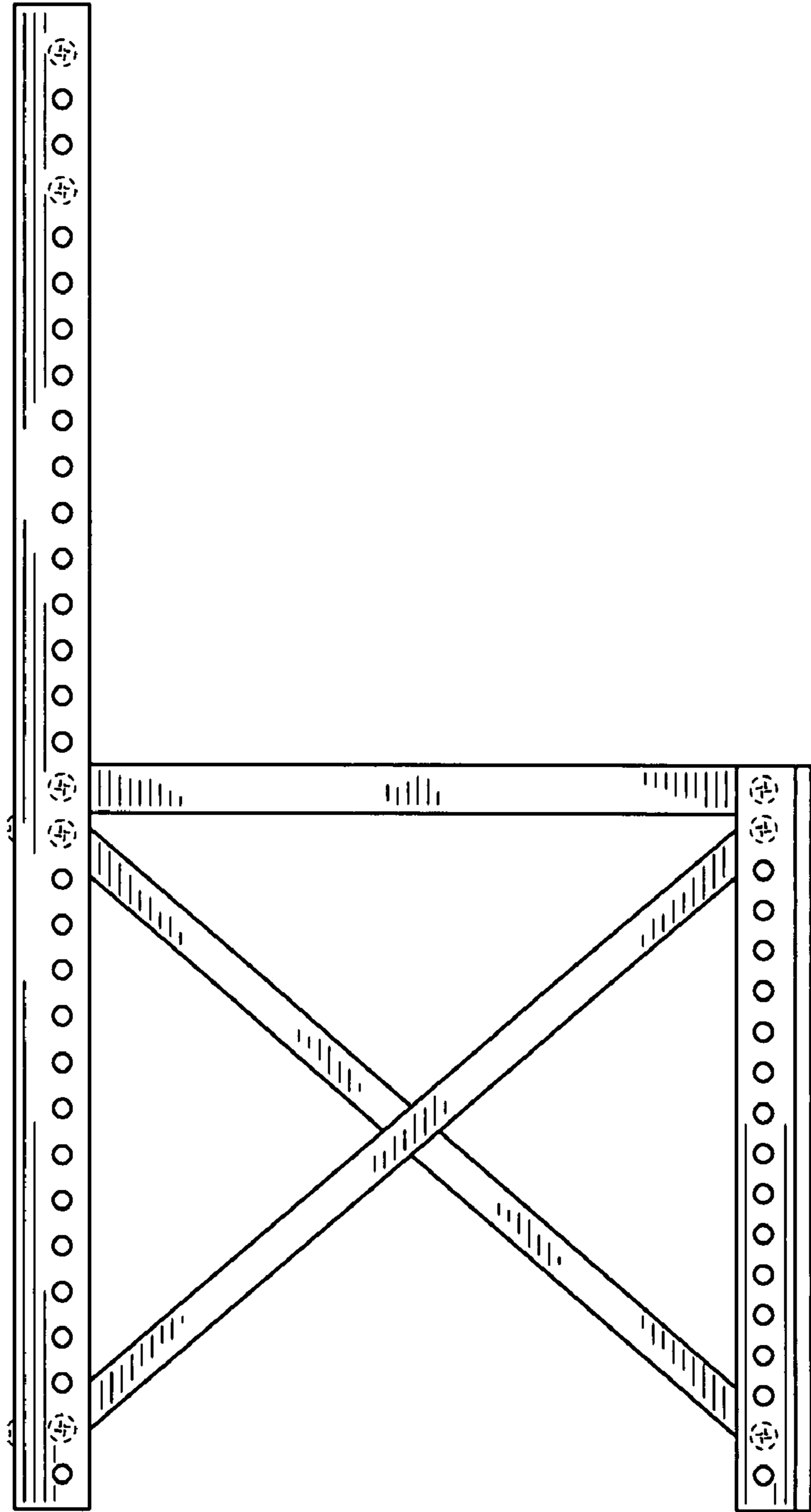

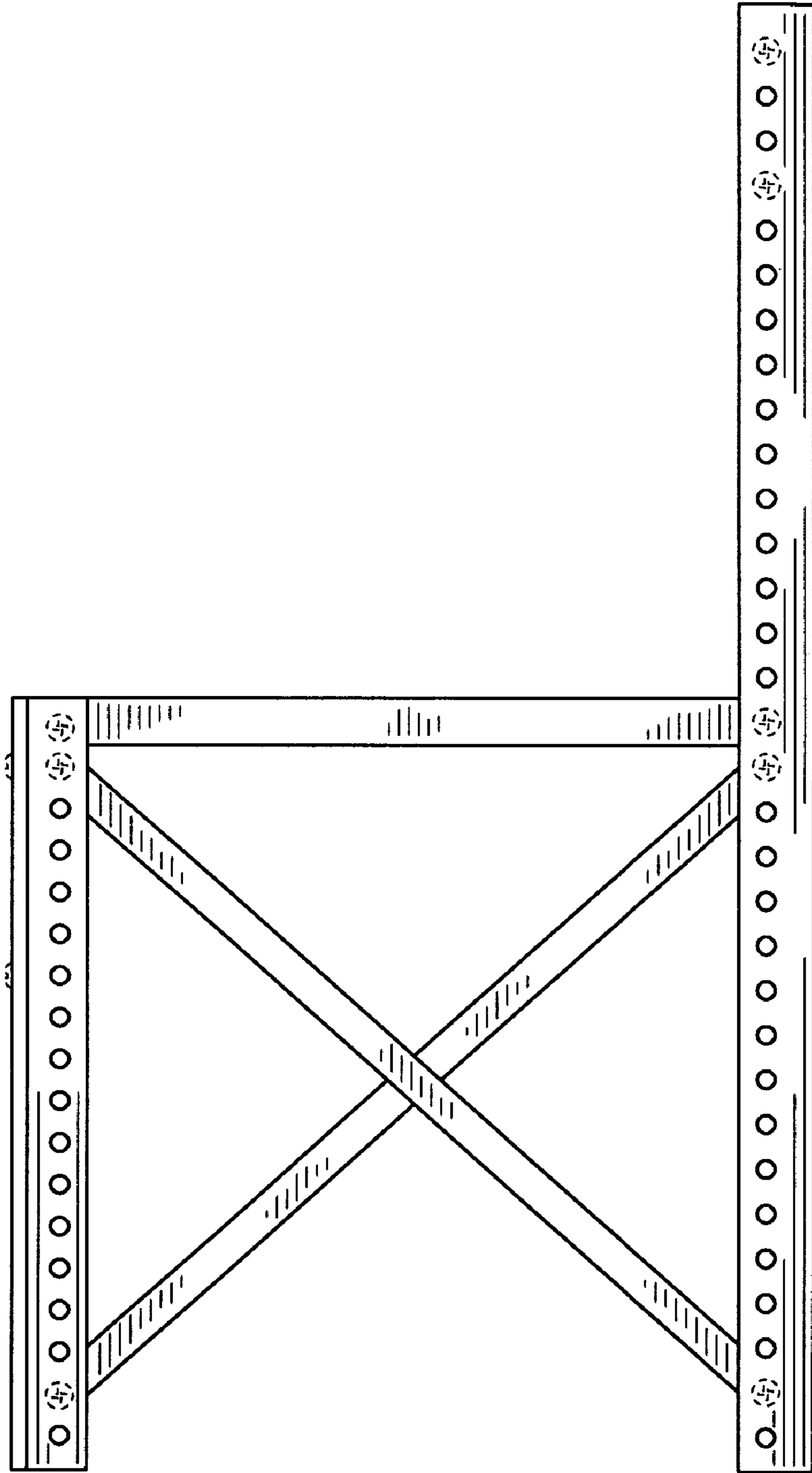

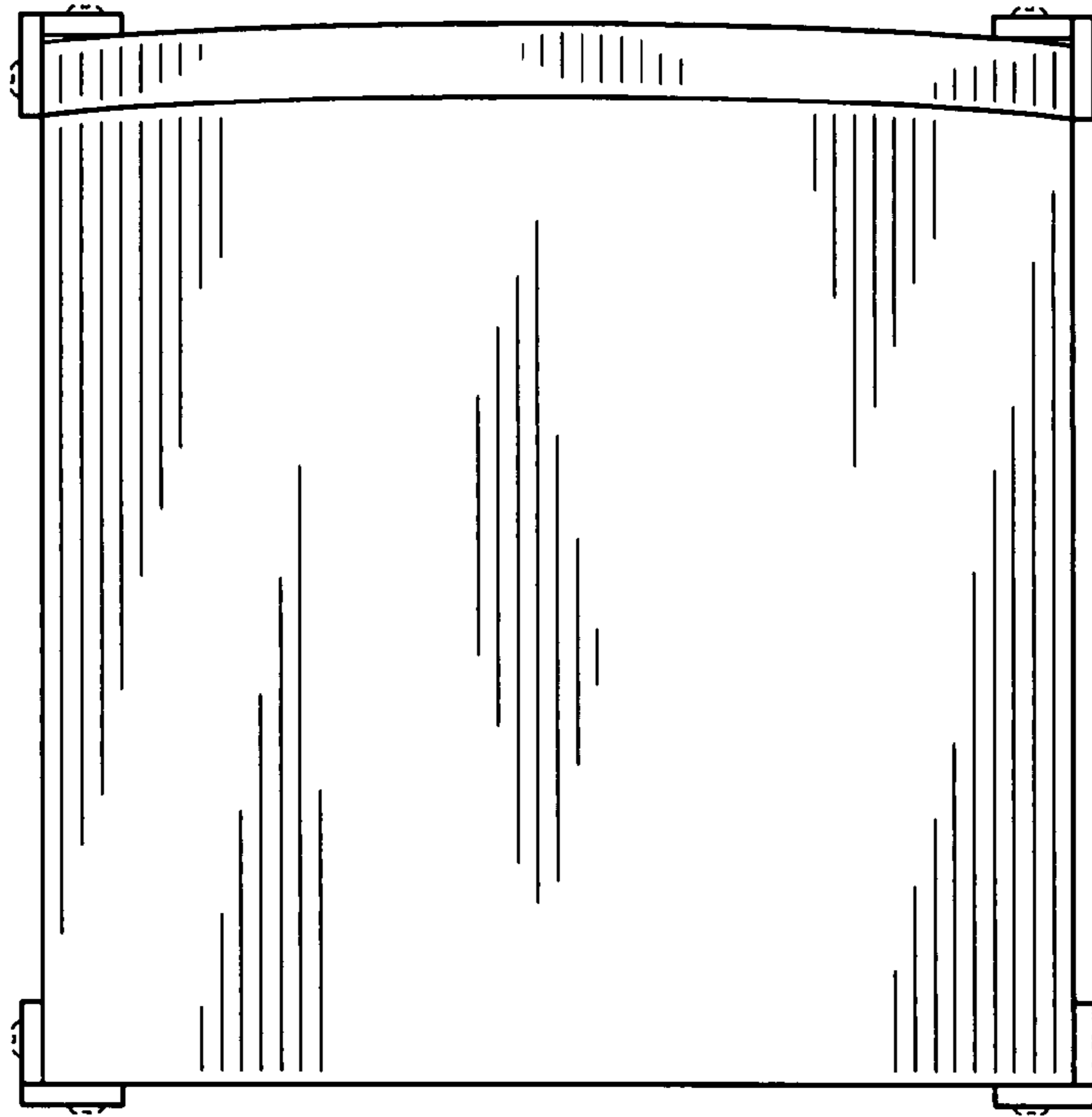

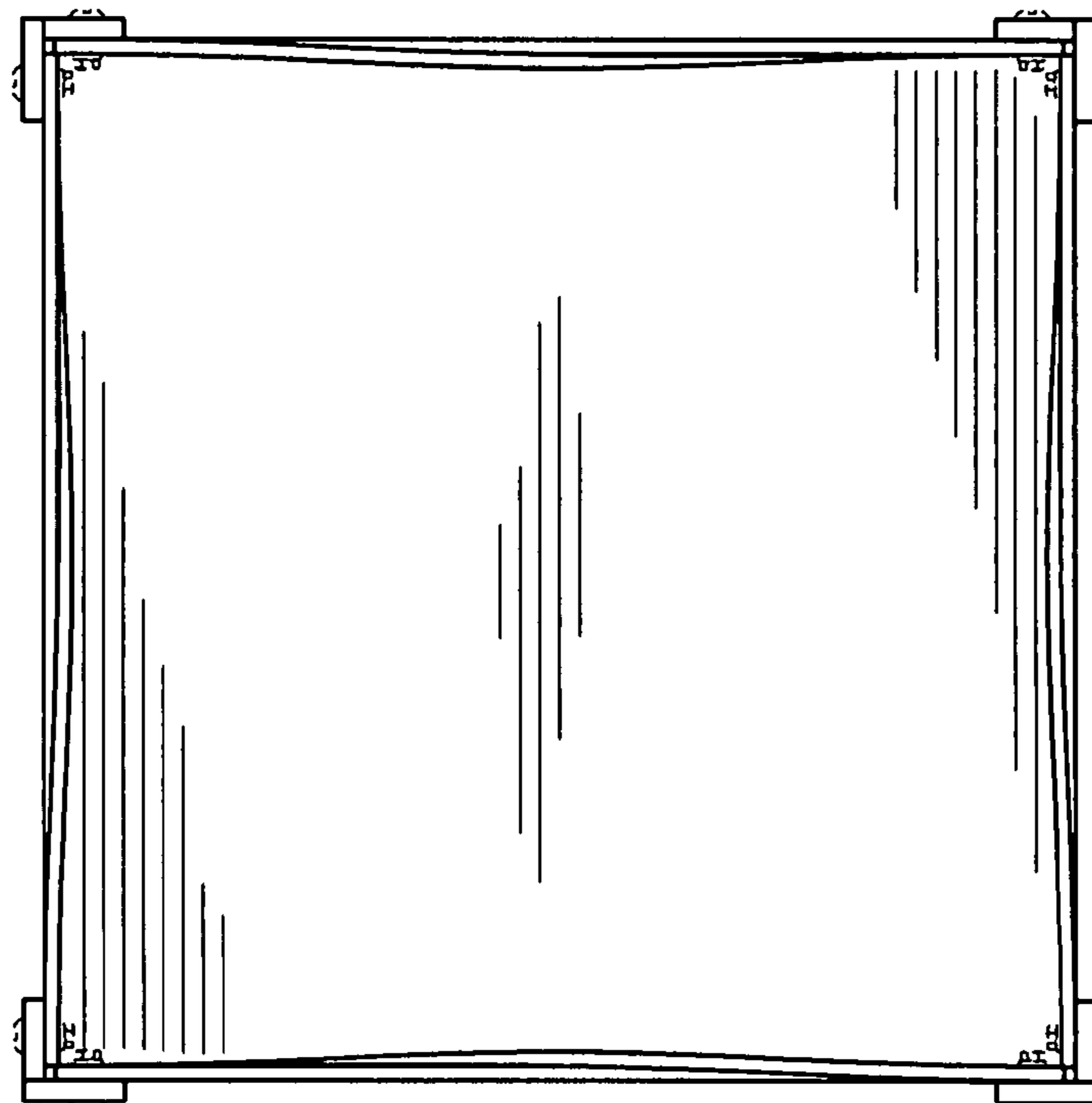

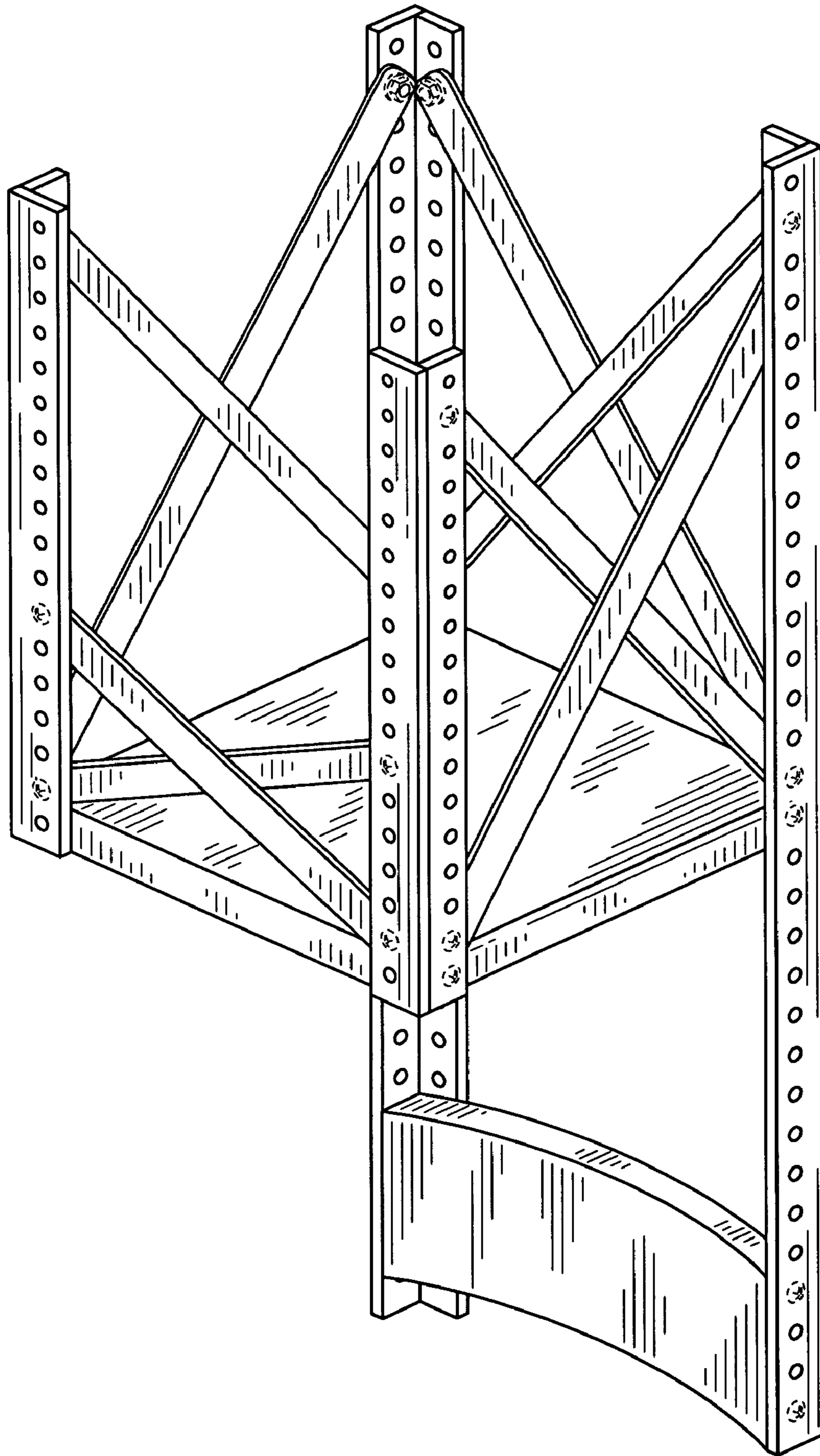
