FIG. 5 is a left side view thereof;

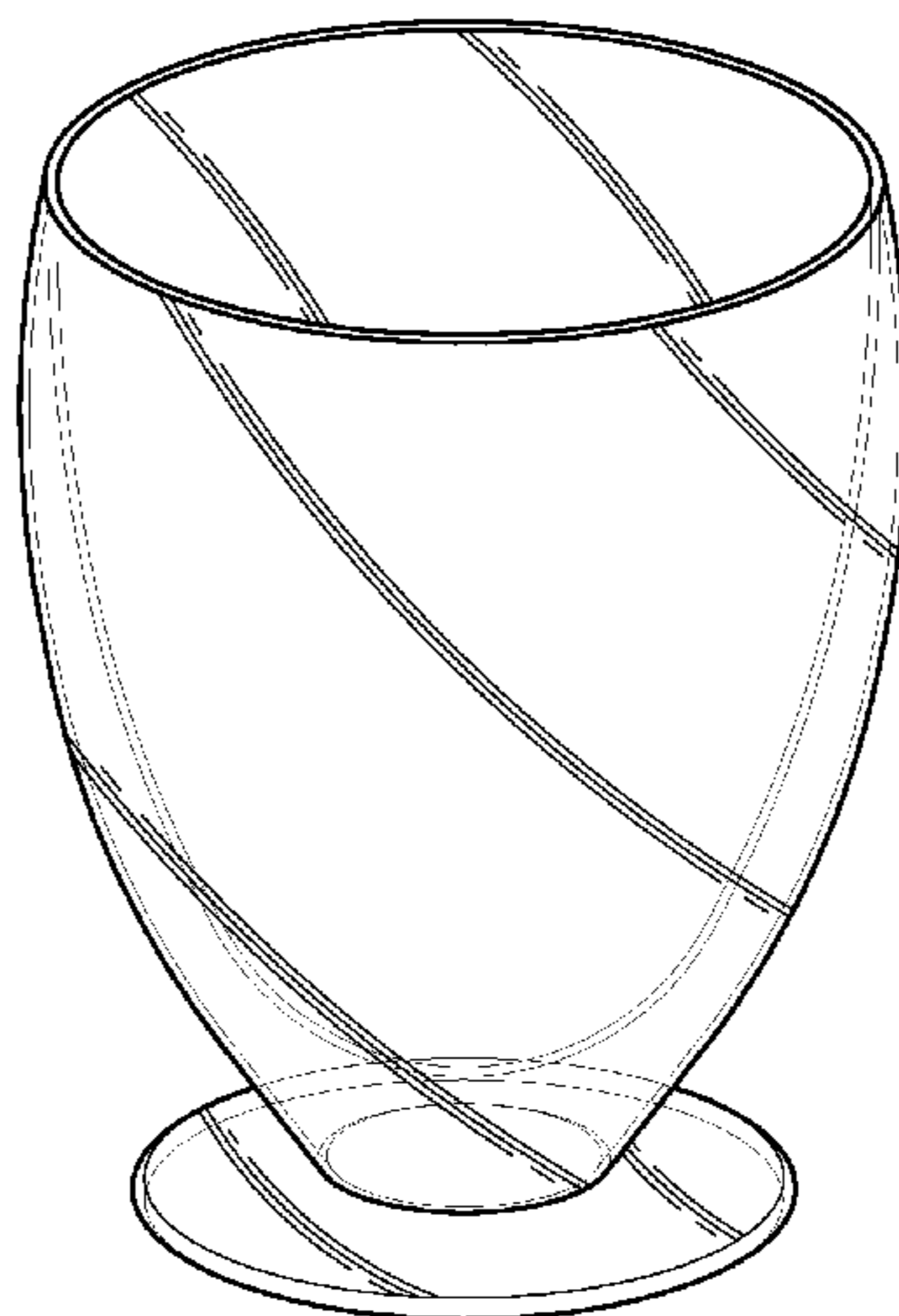
FIG. 6 is a perspective view of a second embodiment of the glass showing my design thereof;

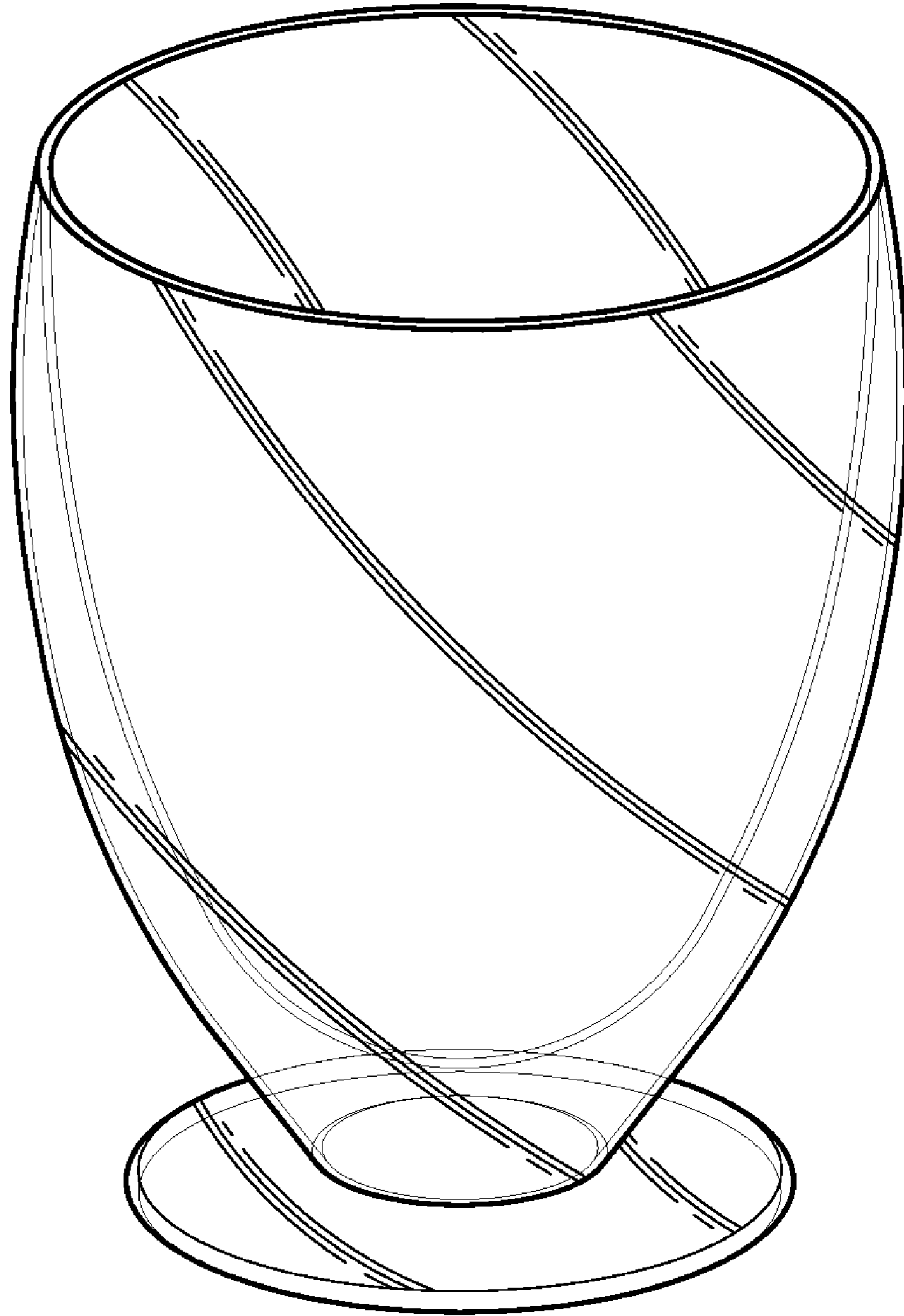

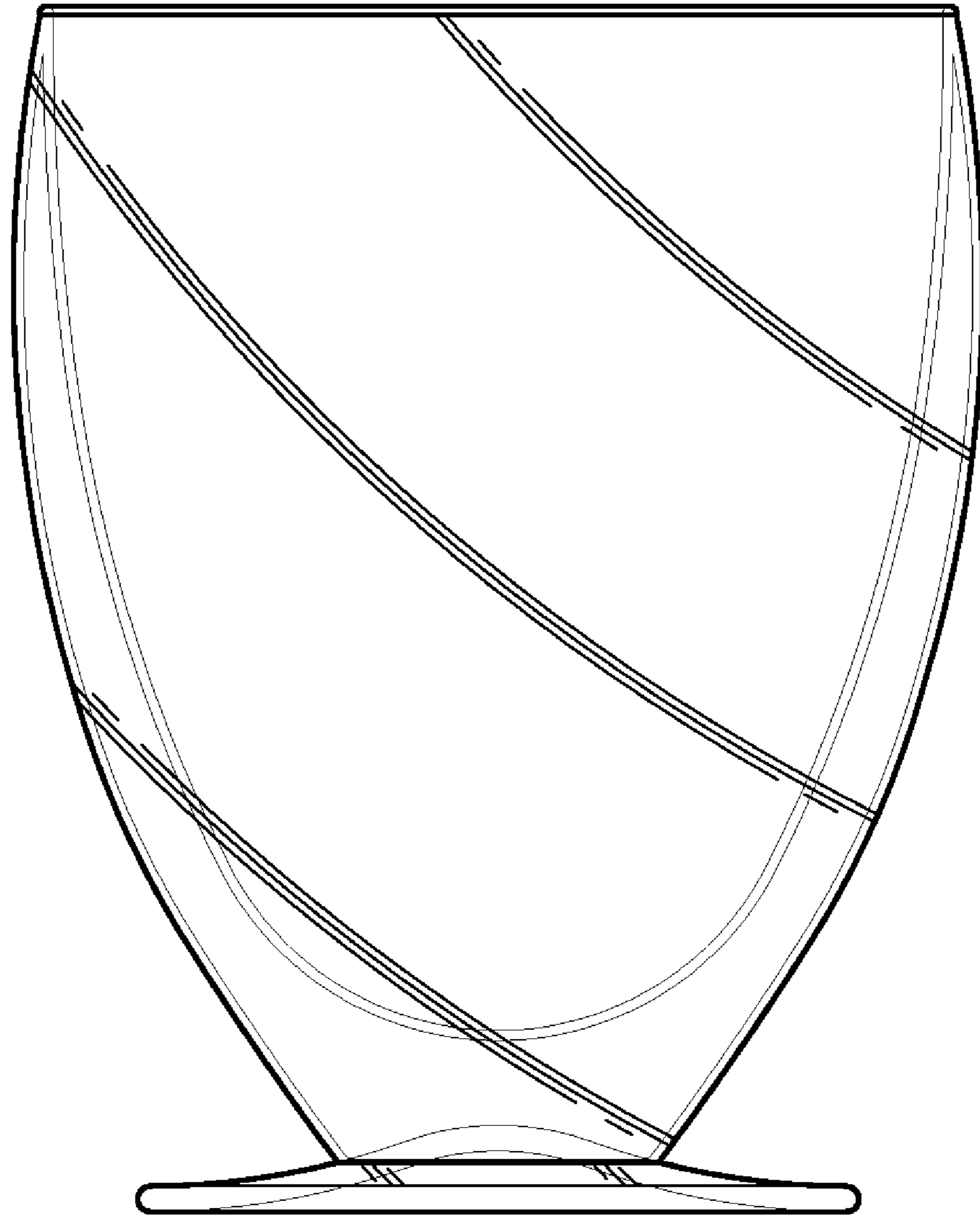

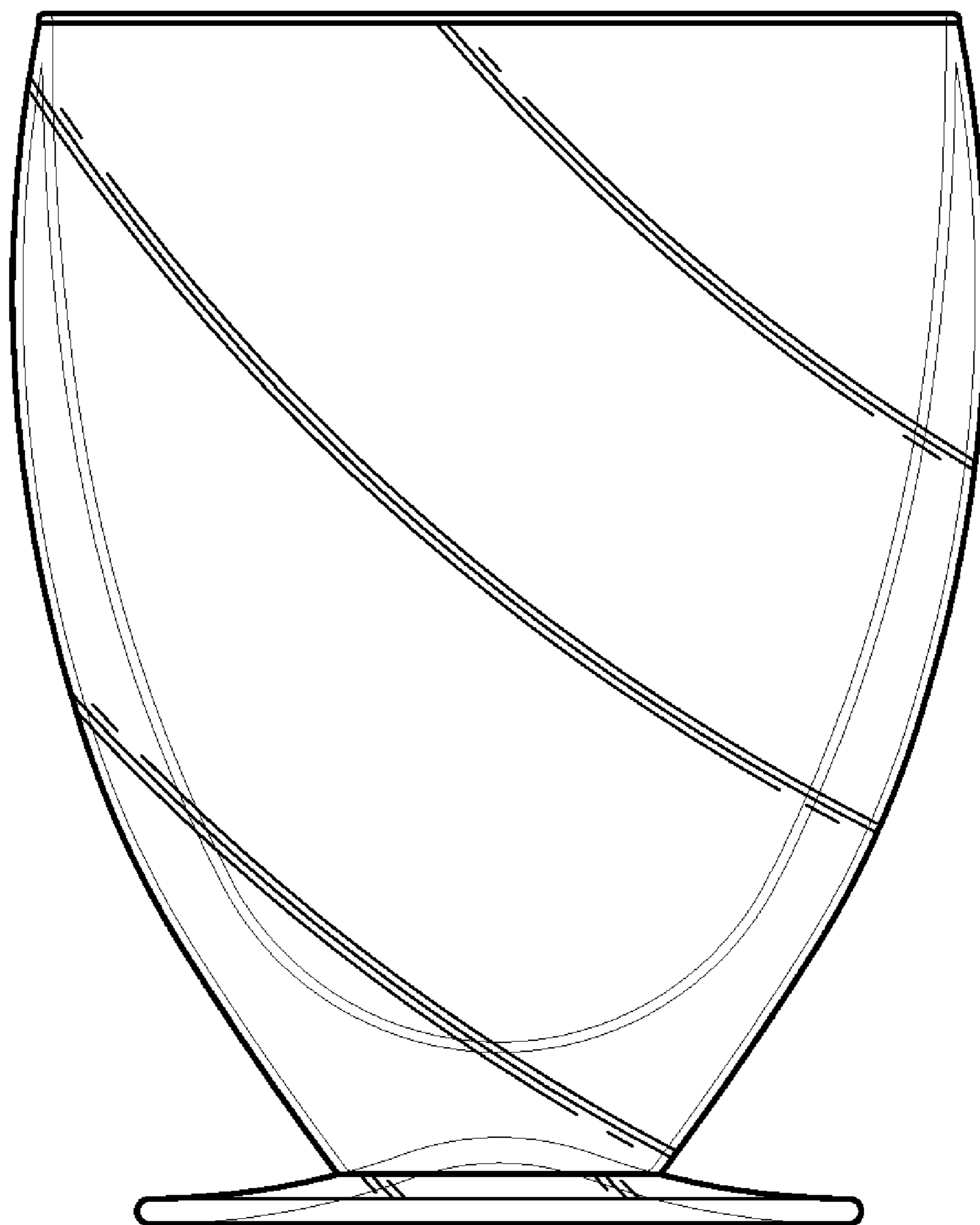

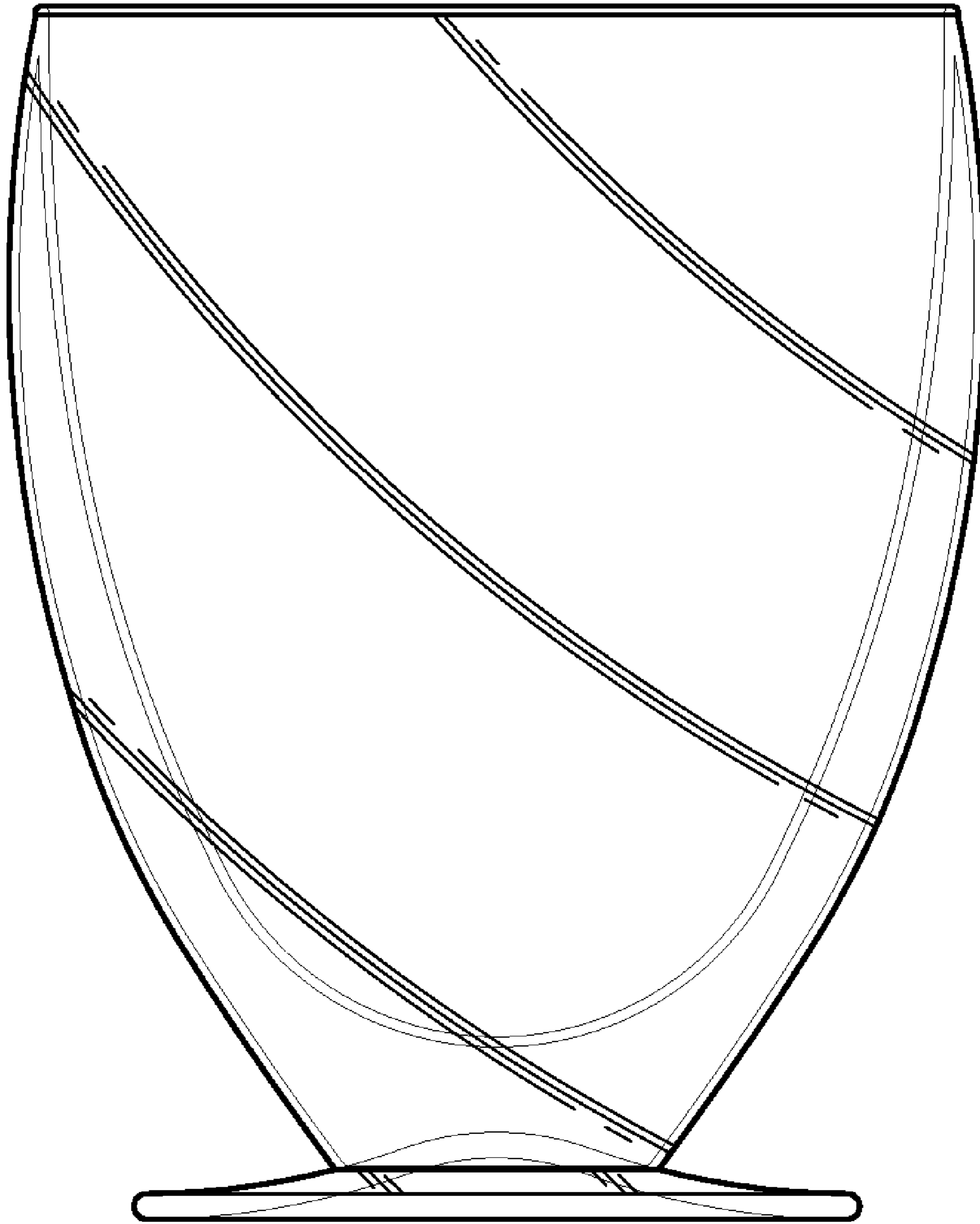

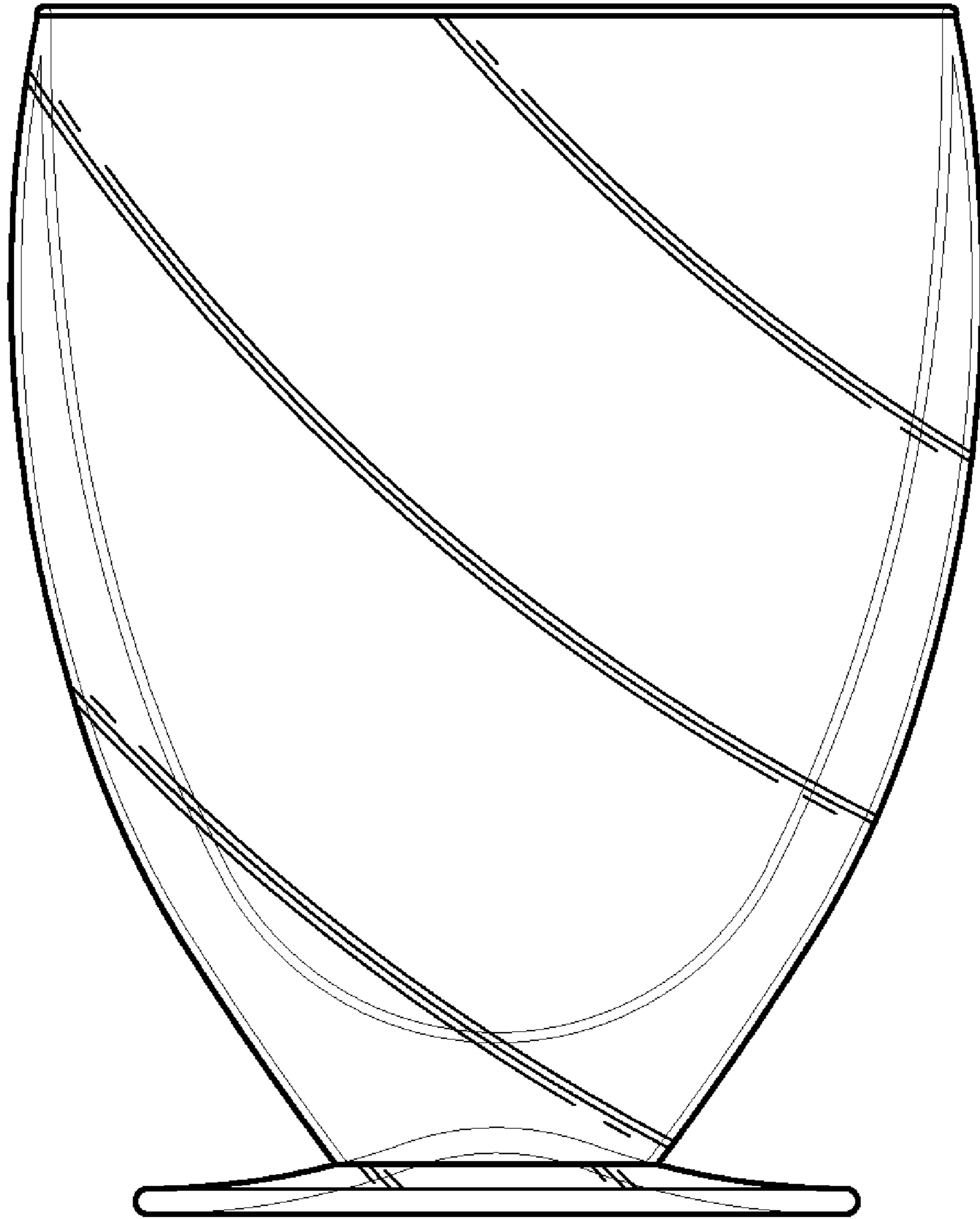

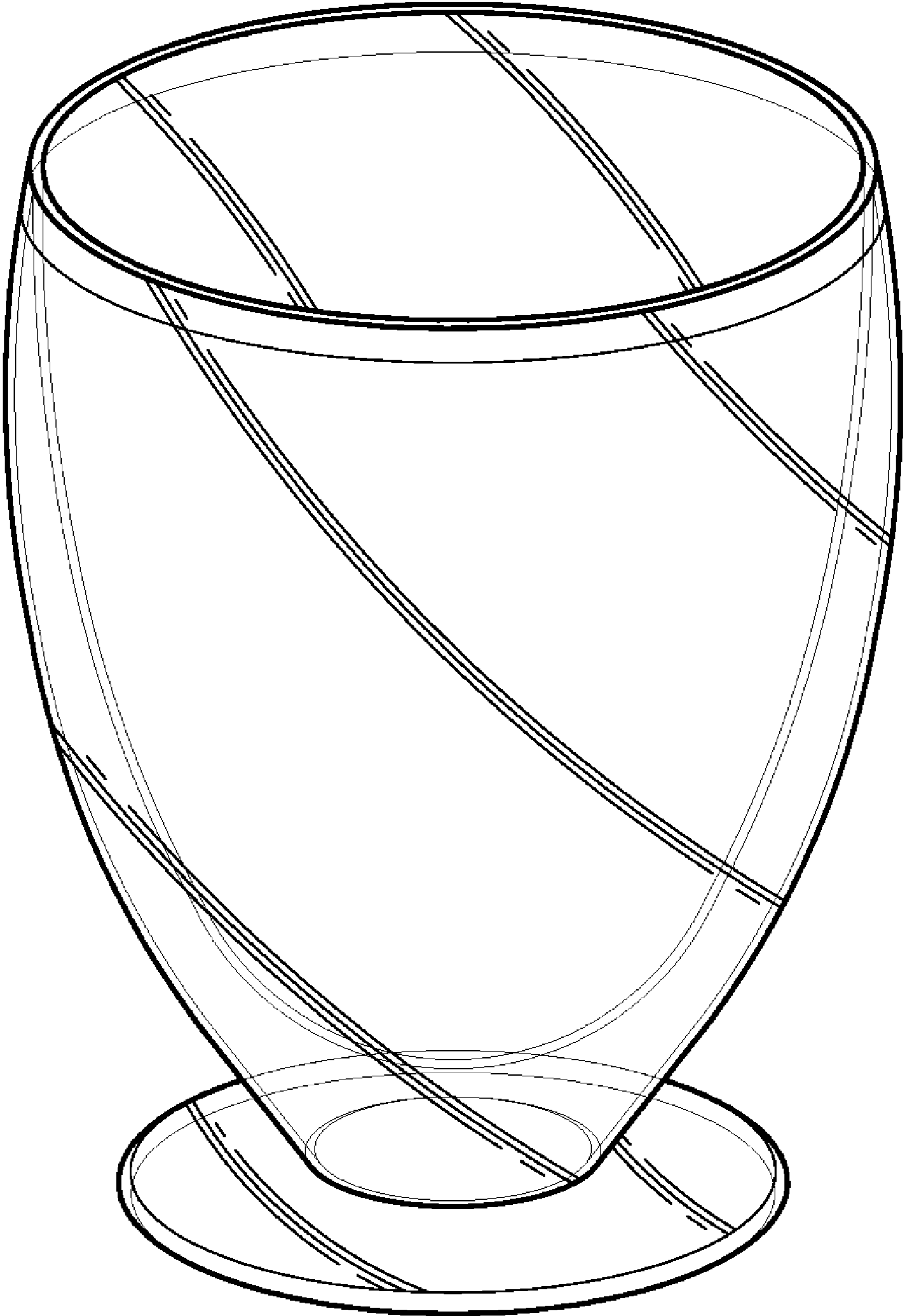

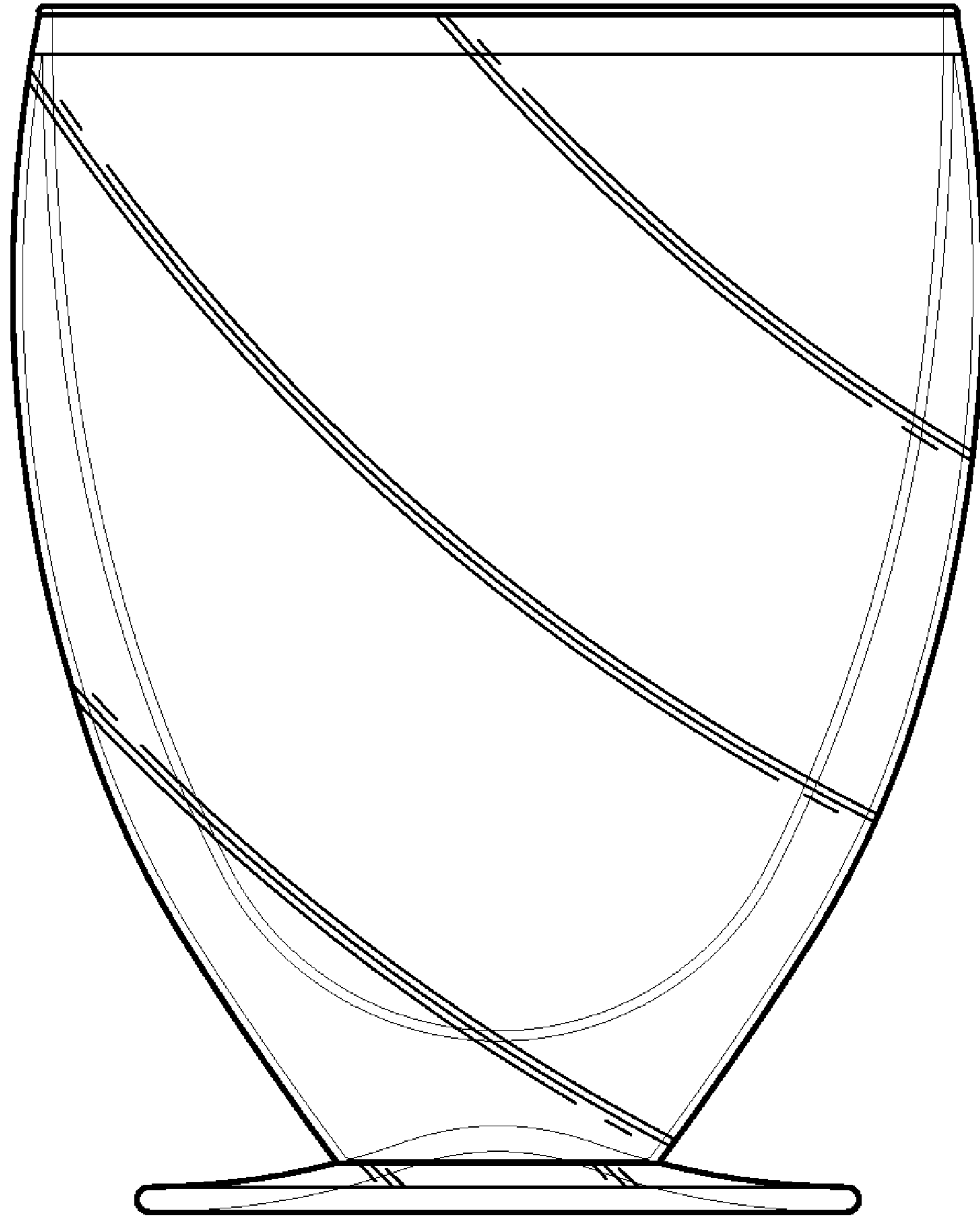

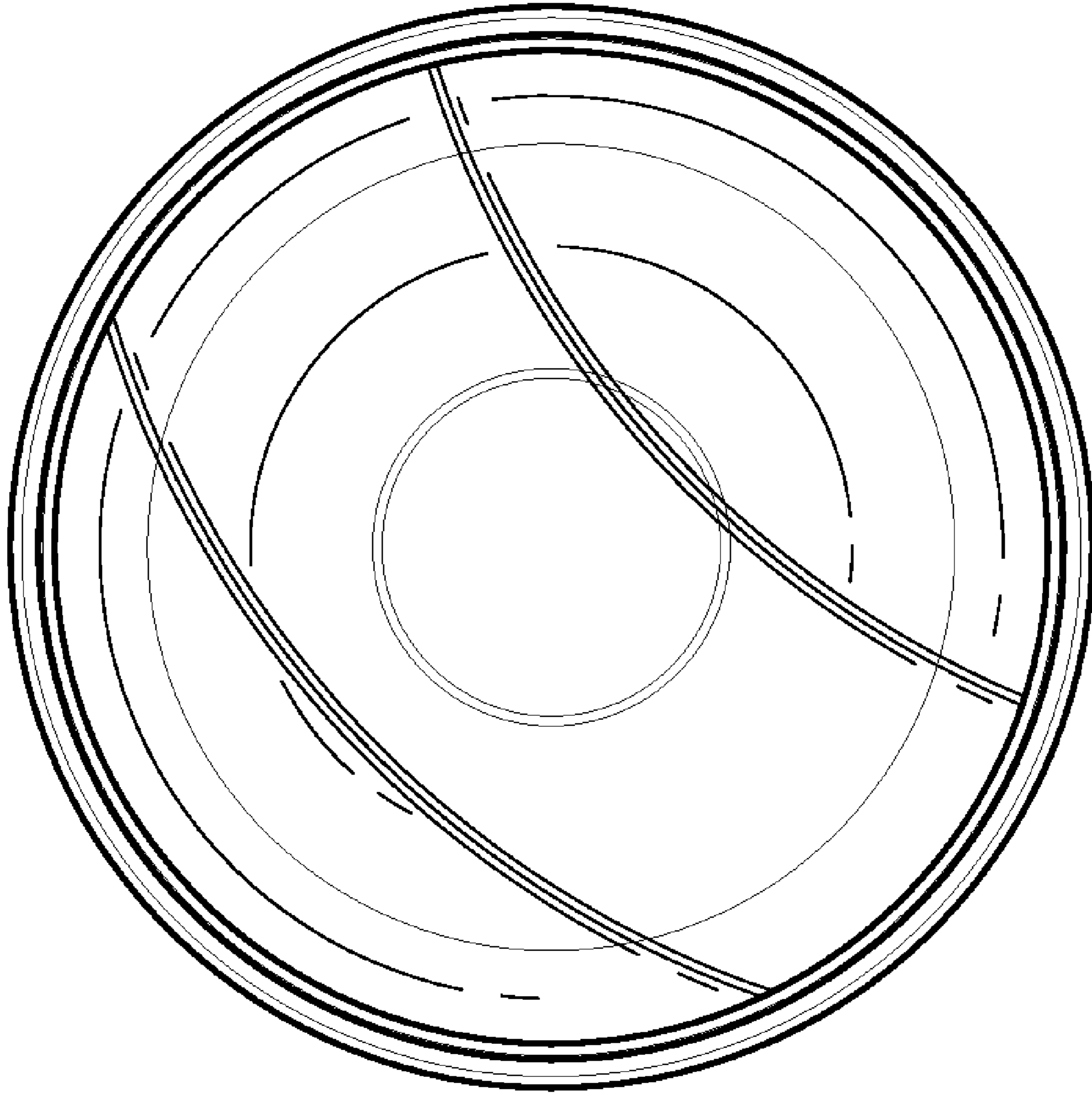

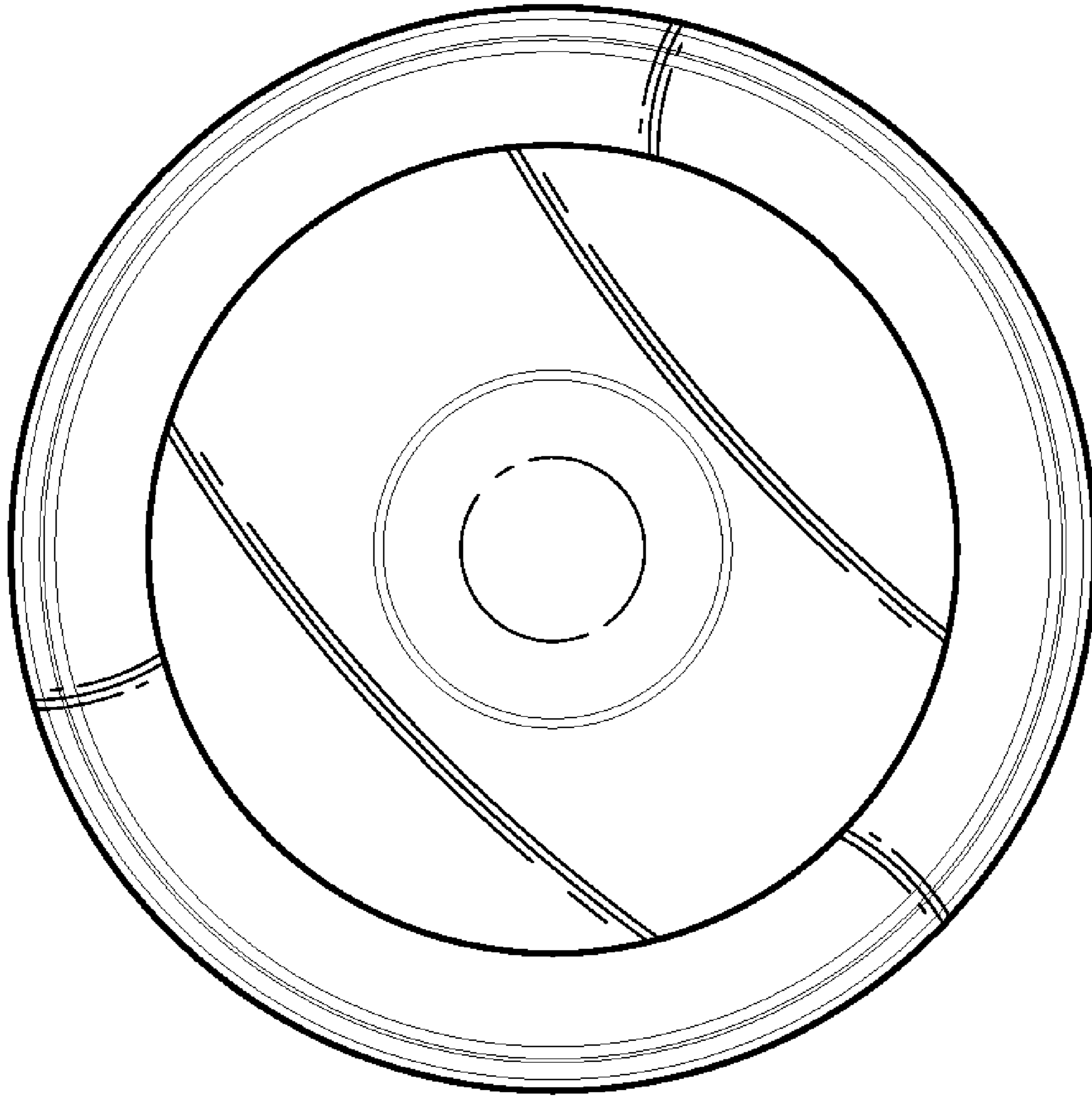
