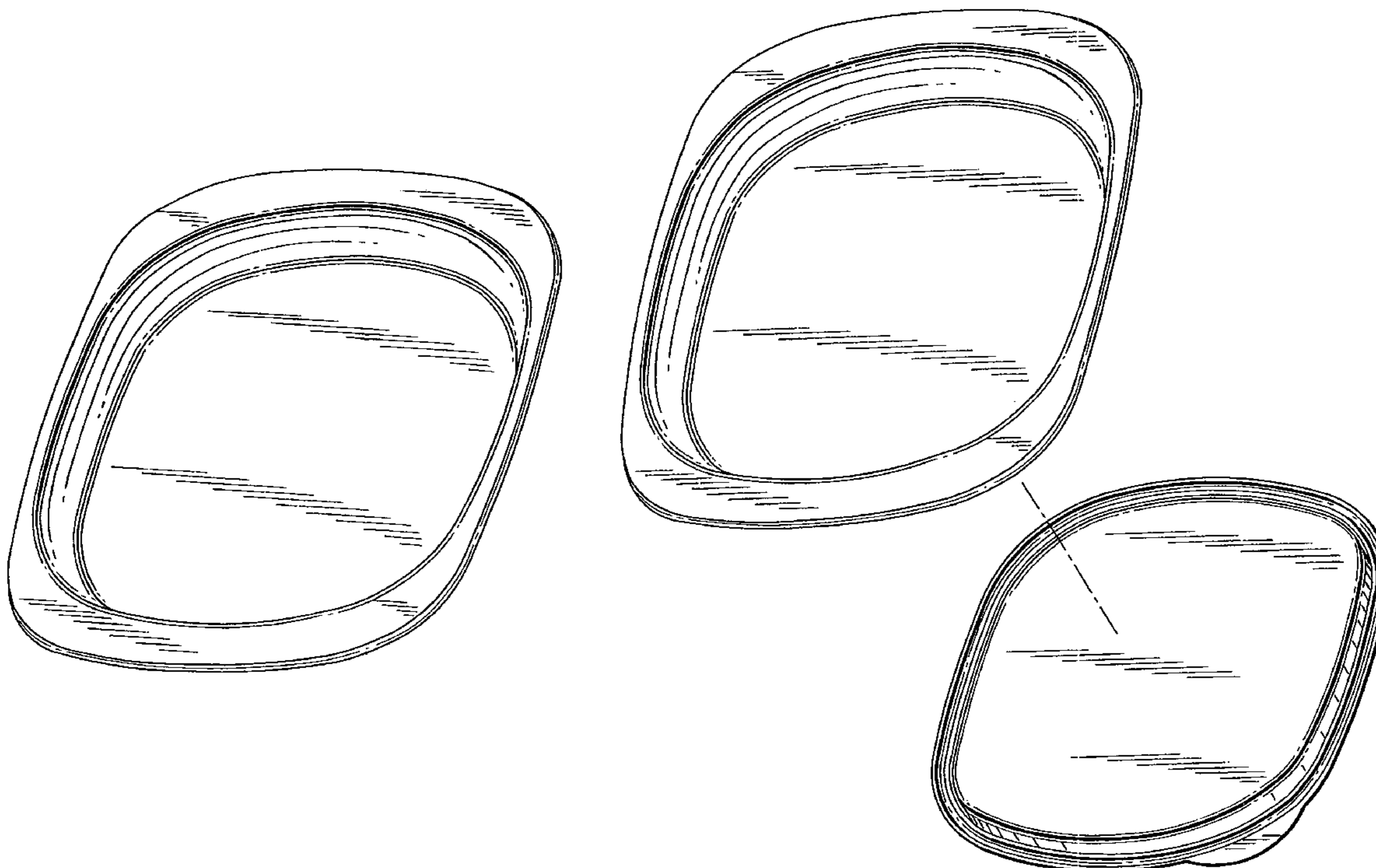
(57) **CLAIM**

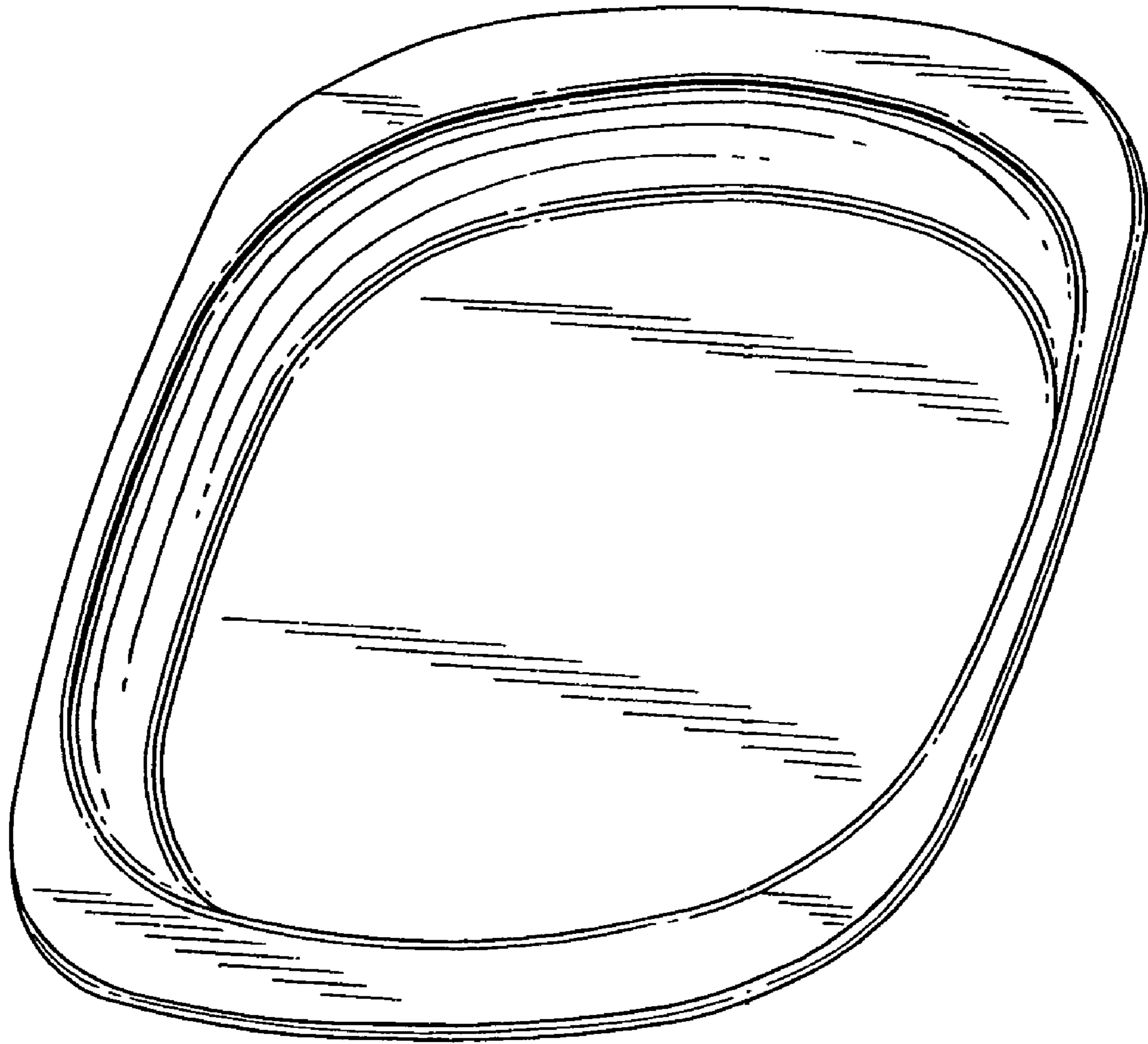
We claim the ornamental design for a plate and base assembly, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a plate and base assembly showing the design of the present invention;

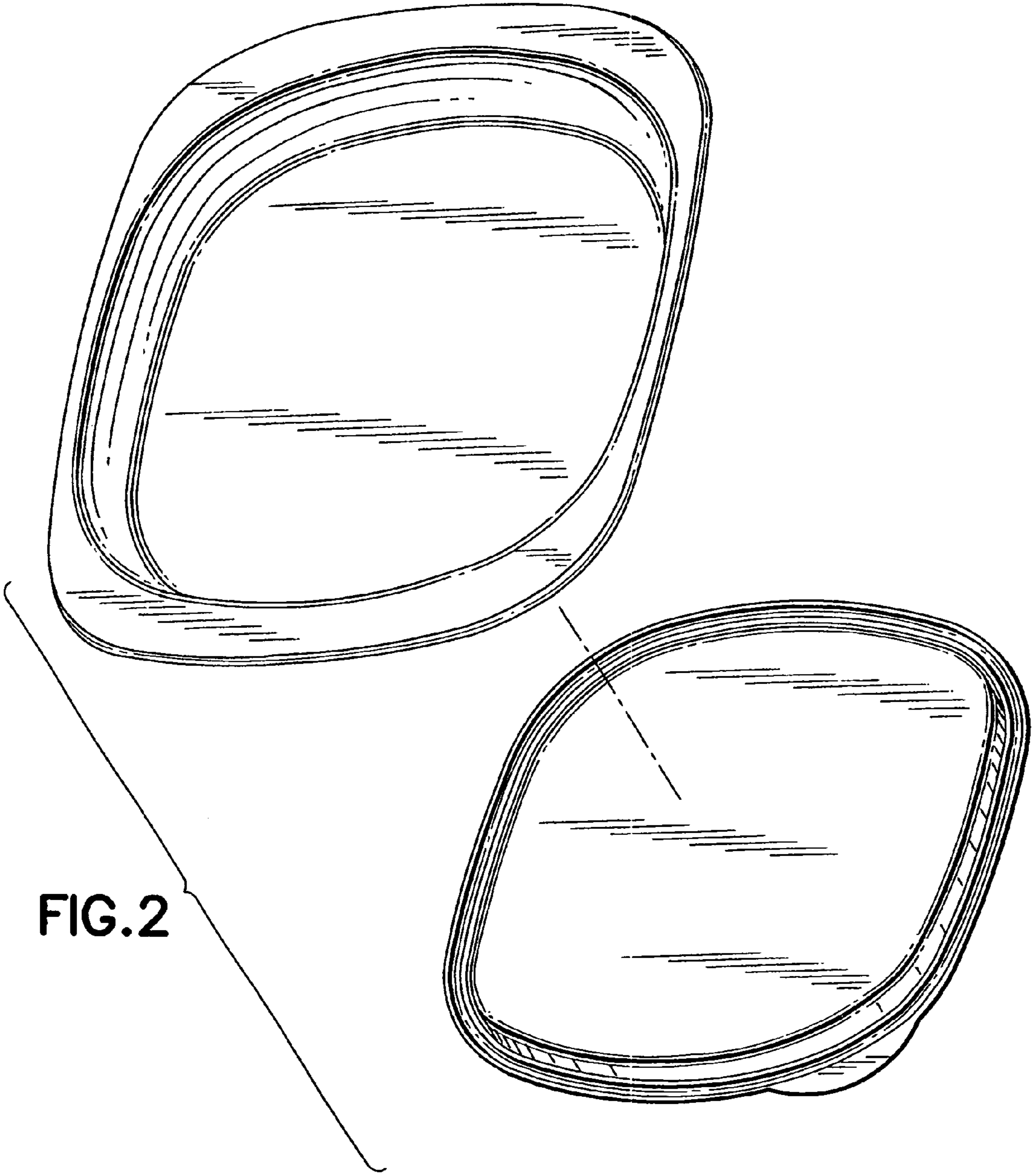

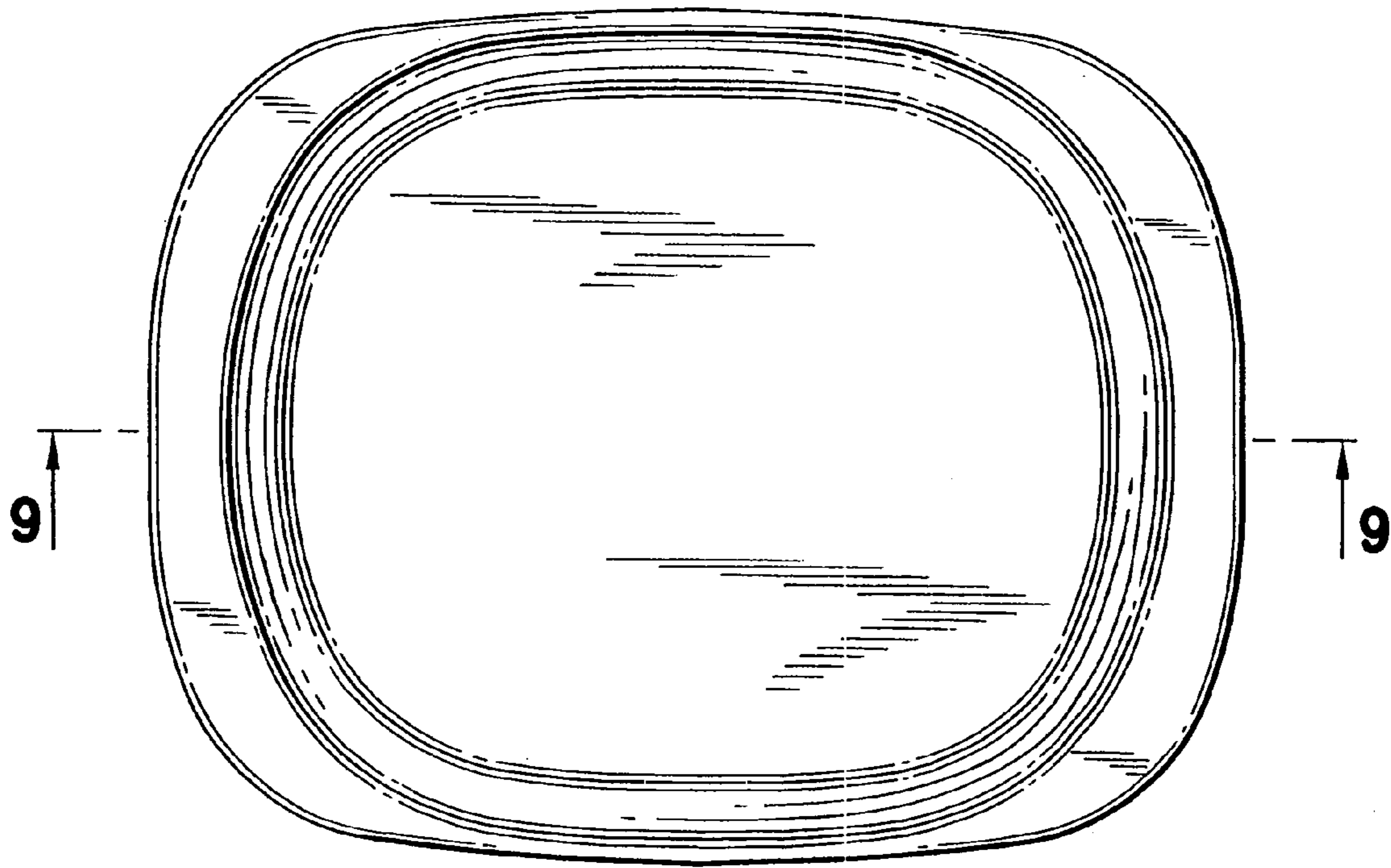

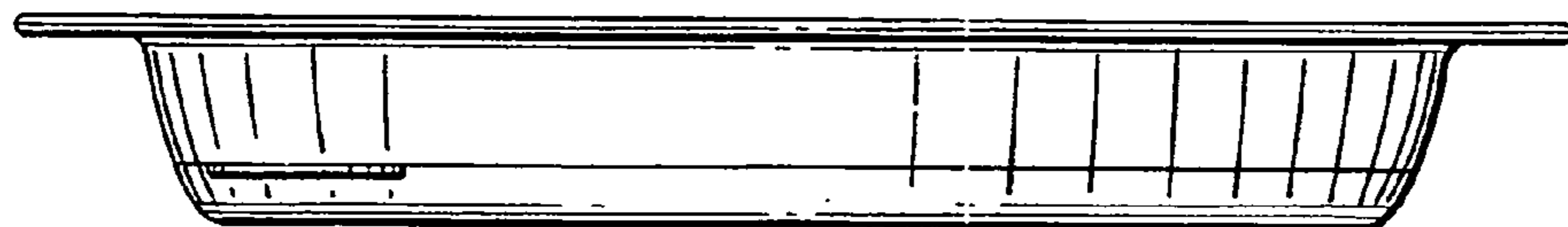
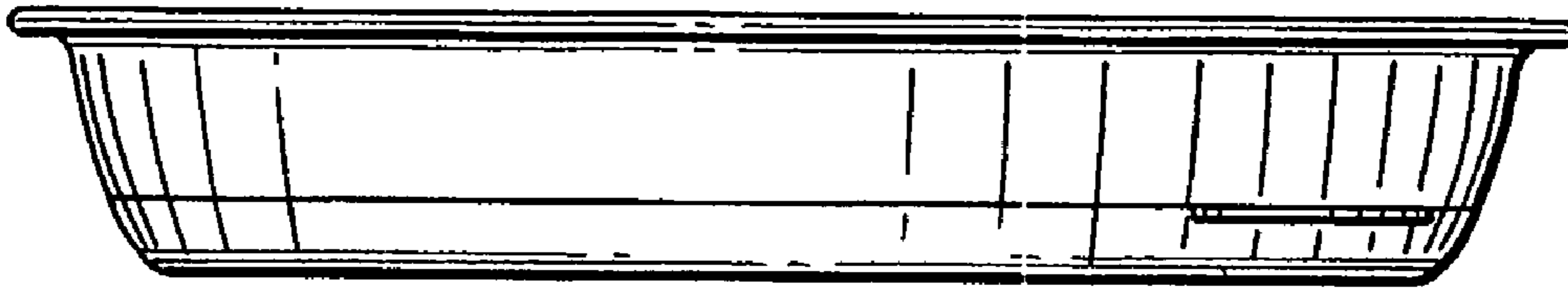
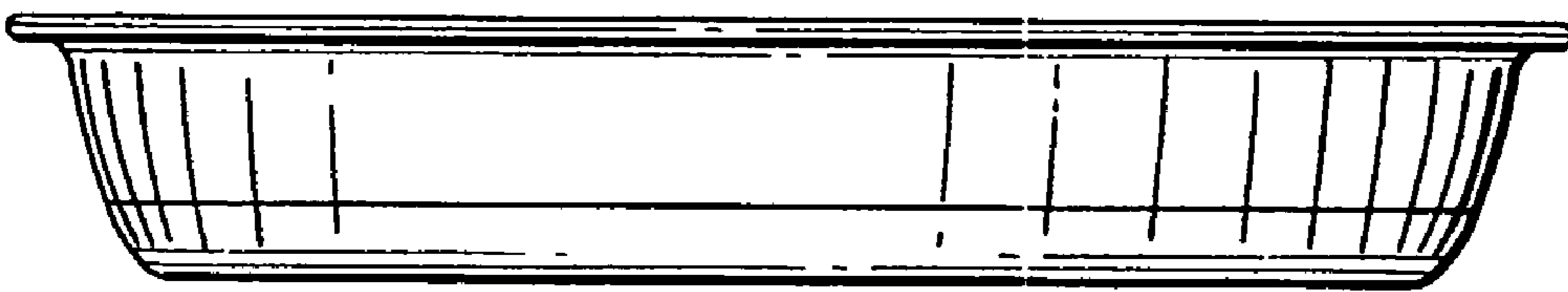

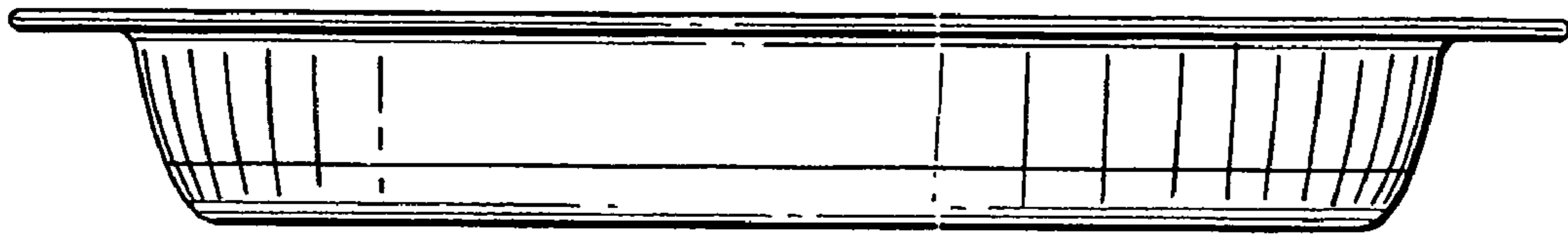

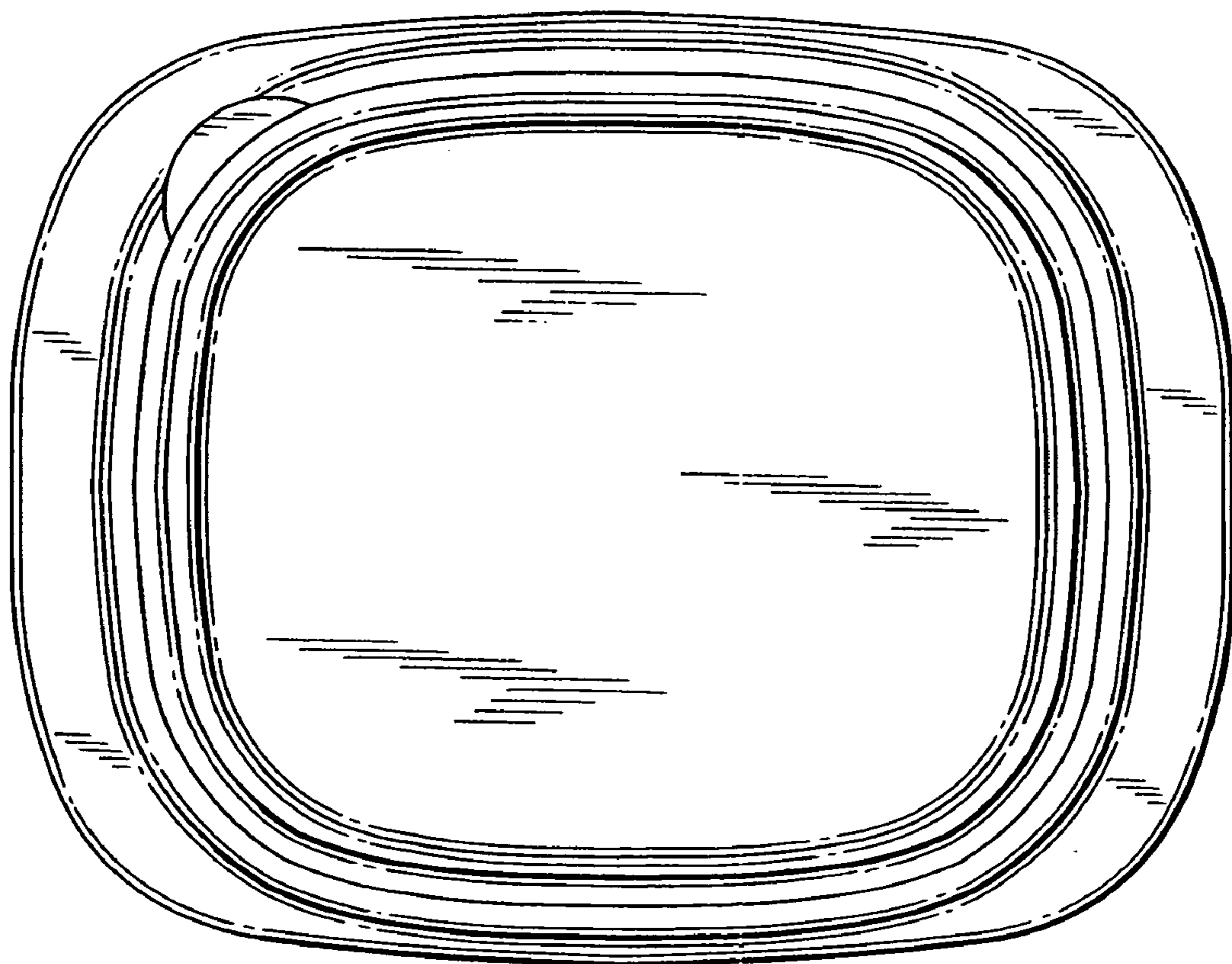

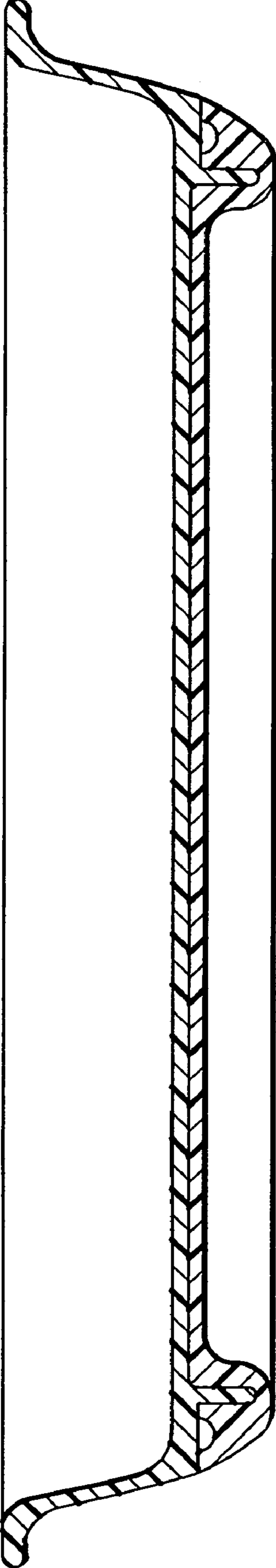
