DESCRIPTION

FIG. 1 is a top, front, perspective view of a container of the present invention;

FIG. 2 is a side elevation view thereof;

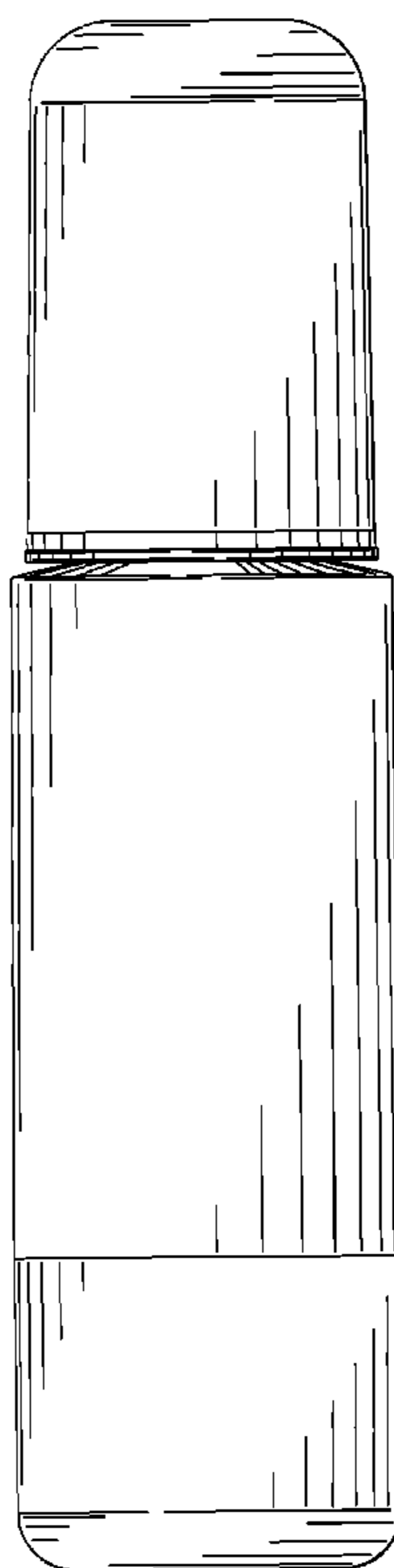
FIG. 3 is a top plan view thereof;

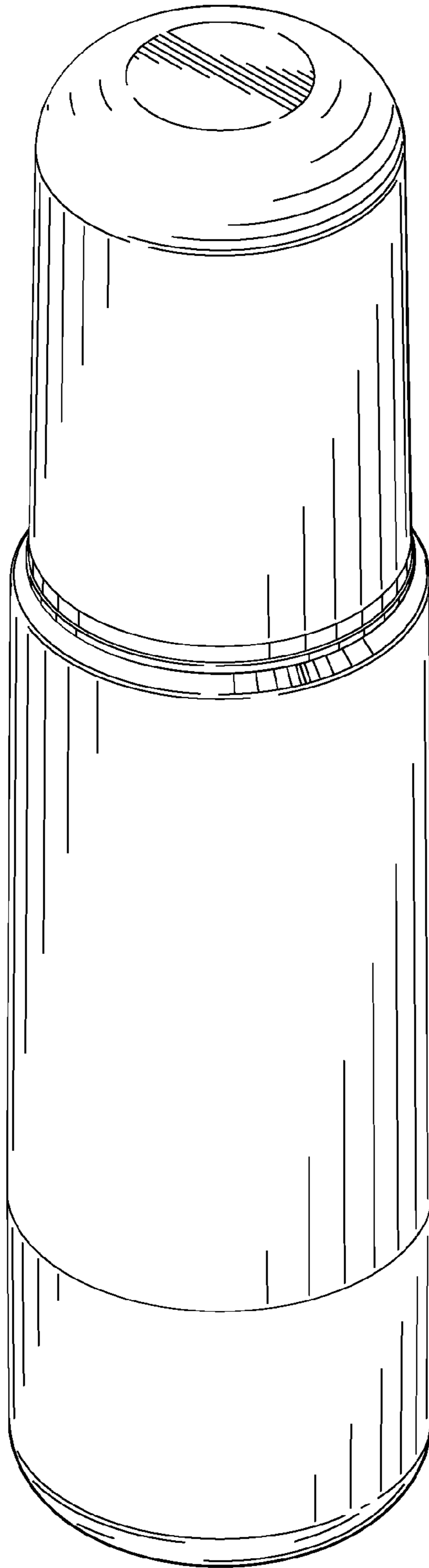

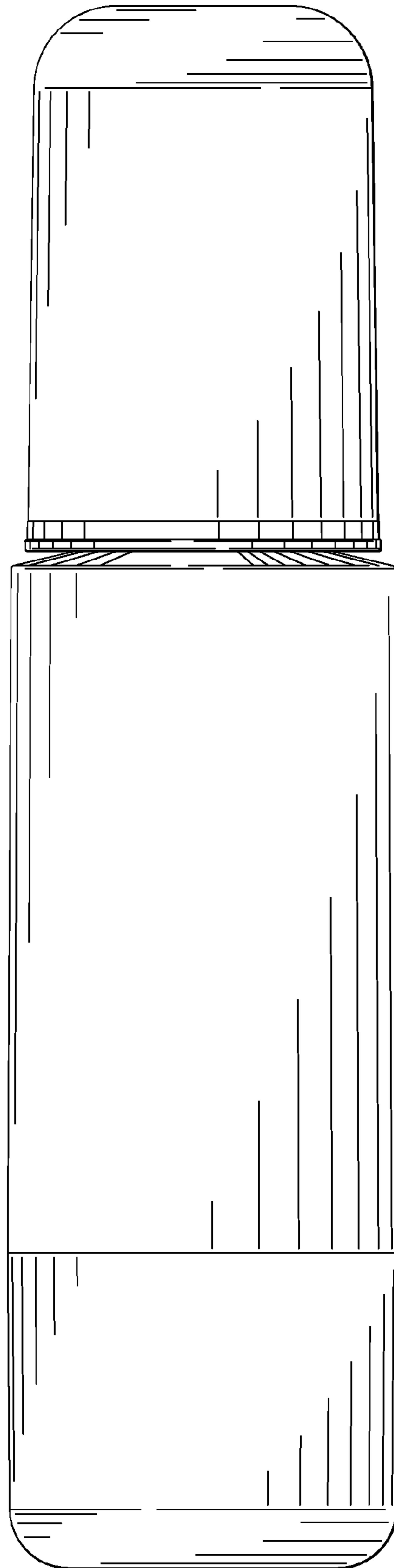

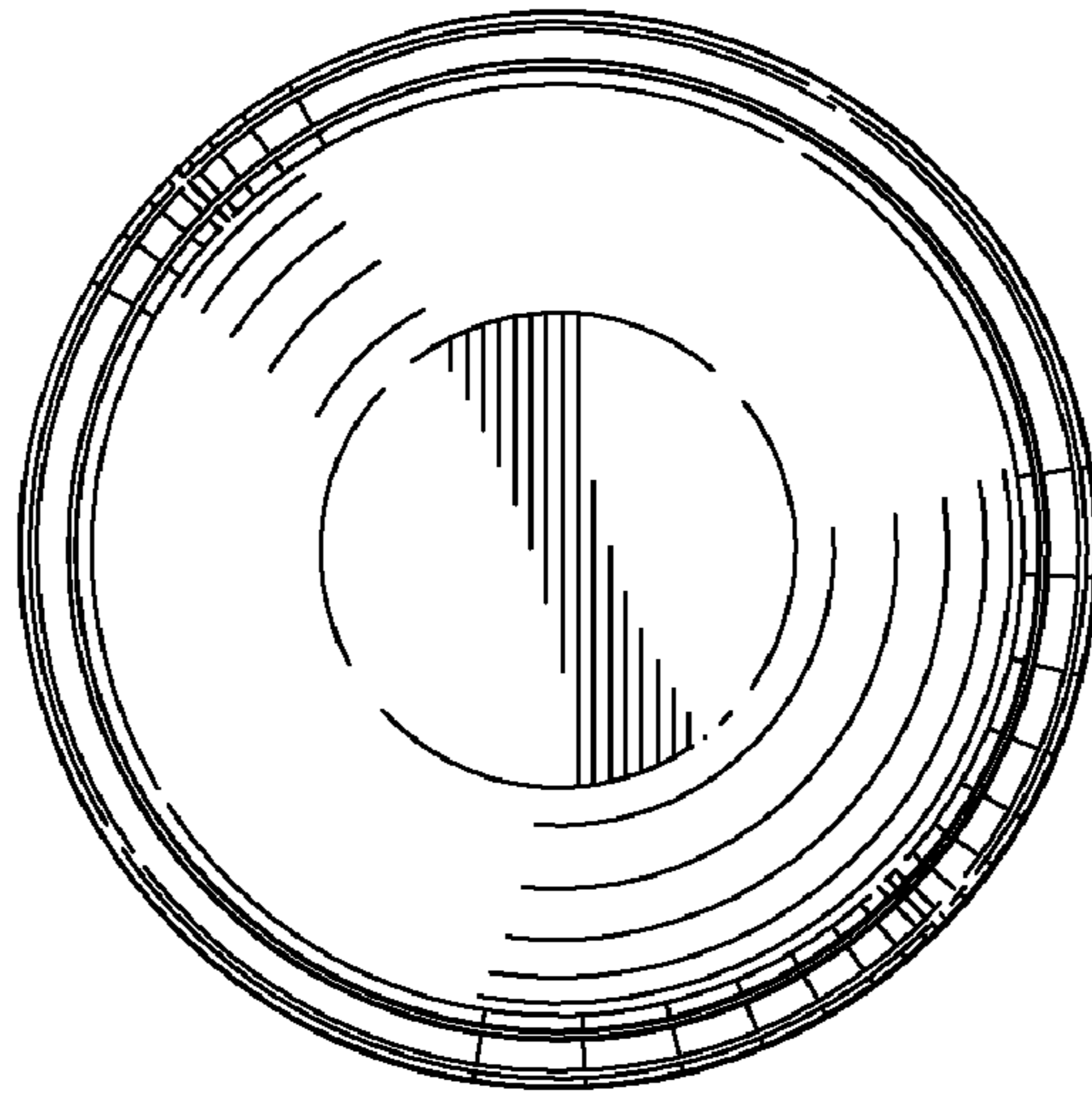

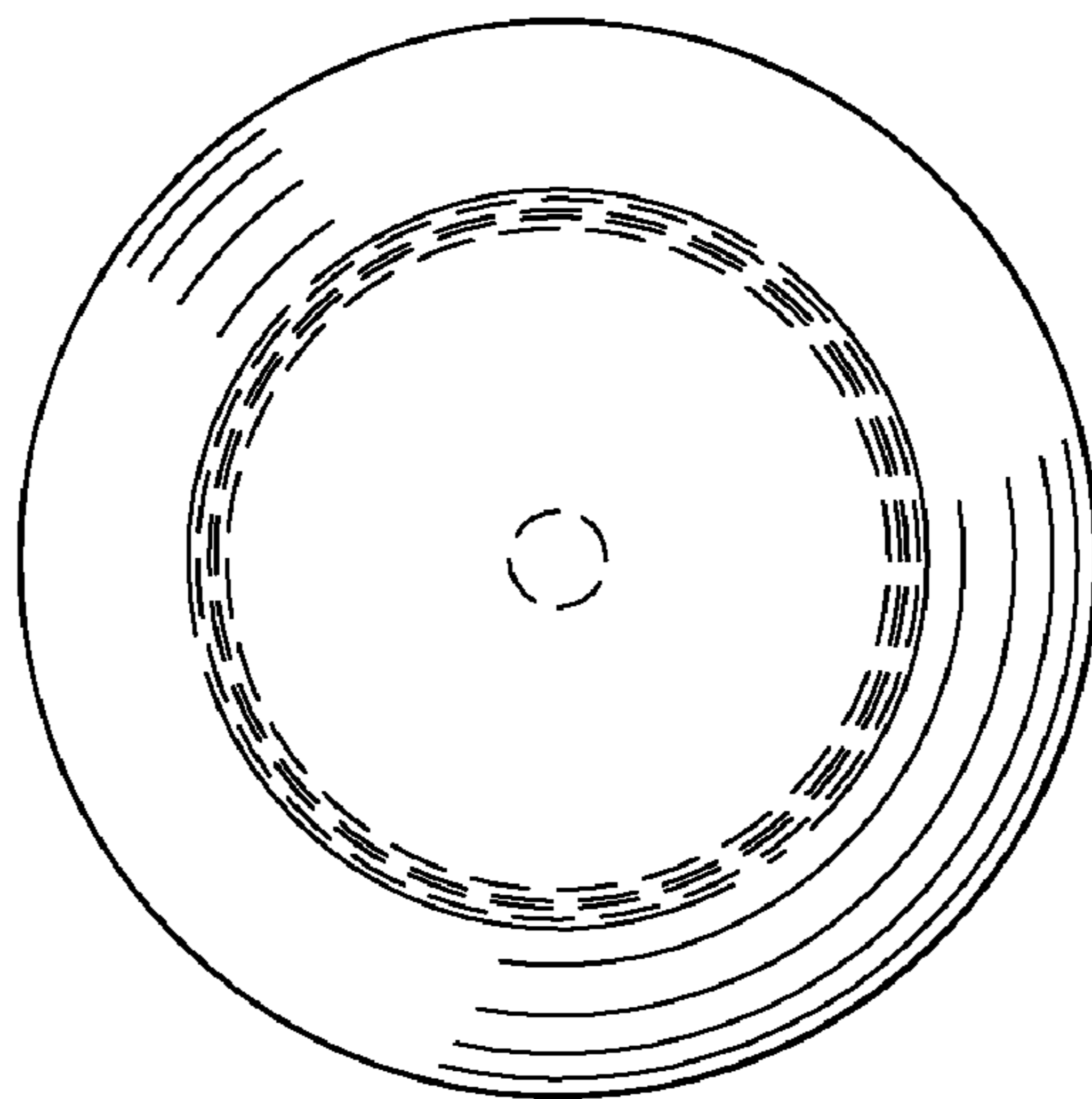

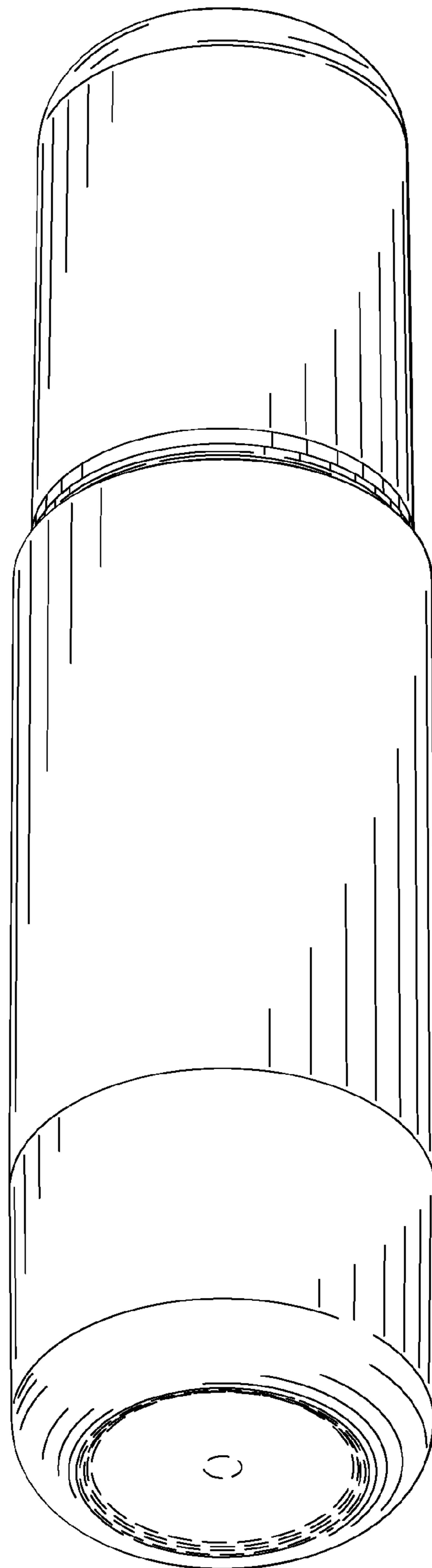
