FIG. 5 is a rear view of the artificial gemstone, natural gemstone, ornamental object made of glass according to the first embodiment;

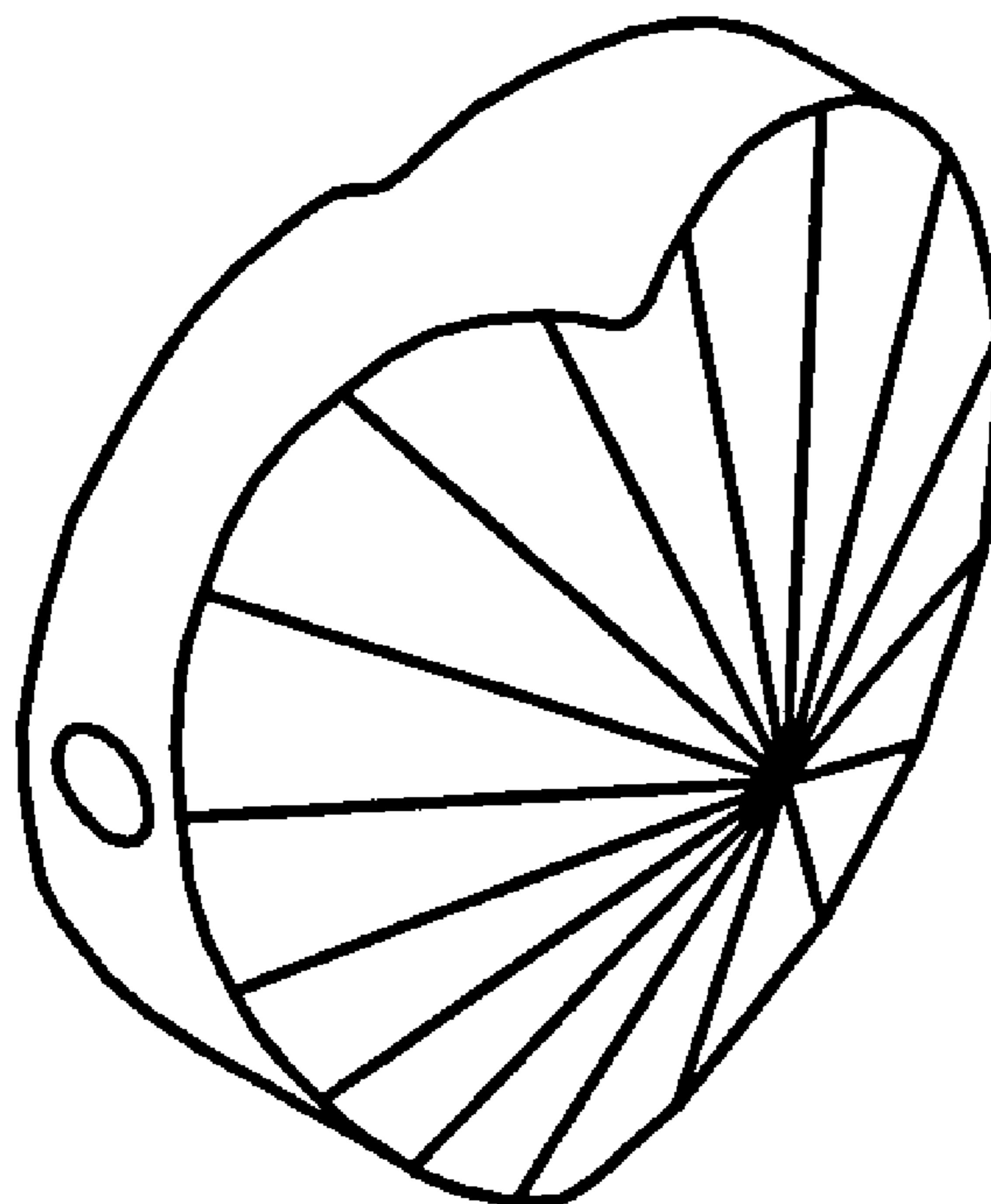
FIG. 6 is a top view of the artificial gemstone, natural gemstone, ornamental object made of glass according to the first embodiment; and,

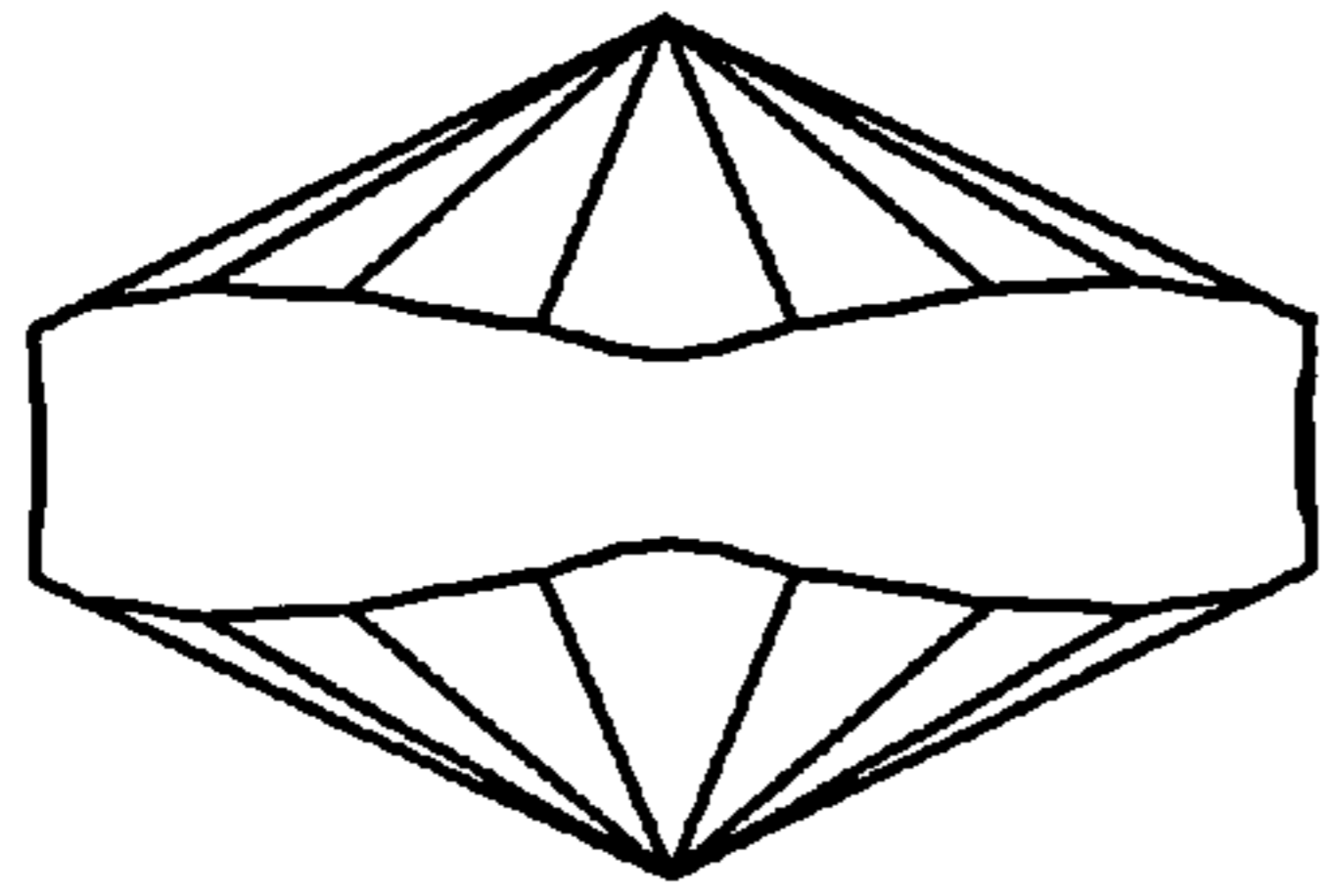

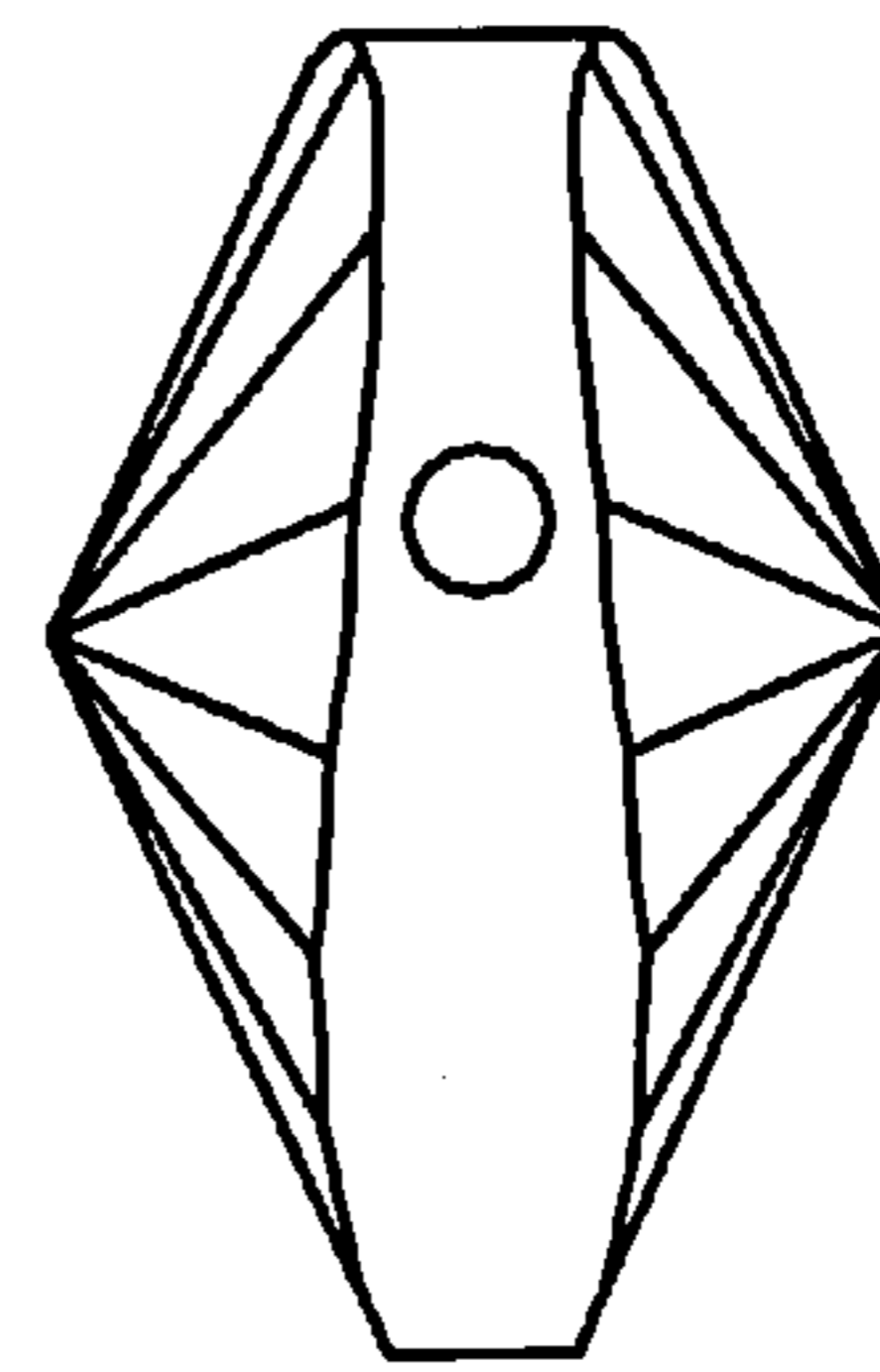

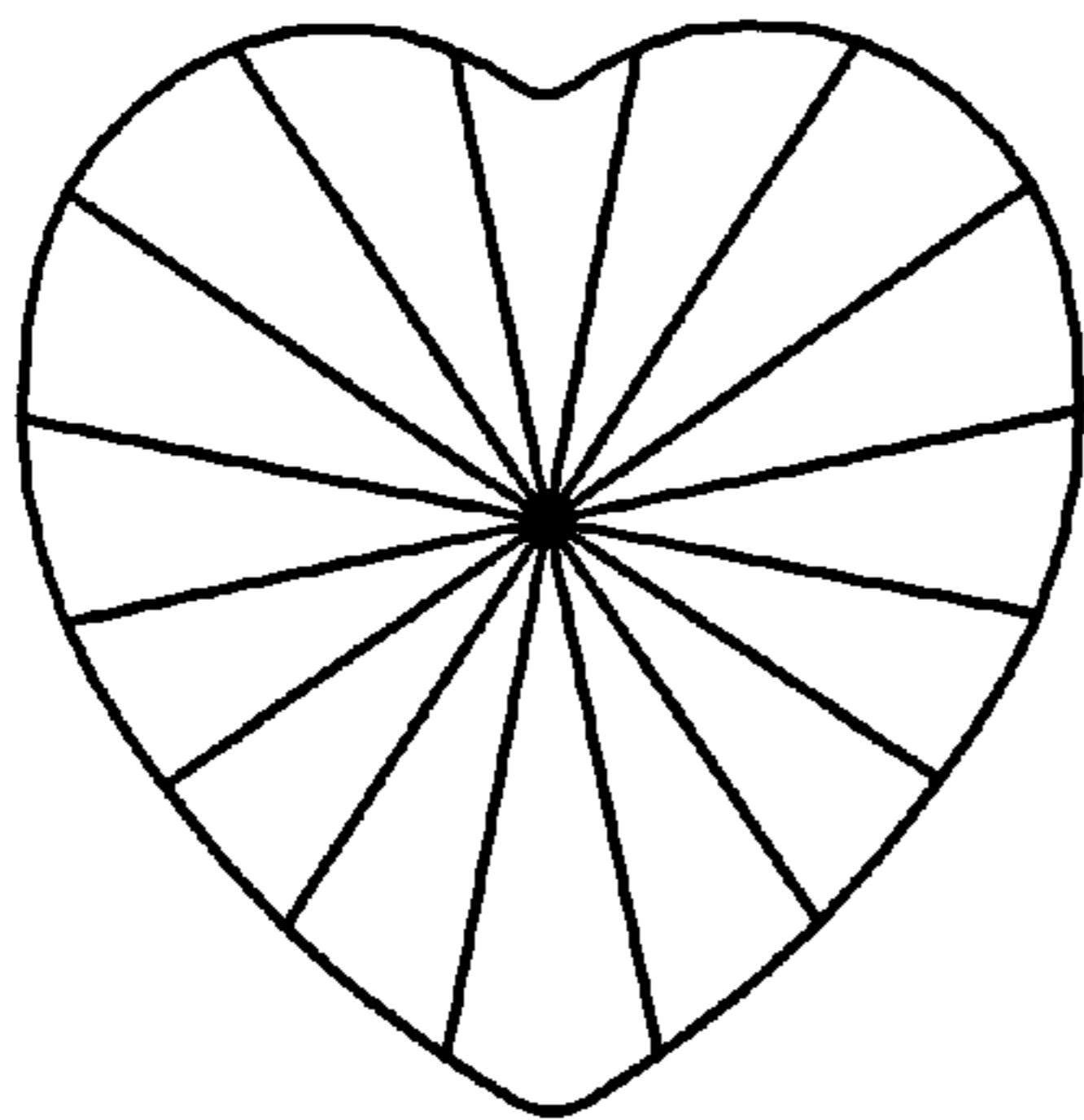

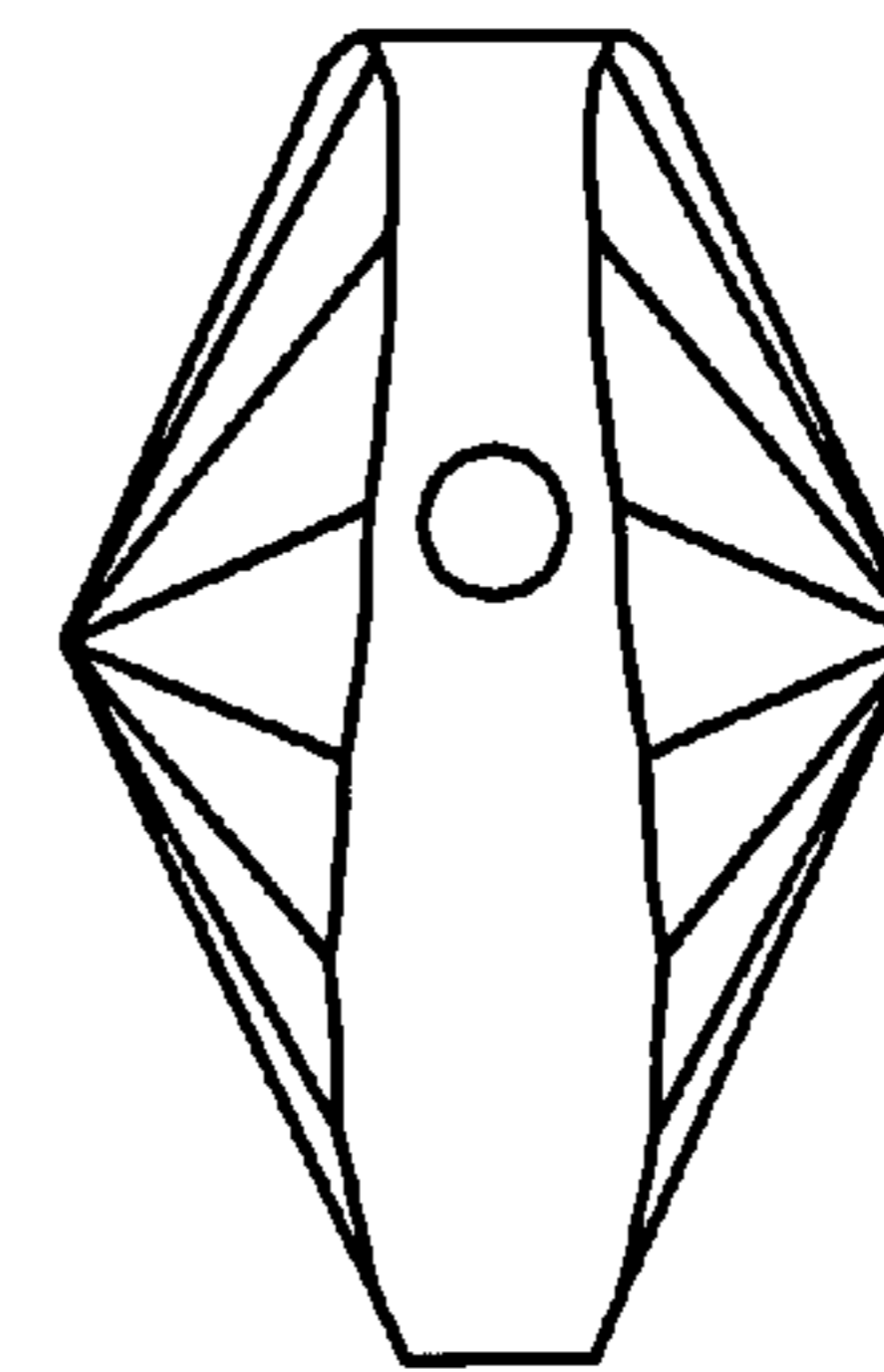

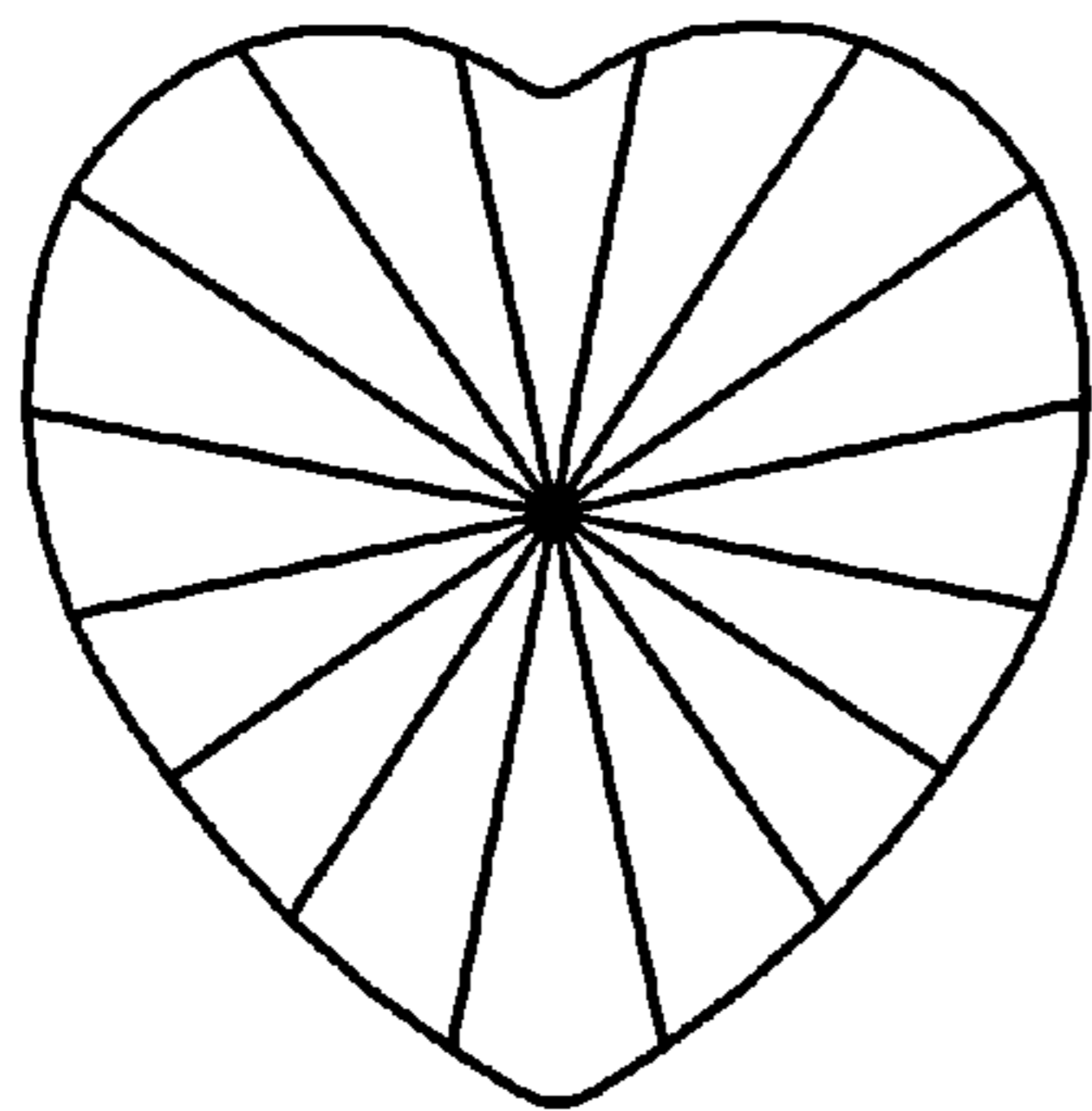

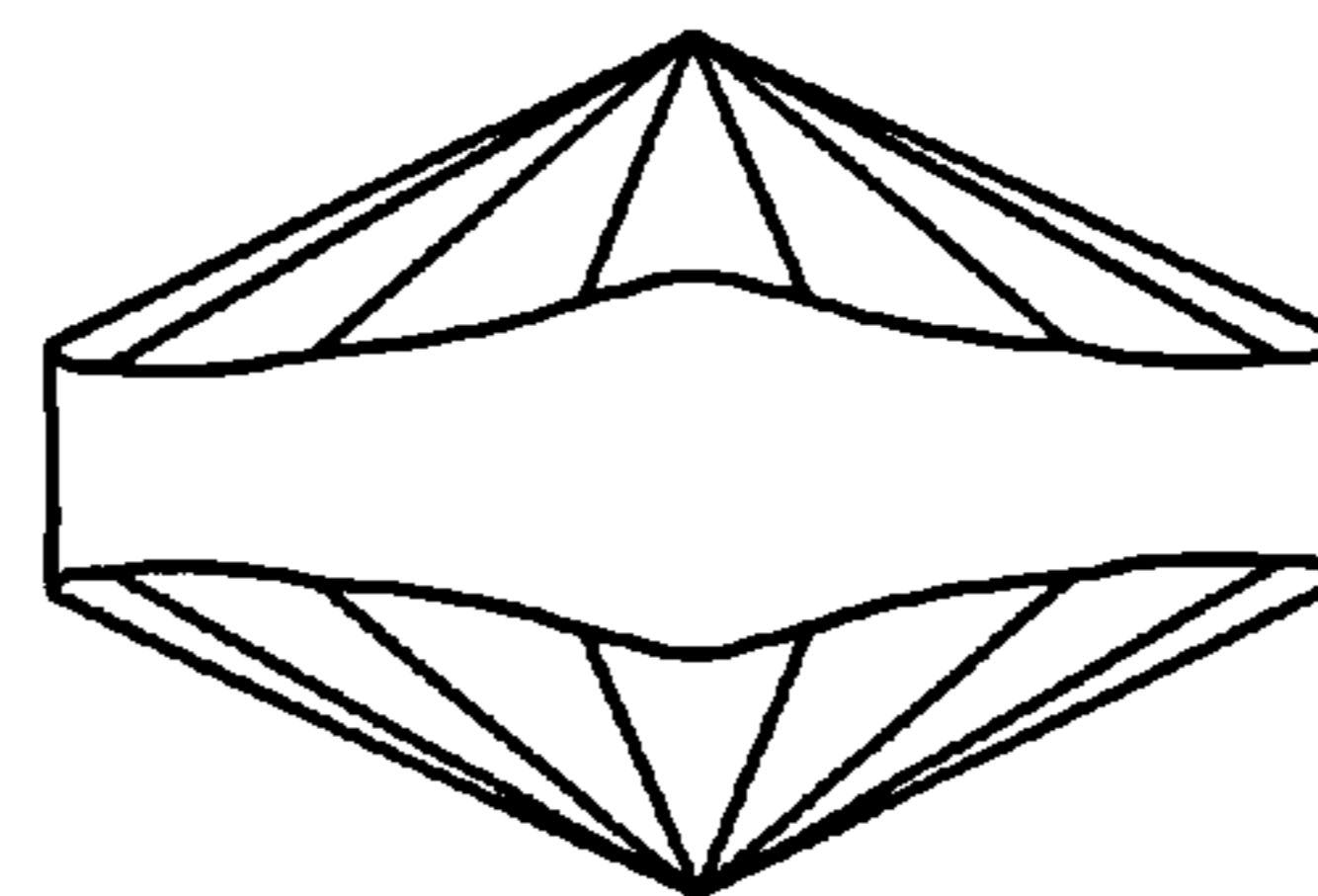

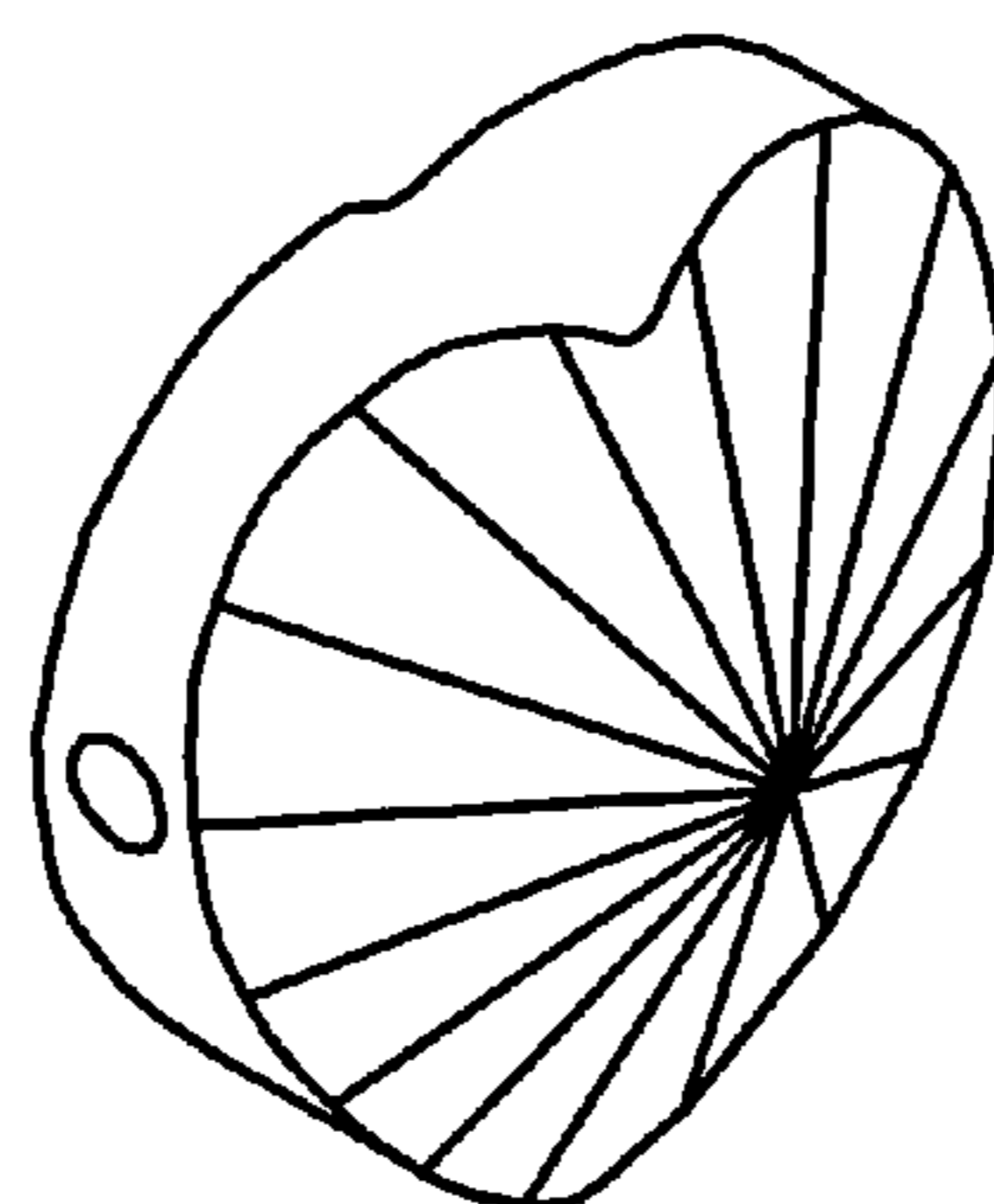
