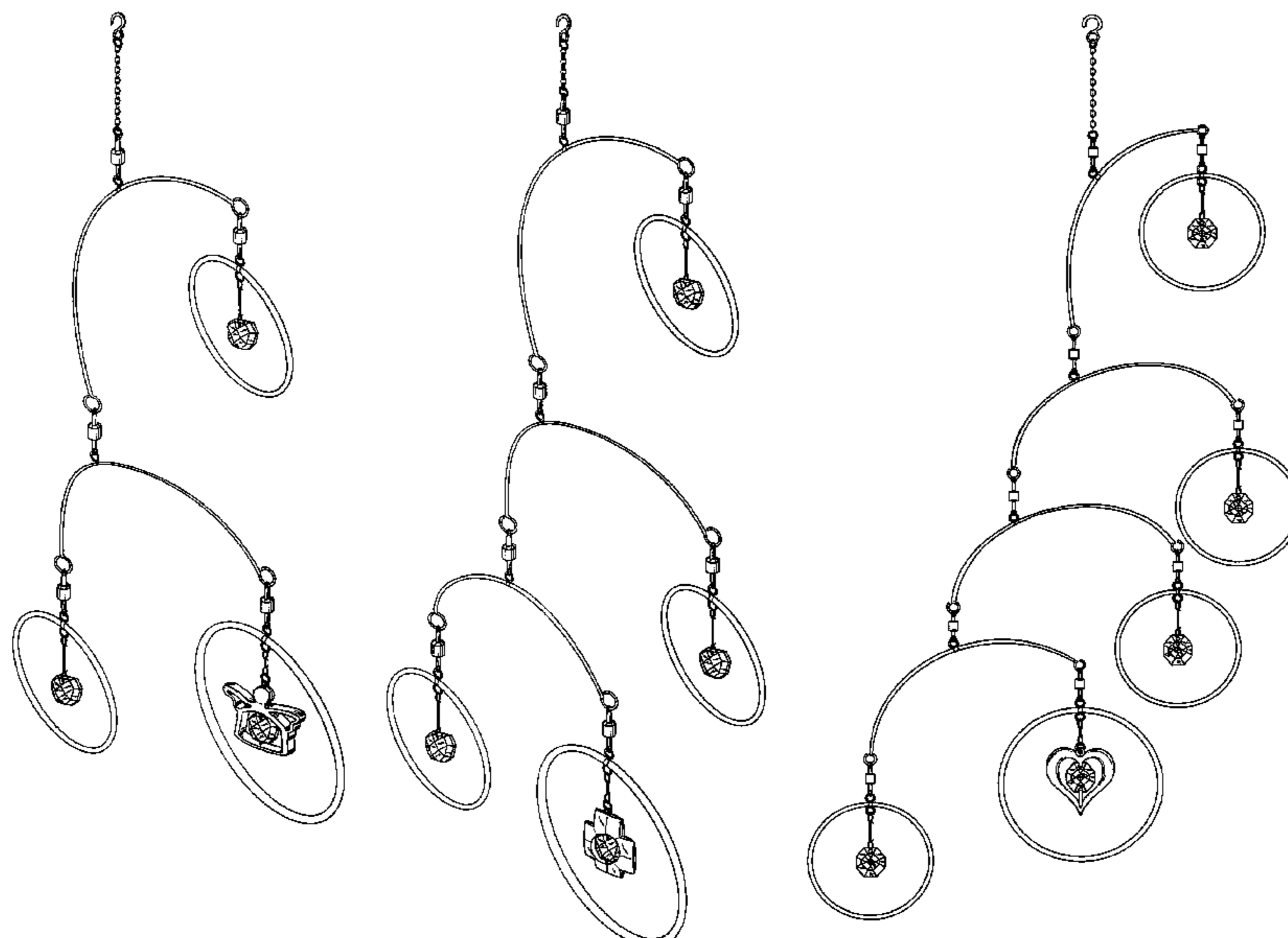
The ornamental design for a sun-catcher mobile, as shown

DESCRIPTION

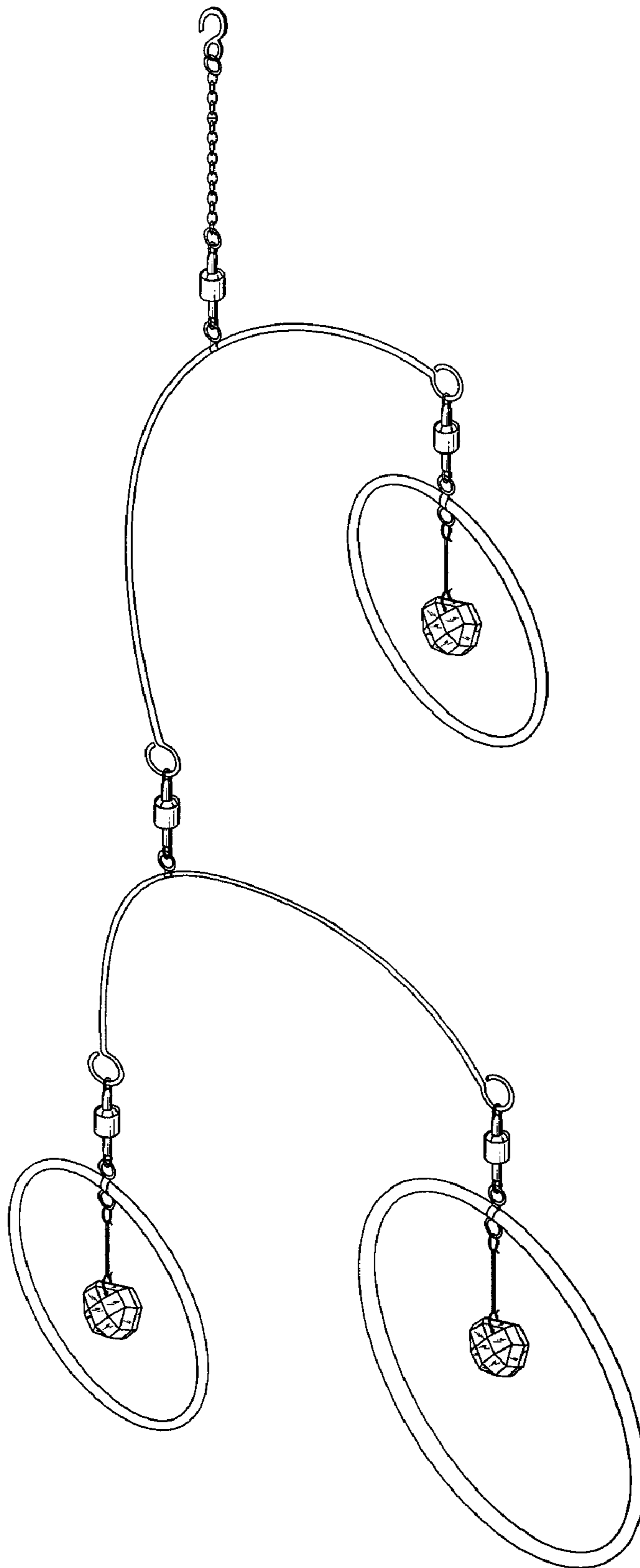

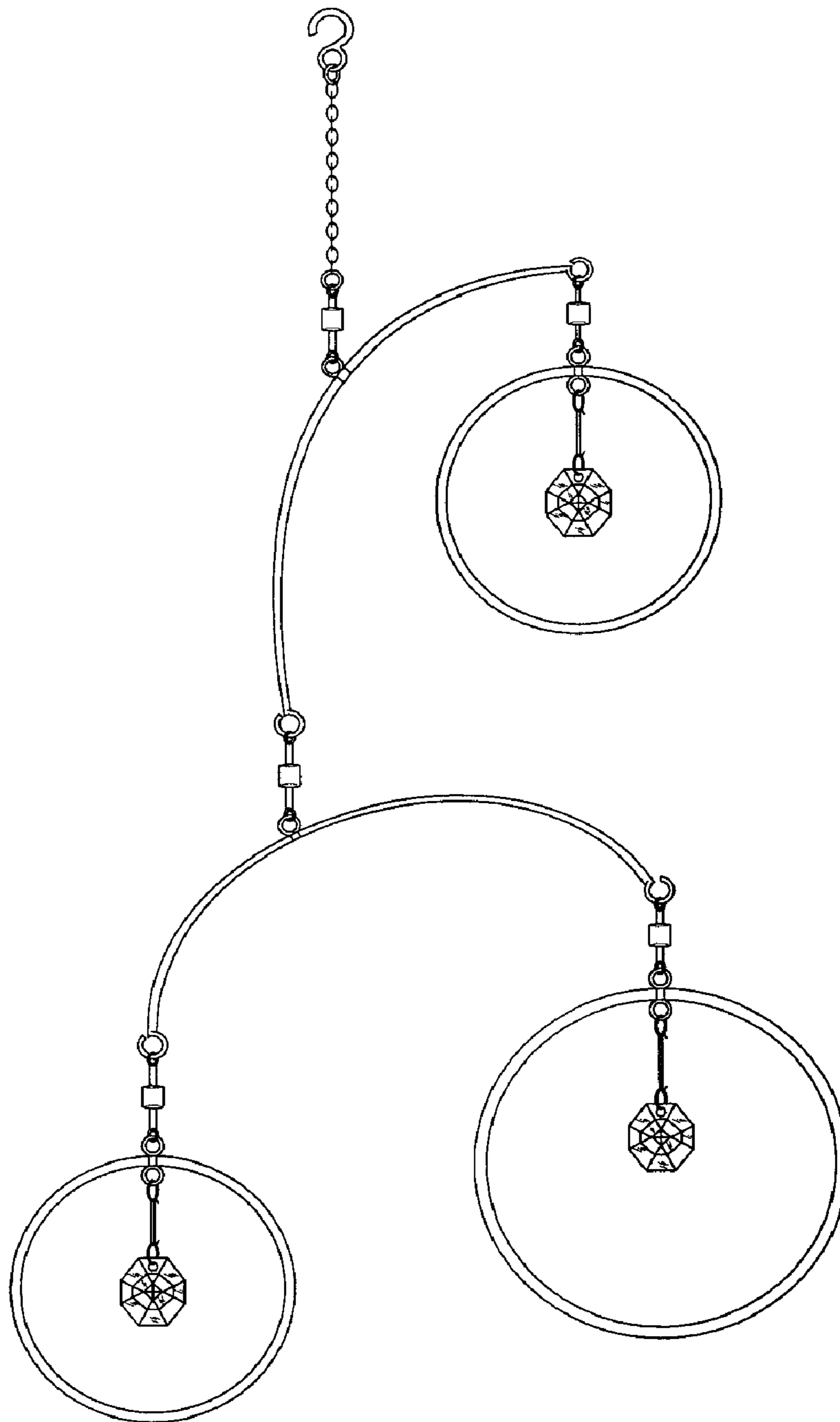

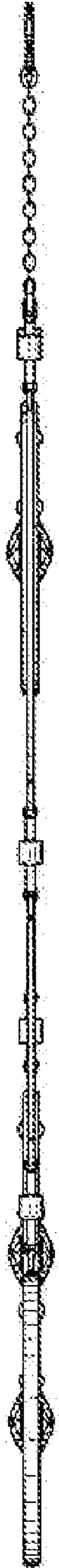

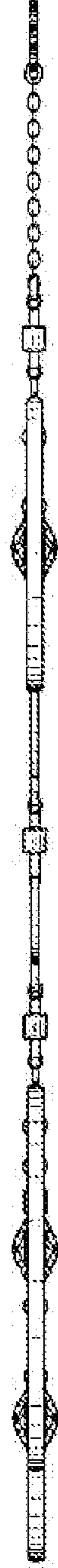

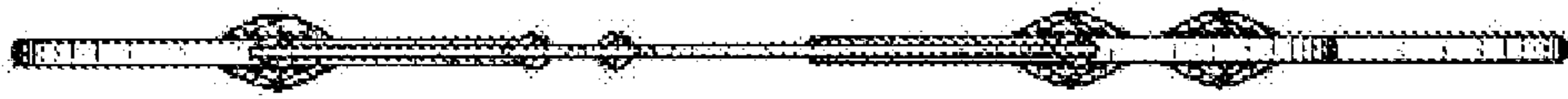

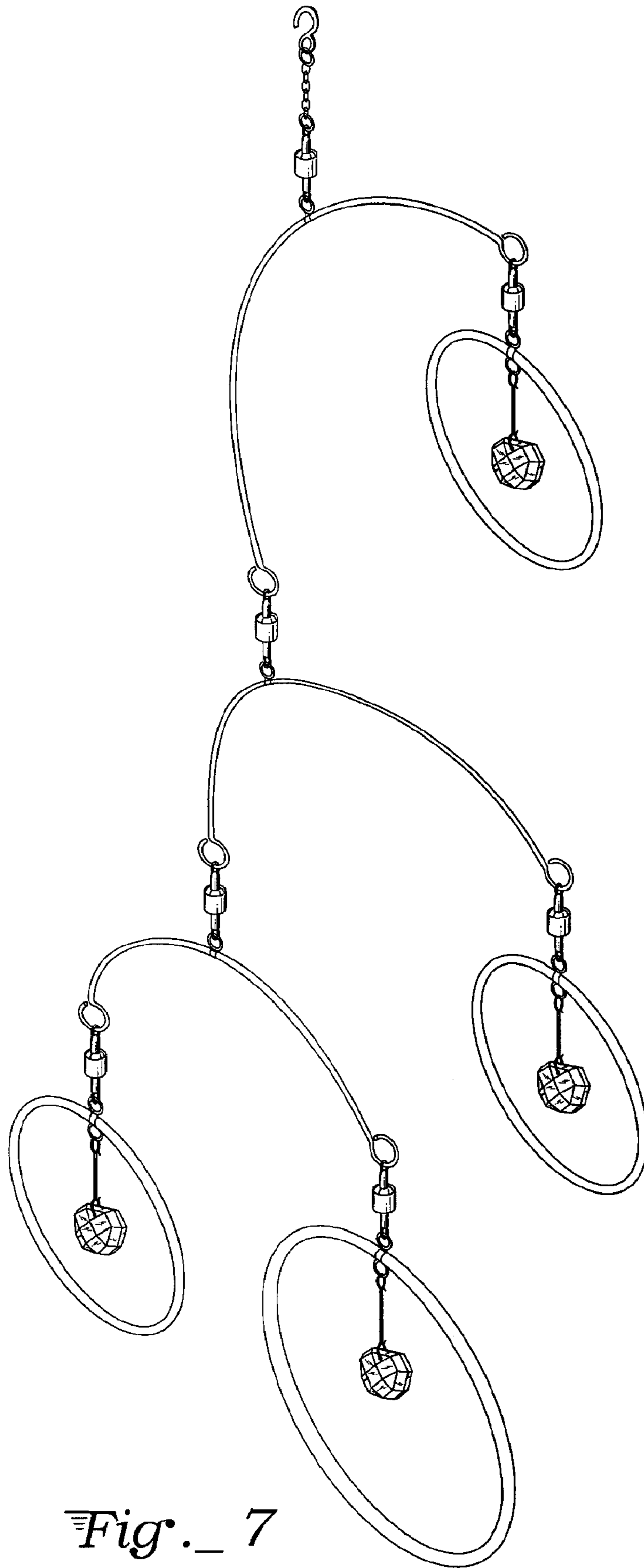

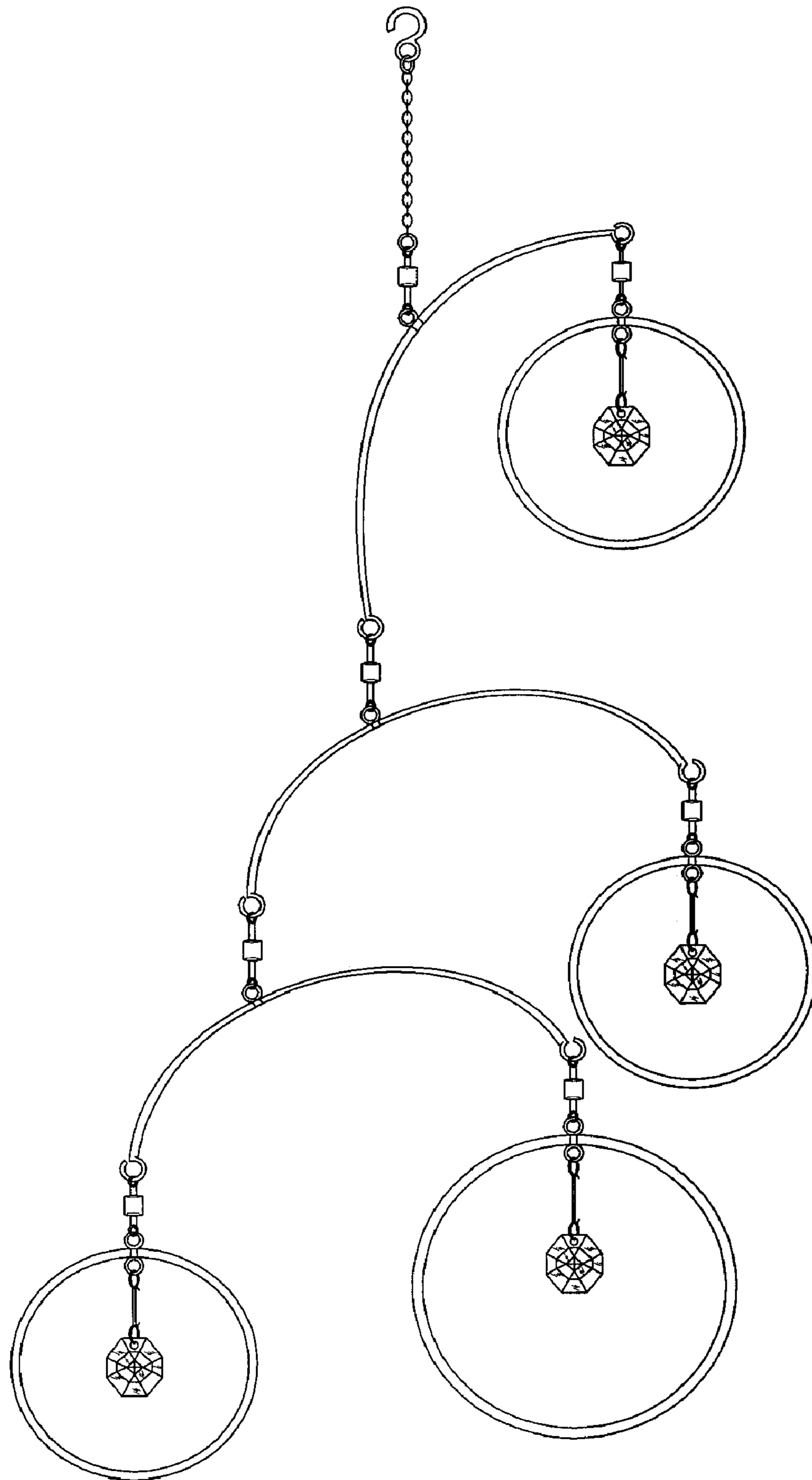

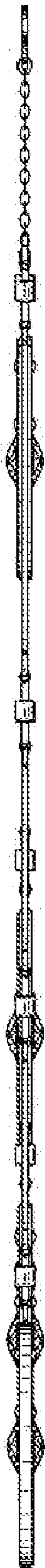

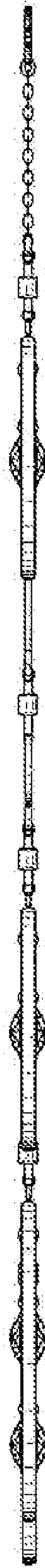

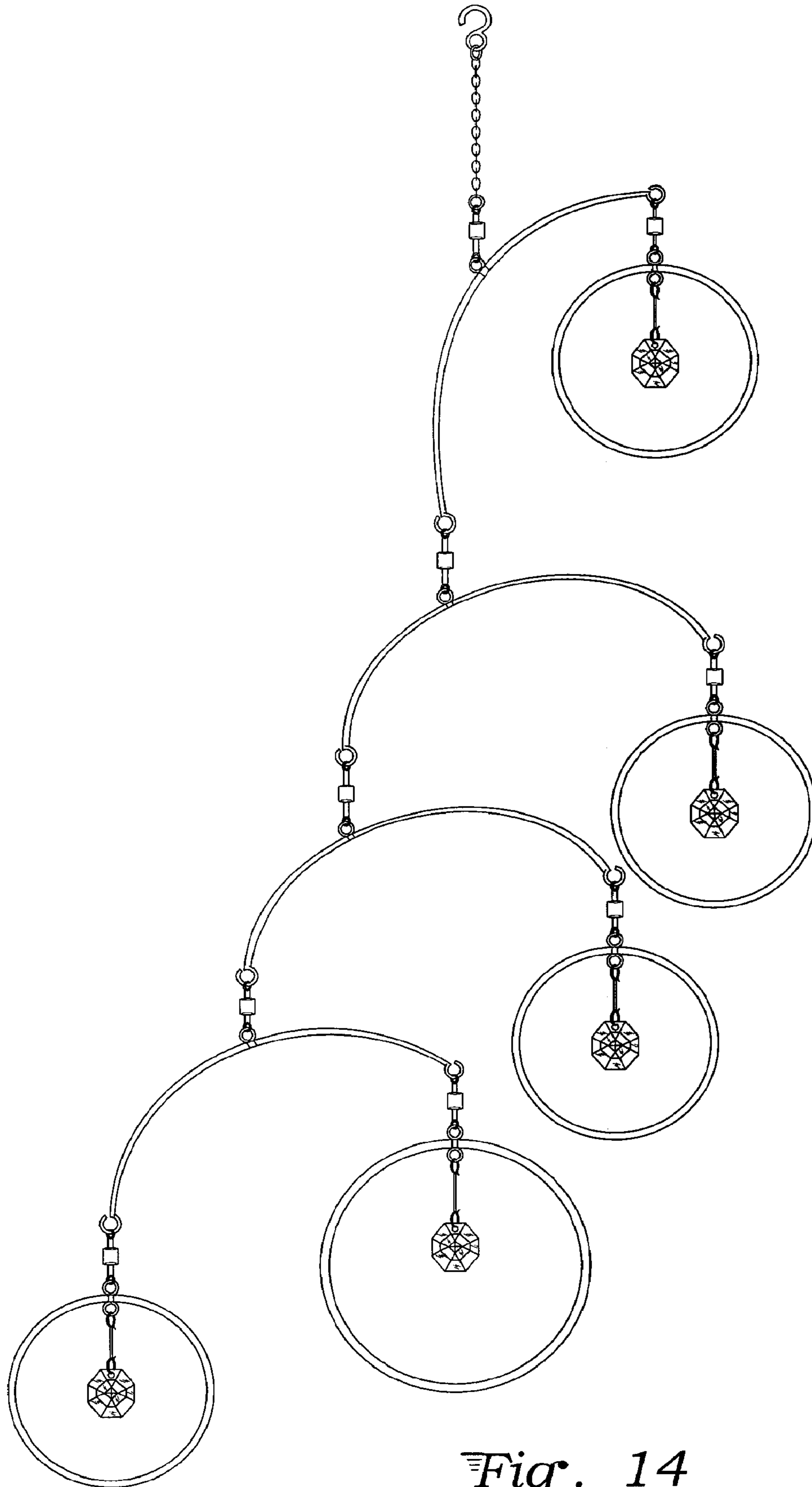

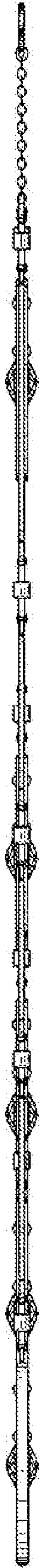

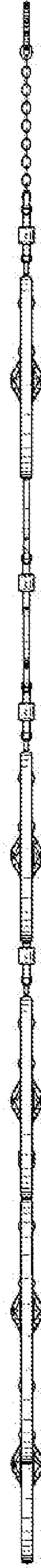

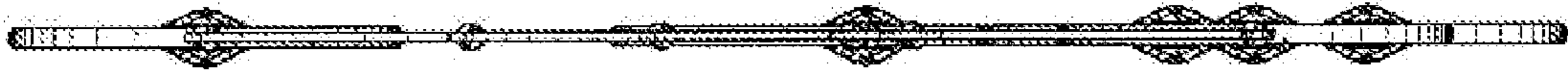

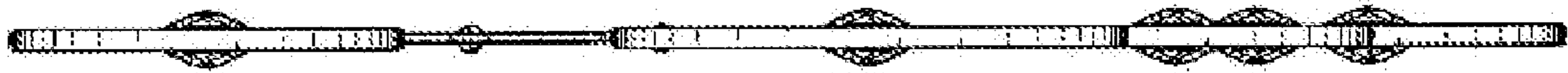

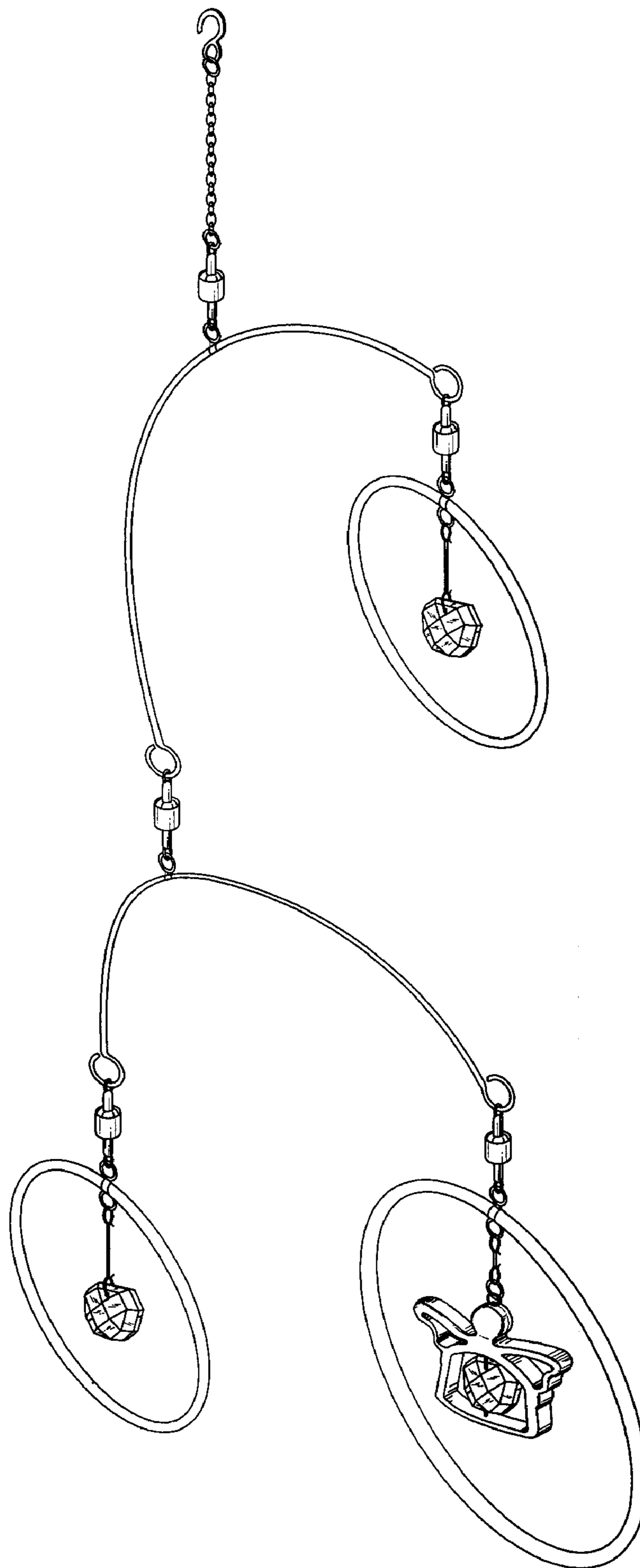

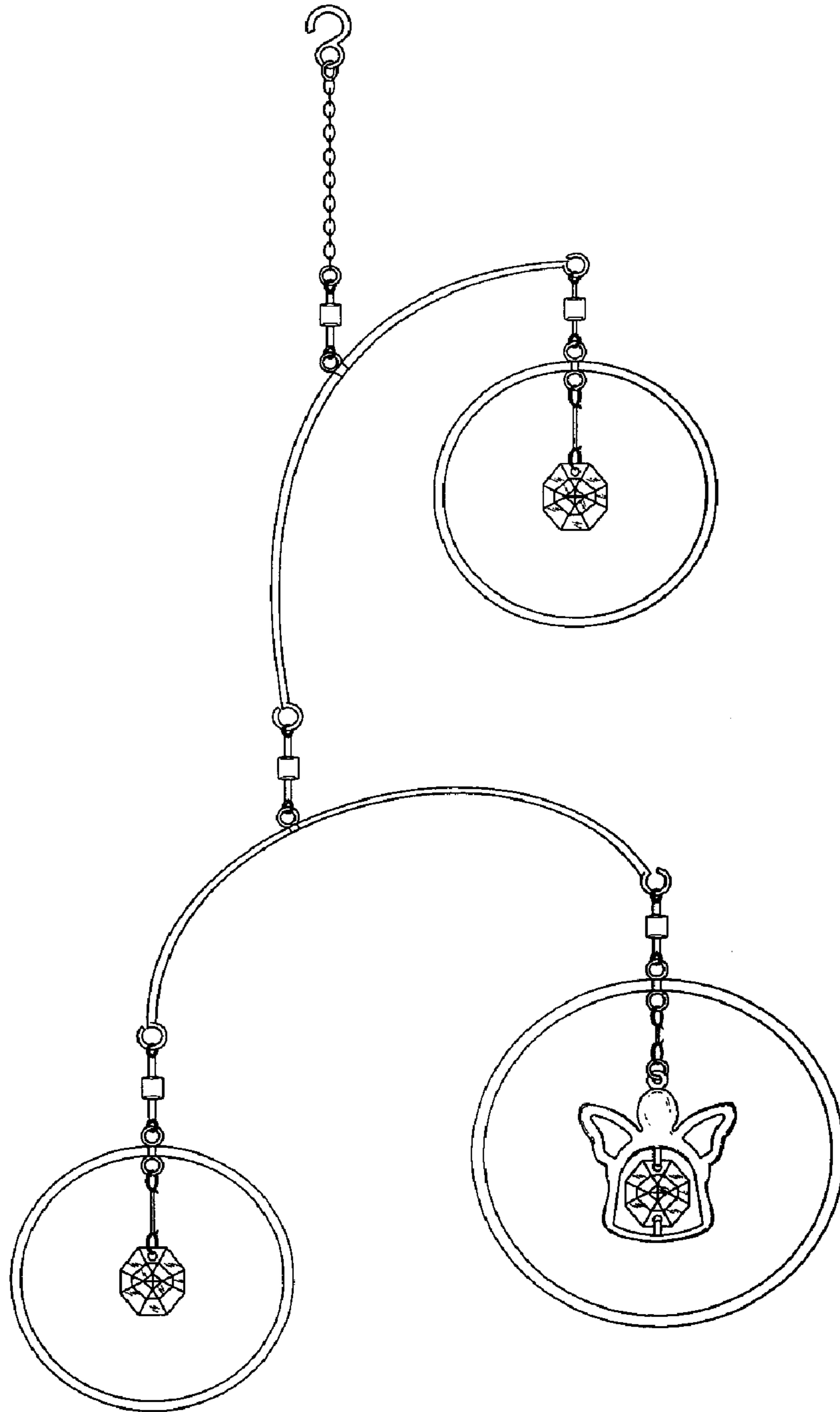

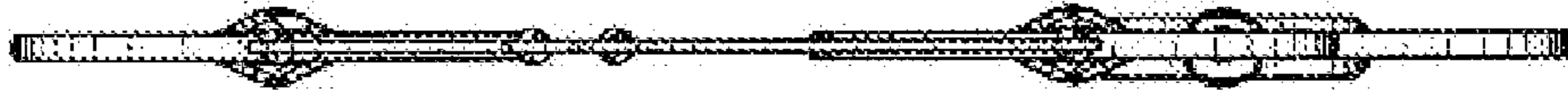

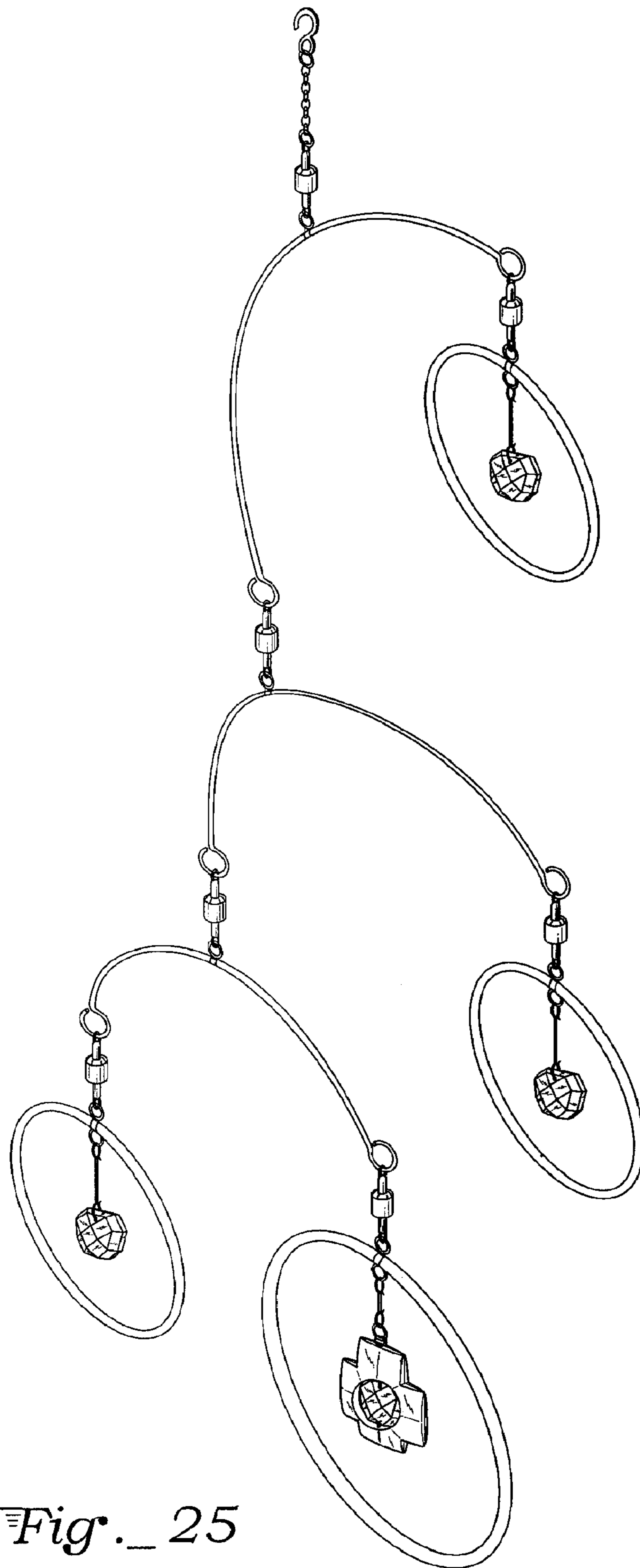

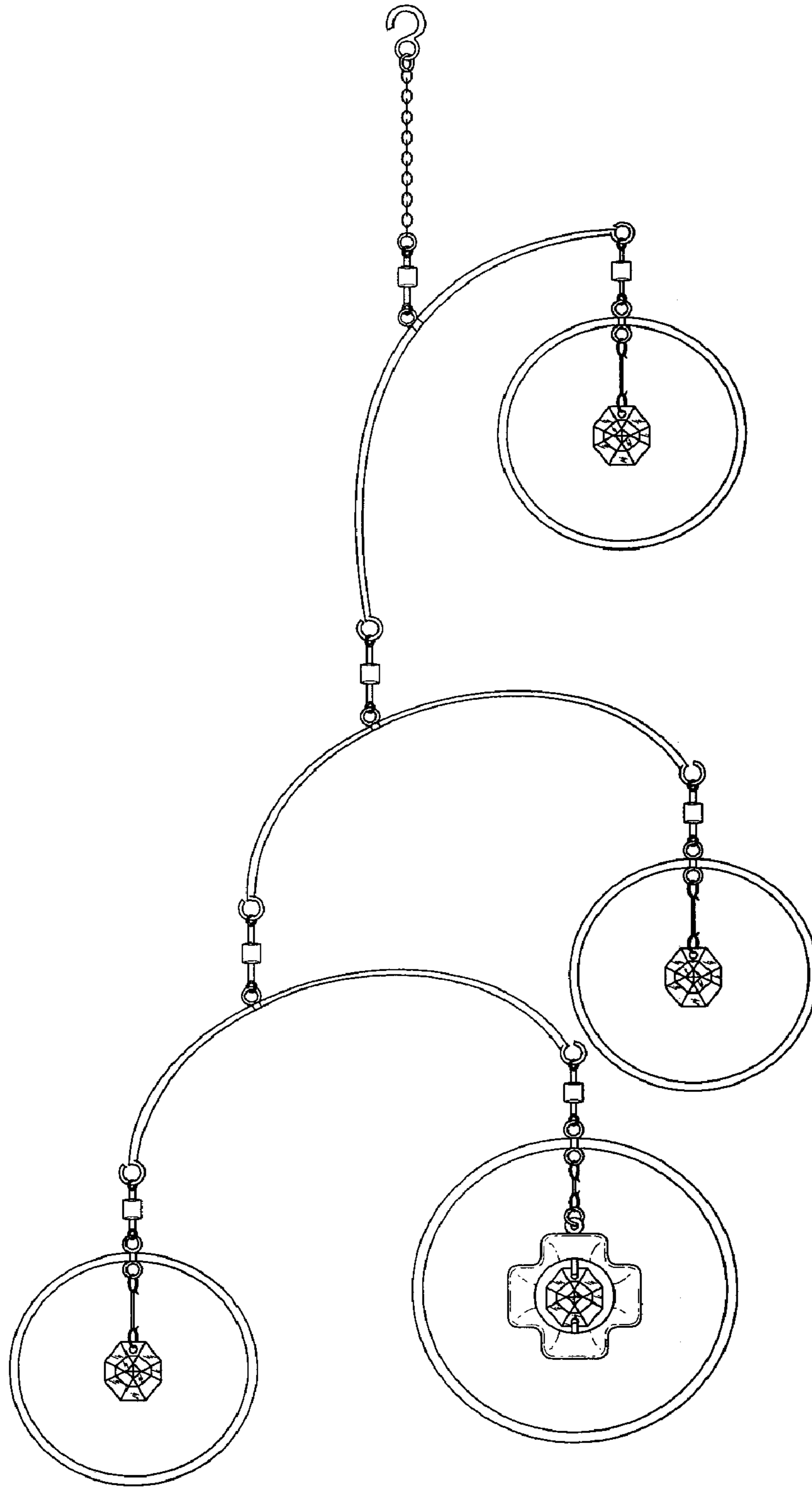

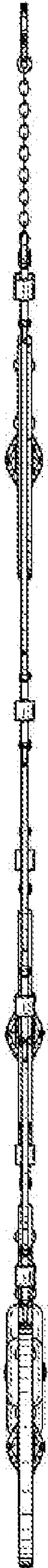

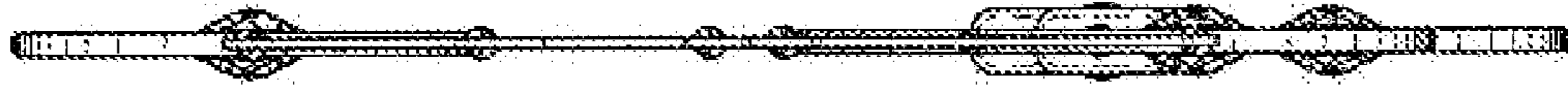

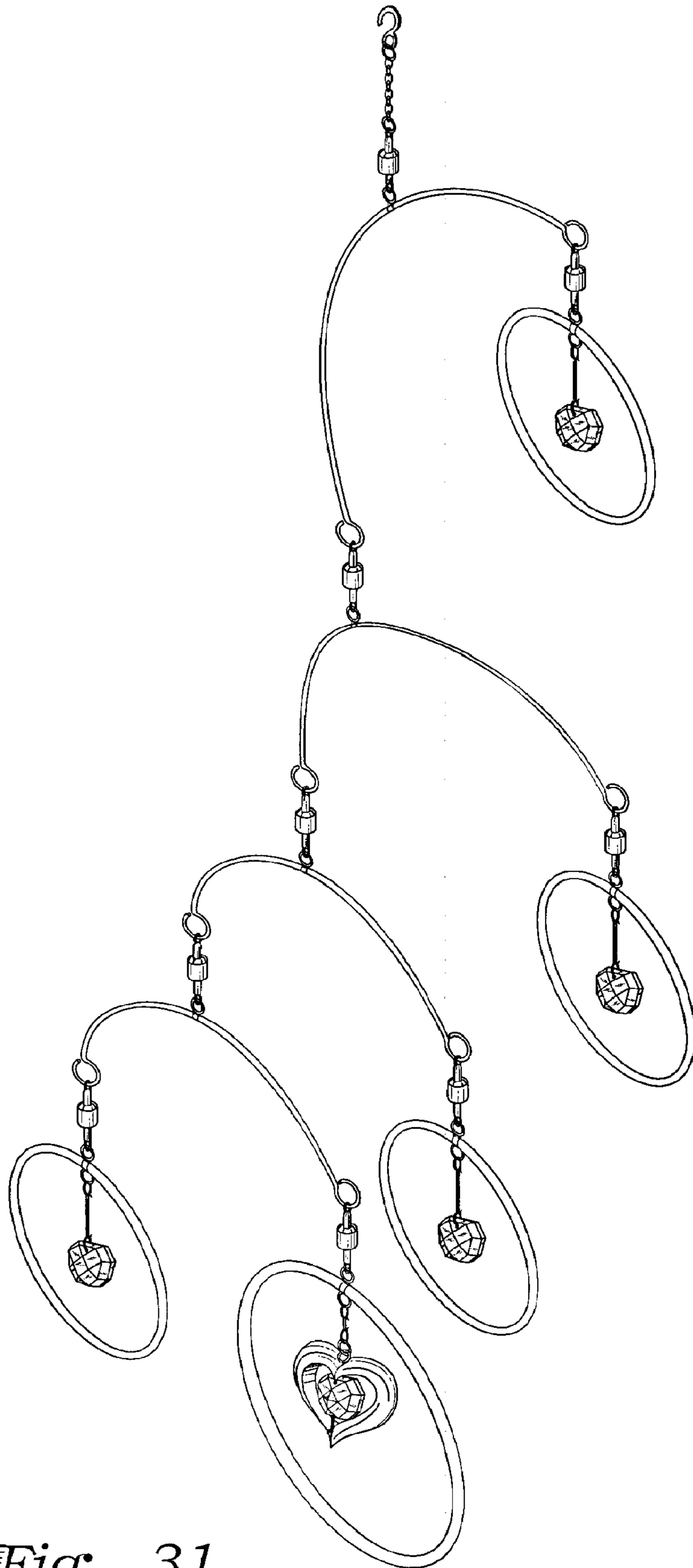

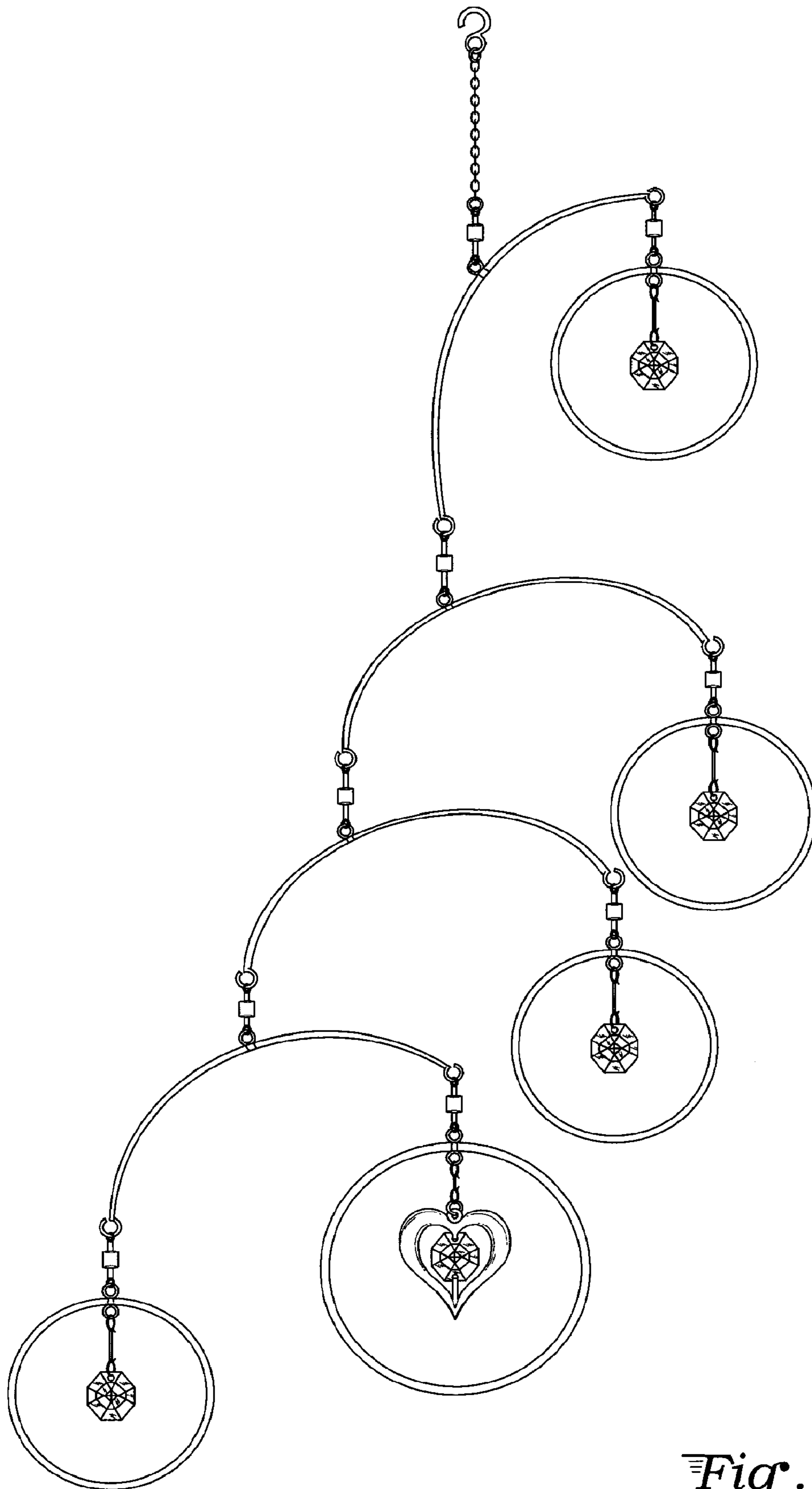

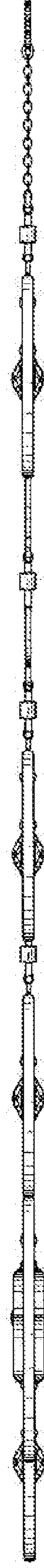

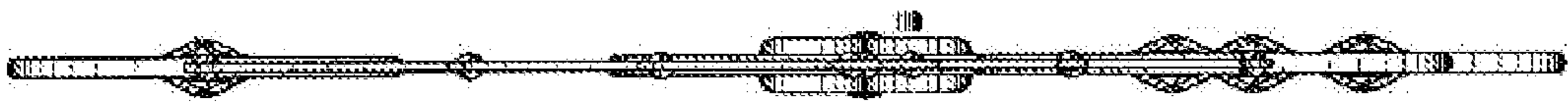

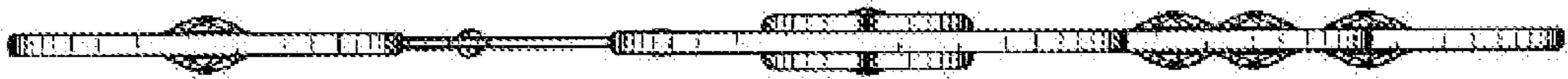
