FIG. 1 is a top plan view of a pick bolster showing our new design.

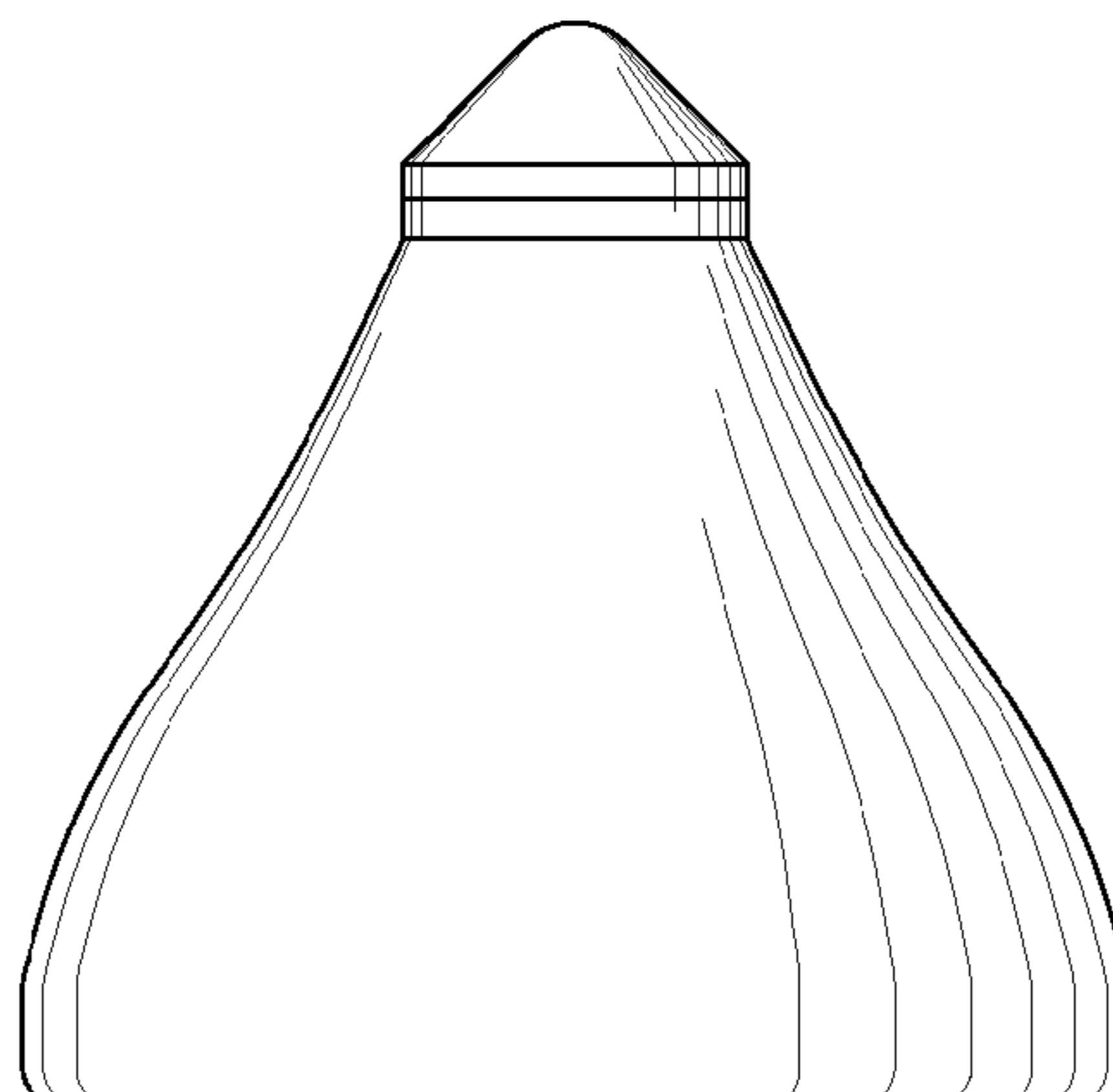
FIG. 2 is a bottom plan view thereof.

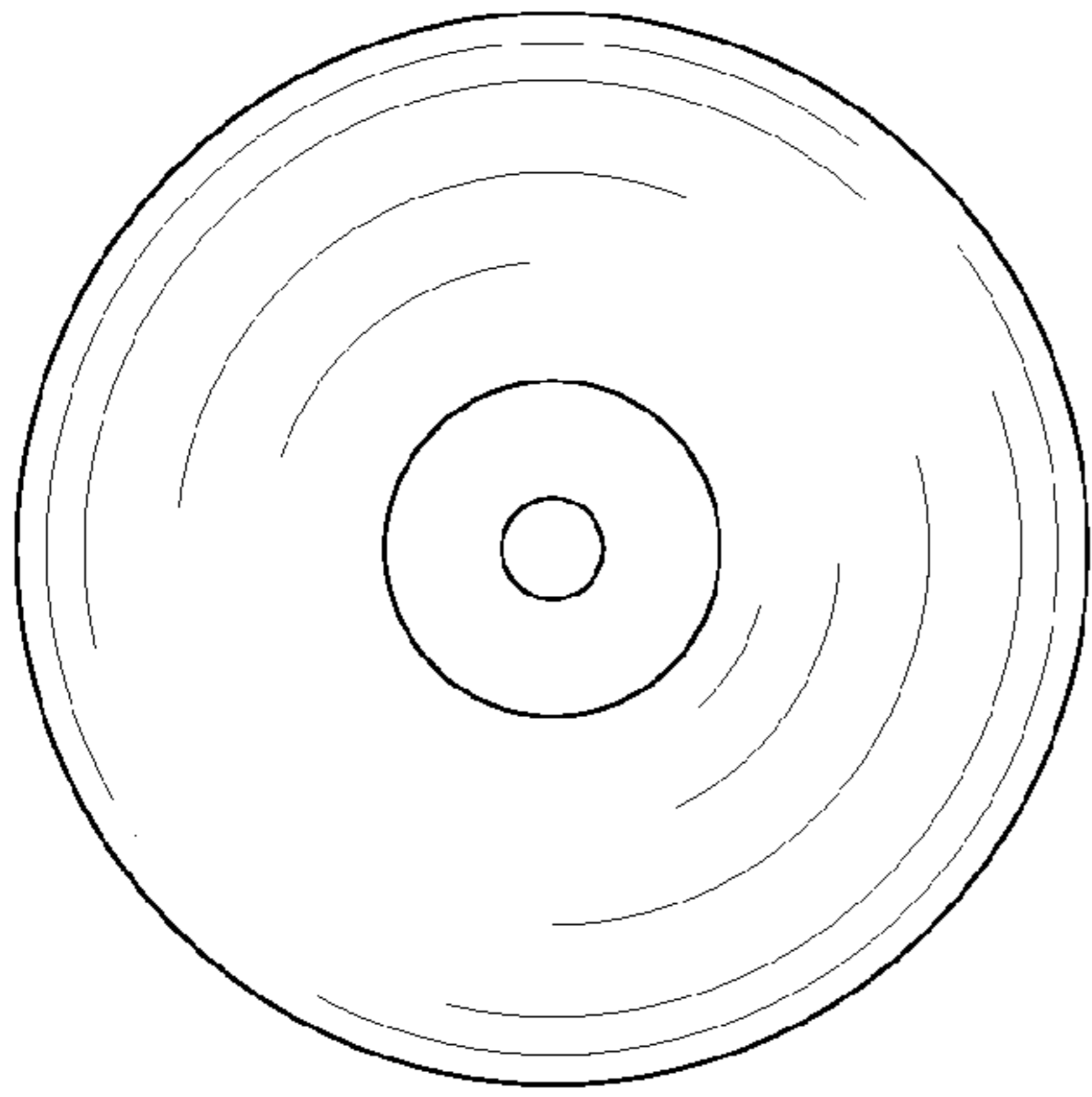

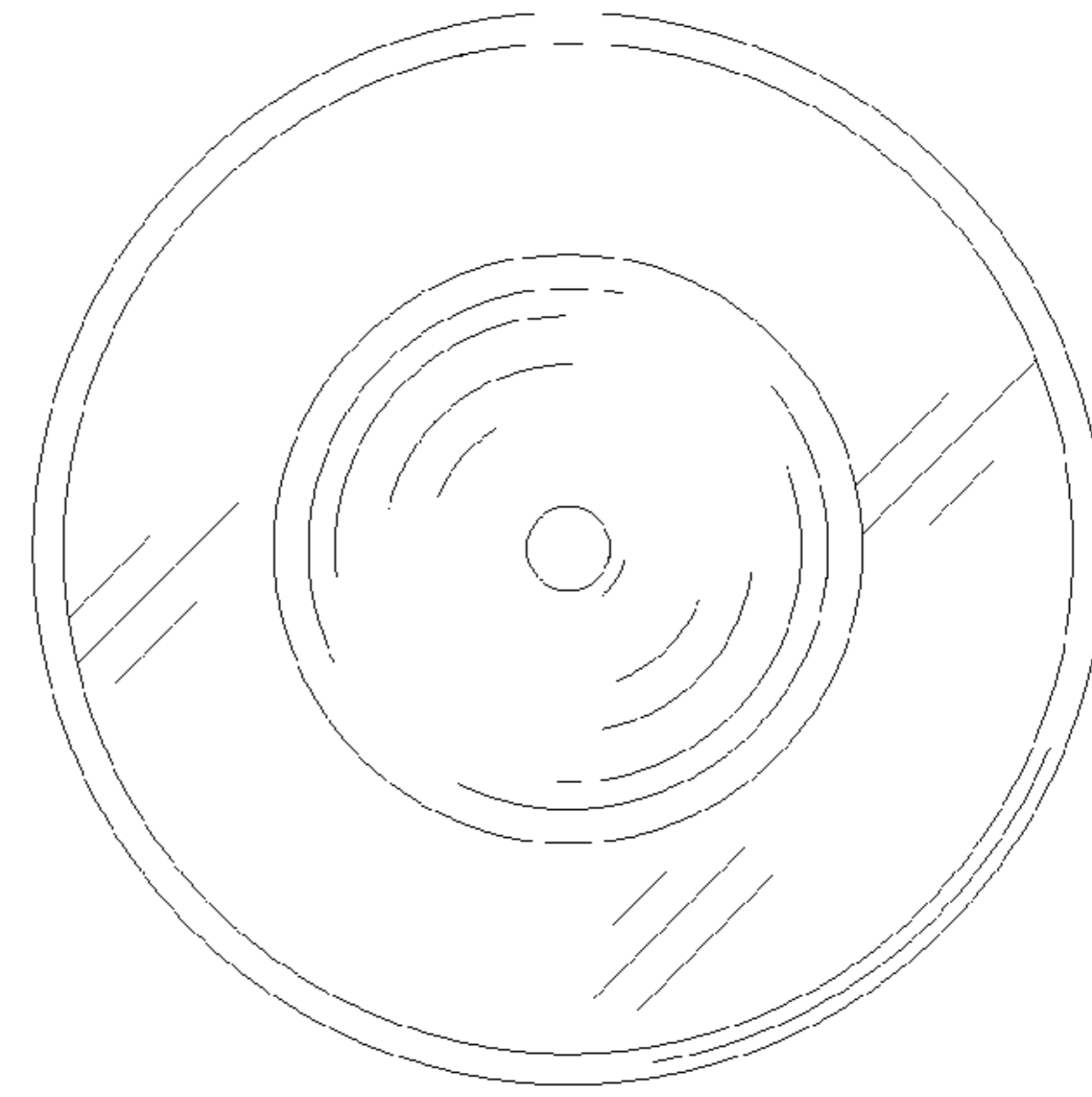

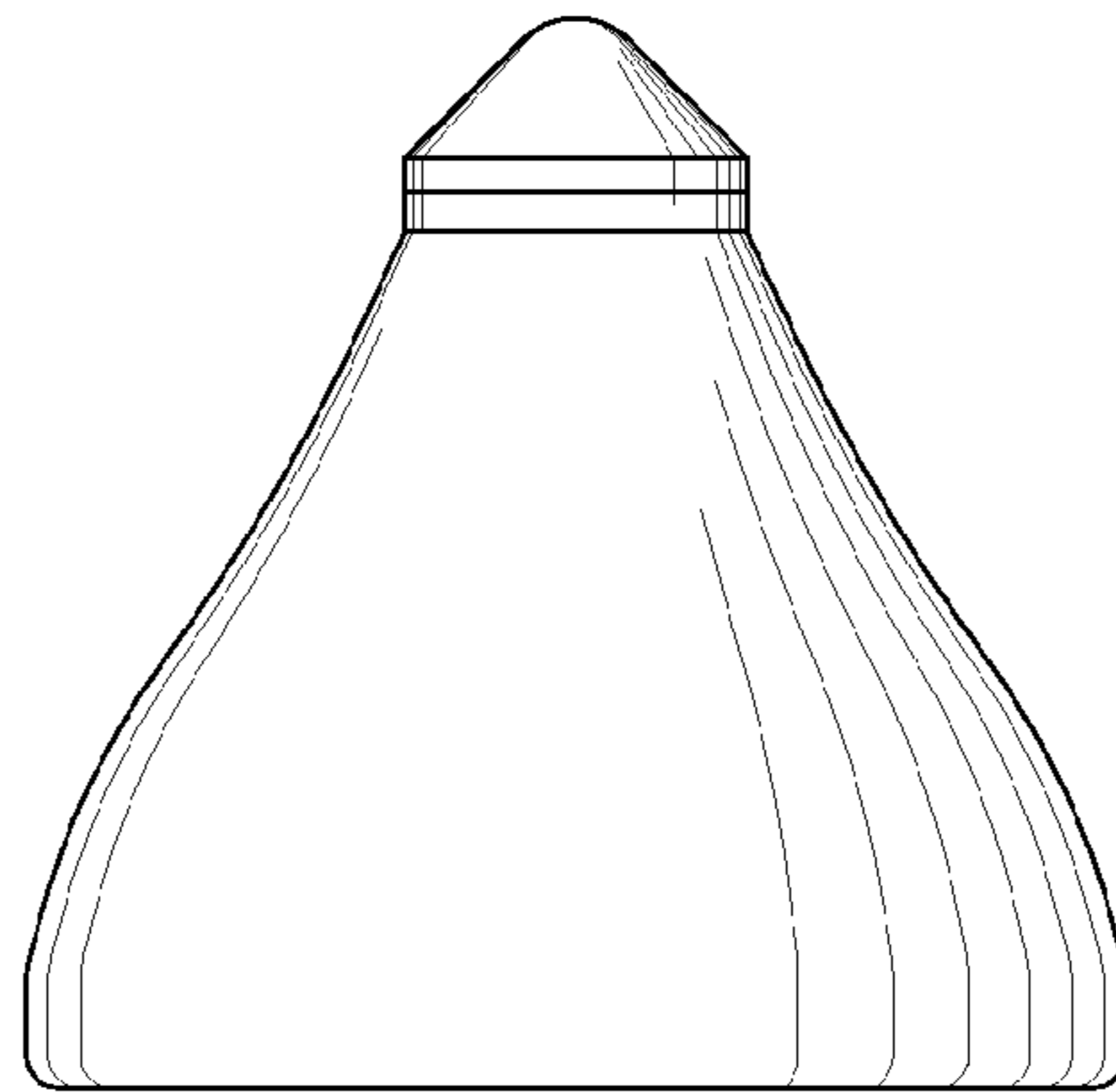

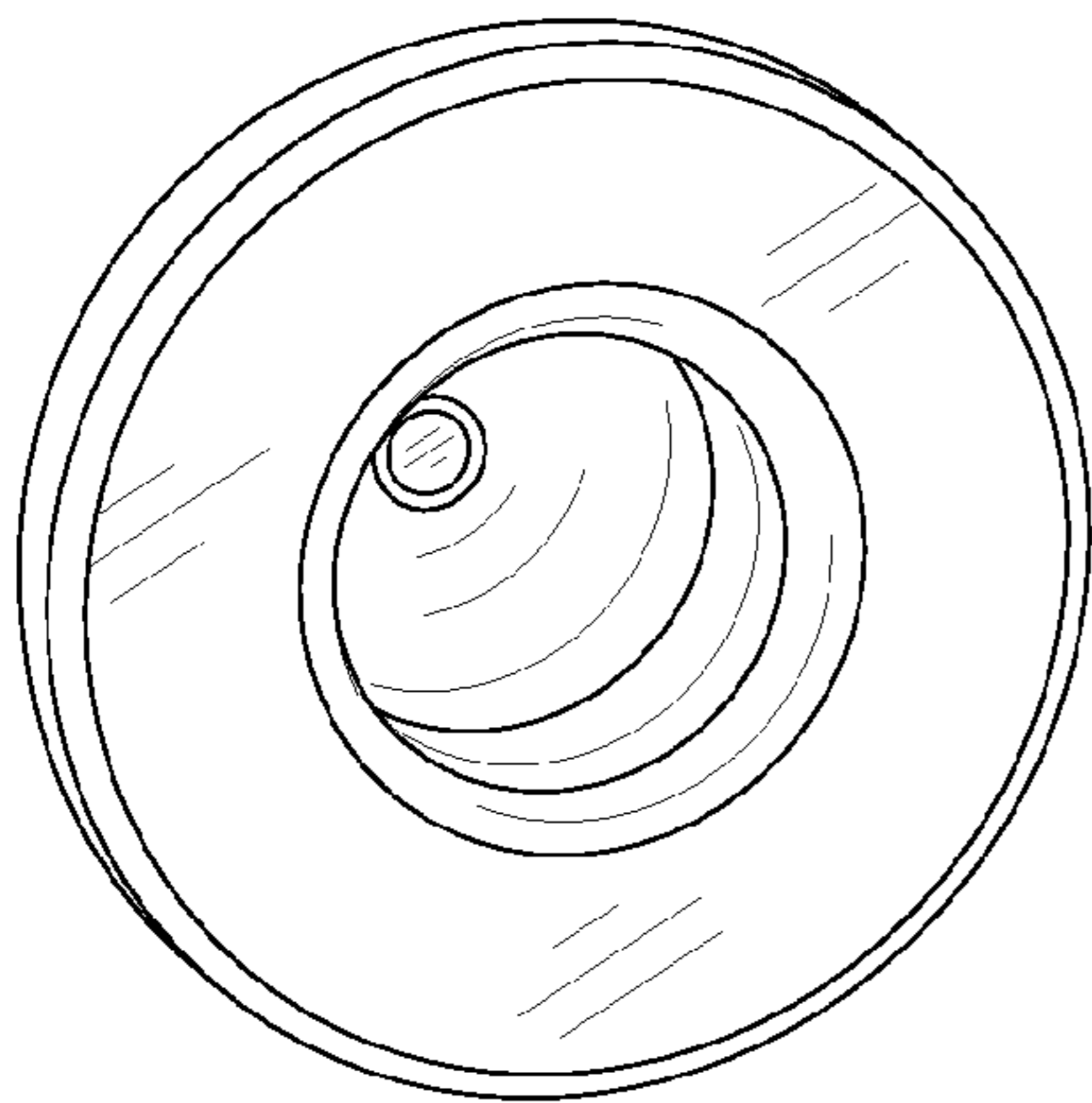

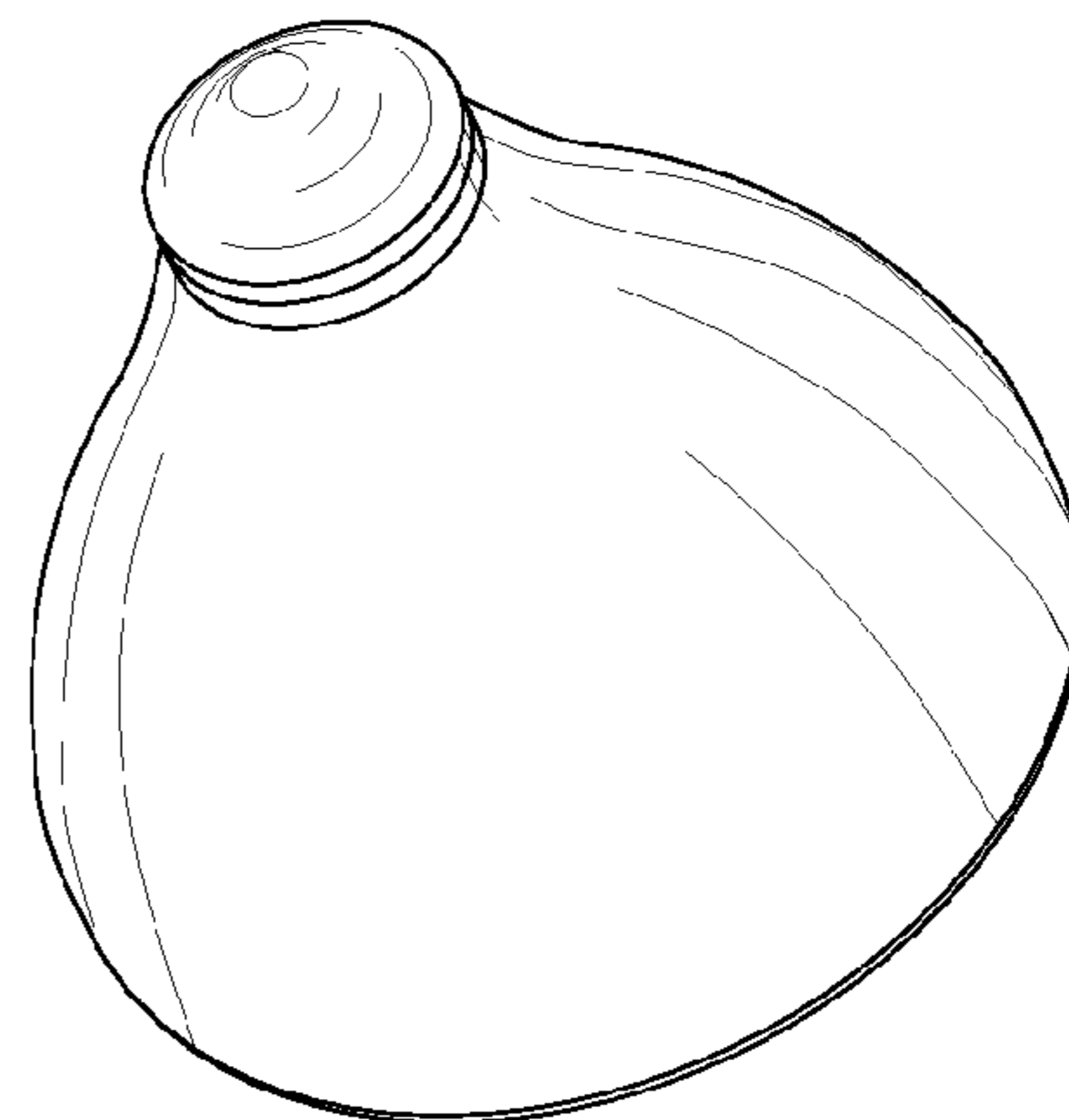
