(57) **CLAIM**

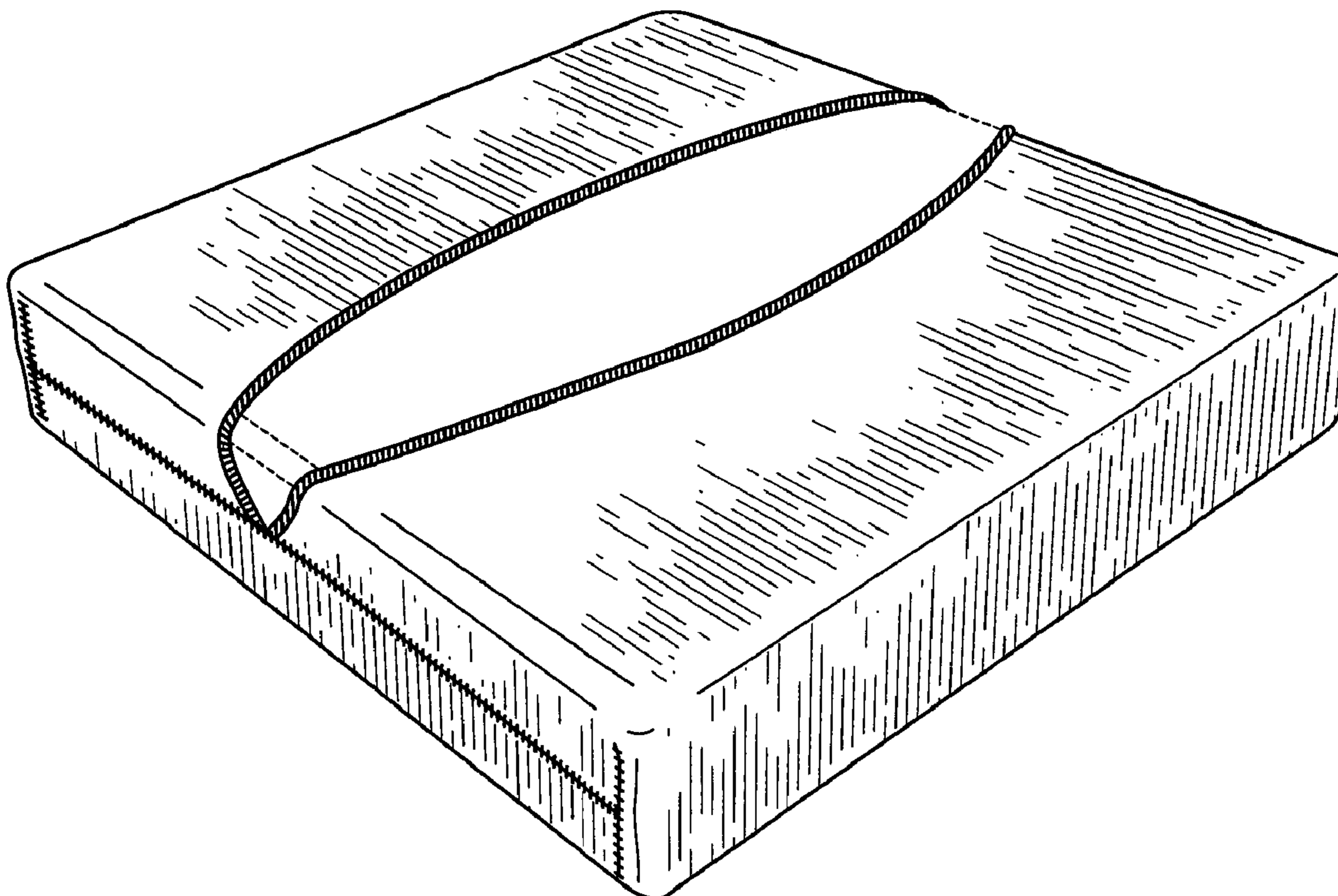
The ornamental design for a cover for binder, book, or publication, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a cover embodying our new design shown upon a binder.
FIG. 2 is a front elevational view thereof.
FIG. 3 is a back elevational view thereof.
FIG. 4 is a right side elevational view thereof, the left side elevational view being the mirror image thereof; and,
FIG. 5 is a top plan view thereof, the bottom plan view being the mirror image thereof.

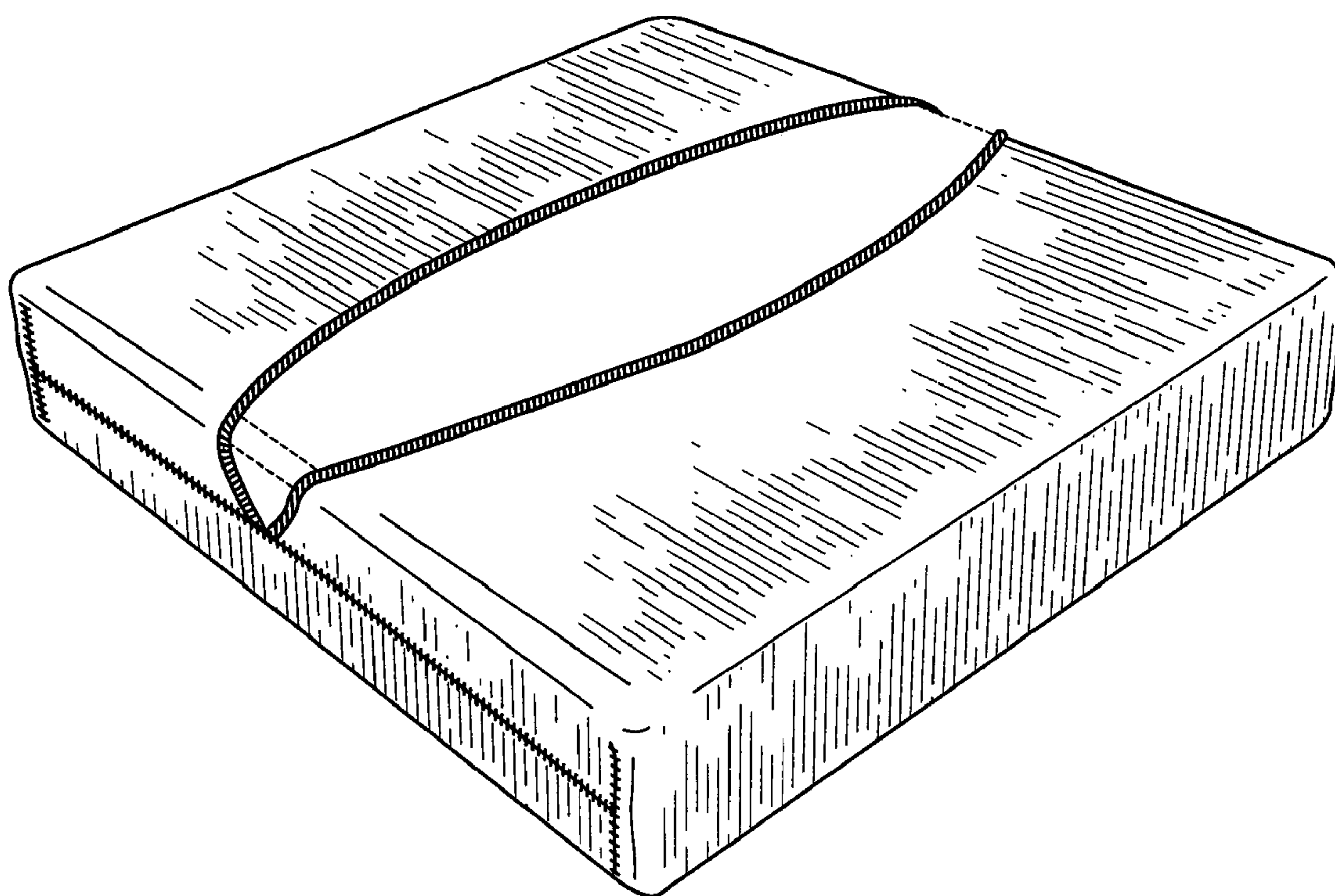

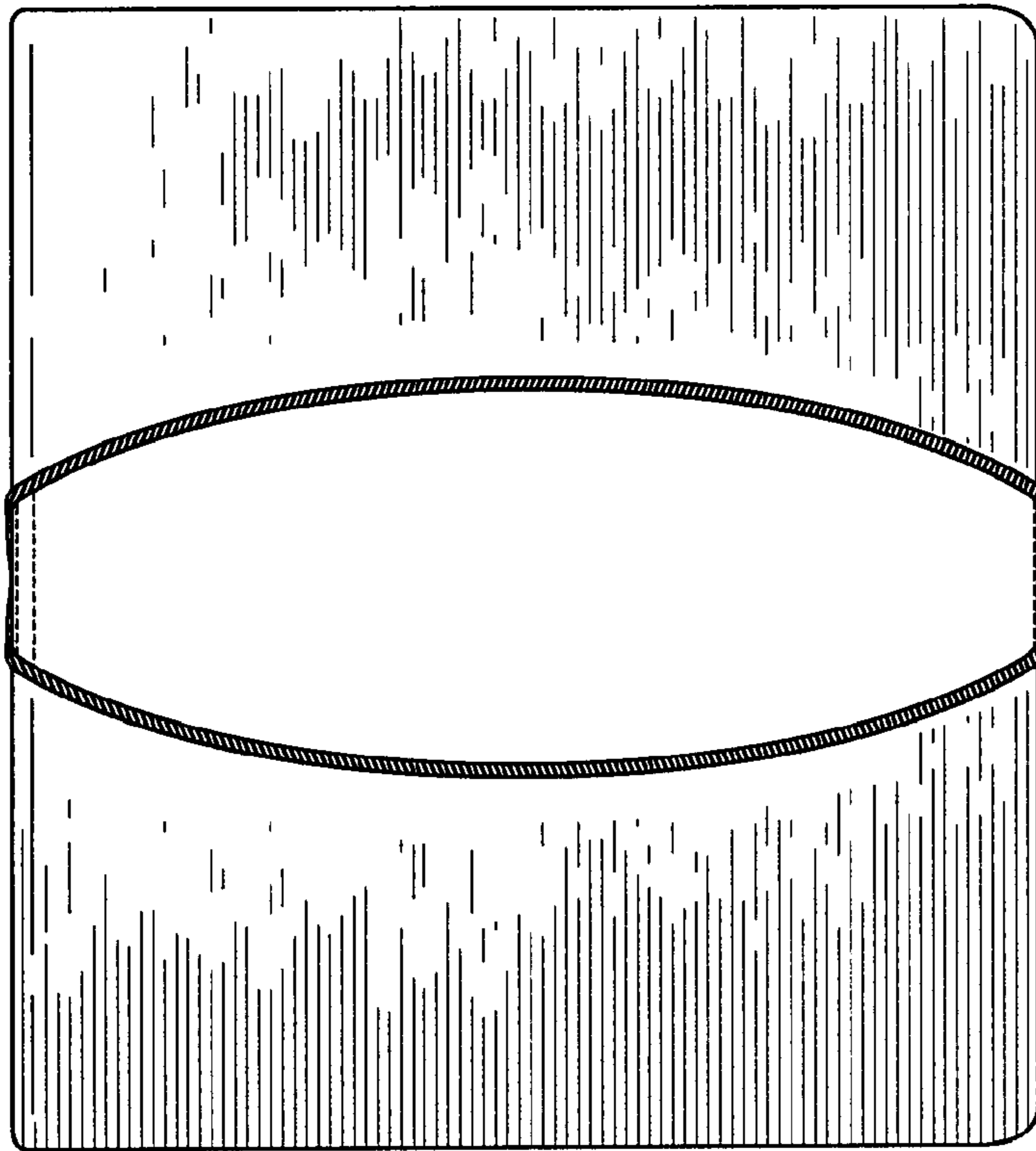

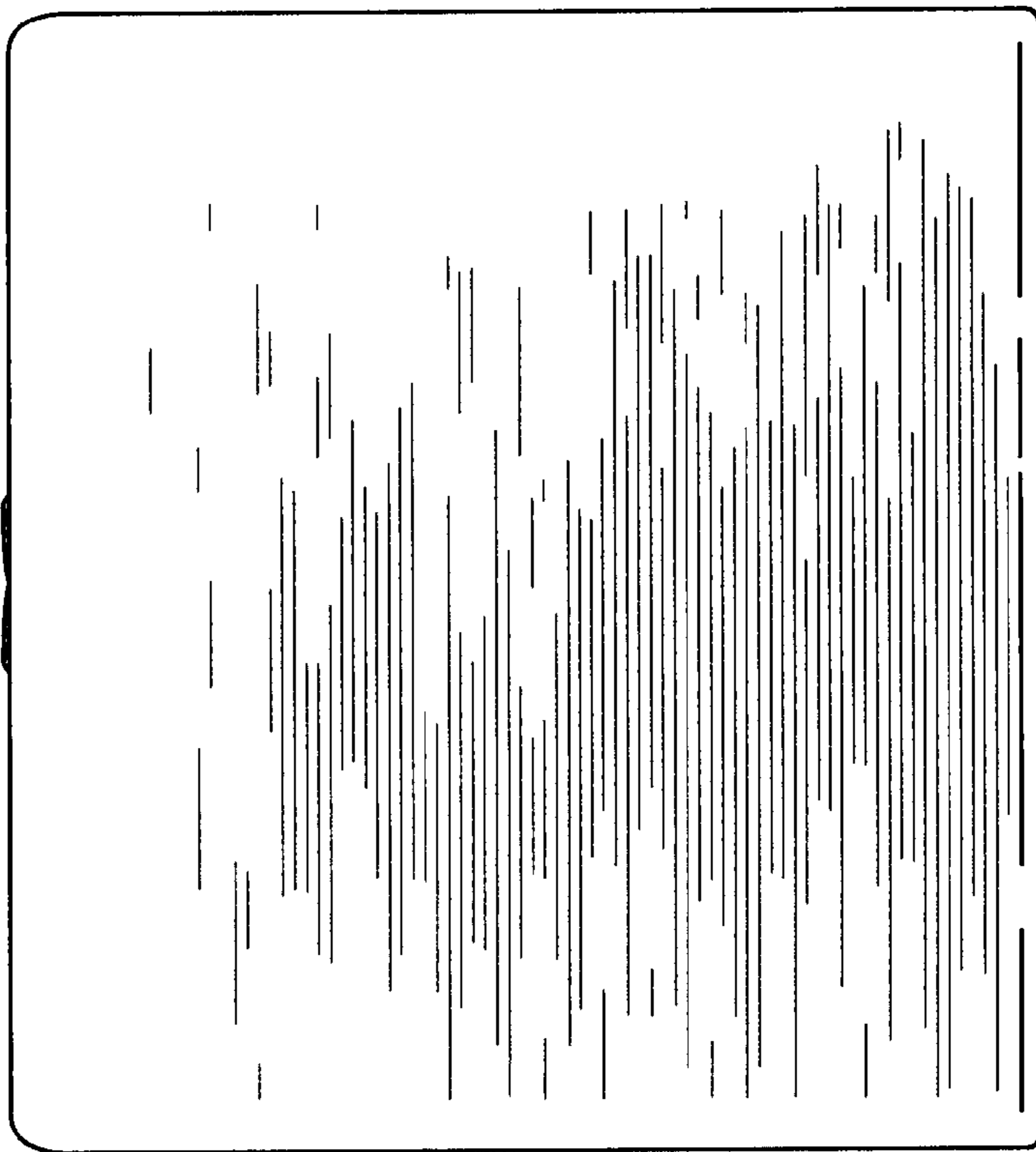

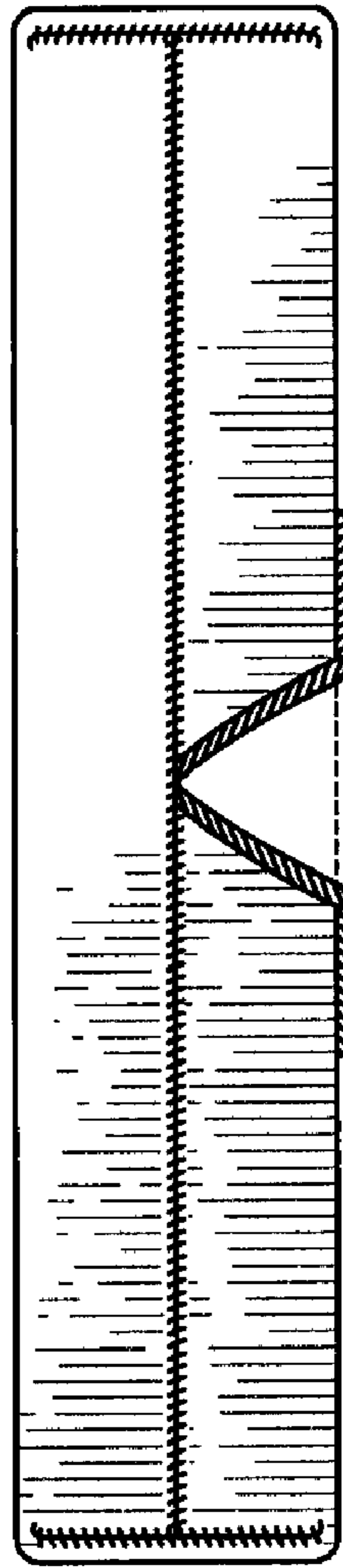

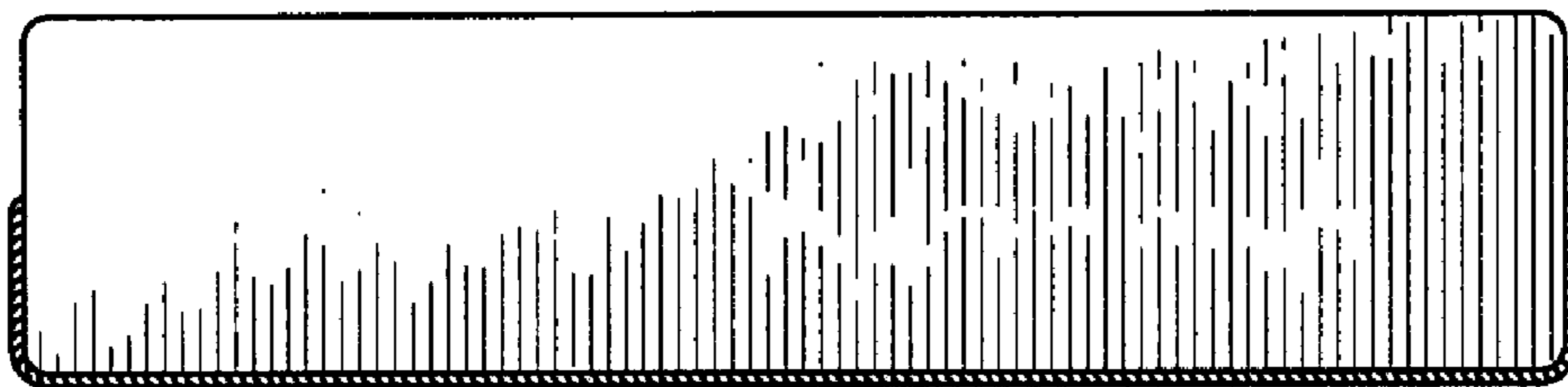
