The ornamental design for a gaming machine, as shown.

DESCRIPTION

A gaming machine embodying the ornamental design disclosed herein is intended to be mounted on a pedestal and used by a player to participate in wagering or other games.

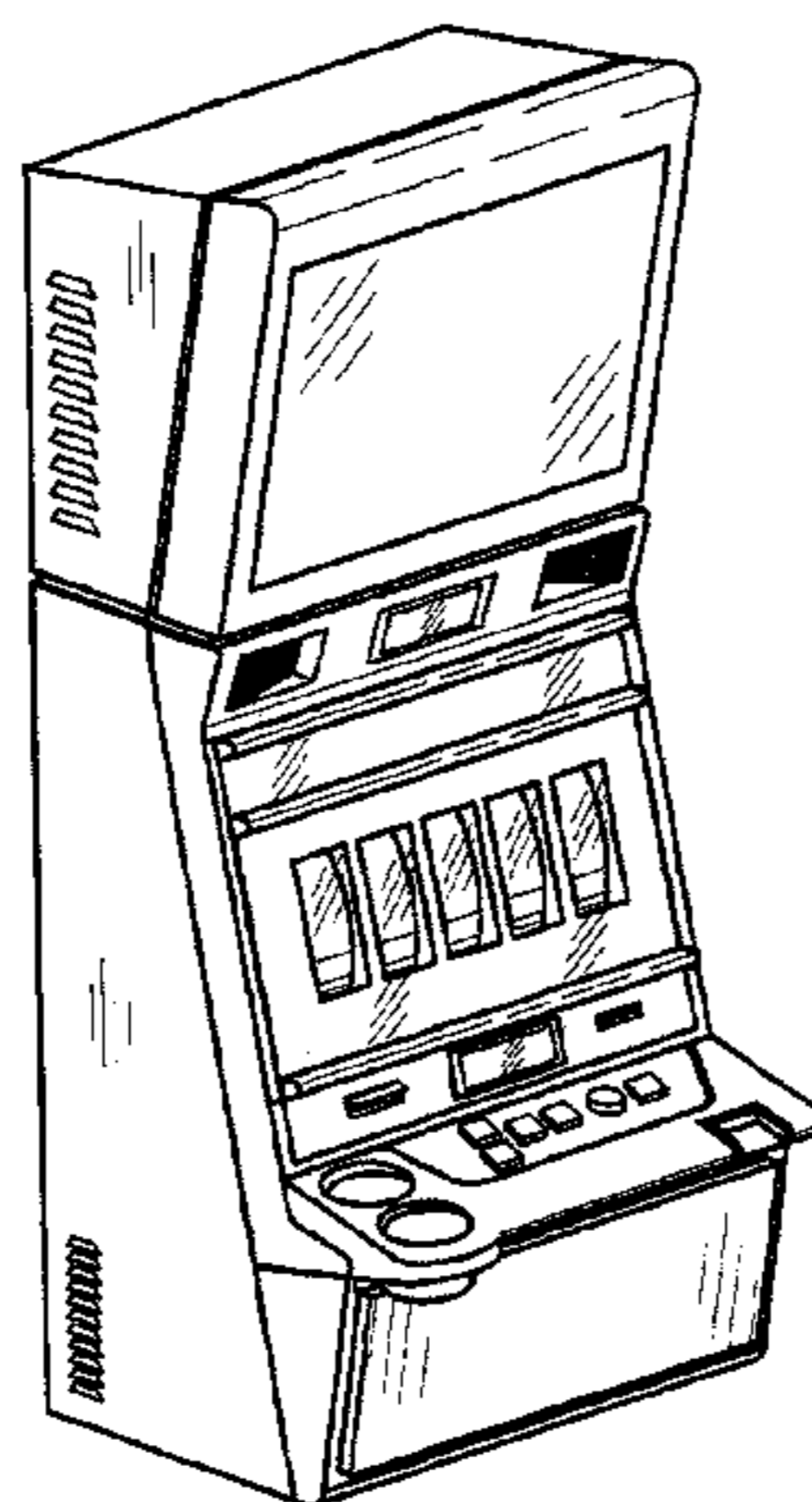
FIG. 1 is a left perspective view of a gaming machine embodying the ornamental design according to the present invention.

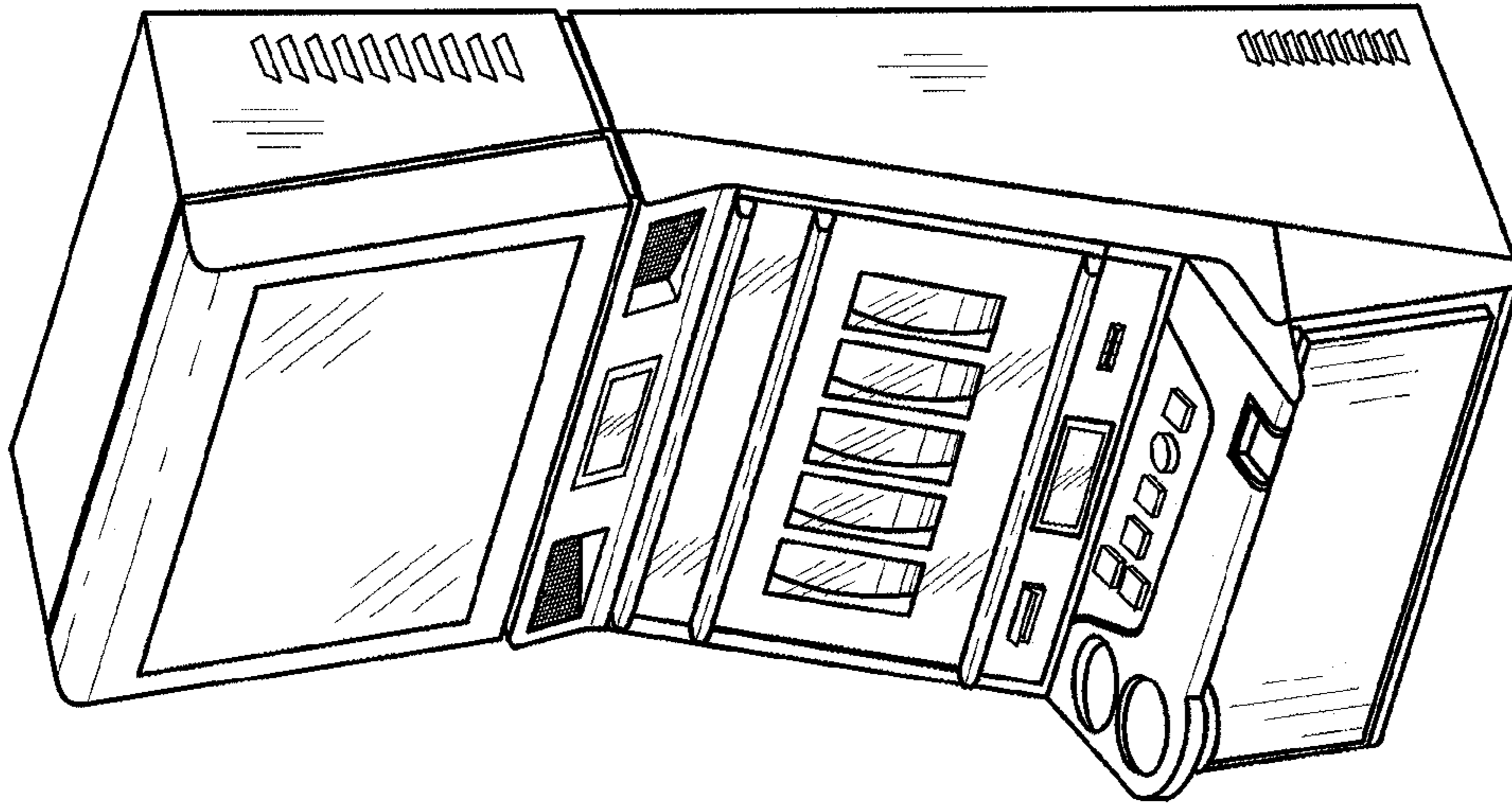

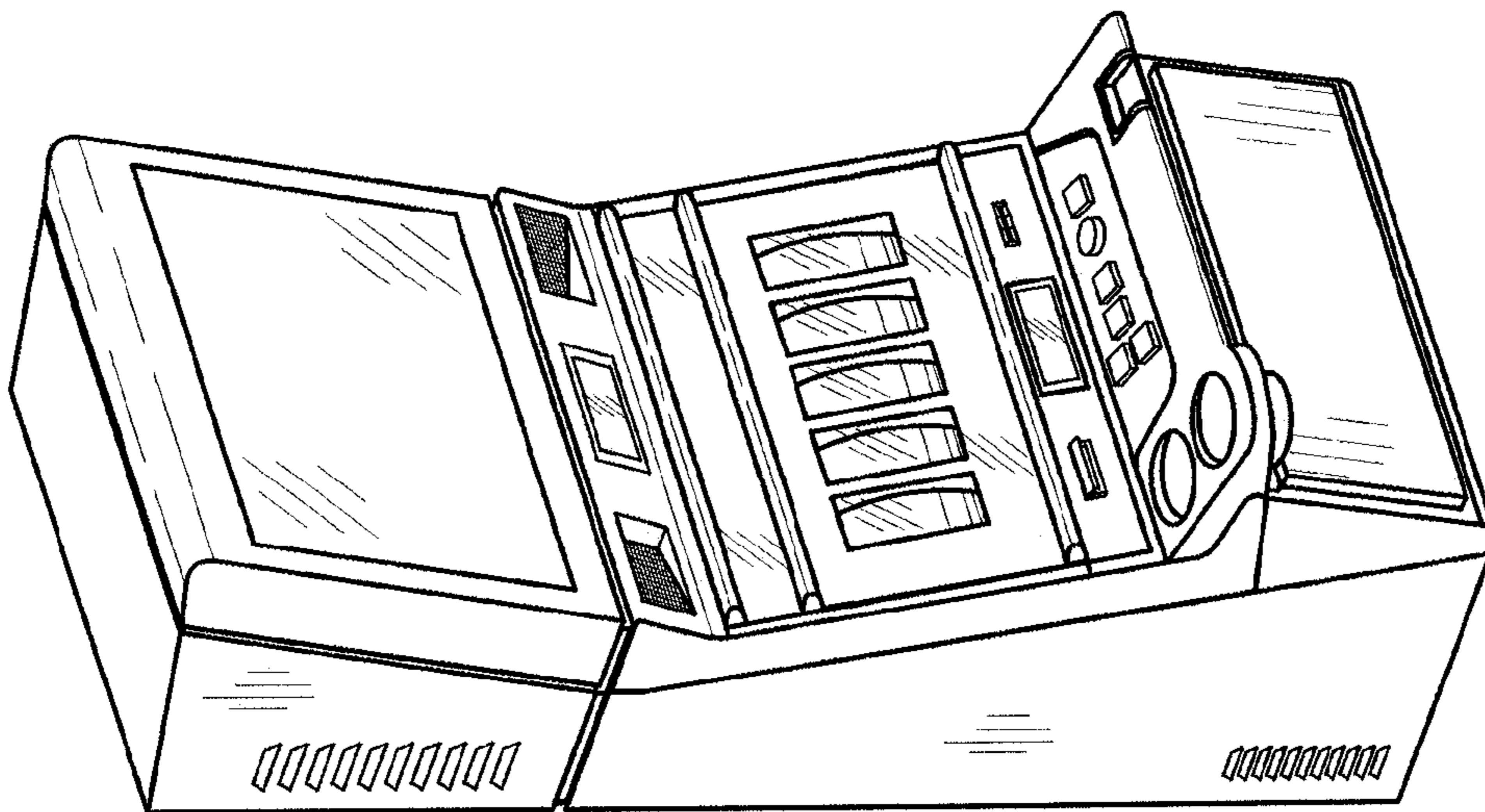

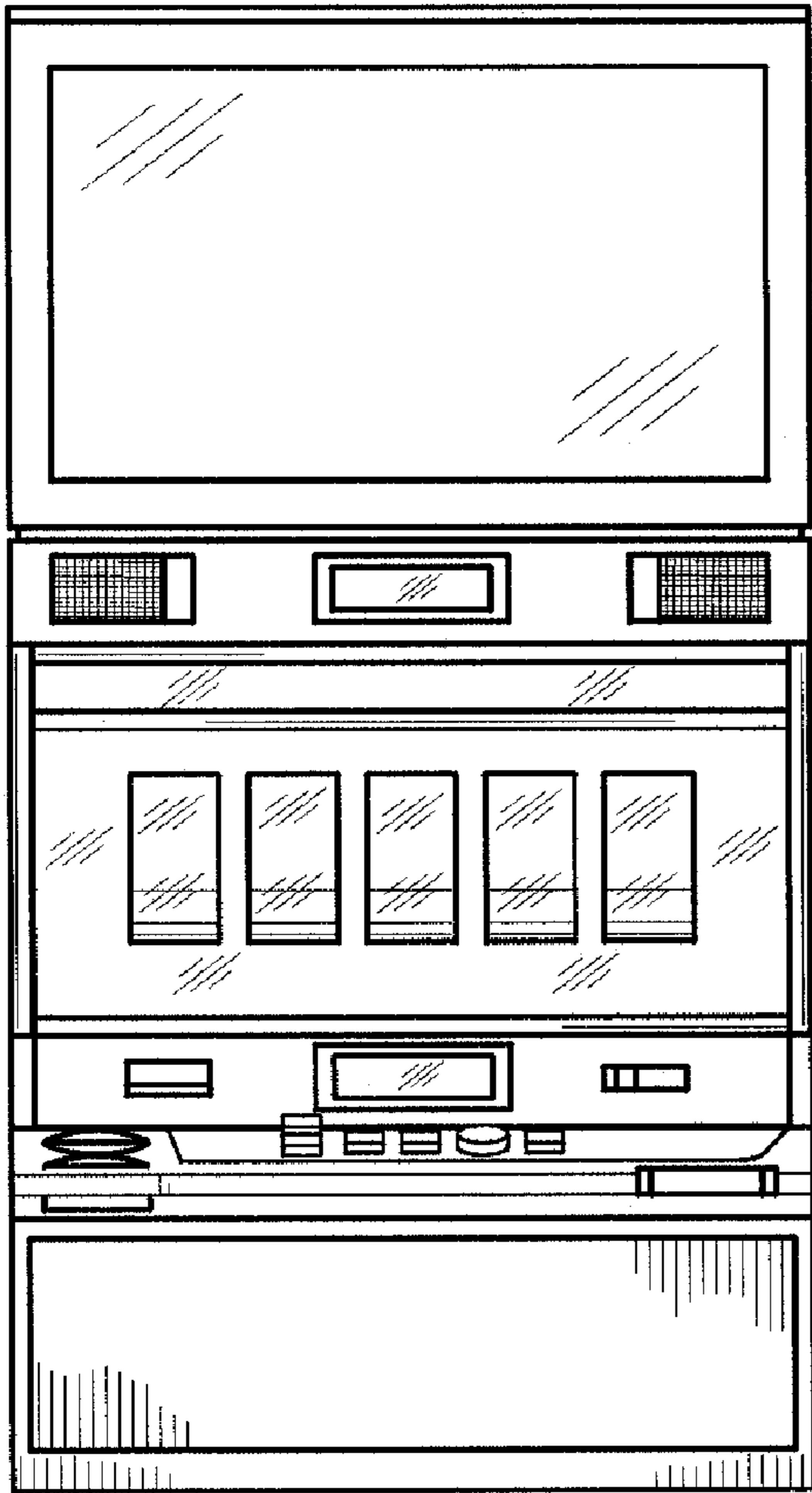

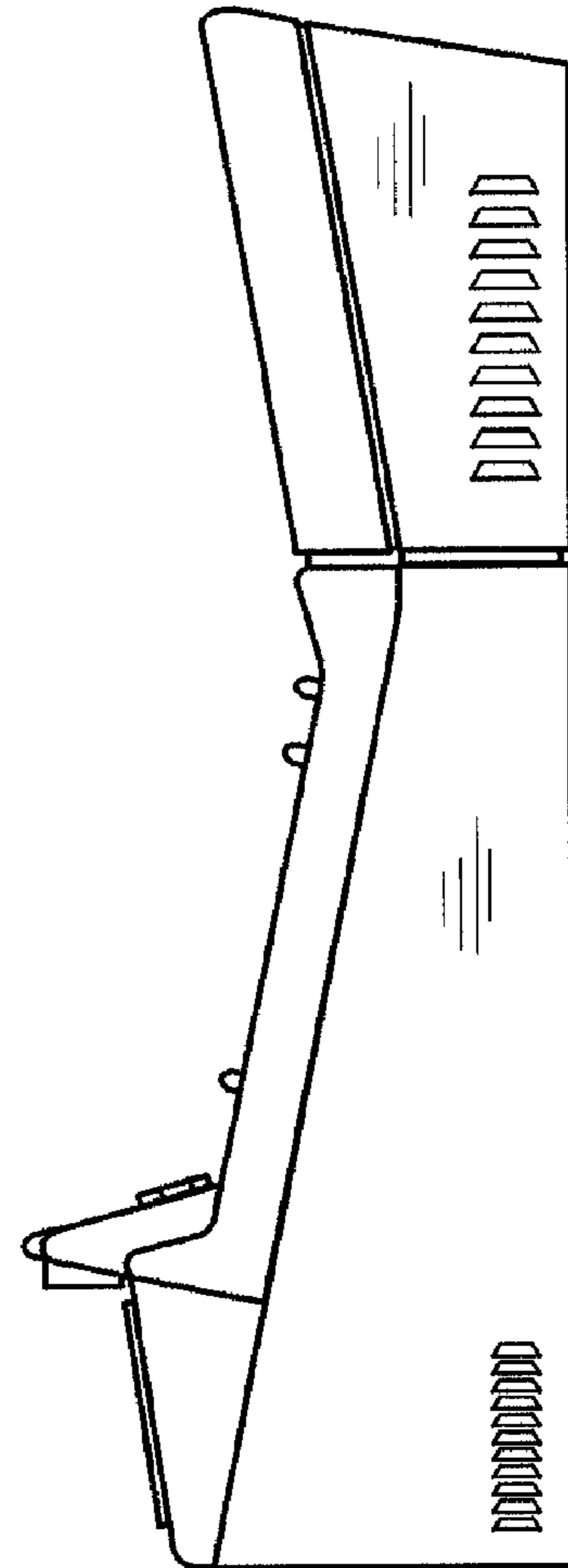
