(57) **CLAIM**

The ornamental design for a handle, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is a handle for a plumbing fixture such as a shower water control or a faucet.

FIG. 1 is a left, top, front perspective view of a handle embodying our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof; and,

FIG. 6 is a bottom plan view thereof.

The broken line representation of an opening in FIG. 6 is for the purpose of illustration only, and forms no part of the claimed design.

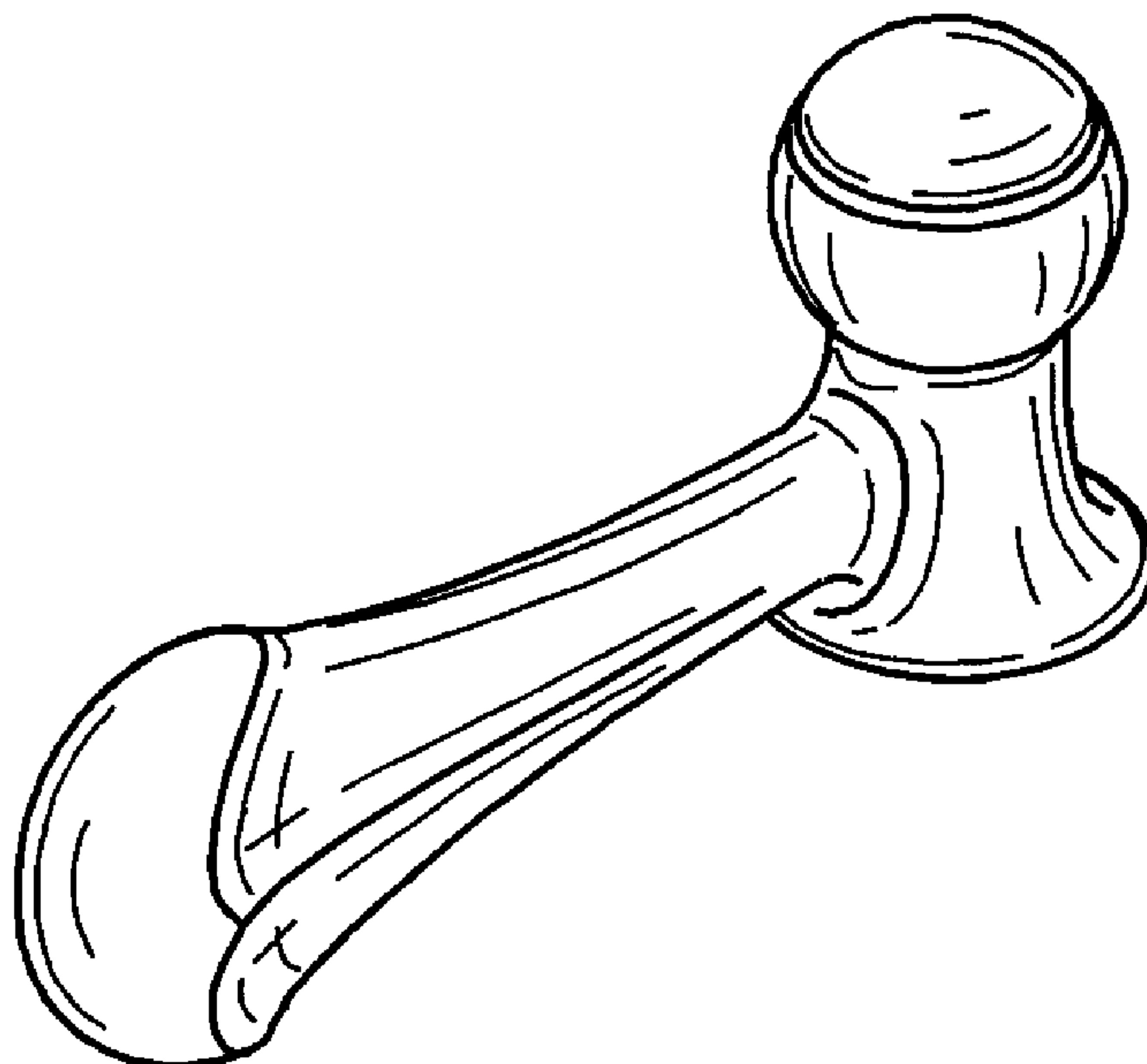

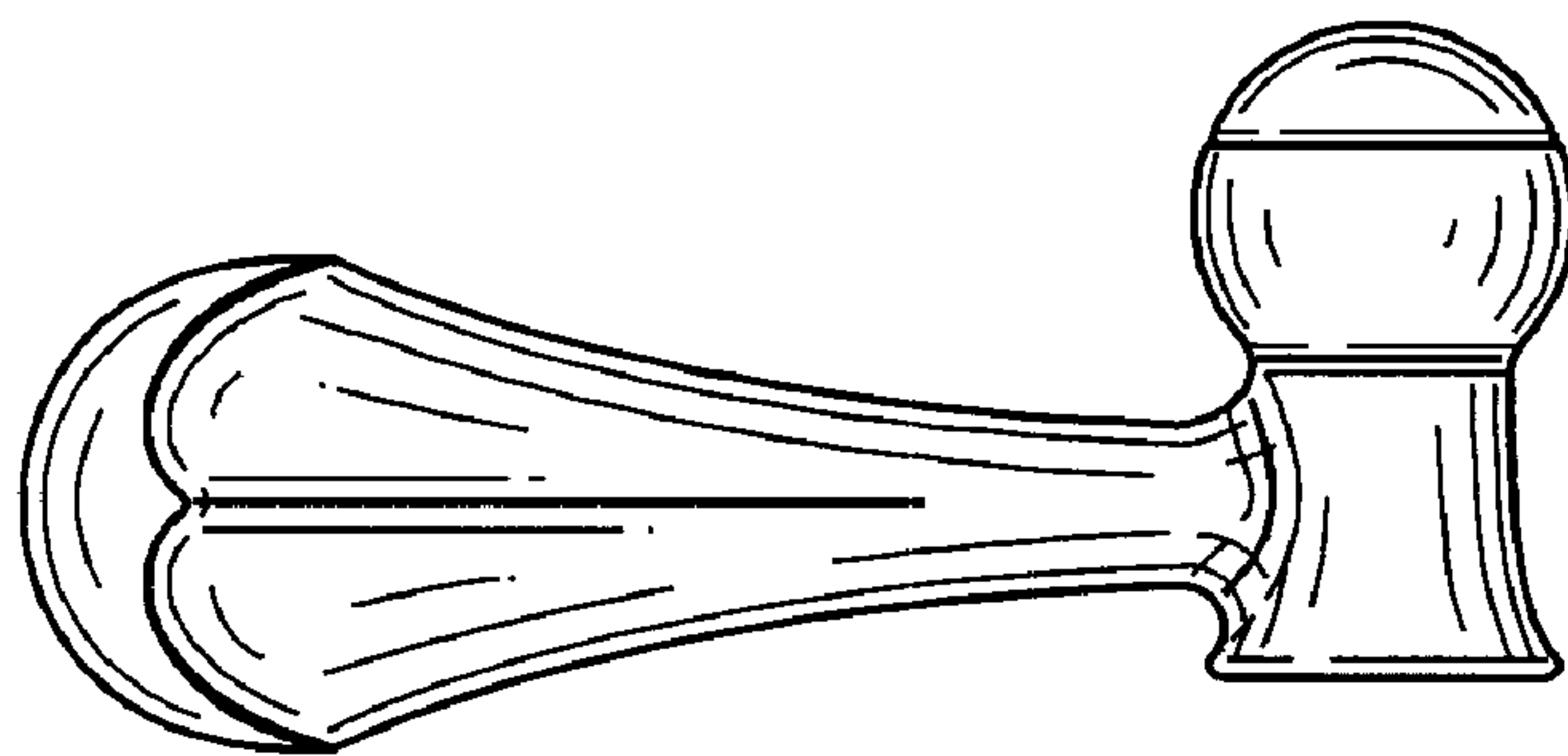
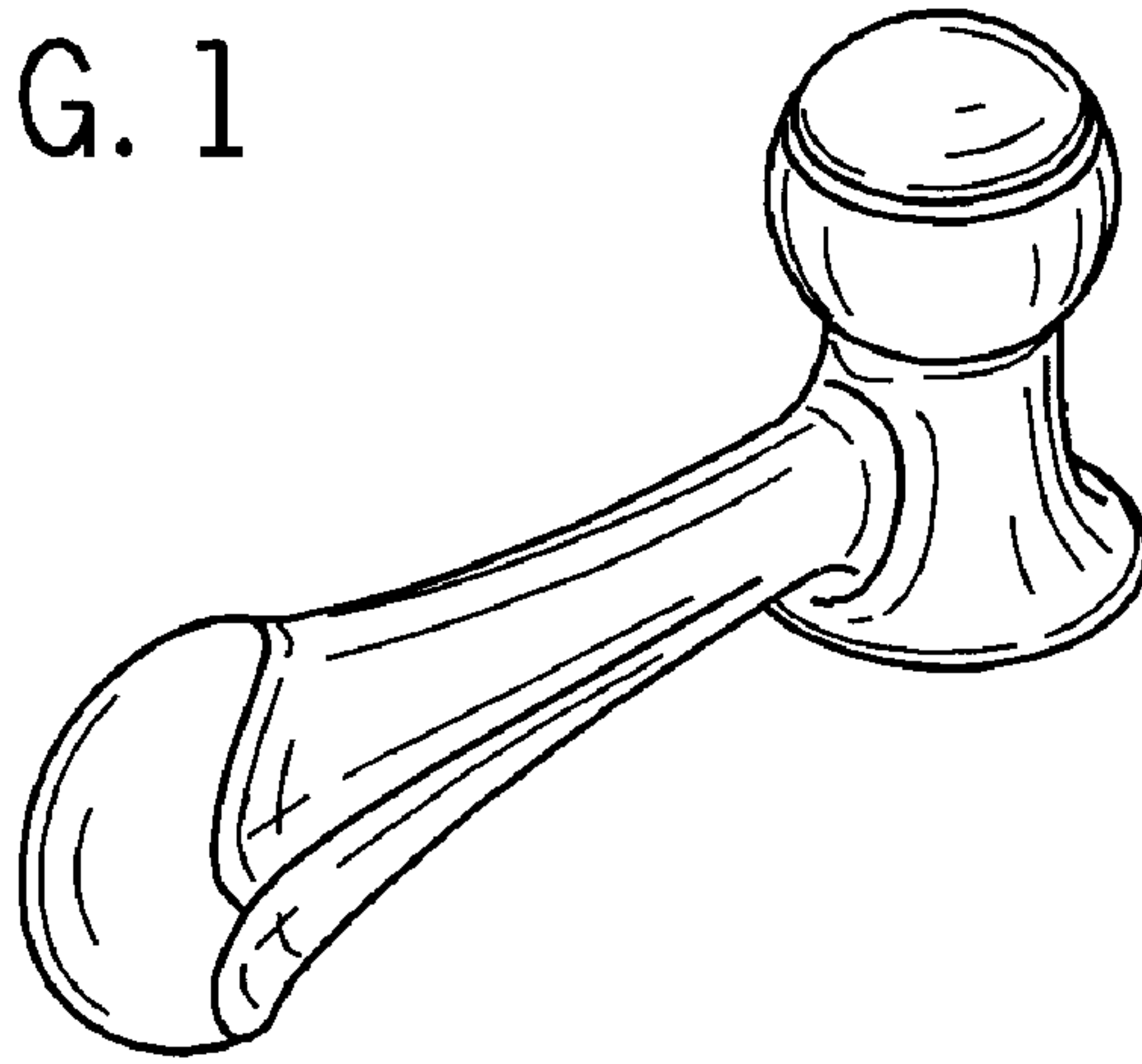

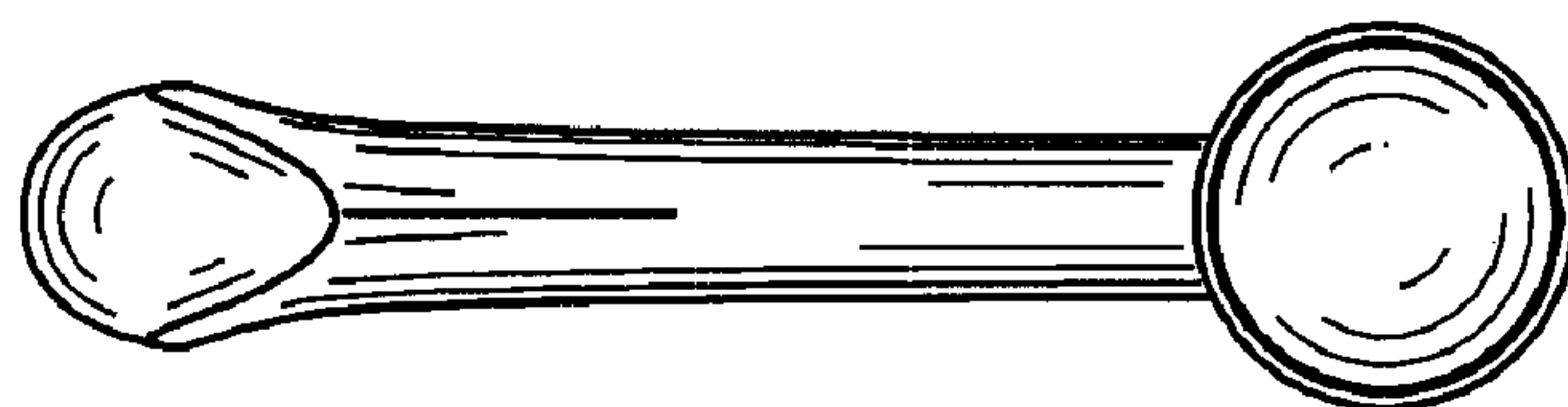

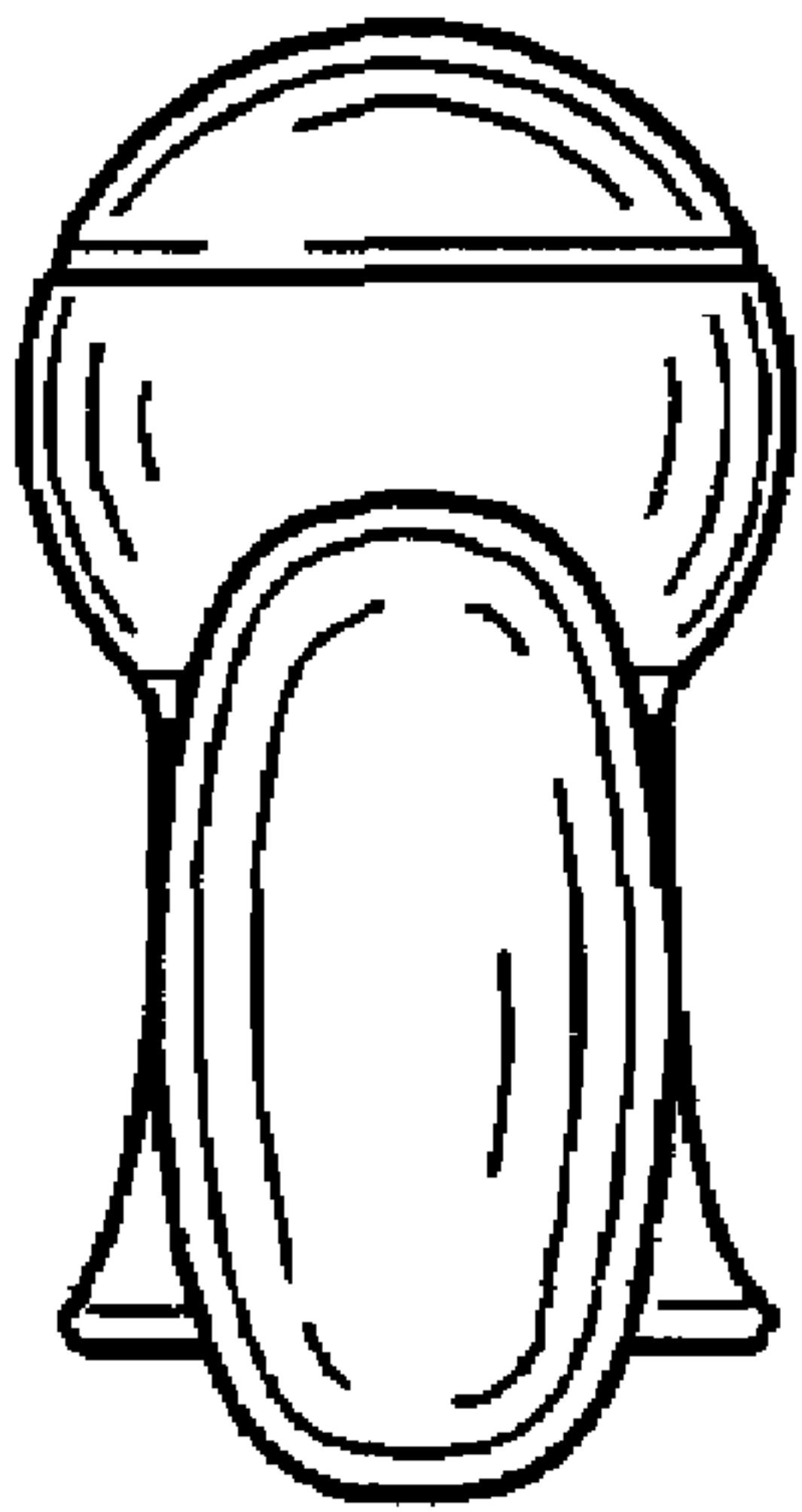

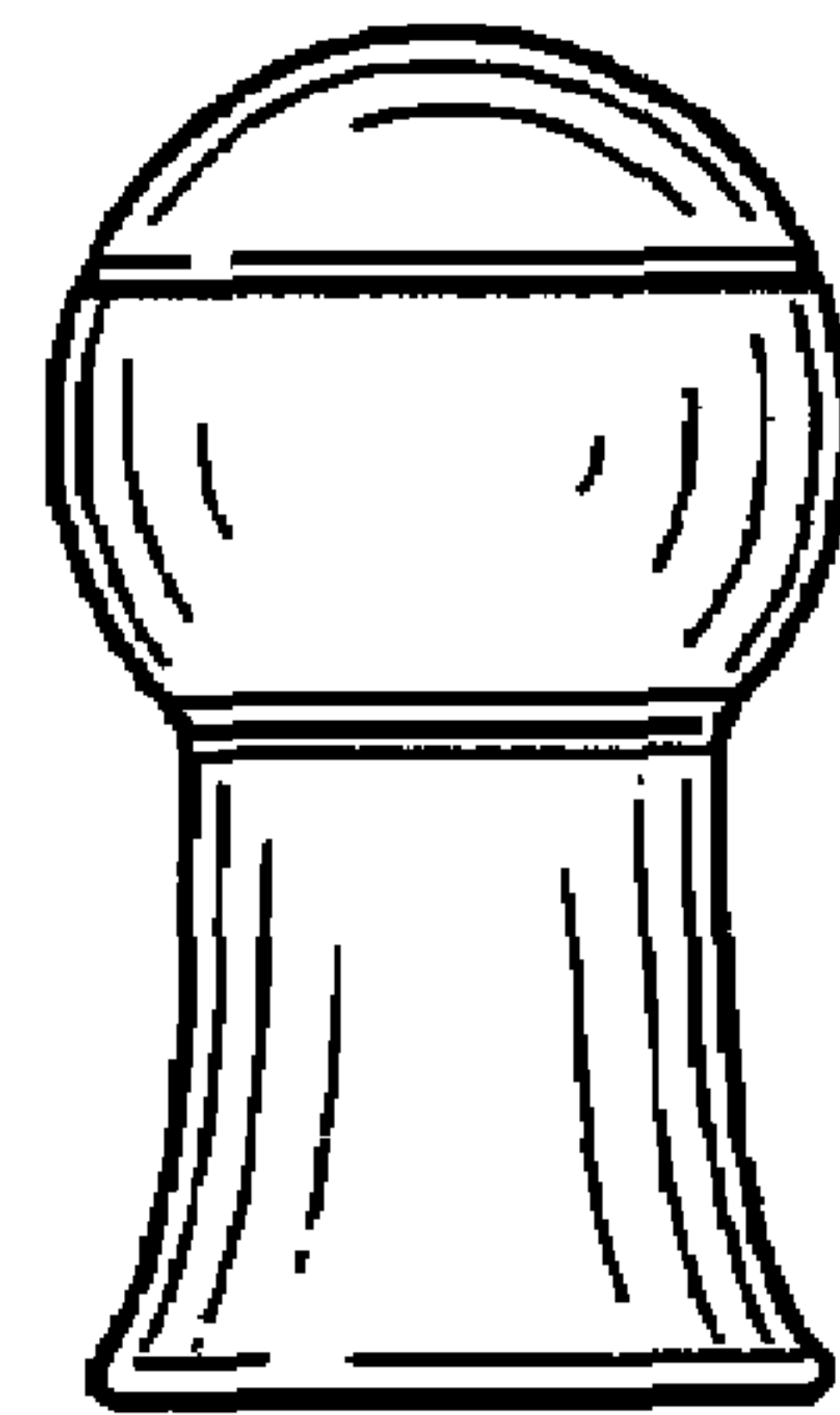

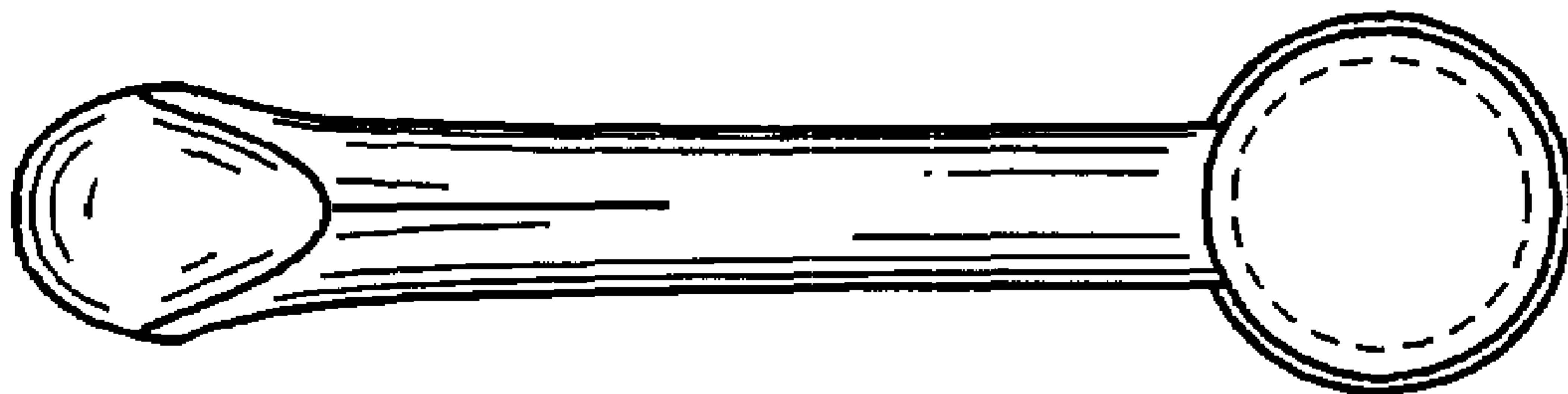
