(57) **CLAIM**

We claim the ornamental design for a handheld vascular compression device, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a first embodiment of a handheld vascular compression device showing our new invention;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a right side elevation thereof, the left side elevation being a mirror image thereof;

FIG. 7 is an isometric view of a second embodiment of a handheld vascular compression device showing our new invention;

FIG. 8 is a top view thereof;

FIG. 9 is a bottom view thereof;

FIG. 10 is a front elevation view thereof;

FIG. 11 is a rear elevation view thereof;

FIG. 12 is a right side elevation thereof, the left side elevation being a mirror image thereof;

FIG. 13 is an isometric view of a third embodiment of a handheld vascular compression device showing our new invention;

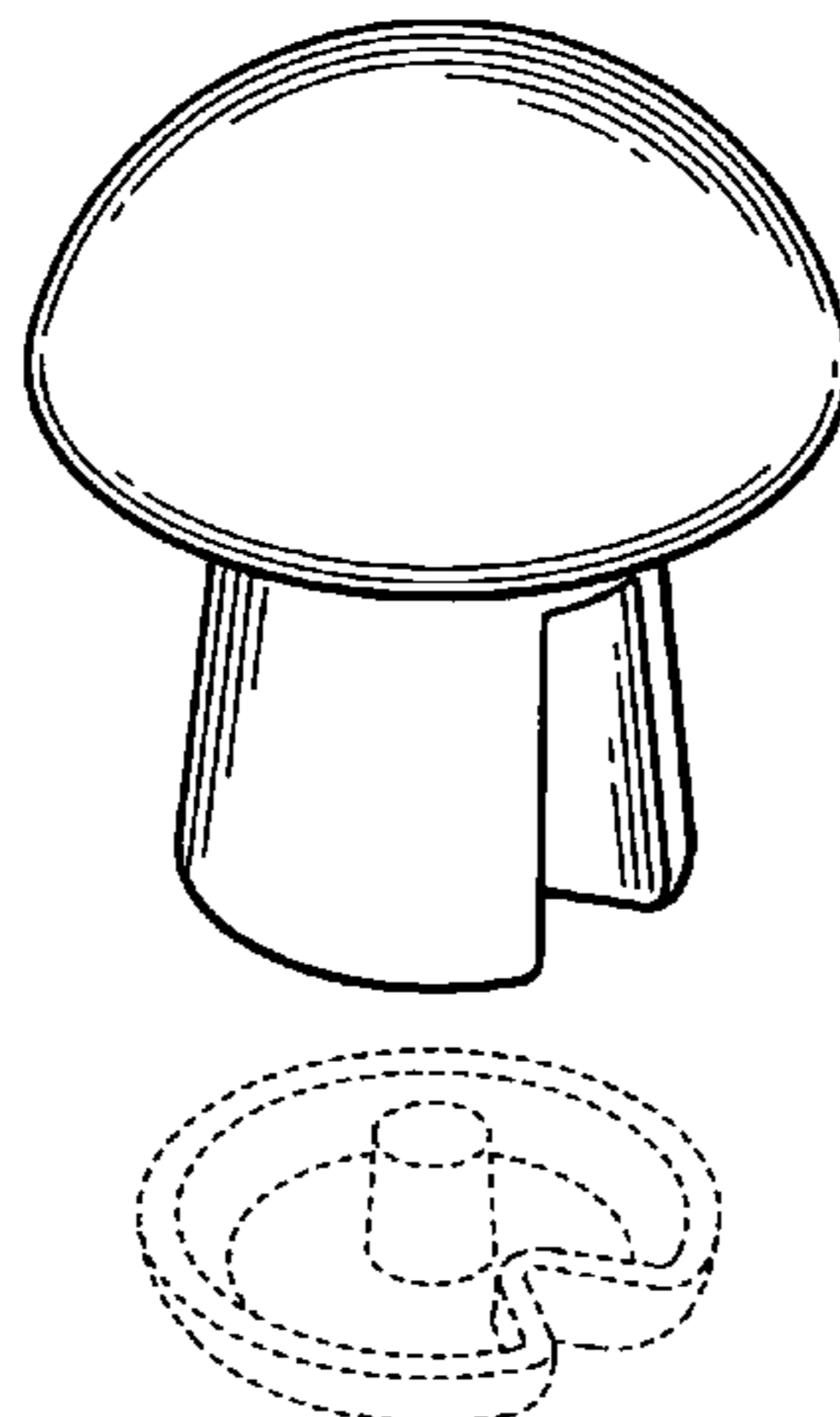
FIG. 14 is a top view thereof;

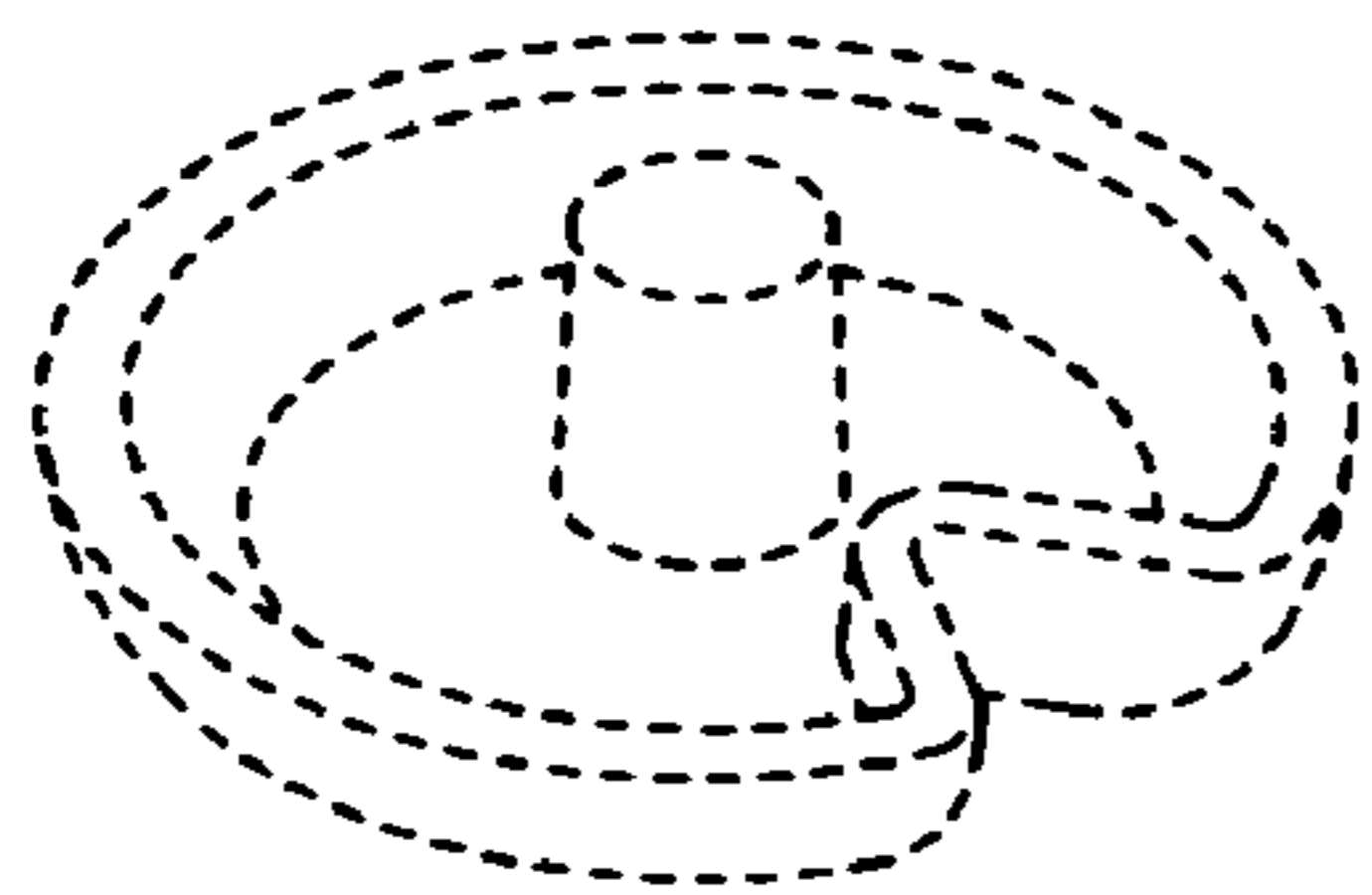
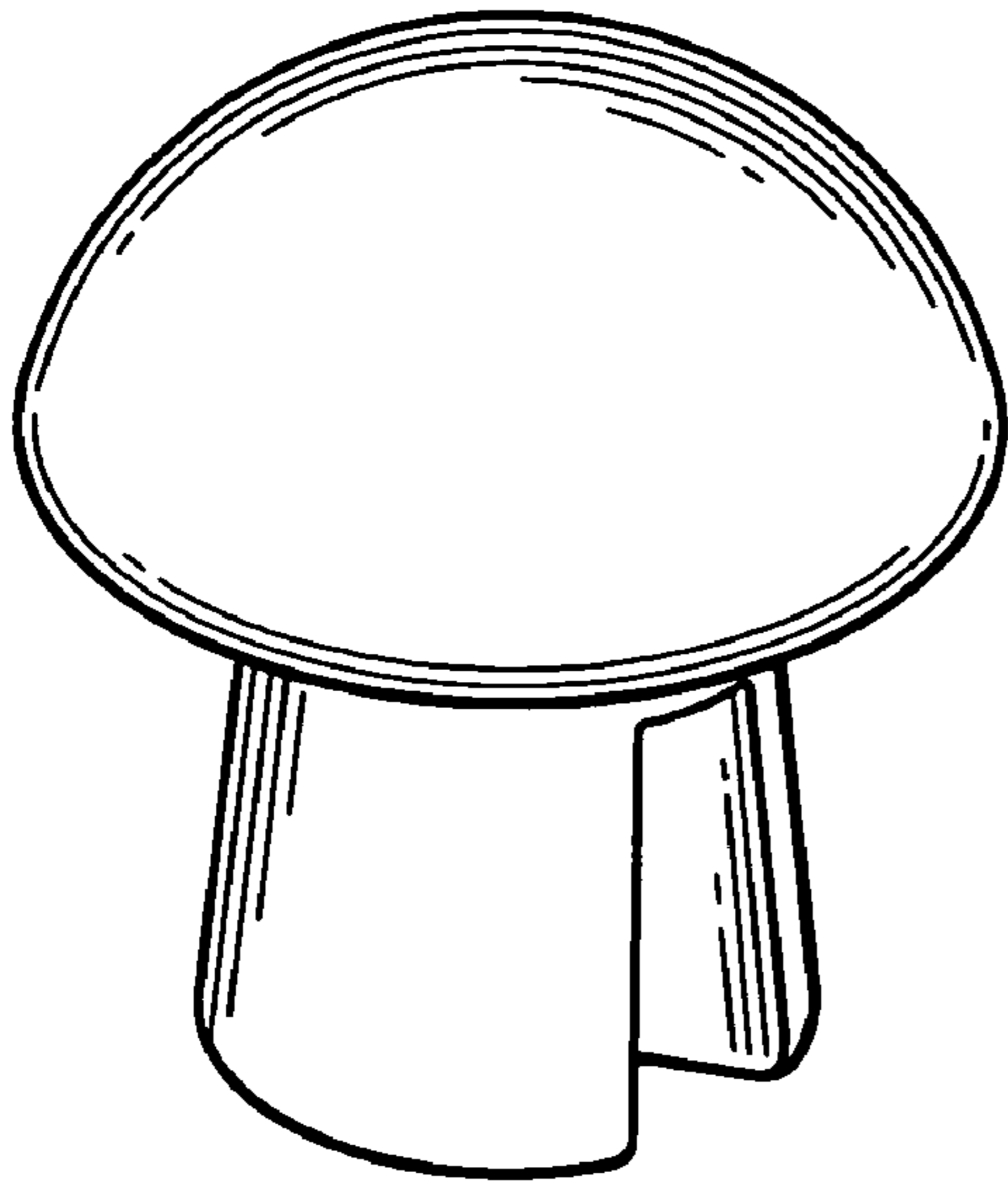
FIG. 15 is a bottom view thereof; and,

FIG. 16 is a front elevation view thereof, the rear, left side and right side elevations being identical thereto.

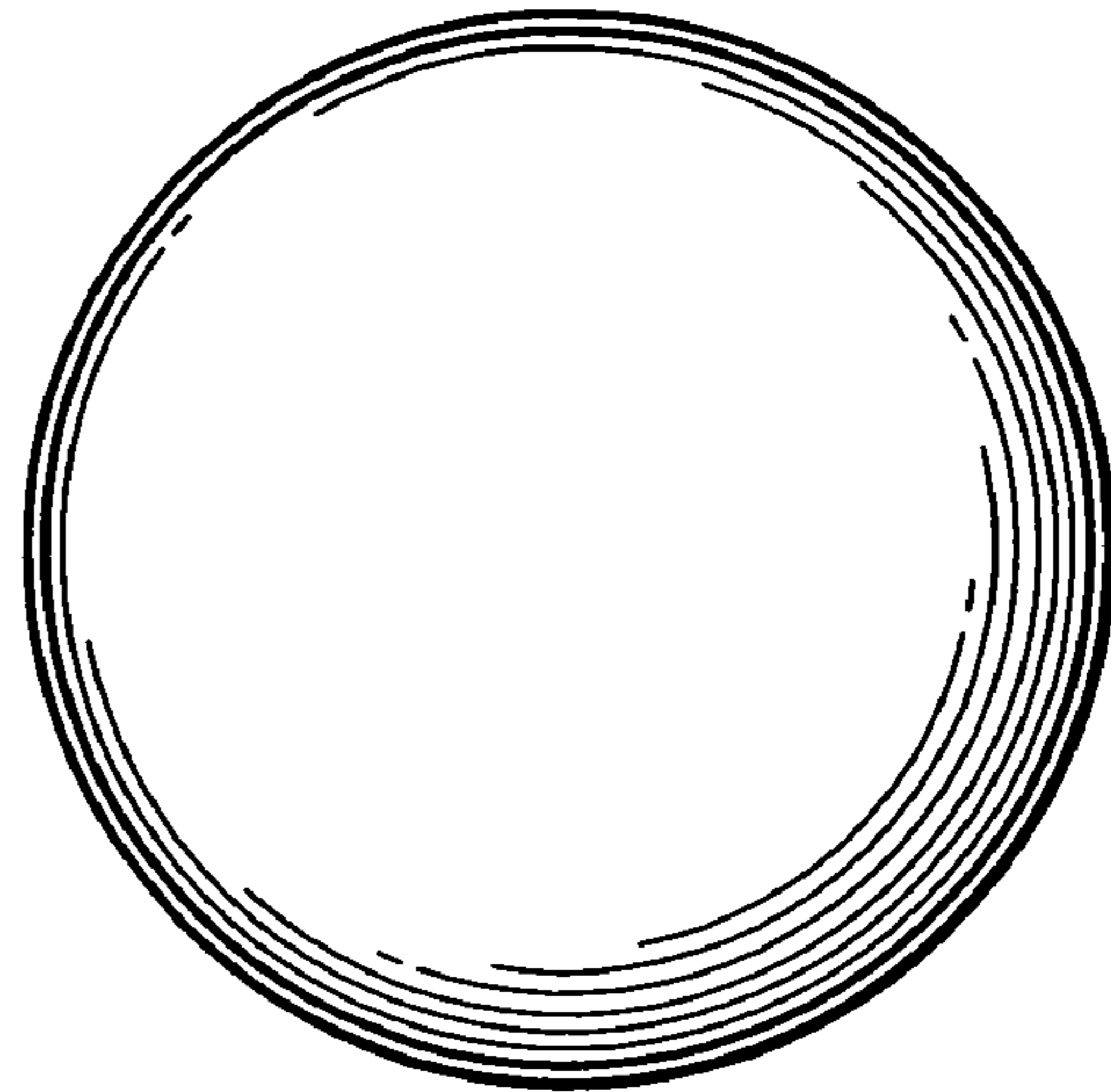
The broken line showing in FIGS. 1, 7 and 13 of the removable compression pad is for illustrative purposes only and forms no part of the claimed design.

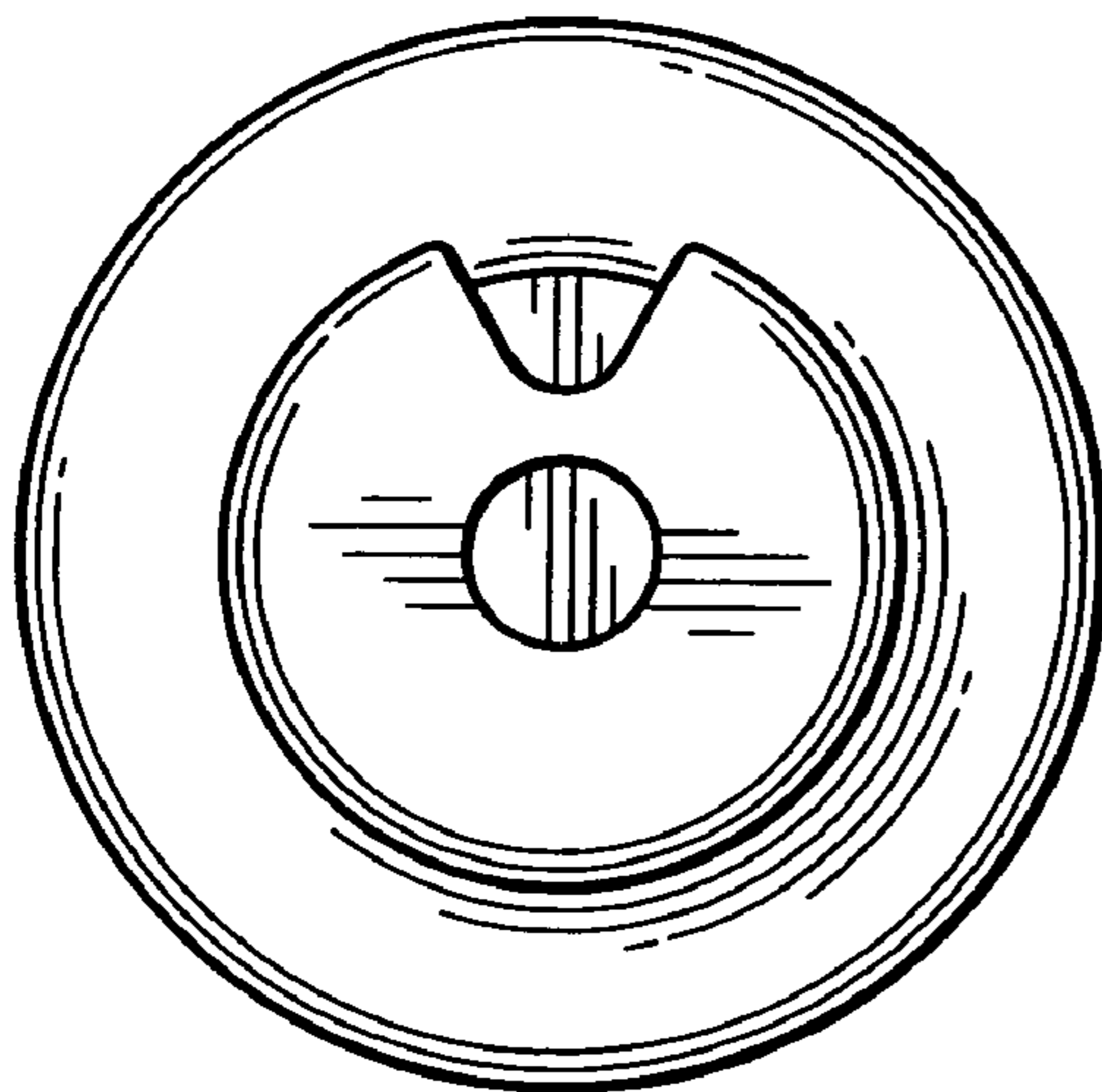




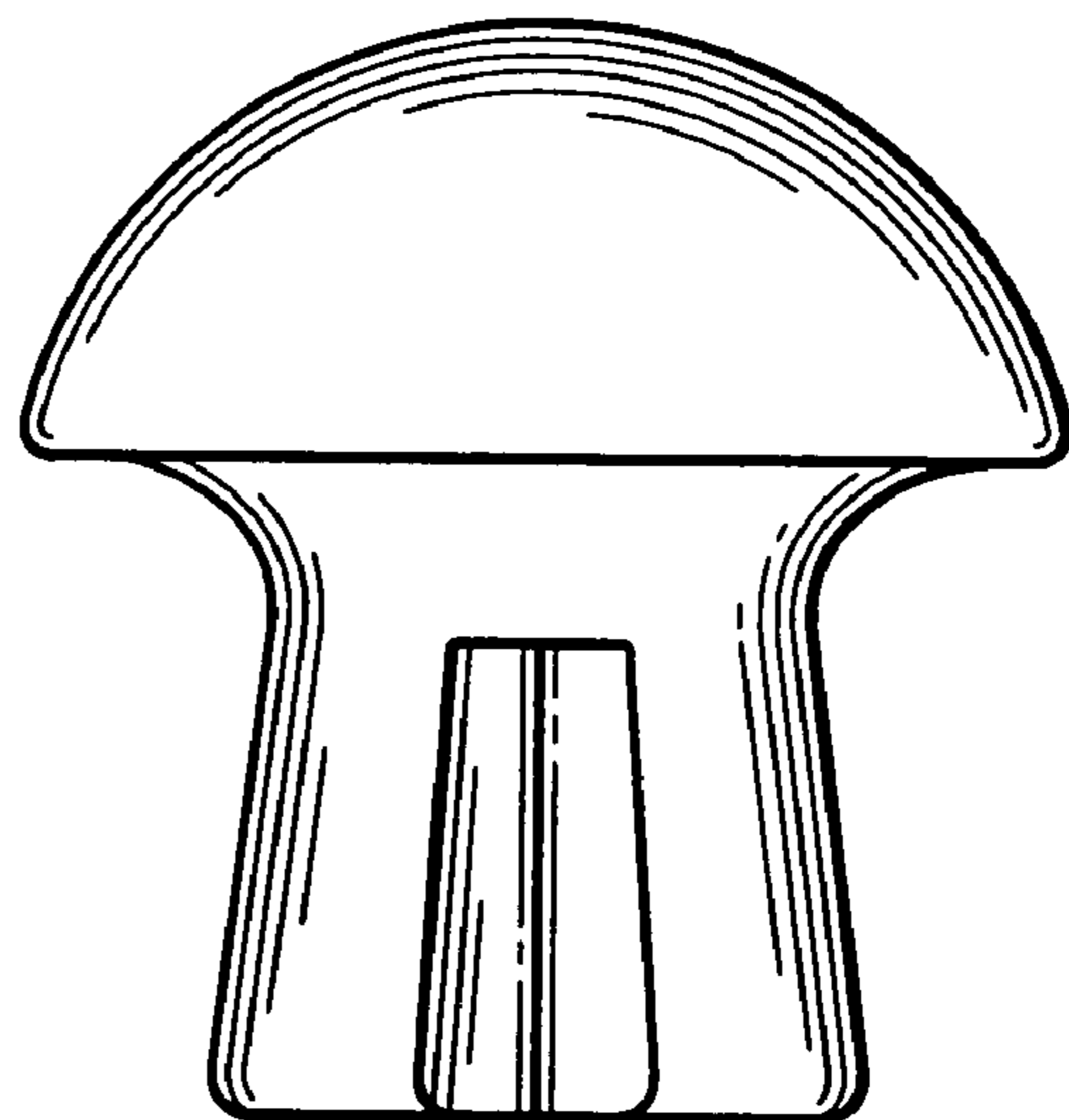

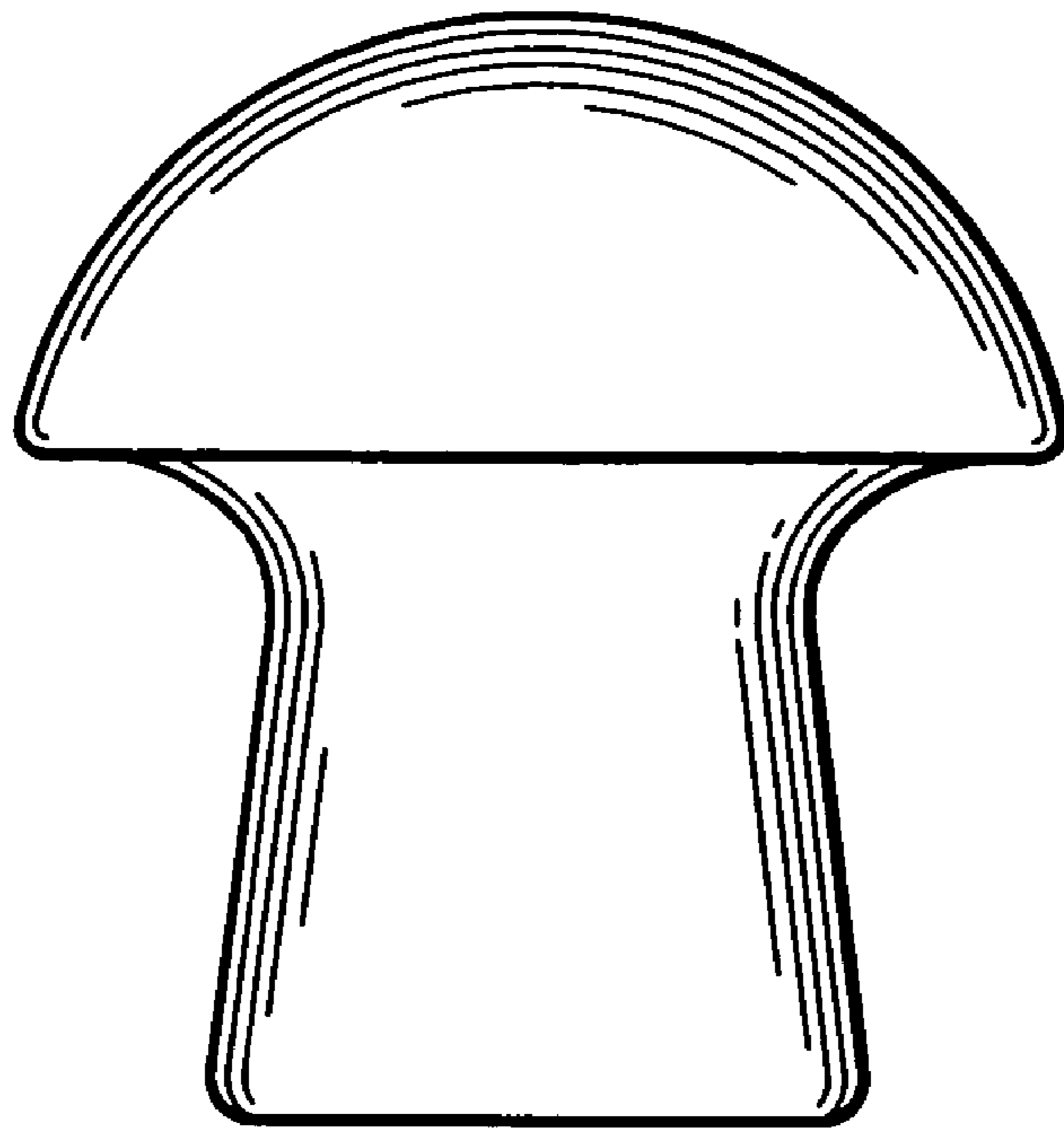

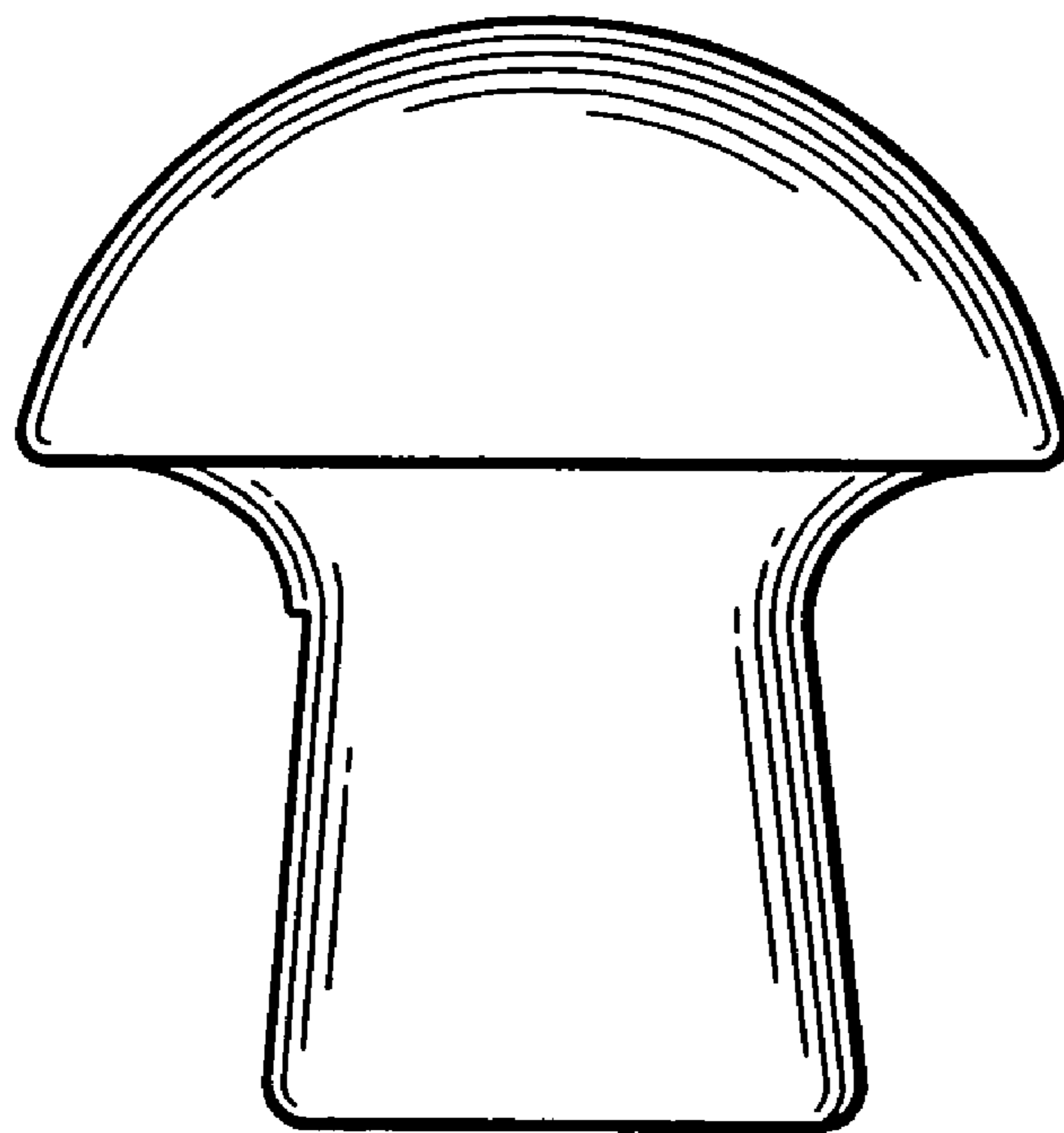

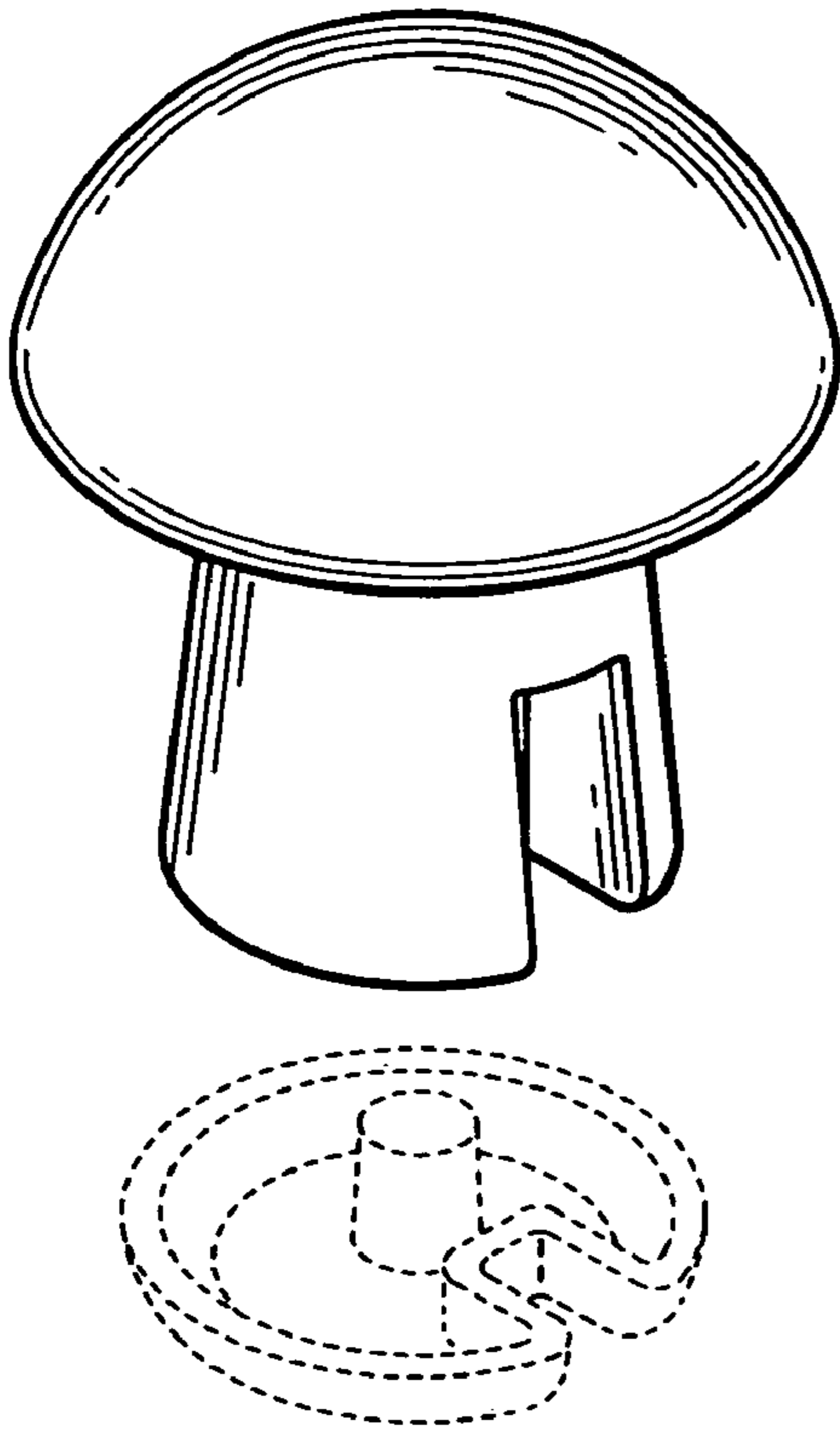

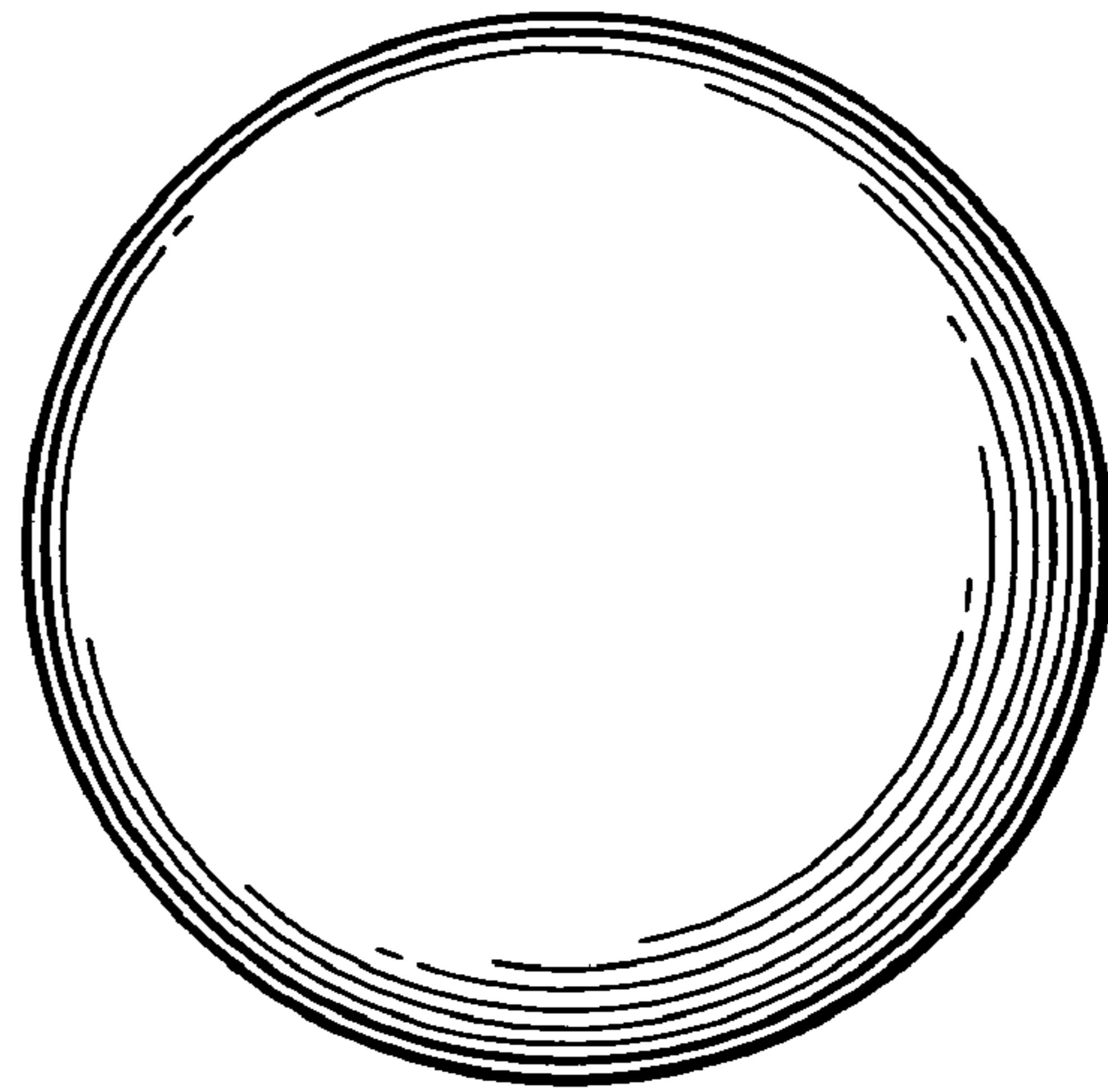

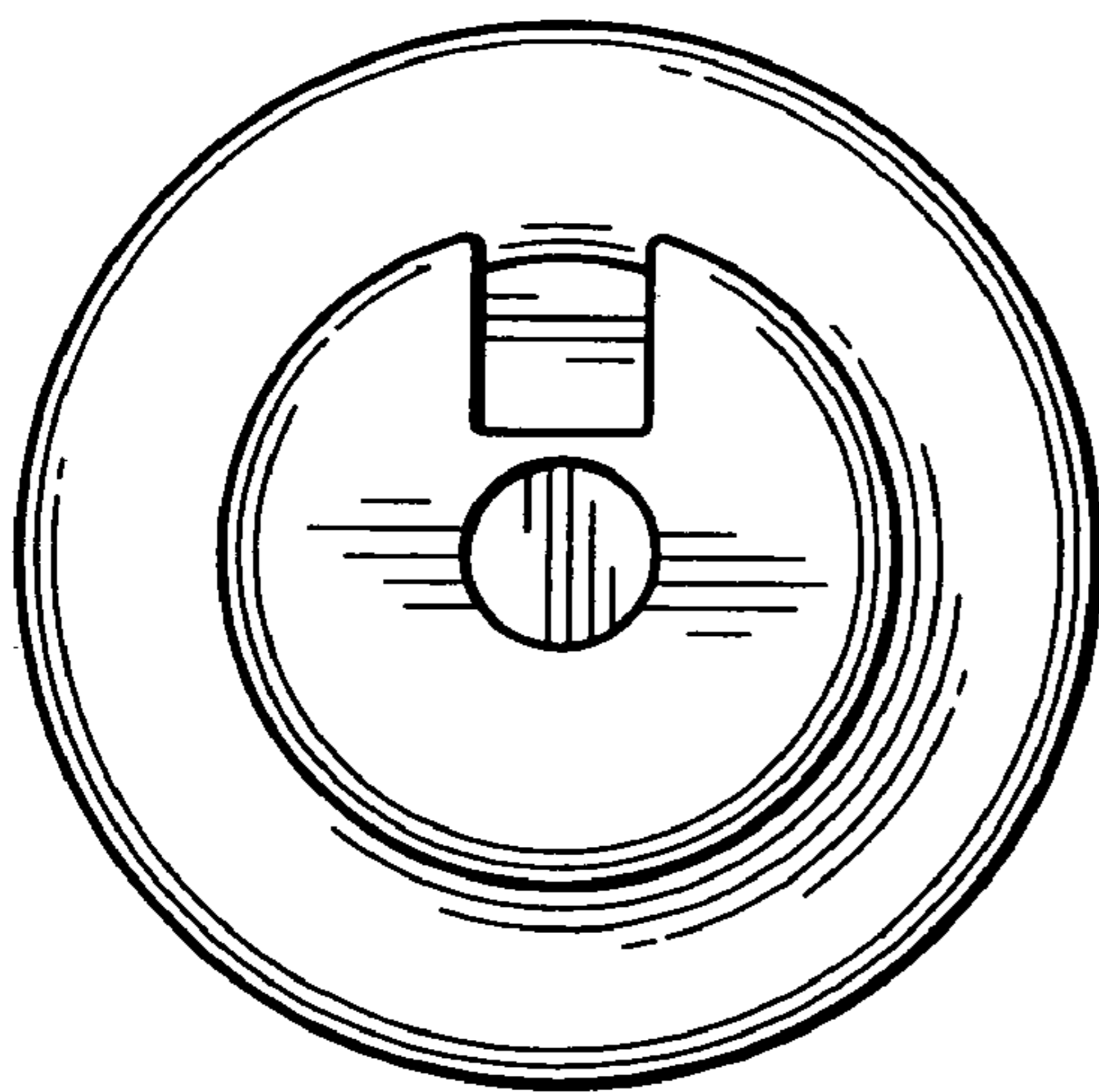

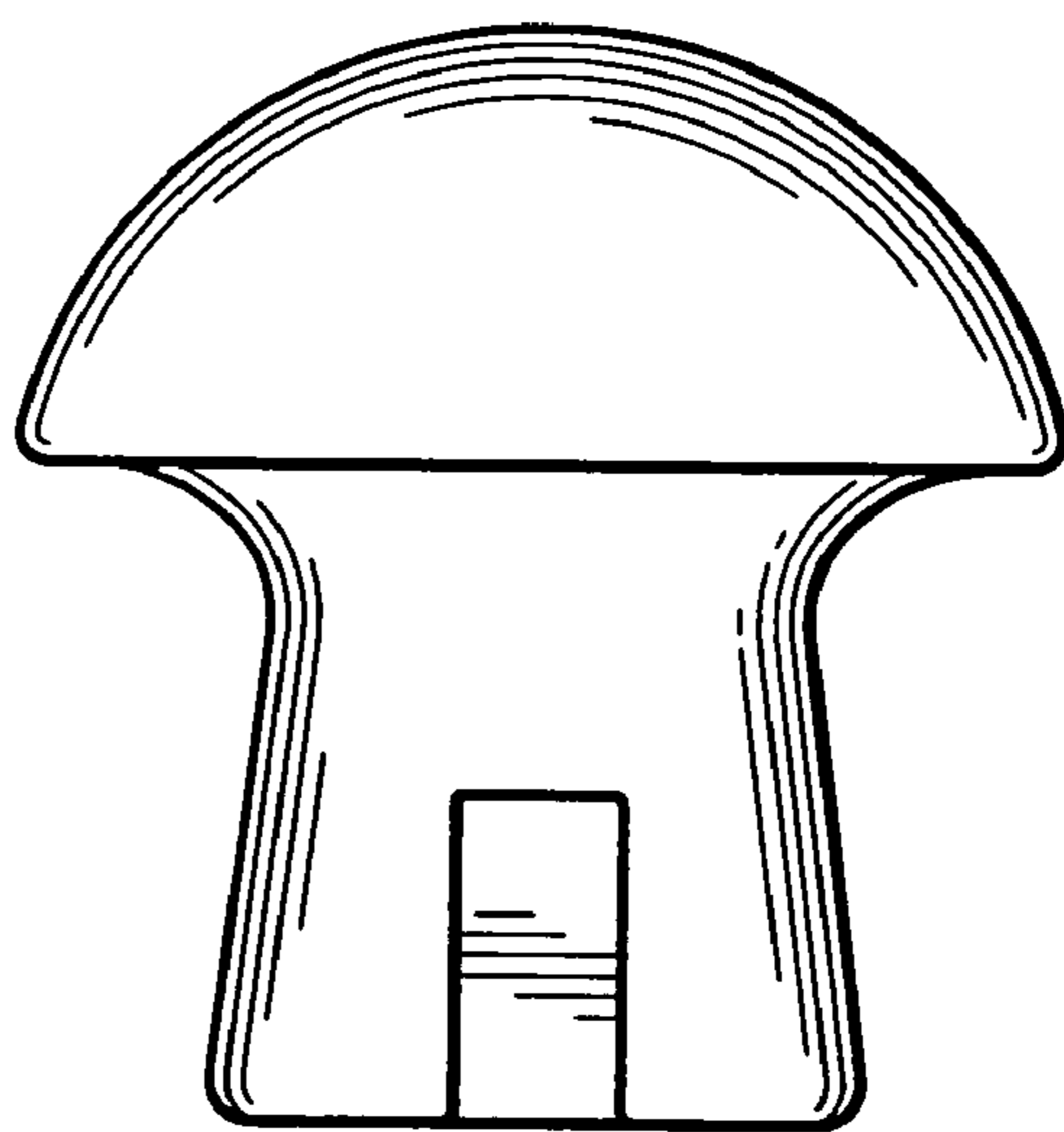

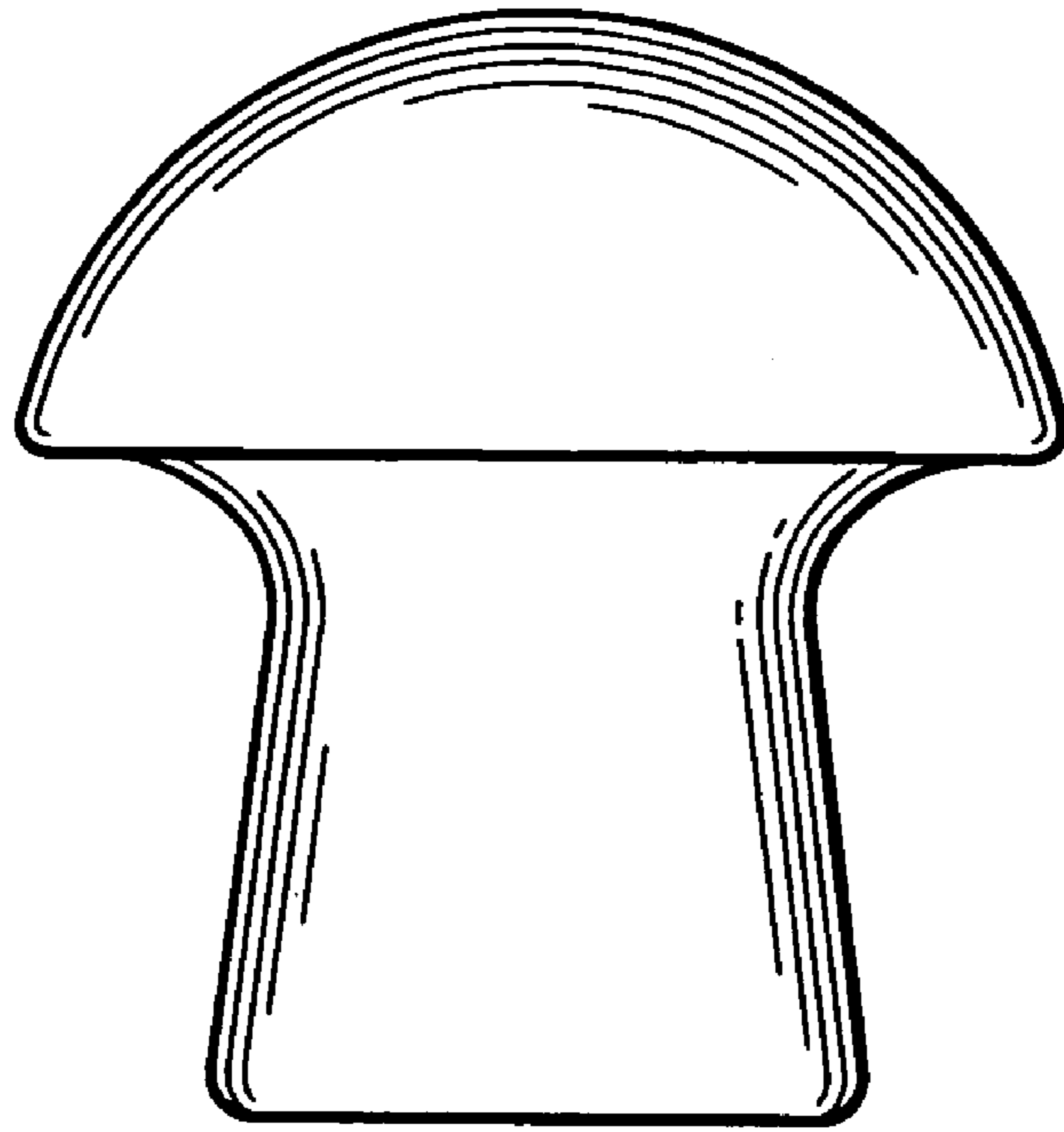

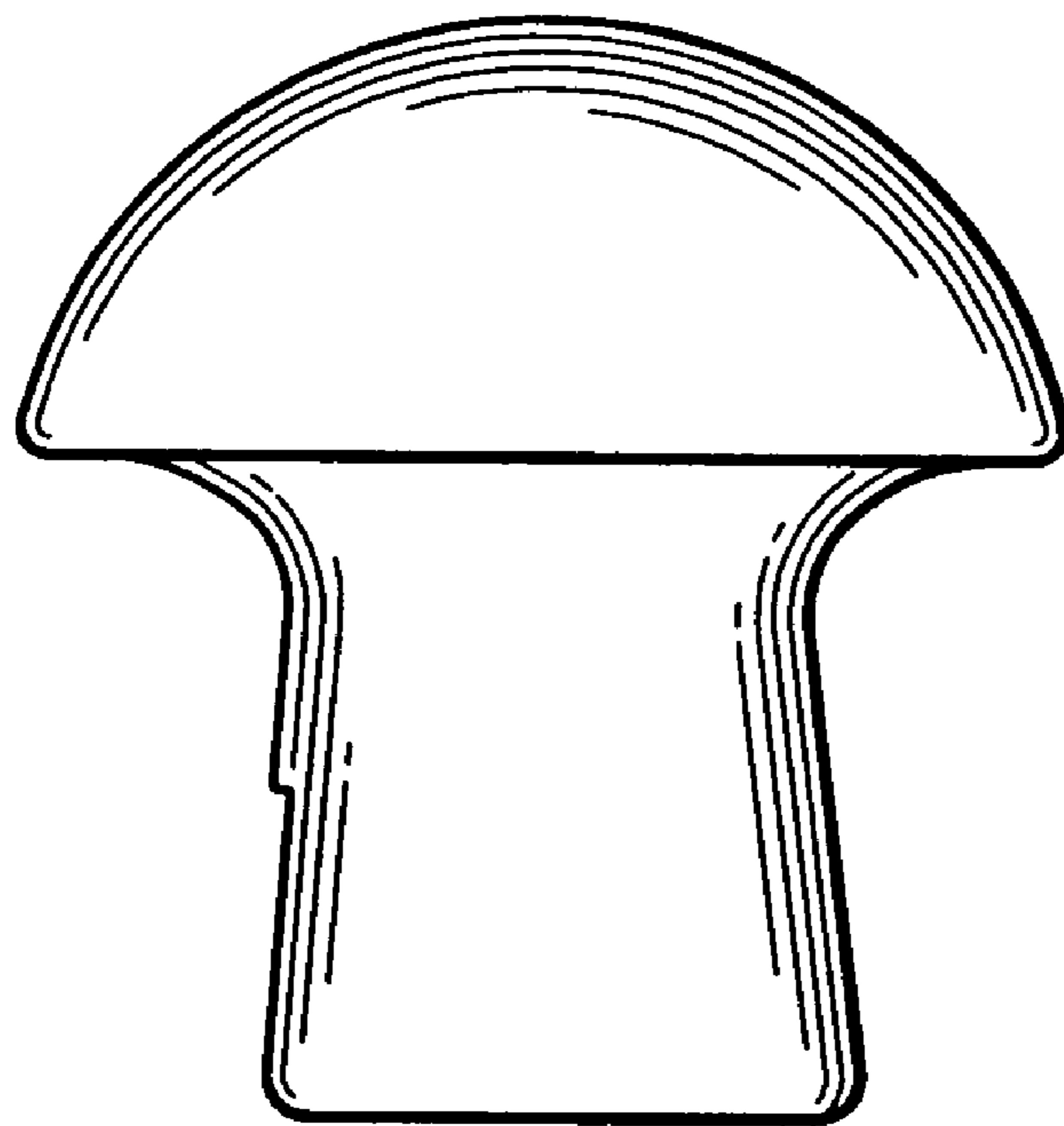

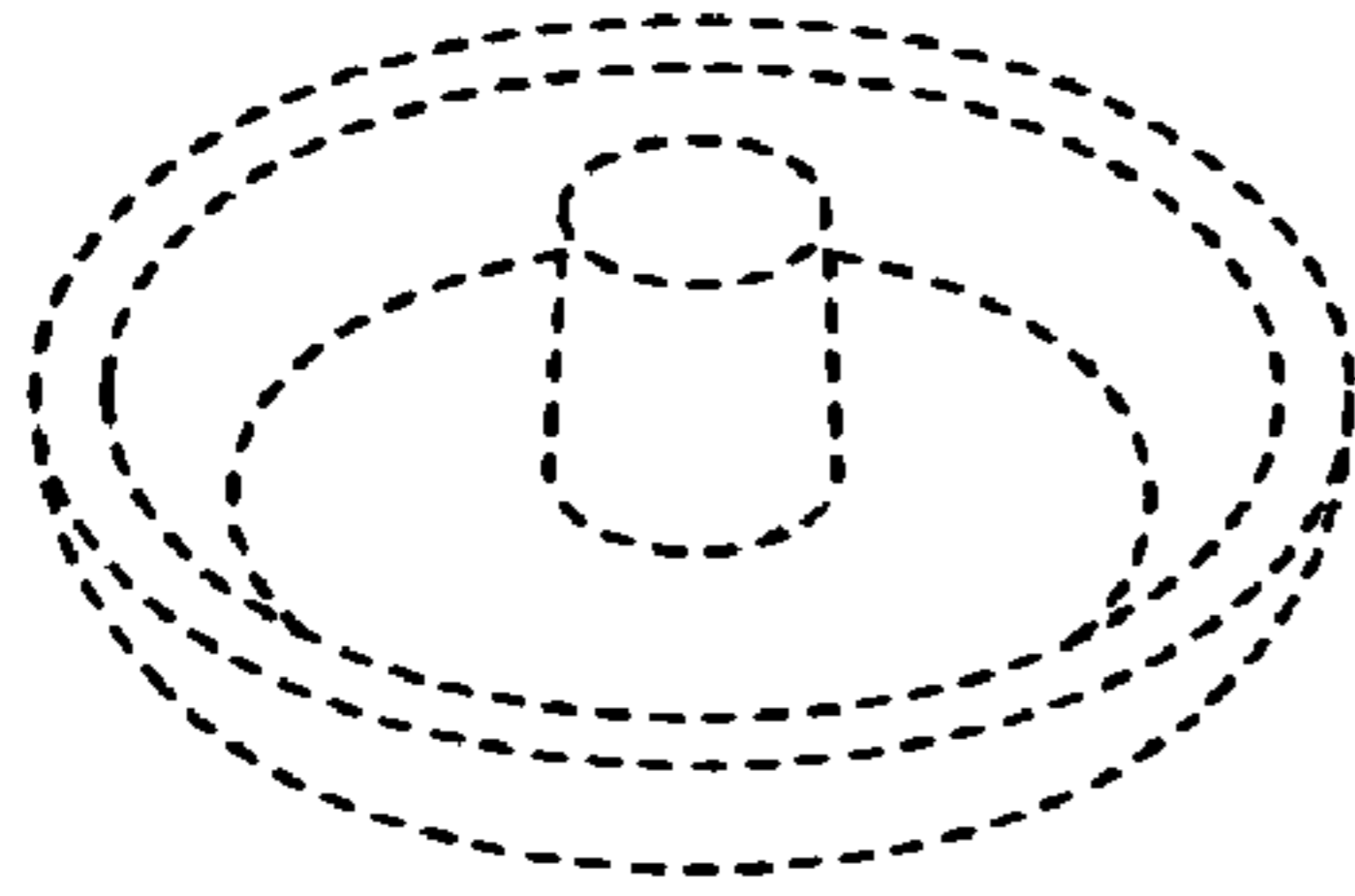
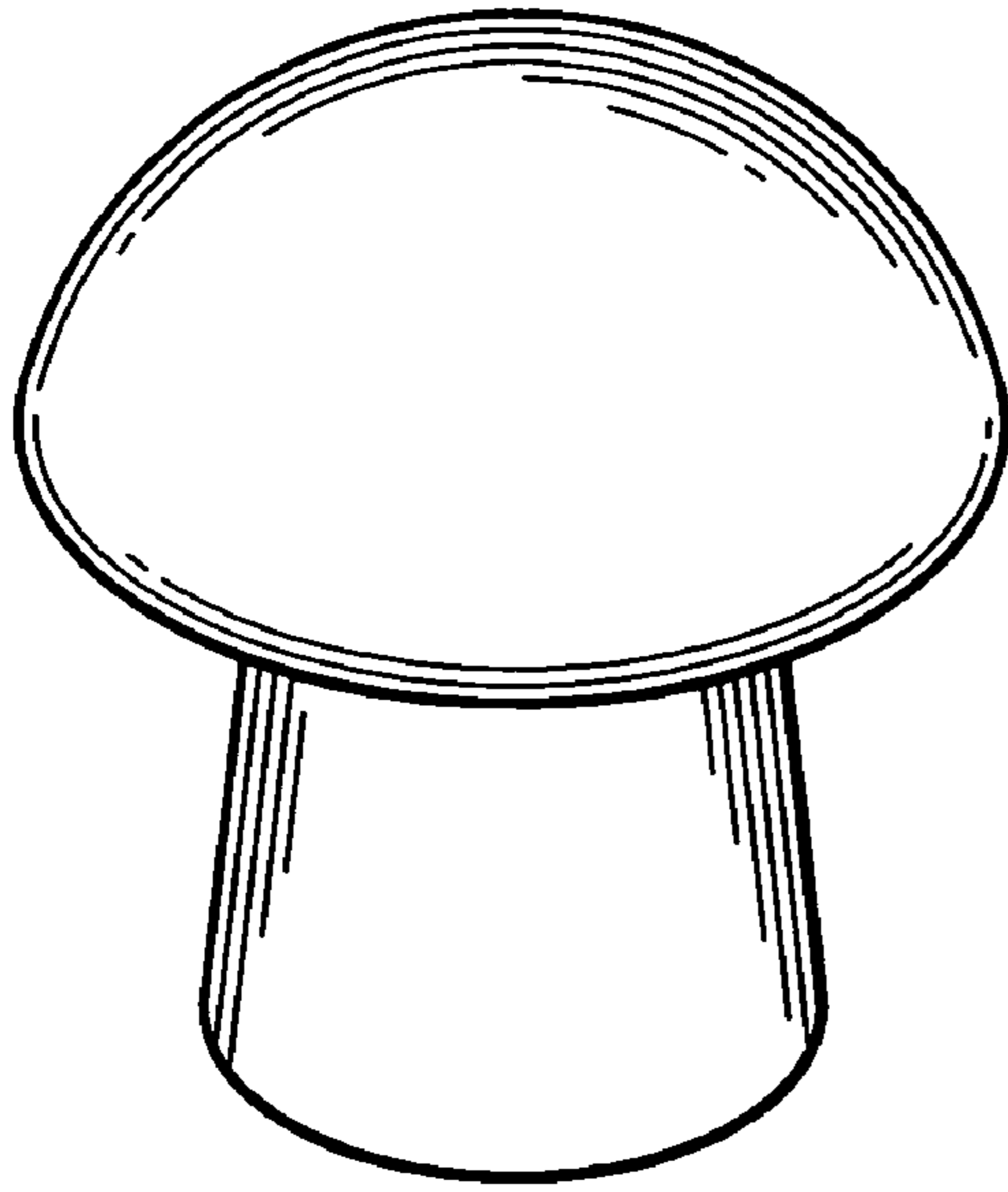

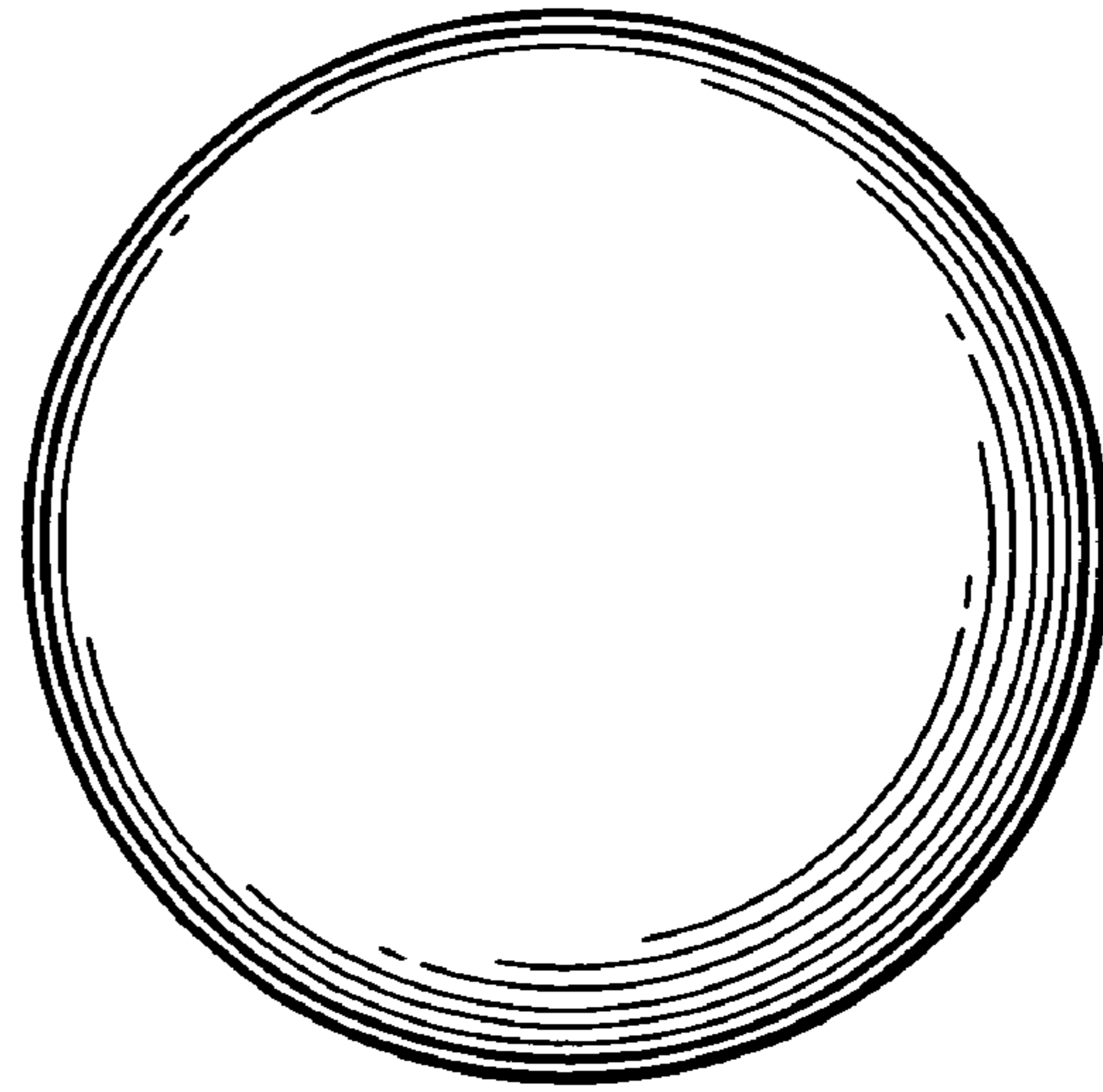

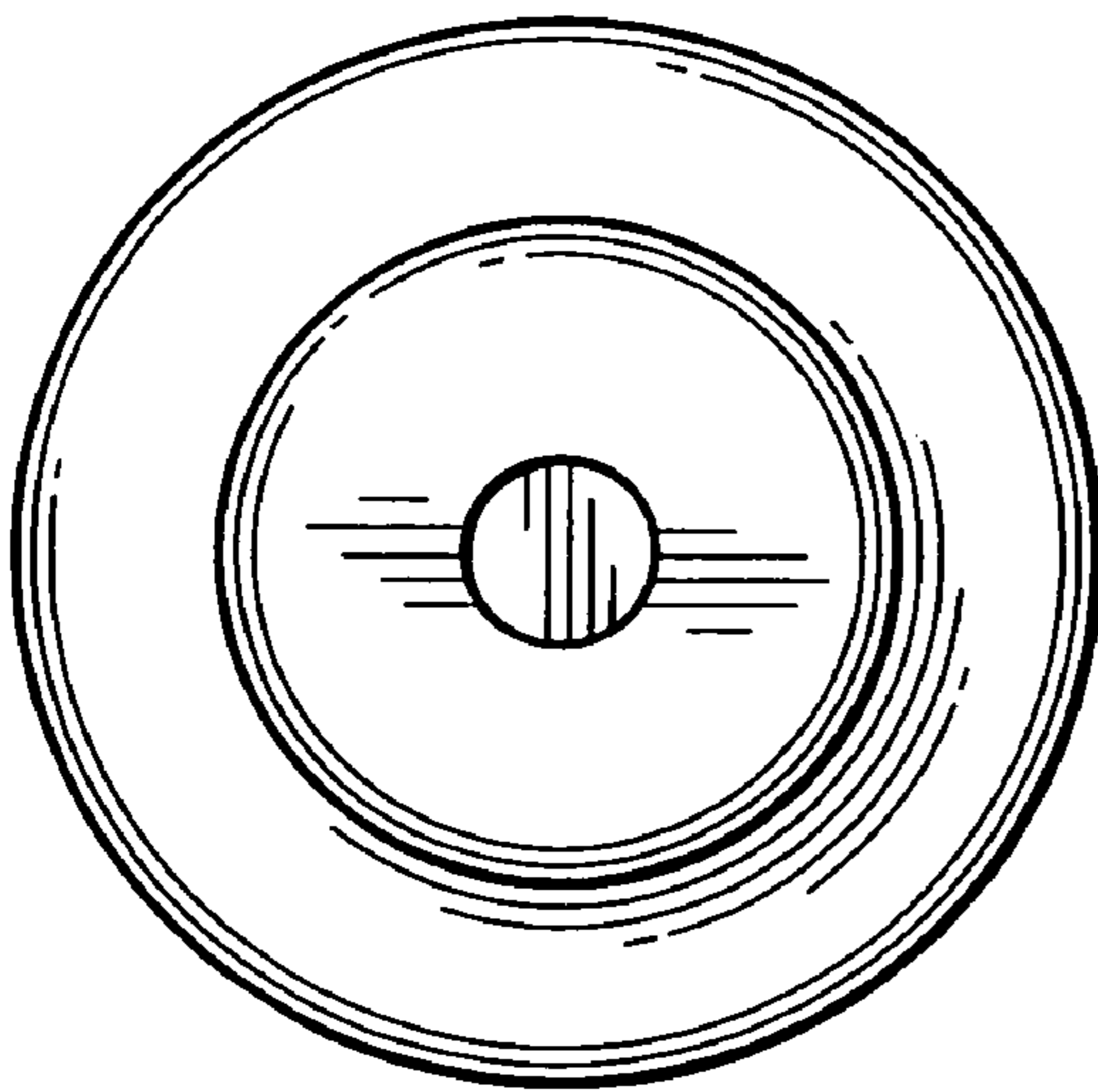

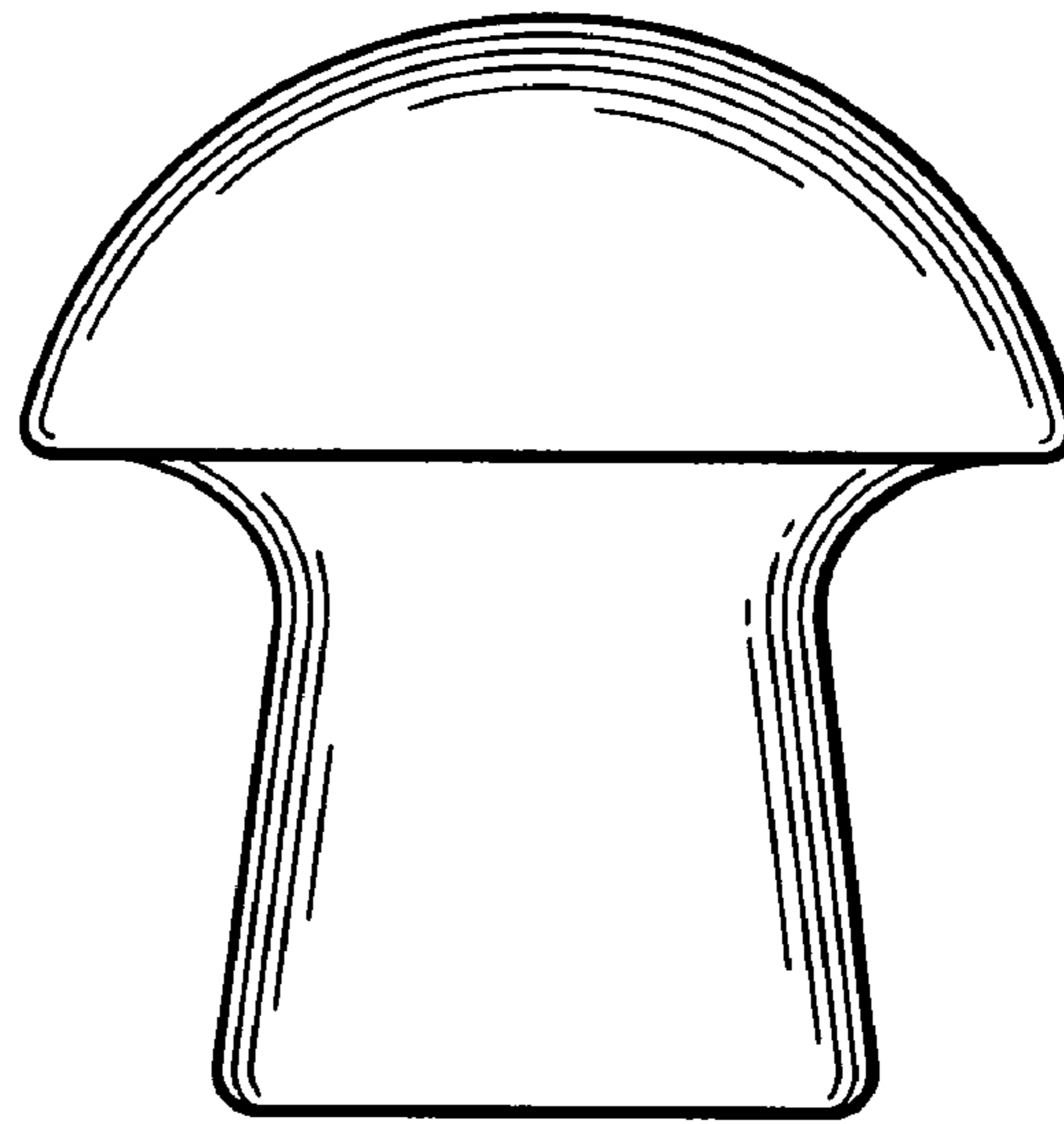
