(57) **CLAIM**

The ornamental design for a light fixture component, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of a light fixture component in accordance with my design;

FIG. 2 is a top plan view of the light fixture component in accordance with my design;

FIG. 3 is a bottom plan view of the light fixture component in accordance with my design;

FIG. 4 is a front elevation view of the light fixture component in accordance with my design;

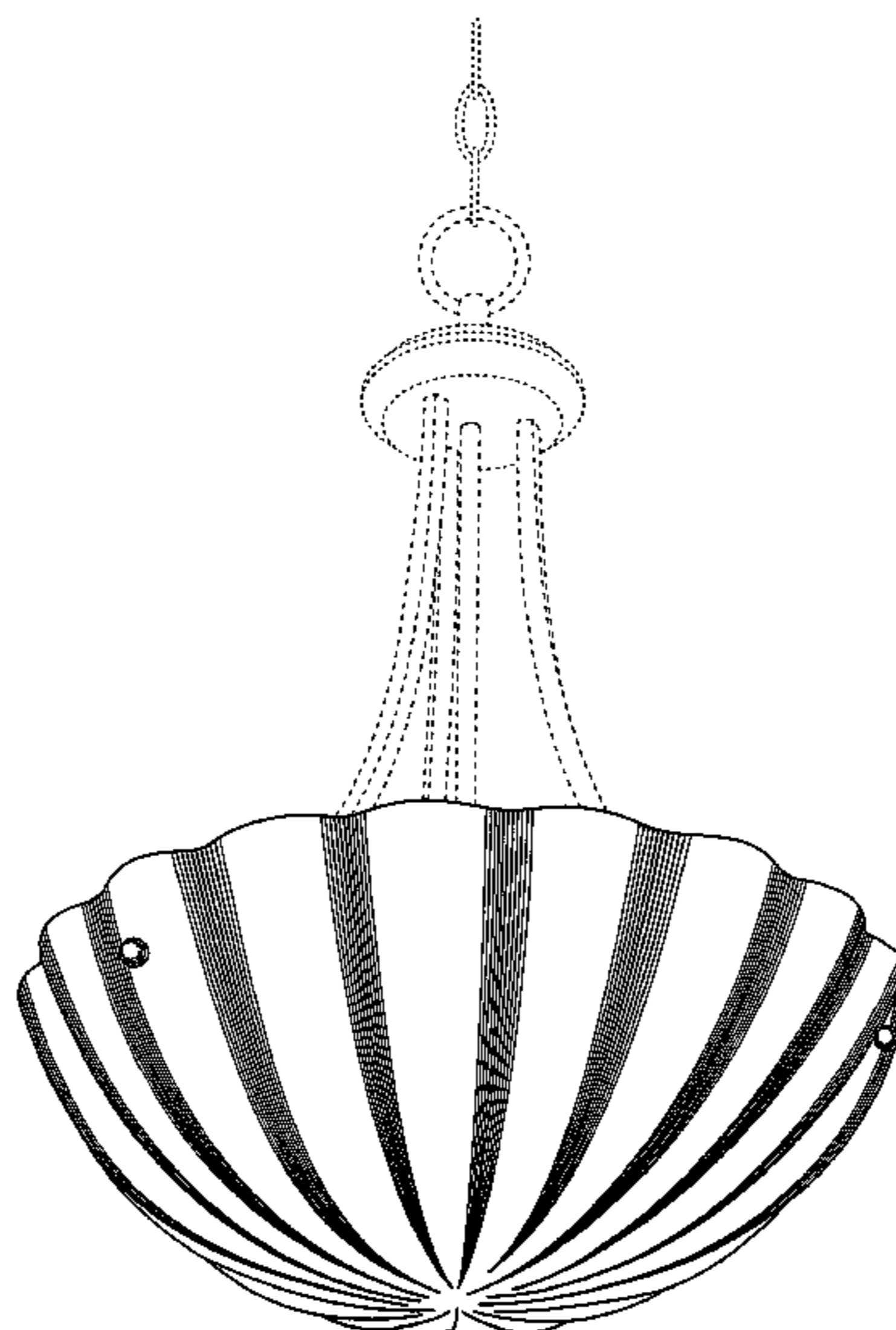
FIG. 5 is a back elevation view of the light fixture component in accordance with my design;

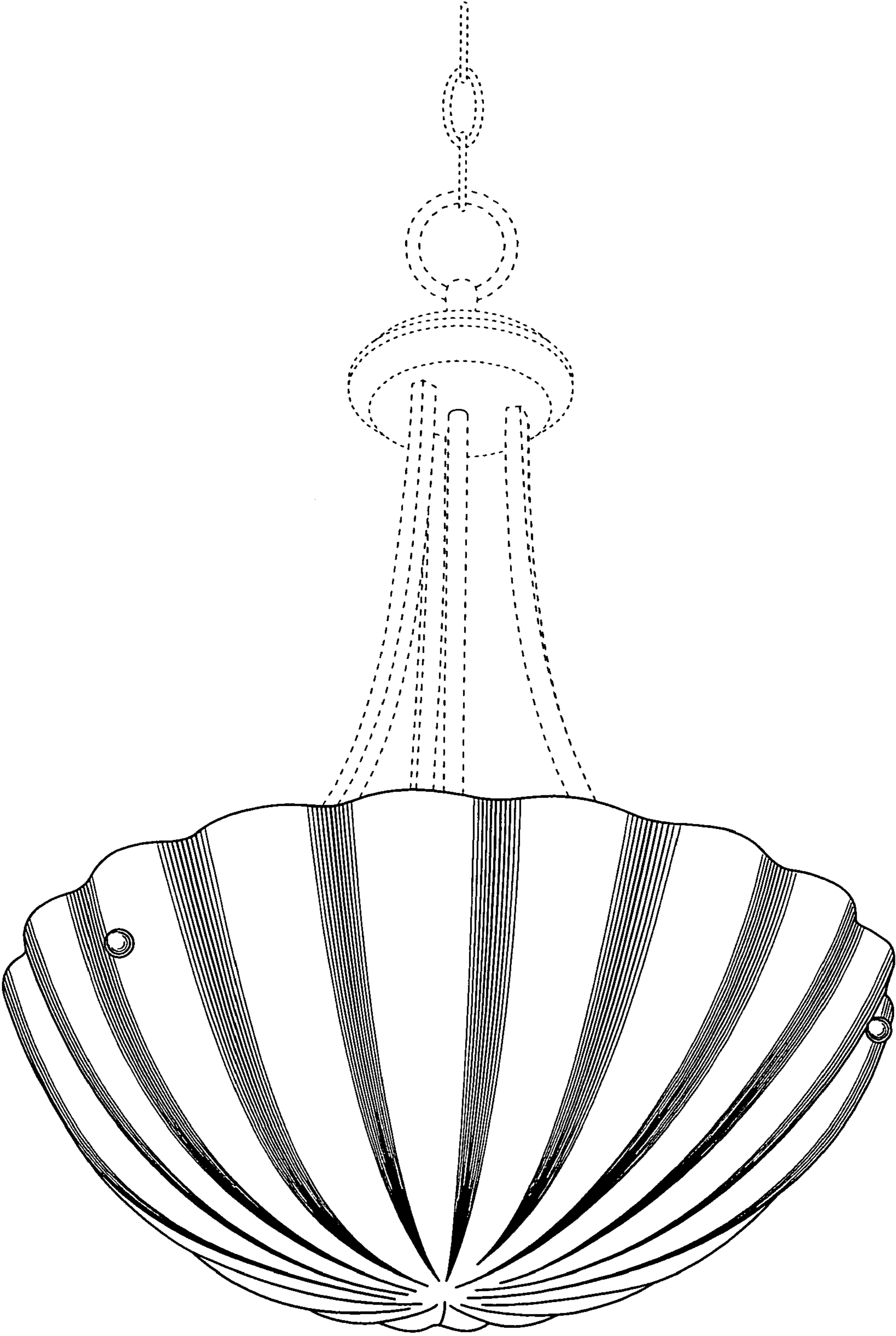

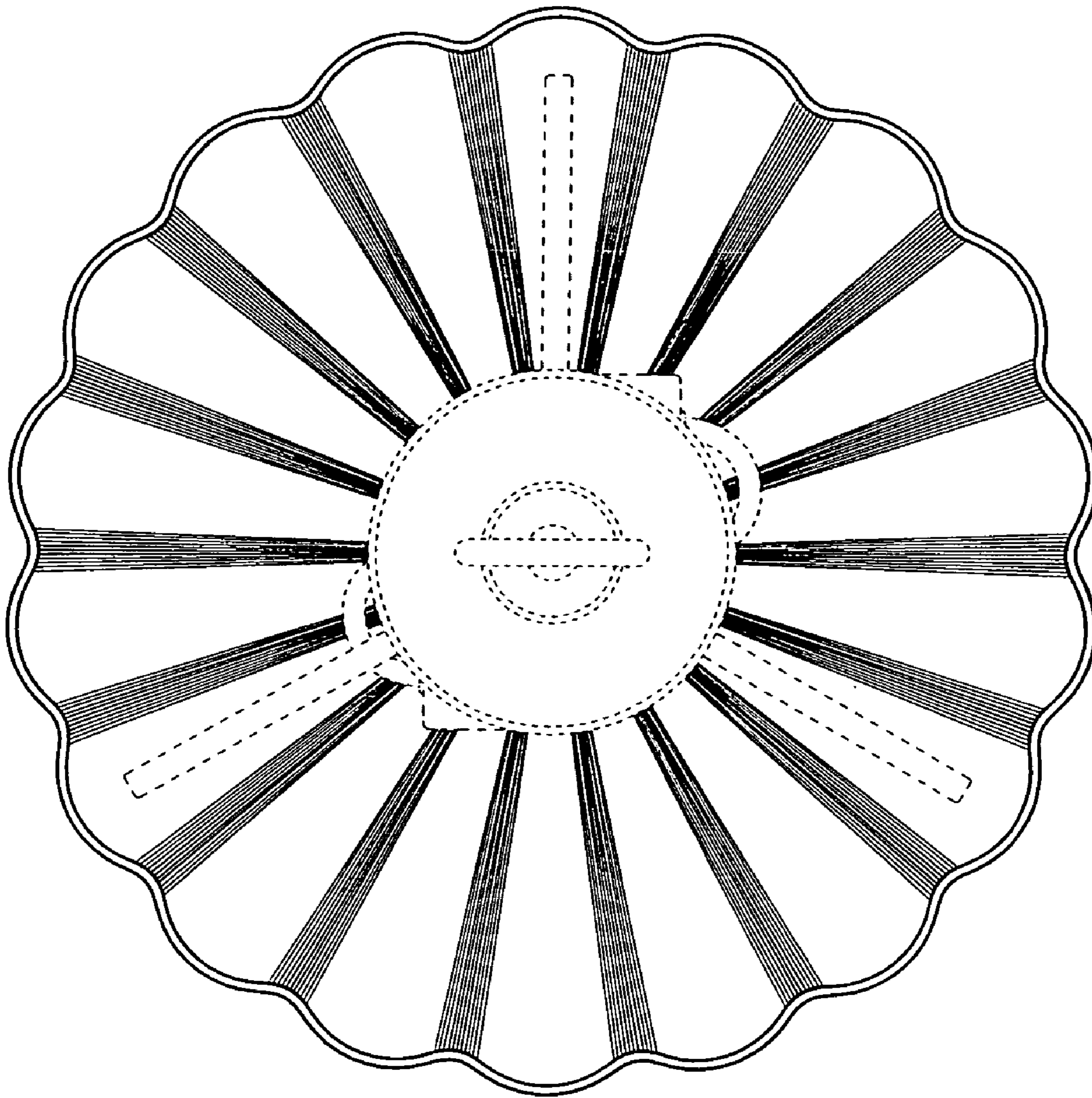

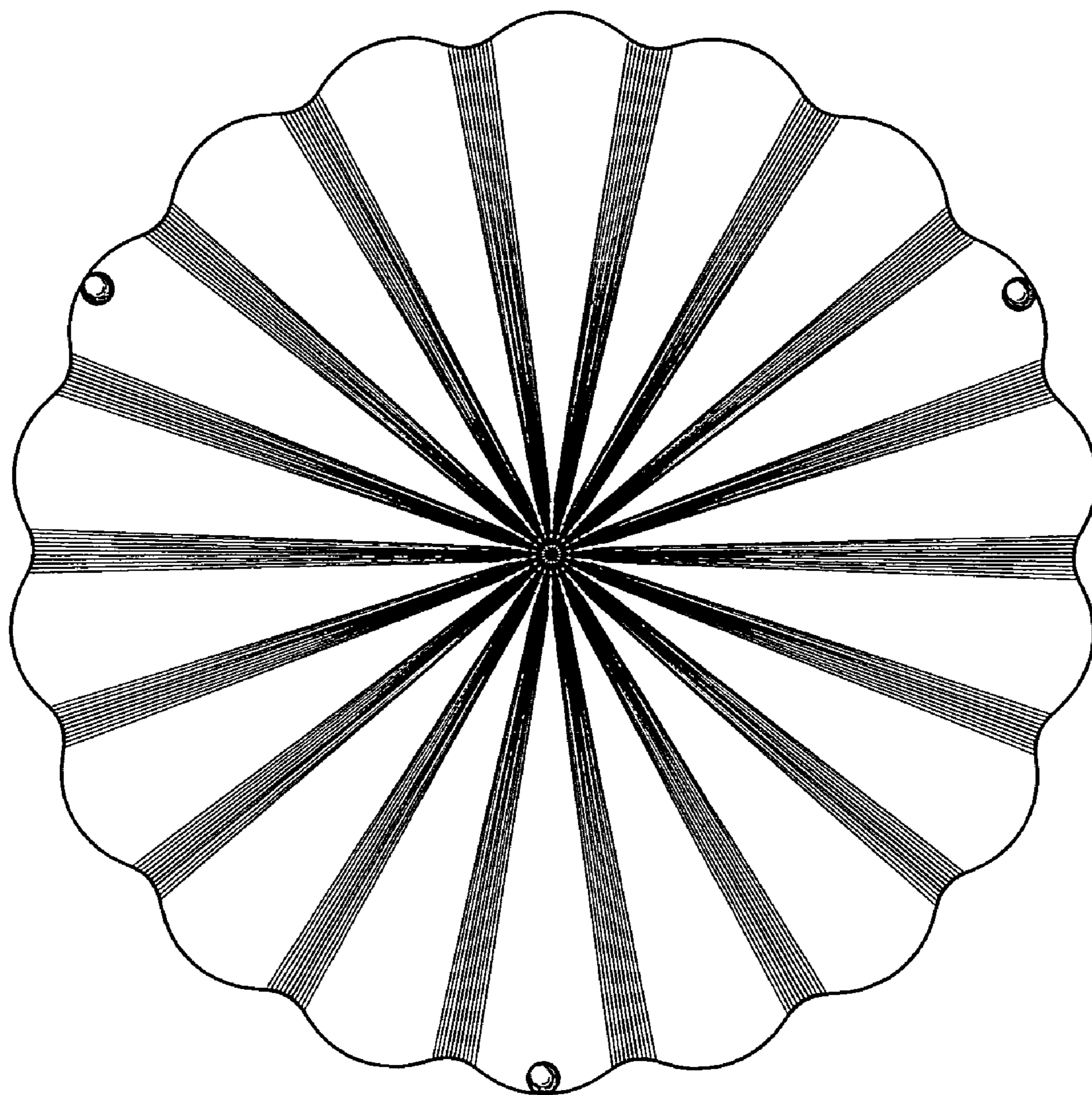

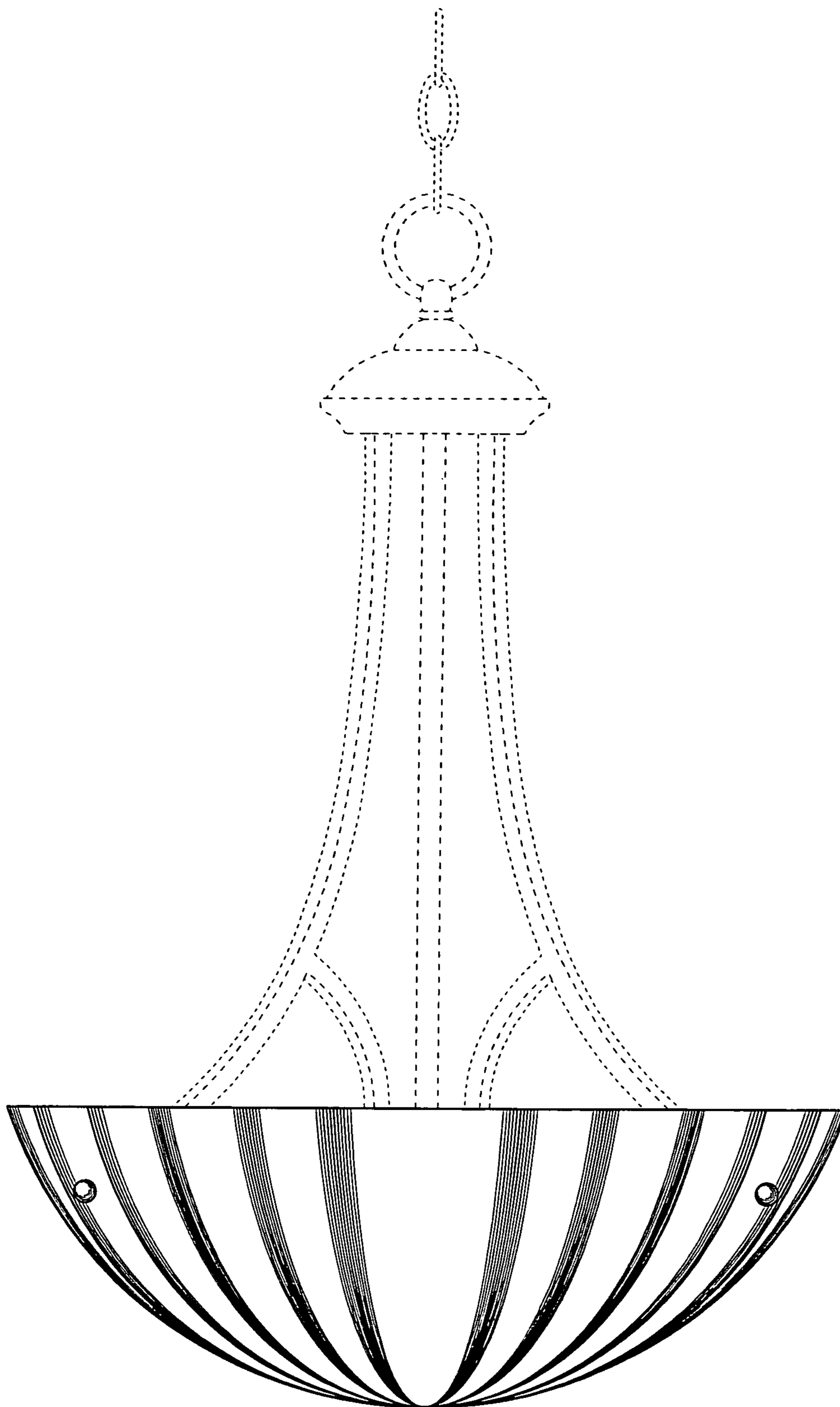

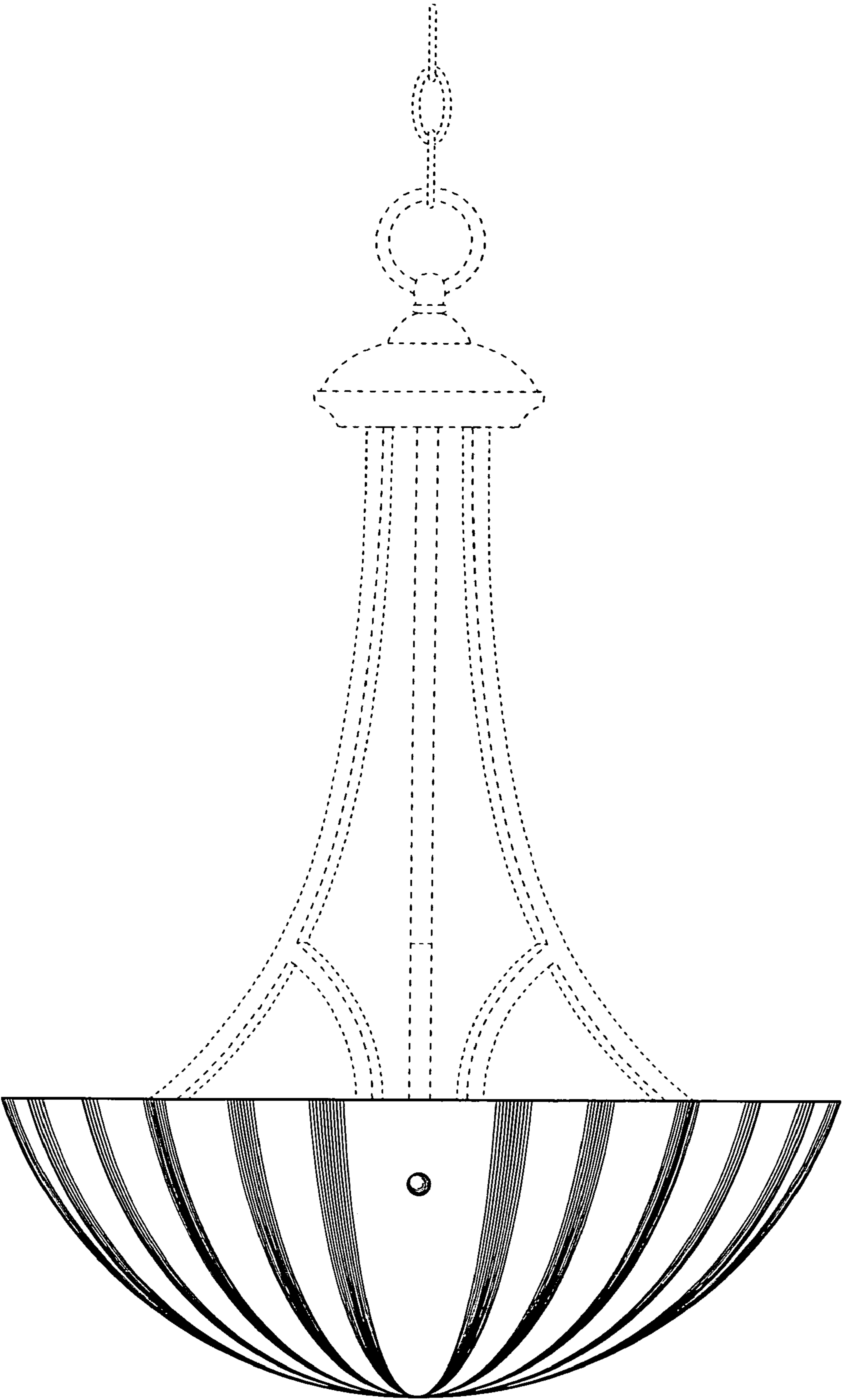

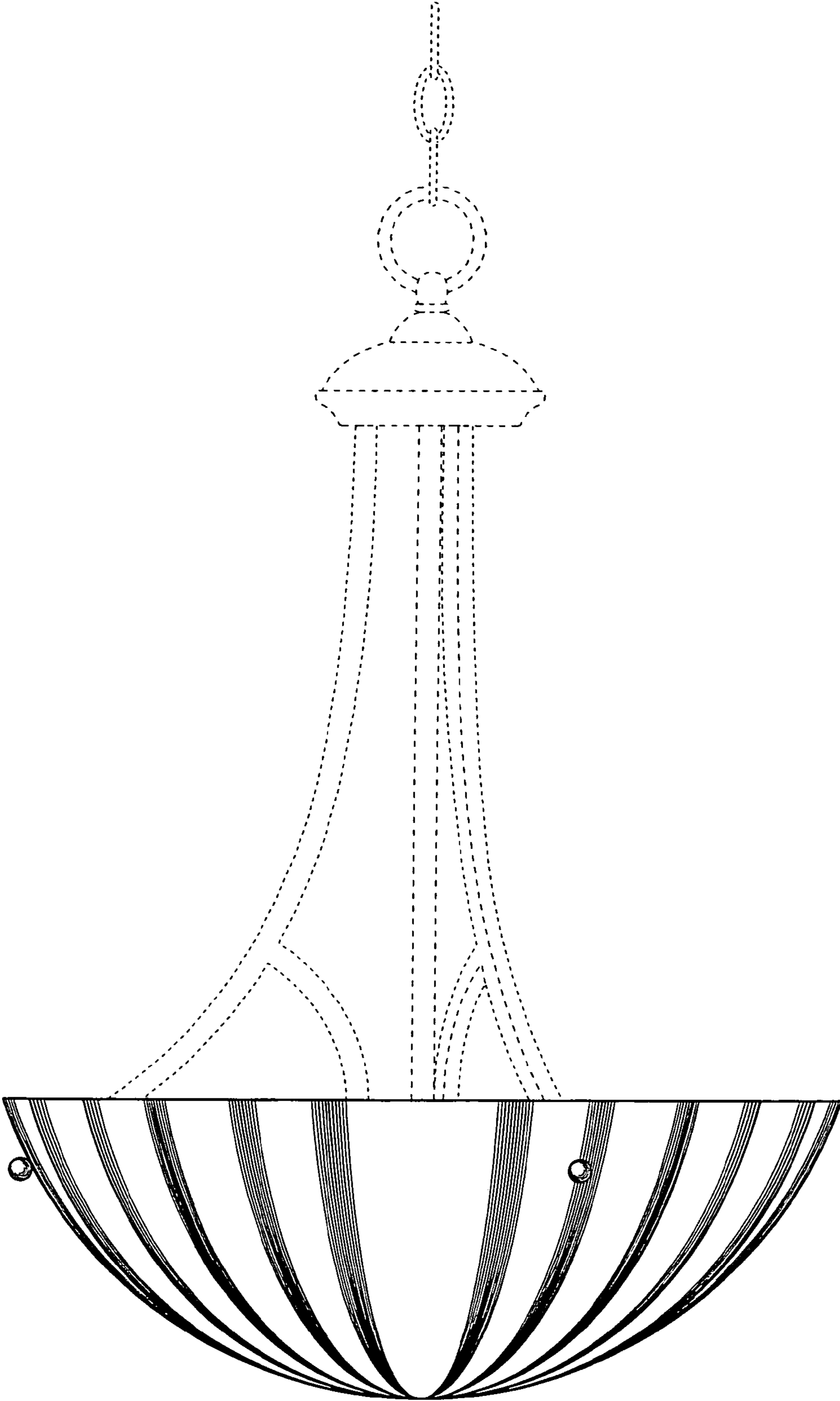

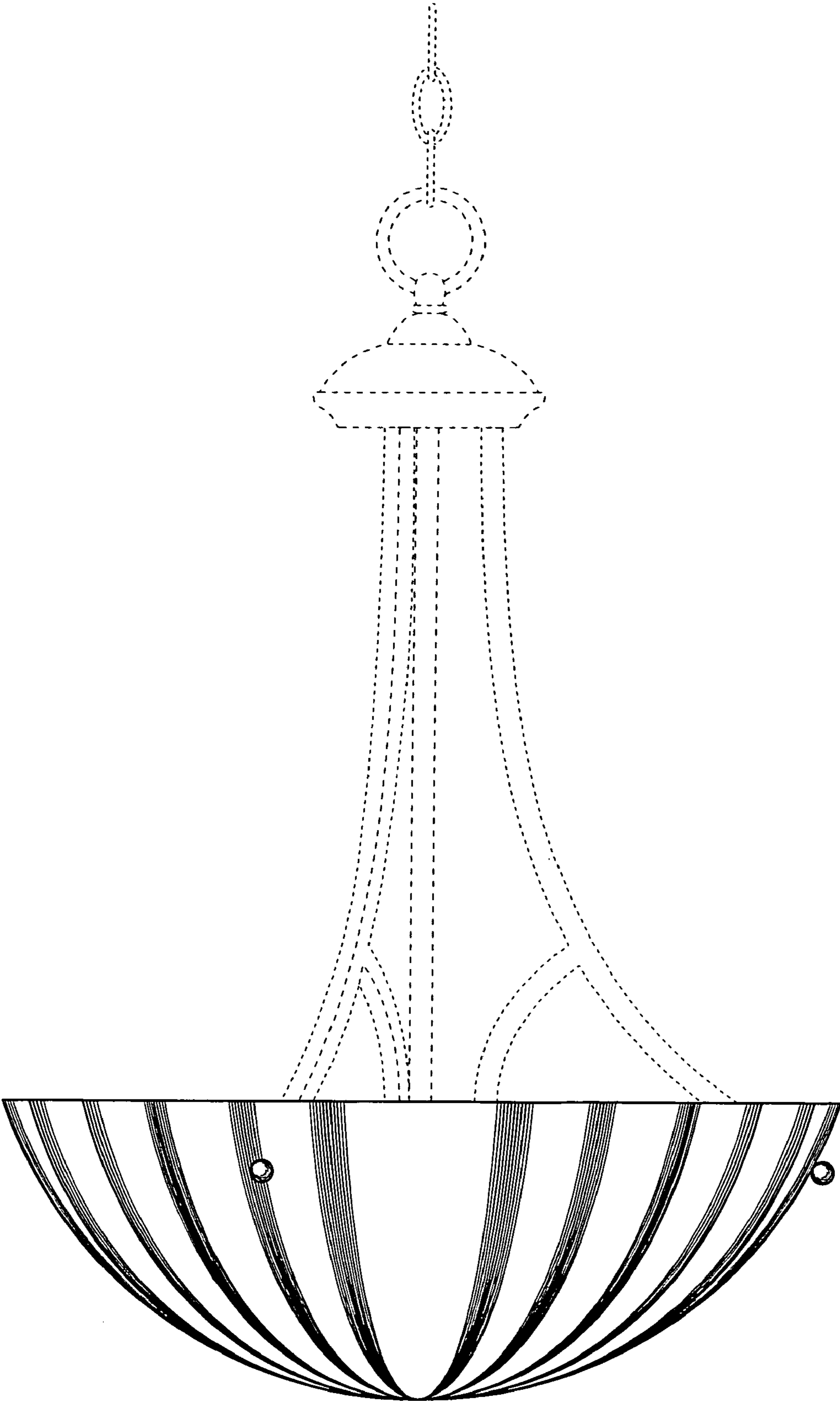
