DESCRIPTION

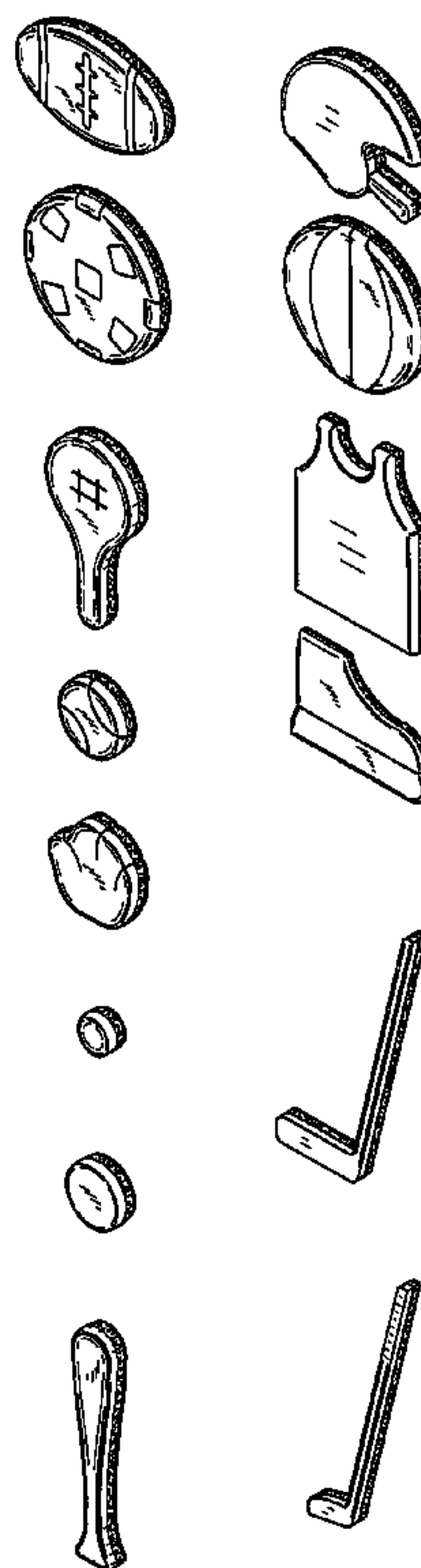
FIG. 1 is a front elevation view of a set of cereal food product showing my new design;

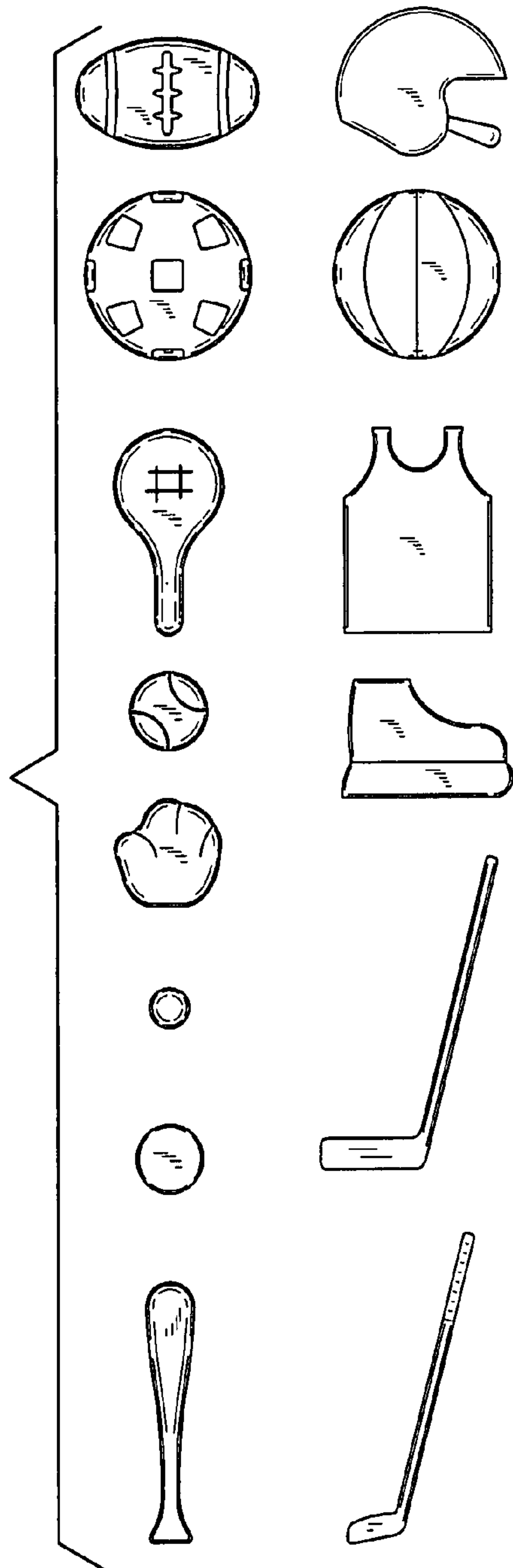

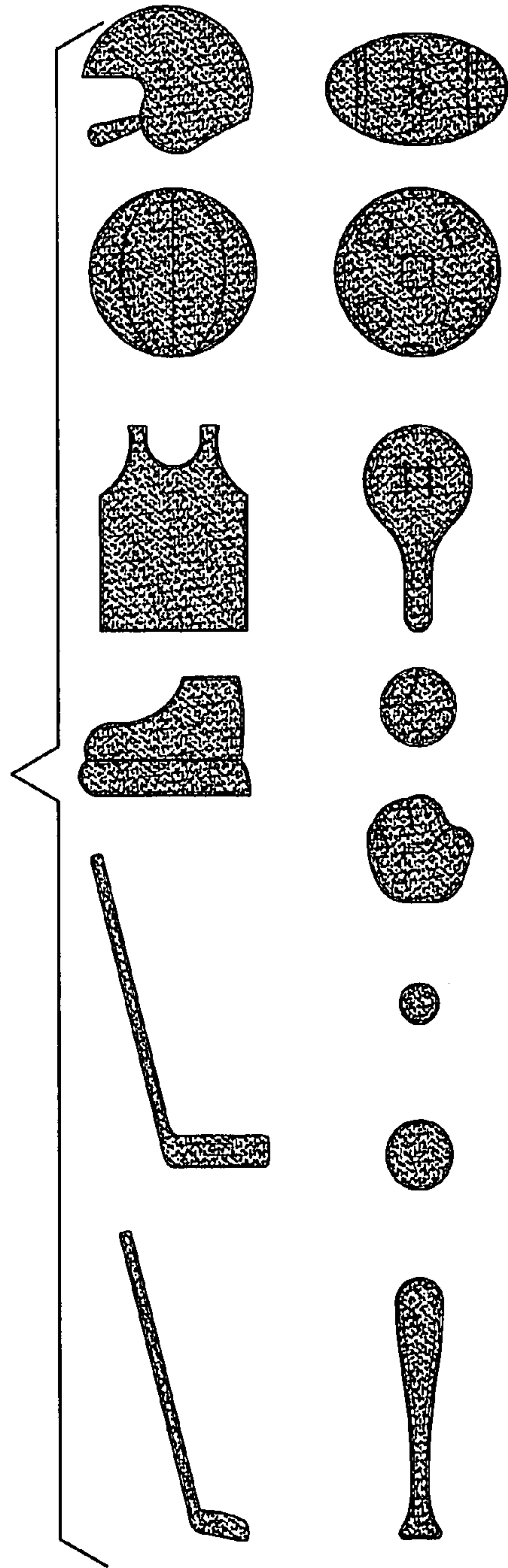

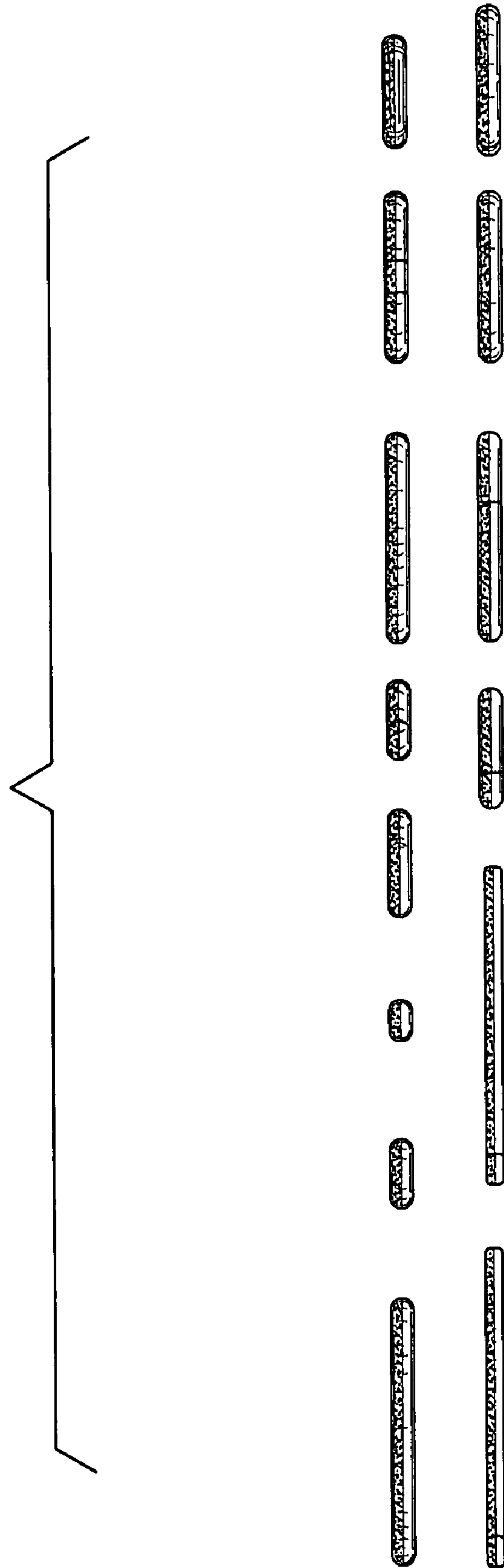
