DESCRIPTION

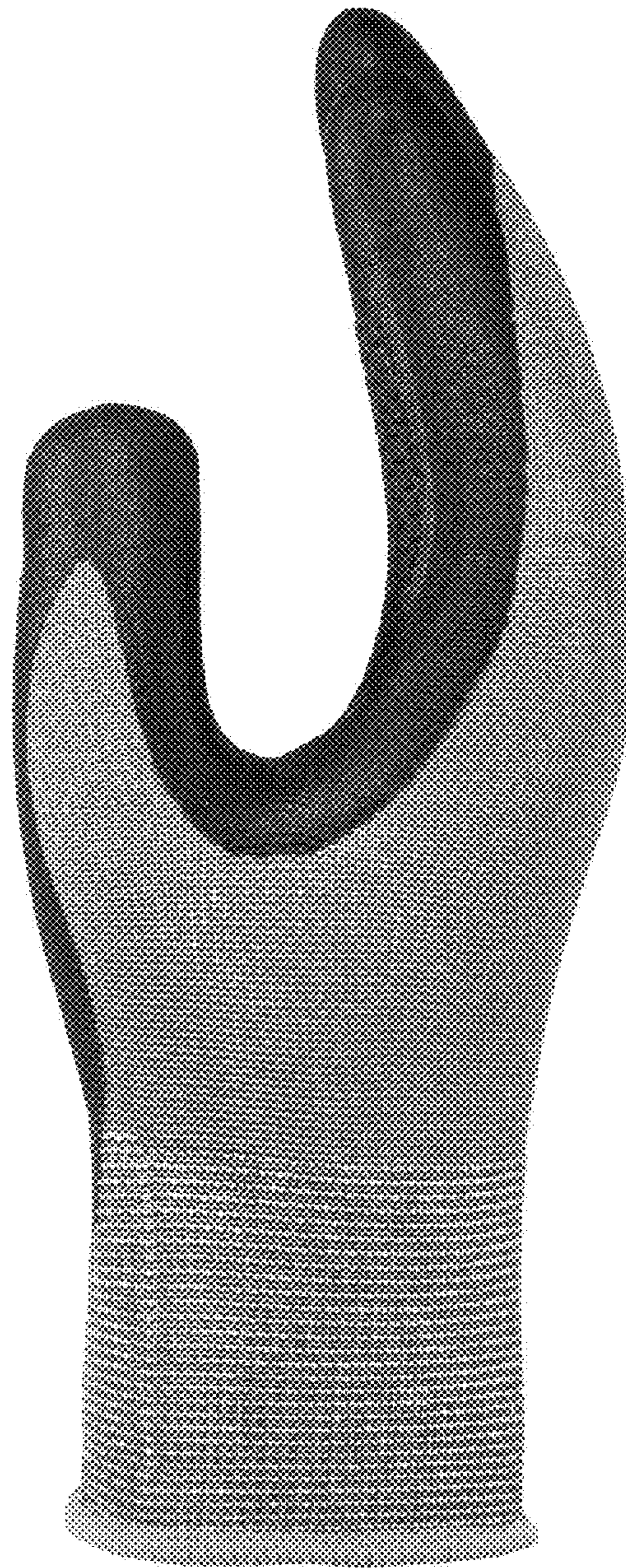

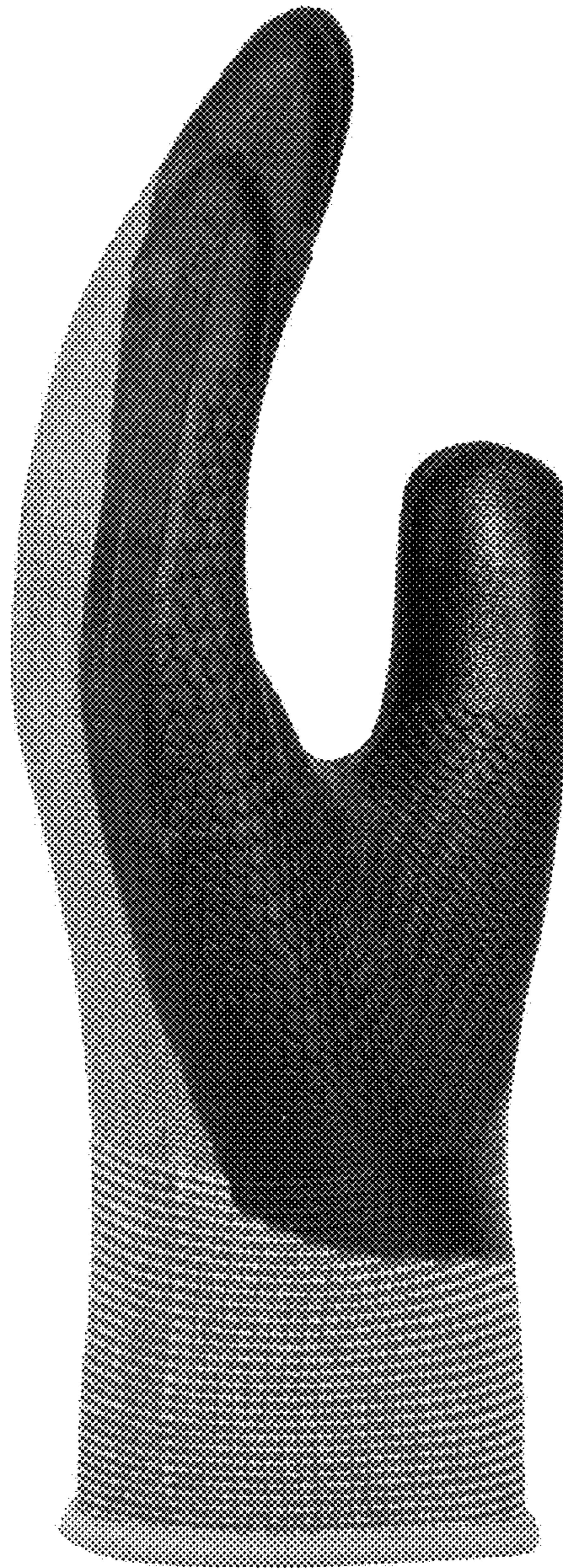

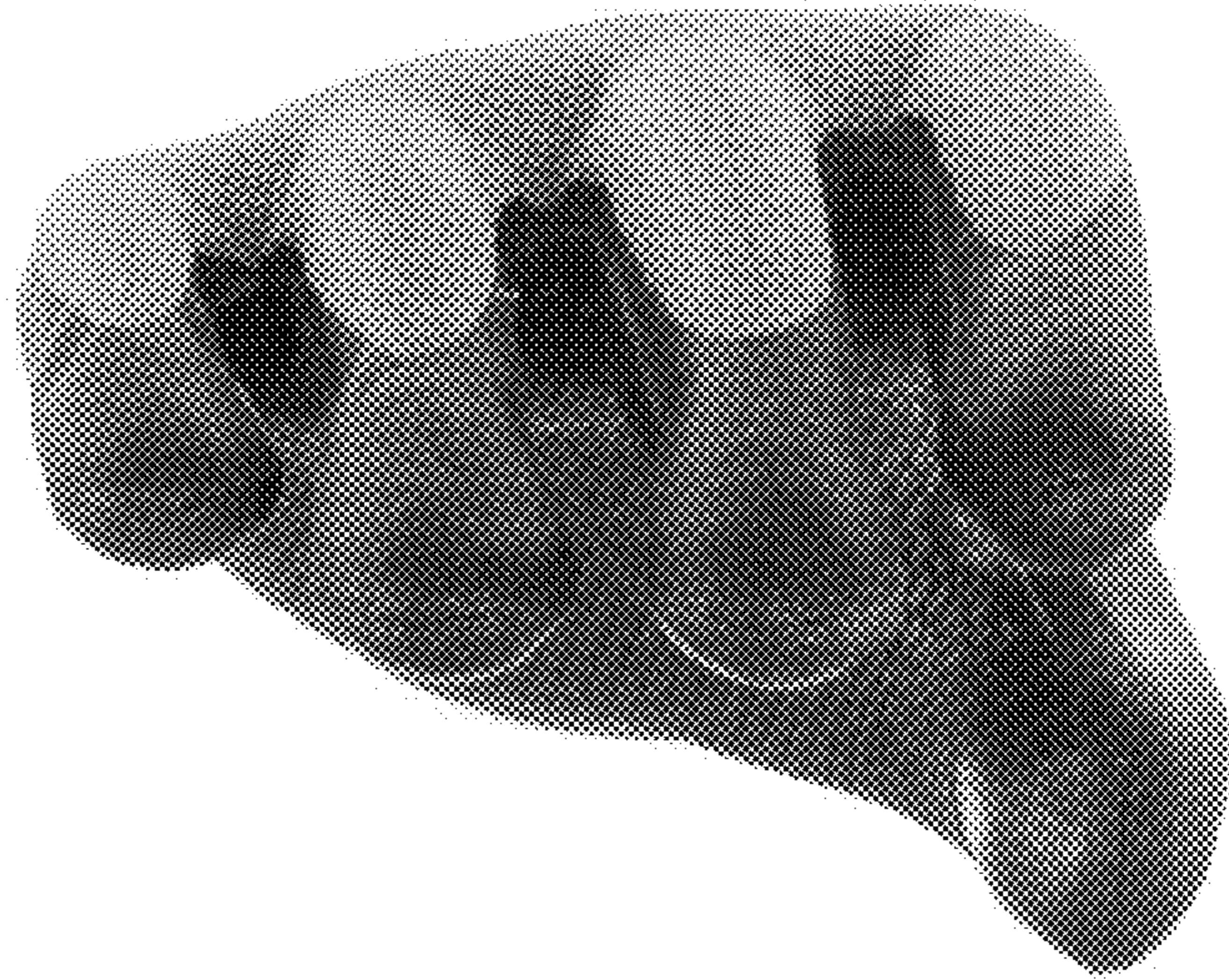

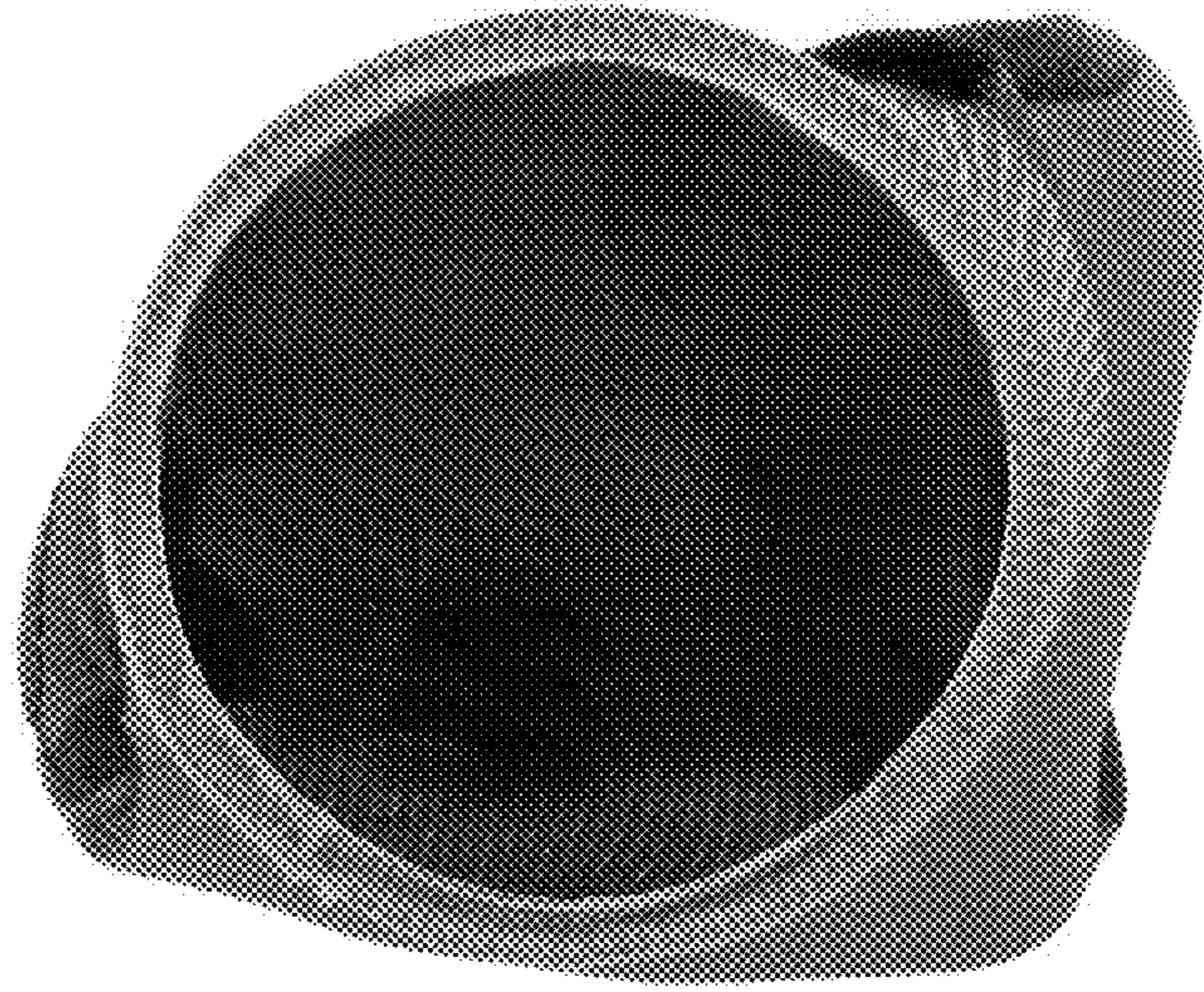

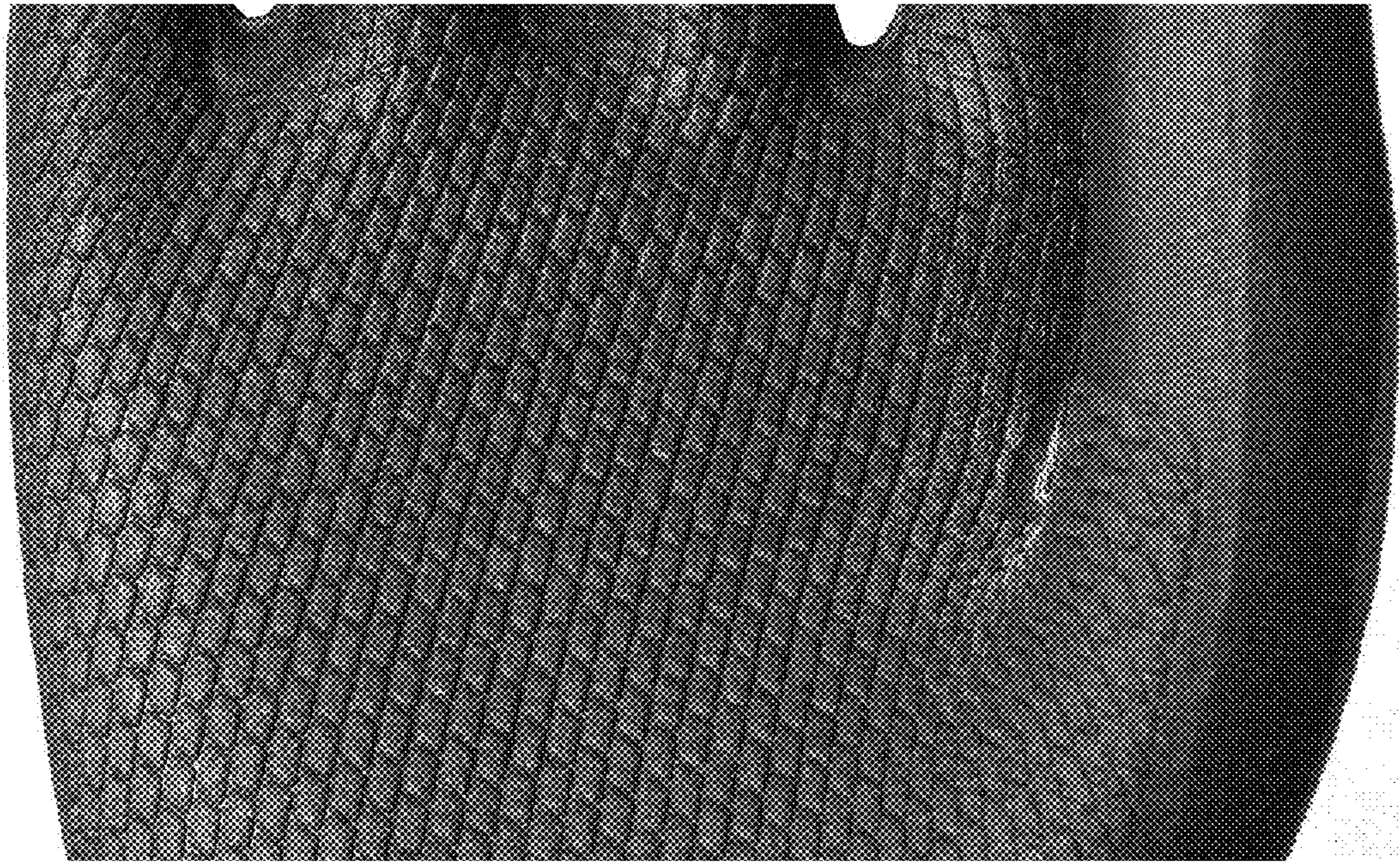
