(57) **CLAIM**

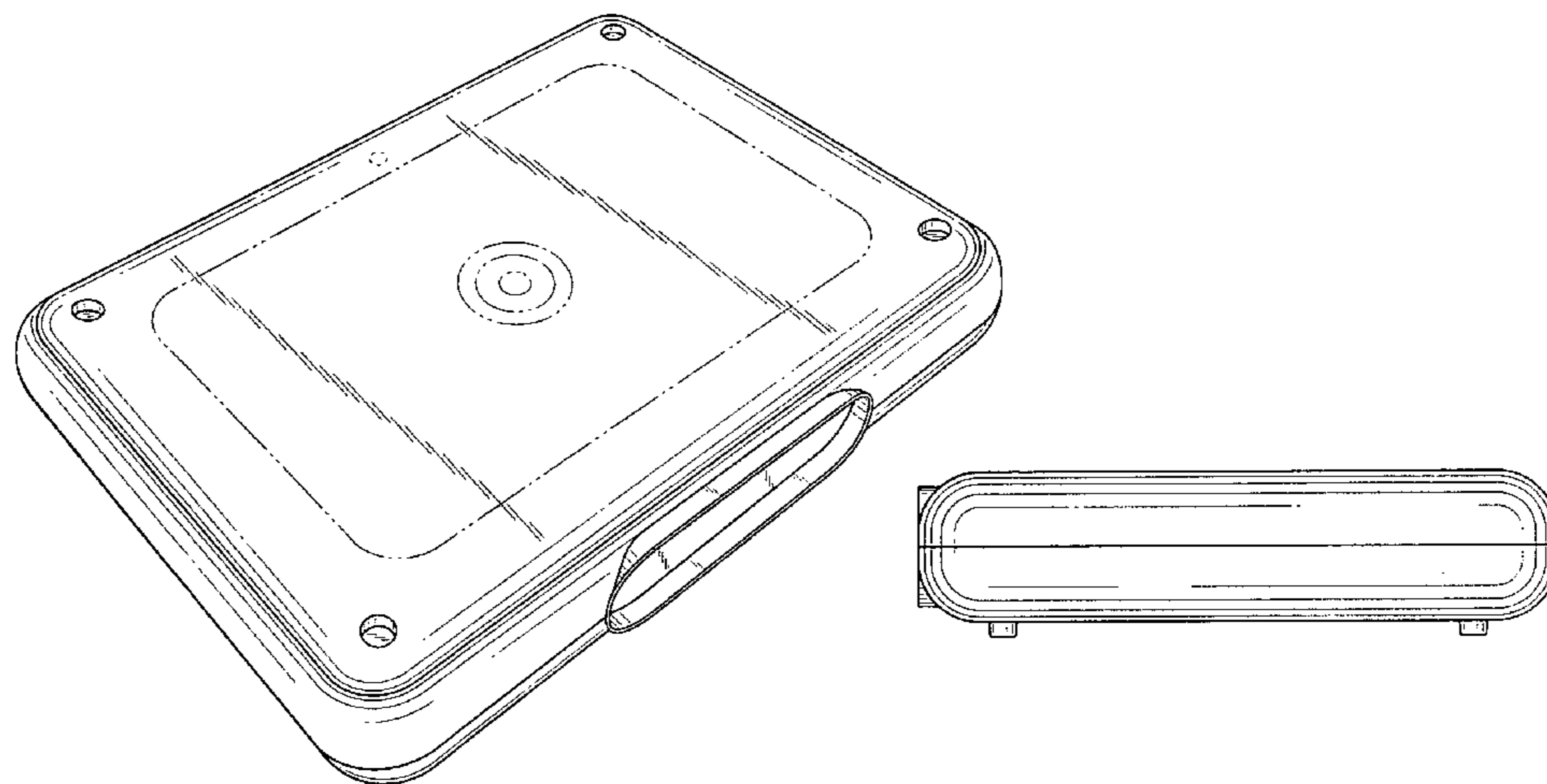
The ornamental design for a container, as shown.

DESCRIPTION

FIG. 1 is an isometric view of a container, according to an embodiment of the invention;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof; and,
FIG. 6 is a right side view thereof with the left side view being a mirror image of the right side view.

The broken lines are for illustrative purposes only and form no part of the claimed design. The rectangular area bounded by broken lines in FIGS. 1 and 2 designates an optional region having a different surface texture than a surrounding area of the container. The remaining broken lines show optional indicia and other optional features.

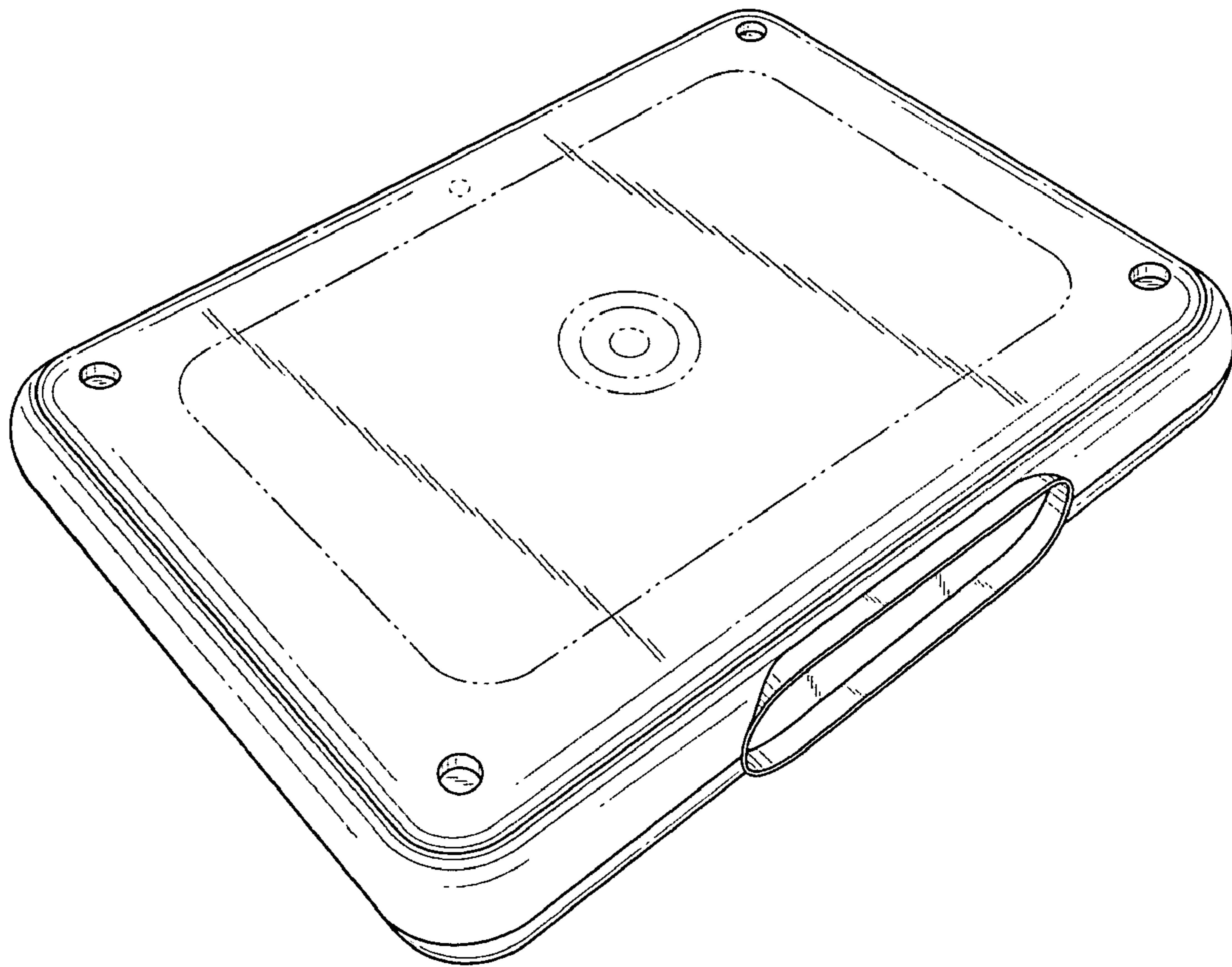

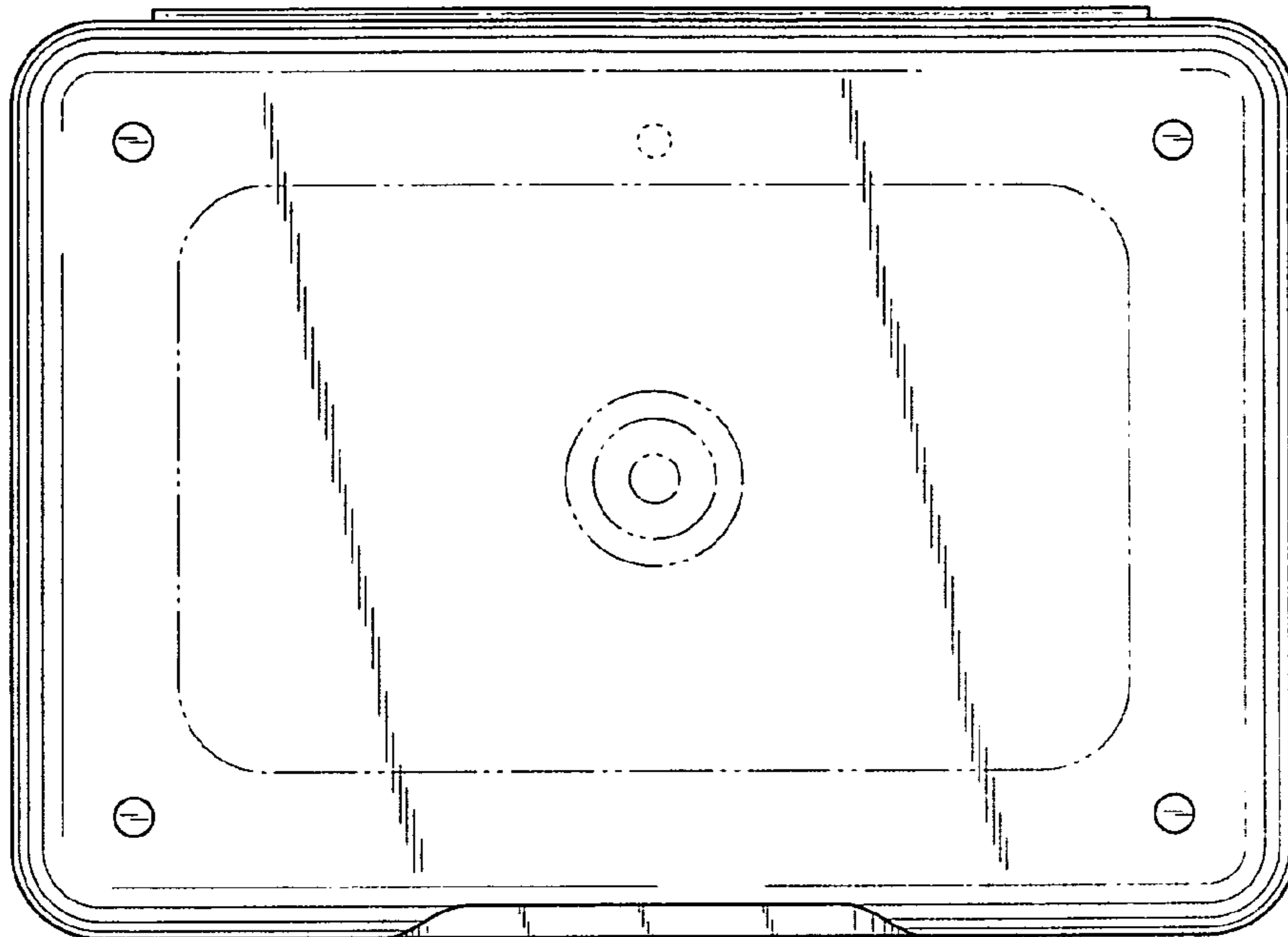

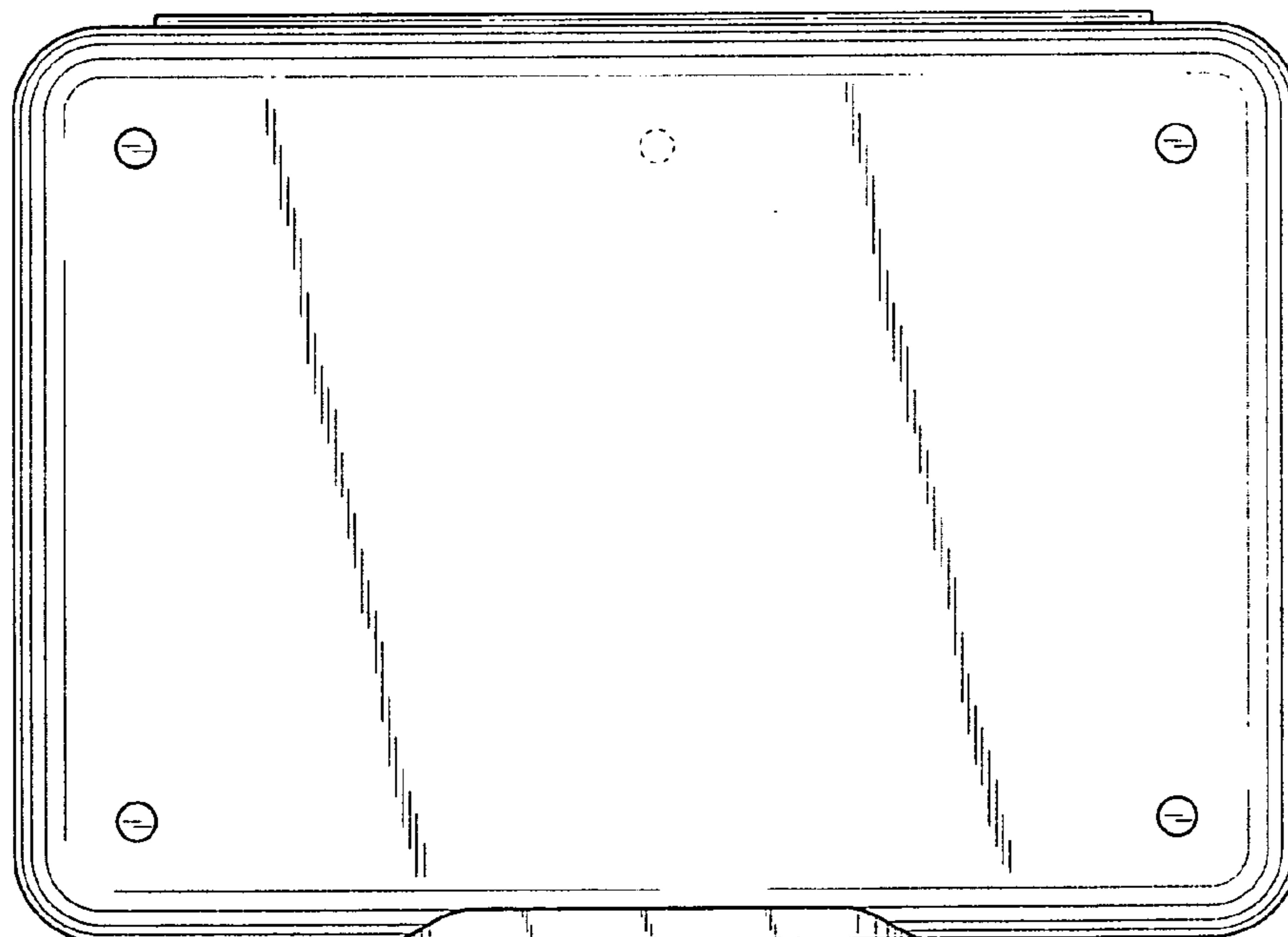

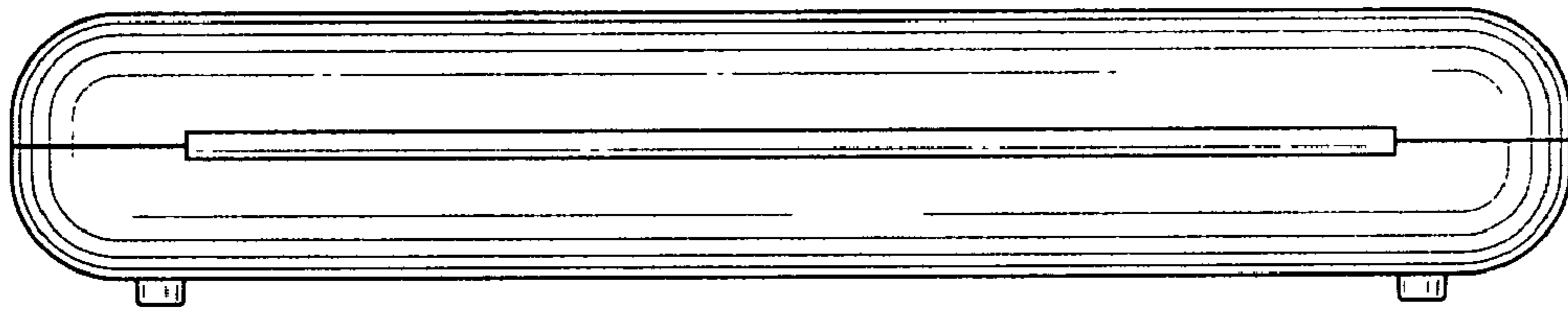

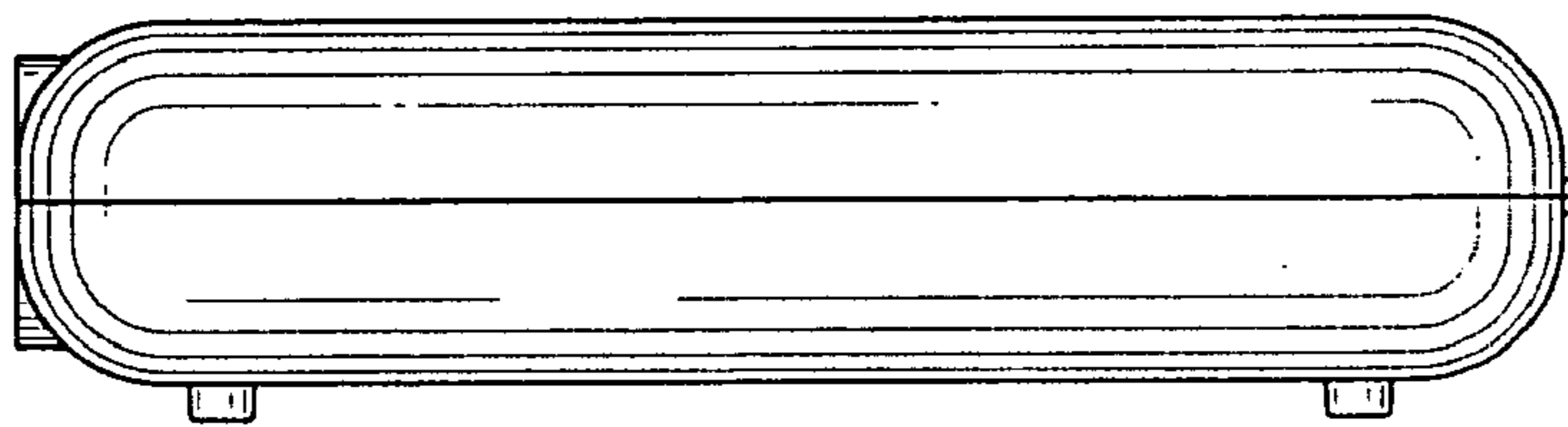
