FIG. 4 is a rear plan view of the coffee machine of FIG. 1;

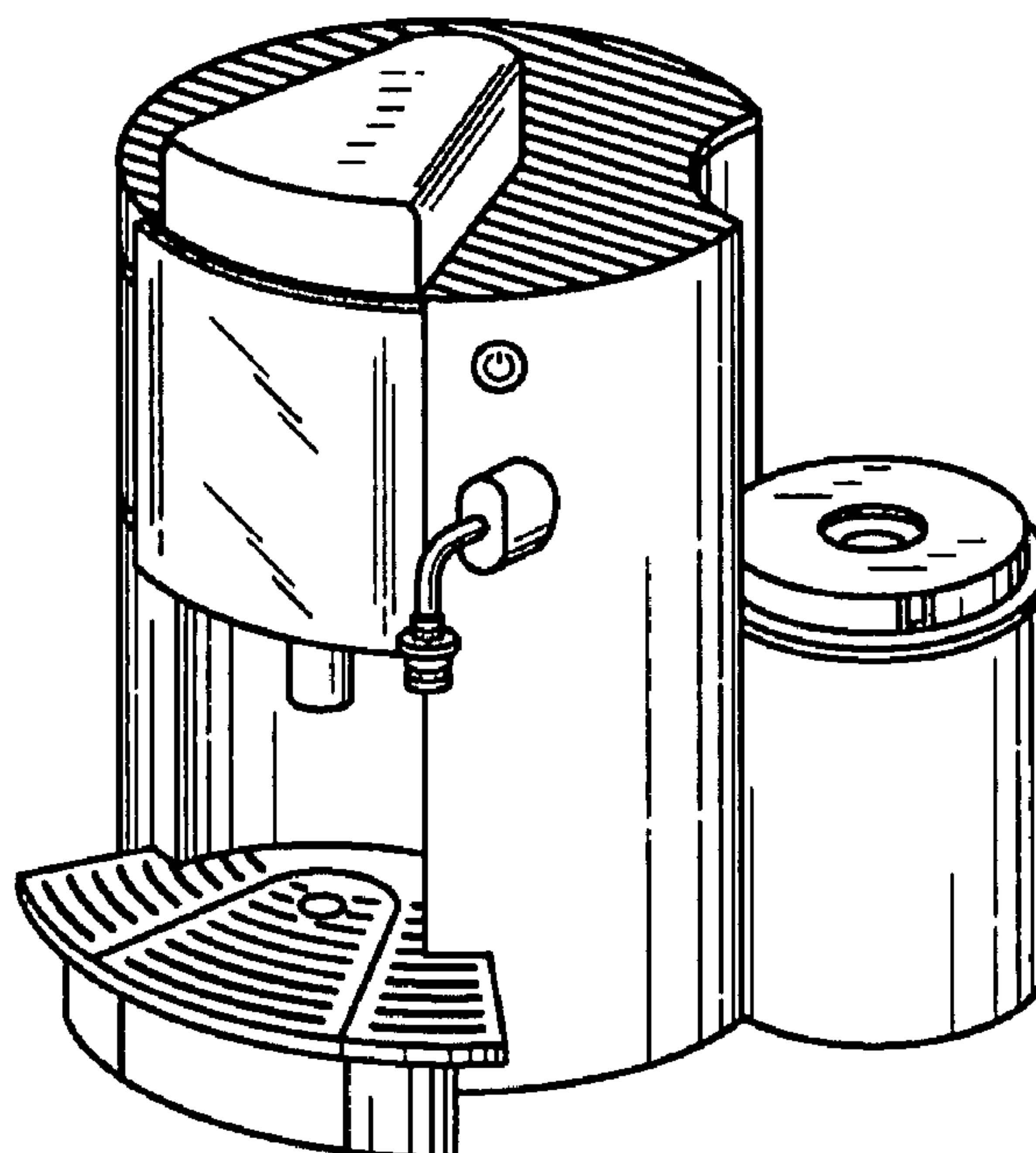
FIG. 5 is a left side view of the coffee machine of FIG. 1;

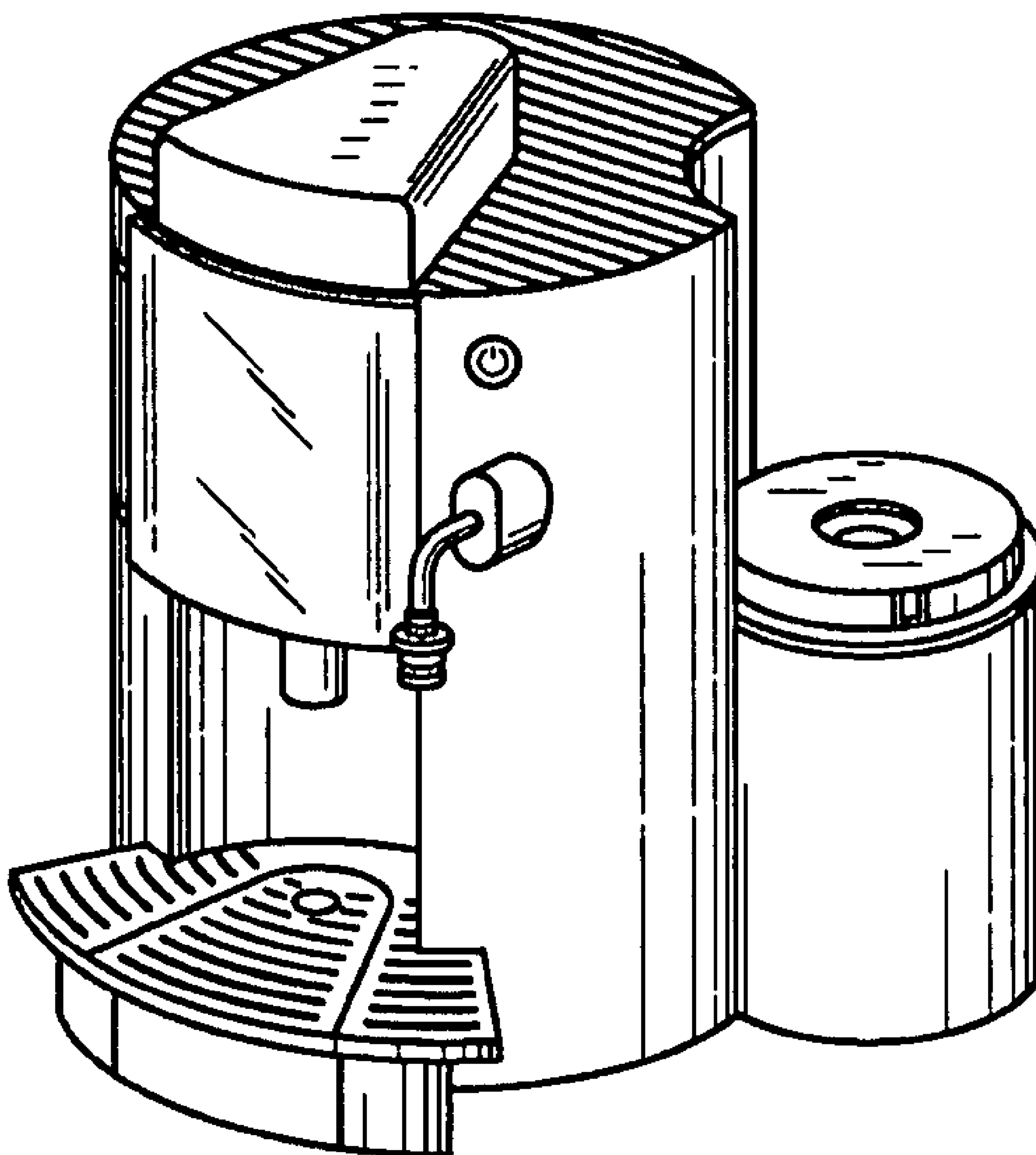

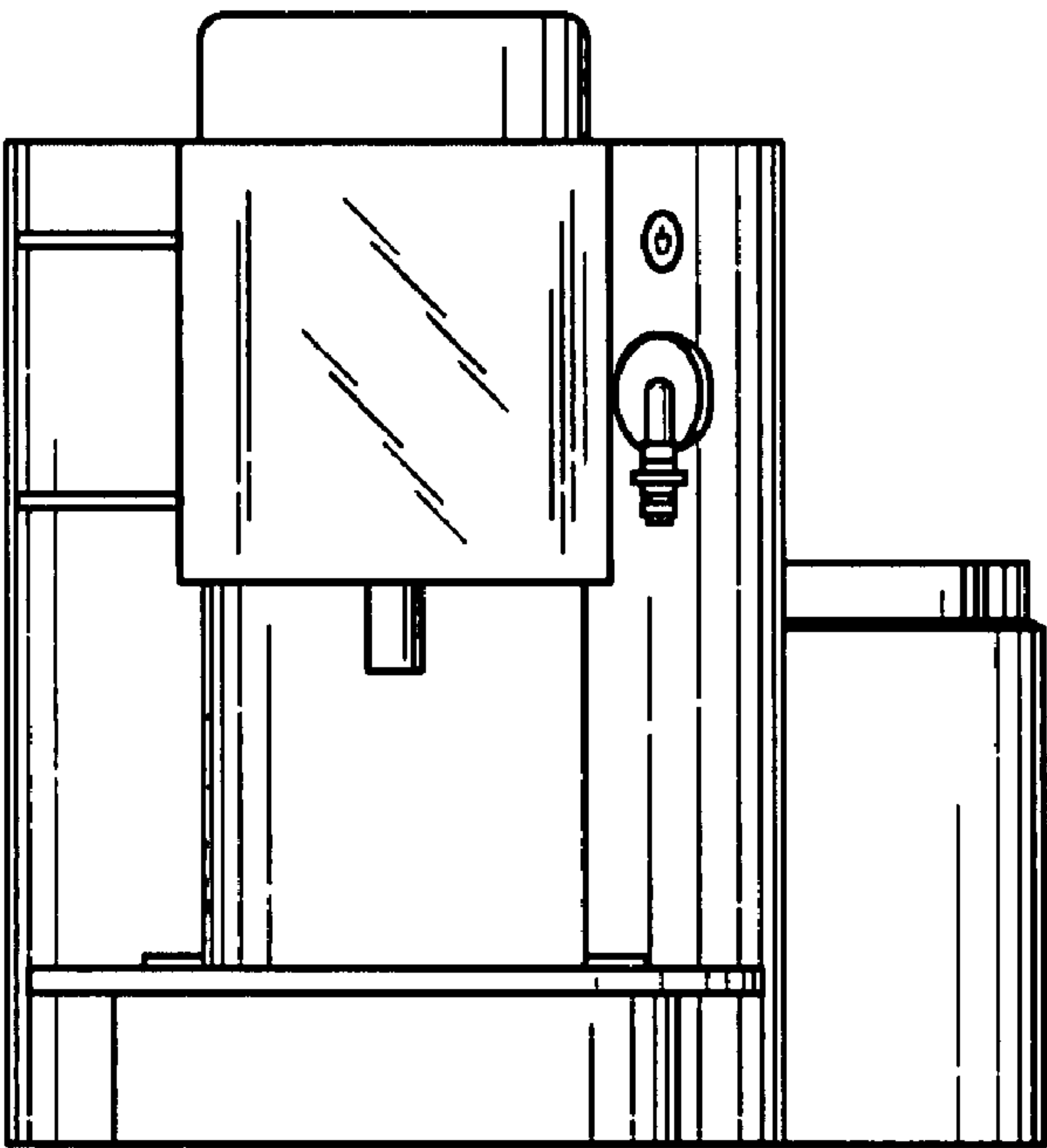

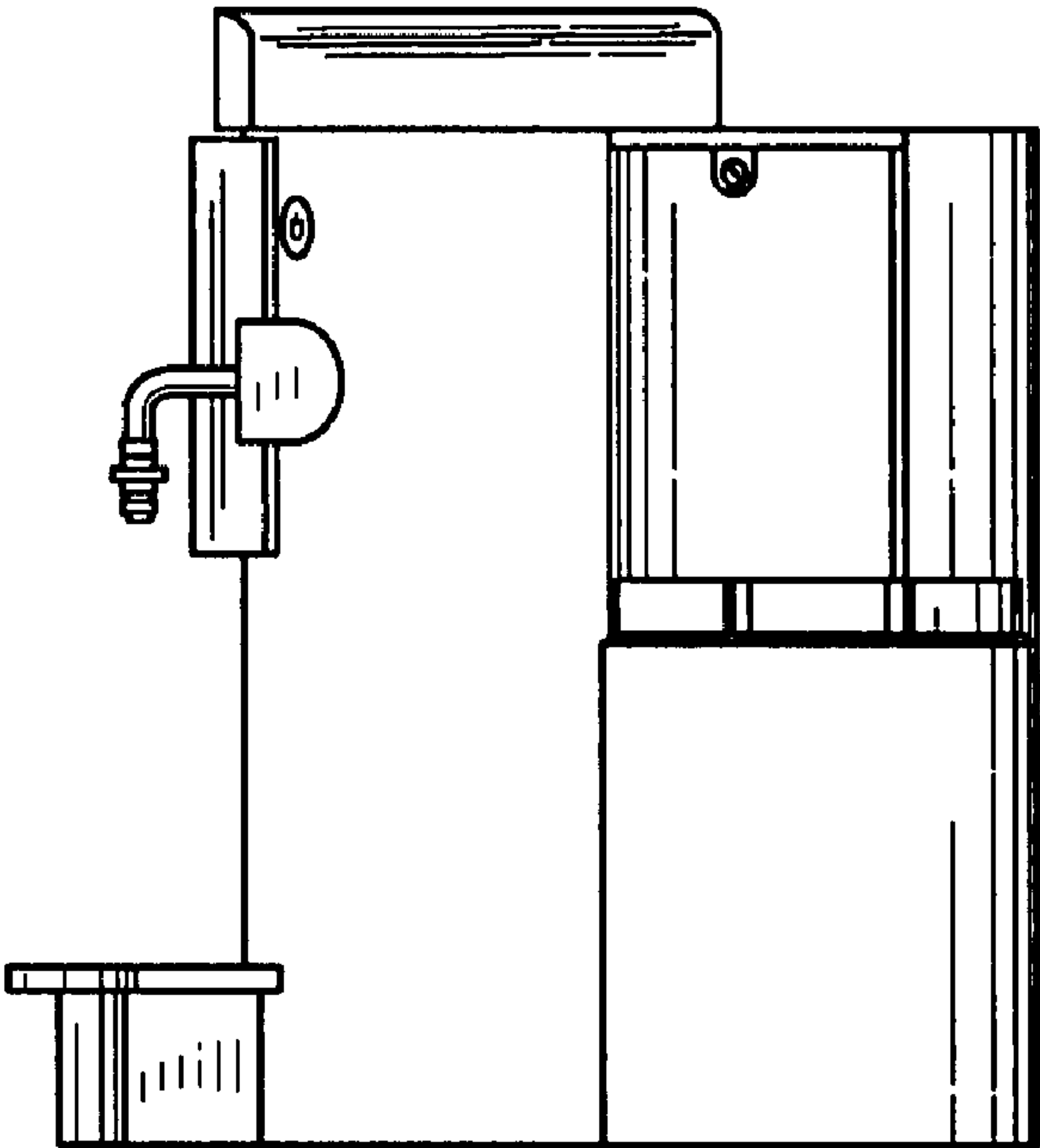

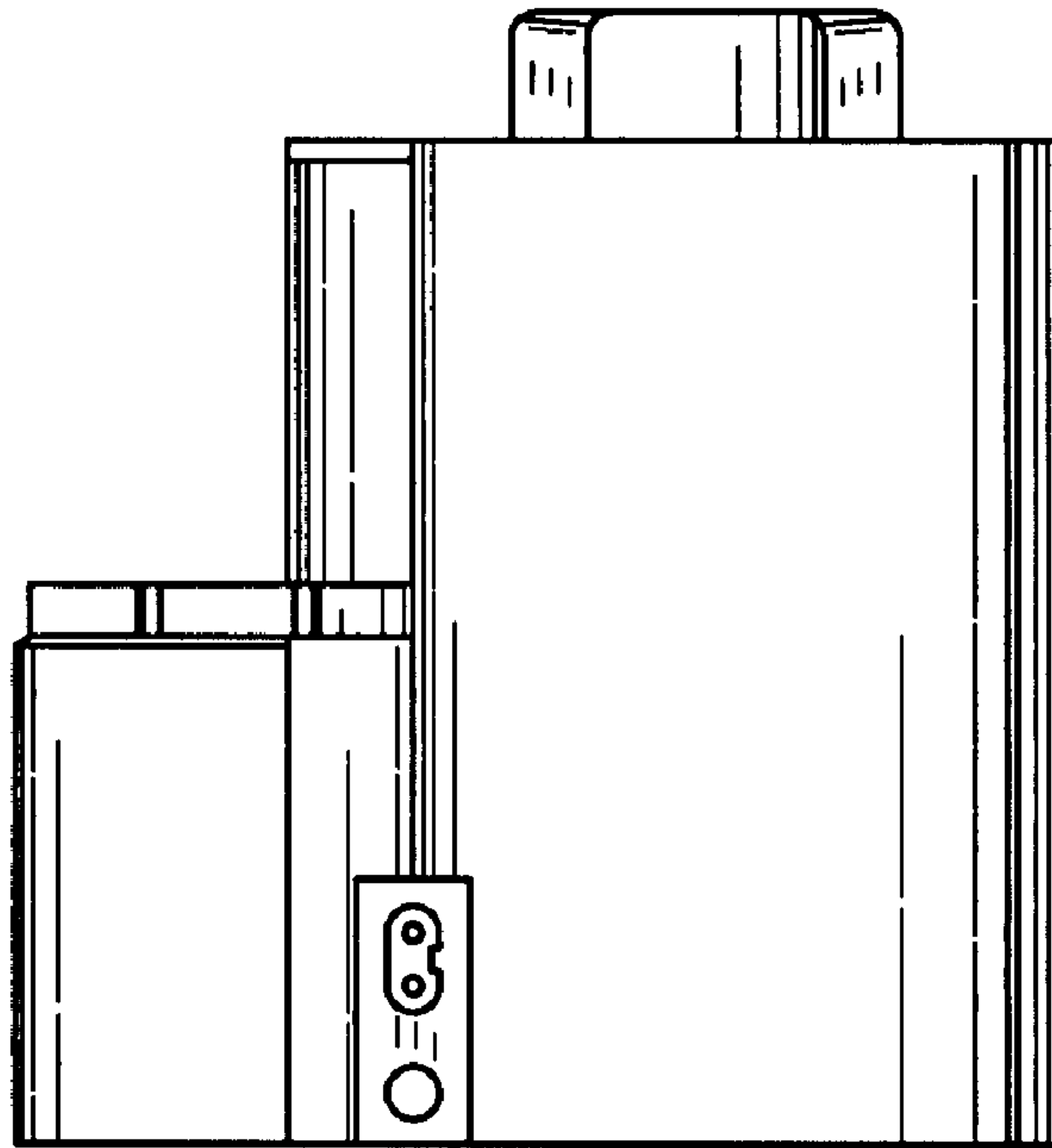

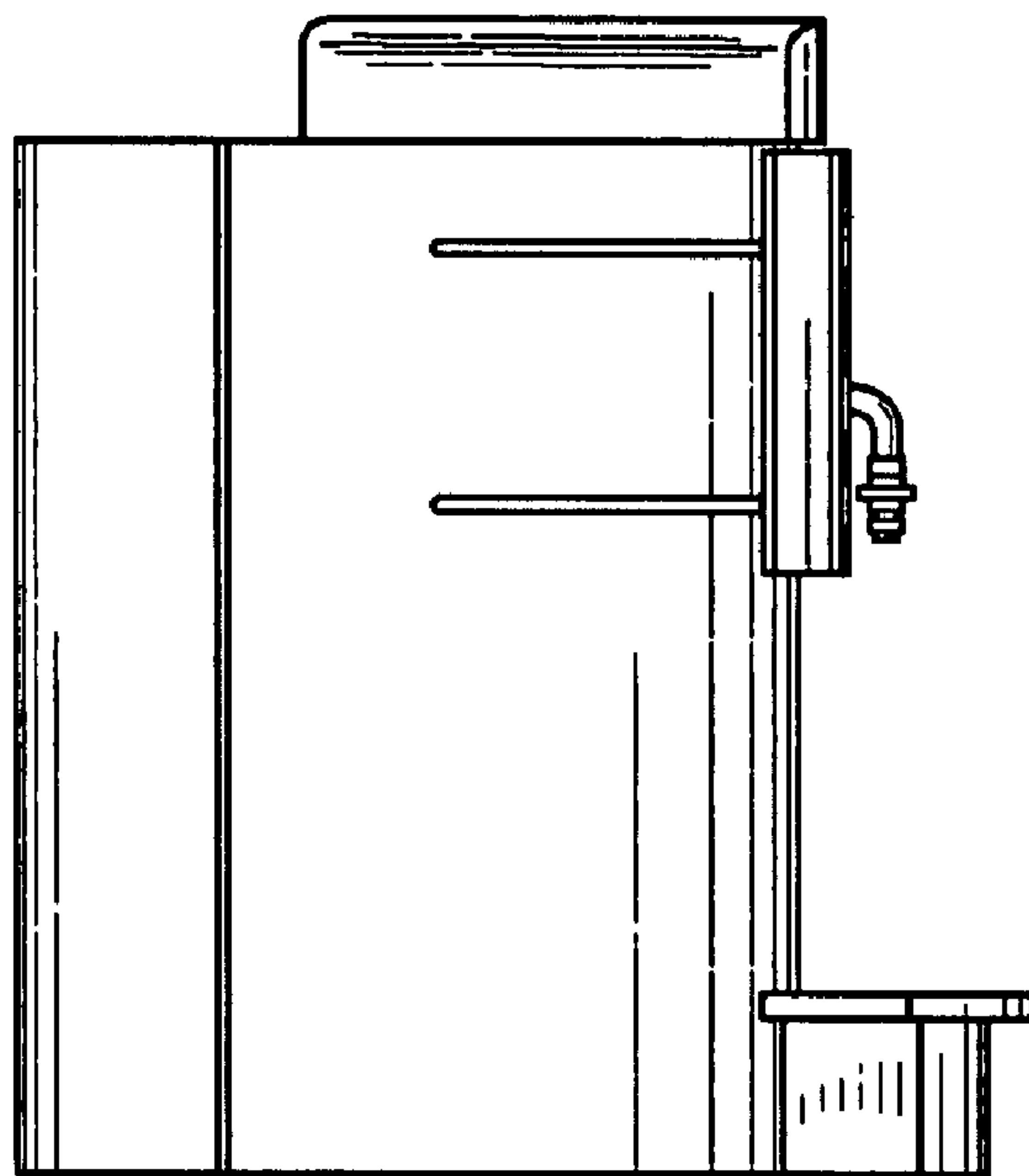

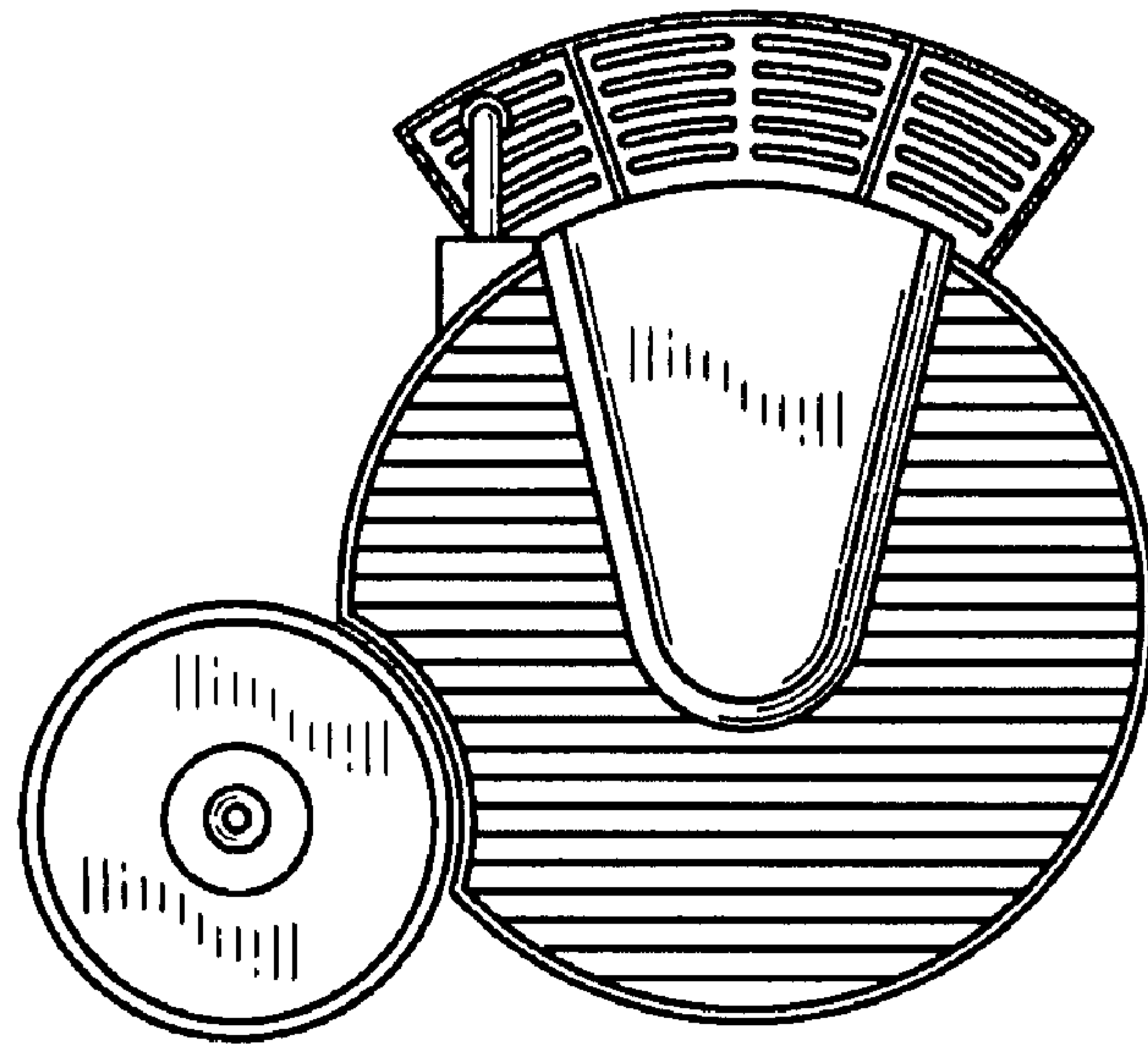

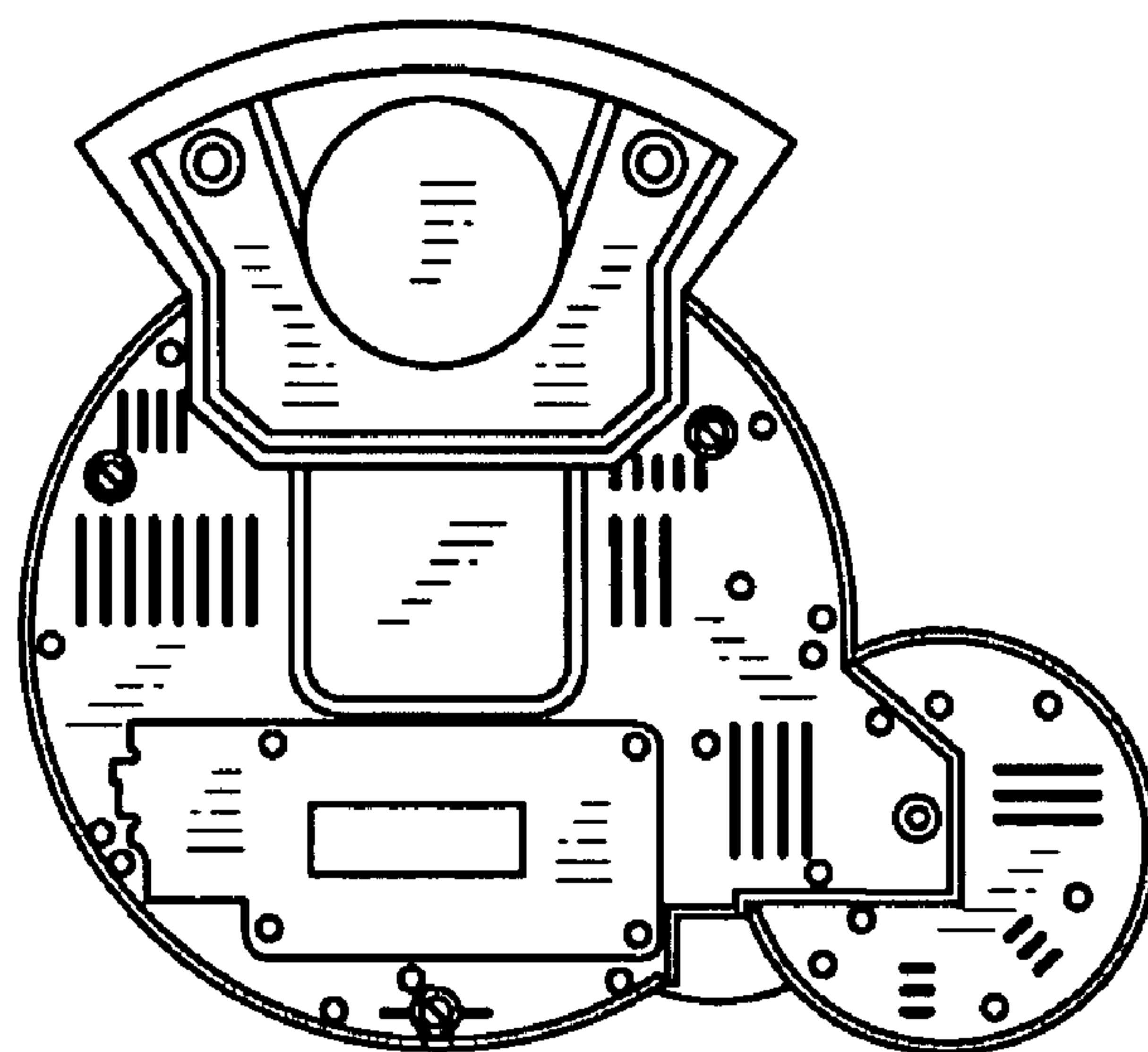
