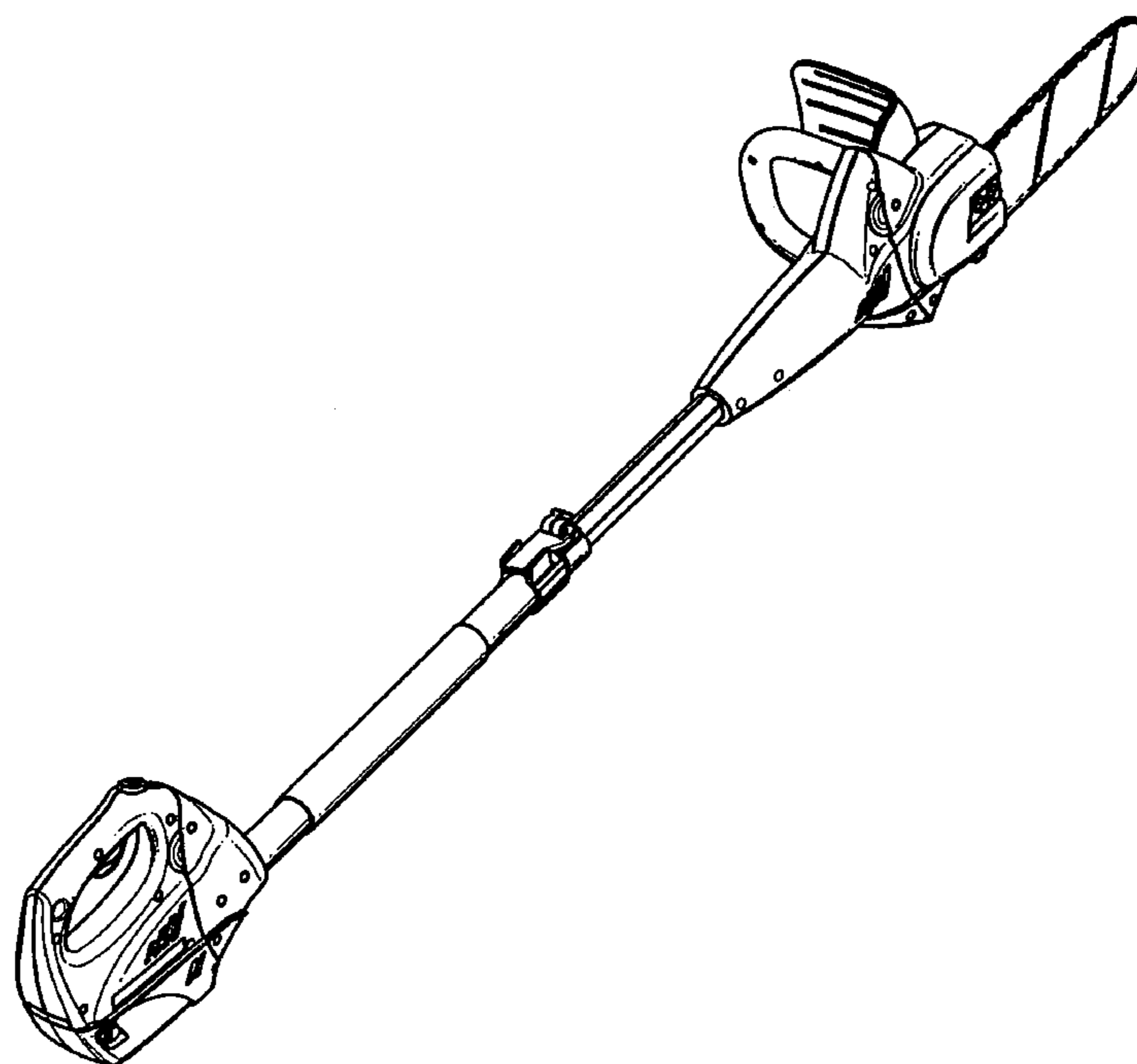
FIG. 5 is a bottom view of the design of the present invention;

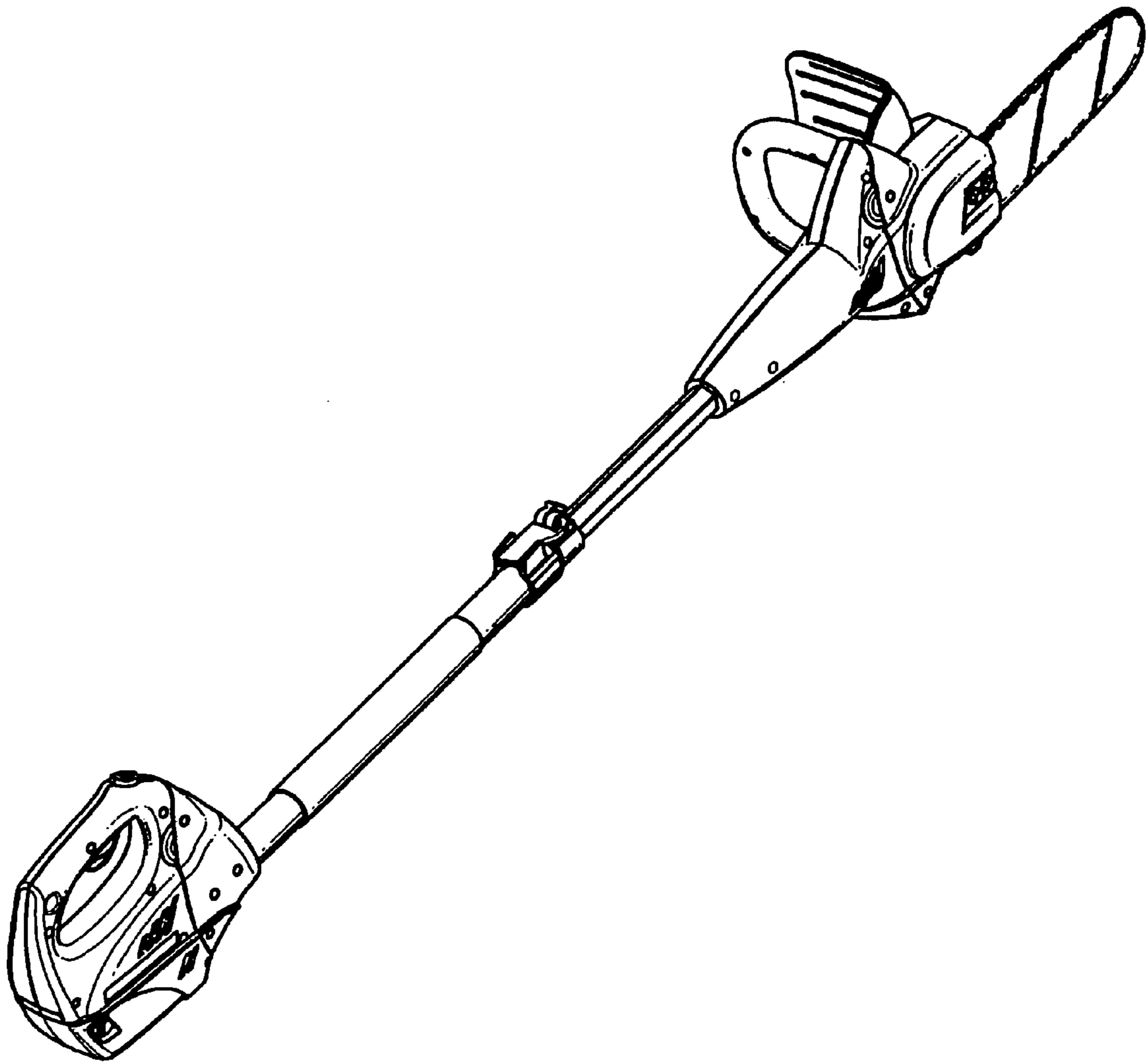

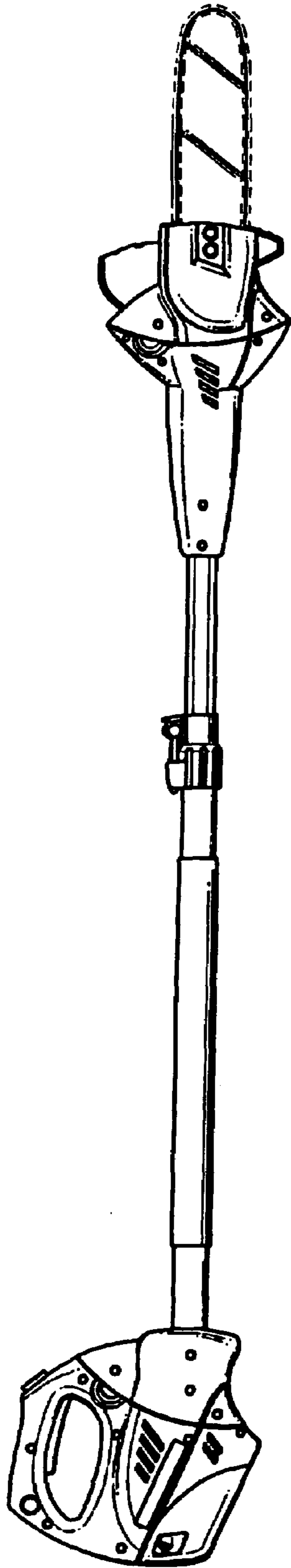

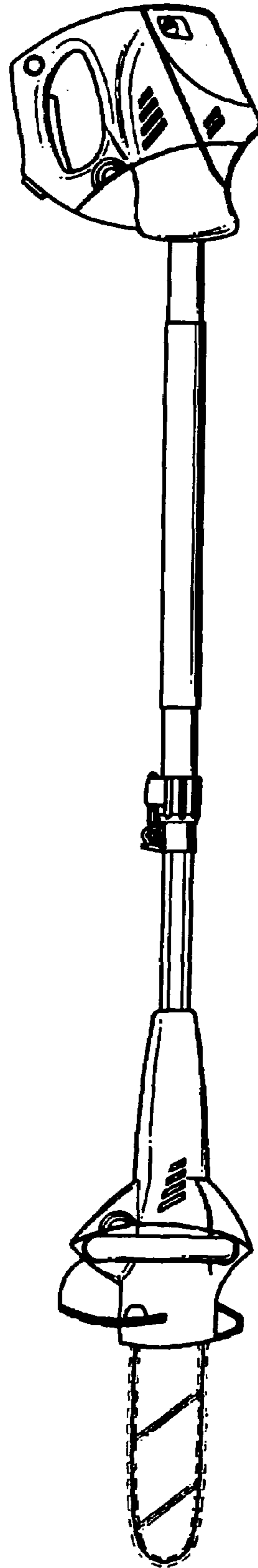

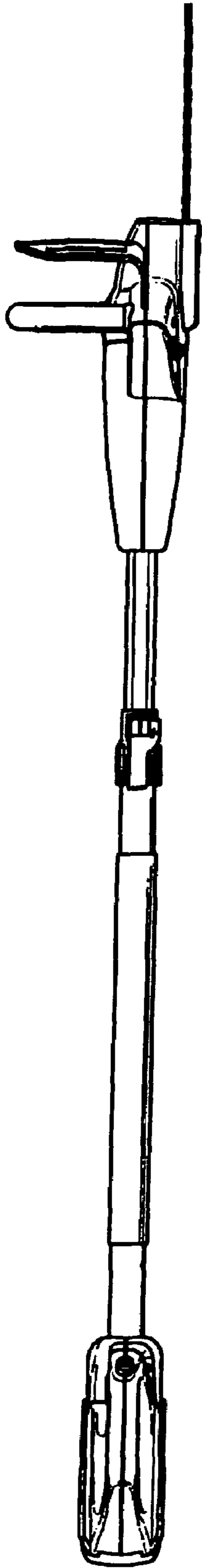

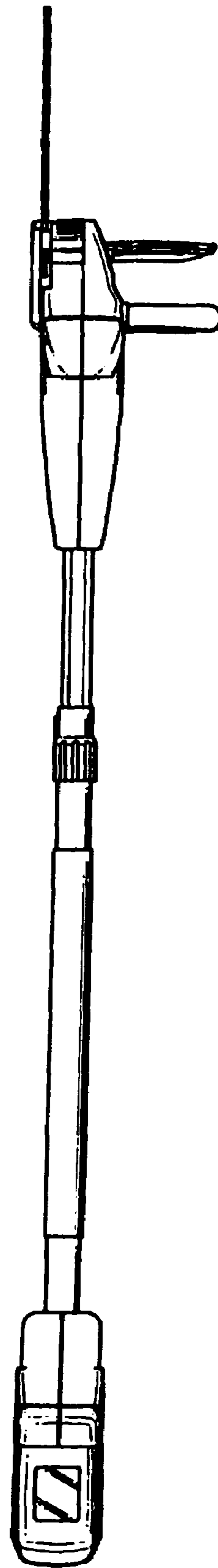

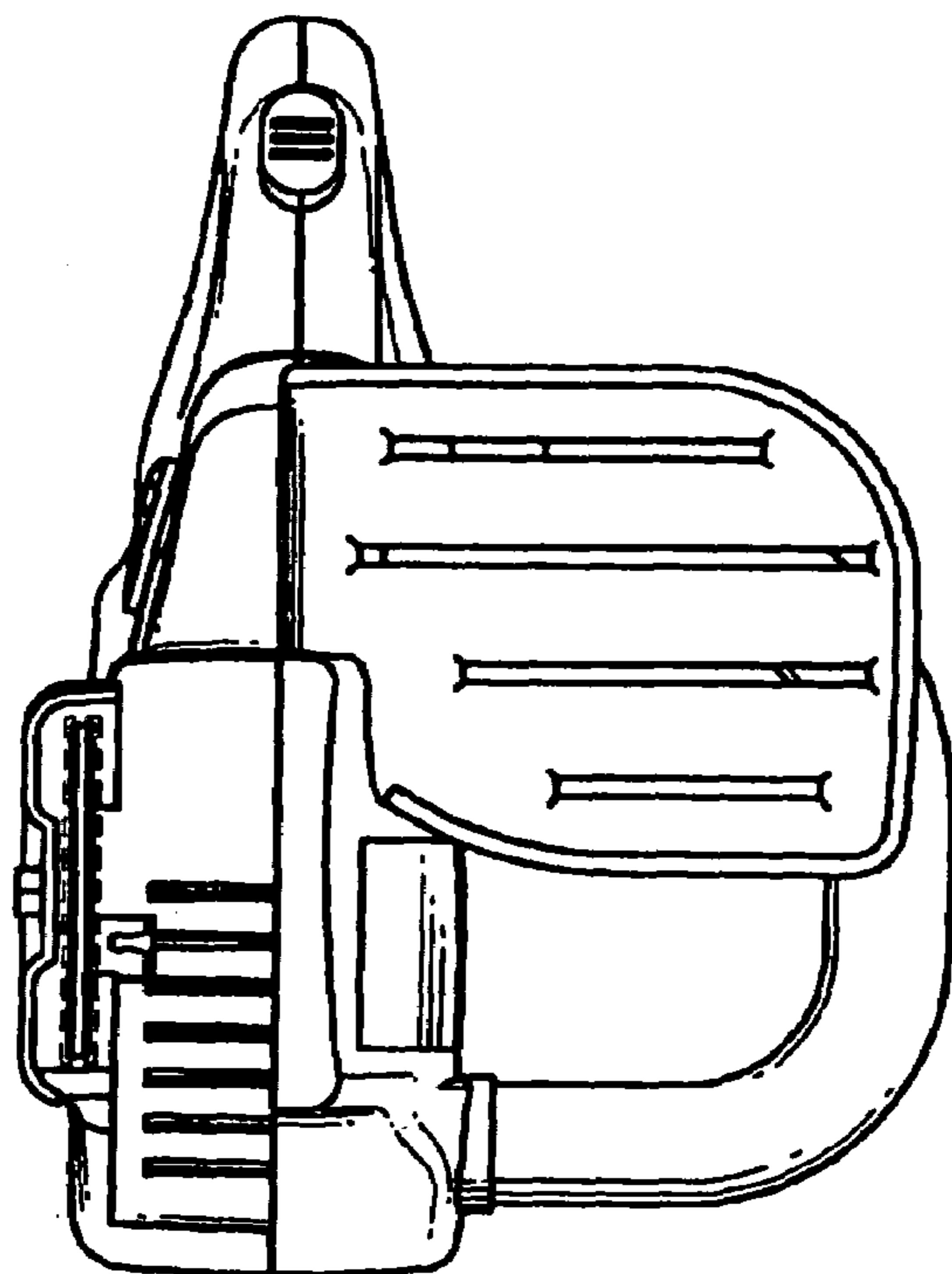

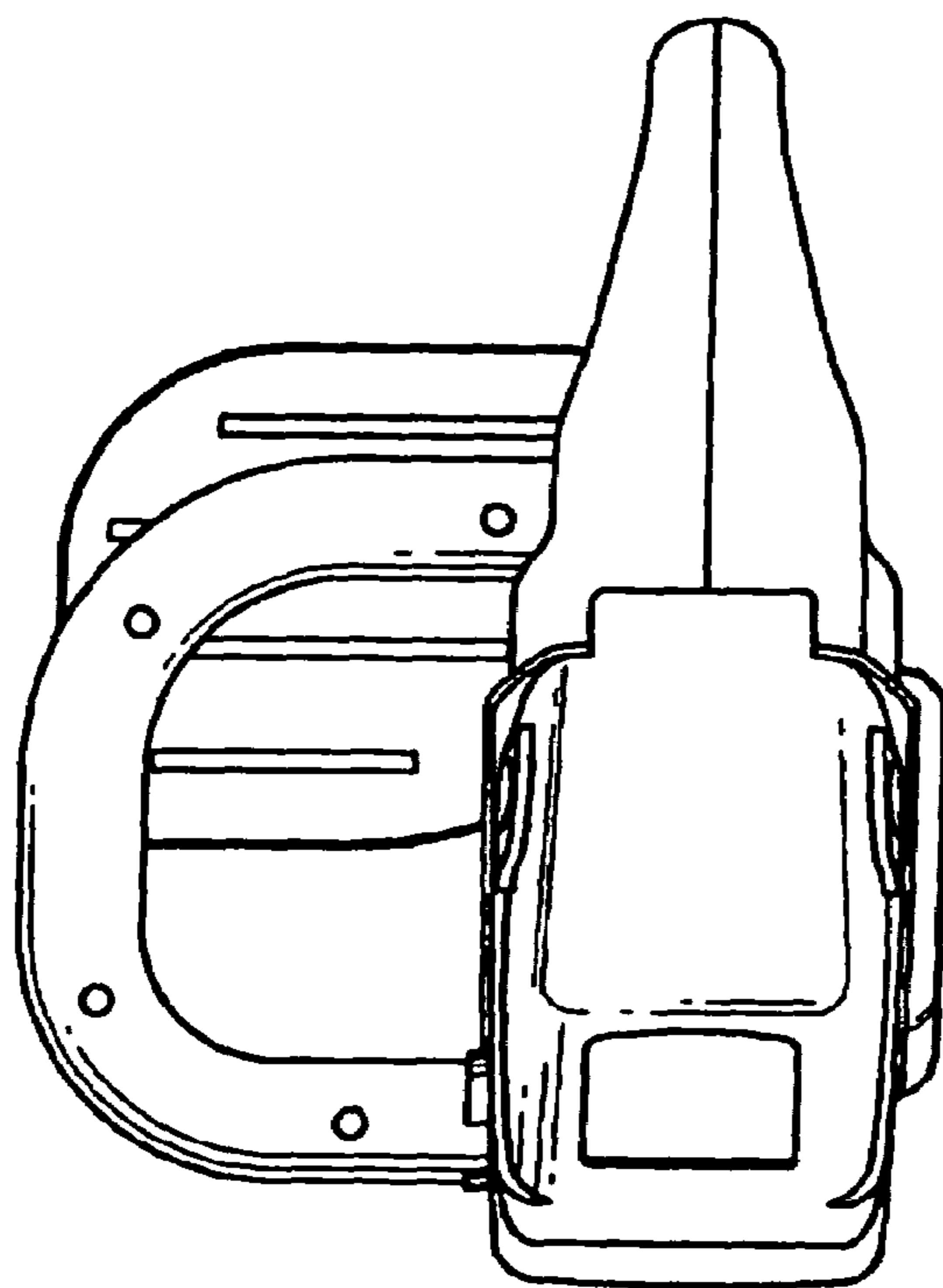
