(57) **CLAIM**

The ornamental design for a 90 degree locking lift hinge, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the 90 degree locking lift hinge.
 FIG. 2 is a right side view of said 90 degree locking lift hinge.
 FIG. 3 is a left side view of said 90 degree locking lift hinge.
 FIG. 4 is a rear view of said 90 degree locking lift hinge.
 FIG. 5 is a top view of said 90 degree locking lift hinge.
 FIG. 6 is a bottom view of said 90 degree locking lift hinge;
 and,
 FIG. 7 is a rear view of said 90 degree locking lift hinge in an alternative closed position.
