FIG. 1 is a top view of a joinder clip showing my new design;

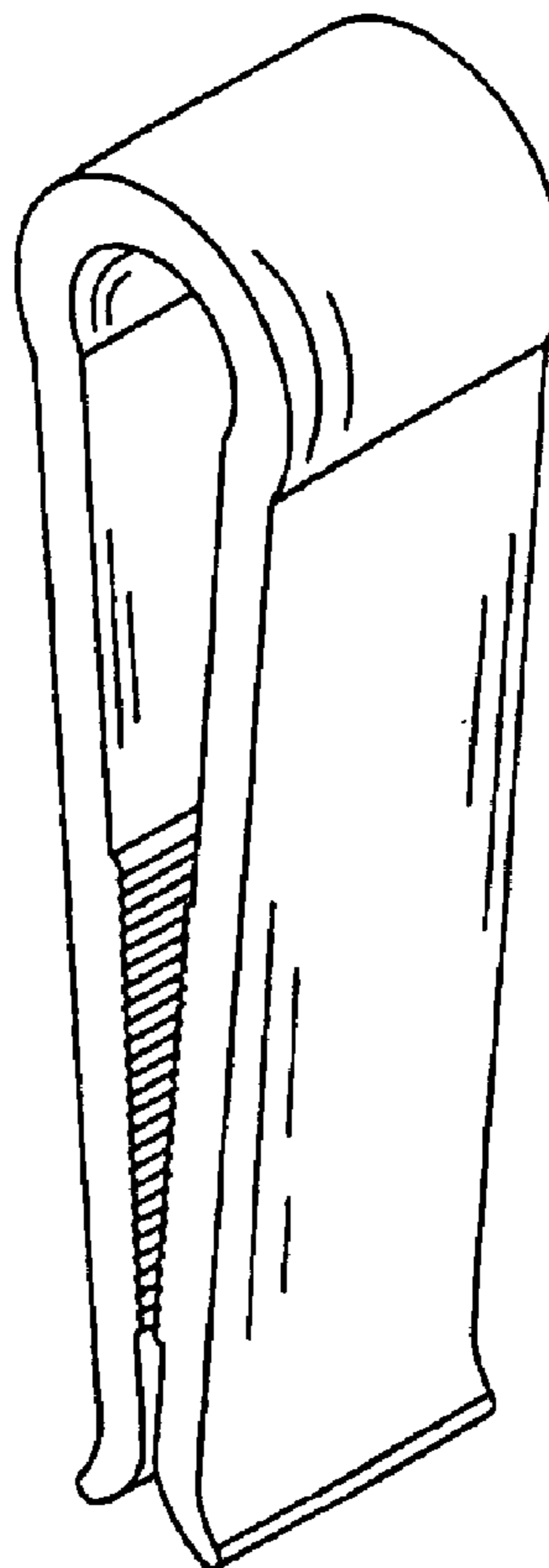
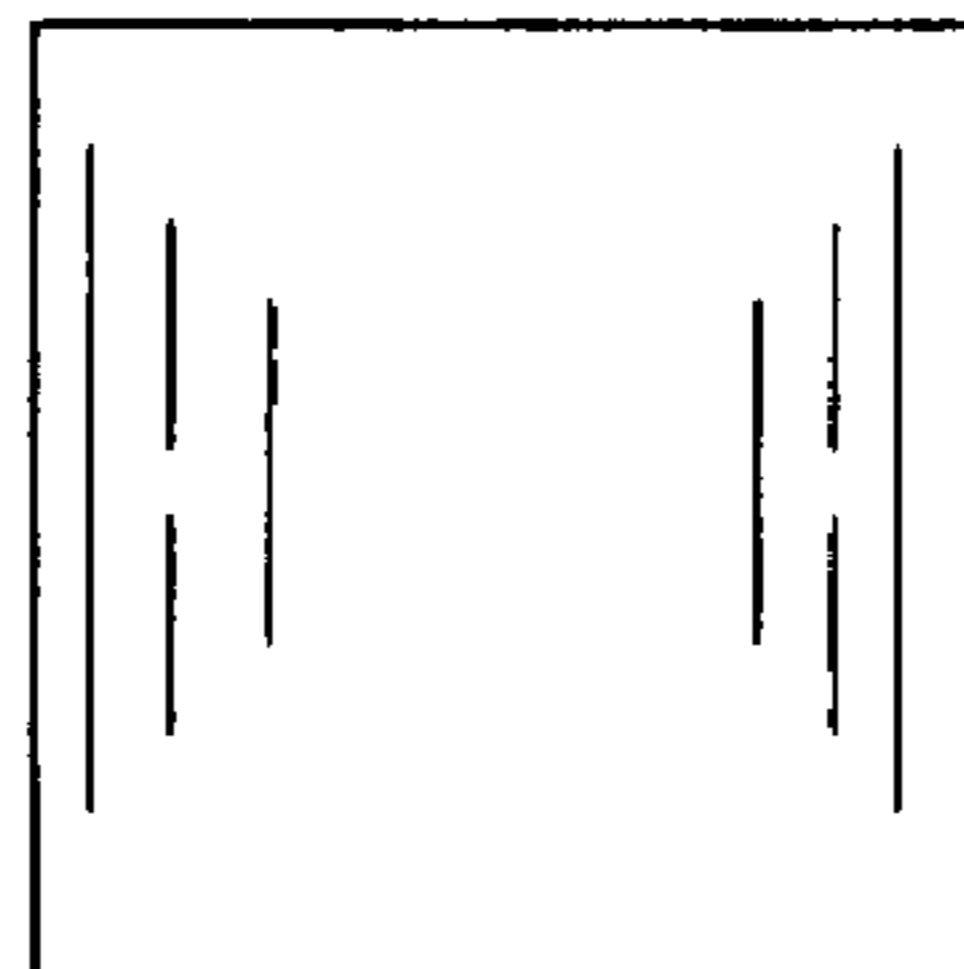
FIG. 2 is a front view thereof; the rear view being the same as the front view;

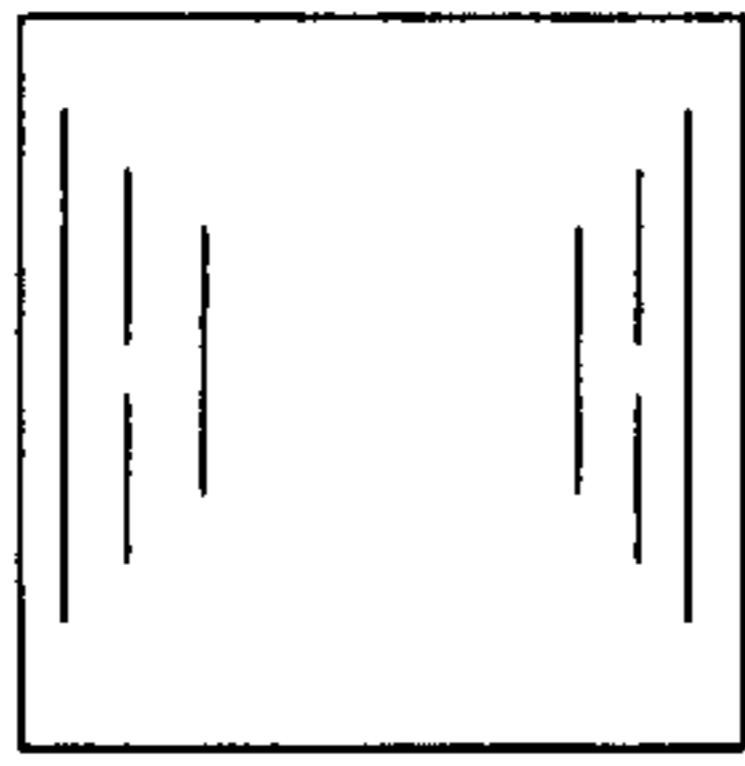
FIG. 3 is a bottom view thereof;

FIG. 4 is a top left rear perspective view thereof; and,

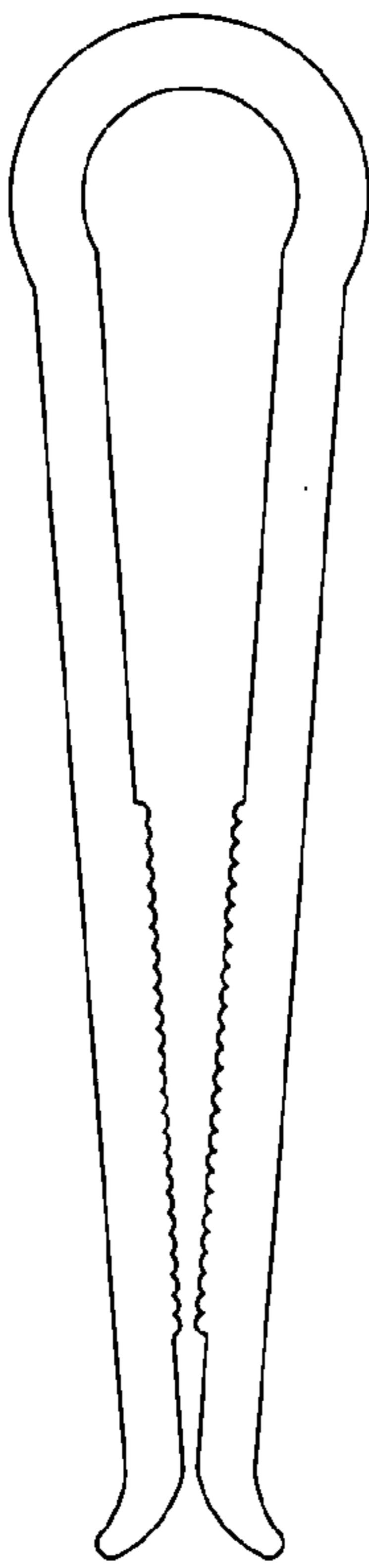
FIG. 5 is a top left front perspective view thereof.

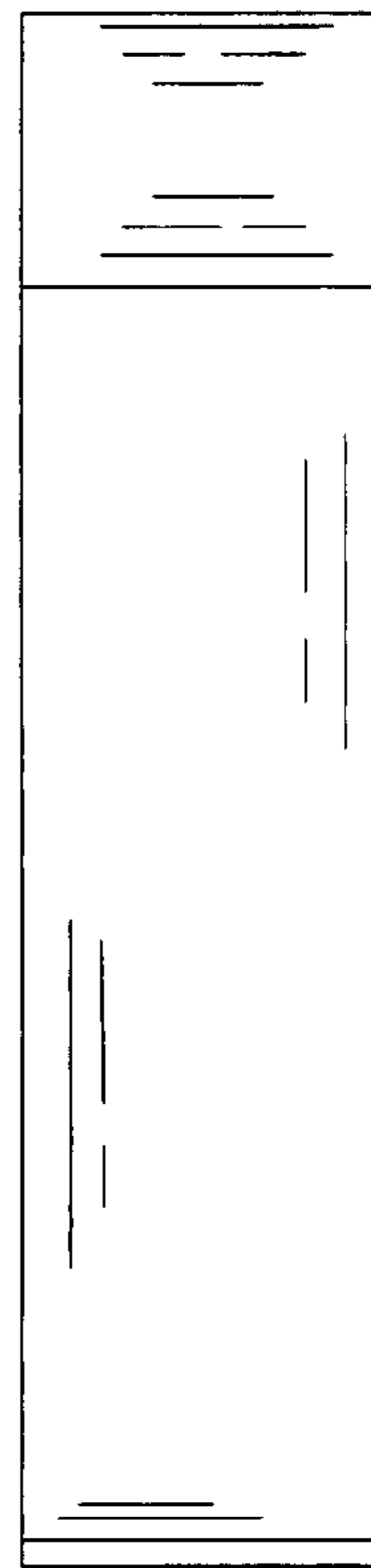




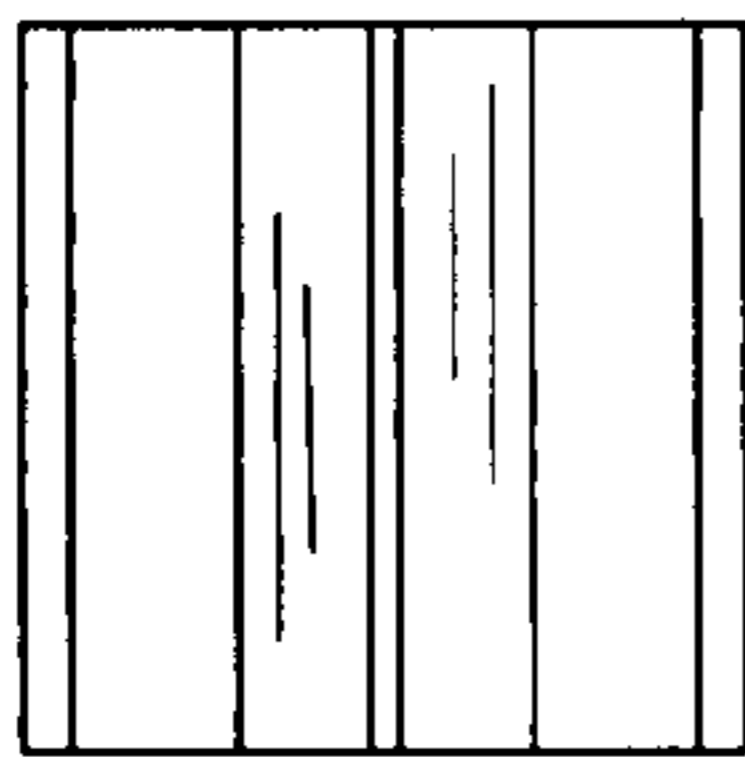

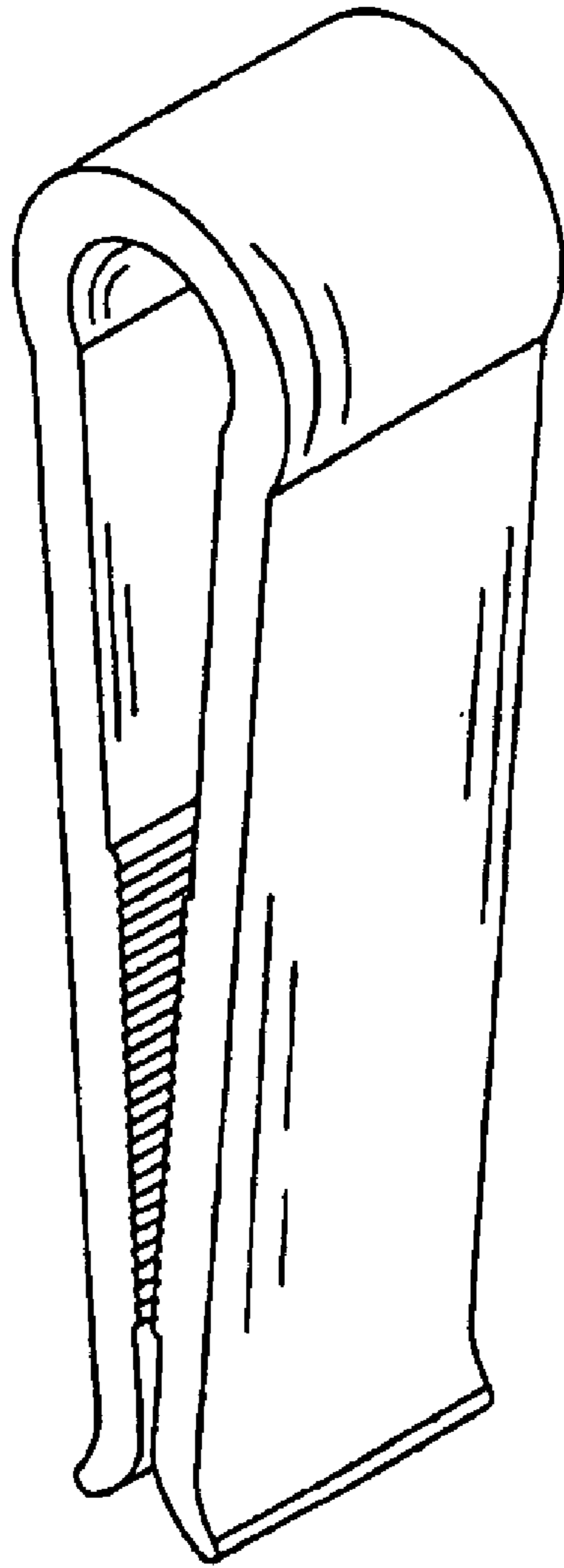
