FIG. 3 is the back view of the cap according to the present invention;

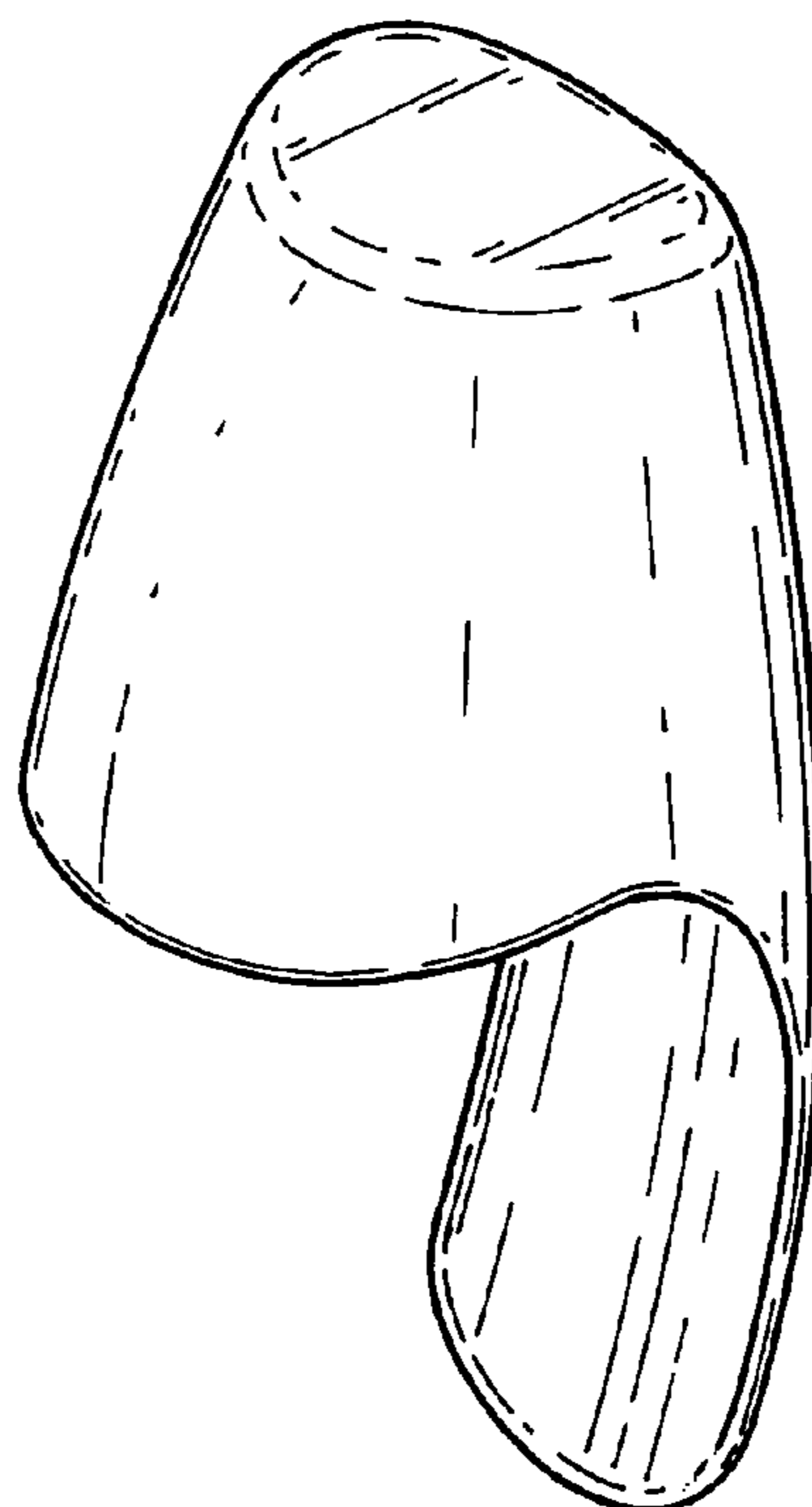
FIG. 4 is the top view of the cap according to the present invention;

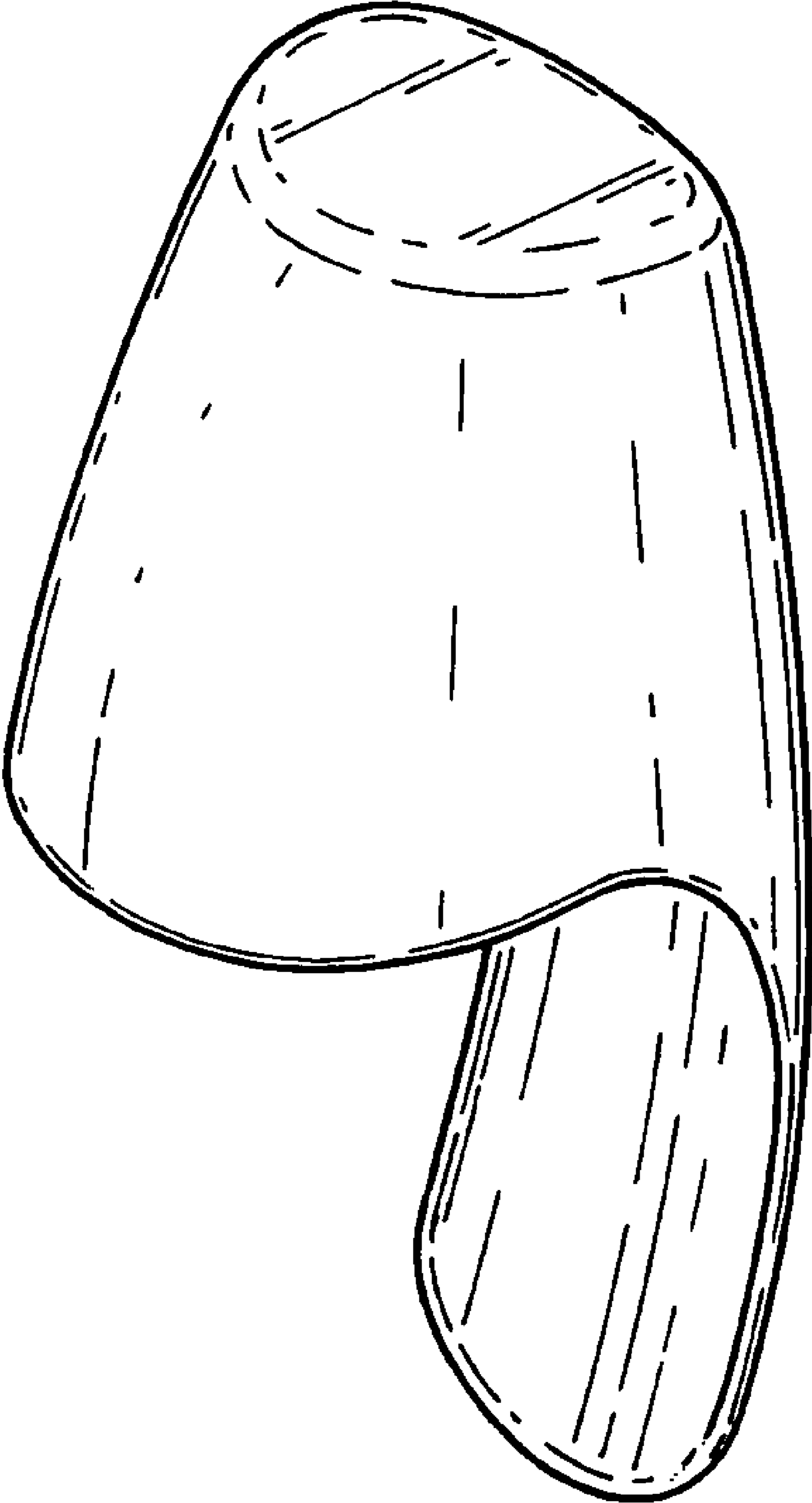

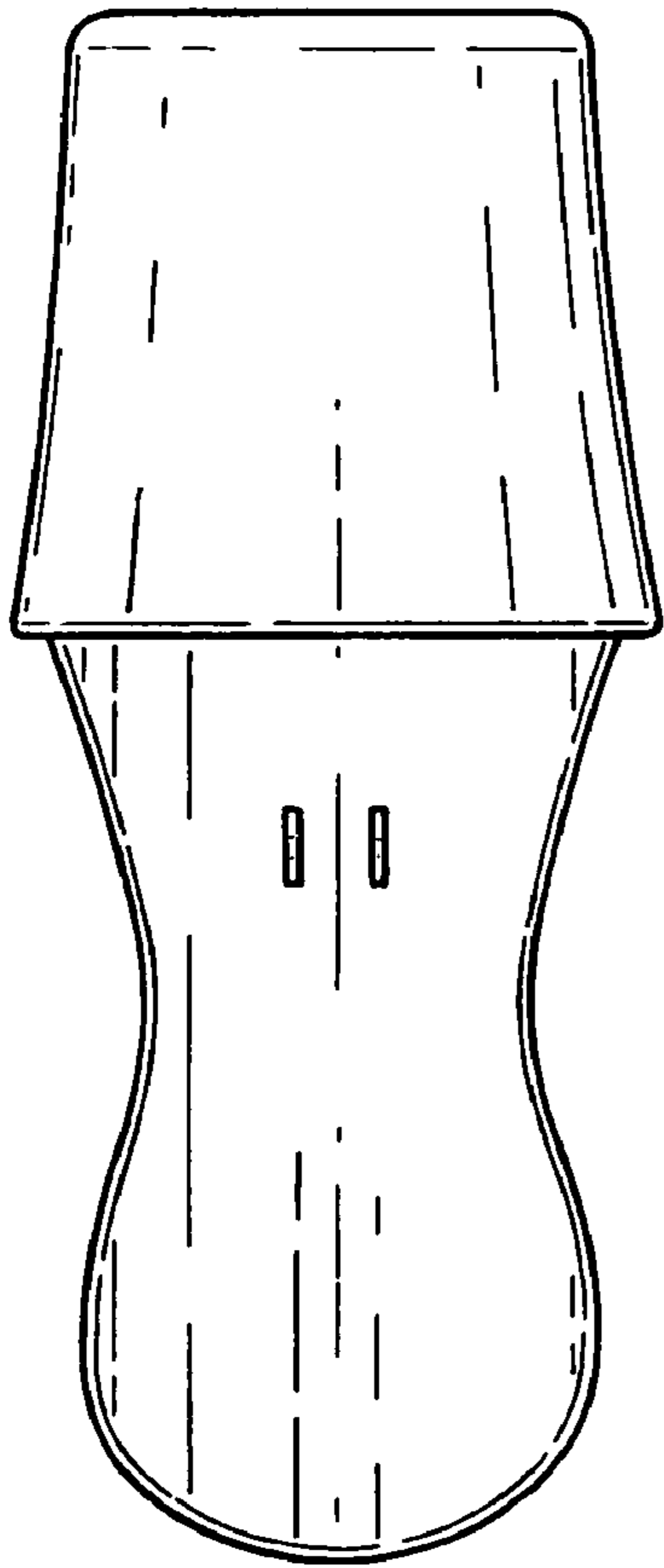

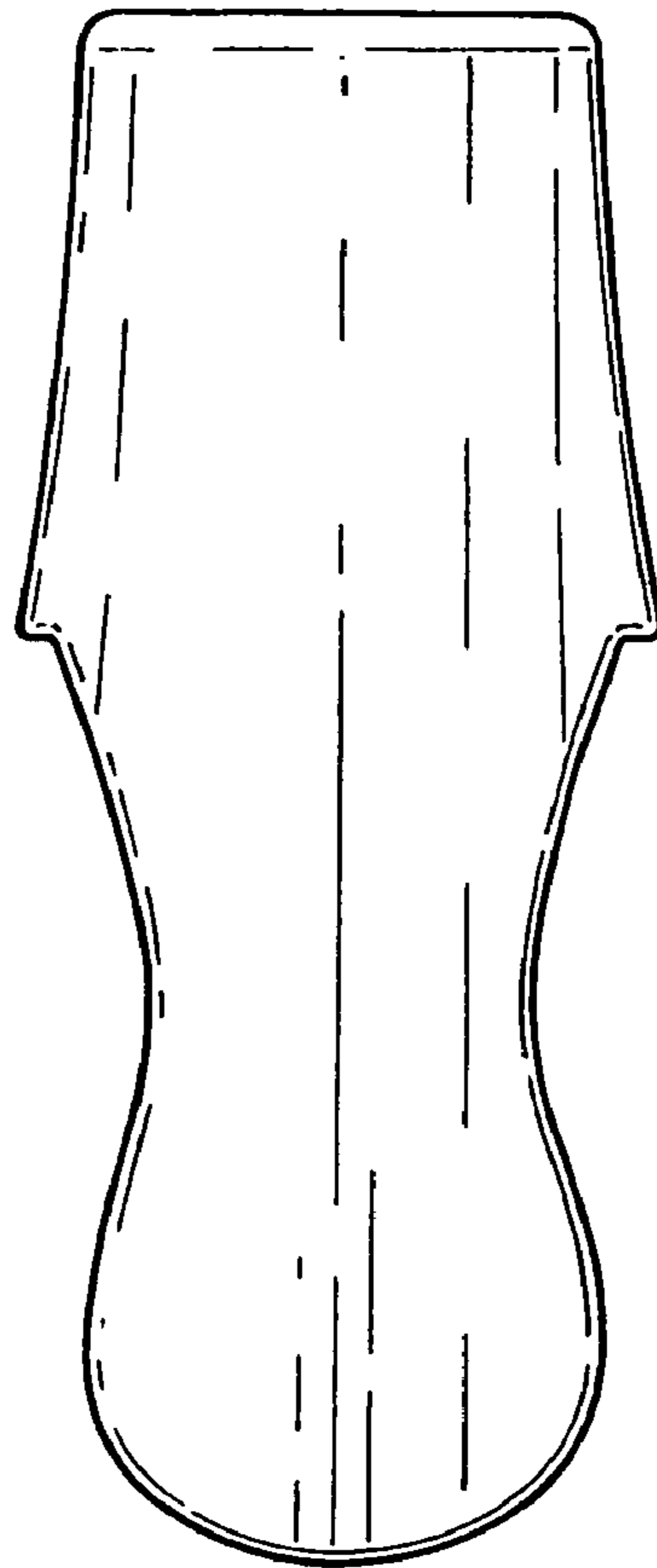

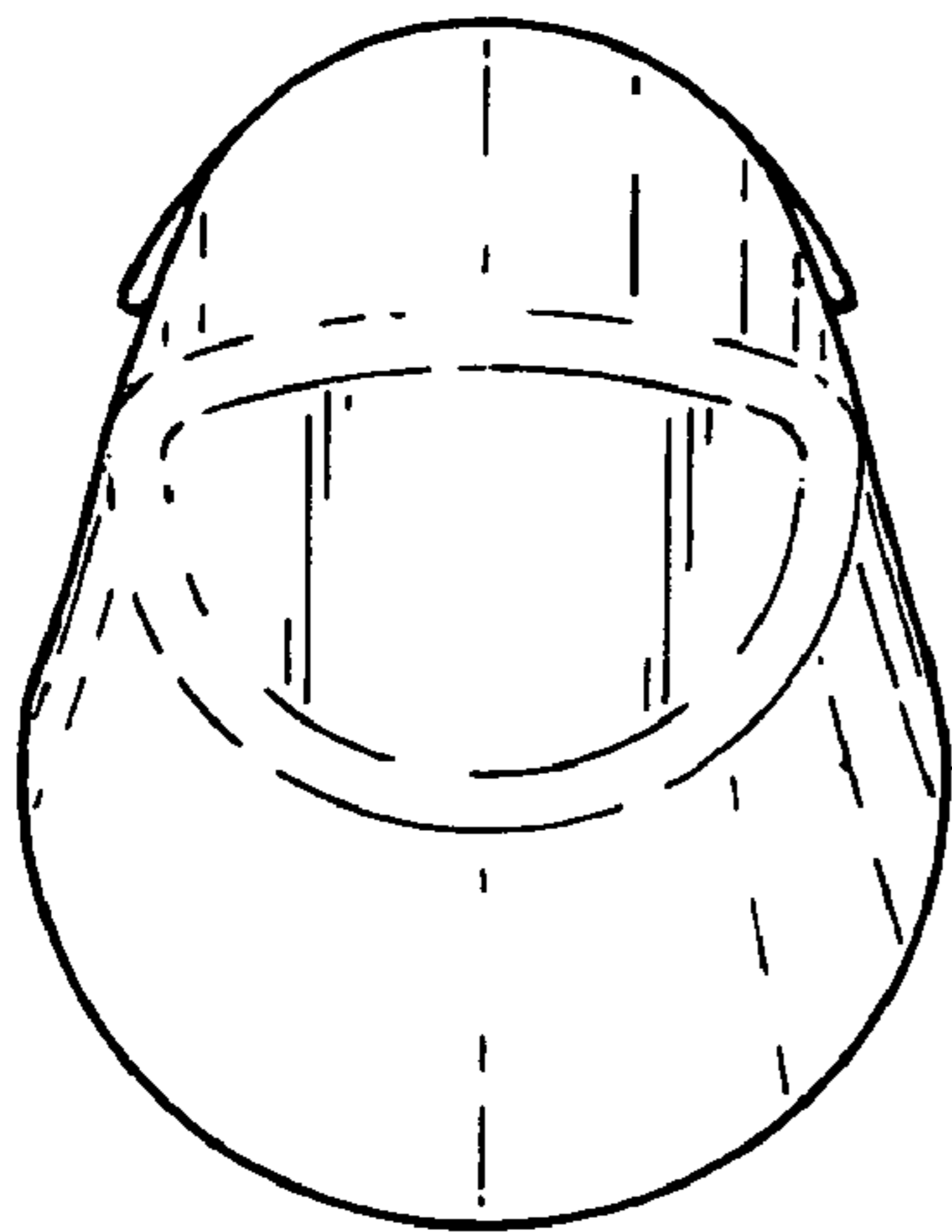

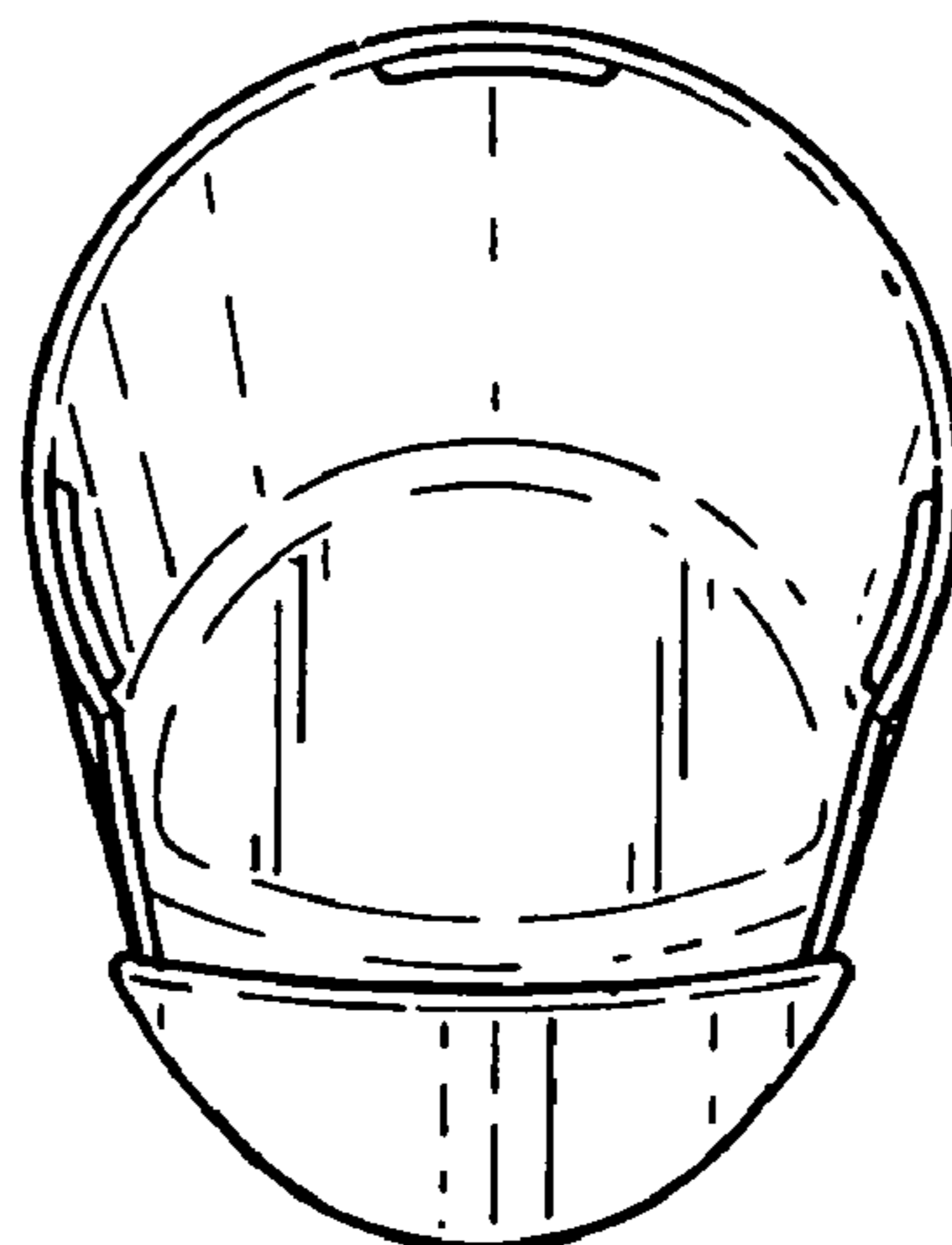

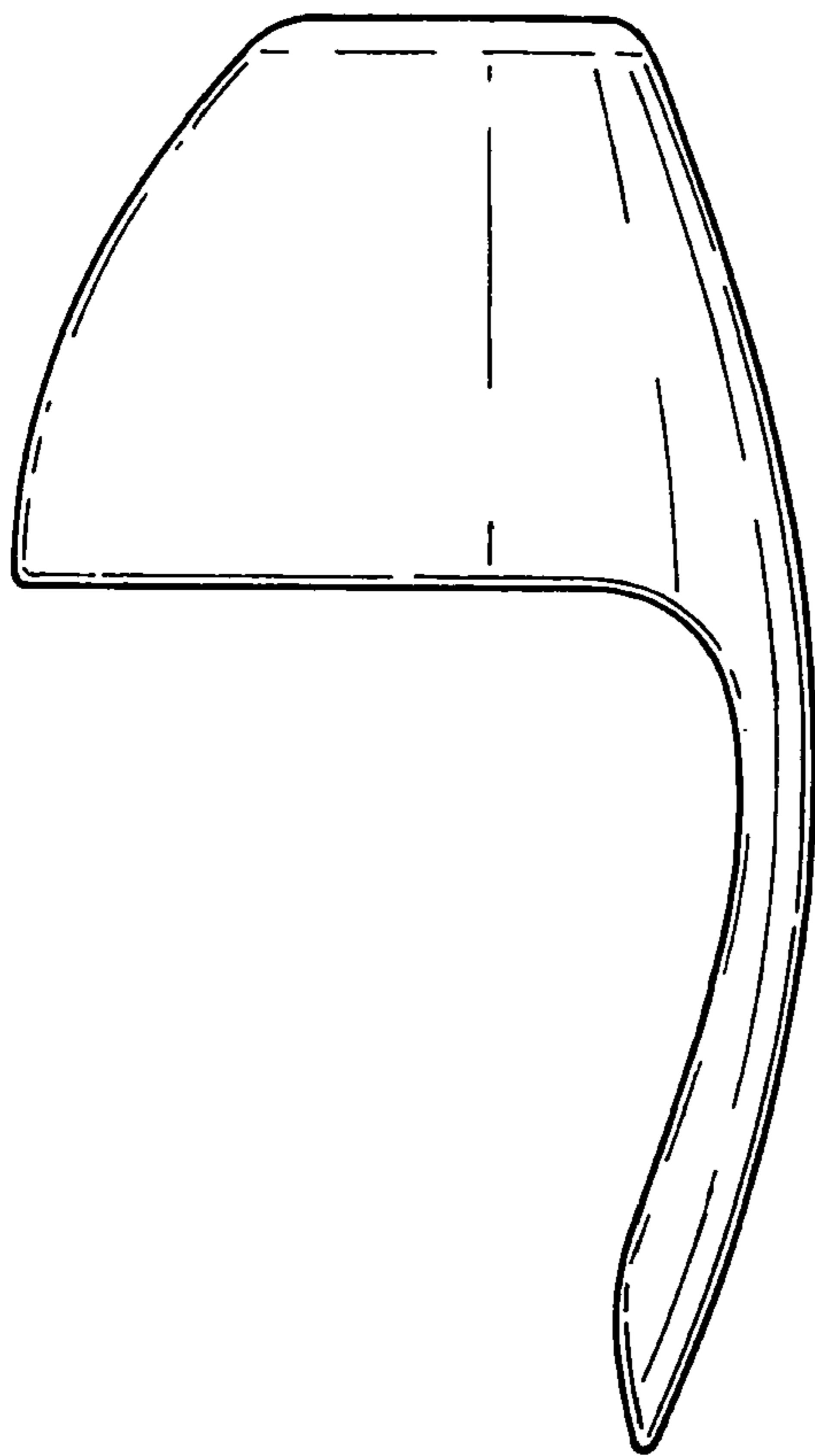

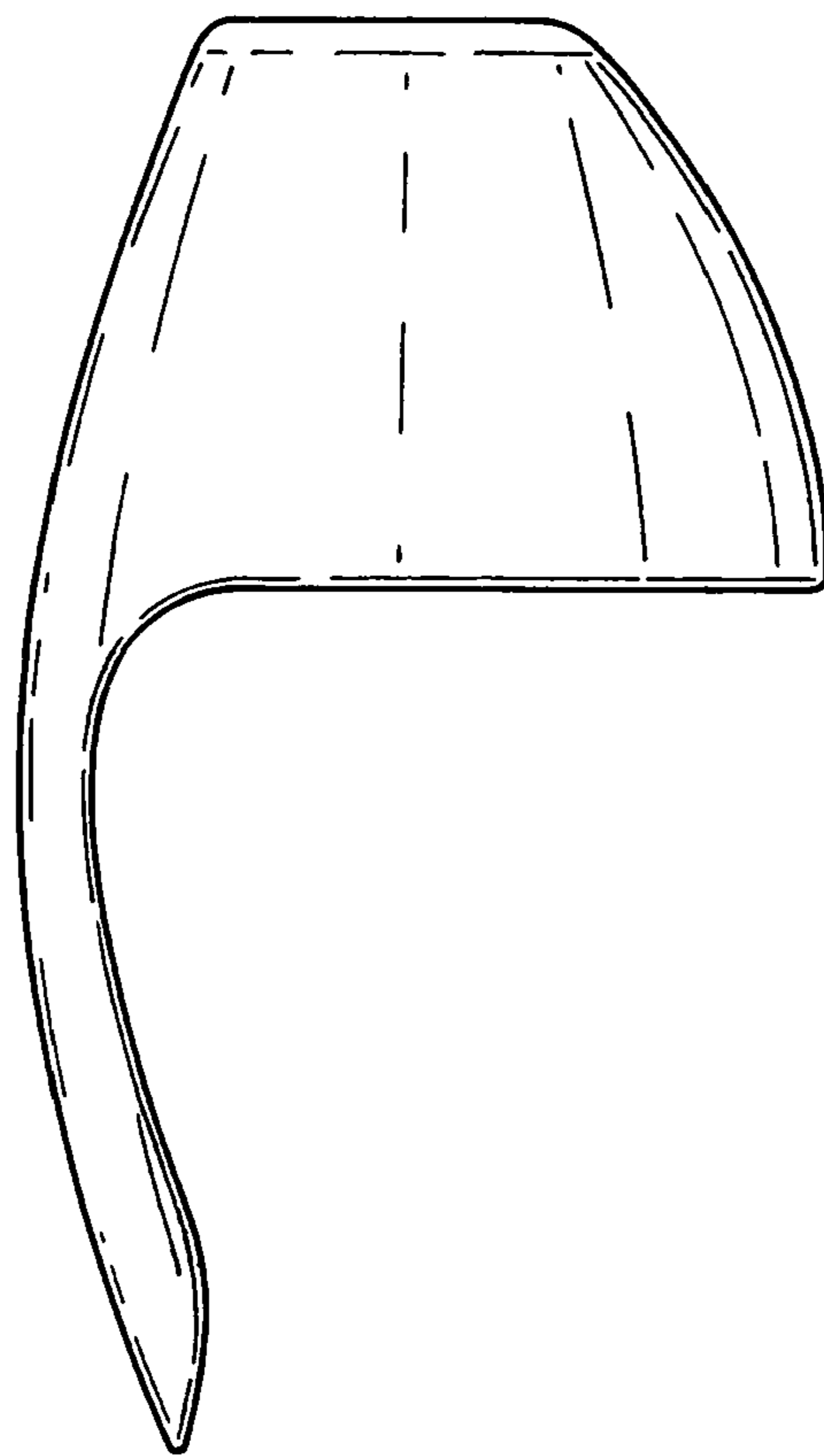
