(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a bottle showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

The dot-dot-dash-dot-dot-dash broken lines shown in the drawings define the boundary lines of the claimed design. The dash-dash-dash-dash broken lines shown in the drawings are for environmental purposes only and form no part of the claimed design.

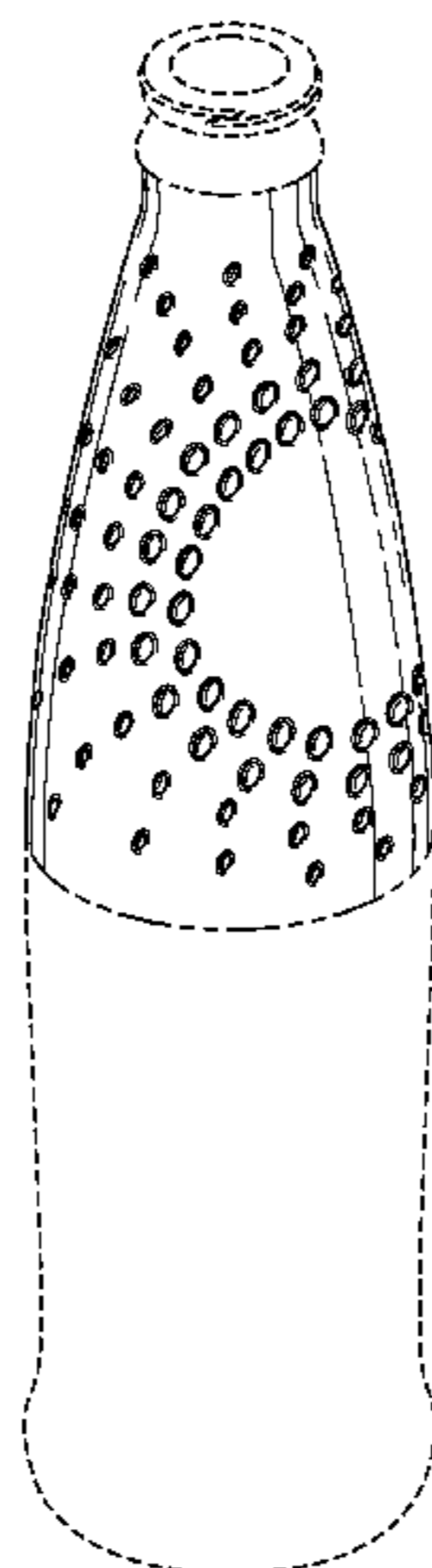

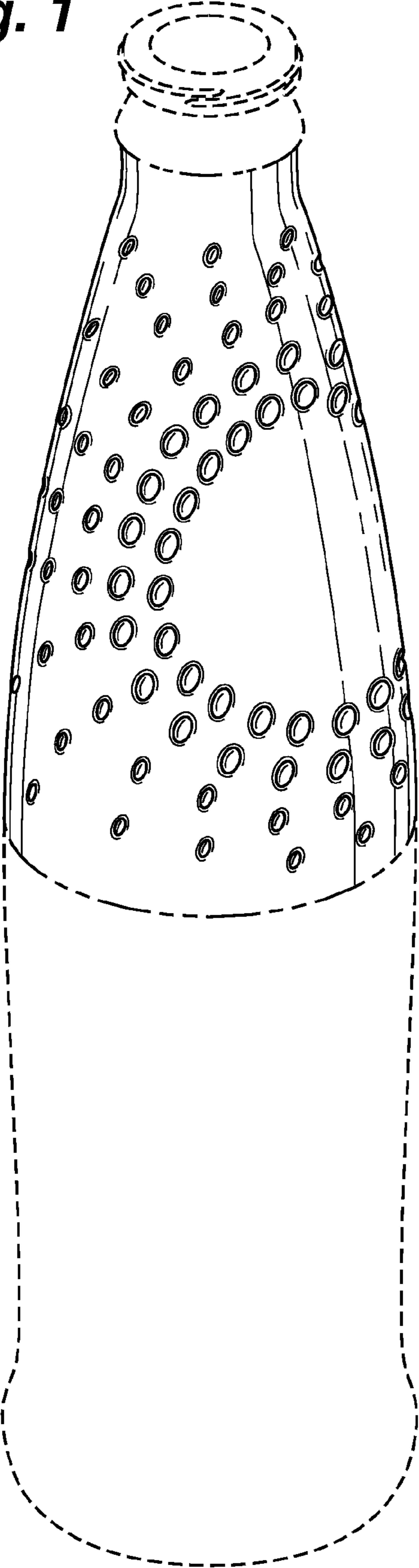

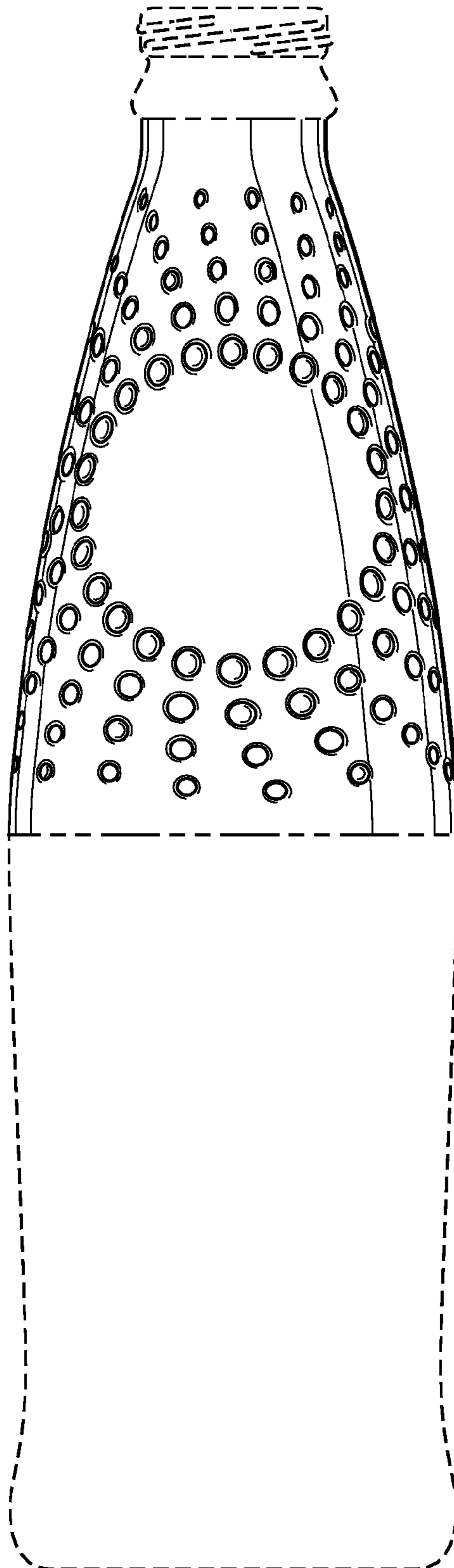

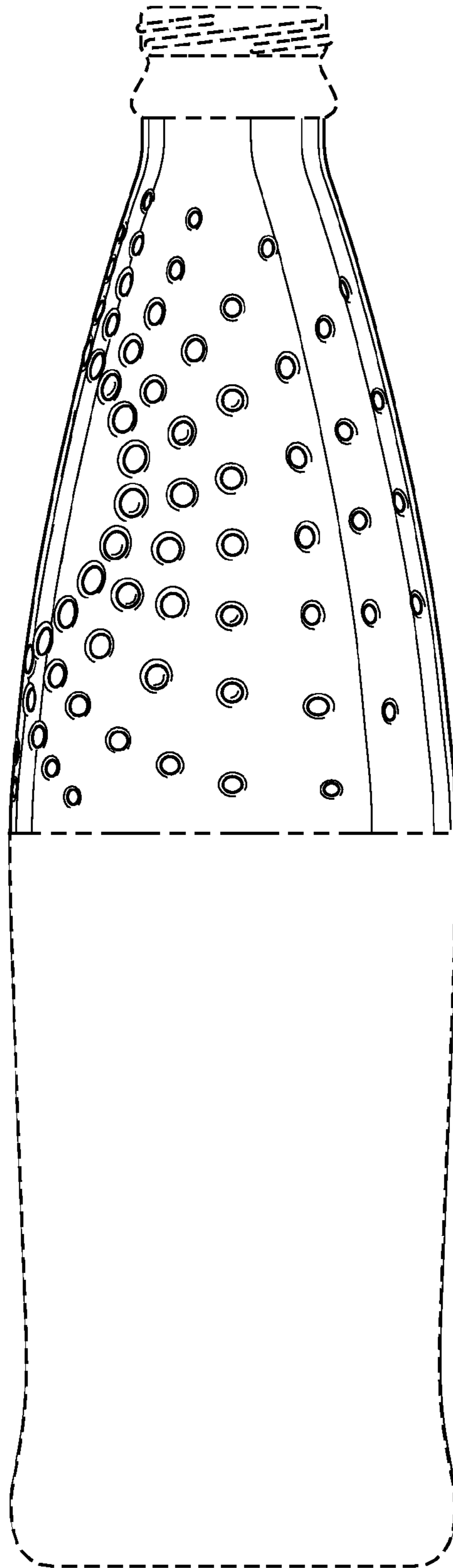

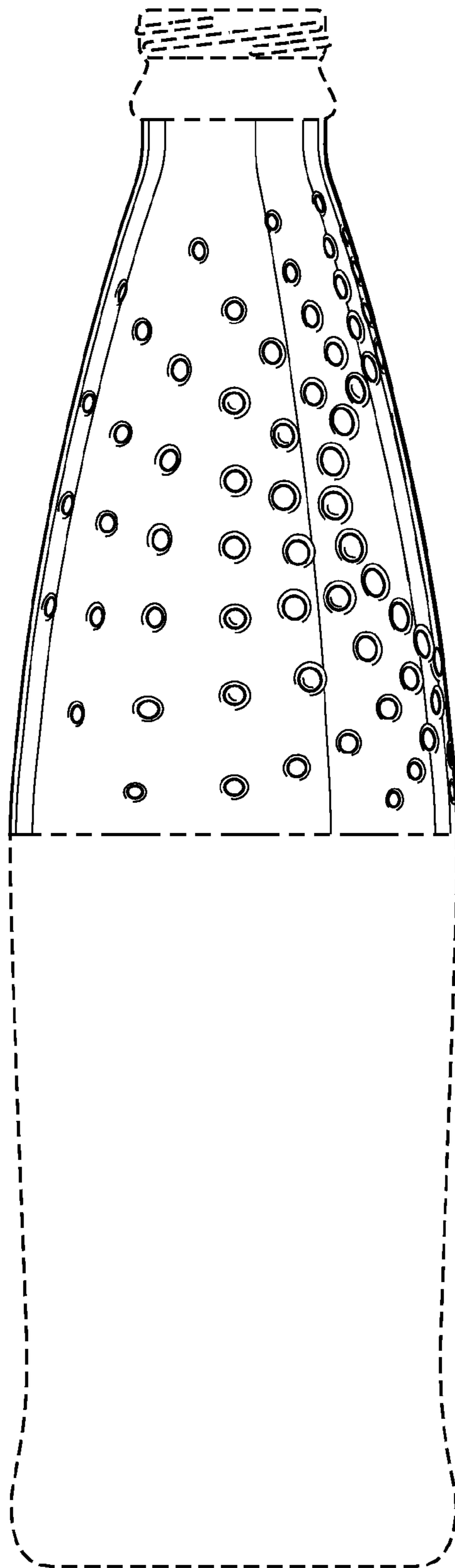

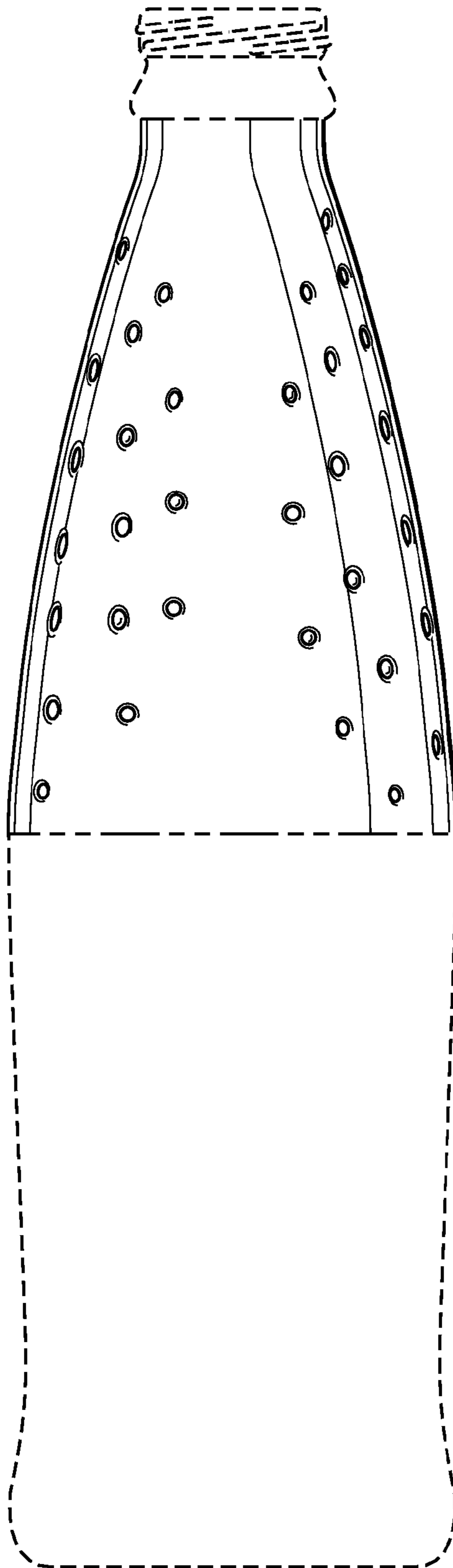

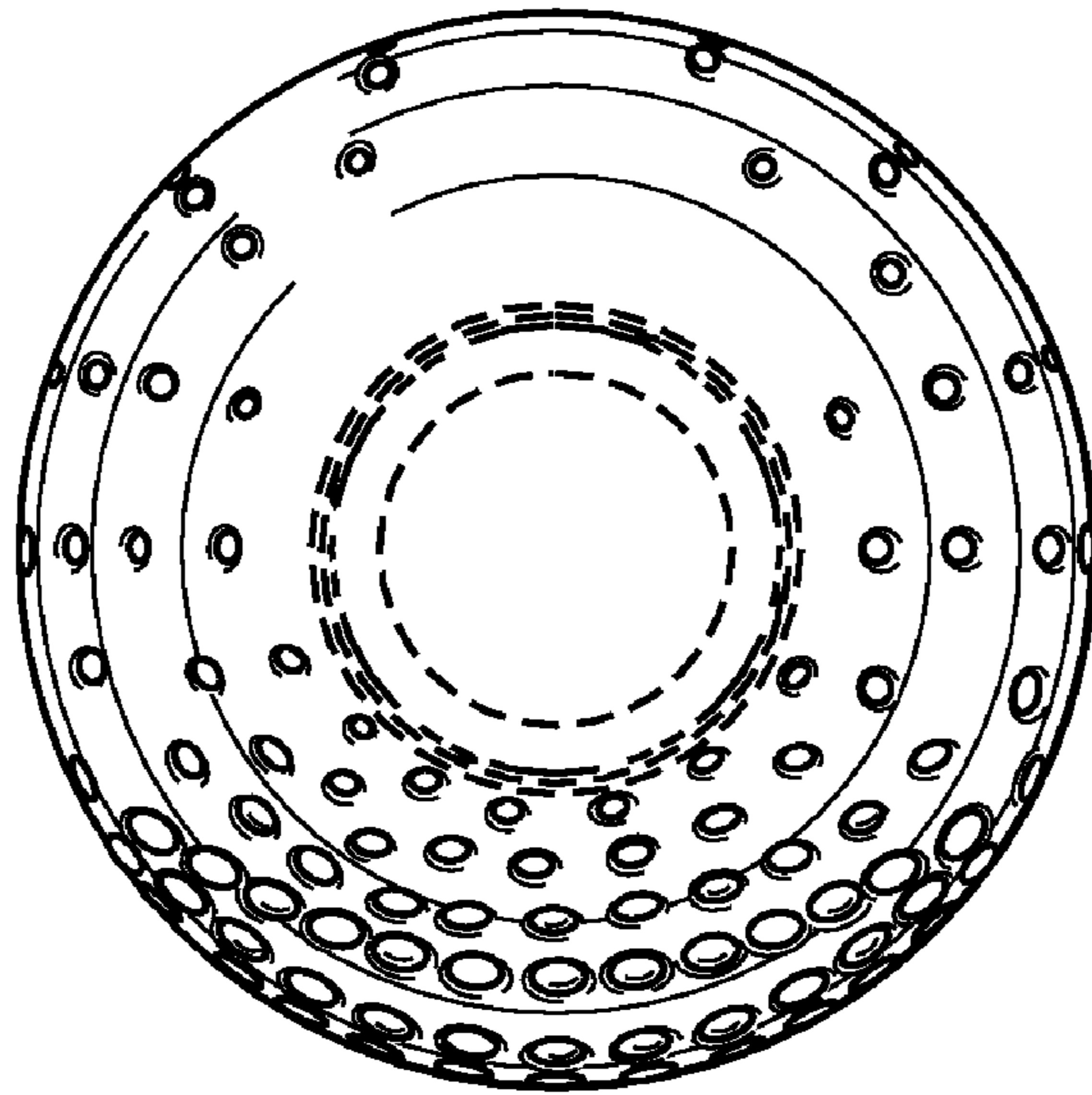
