DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of the
plastic container;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

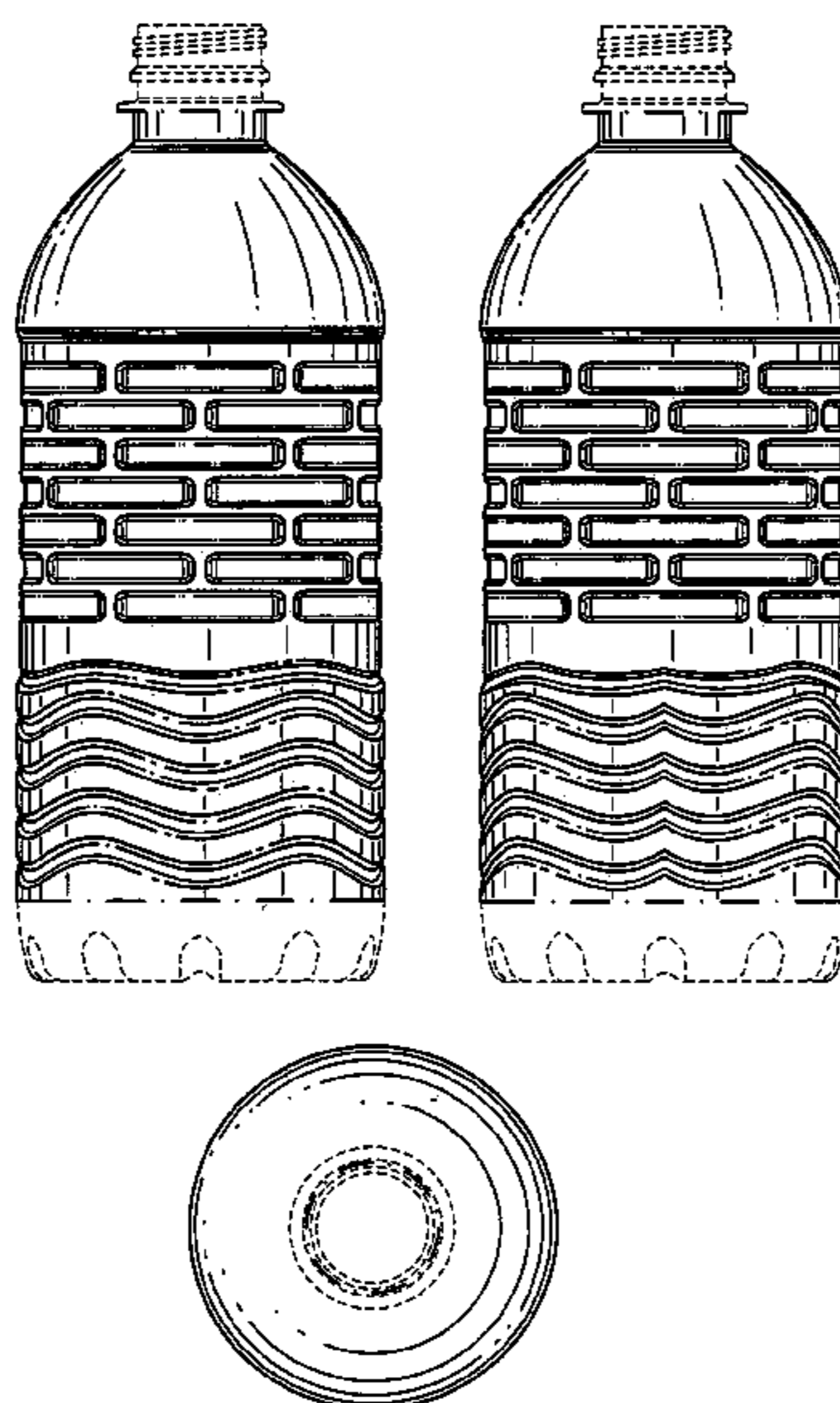
FIG. 4 is a bottom plan view thereof, shown as unclaimed

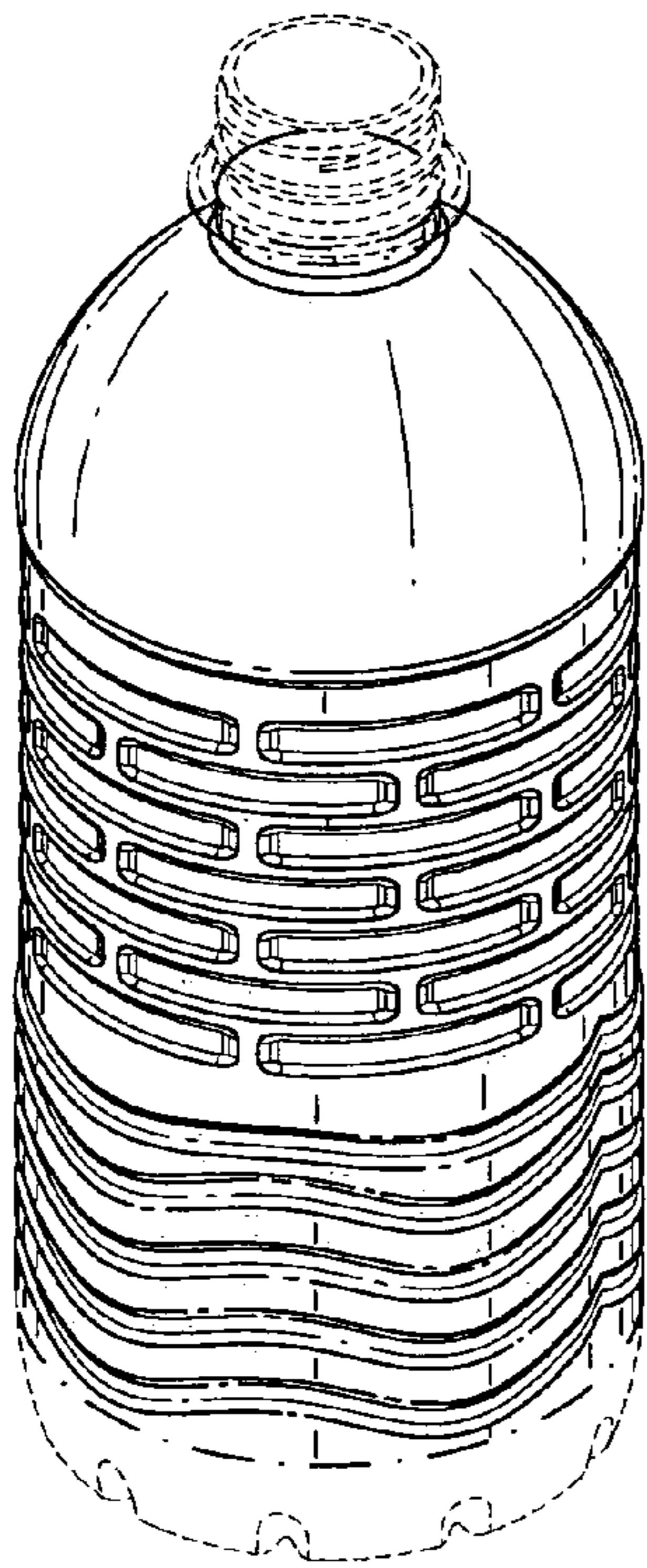

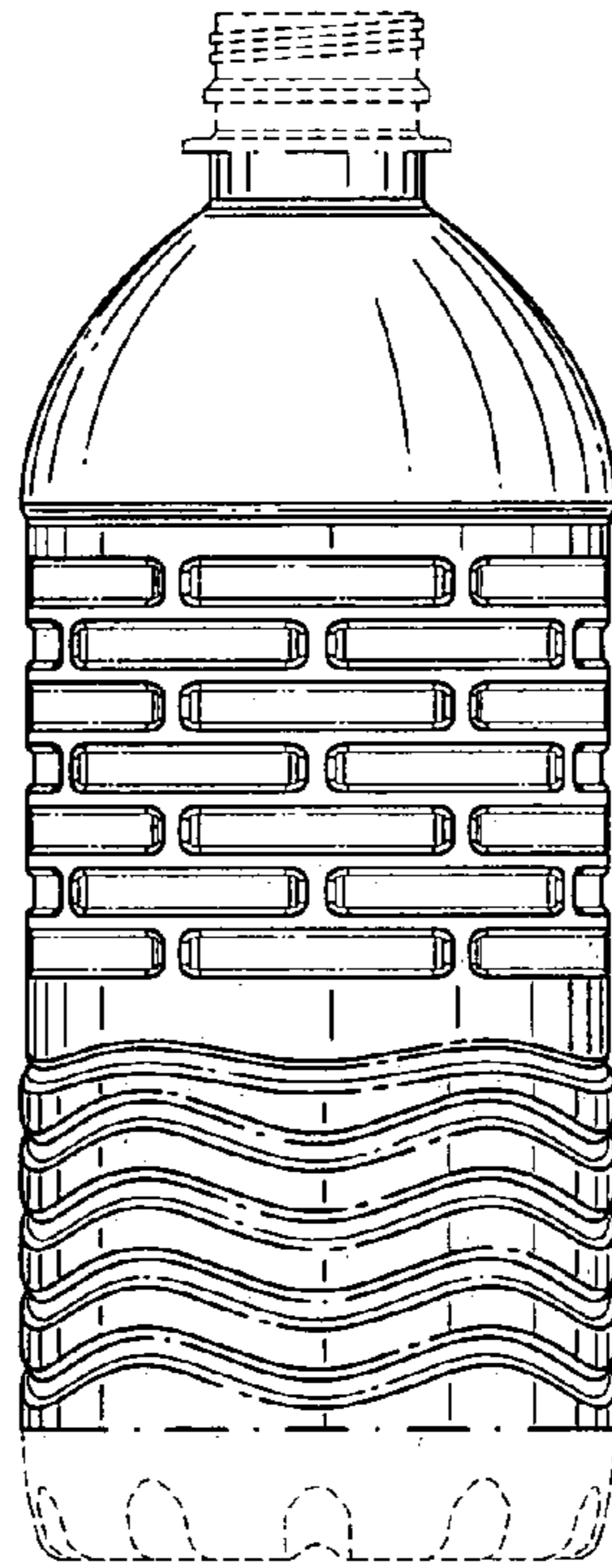

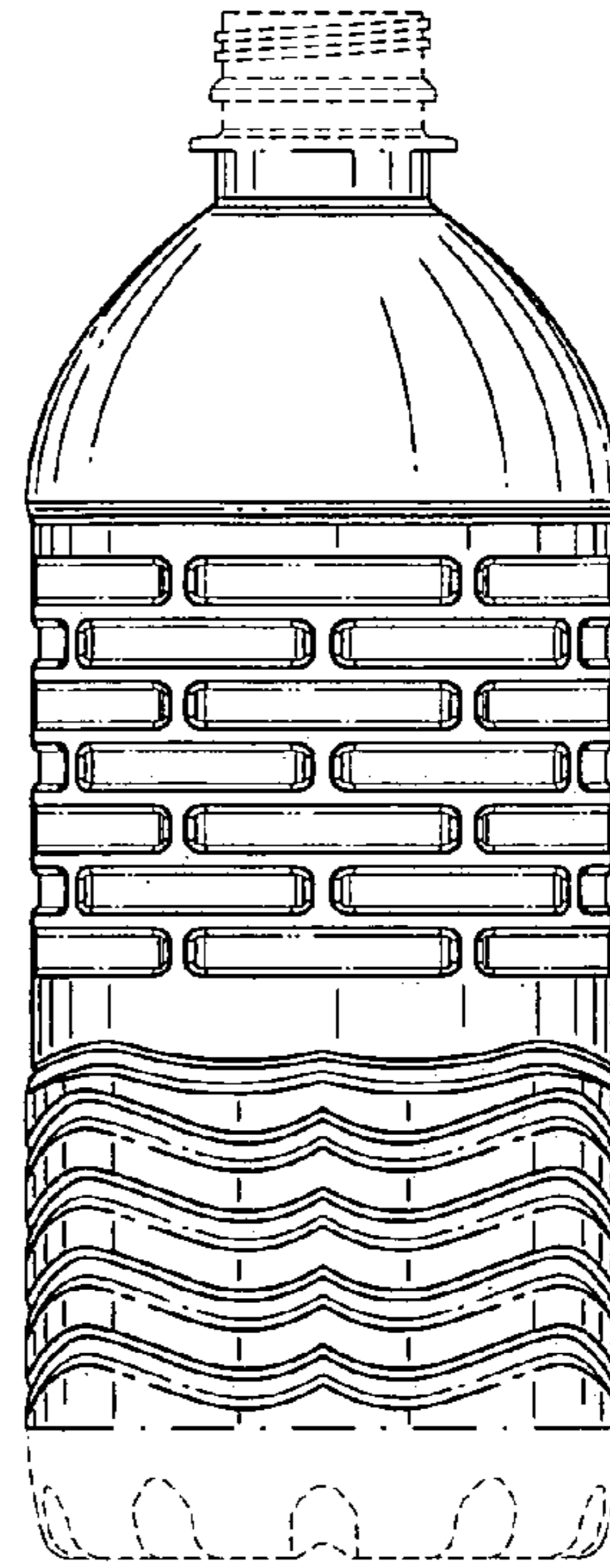

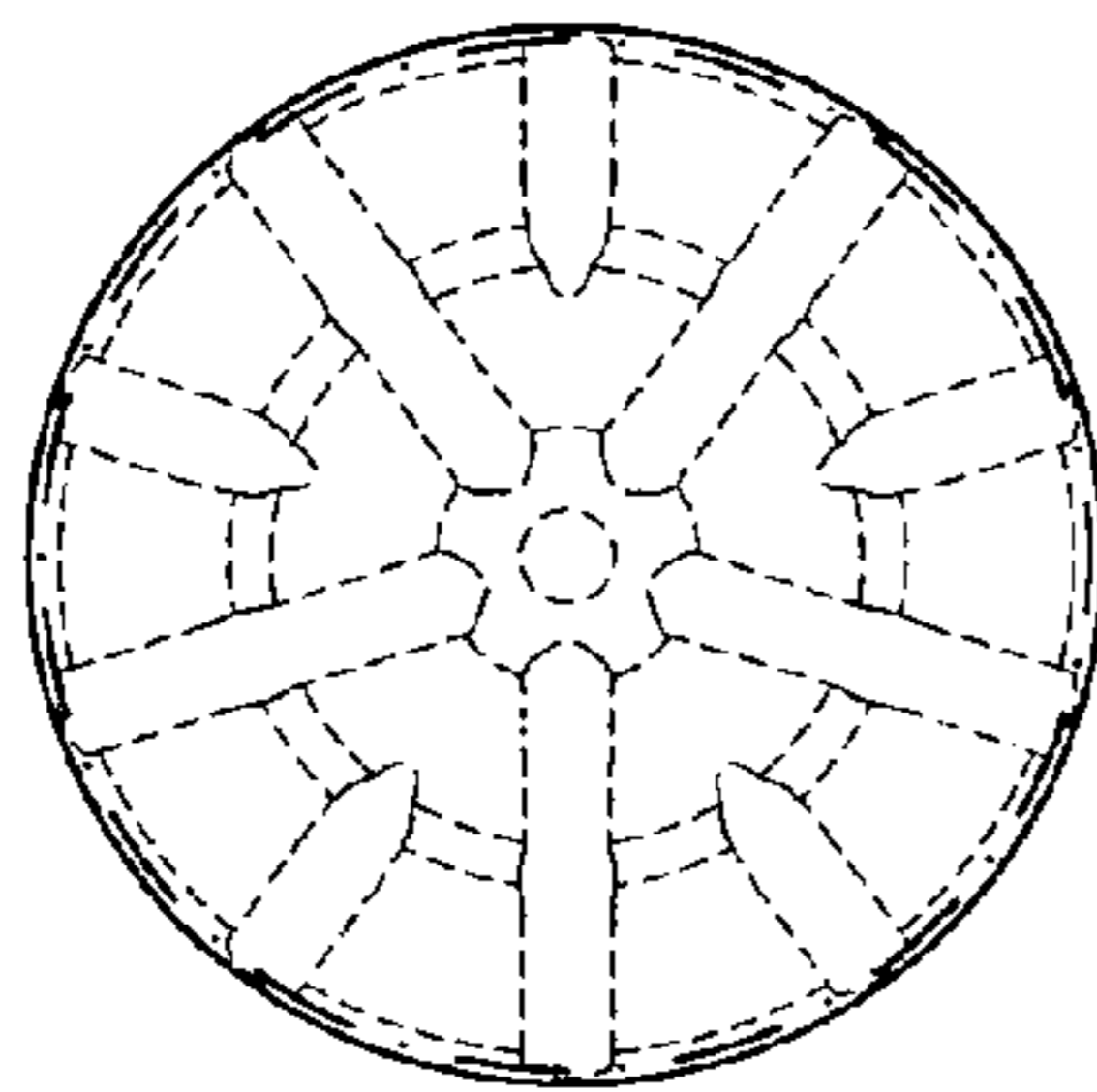

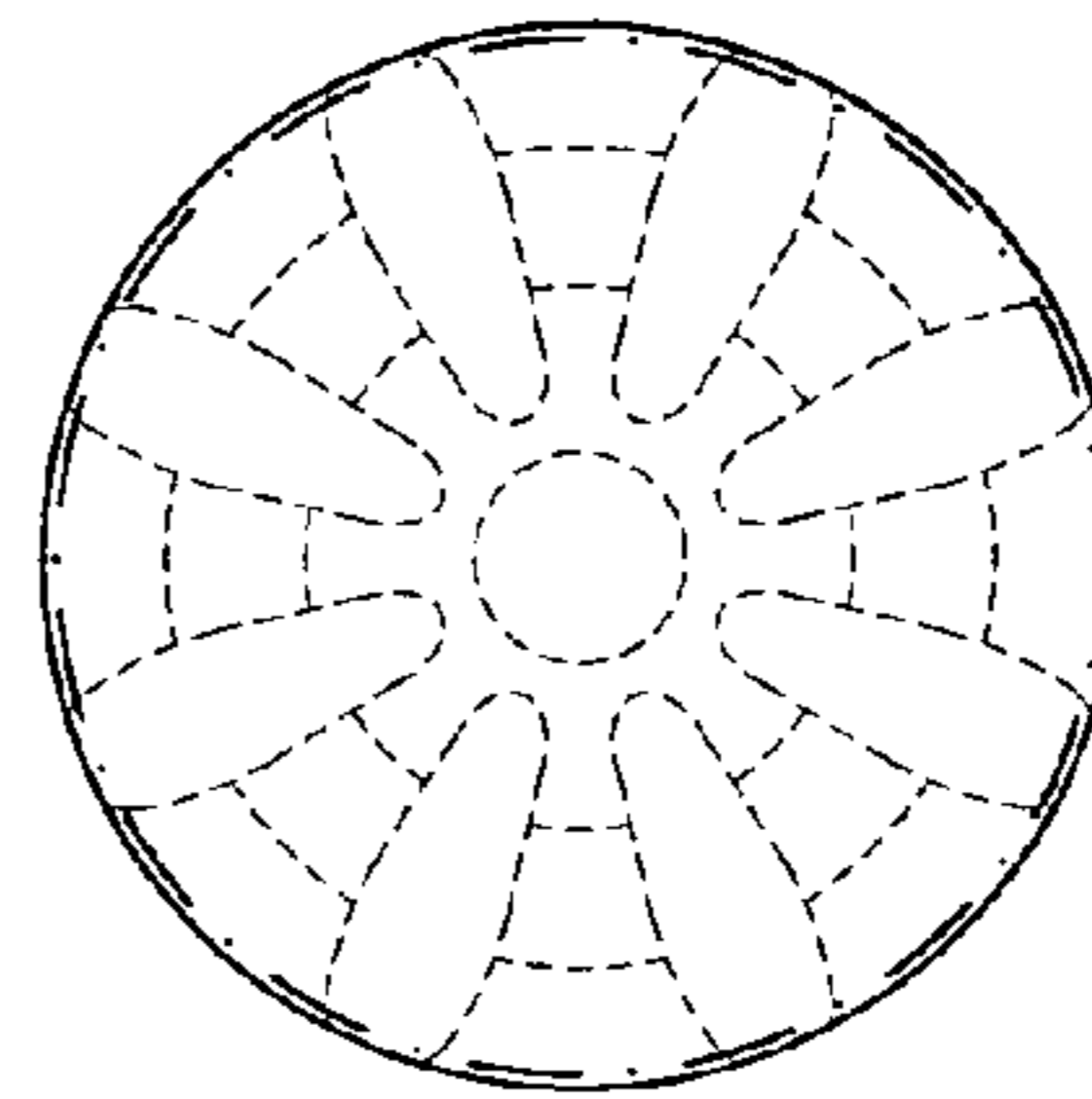

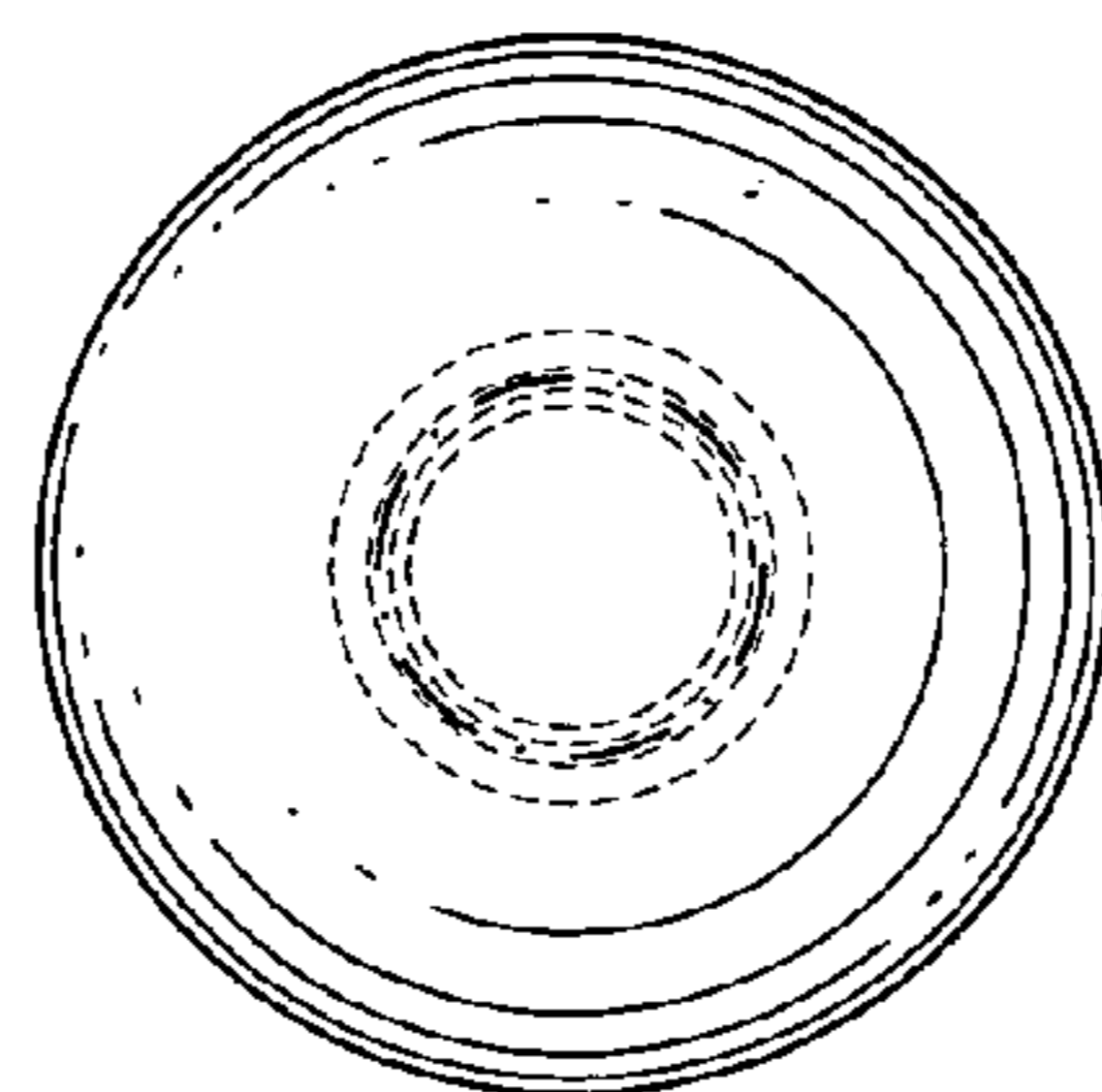
